(57) **CLAIM**

The ornamental design for elements of a front fairing for a snowmobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective illustration, from the rear and left side, of elements of a front fairing for a snowmobile according to my design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a front elevation view thereof;

FIG. 6 is a left side elevation view thereof;

FIG. 7 is a right side elevation view thereof;

FIG. 8 is a perspective illustration from the front and right side, of elements of a front fairing for a snowmobile according to my new design shown on a snowmobile,

FIG. 11 is a rear elevation view thereof;

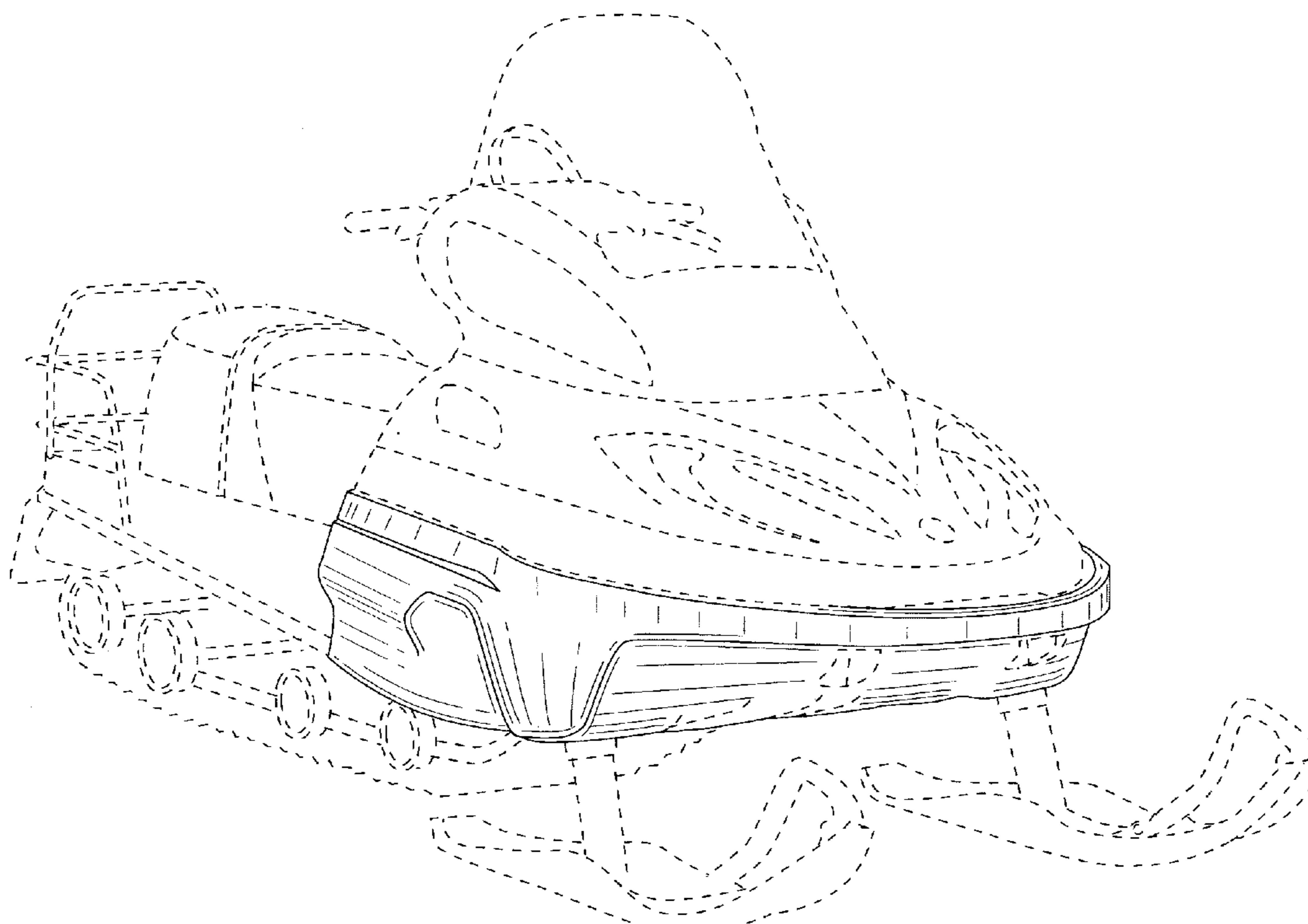
FIG. 12 is a front elevation view thereof;

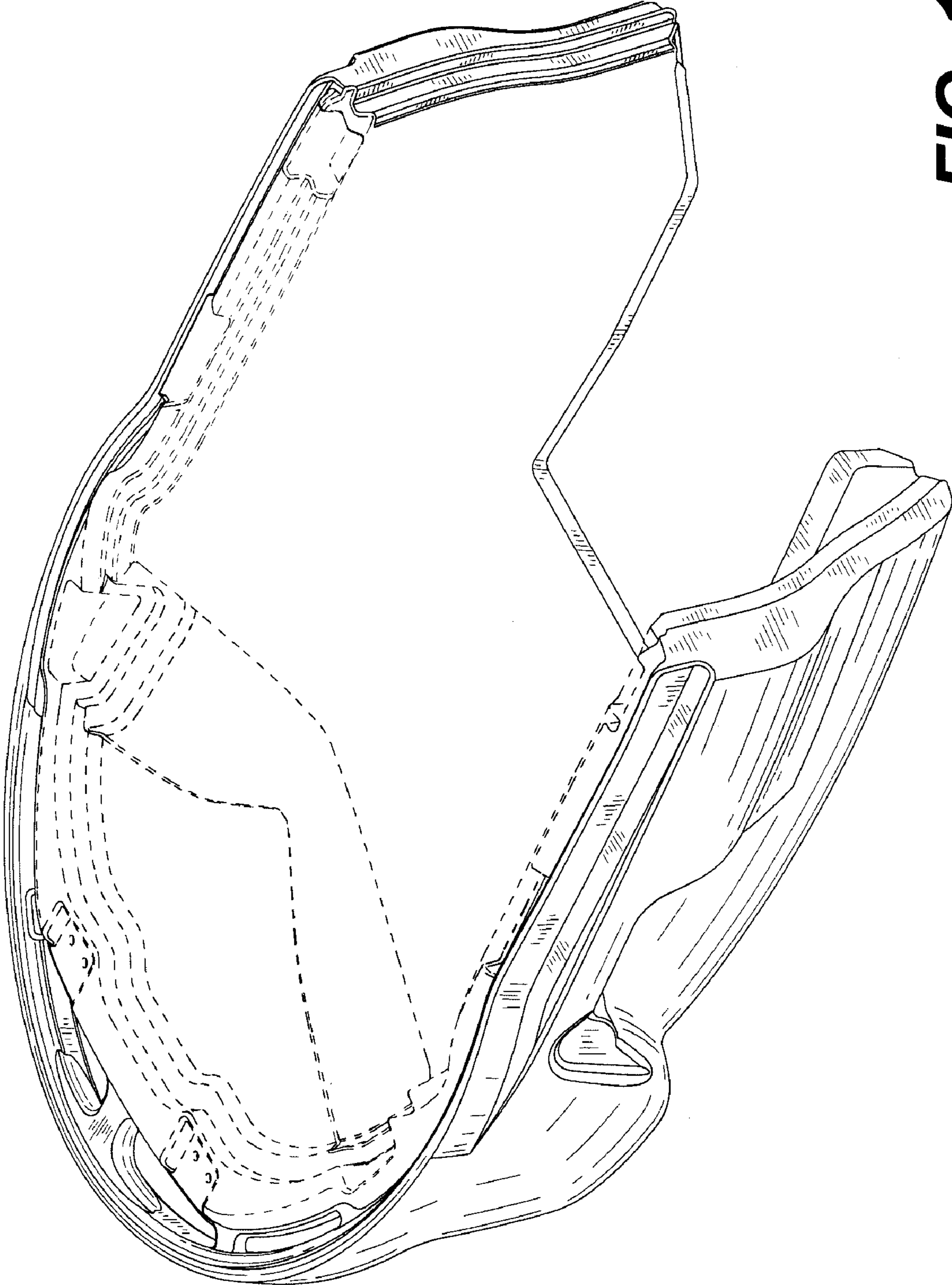

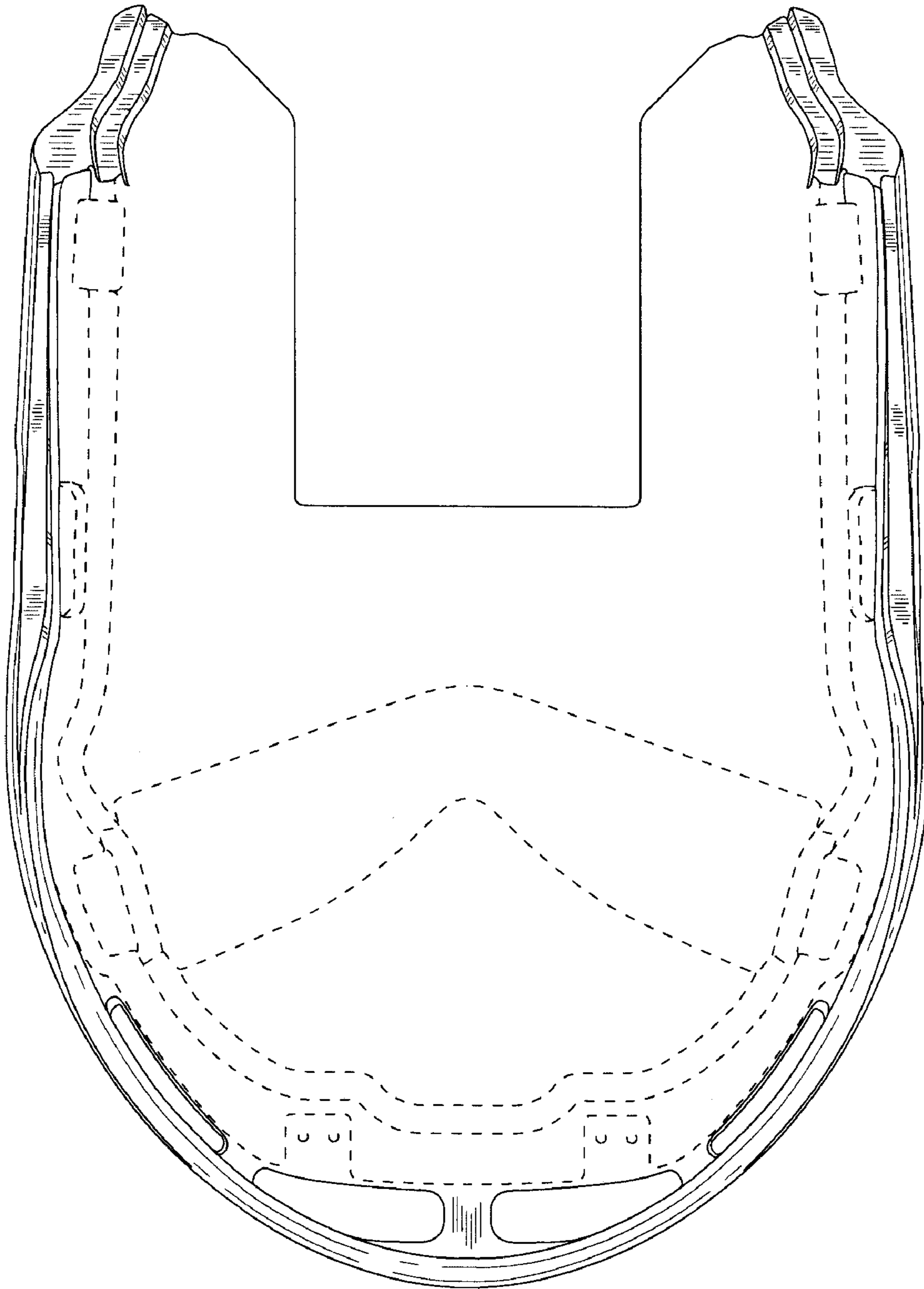

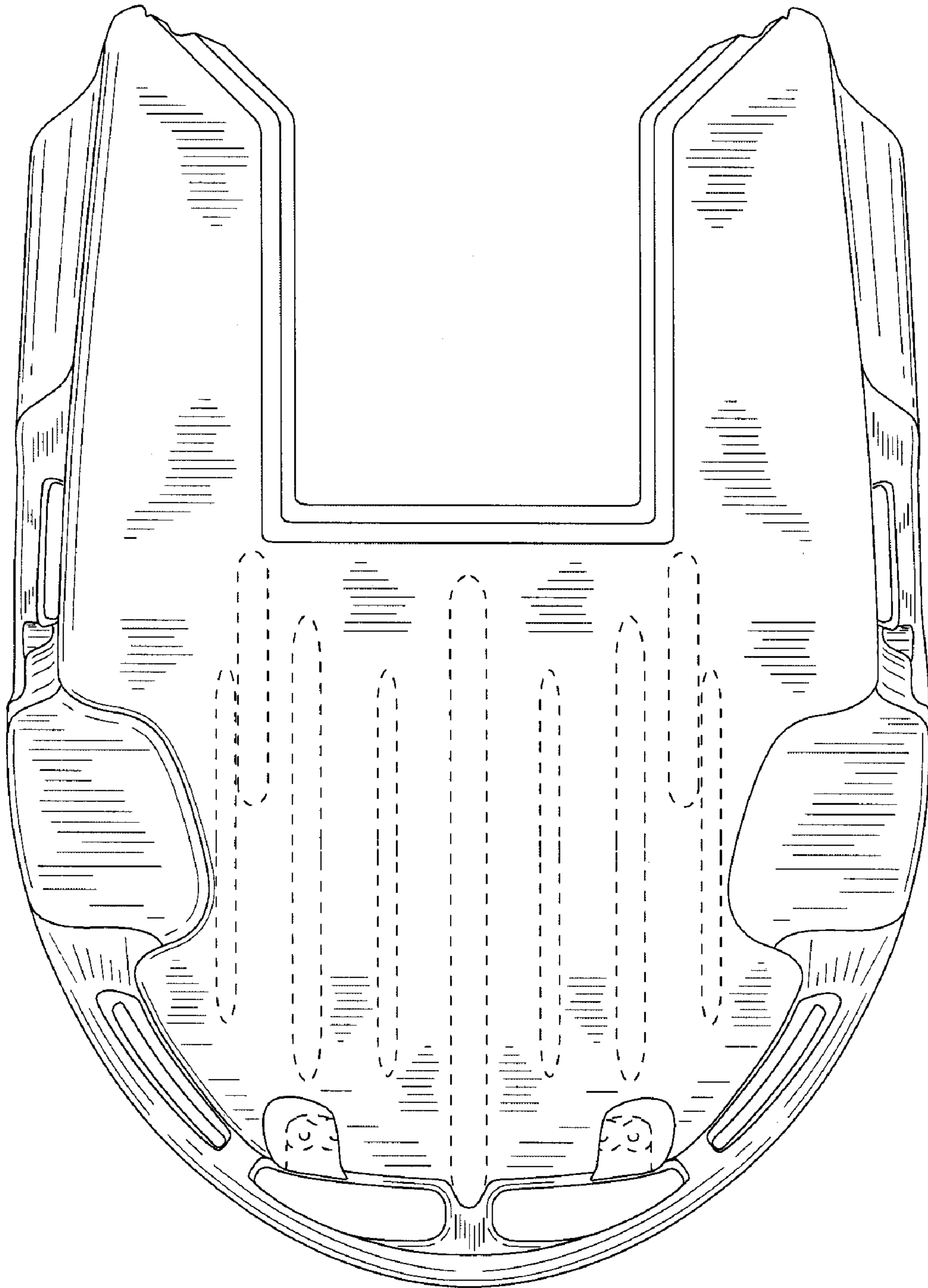

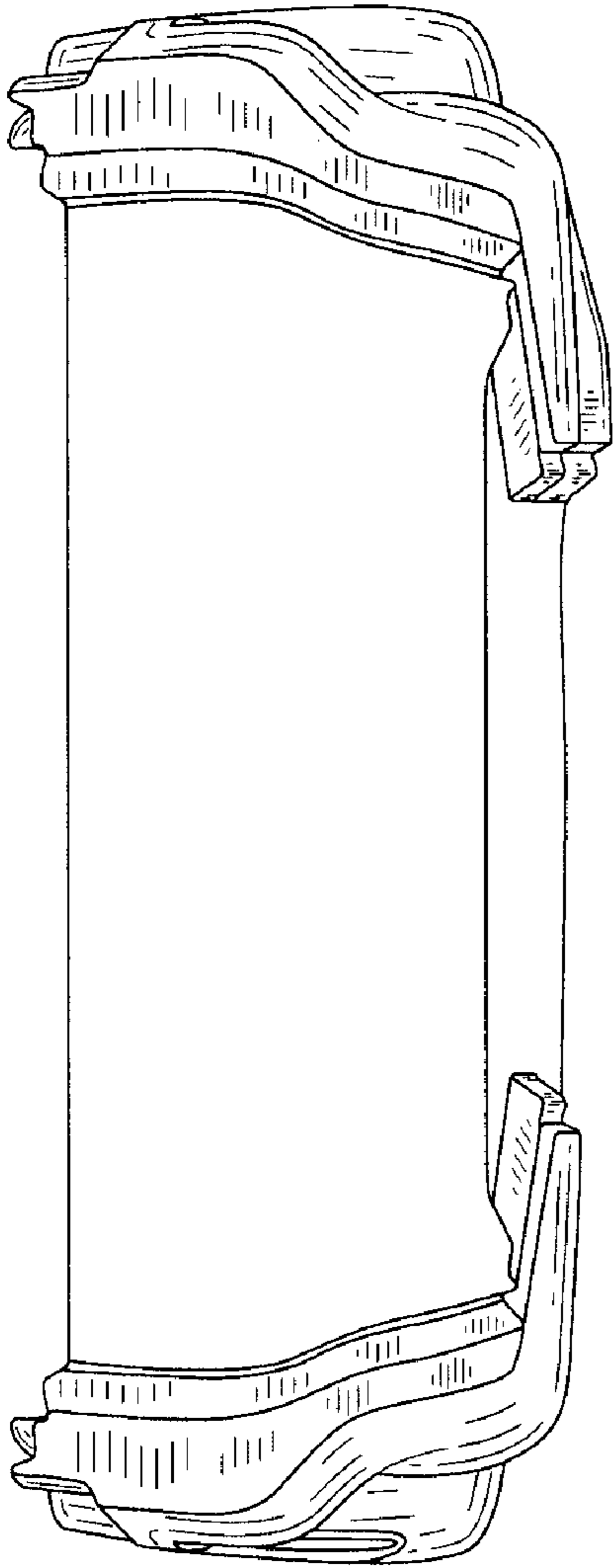

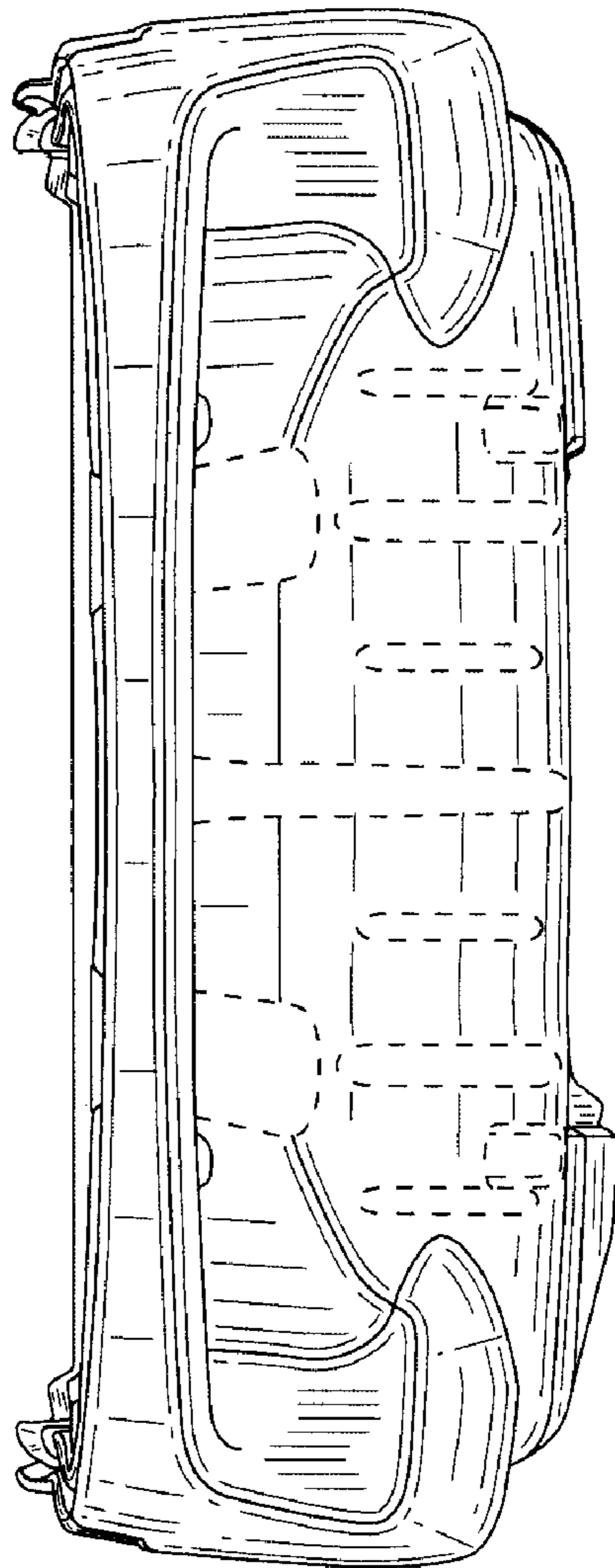

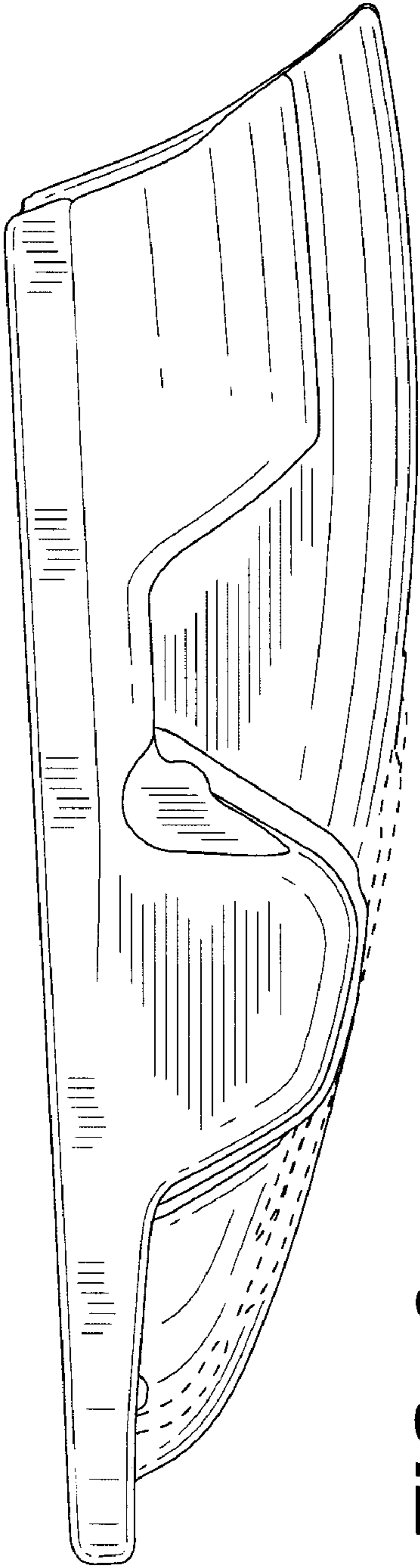

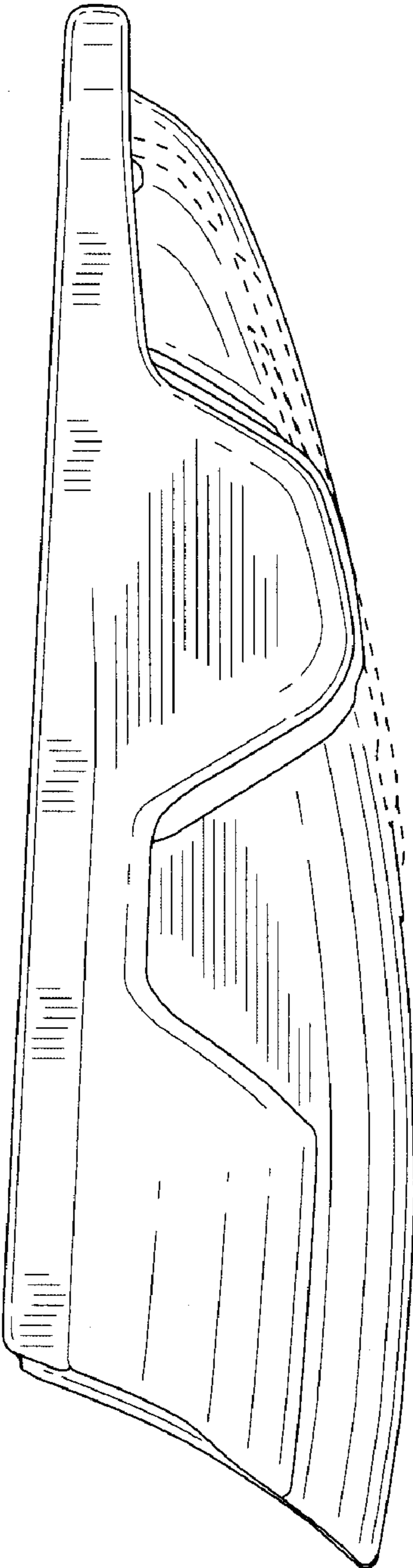

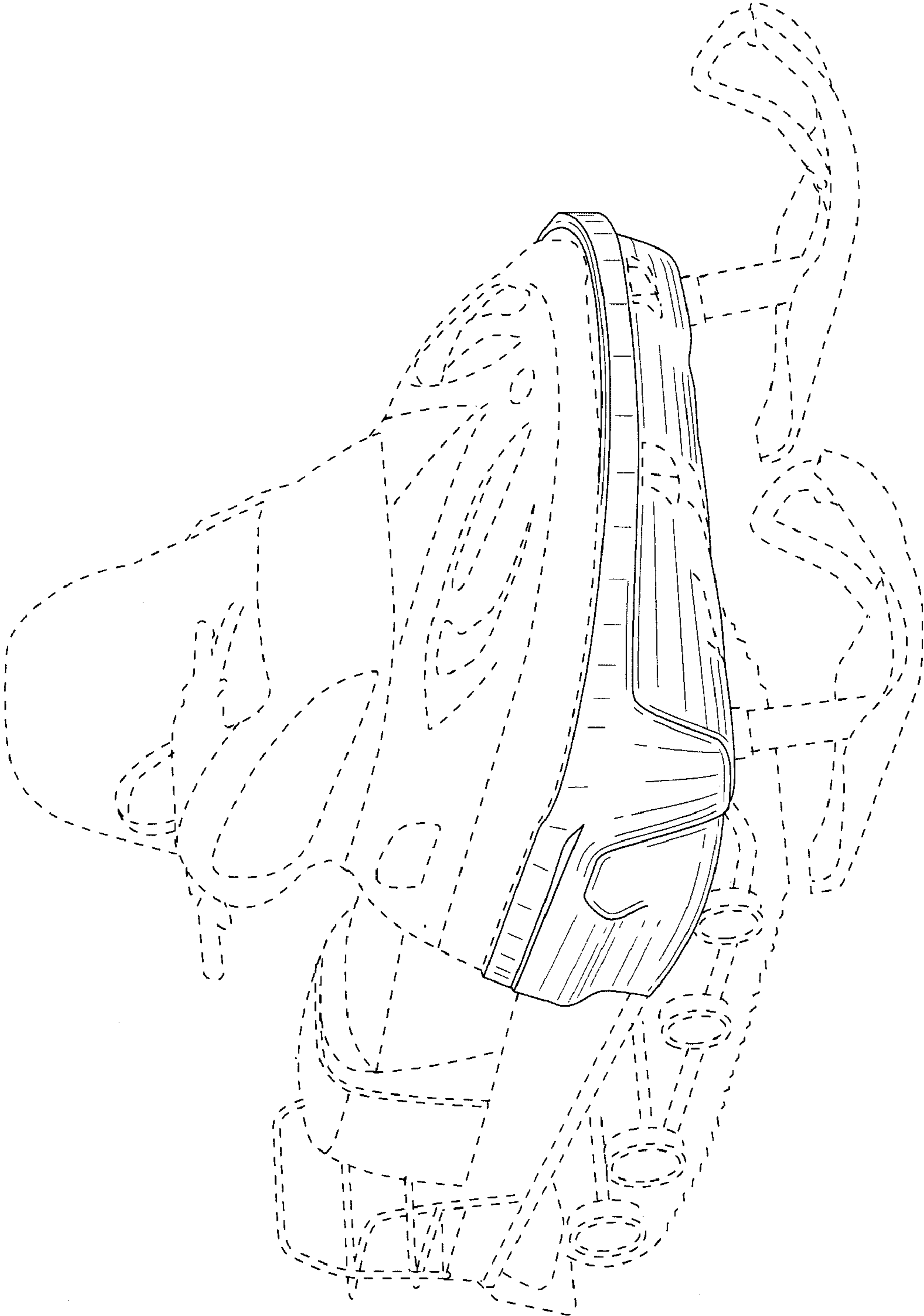

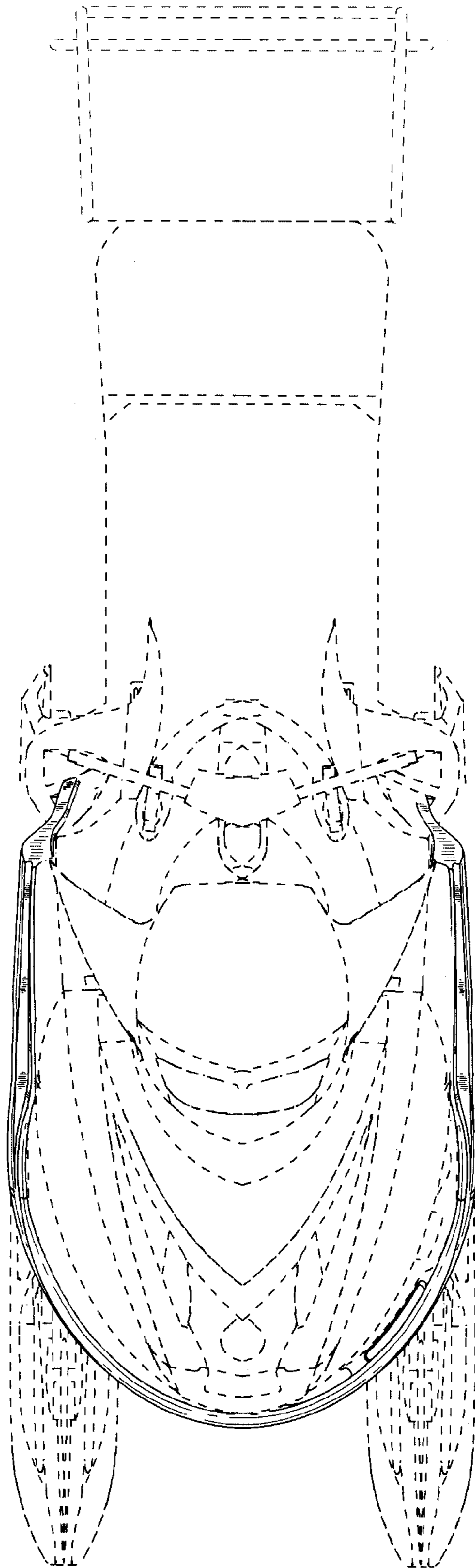

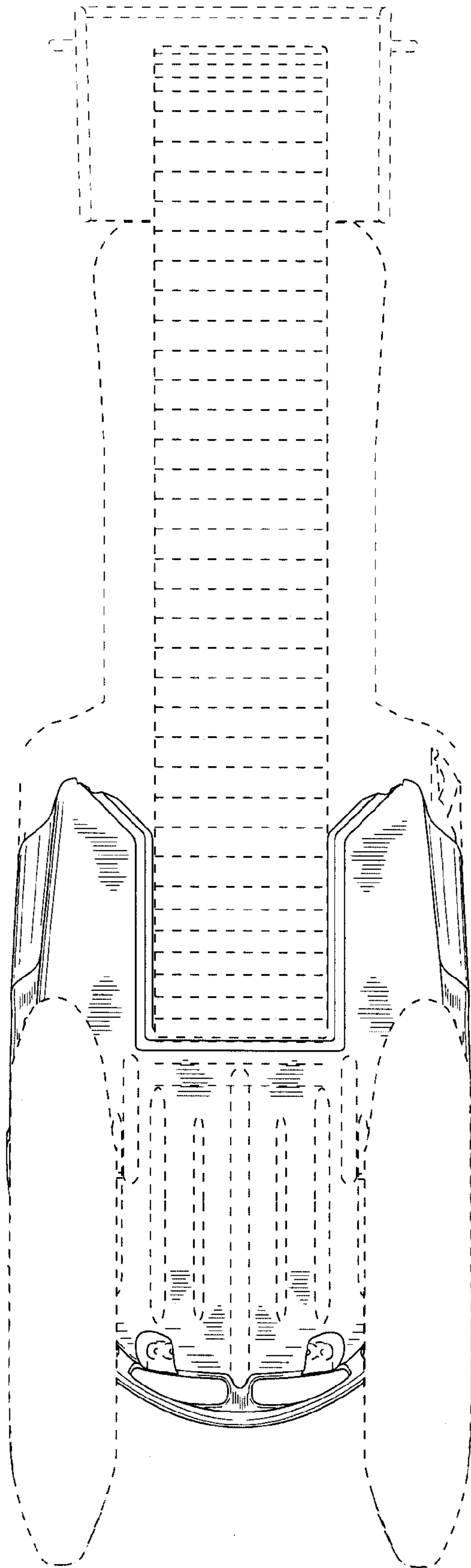

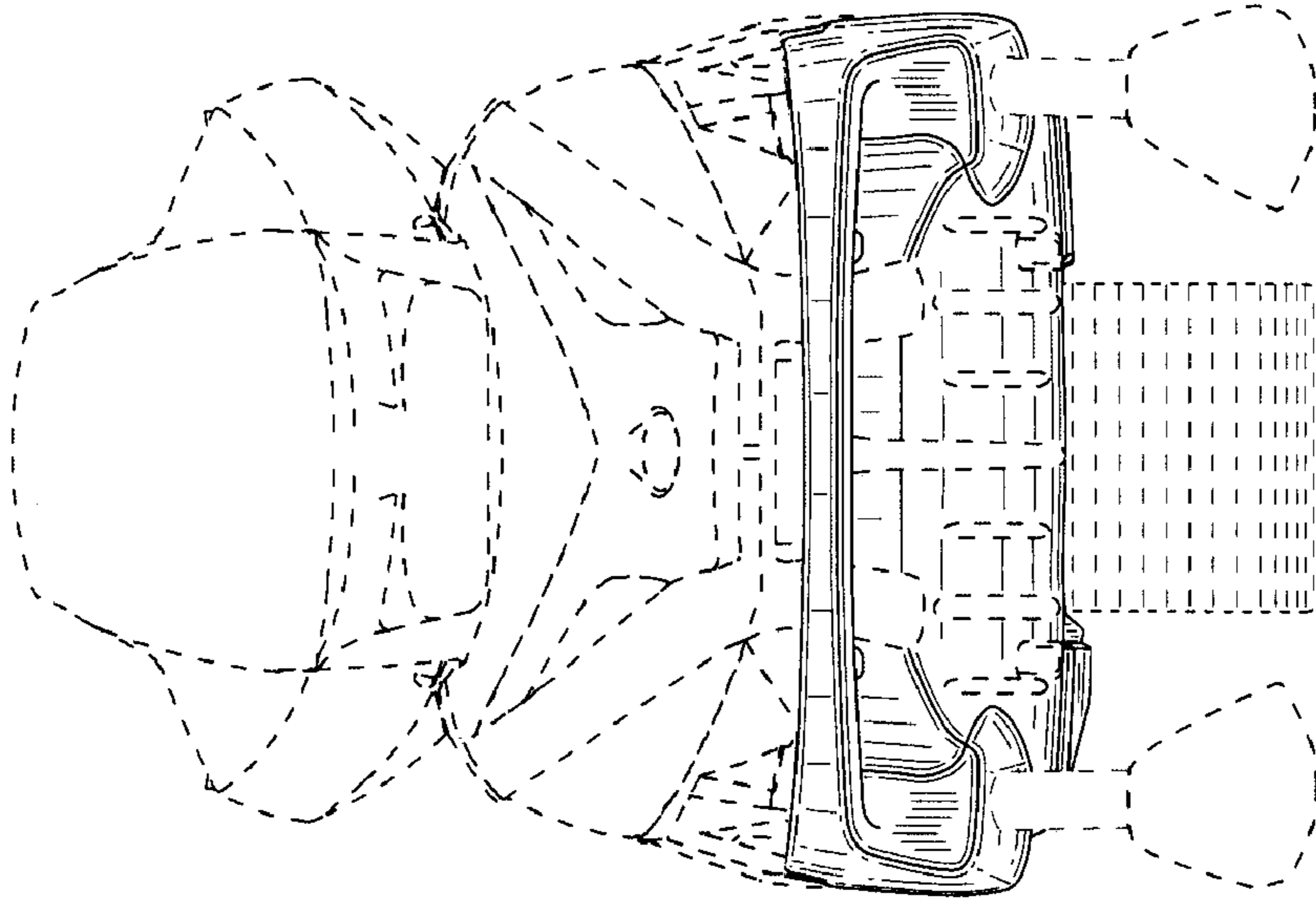

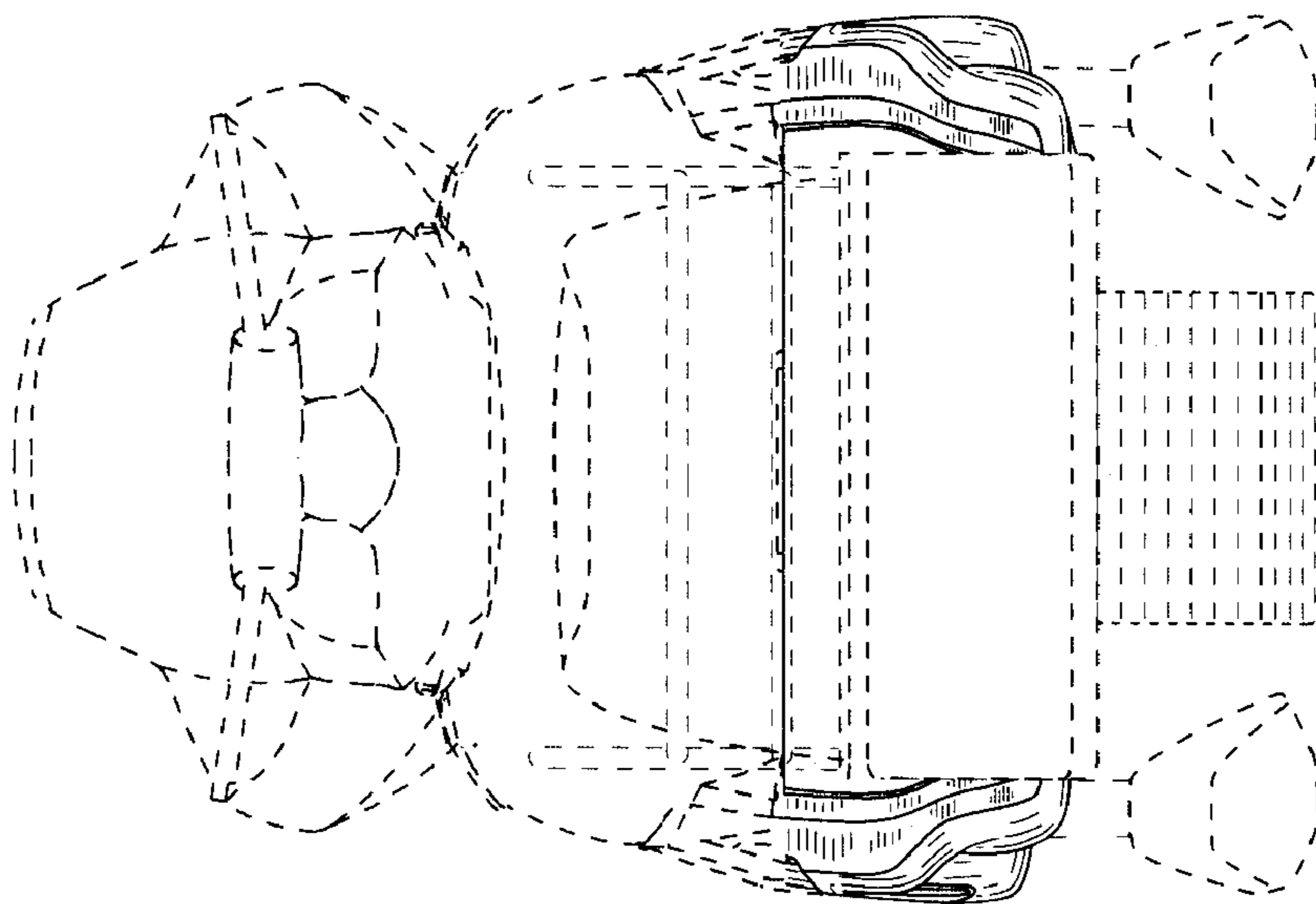

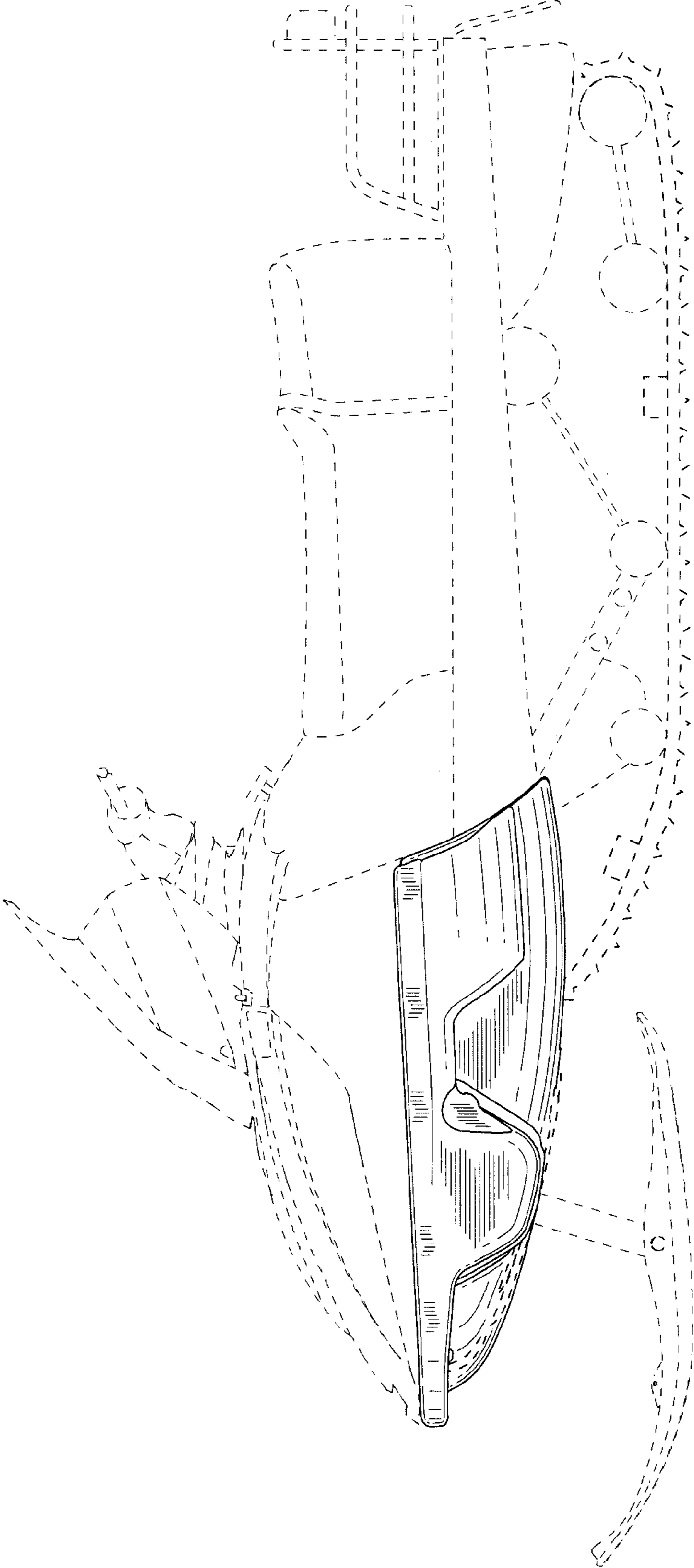

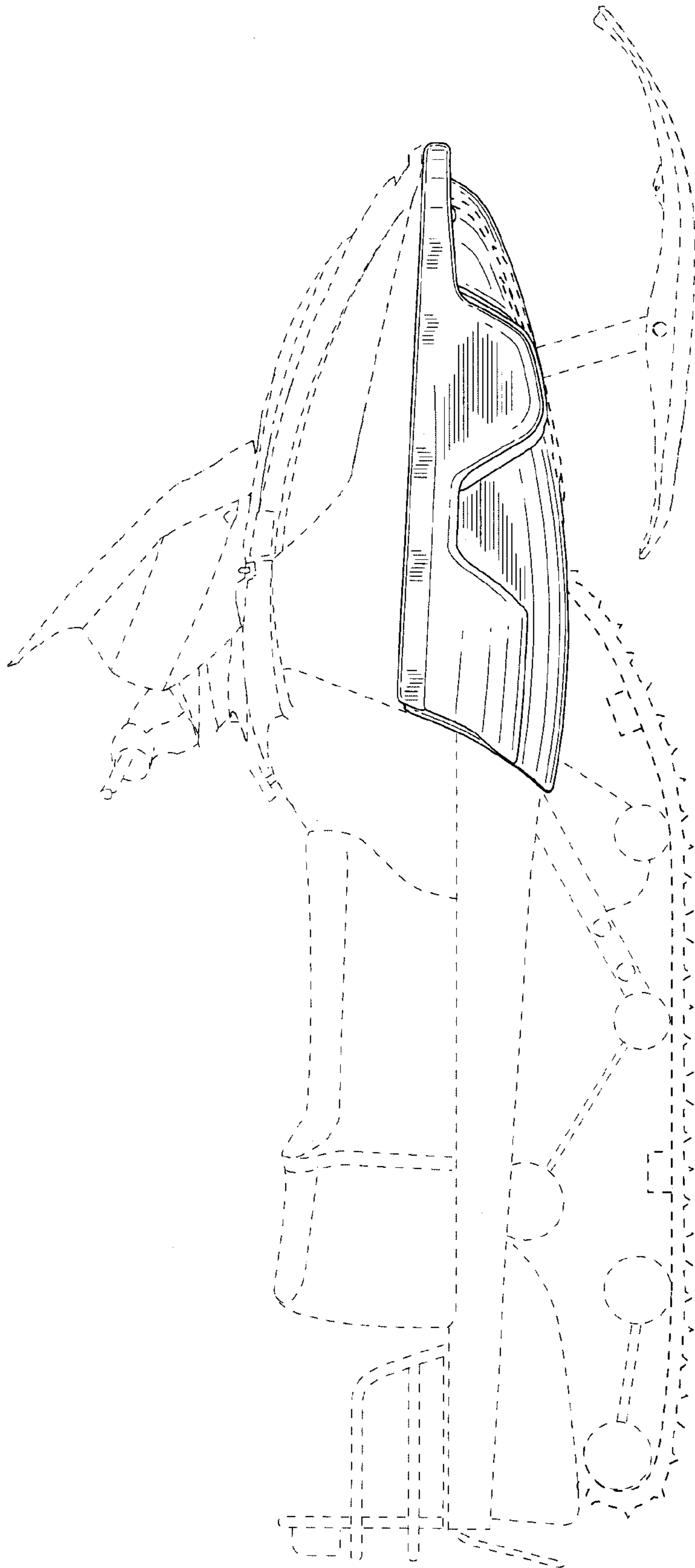
