(57) **CLAIM**

I claim the ornamental design for a radiator for a chipset of a graphic card, as shown and described in the drawings.

**DESCRIPTION**

FIG. 1 is a front perspective view of a radiator for a chipset of a graphic card in accordance with the new design;

FIG. 2 is a front view of the radiator for a chipset of a graphic card of FIG. 1;

FIG. 3 is a rear view of the radiator for a chipset of a graphic card of FIG. 1;

FIG. 4 is a left side view of the radiator for a chipset of a graphic card of FIG. 1;

FIG. 5 is a right side view of the radiator for a chipset of a graphic card of FIG. 1;

FIG. 6 is a top plan view of the radiator for a chipset of a graphic card of FIG. 1;

FIG. 7 is a bottom plan view of the radiator for a chipset of a graphic card of FIG. 1; and,

FIG. 8 is a perspective view illustrating use of the radiator for a chipset of a graphic card.

The broken lines in FIG. 6 indicated environmental elements (e.g., a graphic card) for illustrative purposes only and form no part of the claimed design.

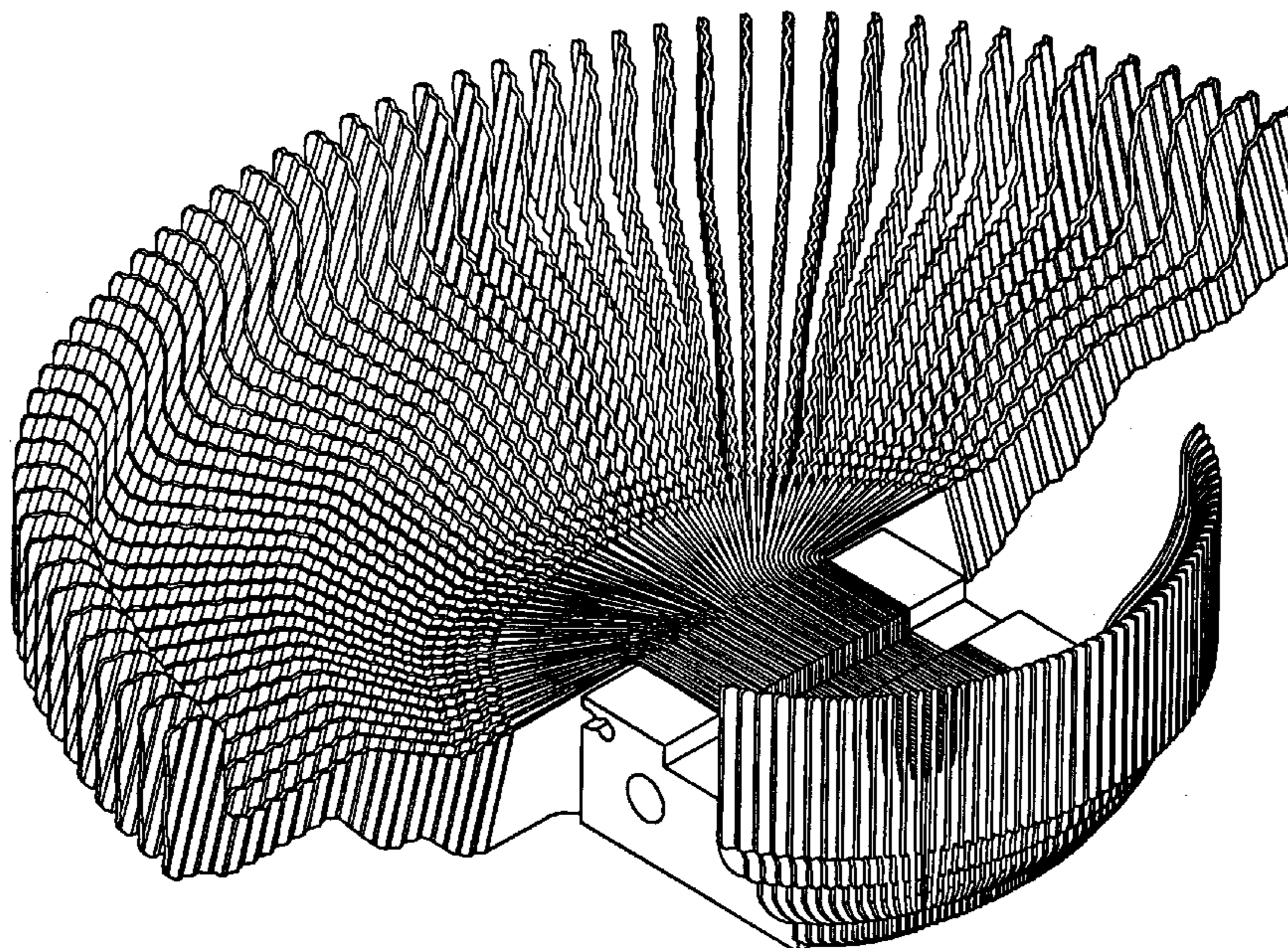

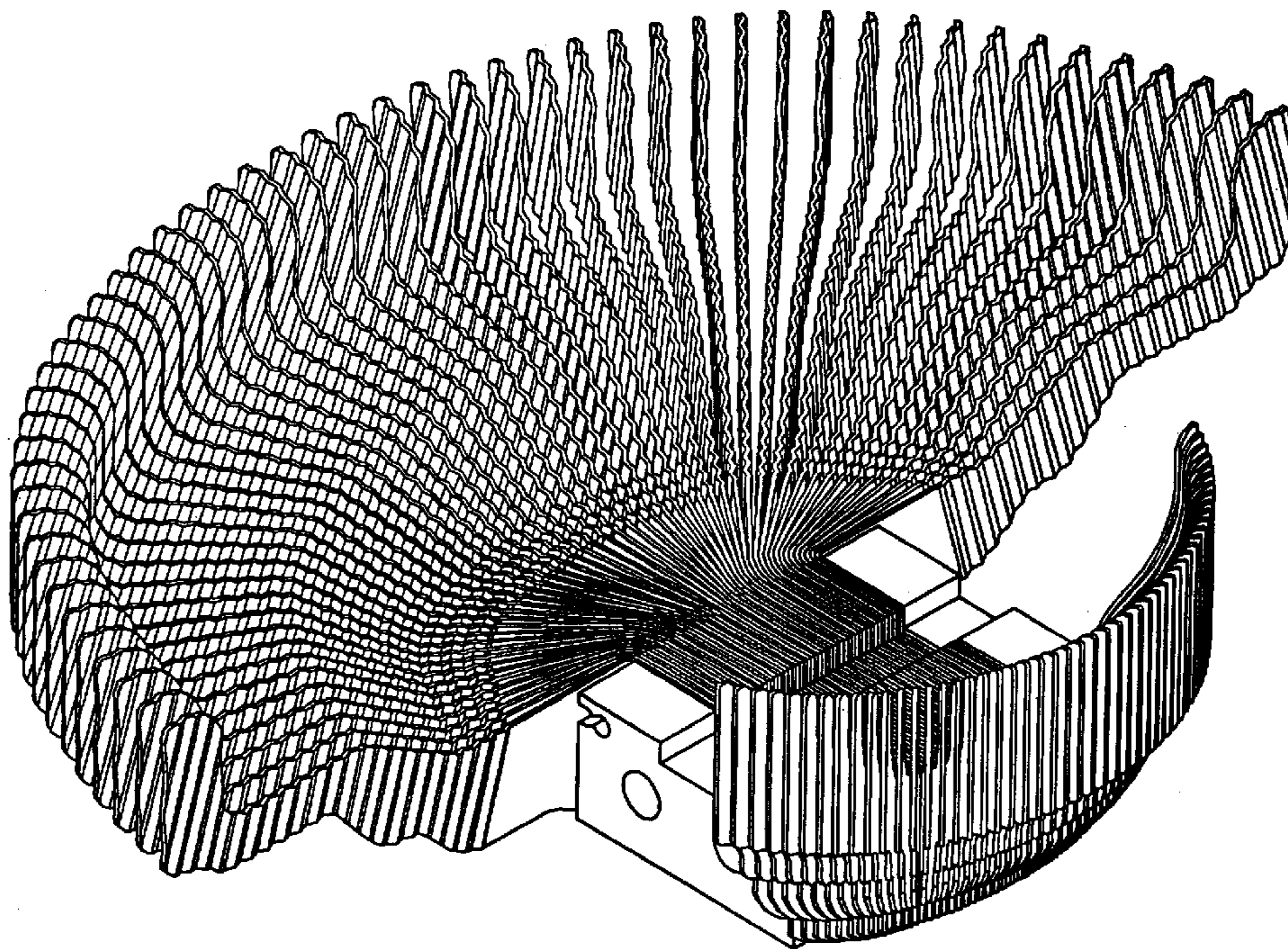

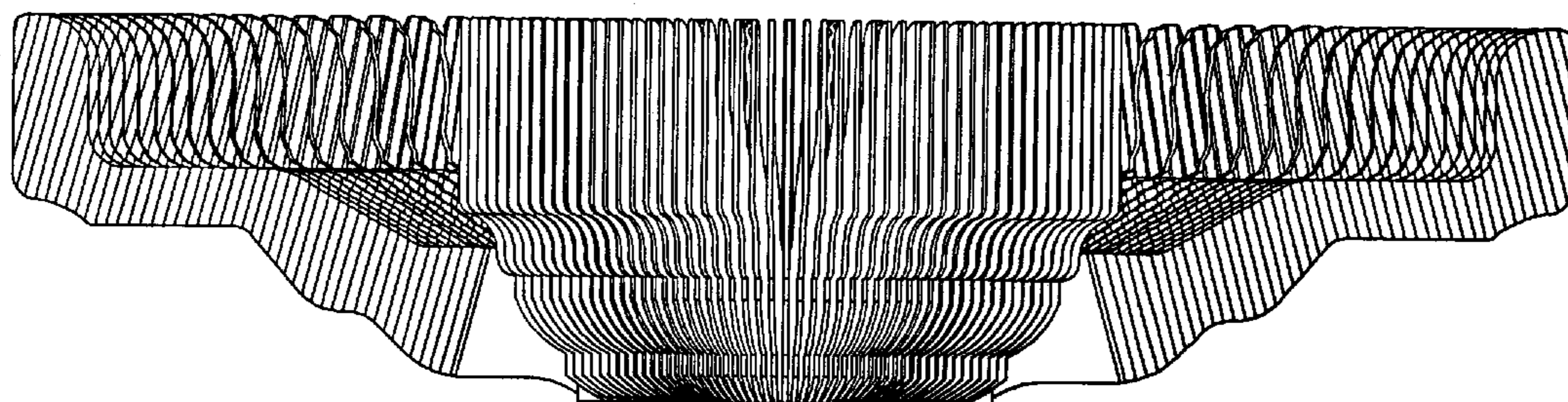

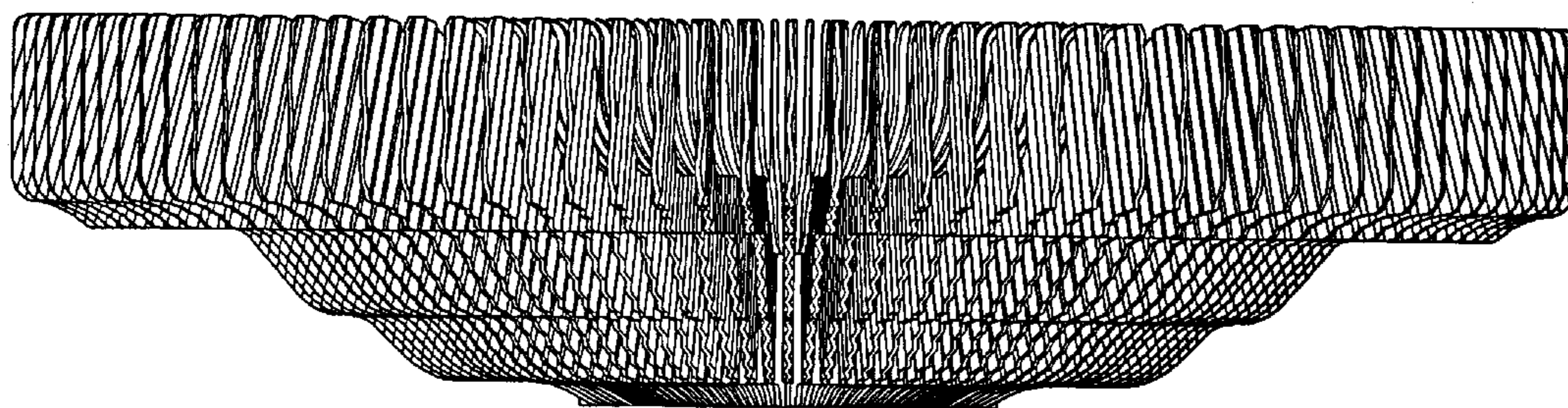

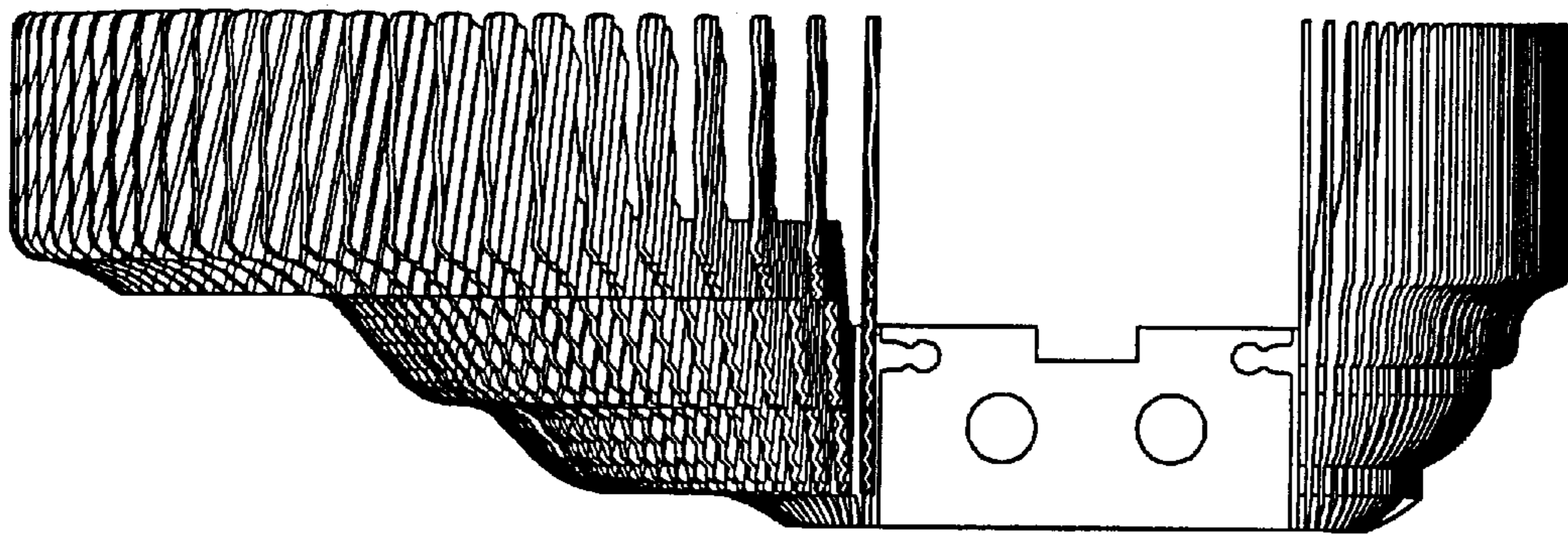

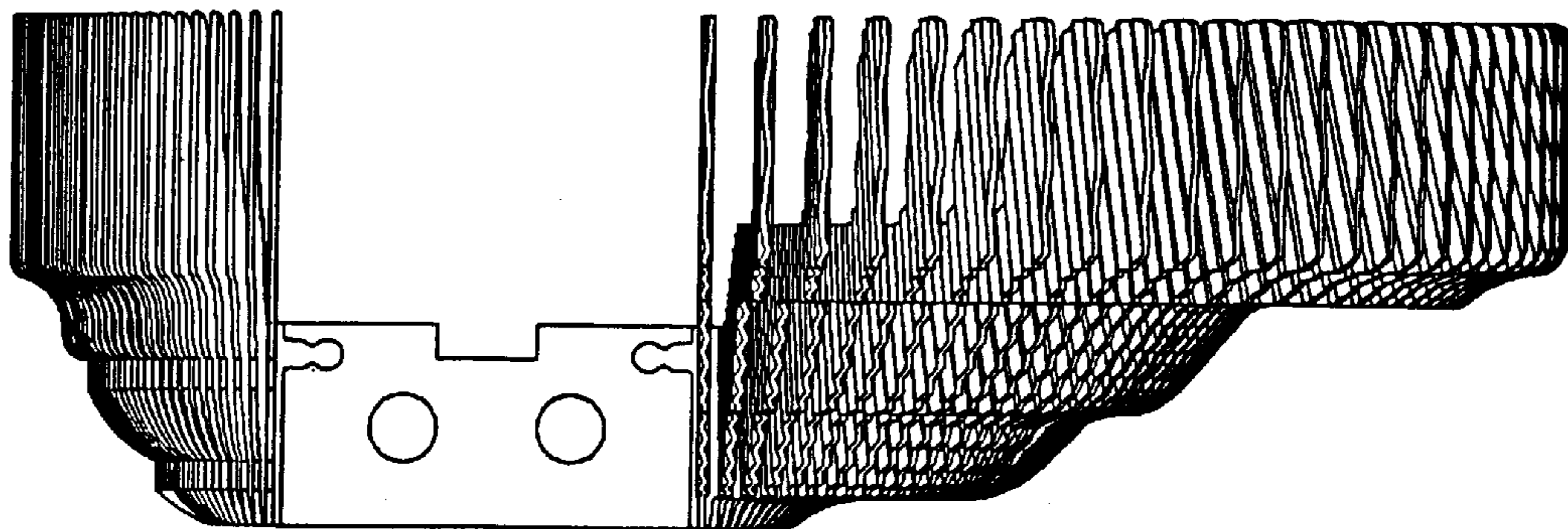

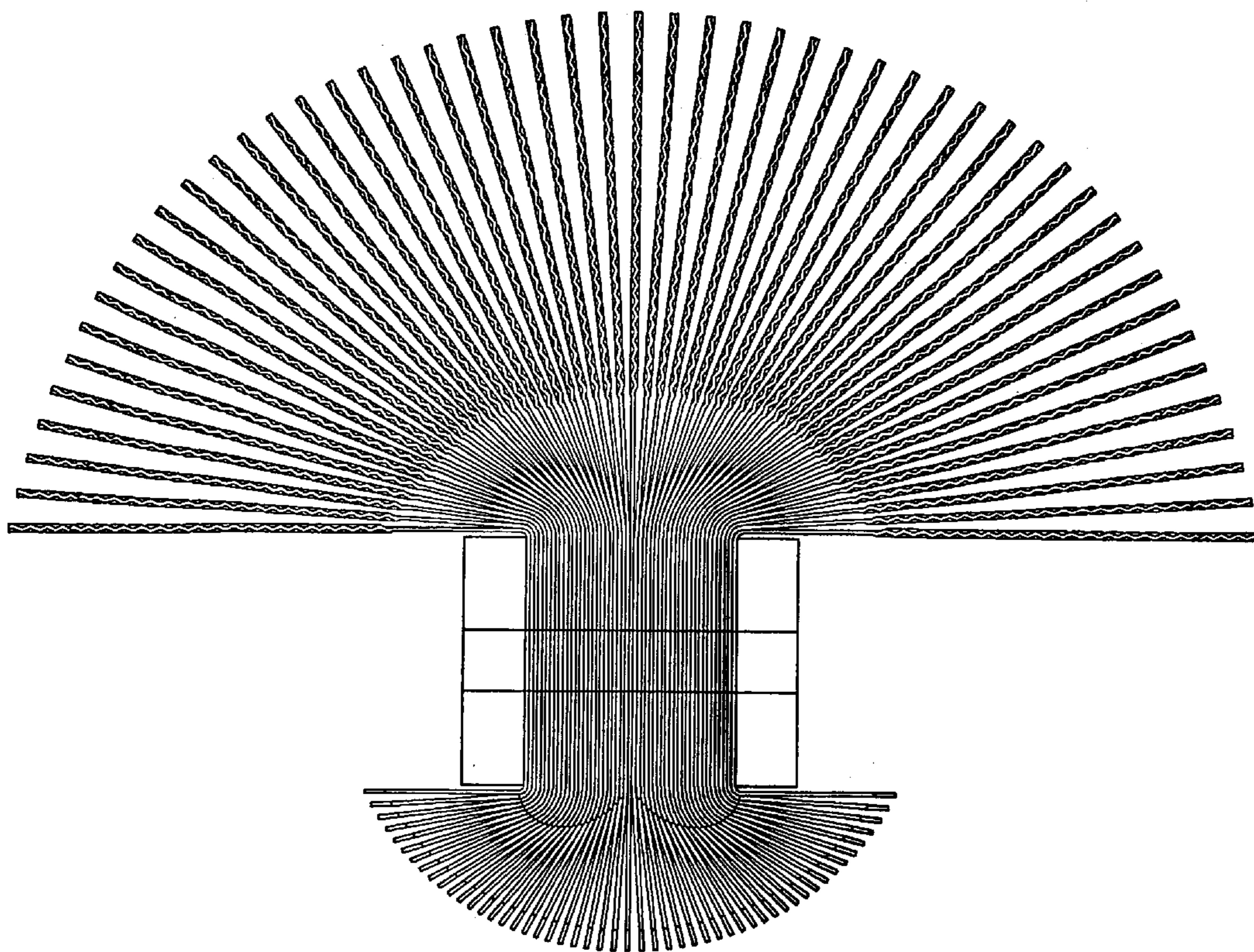

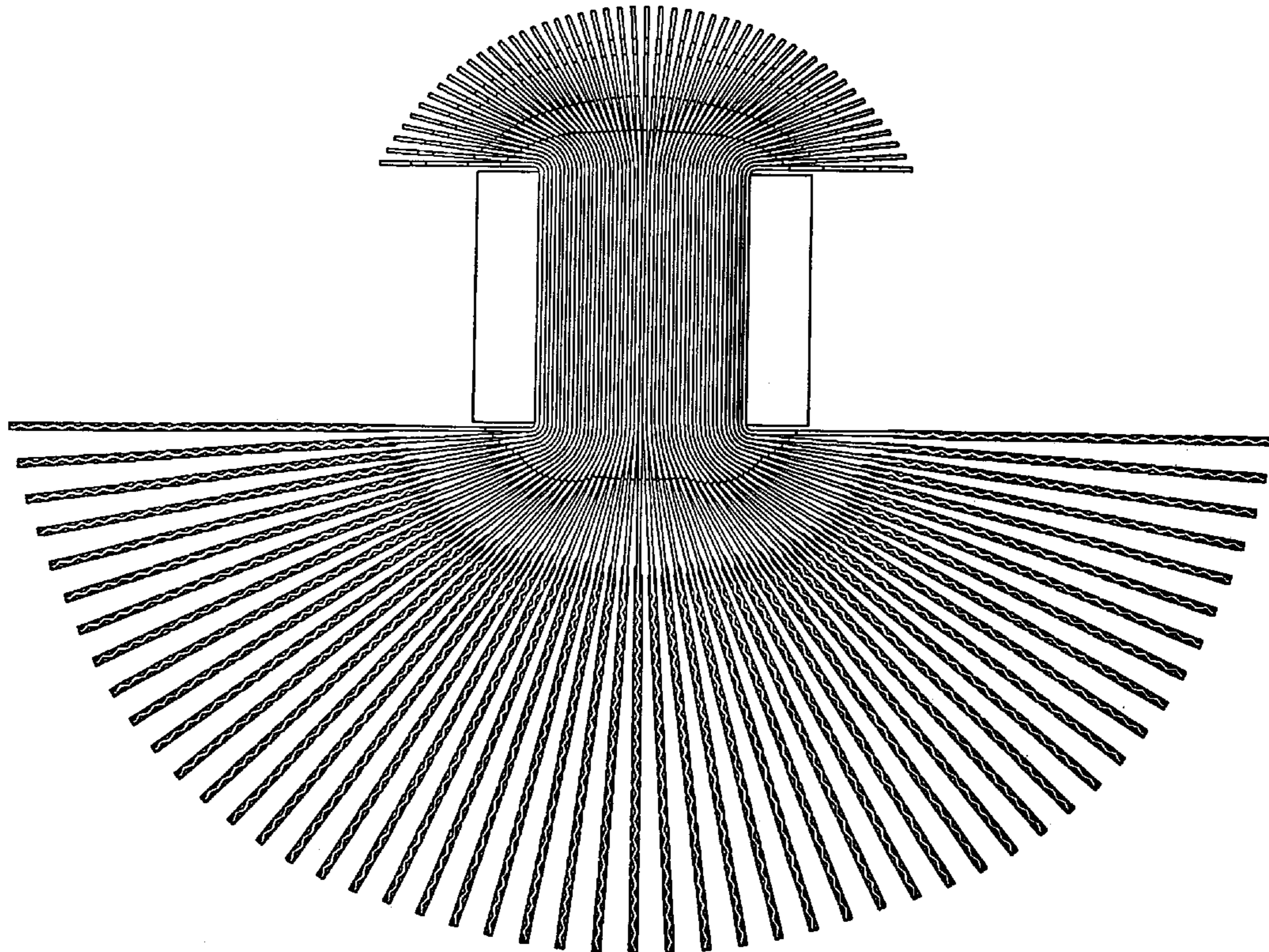
