FIG. 3 is a left sided view thereof;

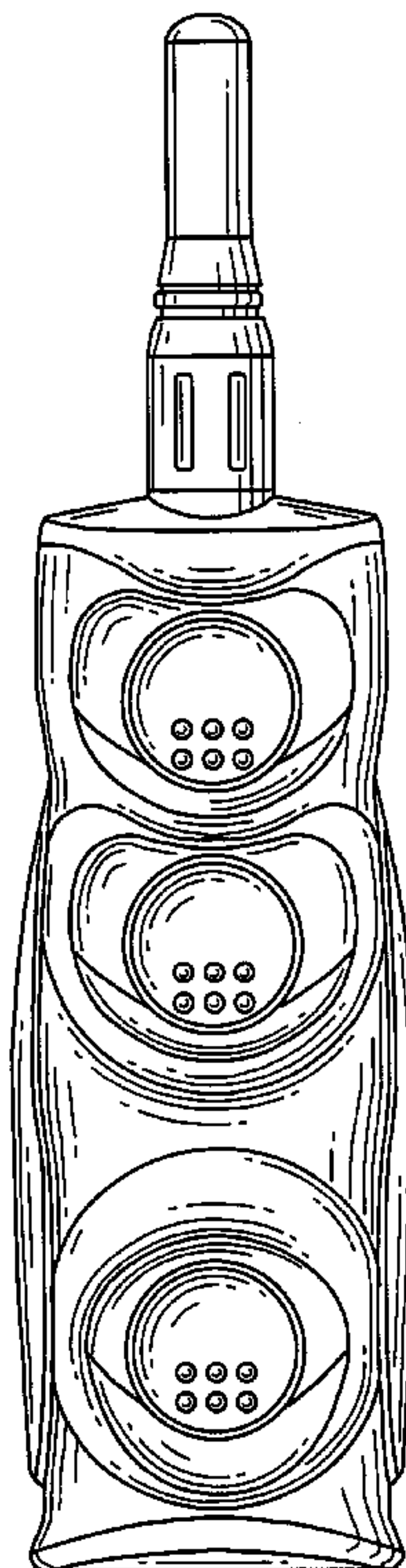
FIG. 4 is a back view thereof; and

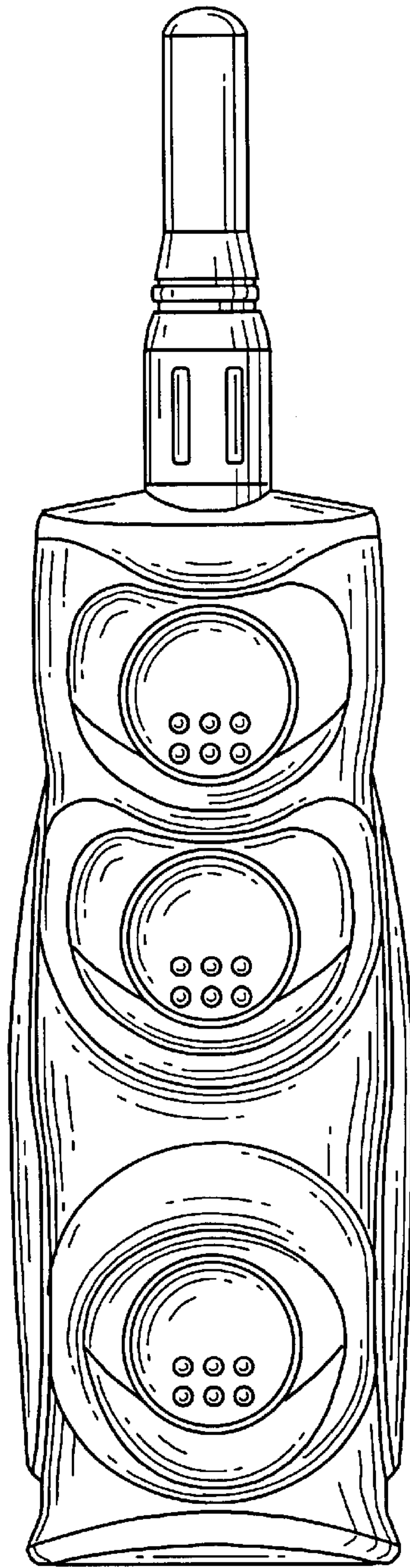

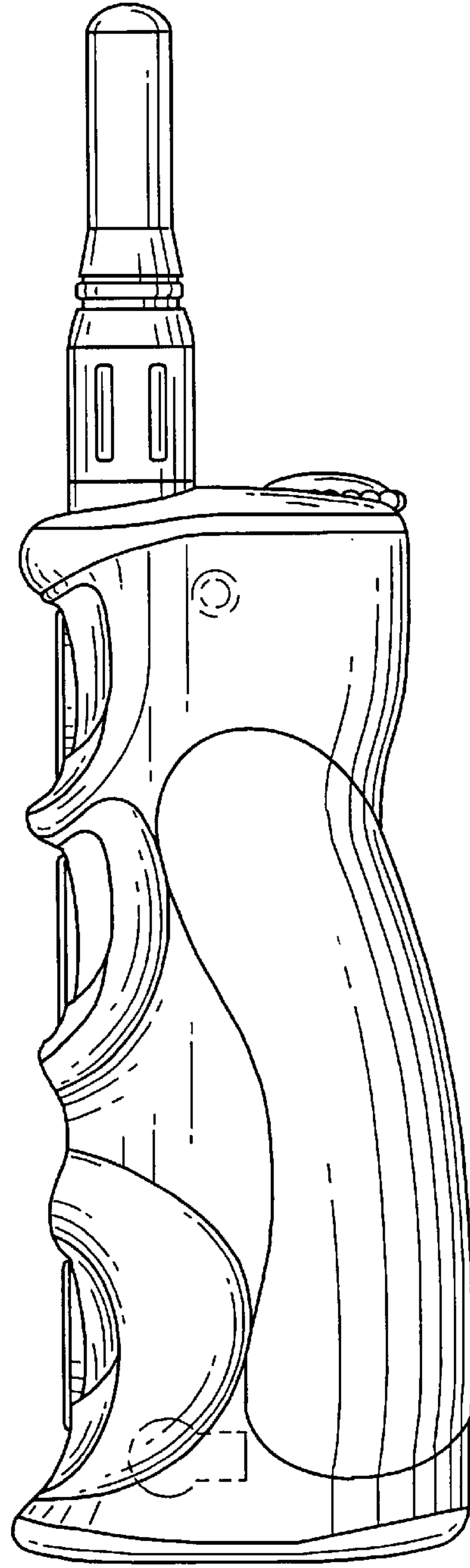

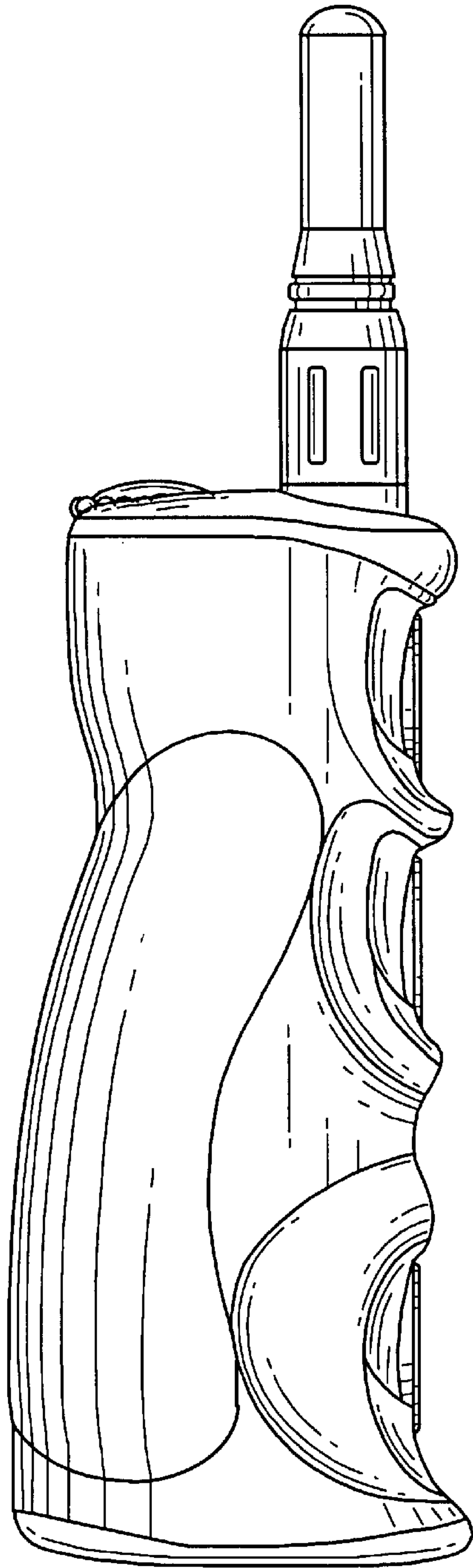

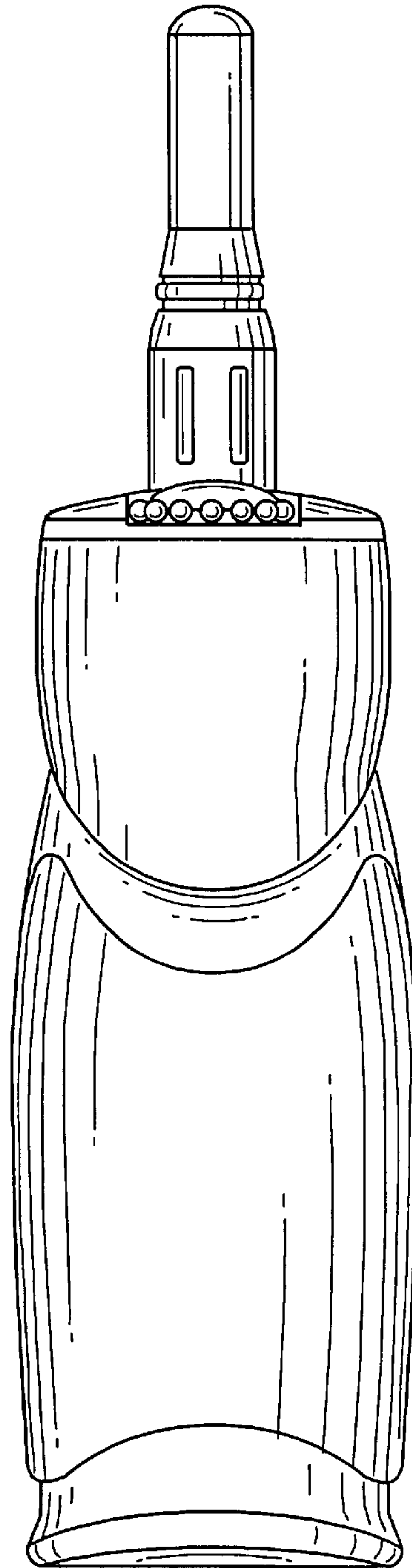

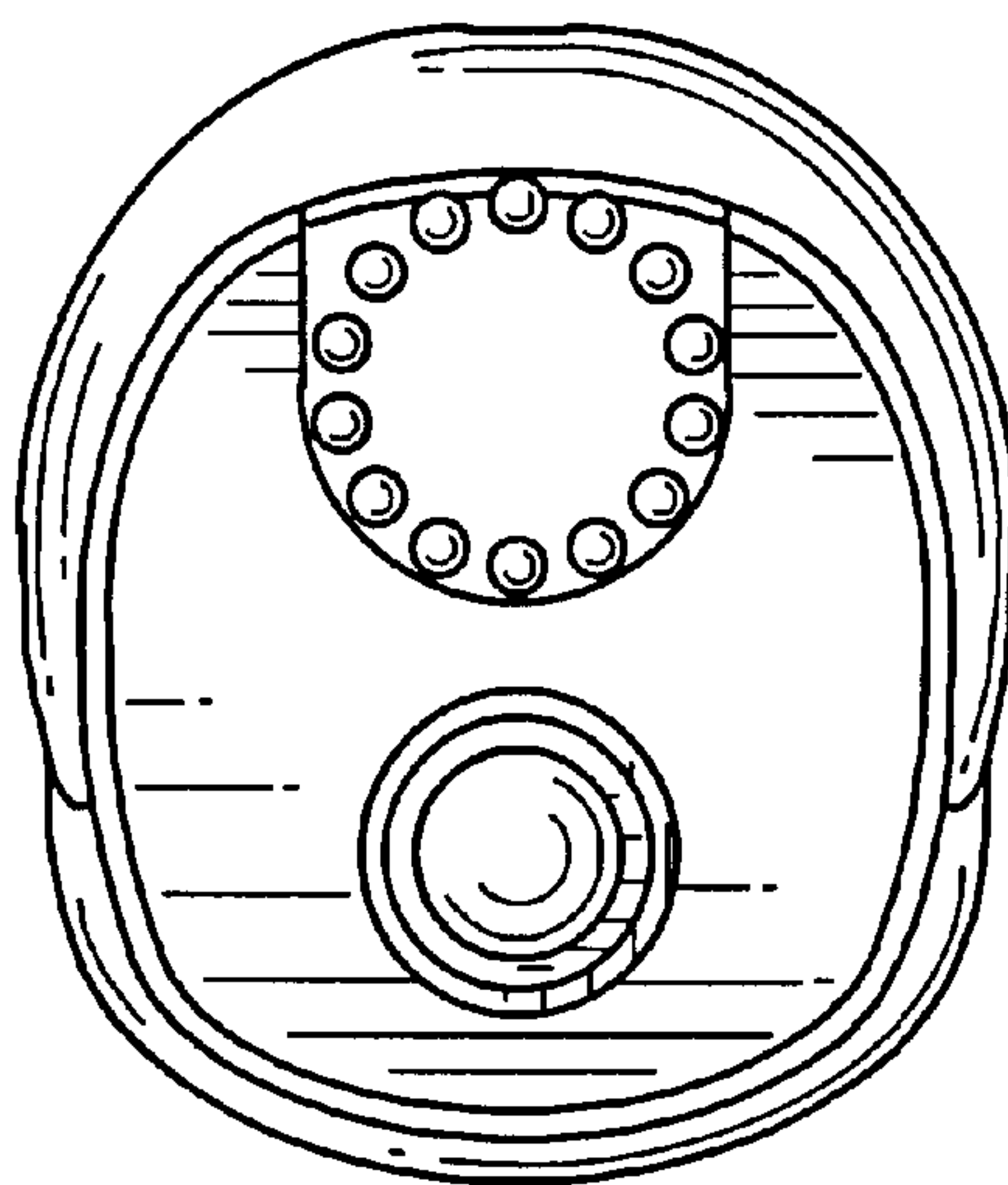

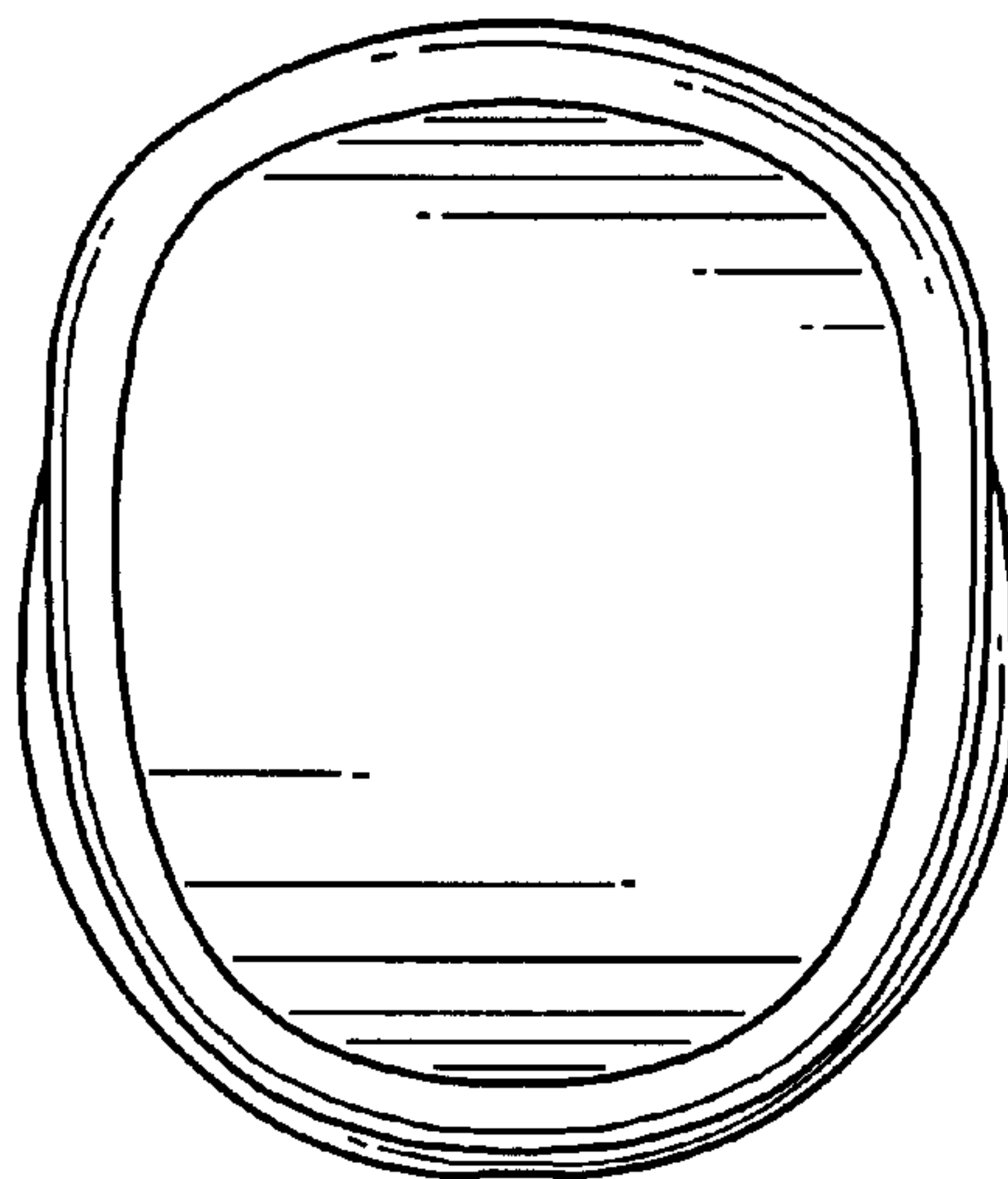
