(57) **CLAIM**

We claim the ornamental design for a reinforcement member for optical storage media, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a reinforcement member for optical storage media of the present invention; and, FIG. 2 is a top view thereof in a closed position.

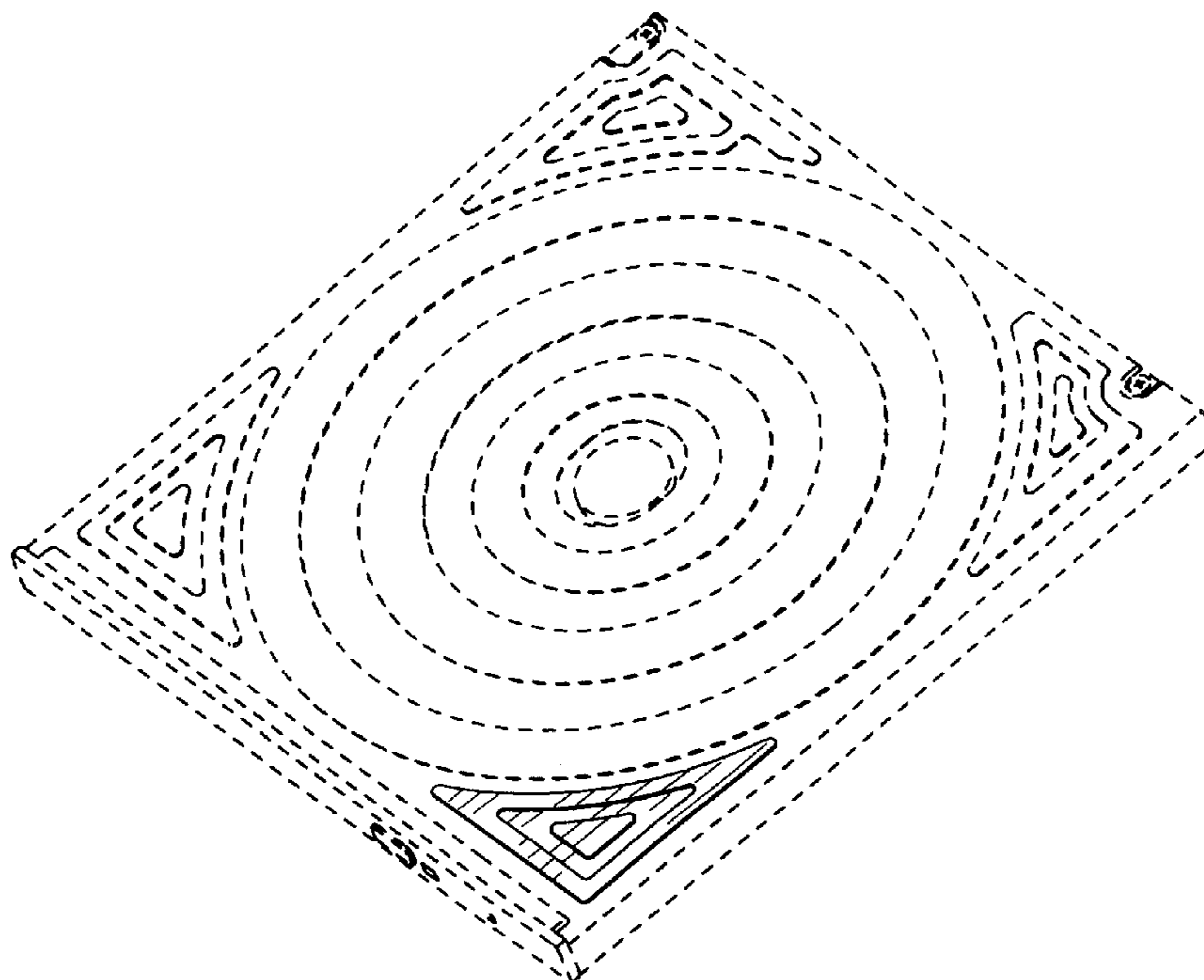

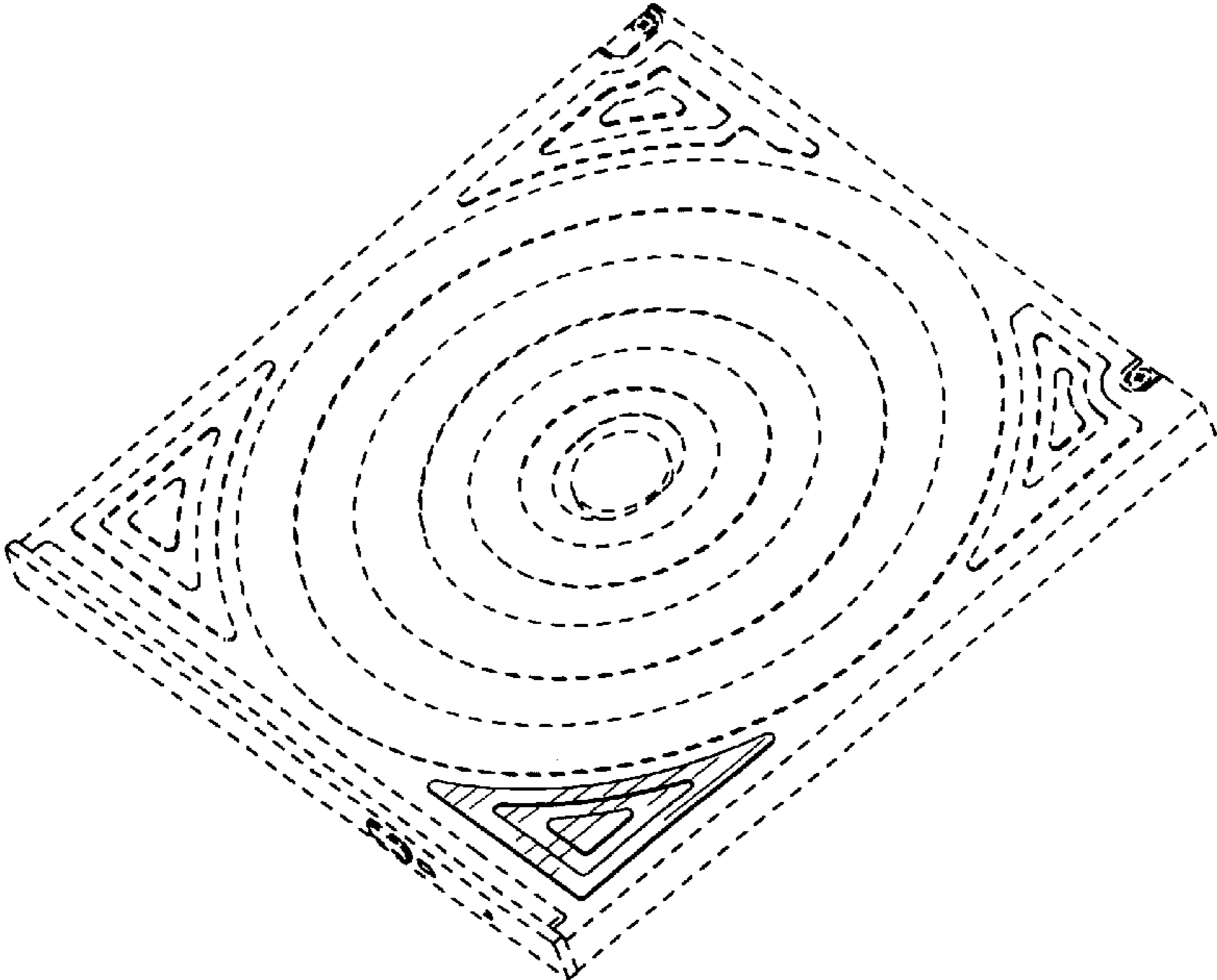
