(57) **CLAIM**

I claim the ornamental design for an air deodorizer holder,
as shown.

DESCRIPTION

FIG. 1 is a perspective view of an air deodorizer holder
comprising the present invention.

FIG. 2 is another perspective view of the air deodorizer
holder shown in FIG. 1.

FIG. 3 is a front elevational view of the air deodorizer holder
shown in FIG. 1 and FIG. 2.

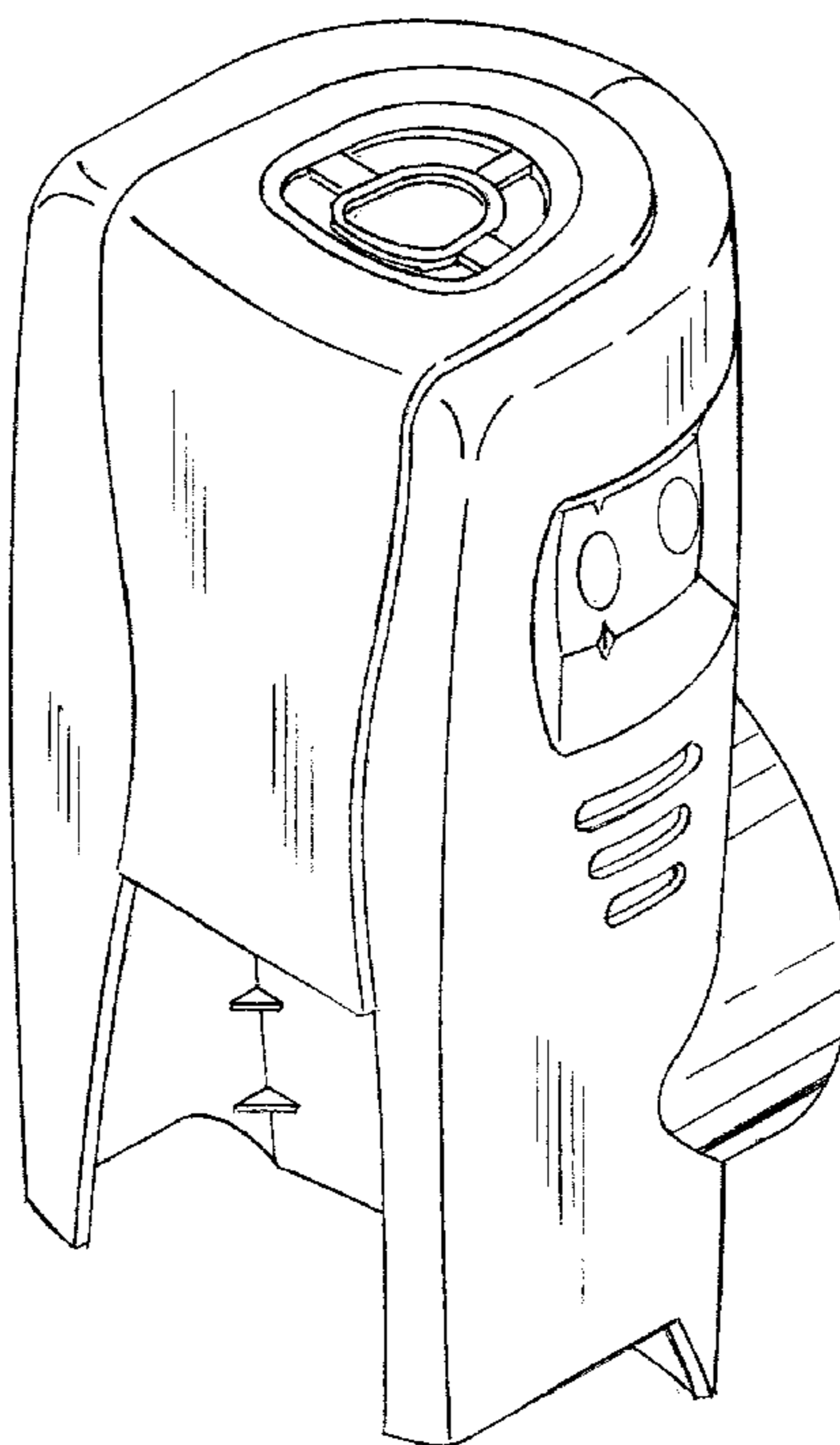
FIG. 4 is a rear elevational view of the air deodorizer holder

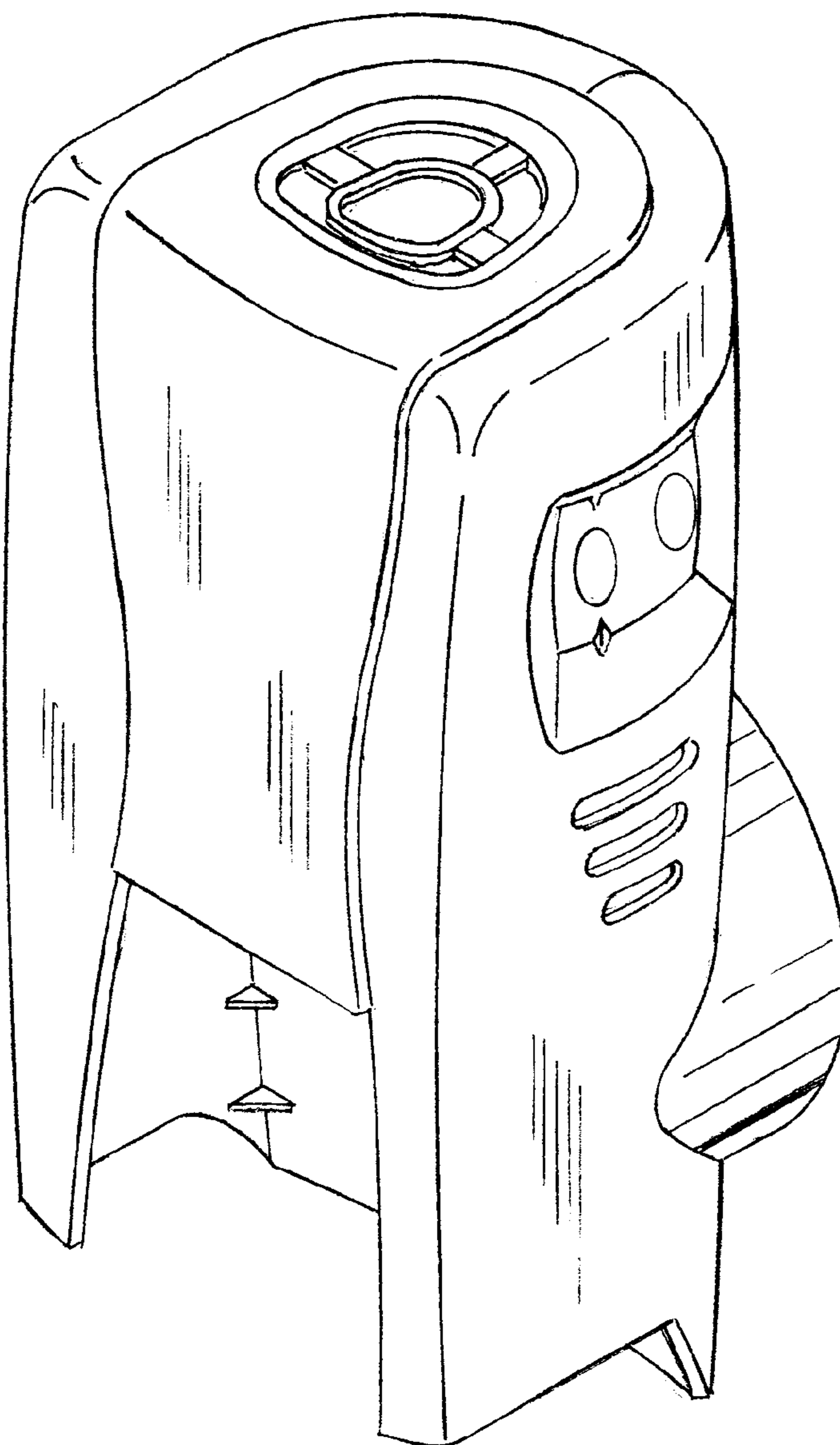

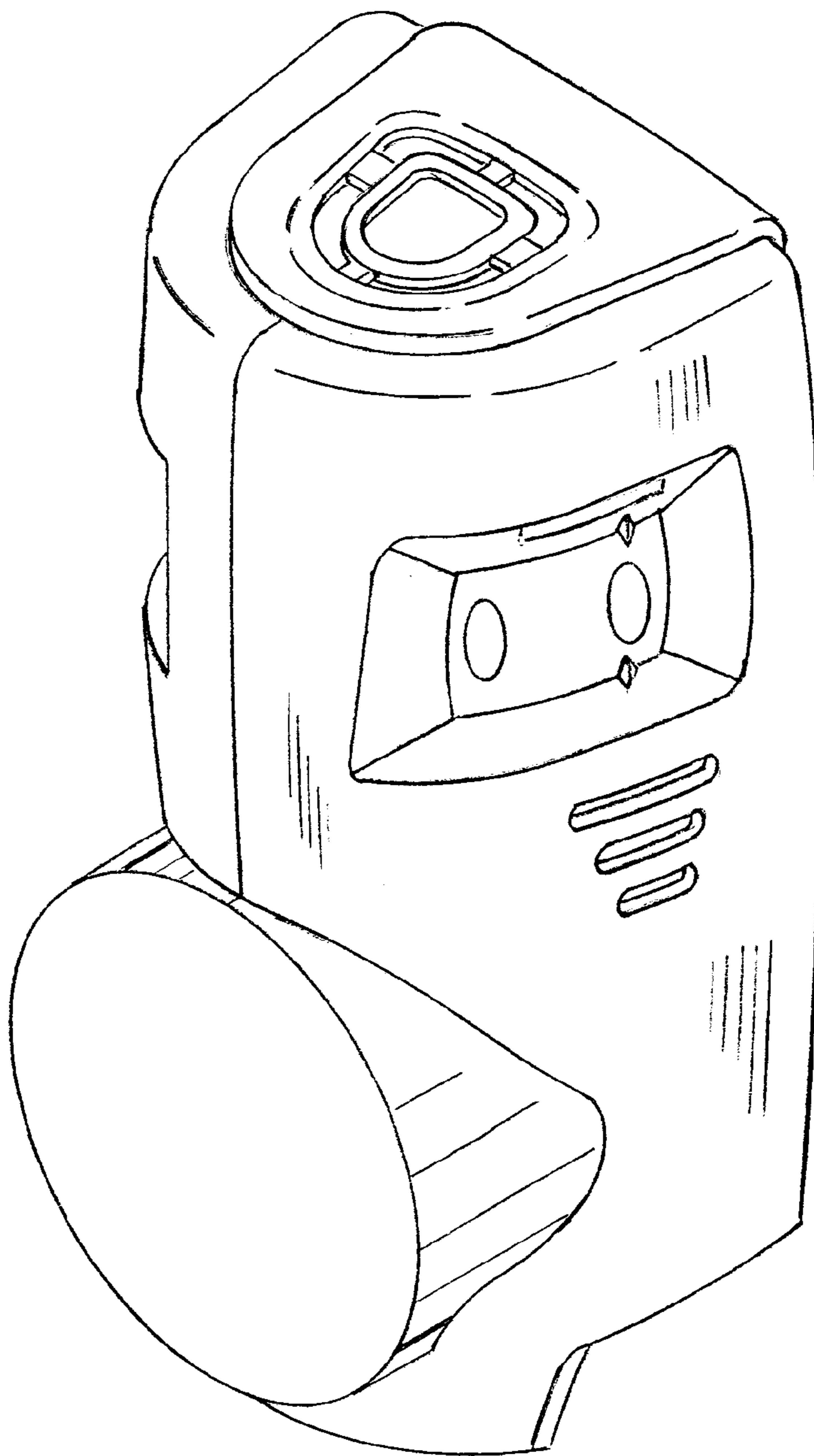

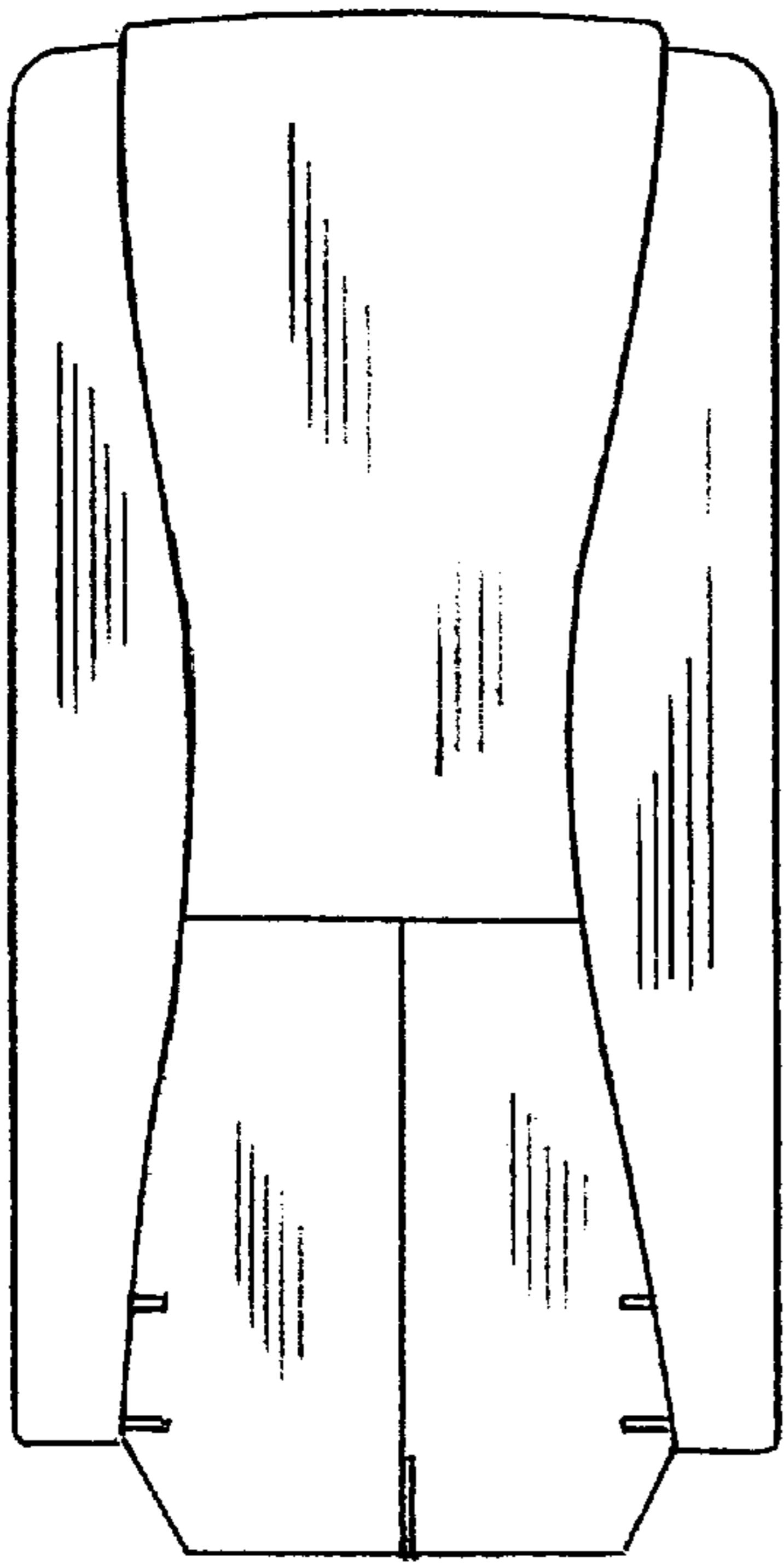

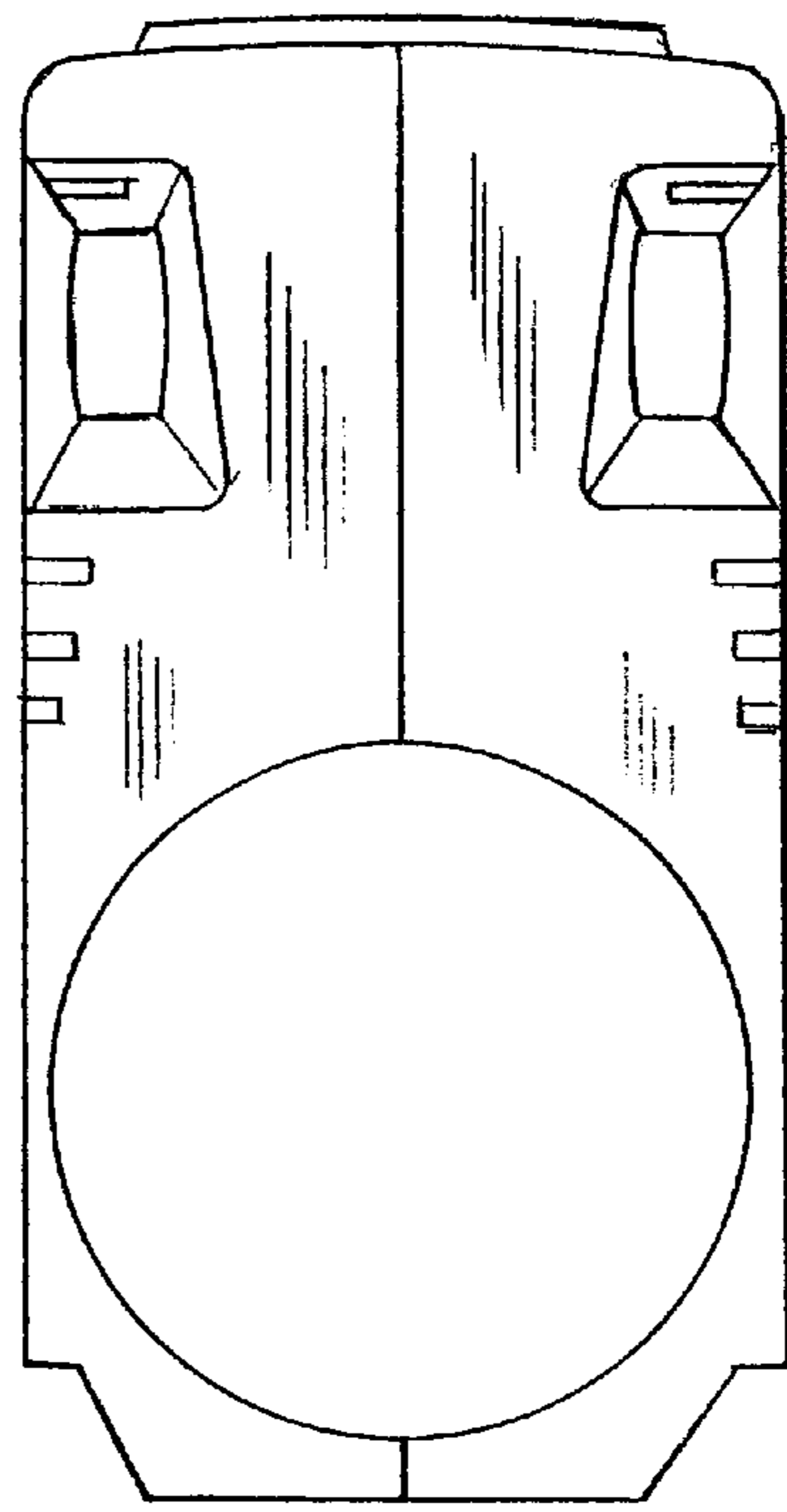

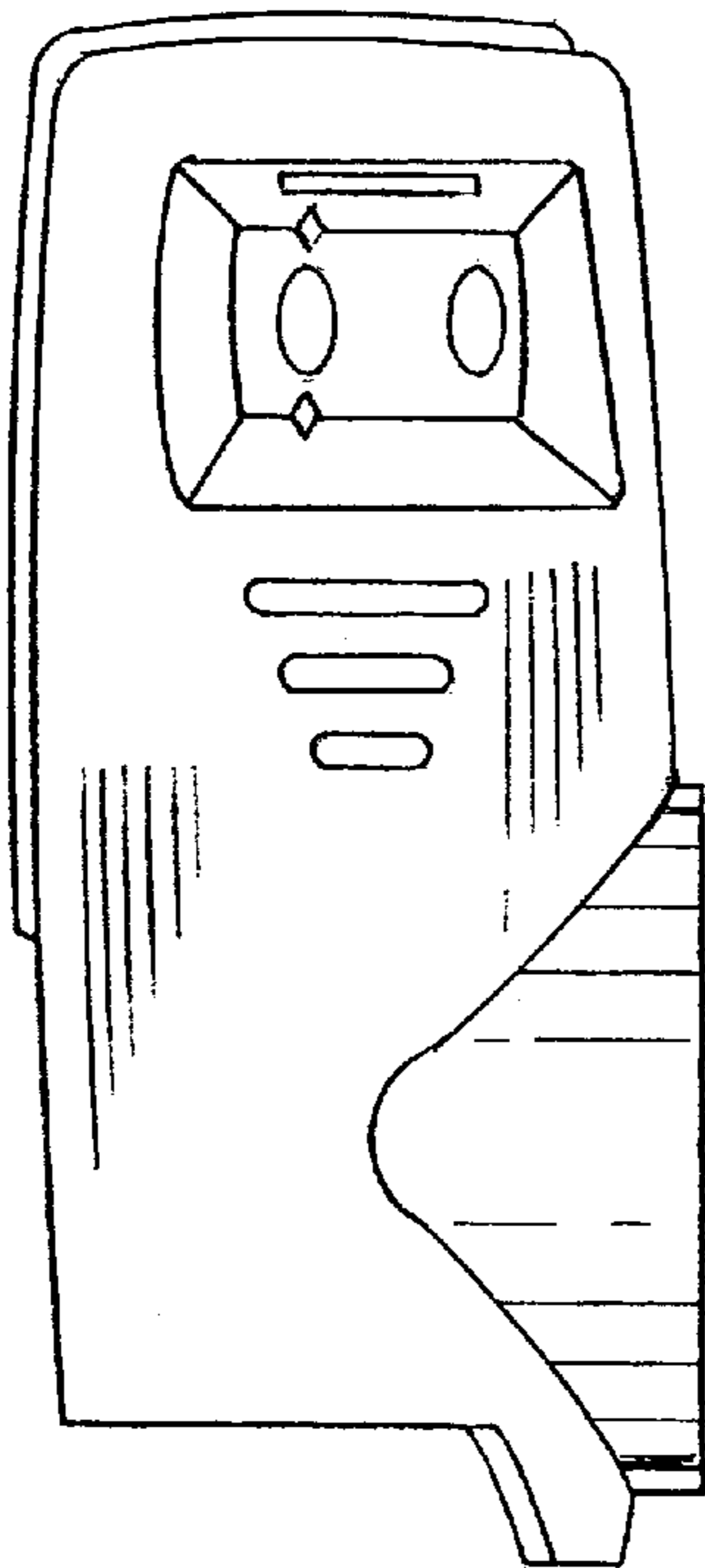

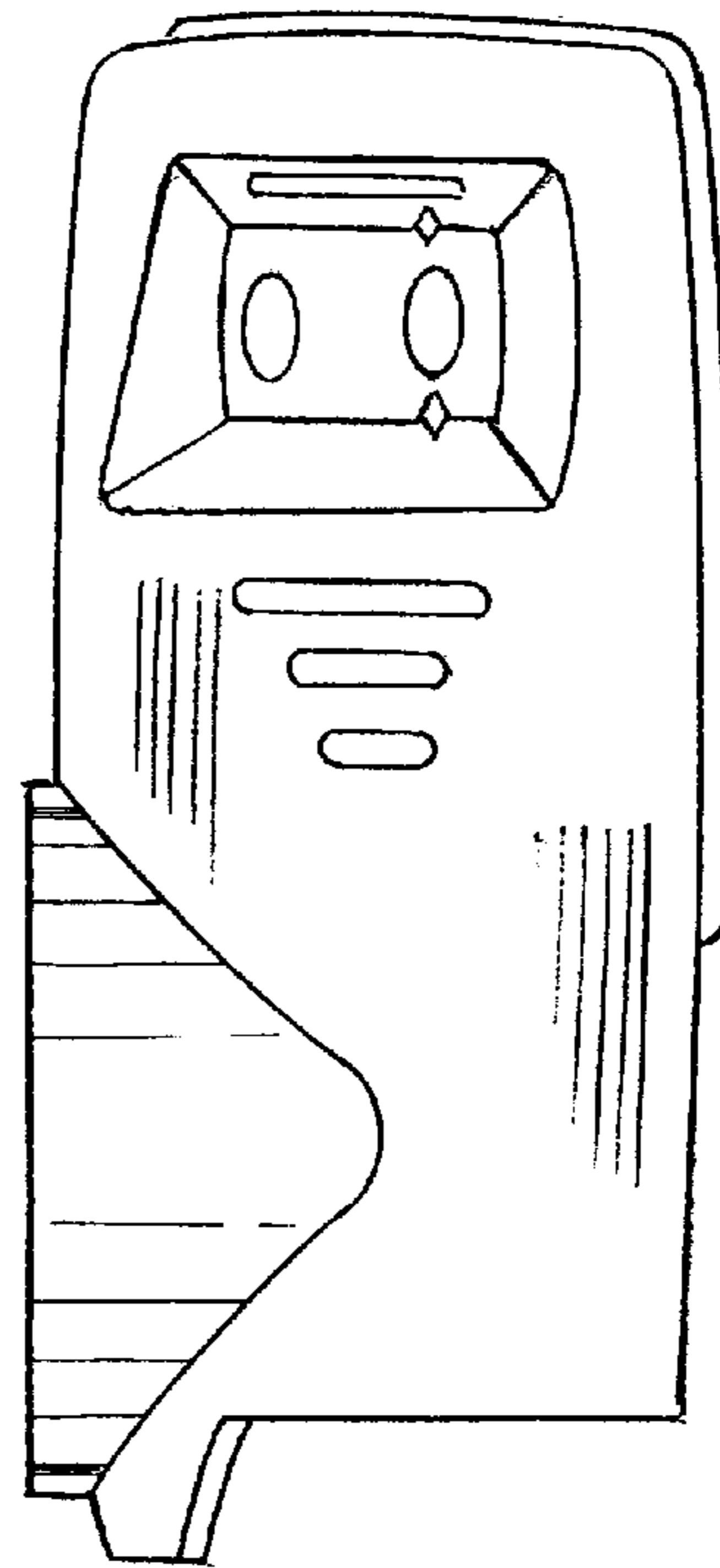

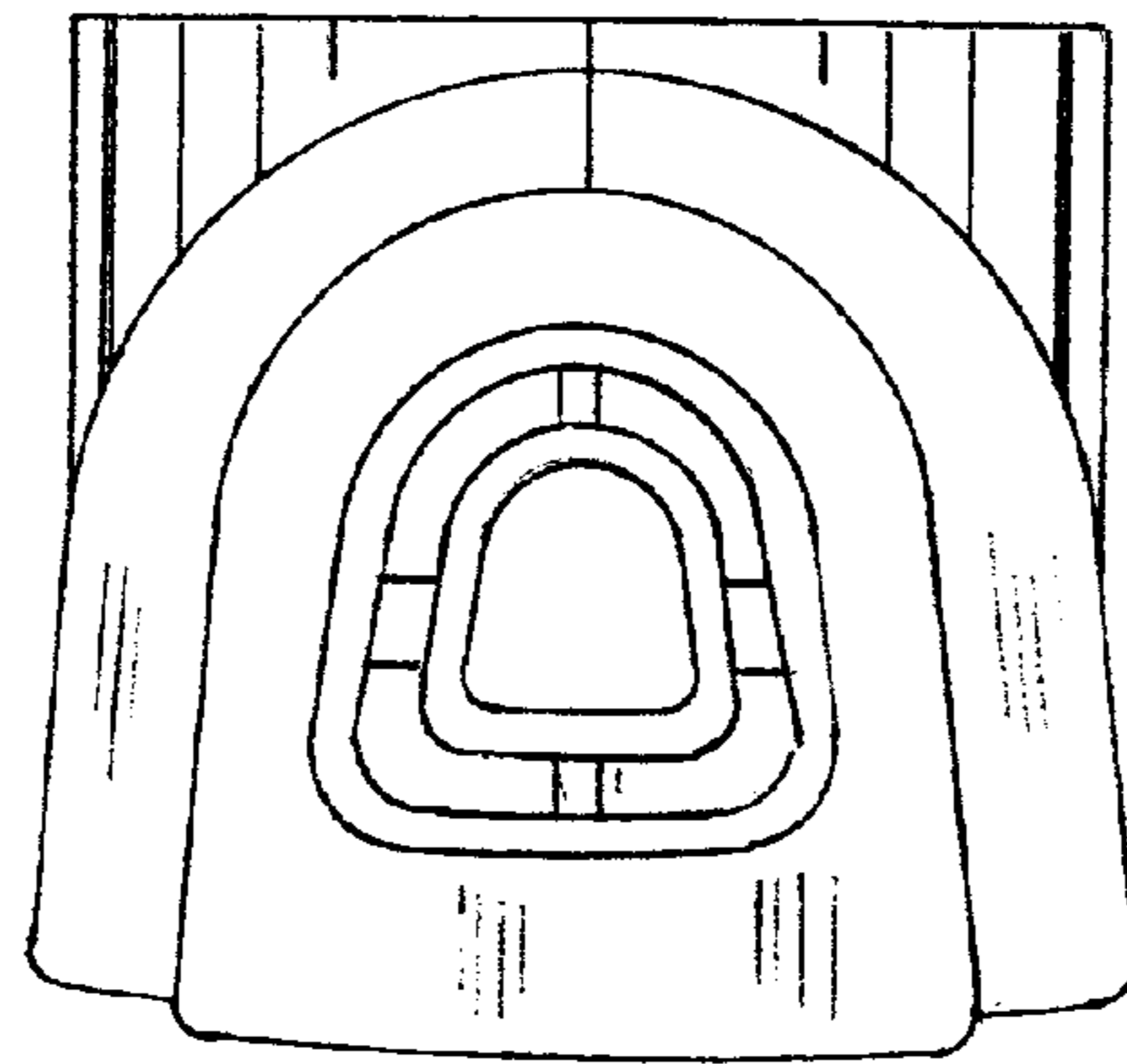

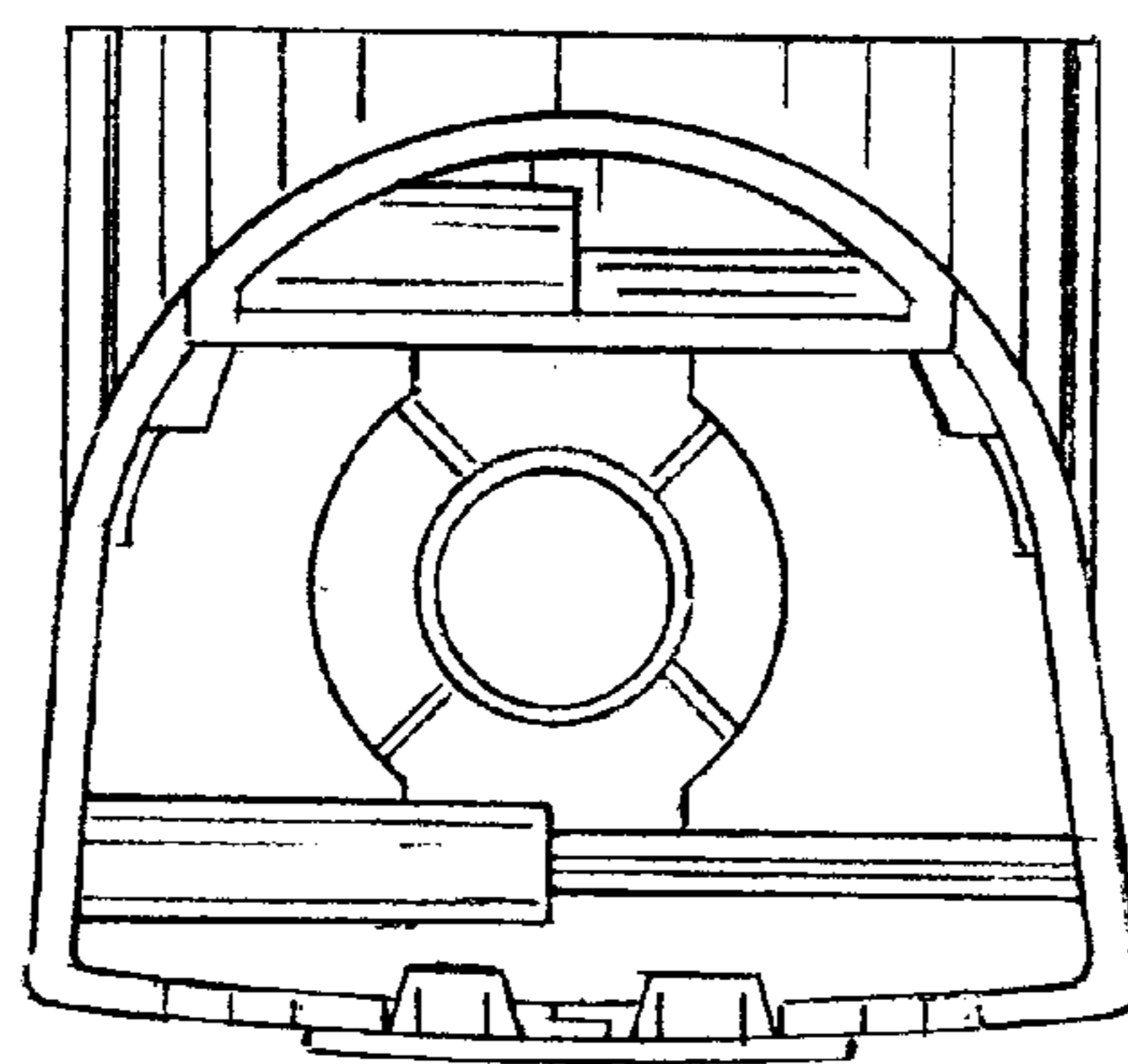
