(57) **CLAIM**

The ornamental design for a hanging pendant light, as shown and described.

DESCRIPTION

FIG. 1 is an upper front, right perspective view of the hanging pendant light showing our new design;

FIG. 2 is a lower front right perspective view thereof.

FIG. 3 is a front side view thereof.

FIG. 4 is a right side view thereof.

FIG. 5 is a rear side view thereof.

FIG. 6 is a left side view thereof.

FIG. 7 is a top view thereof; and,

FIG. 8 is a bottom view thereof.

The broken lines showing of a hanging chain and ceiling mount cap in FIGS. 1-8 are for illustrative purposes only and form no part of the claimed design.

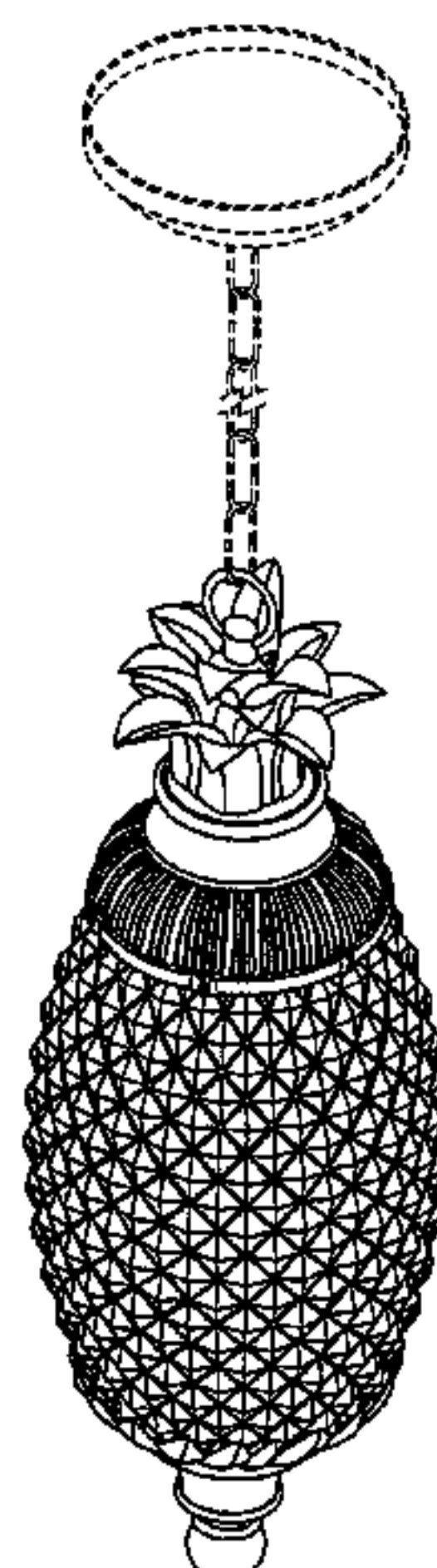

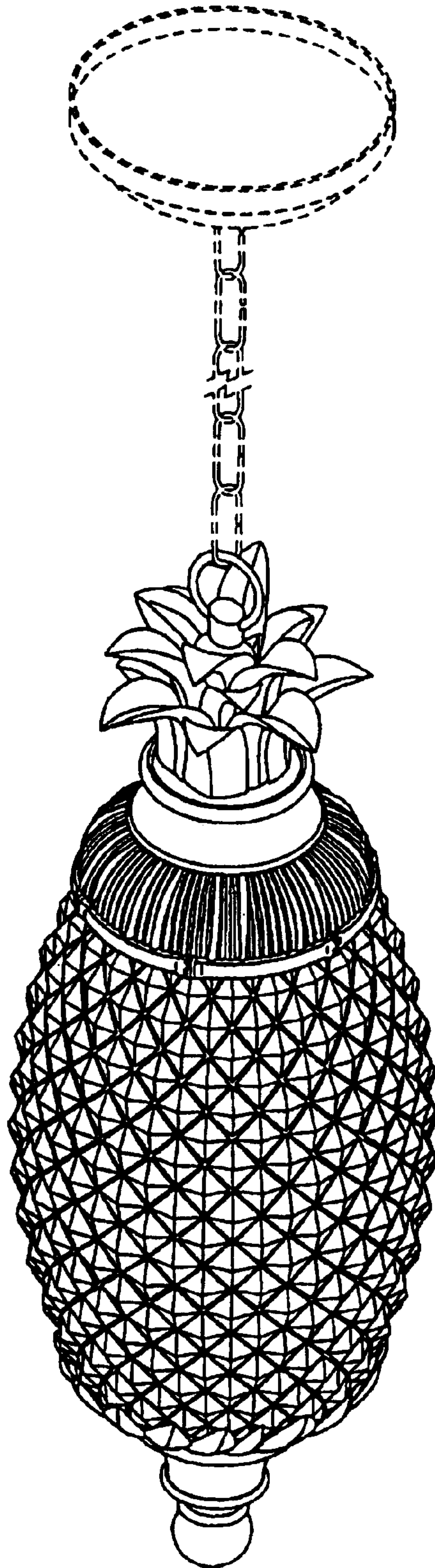

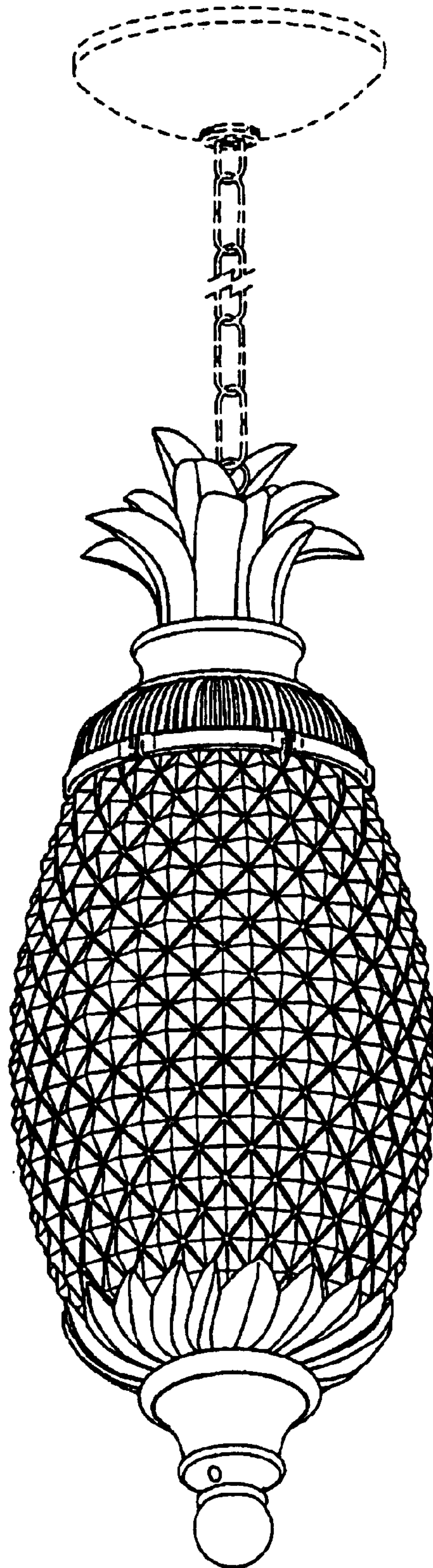

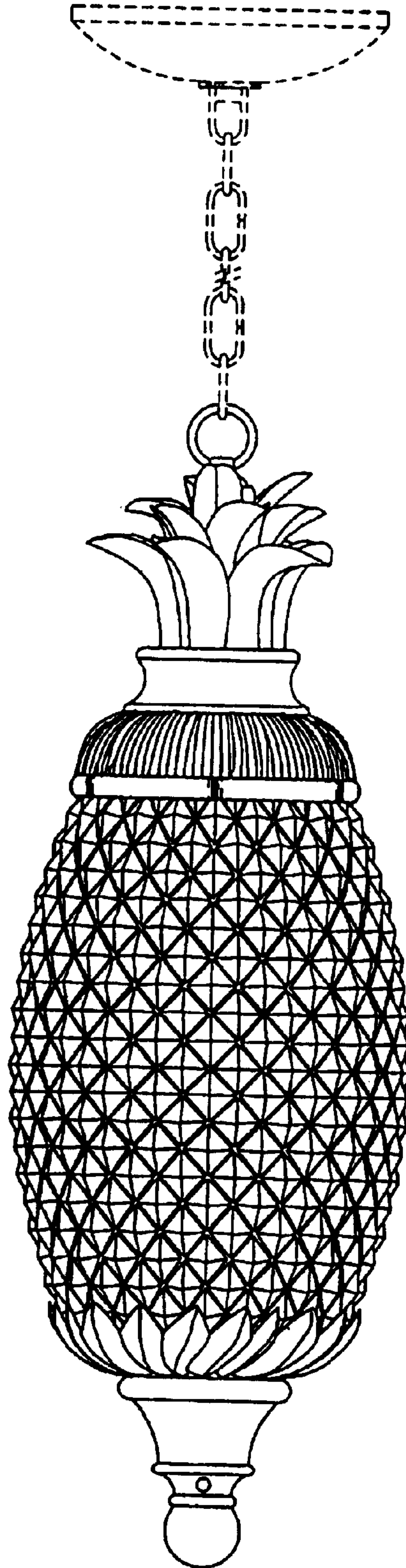

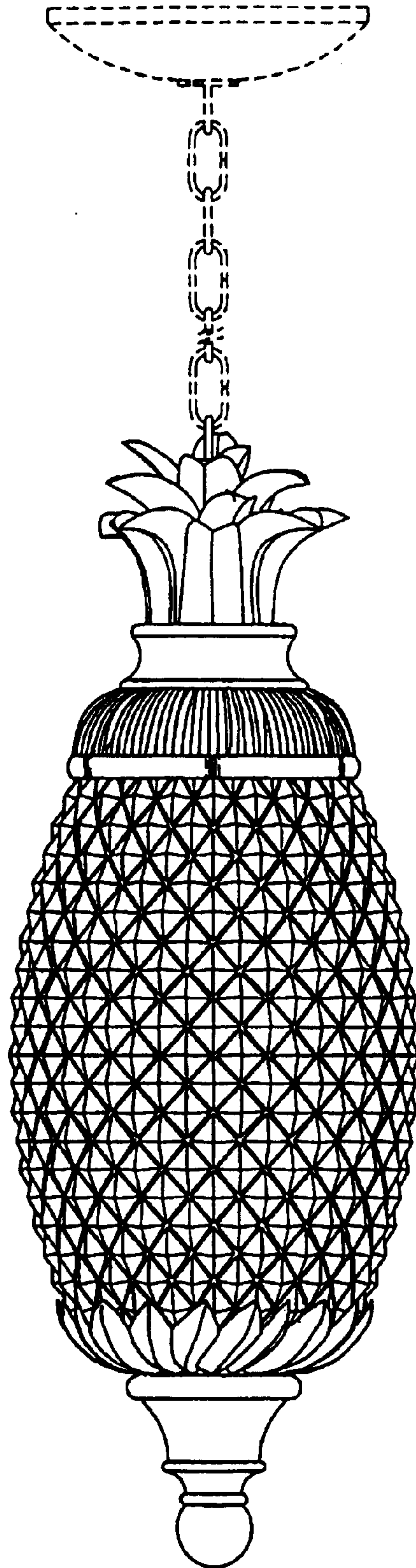

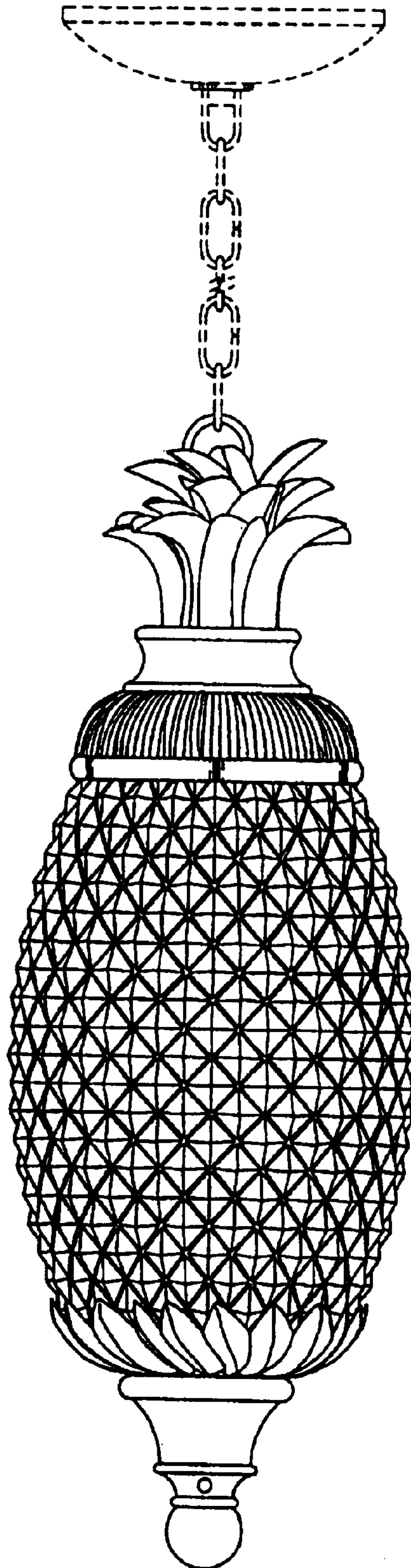

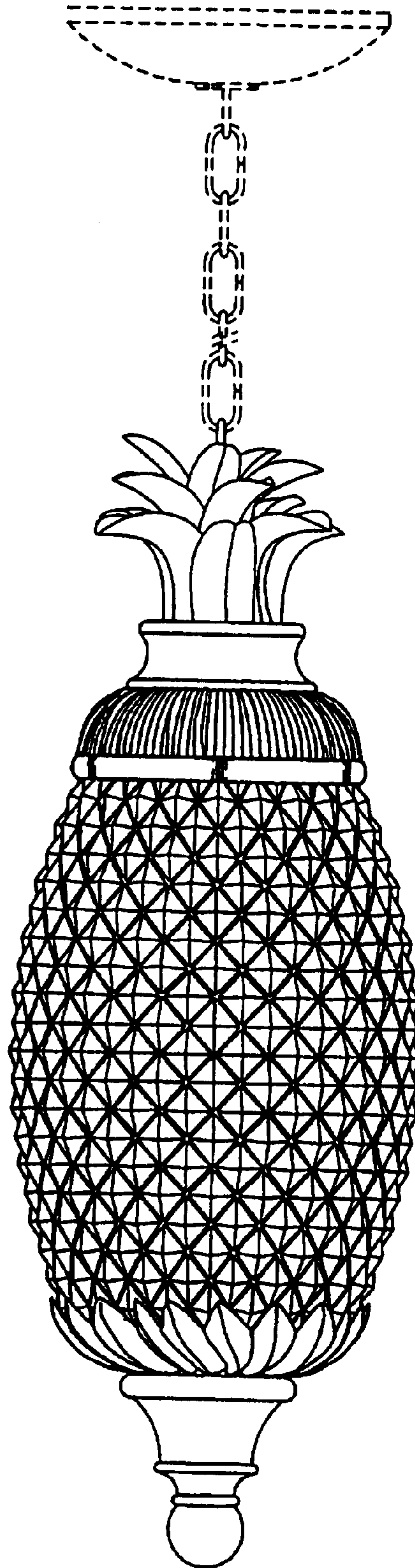

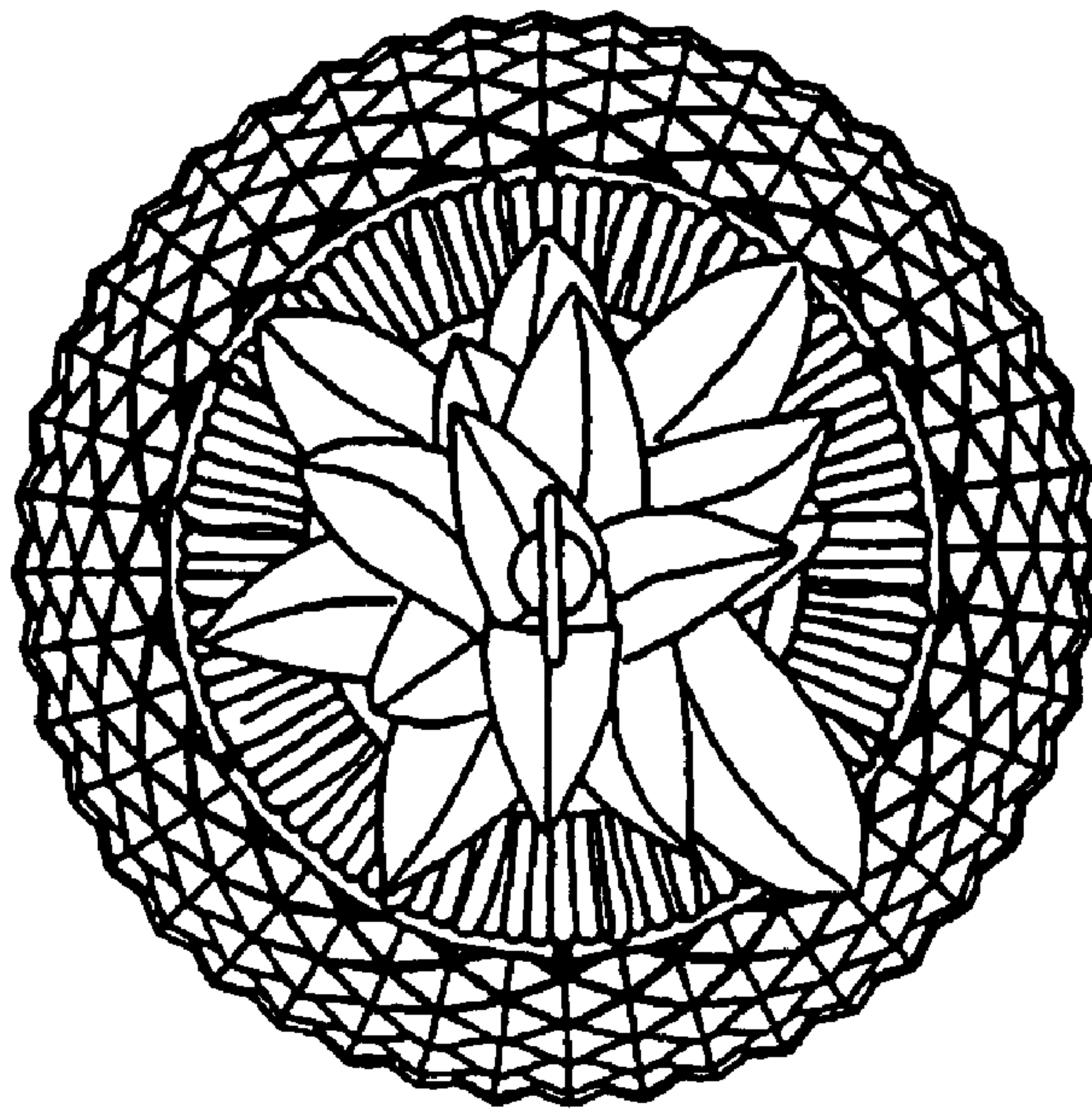
