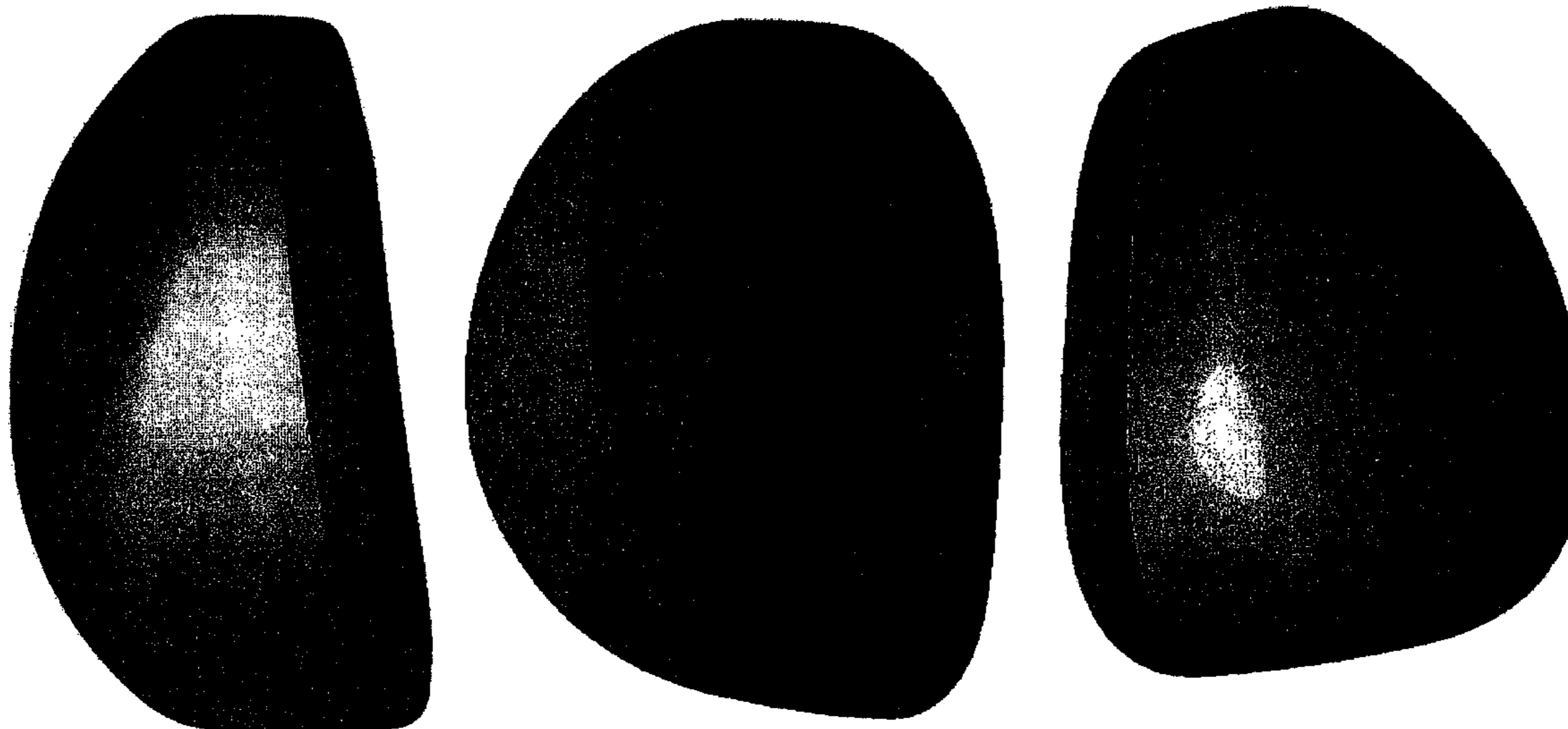

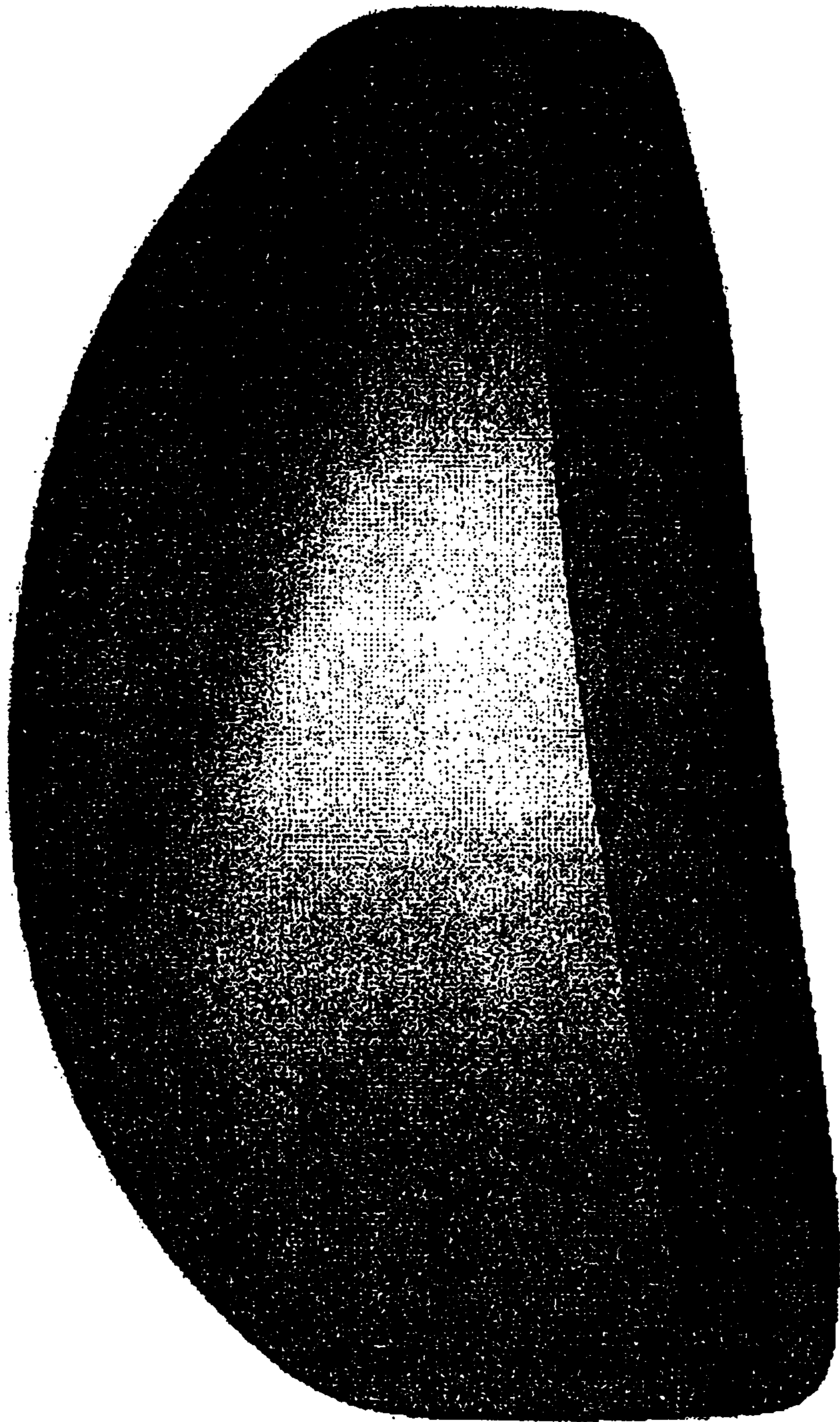
The ornamental design for hearing protector part, as shown and described.

**DESCRIPTION**

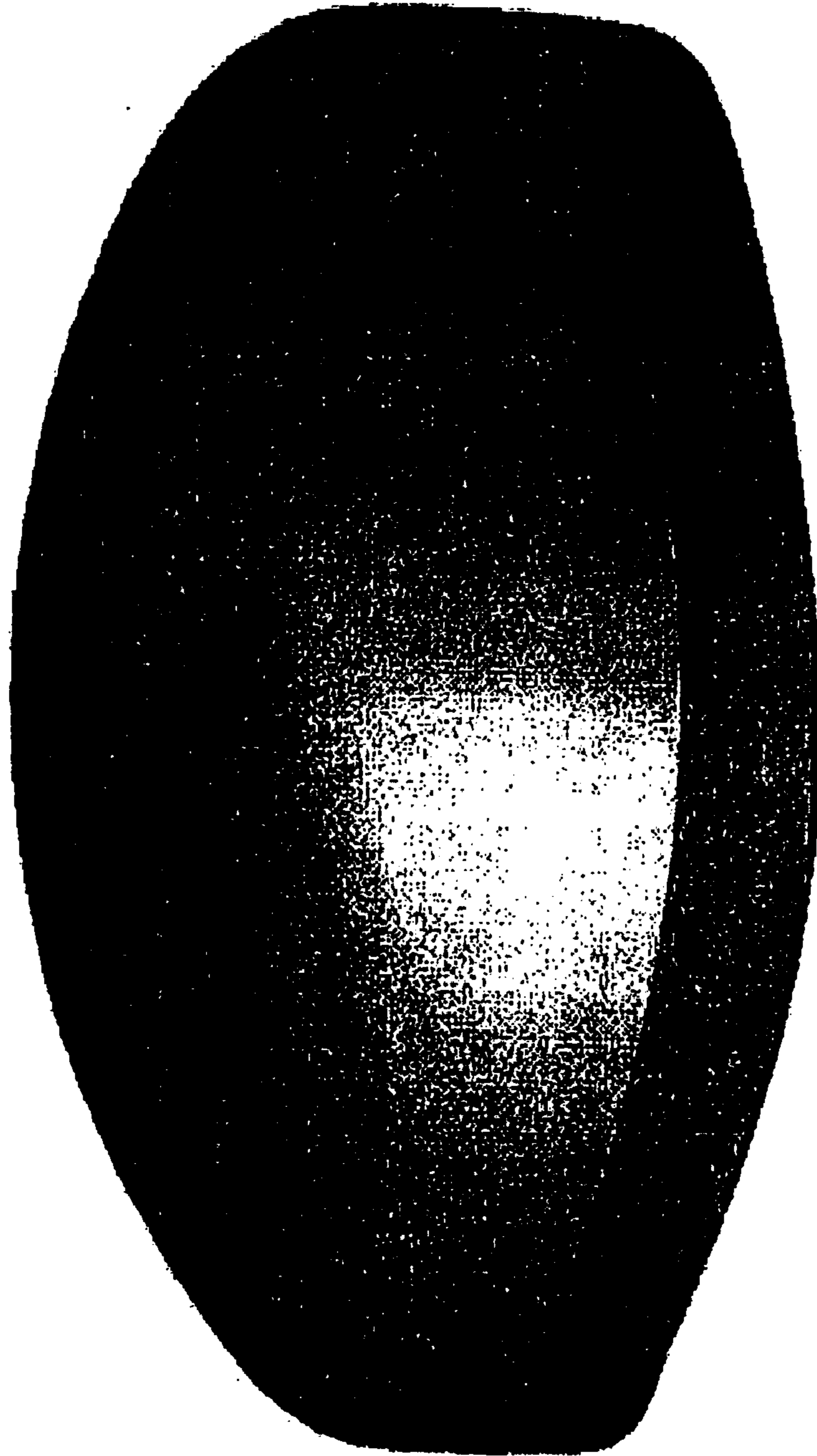
FIG. 1 is a right side view of a hearing protector part, showing our new design;

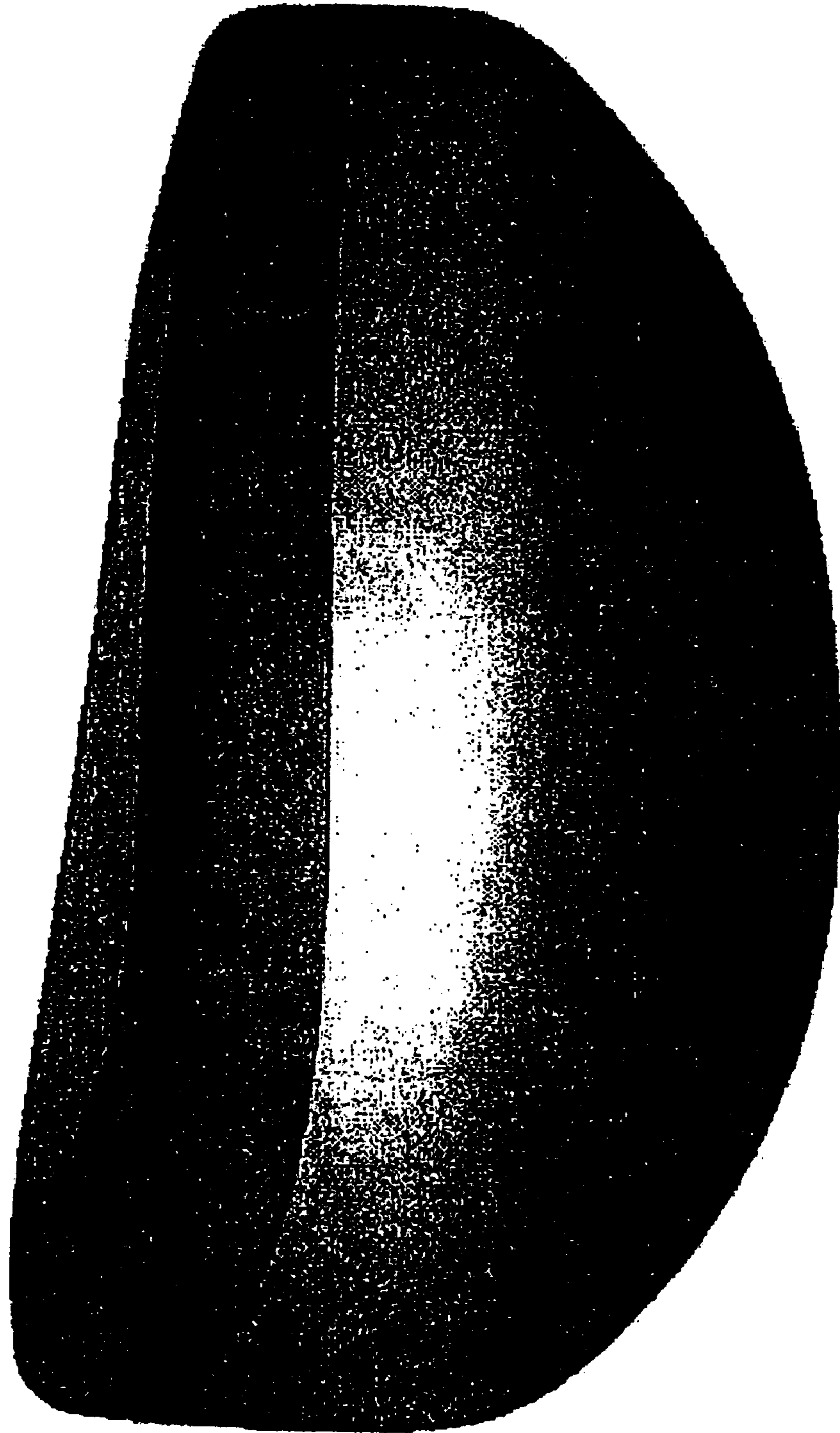

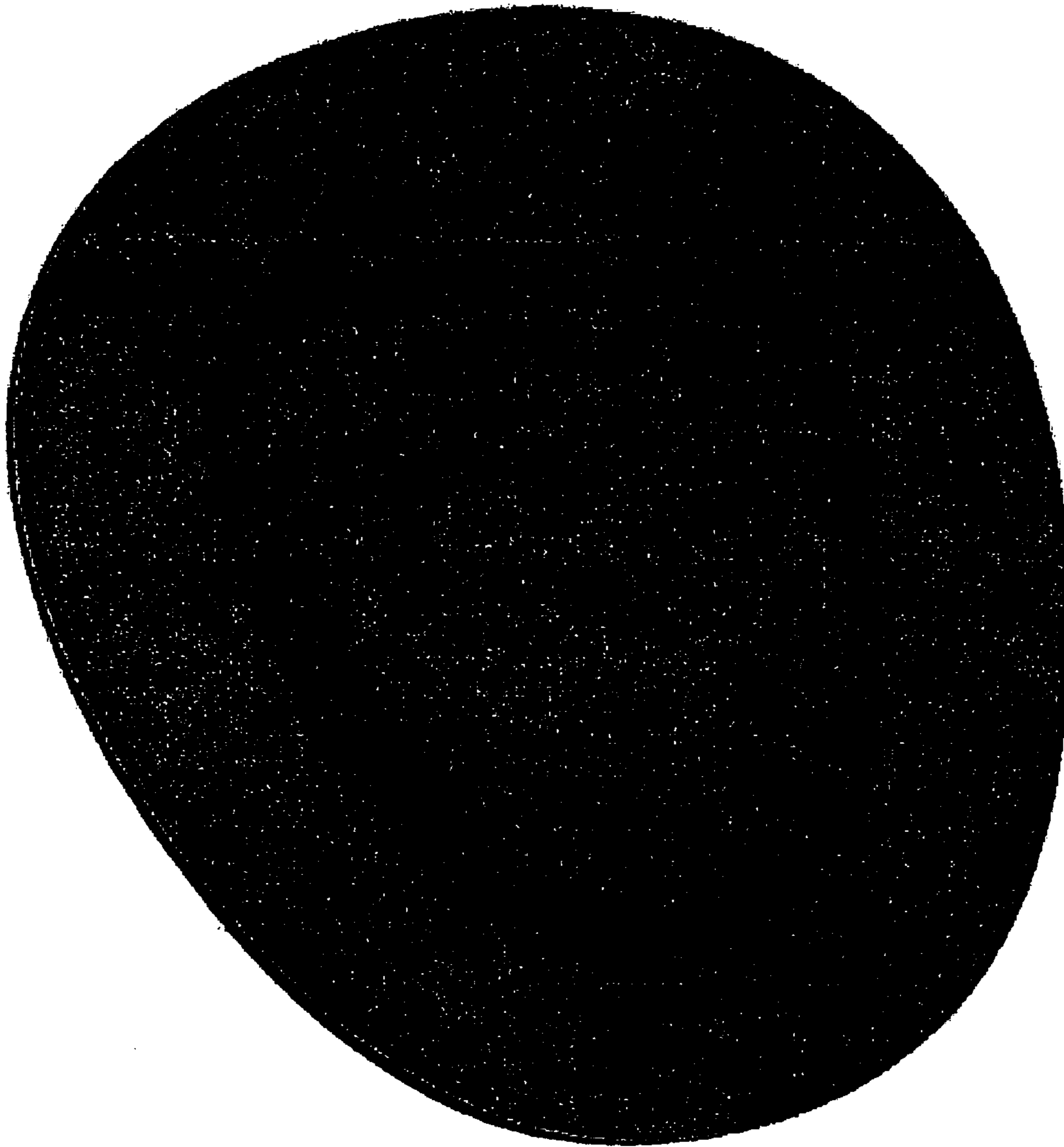
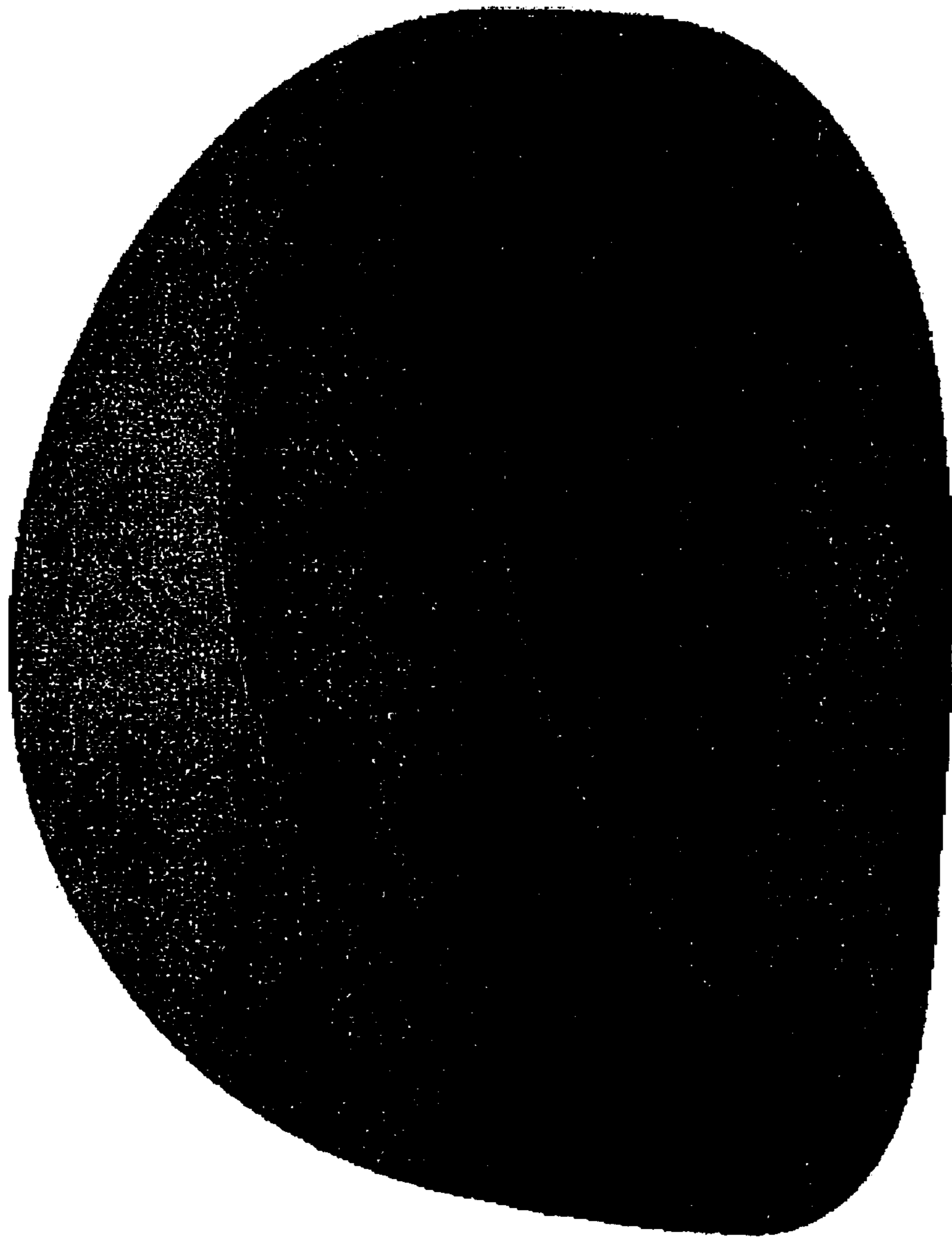
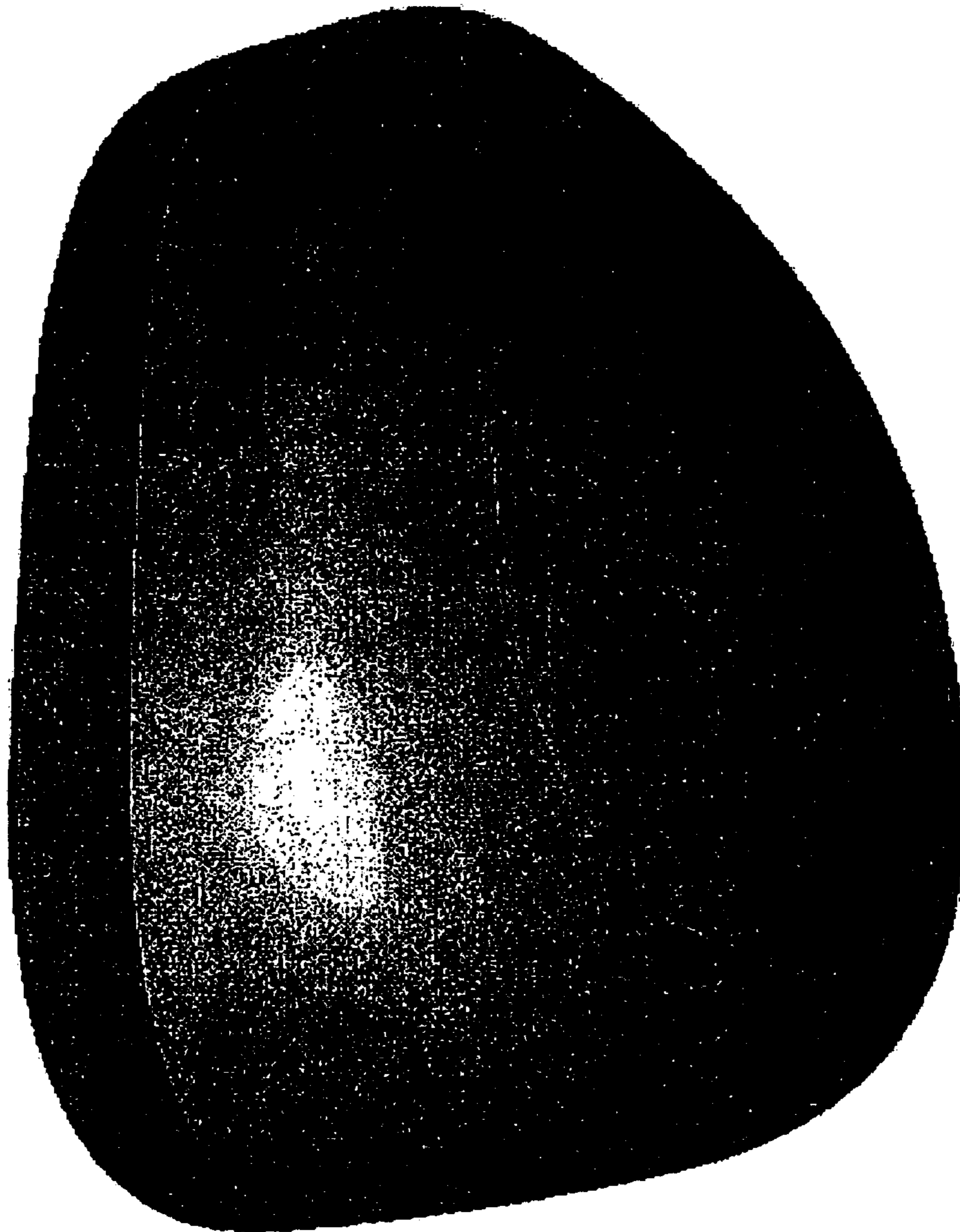


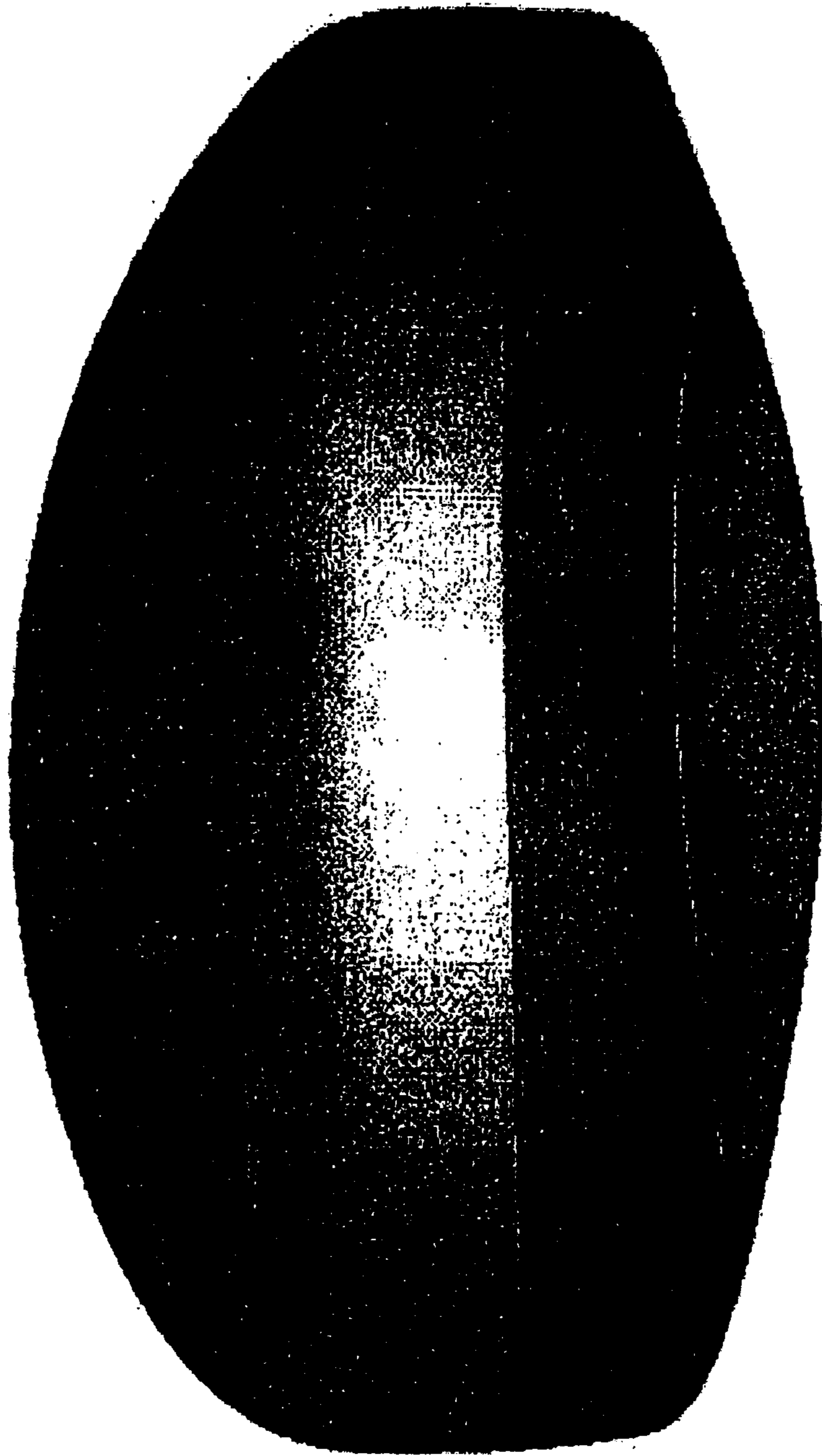
