(57) **CLAIM**

I claim the ornamental design for a hotpad, as illustrated and described.

**DESCRIPTION**

FIG. 1 is a bottom view of the hotpad of the invention; FIG. 2 is a side view of the hotpad; FIG. 3 is a top view of the hotpad; and, FIG. 4 is a cross section view of the hotpad taken along lines 4—4 of FIG. 3.

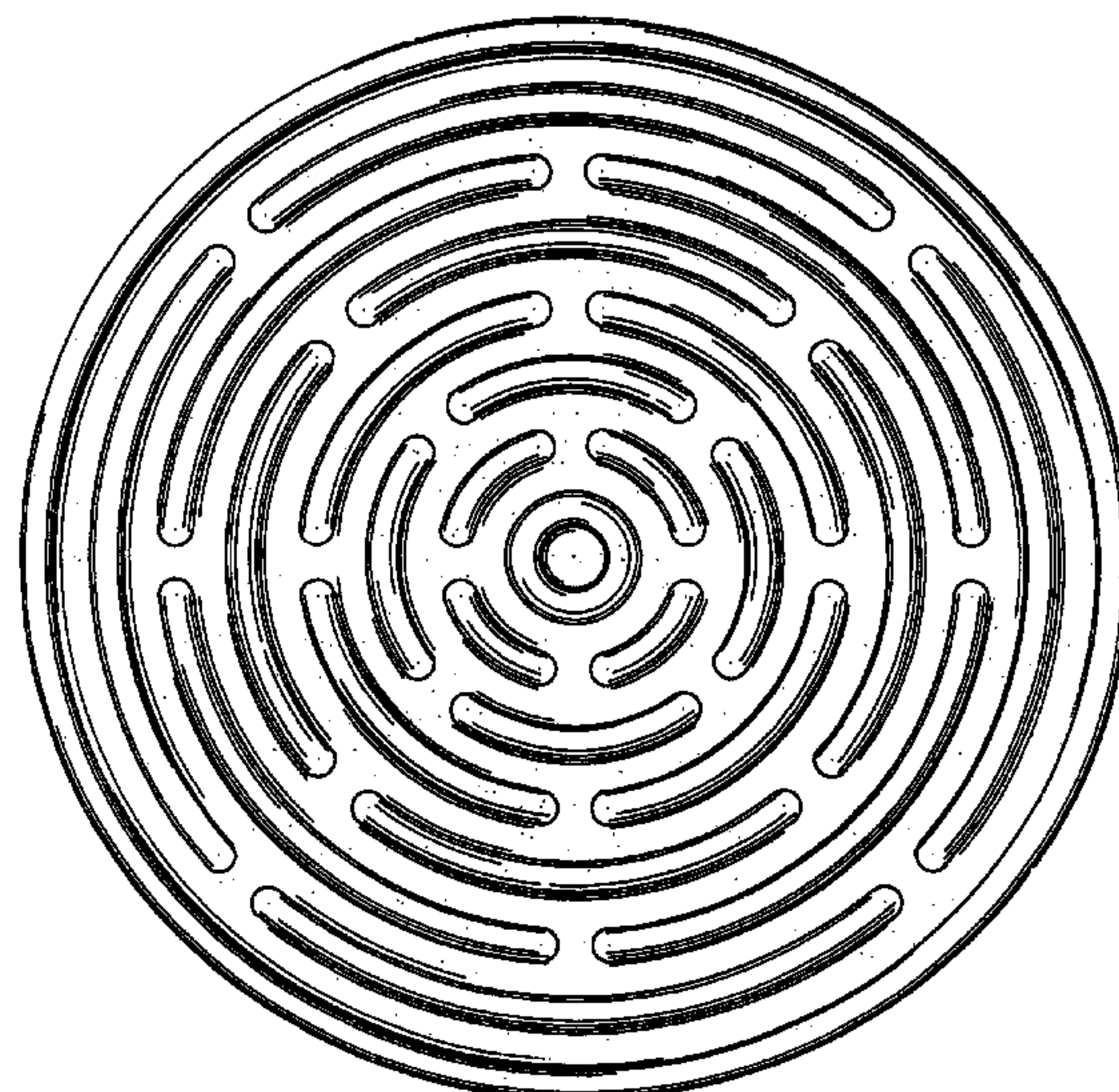

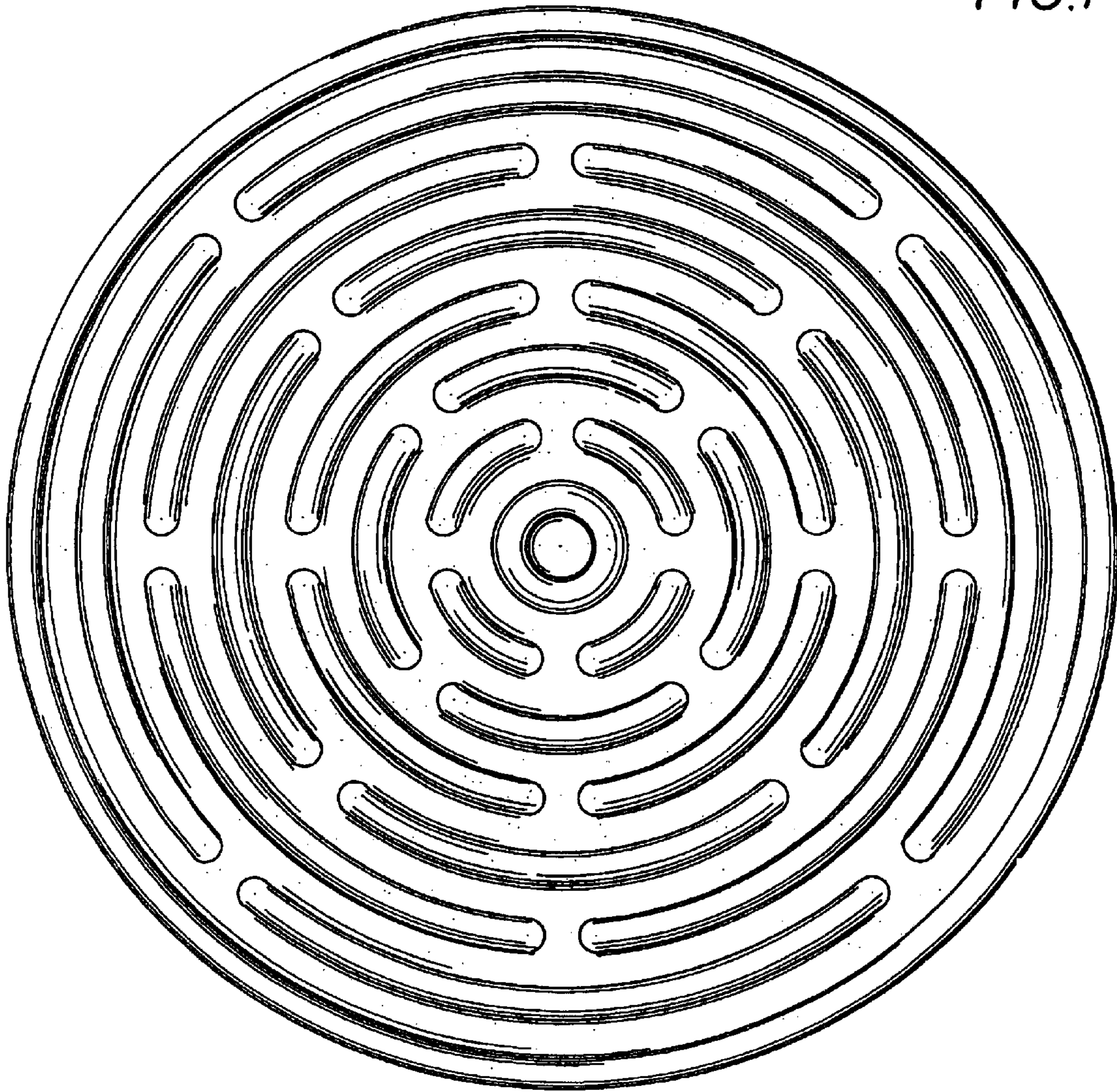

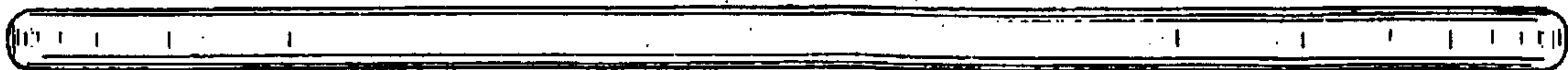
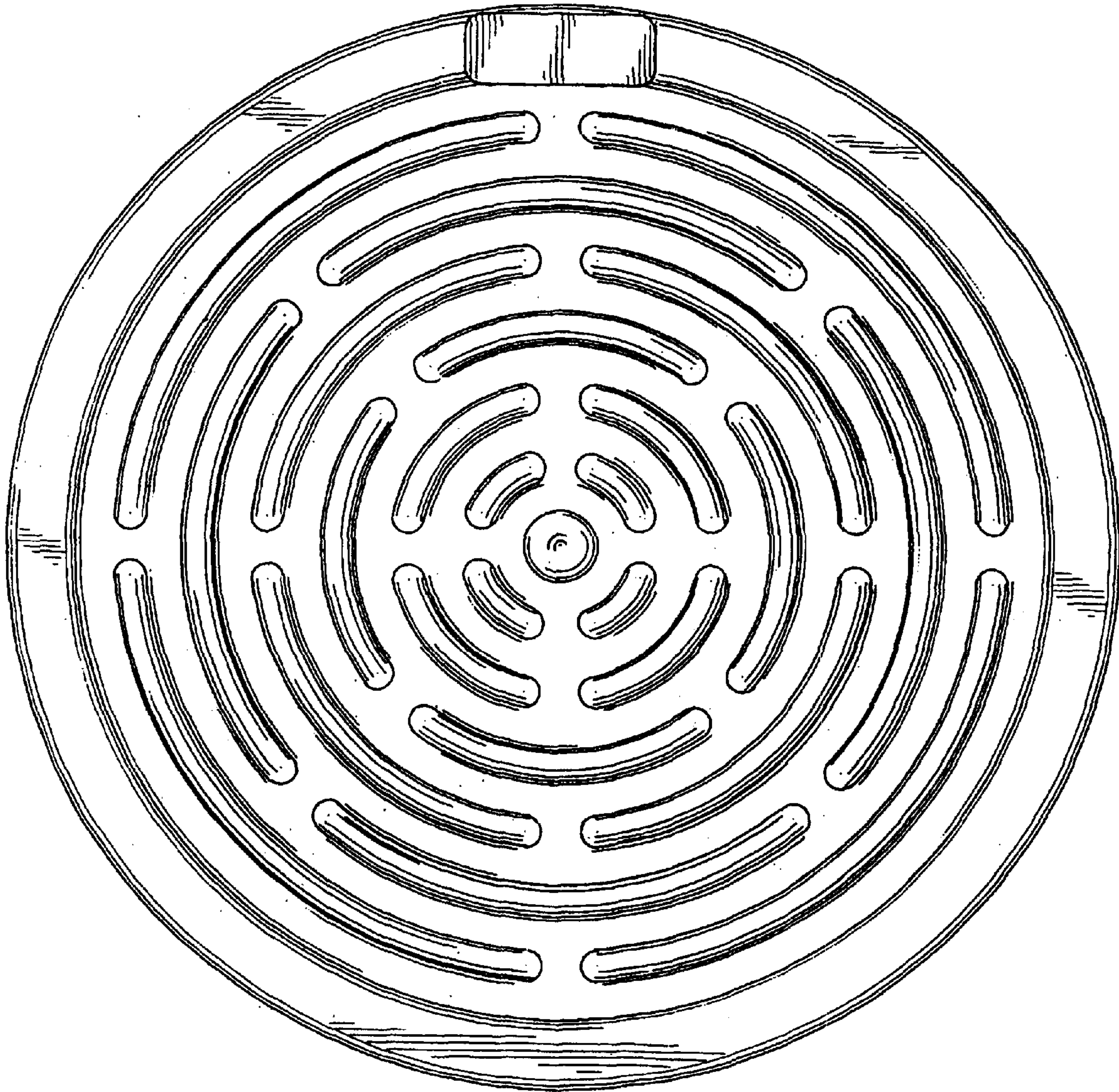
