(57) **CLAIM**

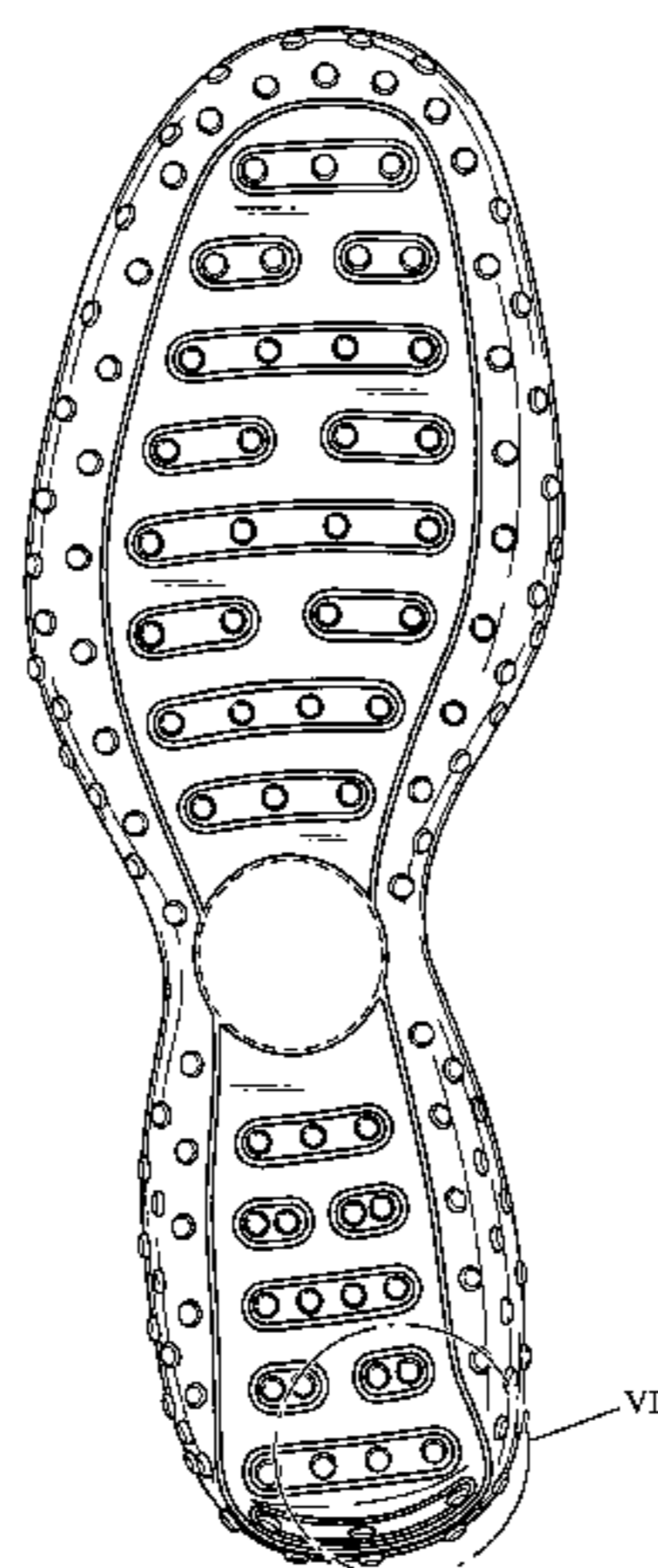
I claim the ornamental design for an outsole for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of an outsole for a shoe showing my new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a back view thereof; and,
FIG. 6 is an enlarged perspective view of the area labeled "6" in FIG. 1.

The broken line showing a curved shape in the arch area of FIG. 1, along with the parallel broken lines around the peripheries of FIGS. 2–5, represent the boundaries of the design; with neither the lines themselves, nor the areas within them forming any part of the claim.

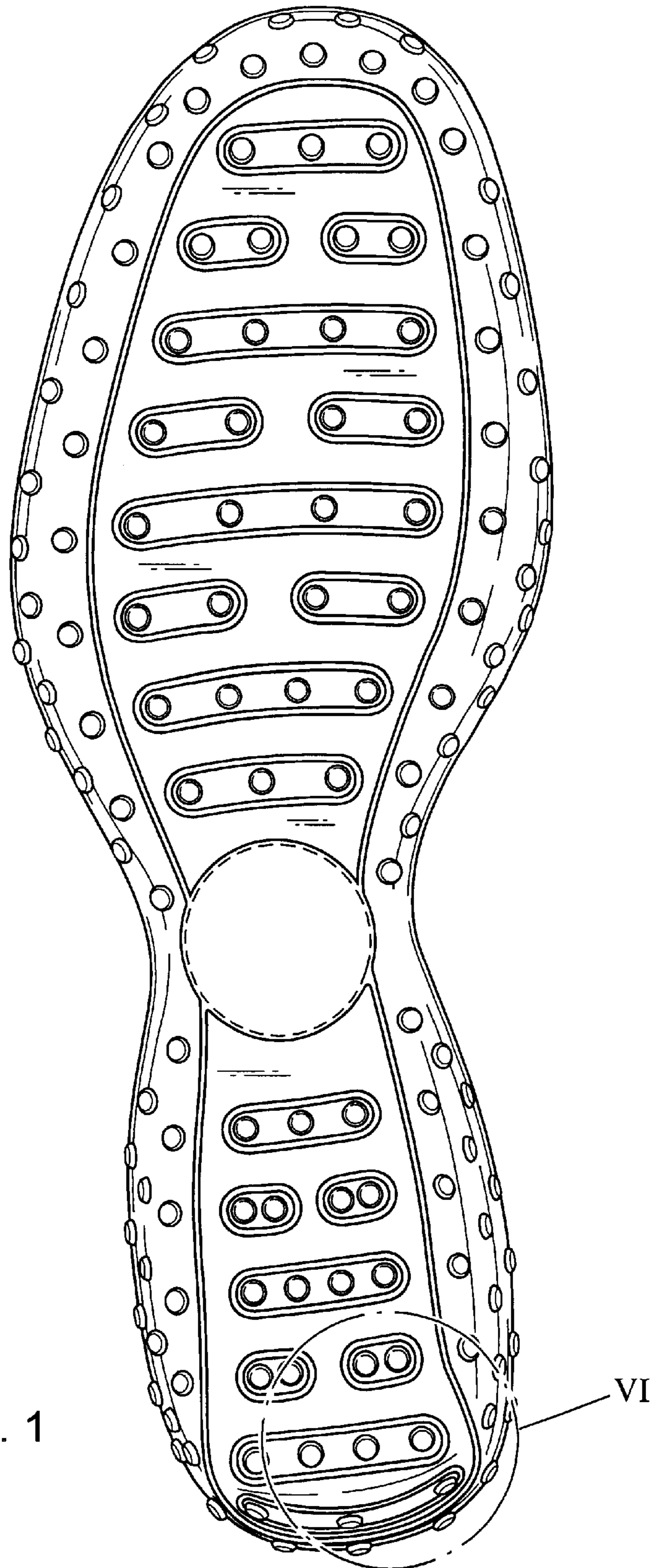

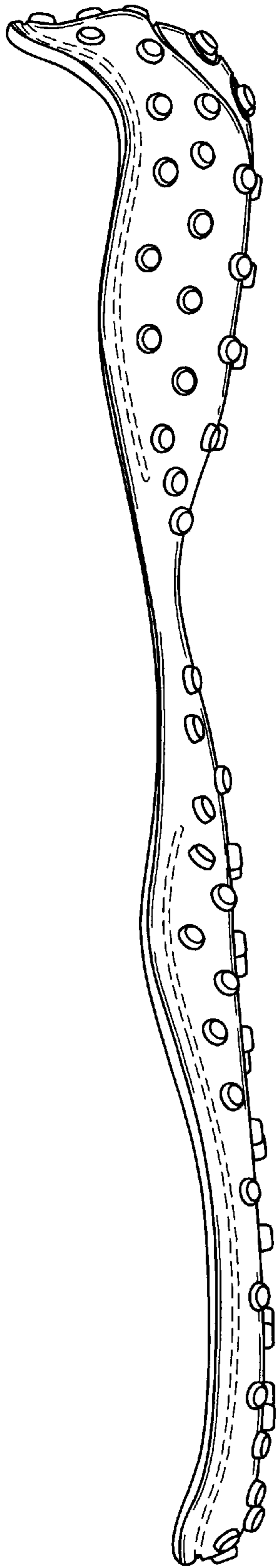

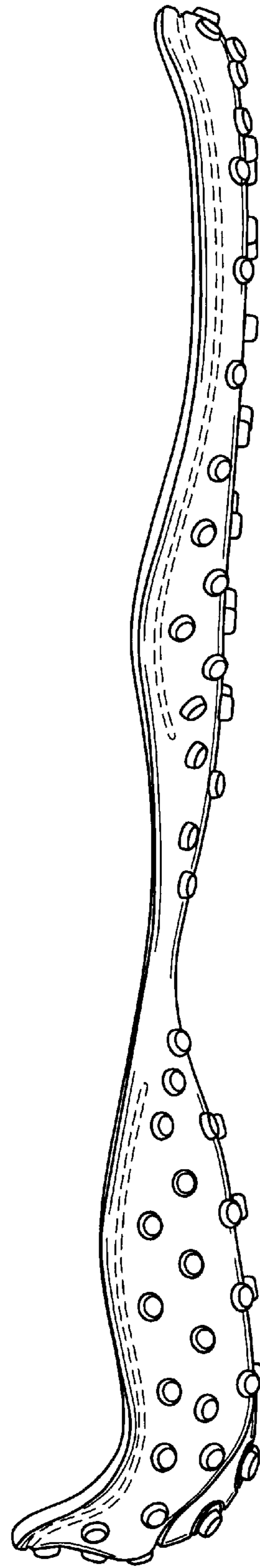

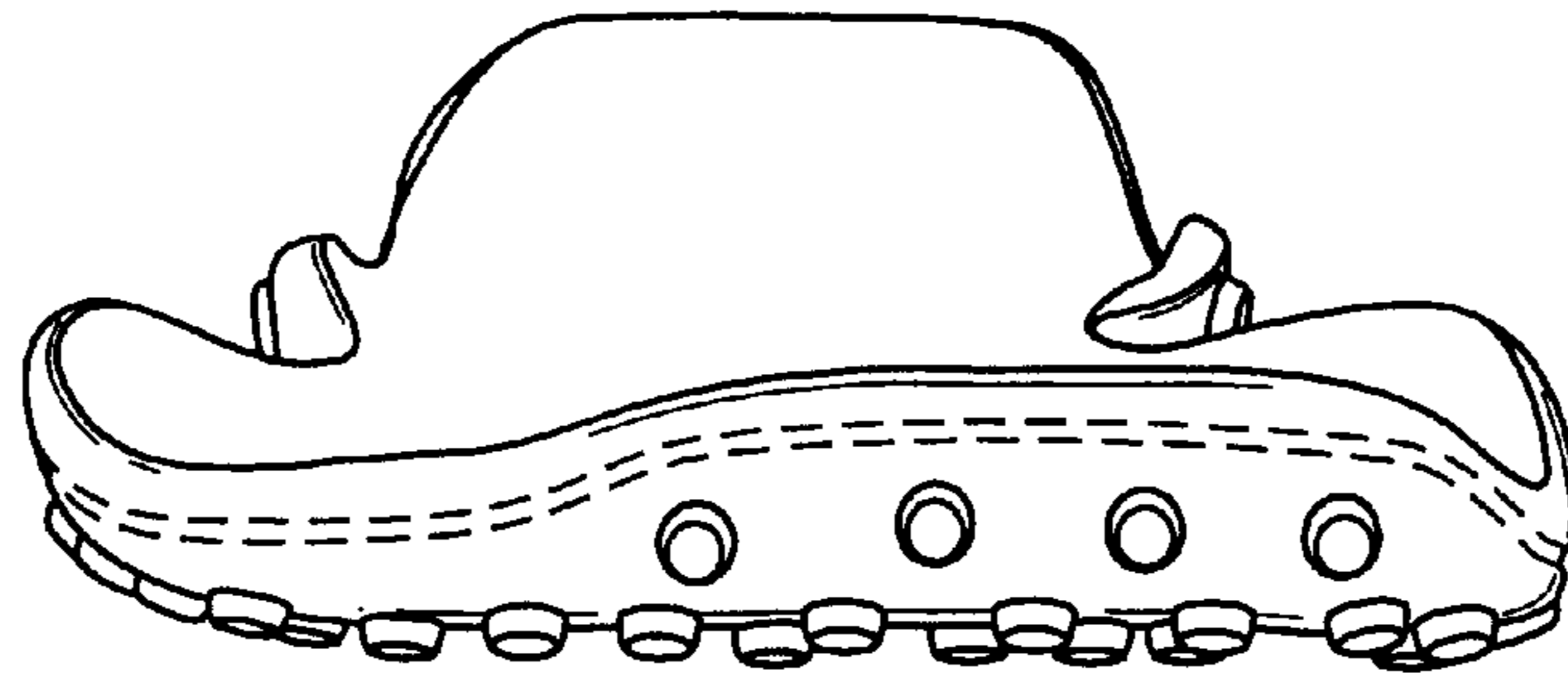

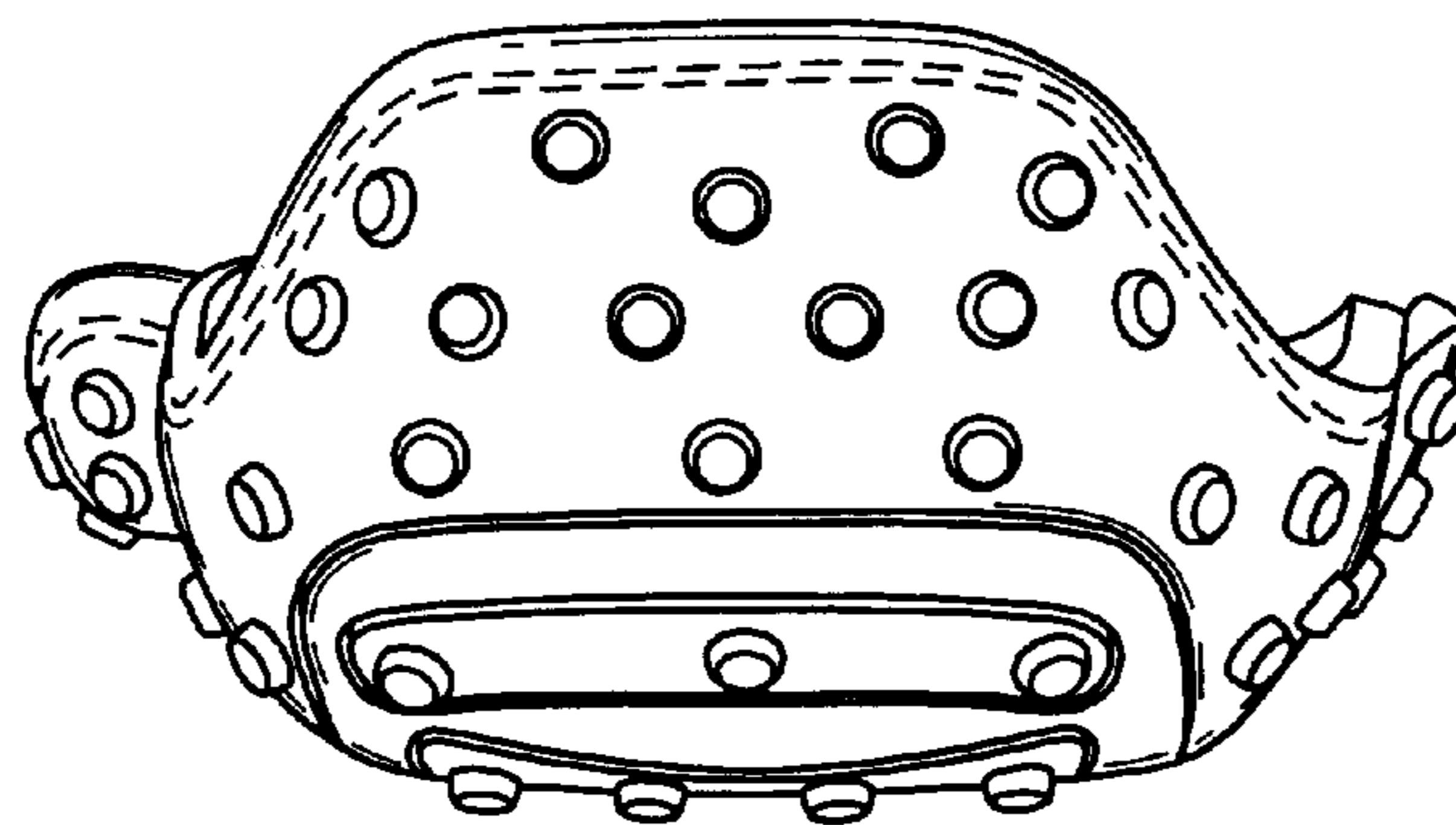

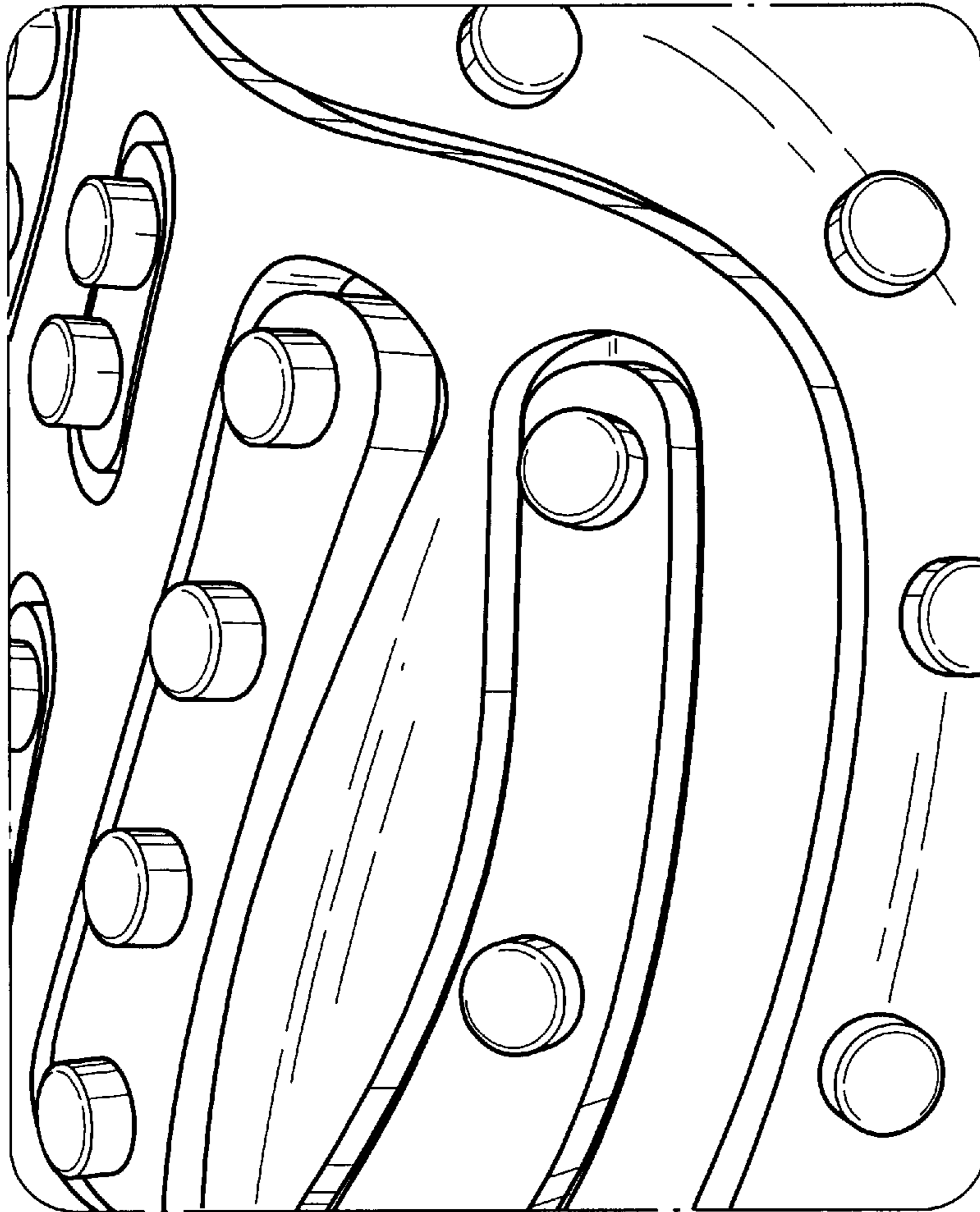
