I claim the ornamental design for a shoe sole, as shown and described.

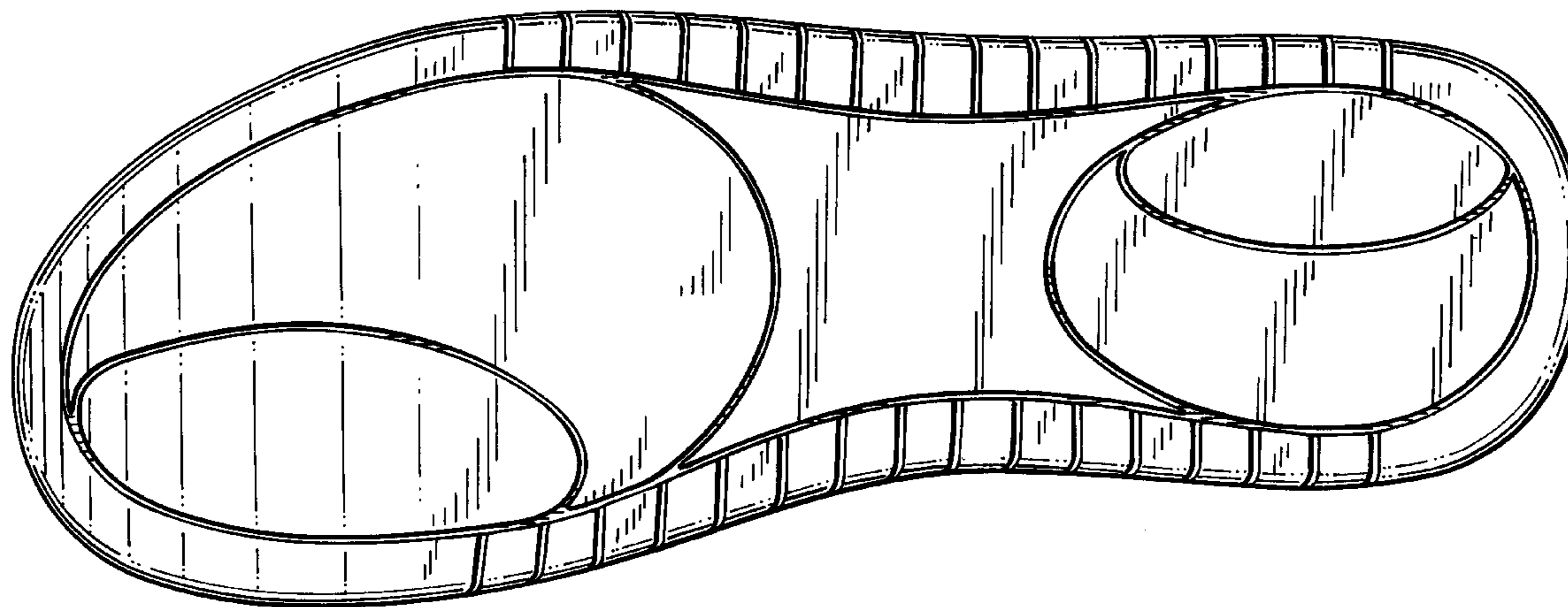
**DESCRIPTION**

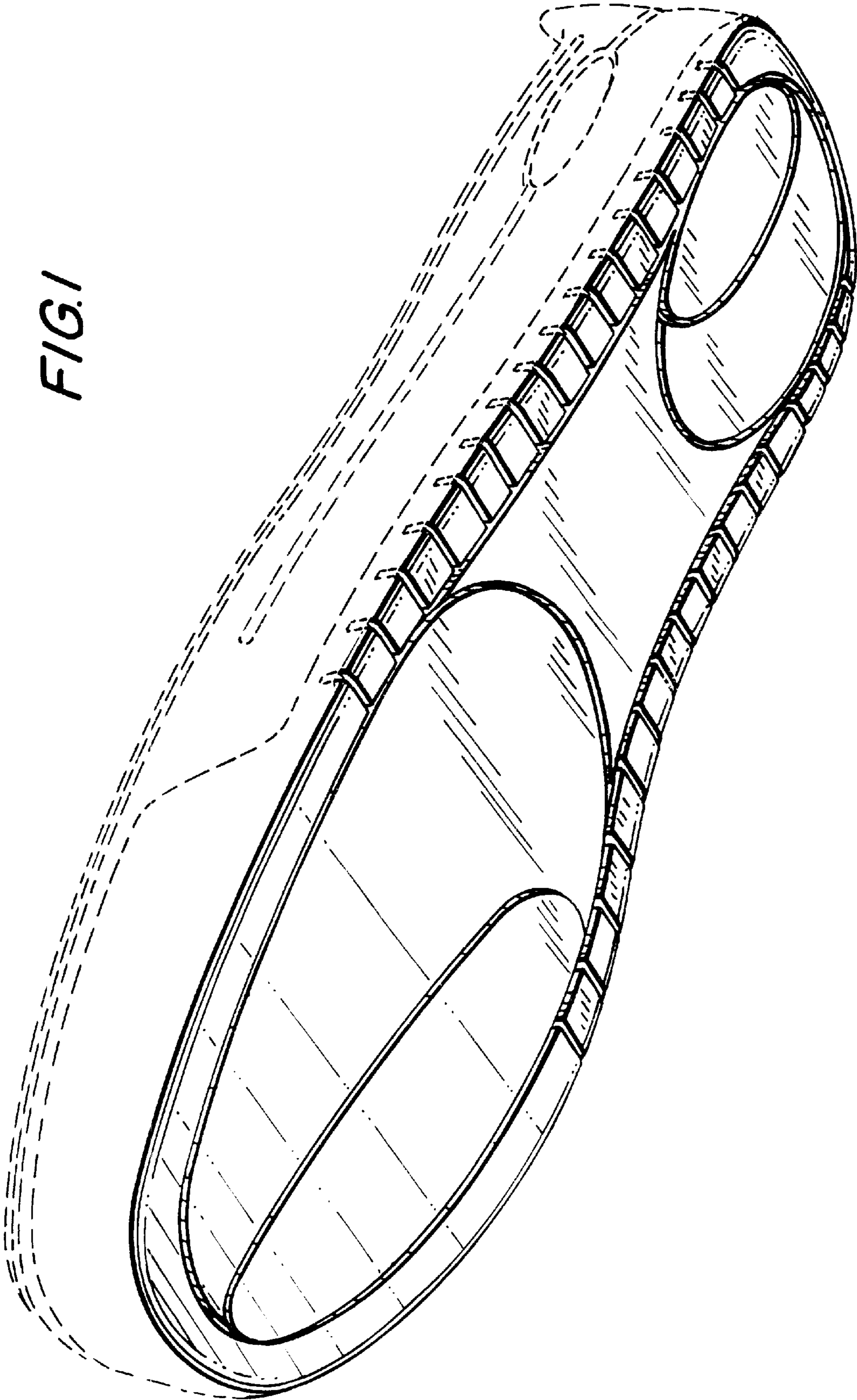
