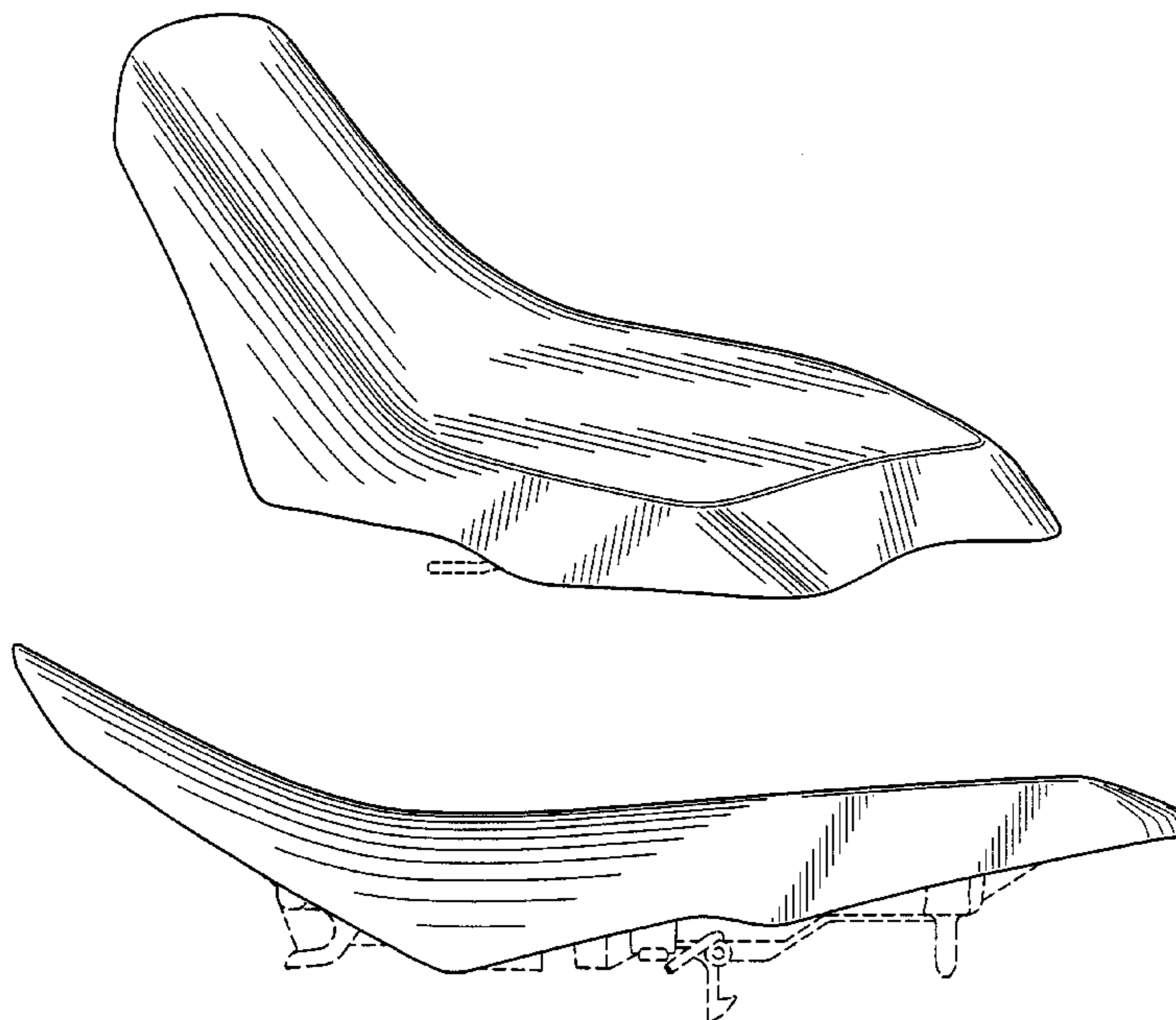
(57) **CLAIM**

The ornamental design for a seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a left rear perspective view of a seat;  
FIG. 2 is a left side elevational view of the seat of FIG. 1;  
FIG. 3 is a bottom plan view of the seat of FIG. 1;  
FIG. 4 is a left front perspective view of the seat of FIG. 1 on a reduced scale provided upon an exemplary four wheeled vehicle;  
FIG. 5 is a left rear perspective view of the seat of FIG. 4 provided upon the exemplary four wheeled vehicle;  
FIG. 6 is a rear perspective view of the seat of FIG. 4 provided upon the exemplary four wheeled vehicle;  
FIG. 7 is a left side perspective view of the seat of FIG. 4 provided upon the exemplary four wheeled vehicle;  
FIG. 8 is a right side perspective view of the seat of FIG. 4 provided upon the exemplary four wheeled vehicle; and,  
FIG. 9 is a top perspective view of the seat of FIG. 4 provided upon the exemplary four wheeled vehicle.

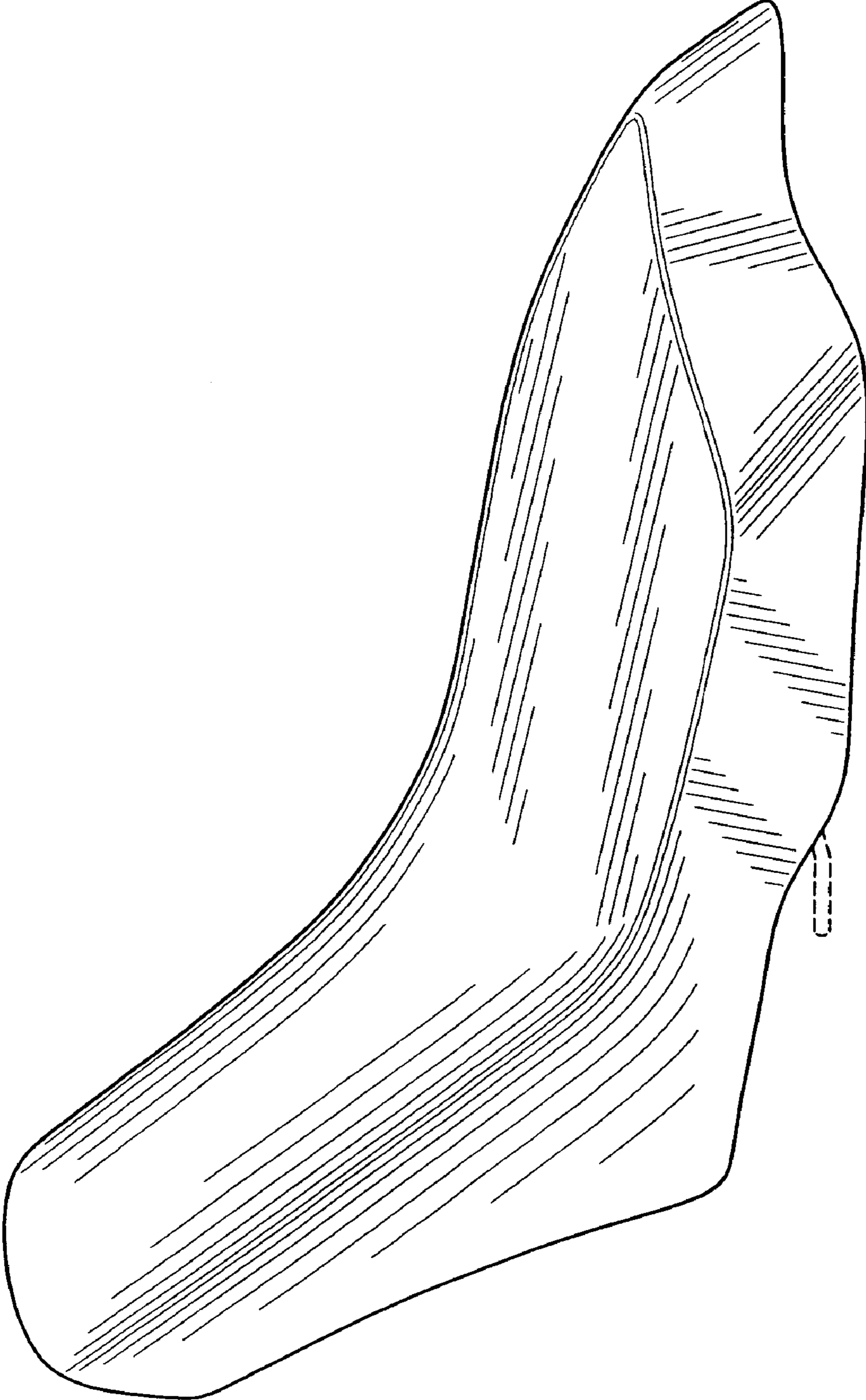

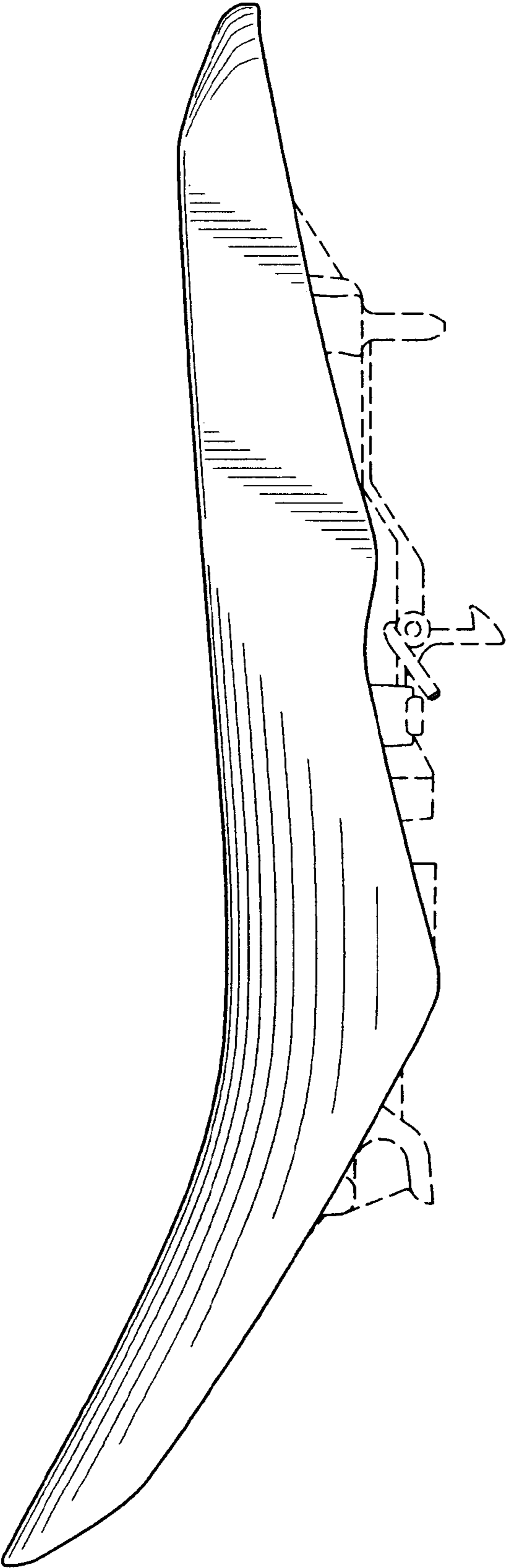

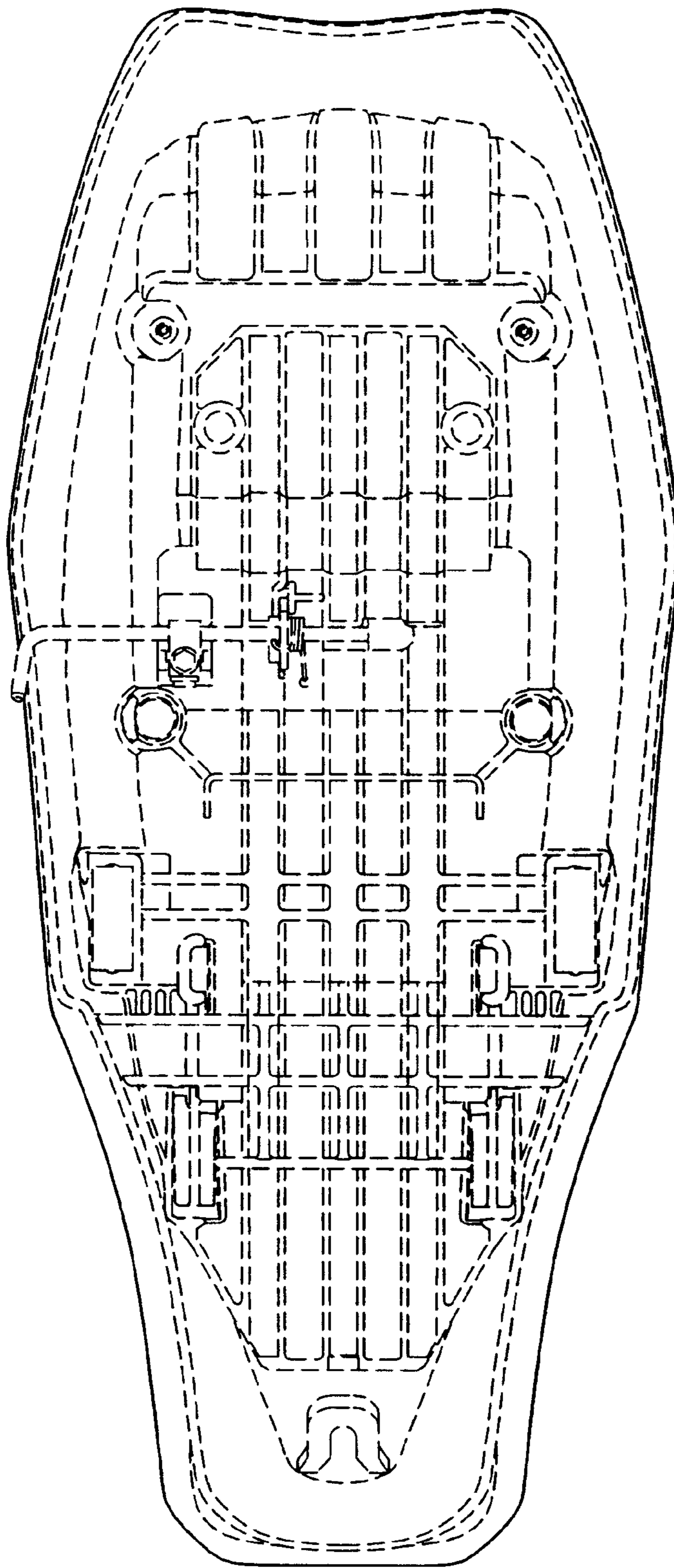

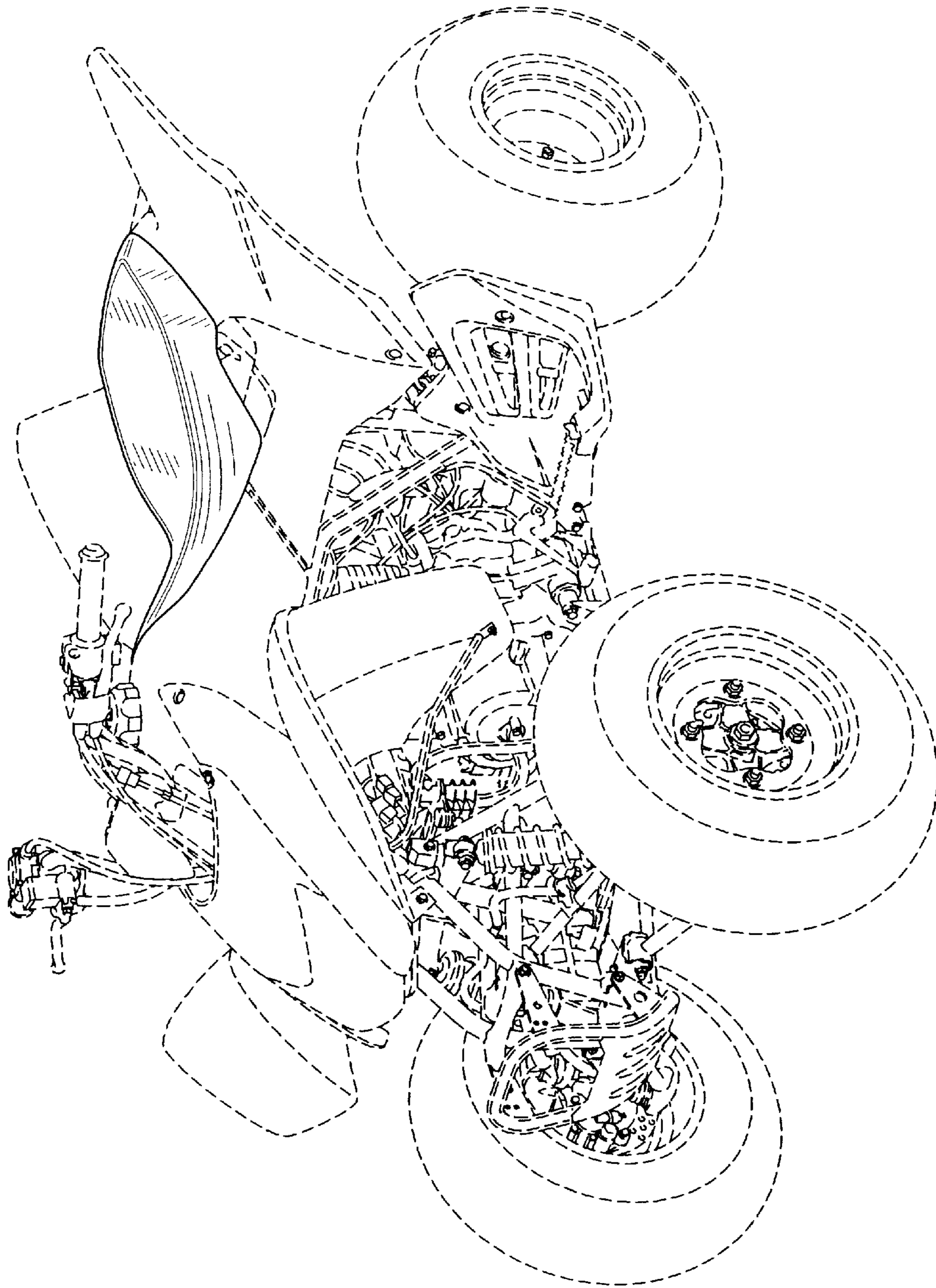

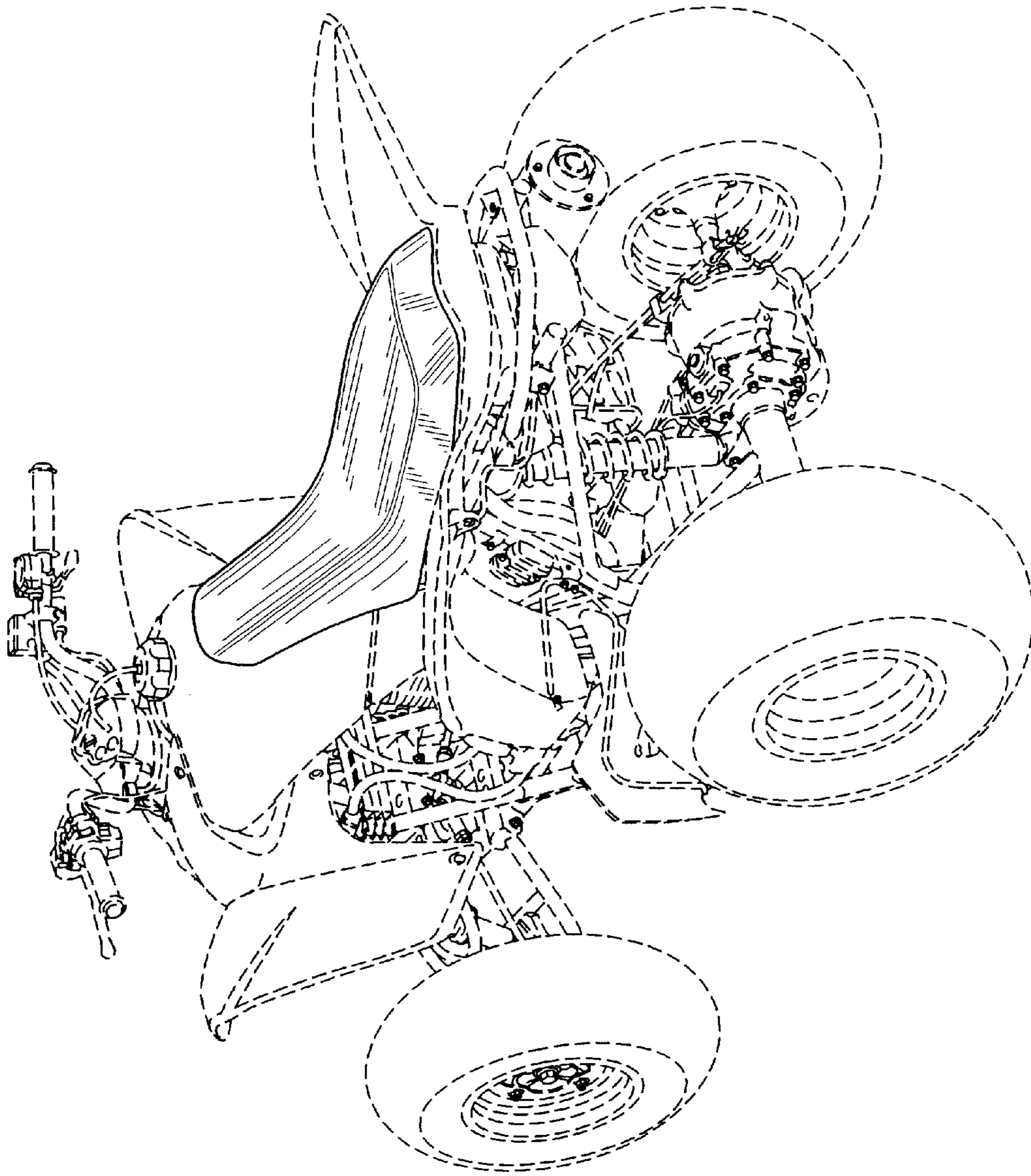

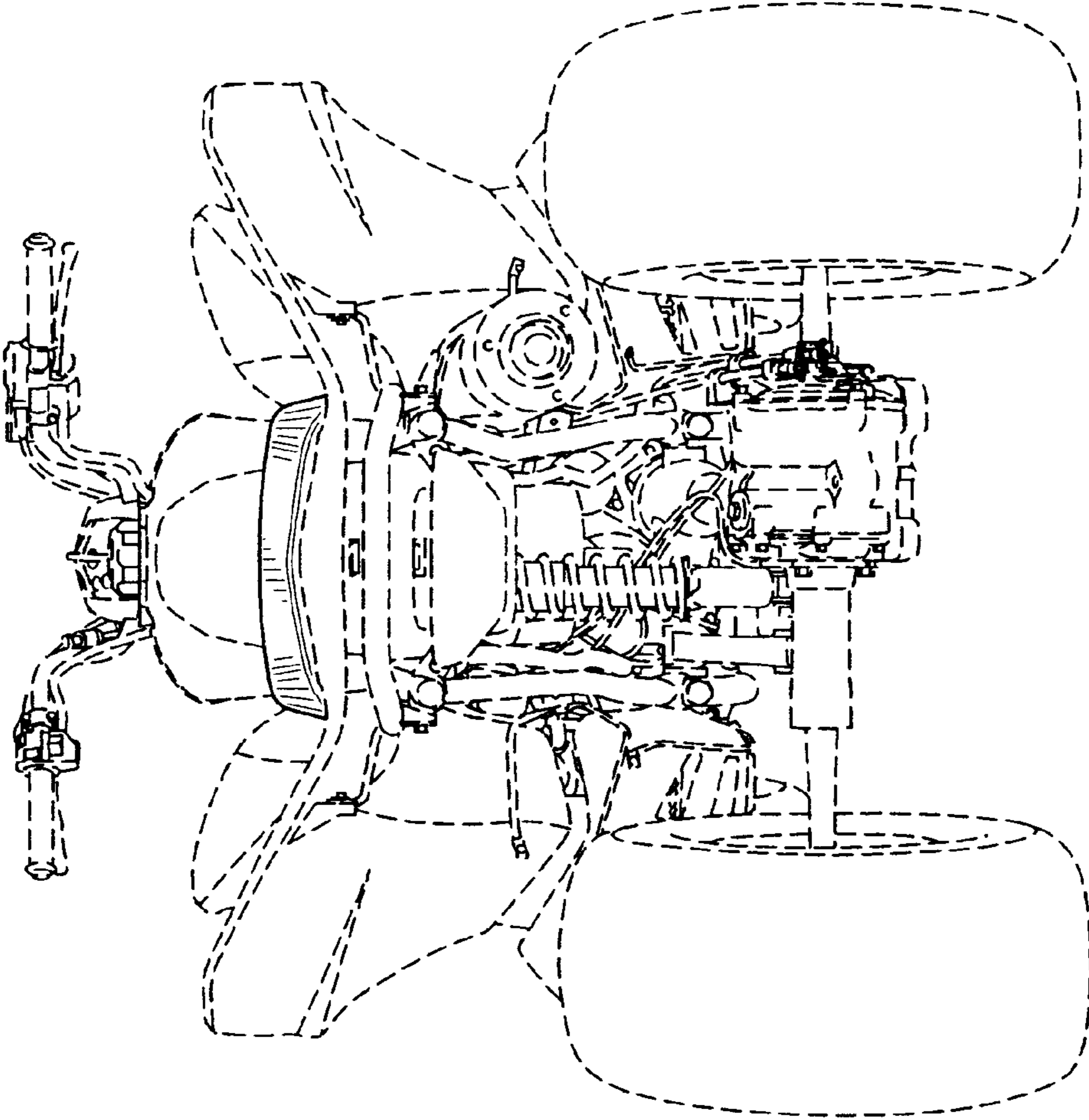

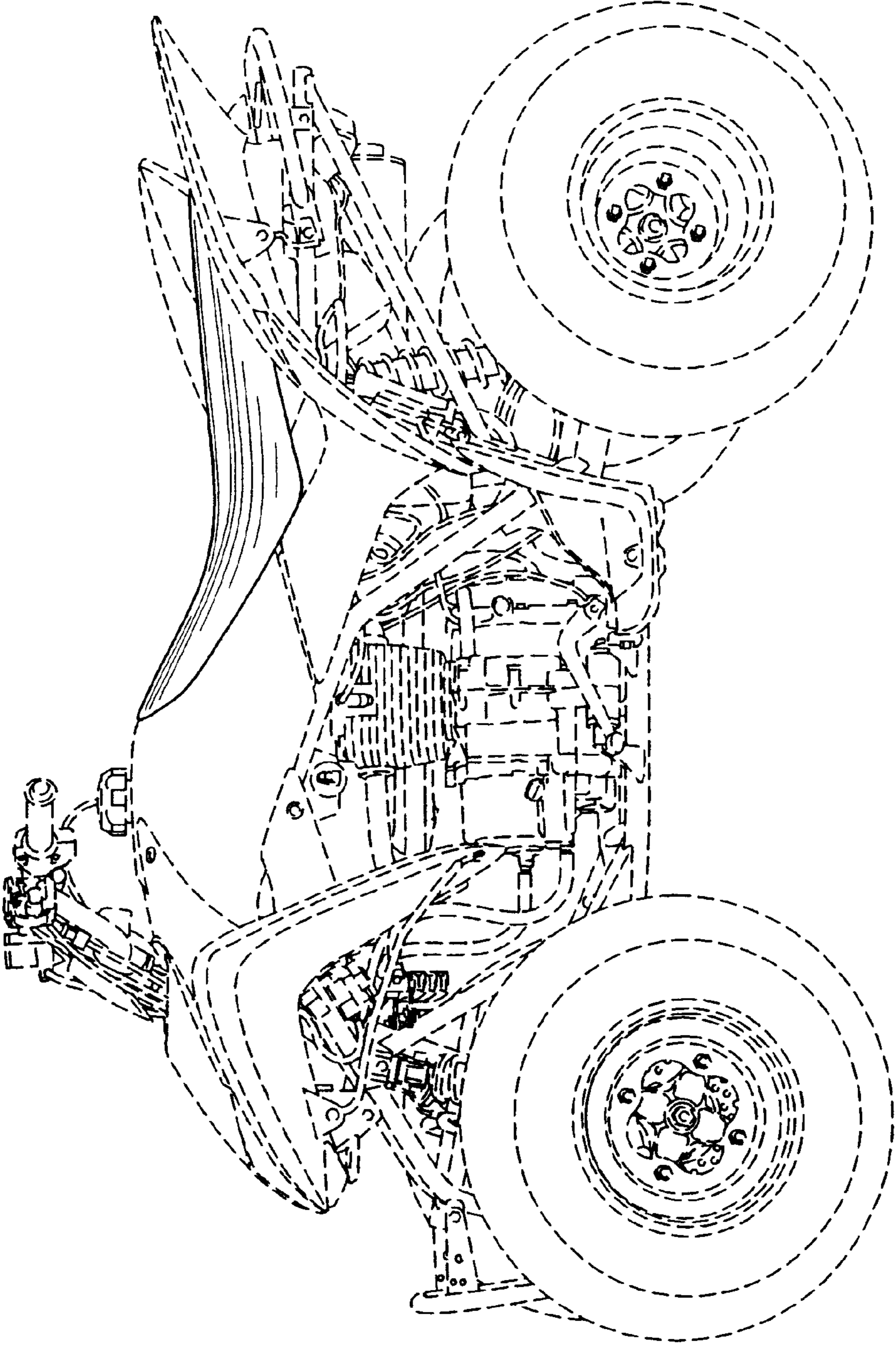

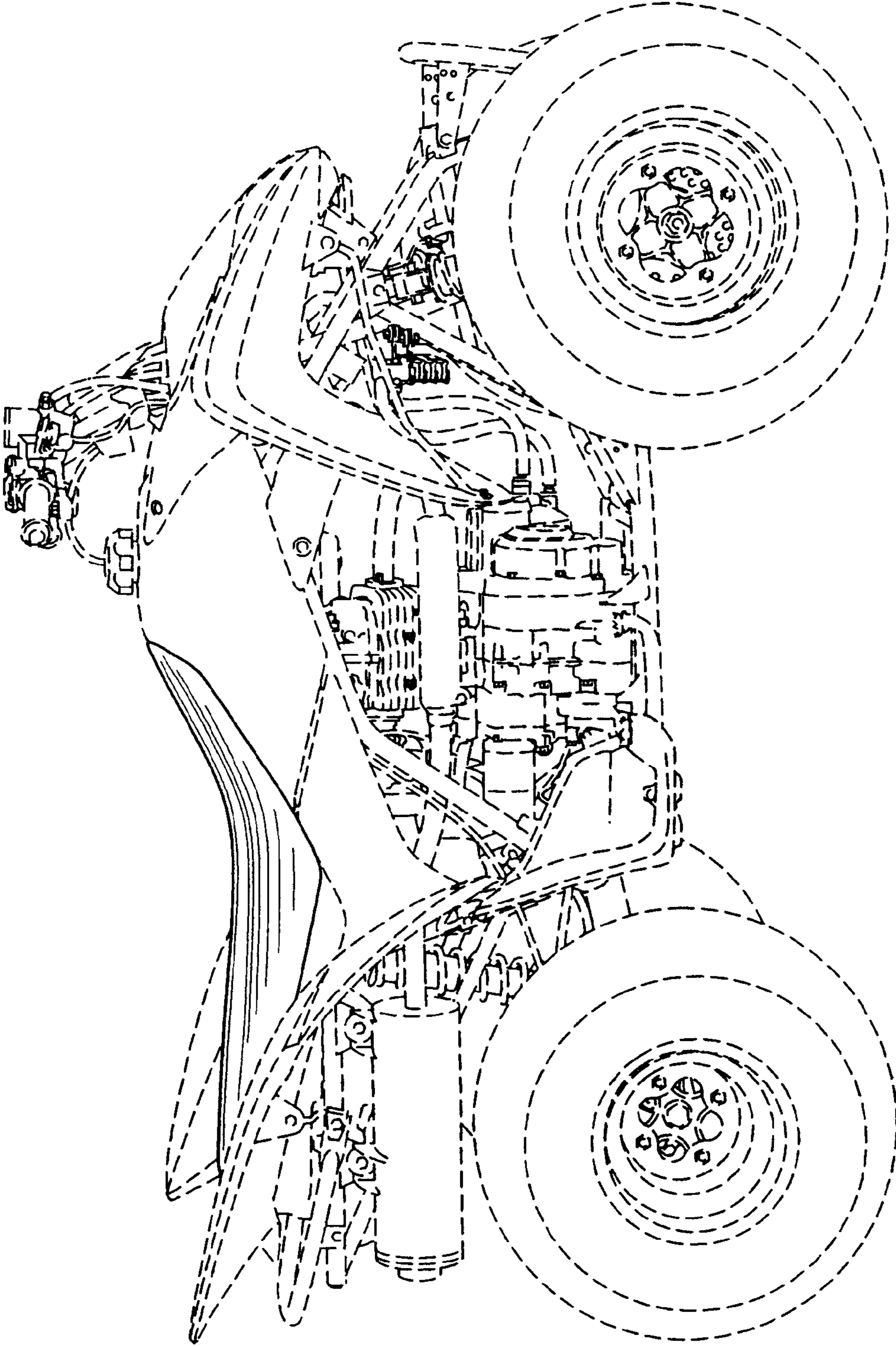

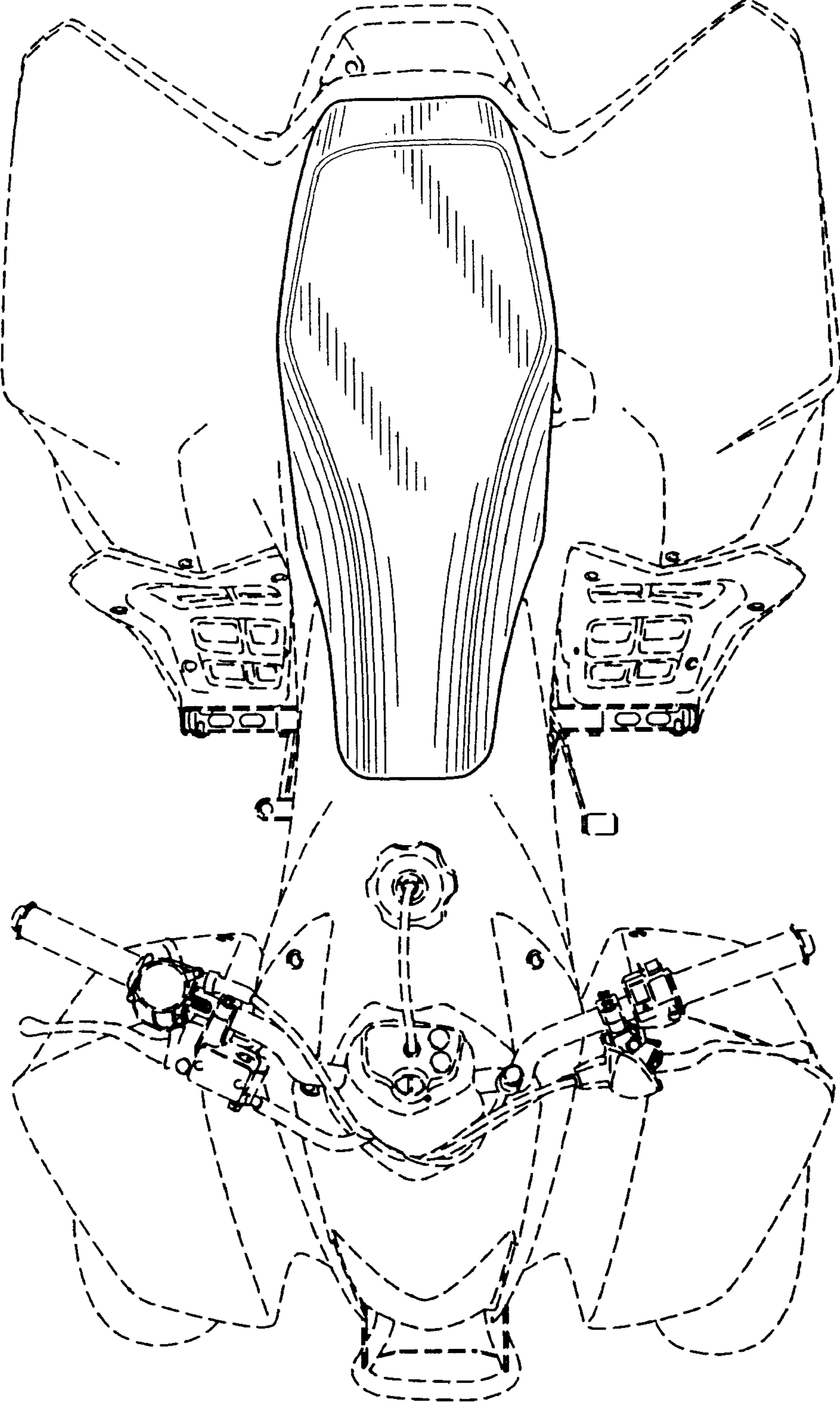
