(57) **CLAIM**

The ornamental design for a vehicle seat, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a vehicle seat showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is side elevational view, the opposite side being substantially a mirror image thereof; and,
FIG. 4 is a rear perspective view thereof.
The broken line showings of the seat belt elements and lower bar are for illustrative purposes only and form no part of the claimed design.

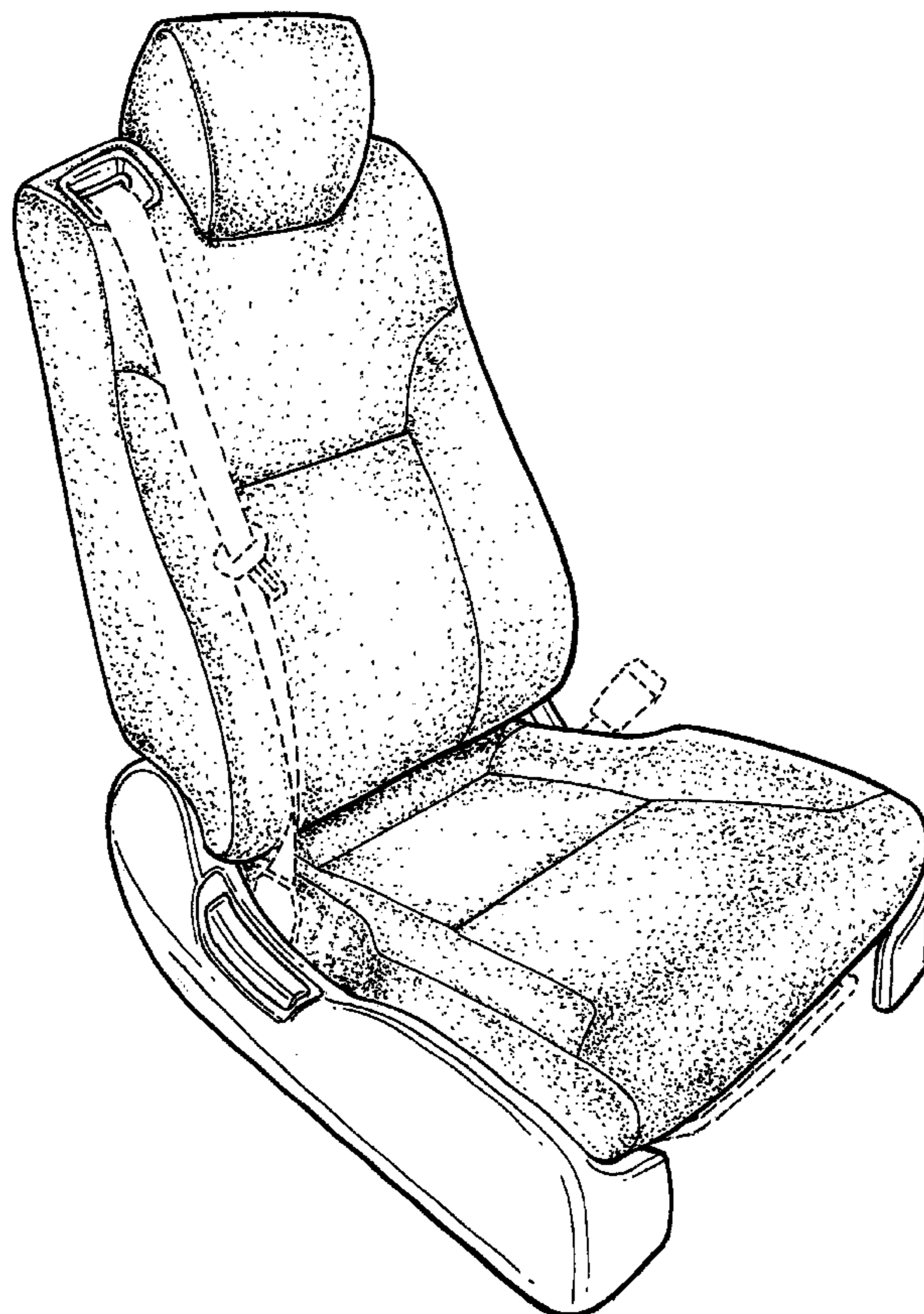

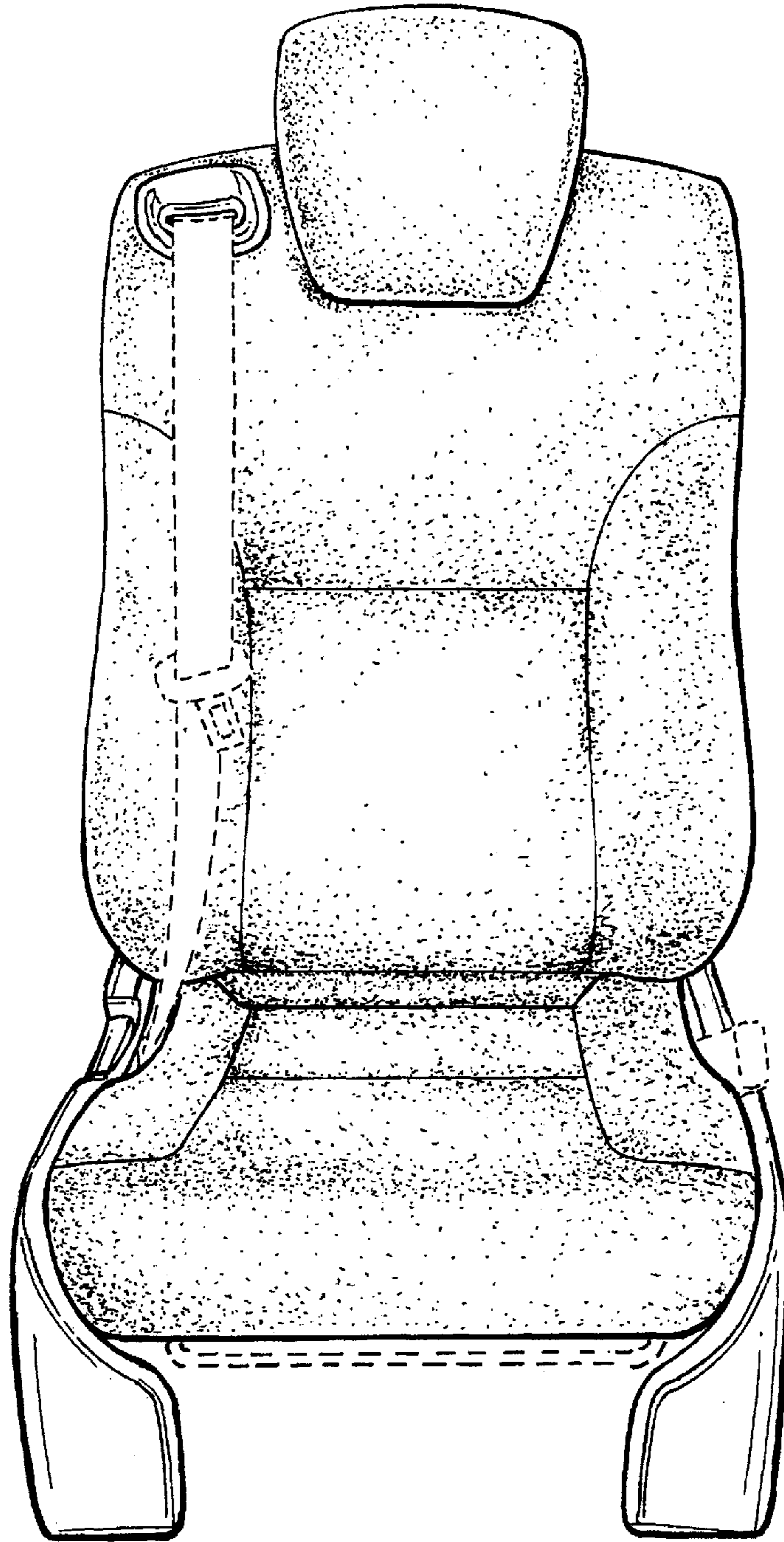

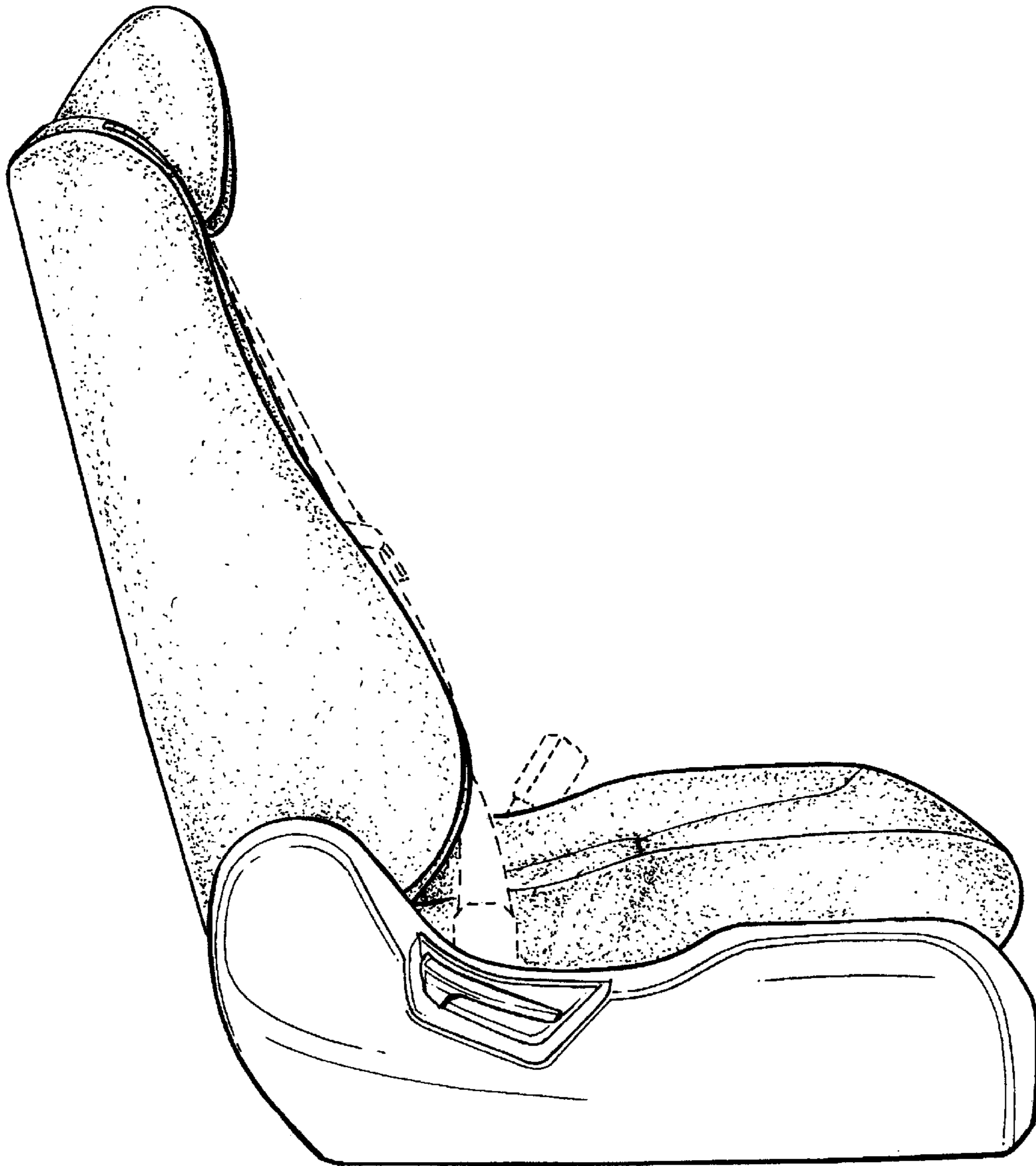

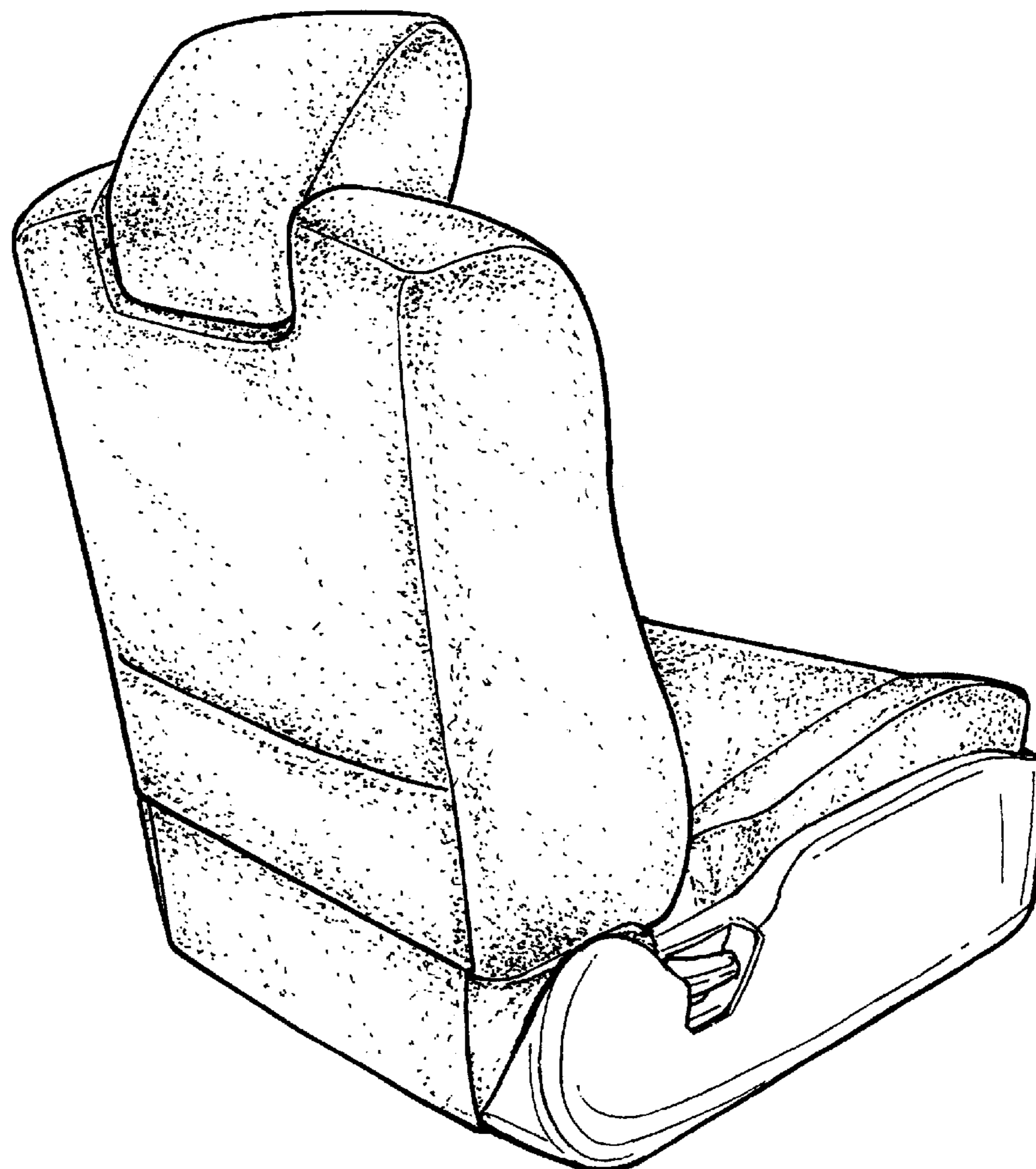
