(57) **CLAIM**

The ornamental design for a vacuum bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view from above of a vacuum bottle, showing my new design:

FIG. 2 is a front view thereof, the rear view being a mirror image thereof;

FIG. 4 is a bottom plan view thereof;

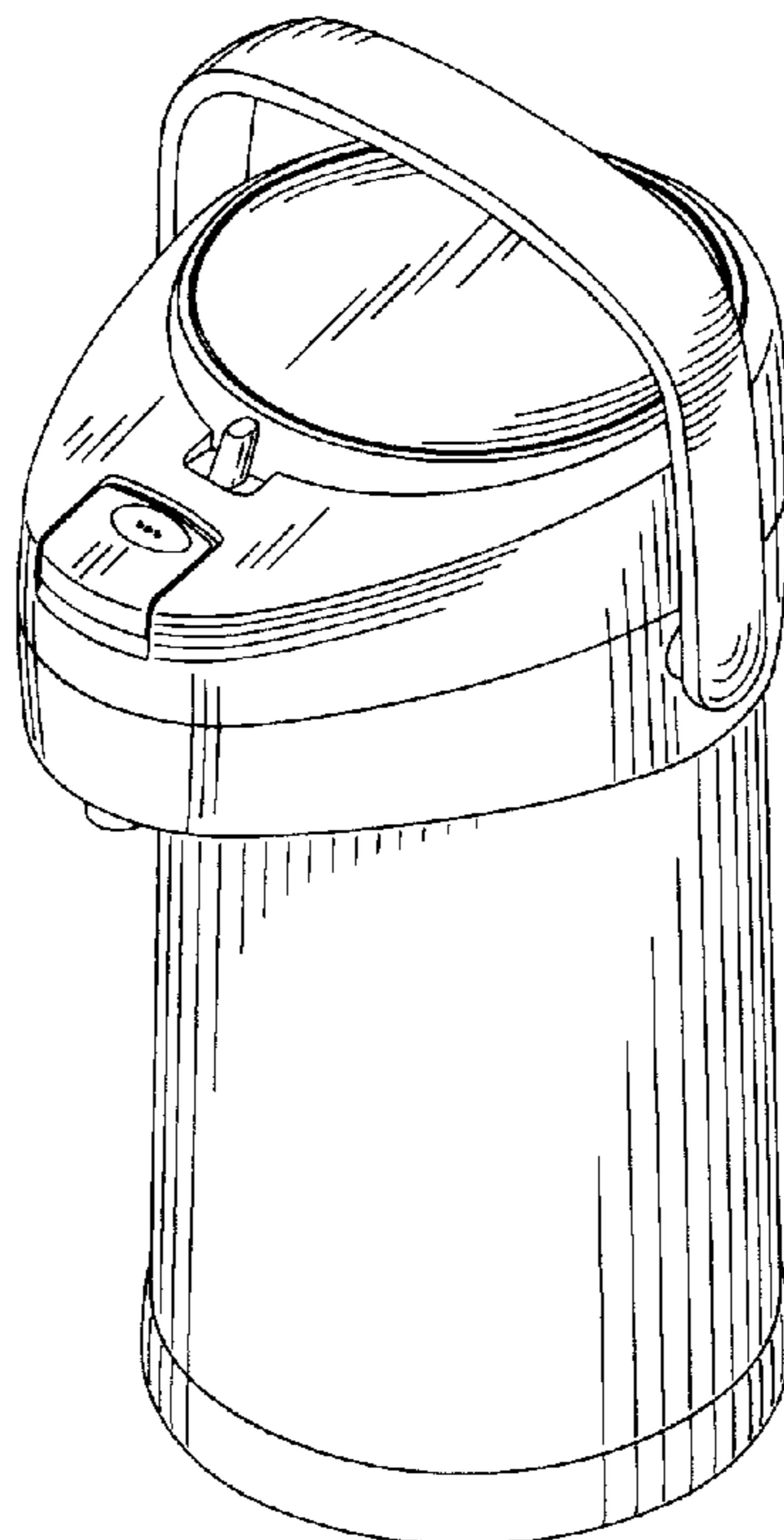

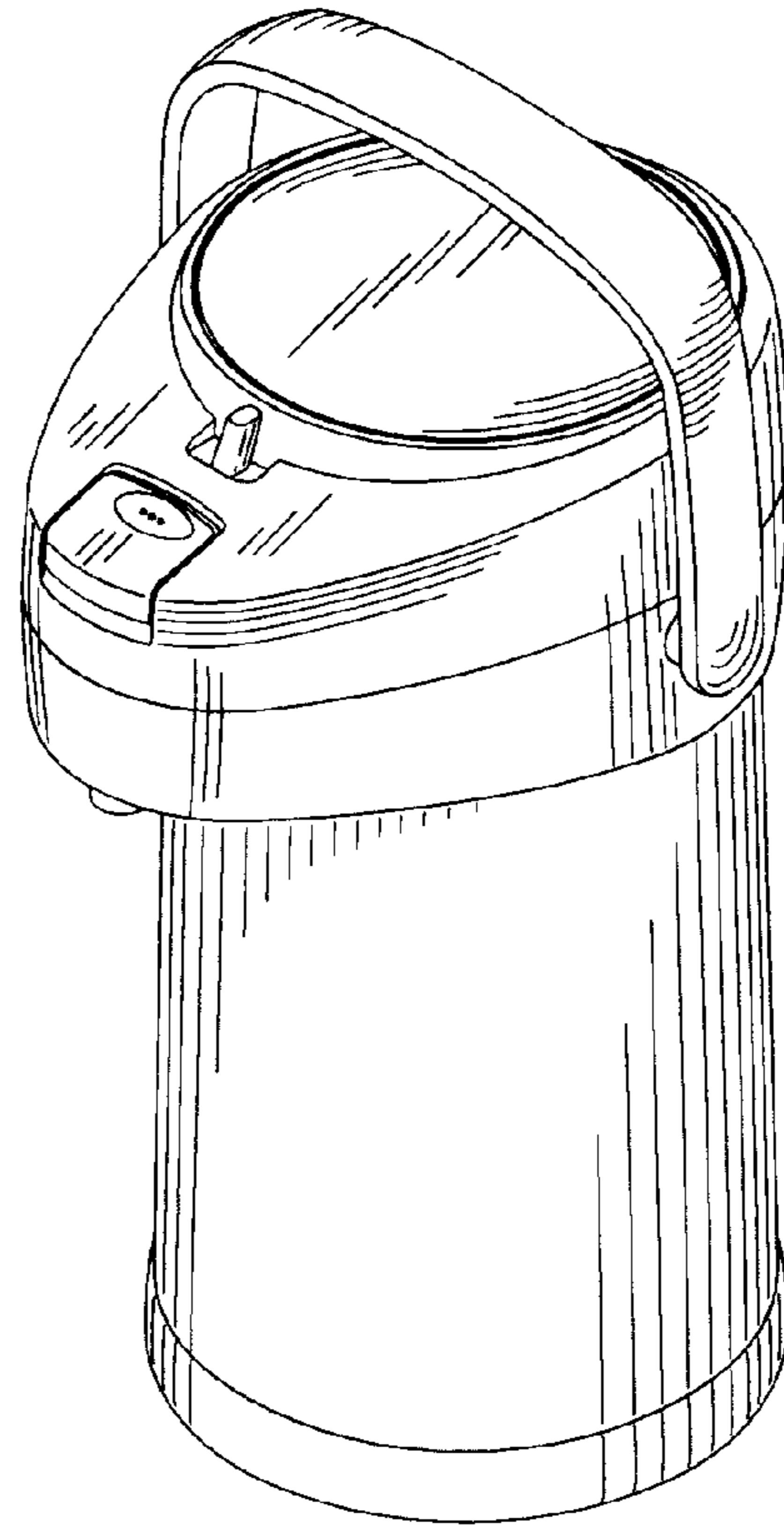

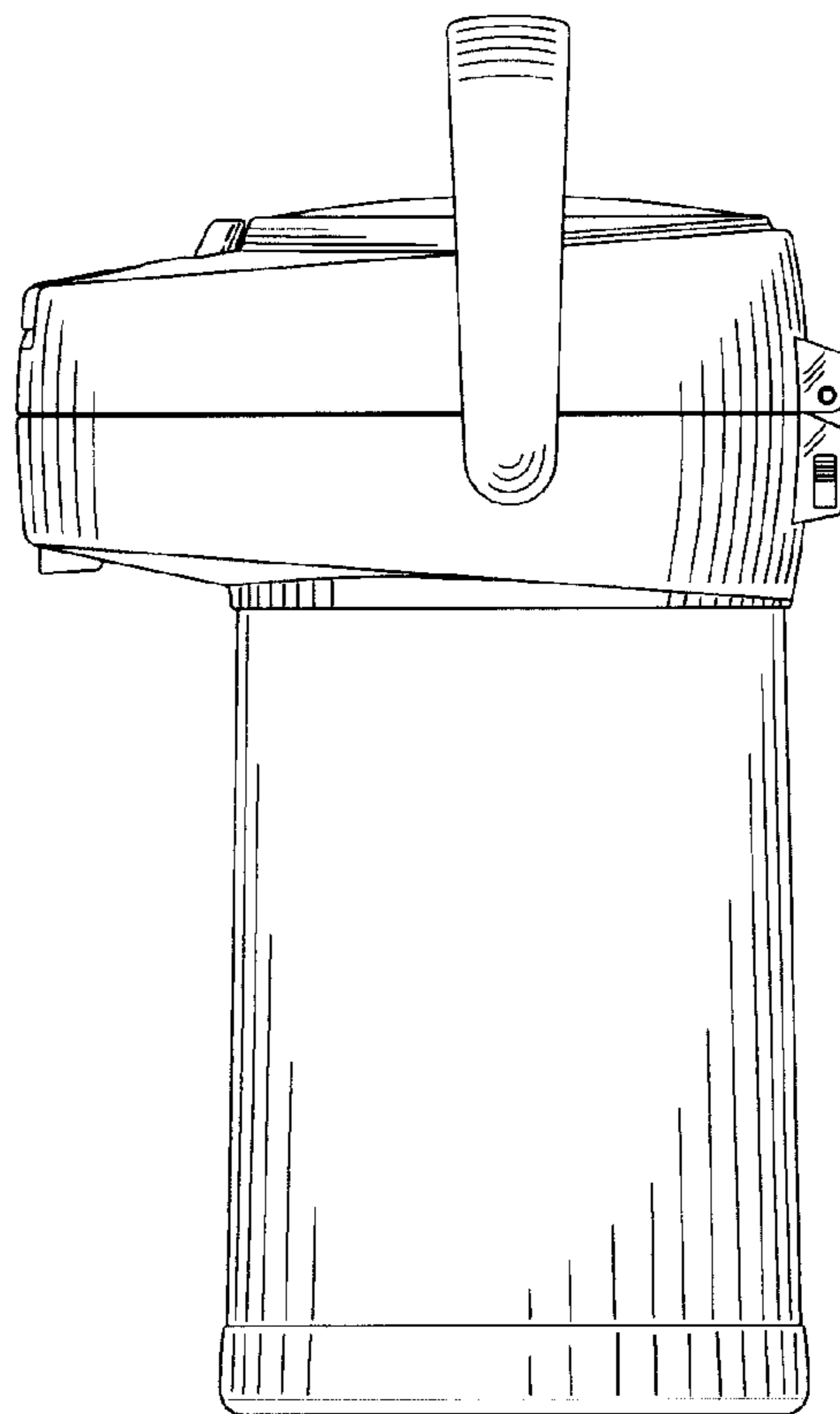

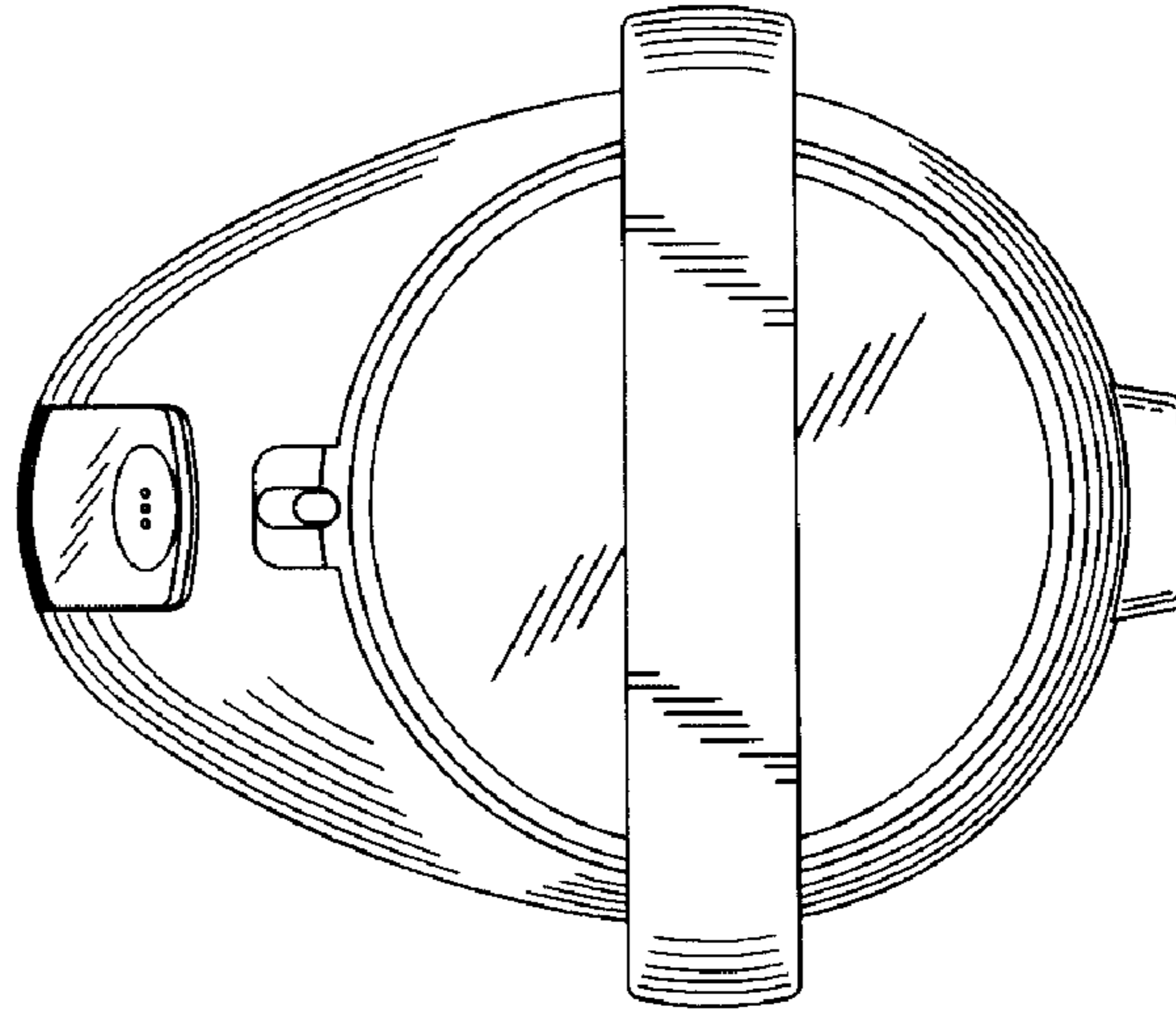

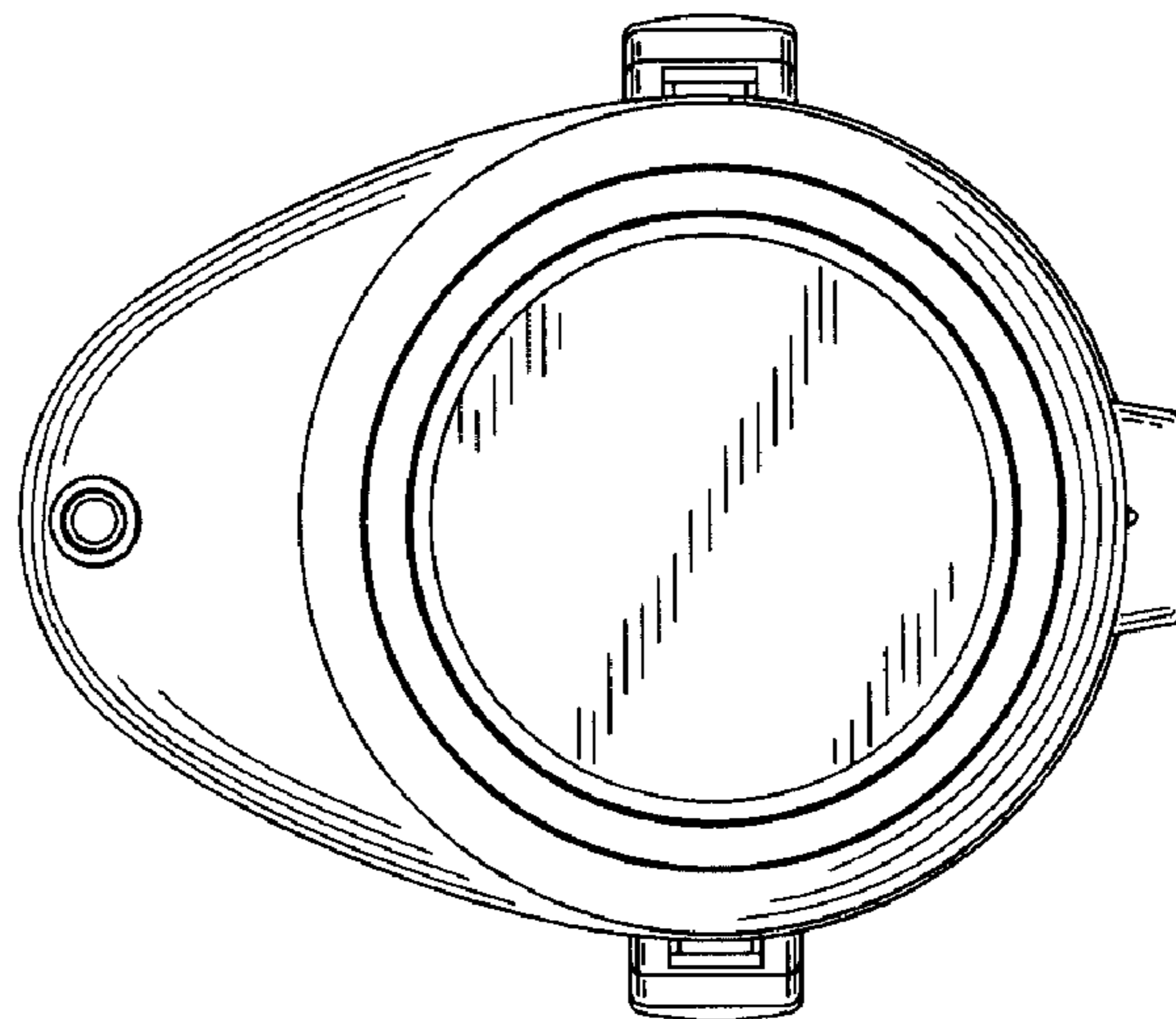

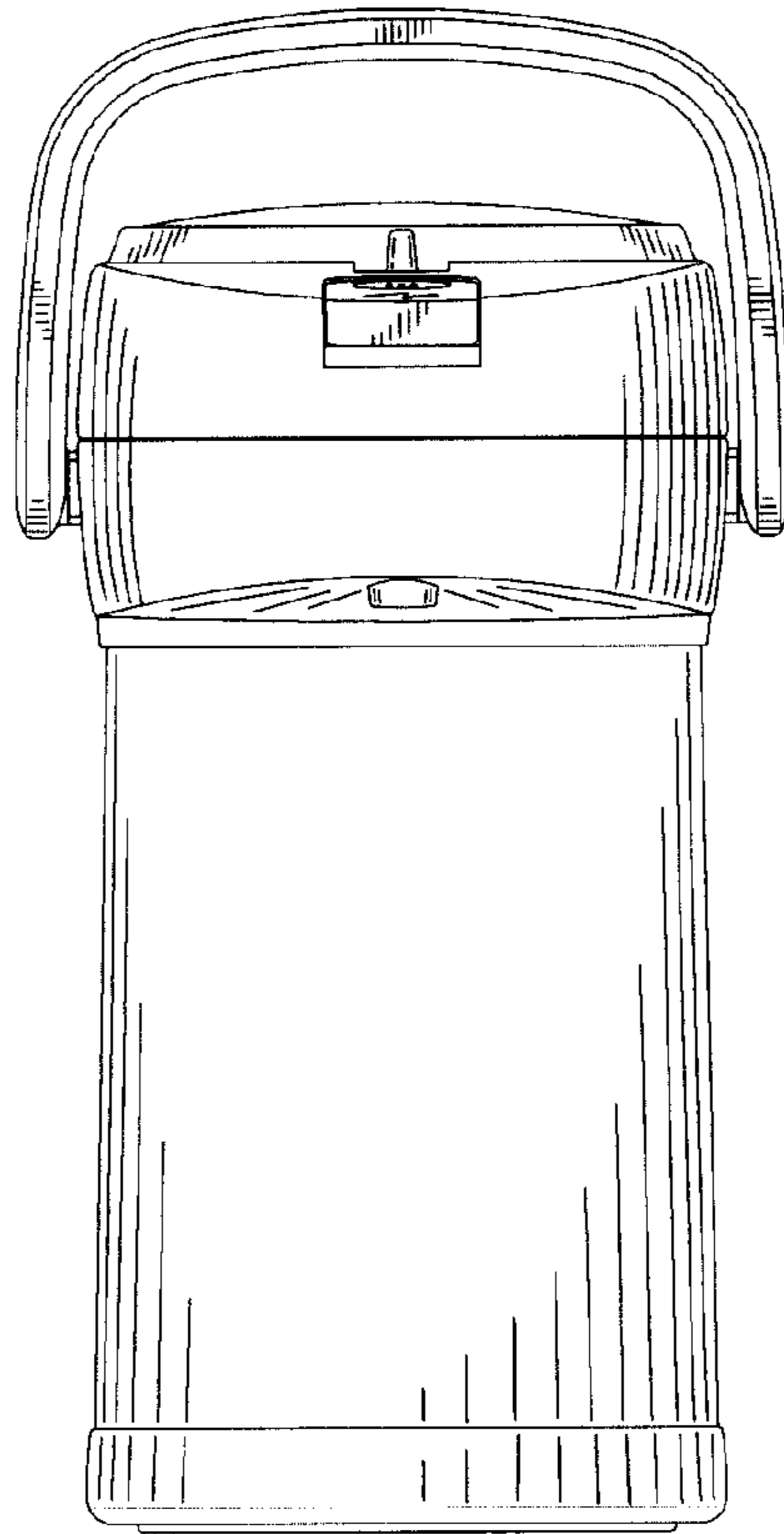
