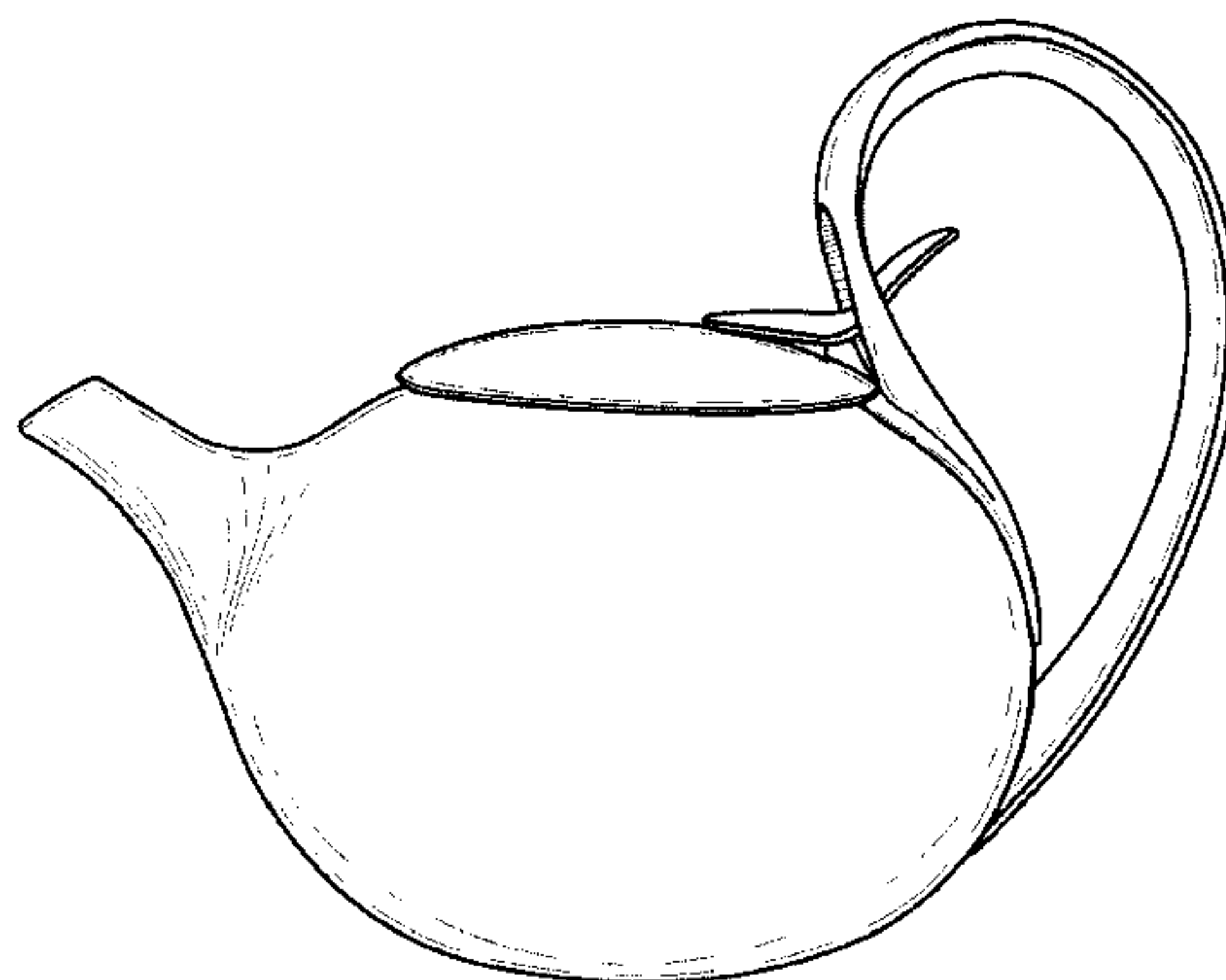
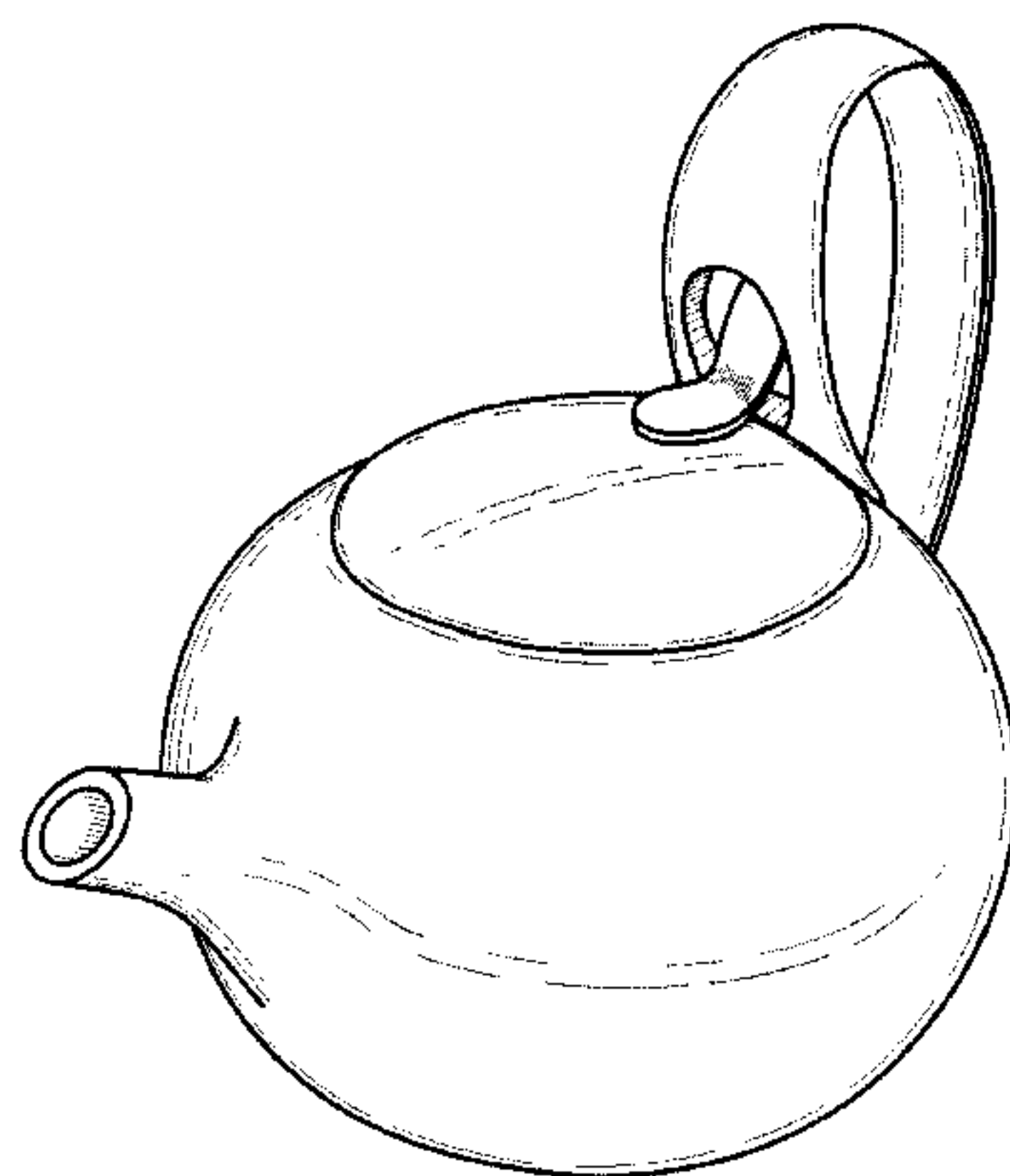

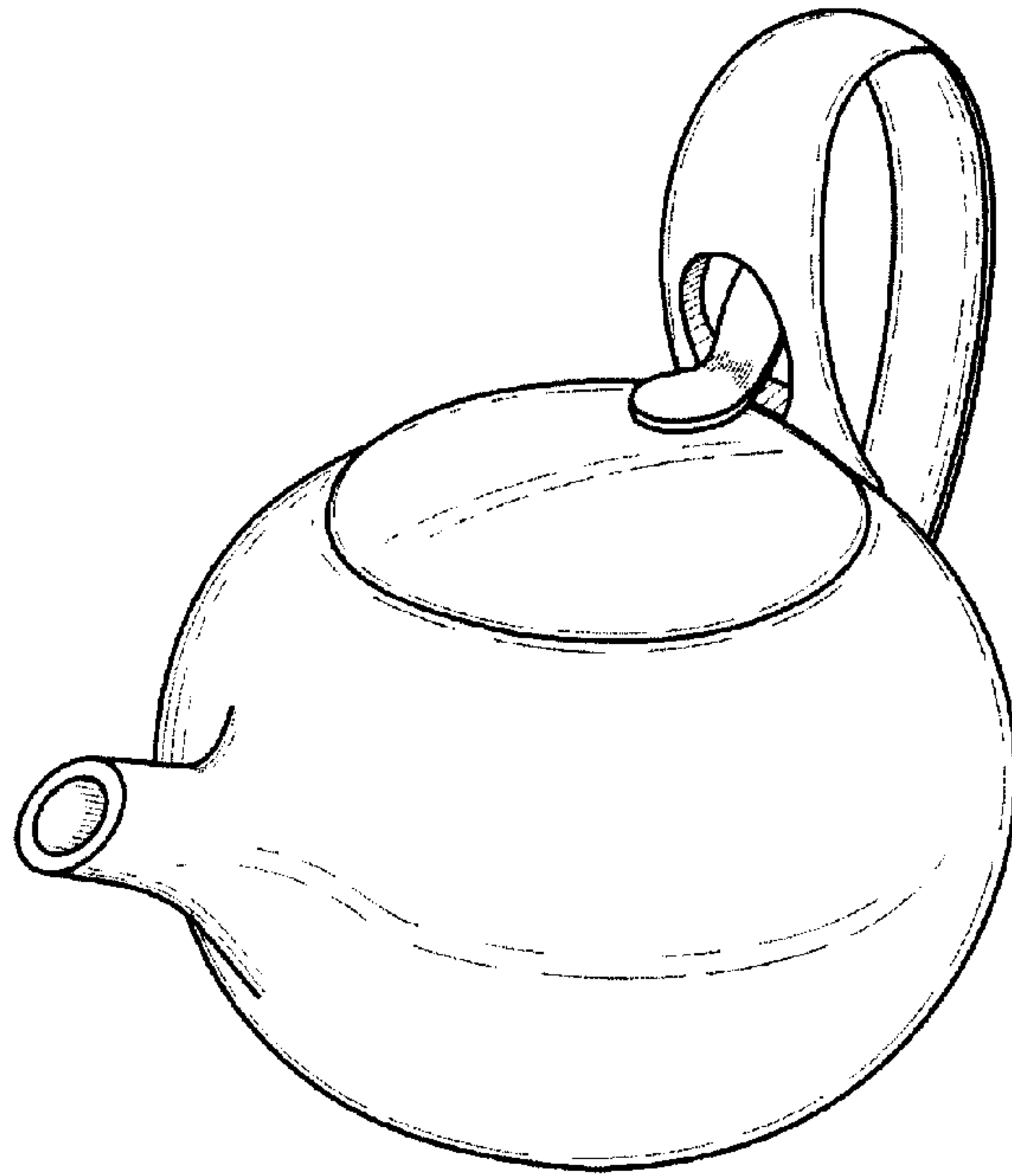
The ornamental design for a teapot, as shown.

**DESCRIPTION**

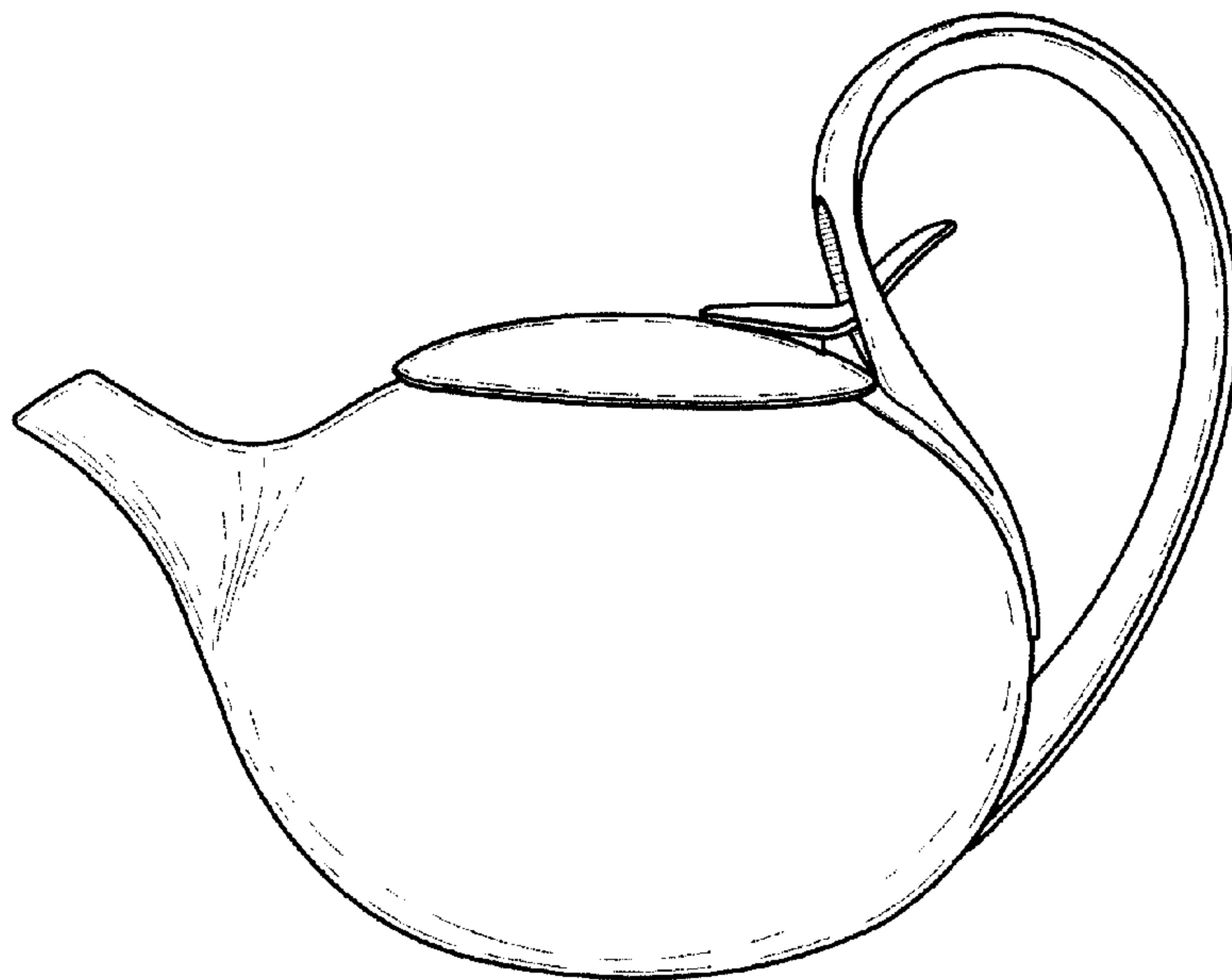
FIG. 1 is a front perspective view of the teapot, showing my new design;

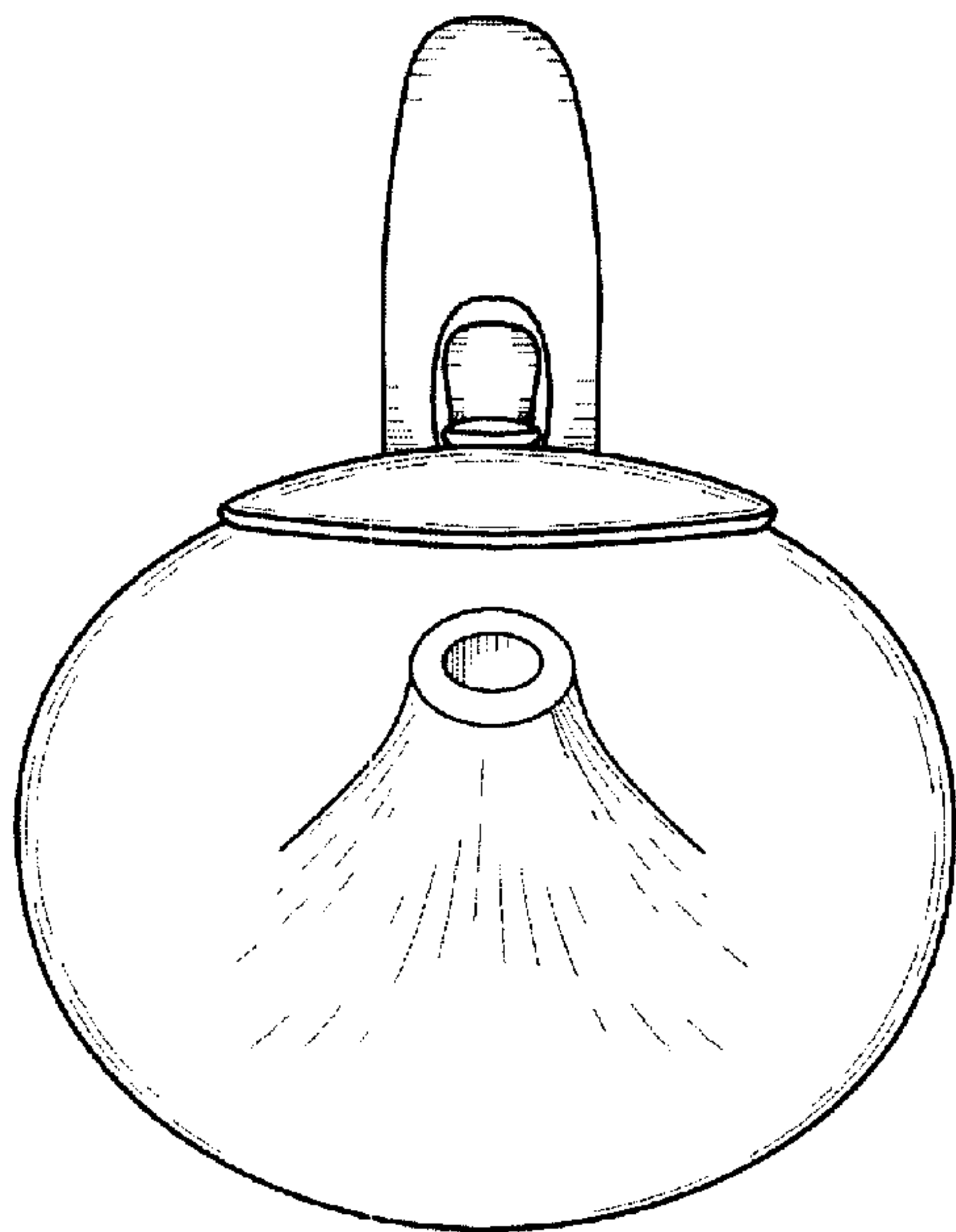




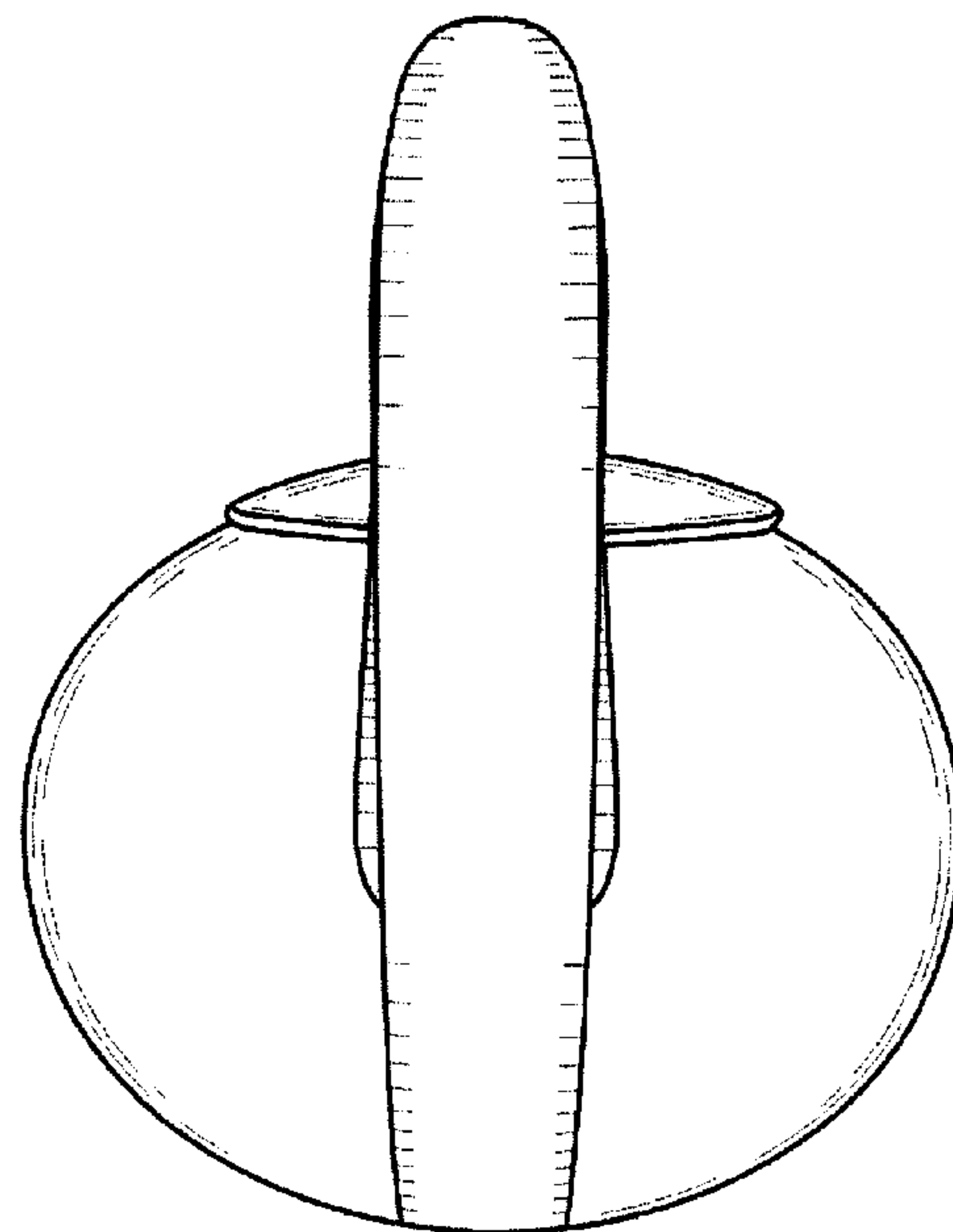

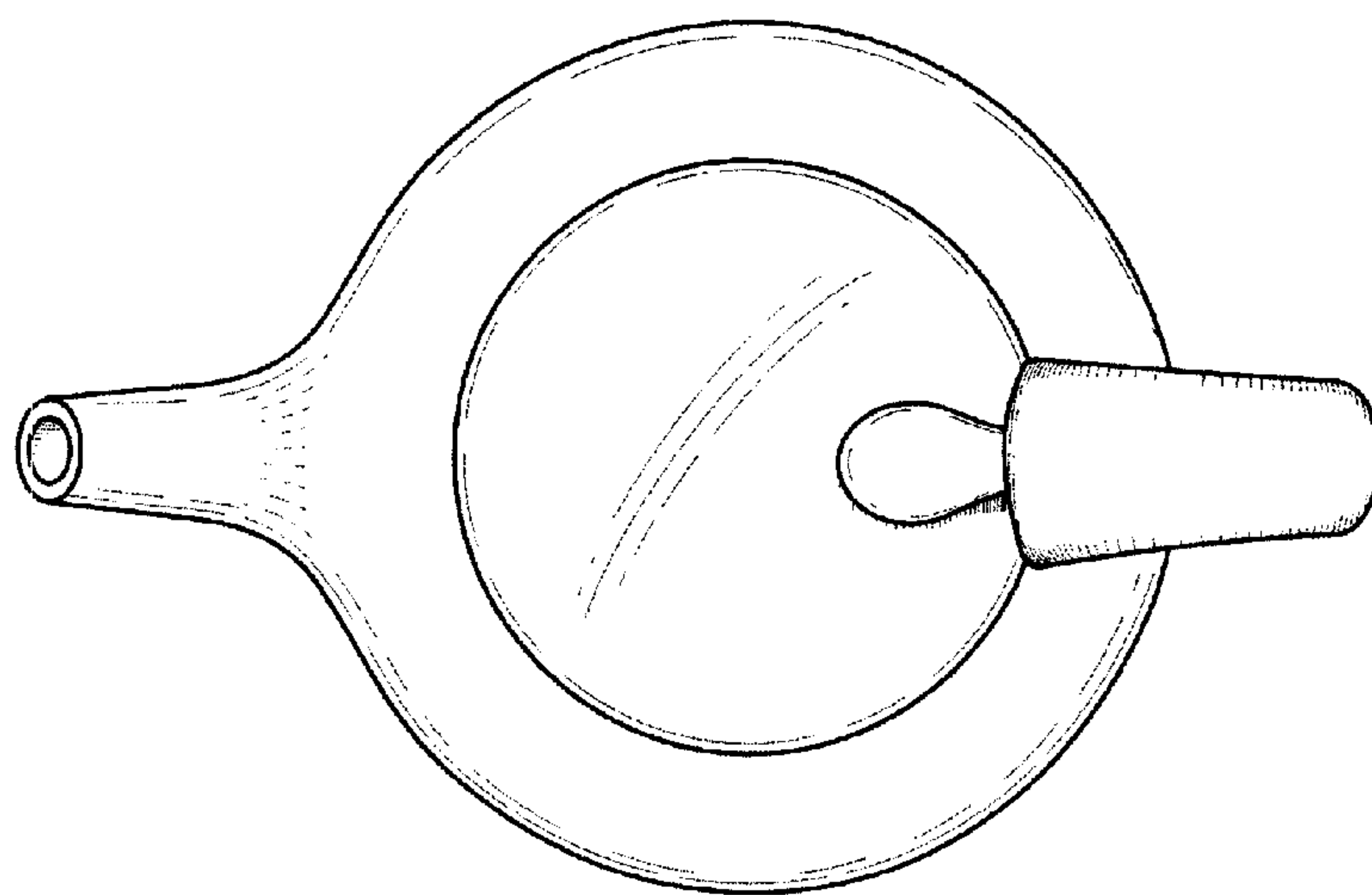

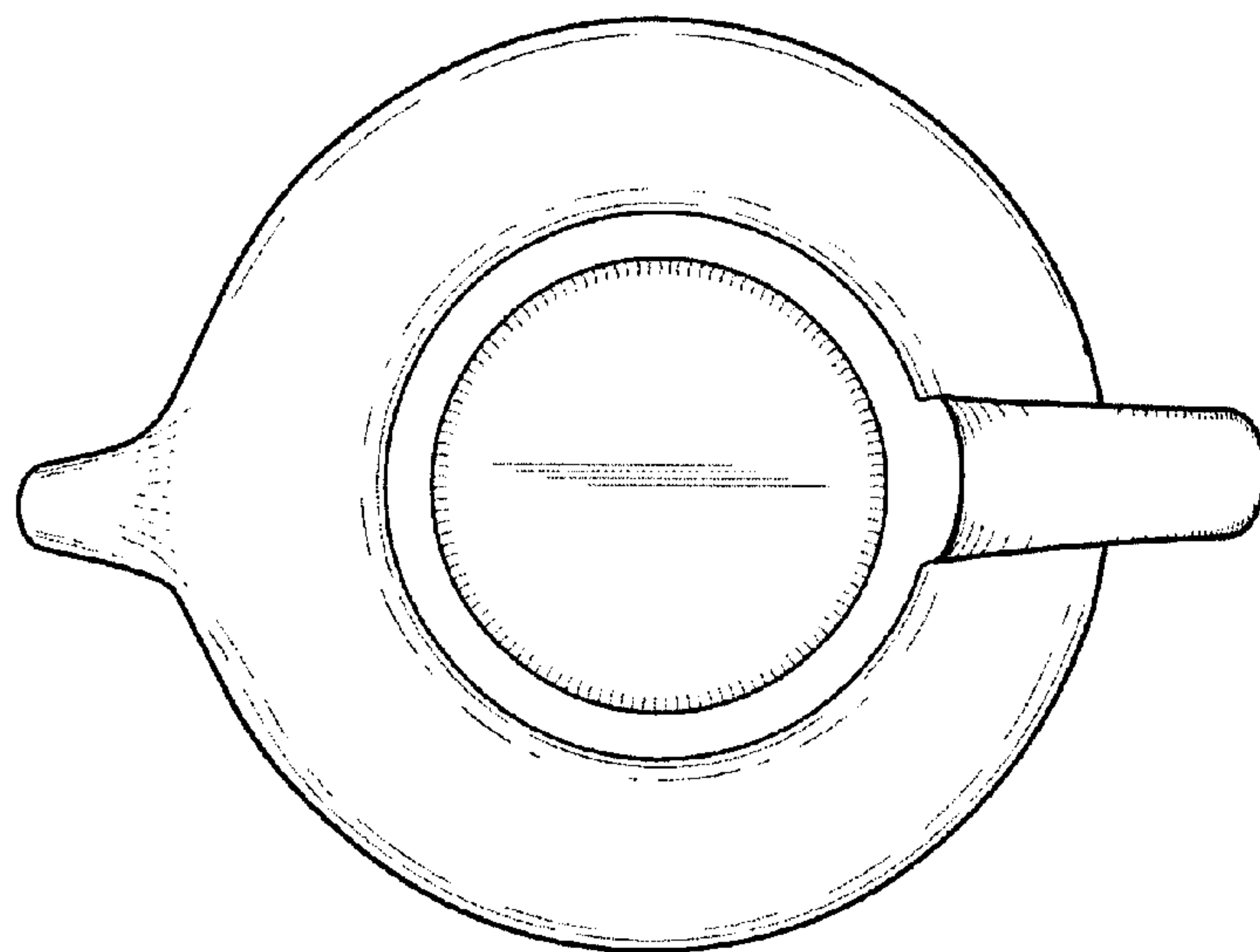

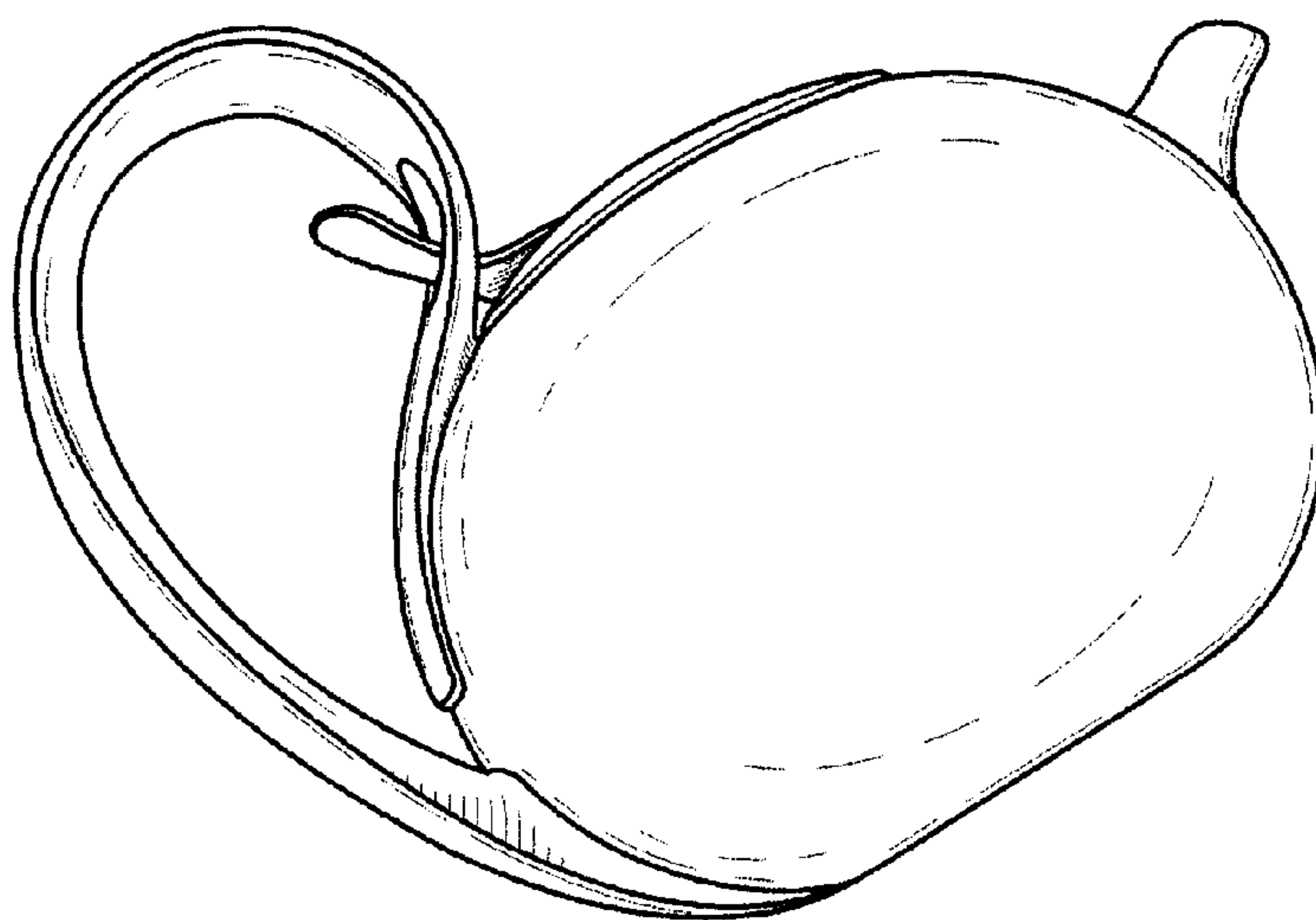
