(57) **CLAIM**

The ornamental design for a wristwatch, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the front and right side of a wristwatch showing our new design;
FIG. 2 is a front elevation thereof;
FIG. 3 is a perspective view of the rear and right side thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof; and
FIG. 7 is a top plan view thereof; and
FIG. 8 is a bottom plan view thereof.

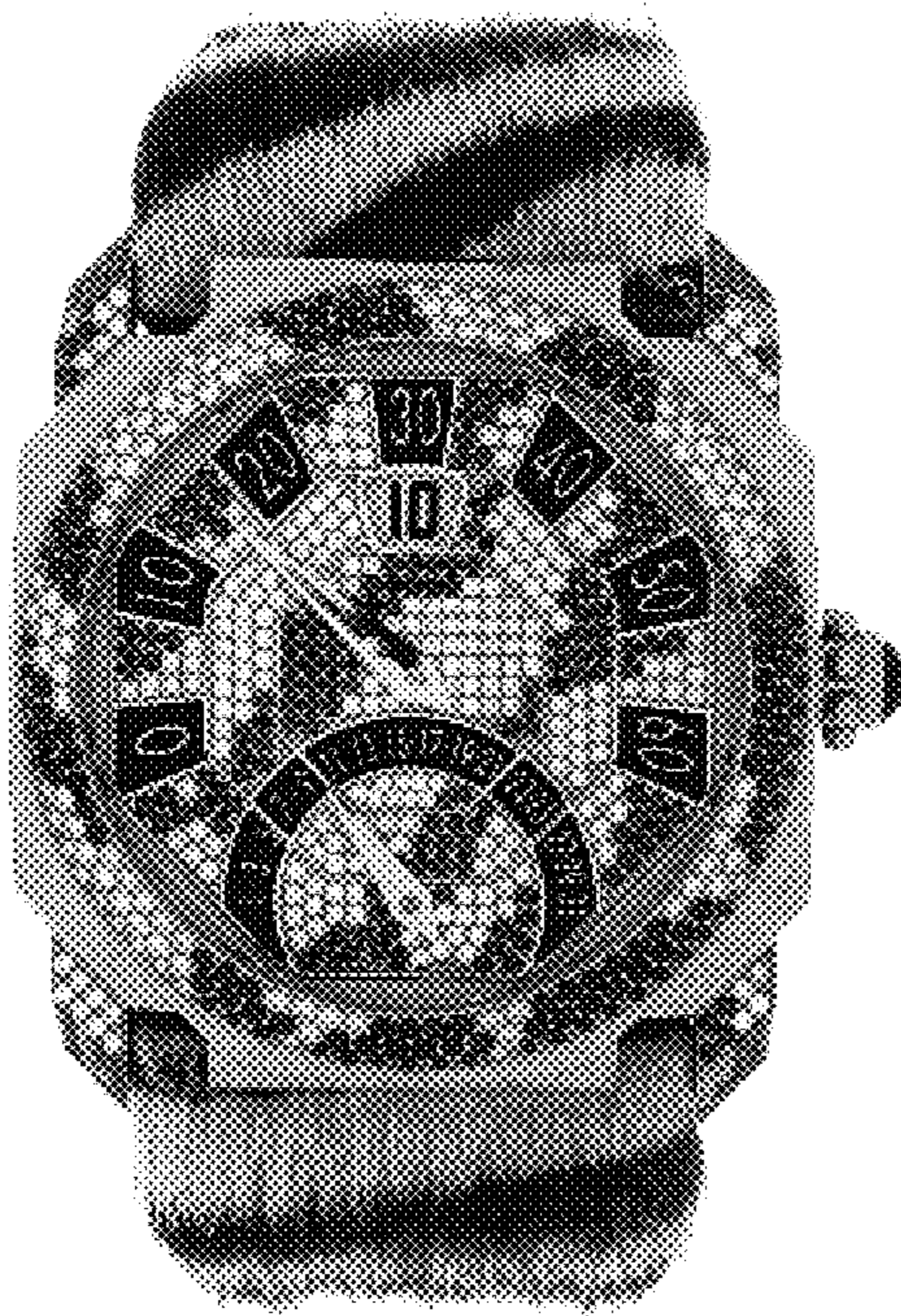

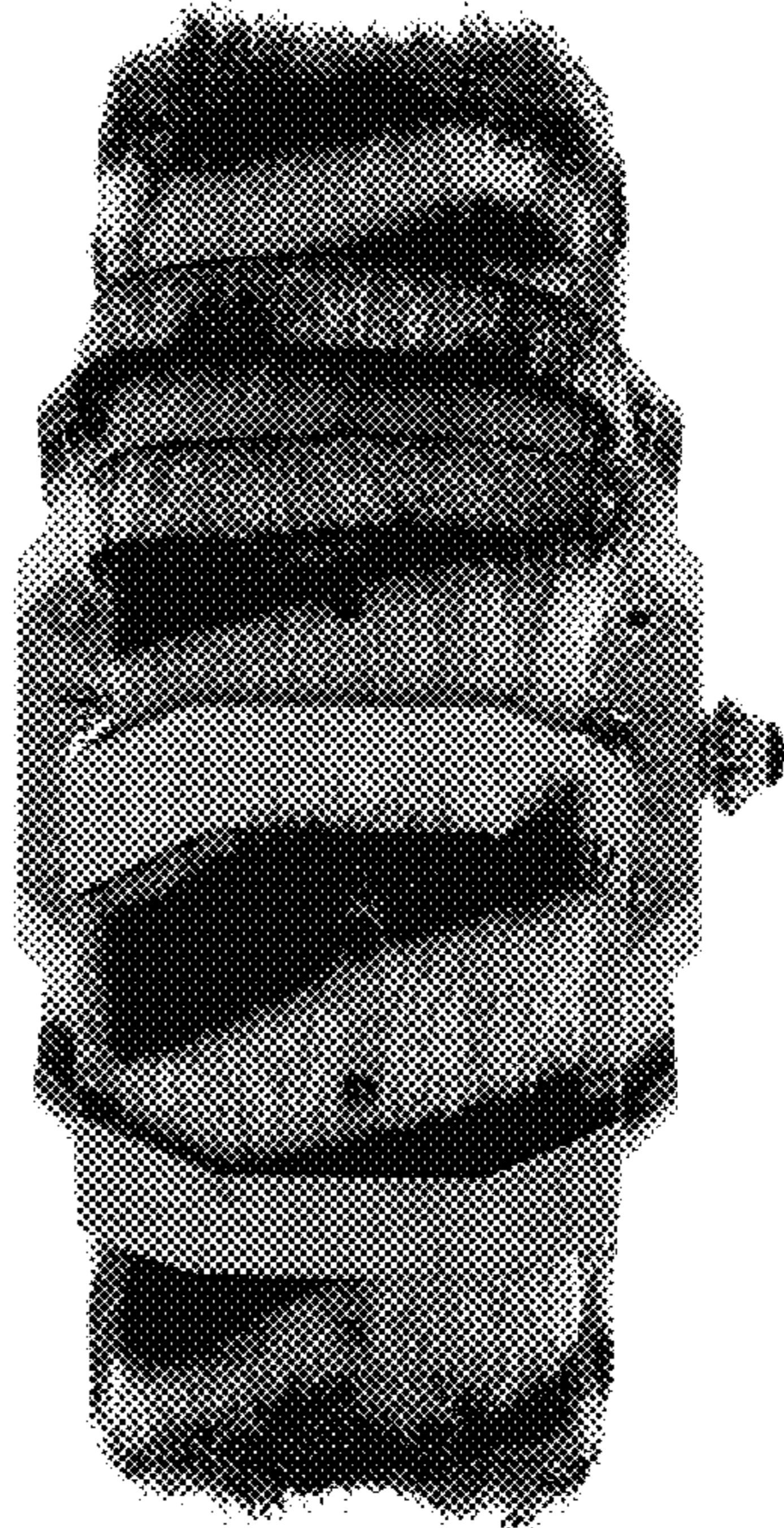

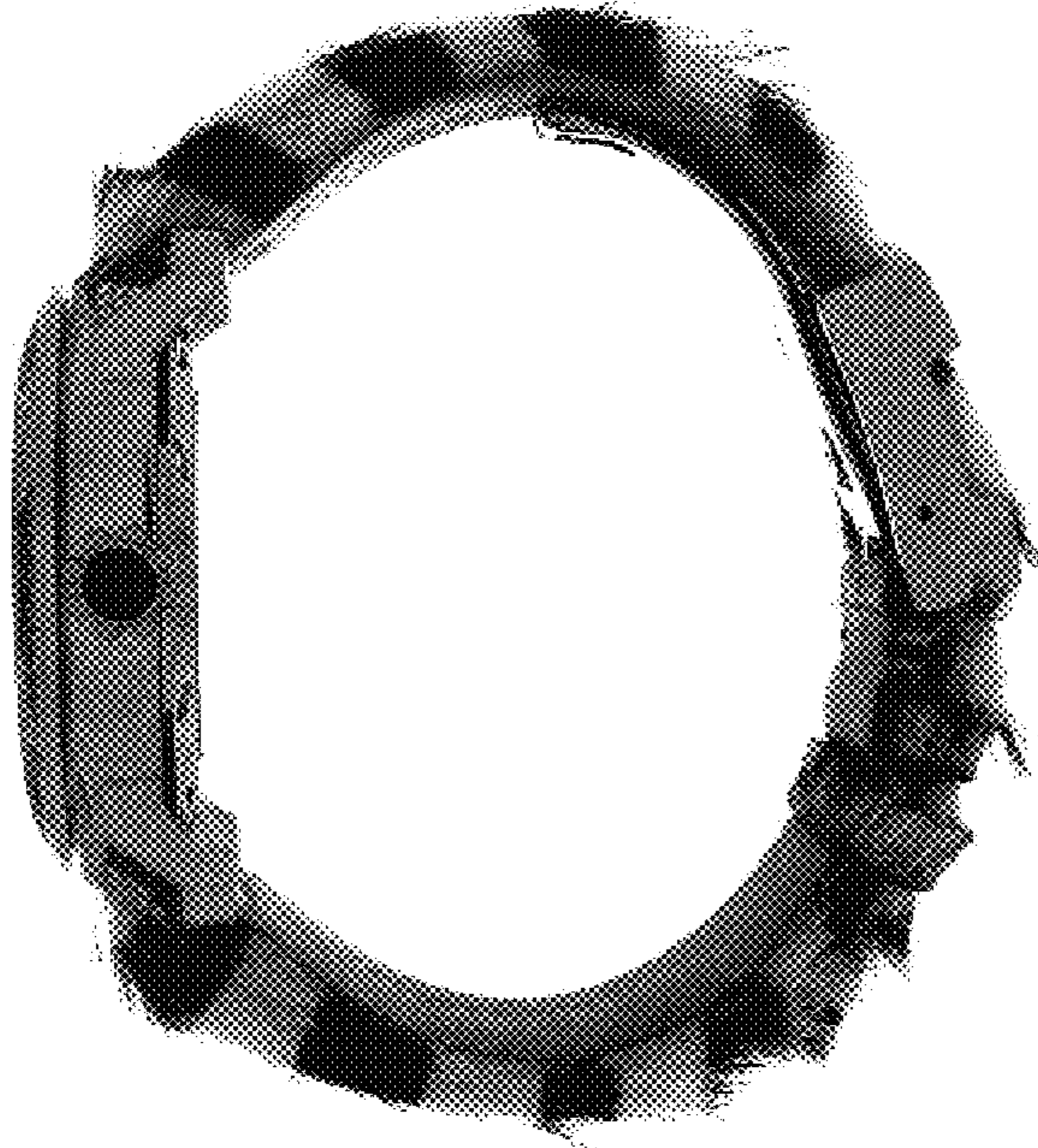

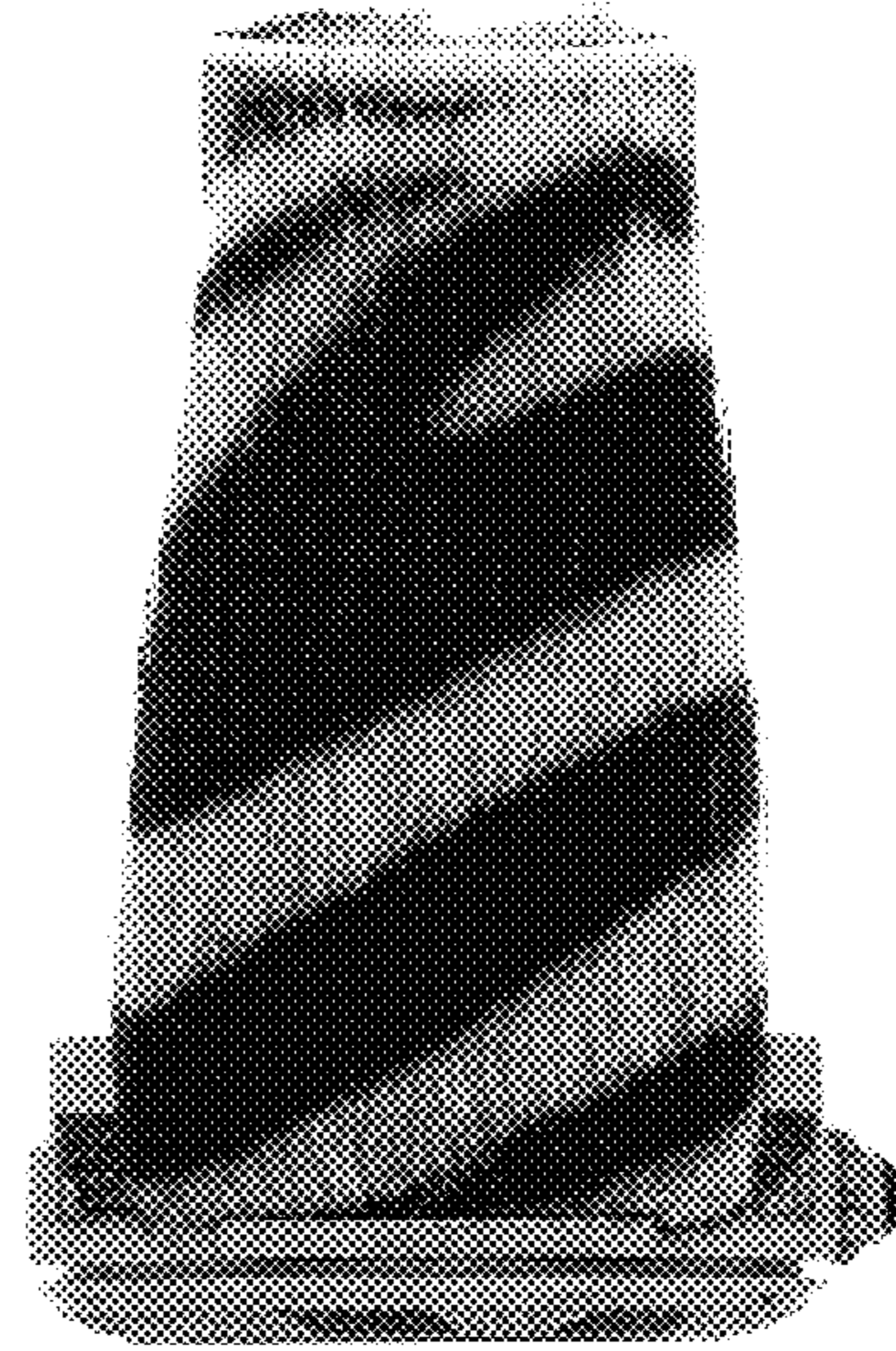

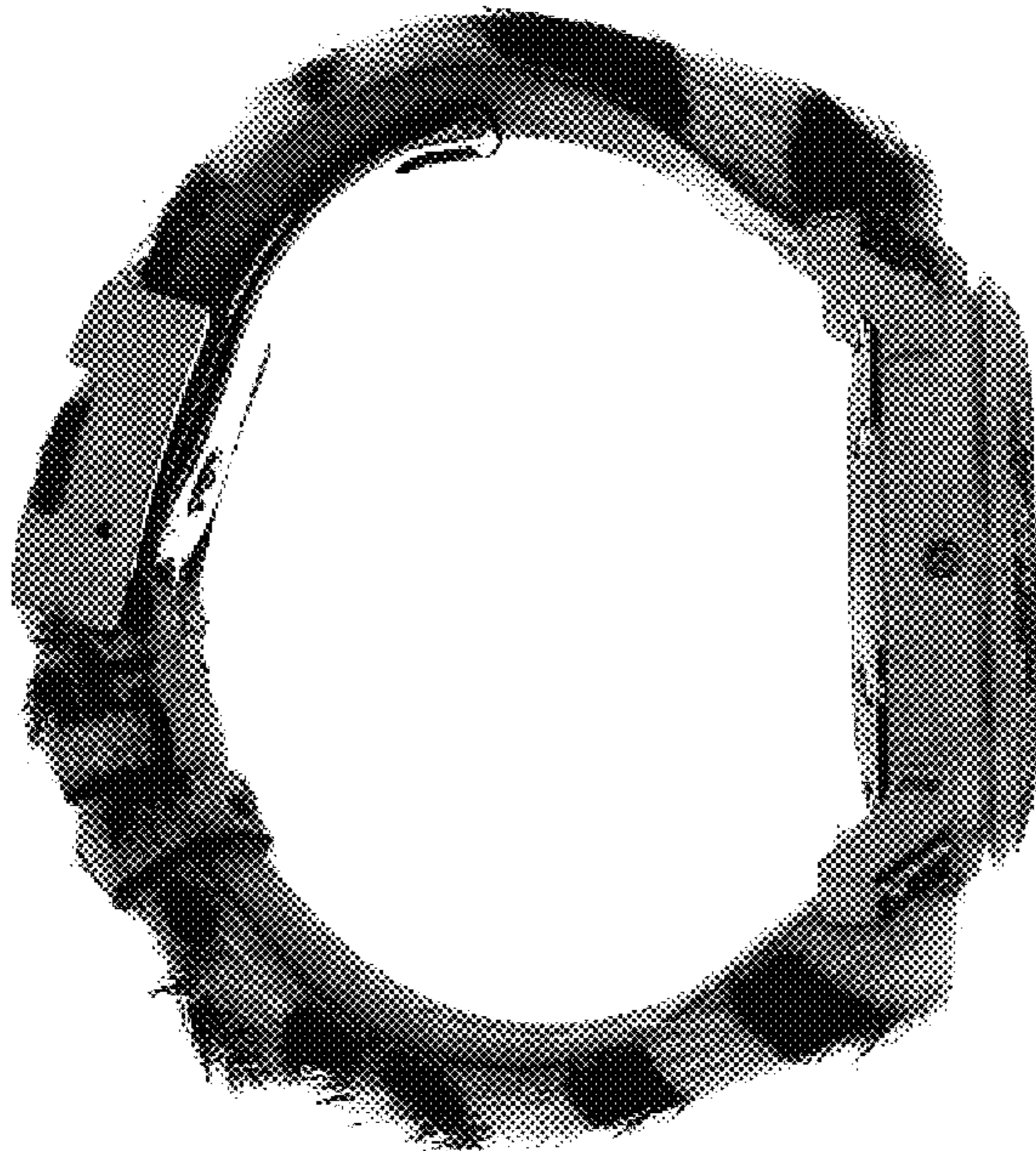
