(57) **CLAIM**

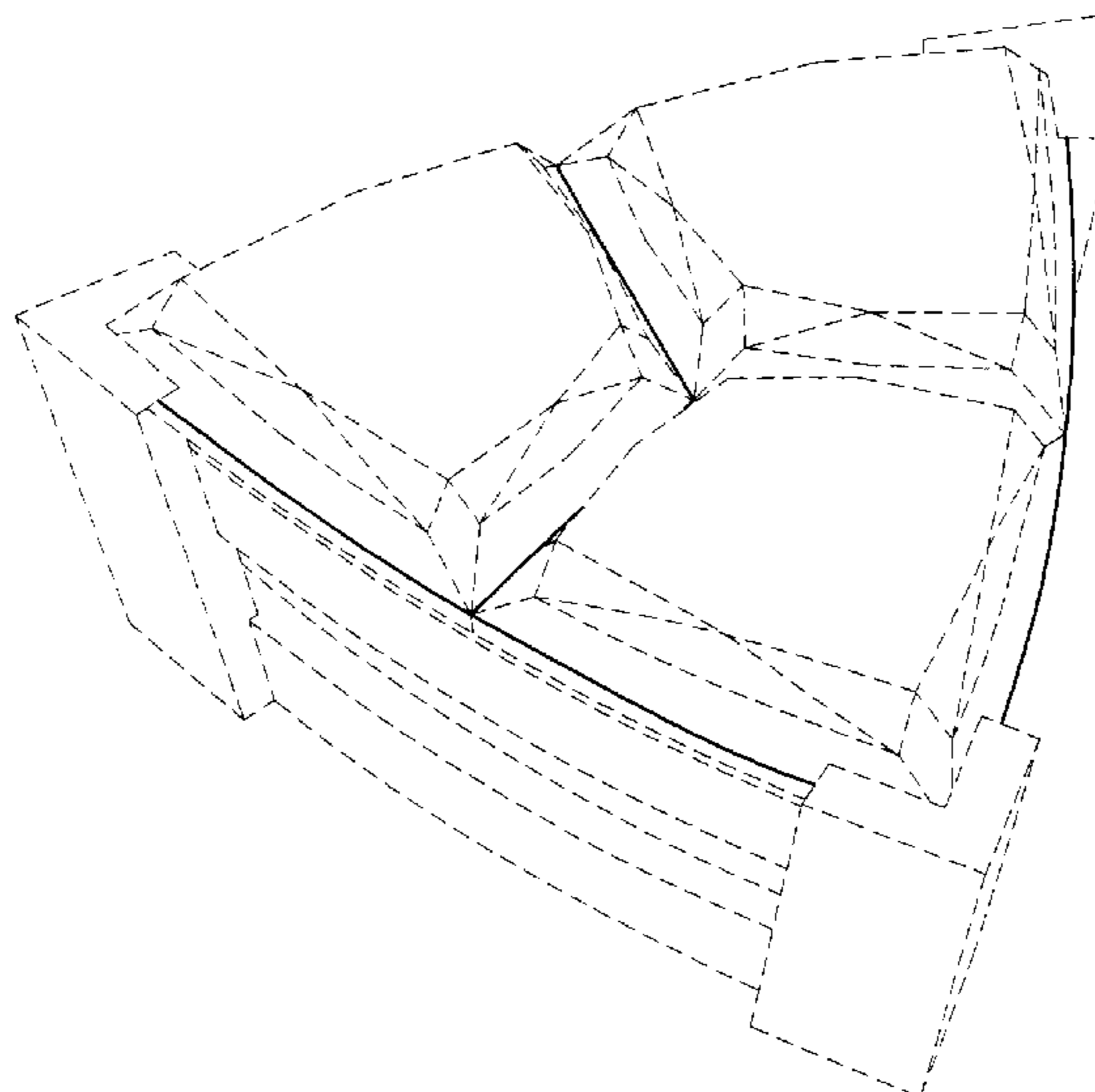
The ornamental design of the jewelry arrangement, as shown and described.

DESCRIPTION

FIG. 1 is a top view of an exemplary embodiment of a jewelry arrangement showing my new design;
FIG. 2 is a bottom side view of the jewelry arrangement of FIG. 1;
FIG. 3 is a right side view of the jewelry arrangement of FIG. 1;
FIG. 4 is a left side view of the jewelry arrangement of FIG. 1; and,

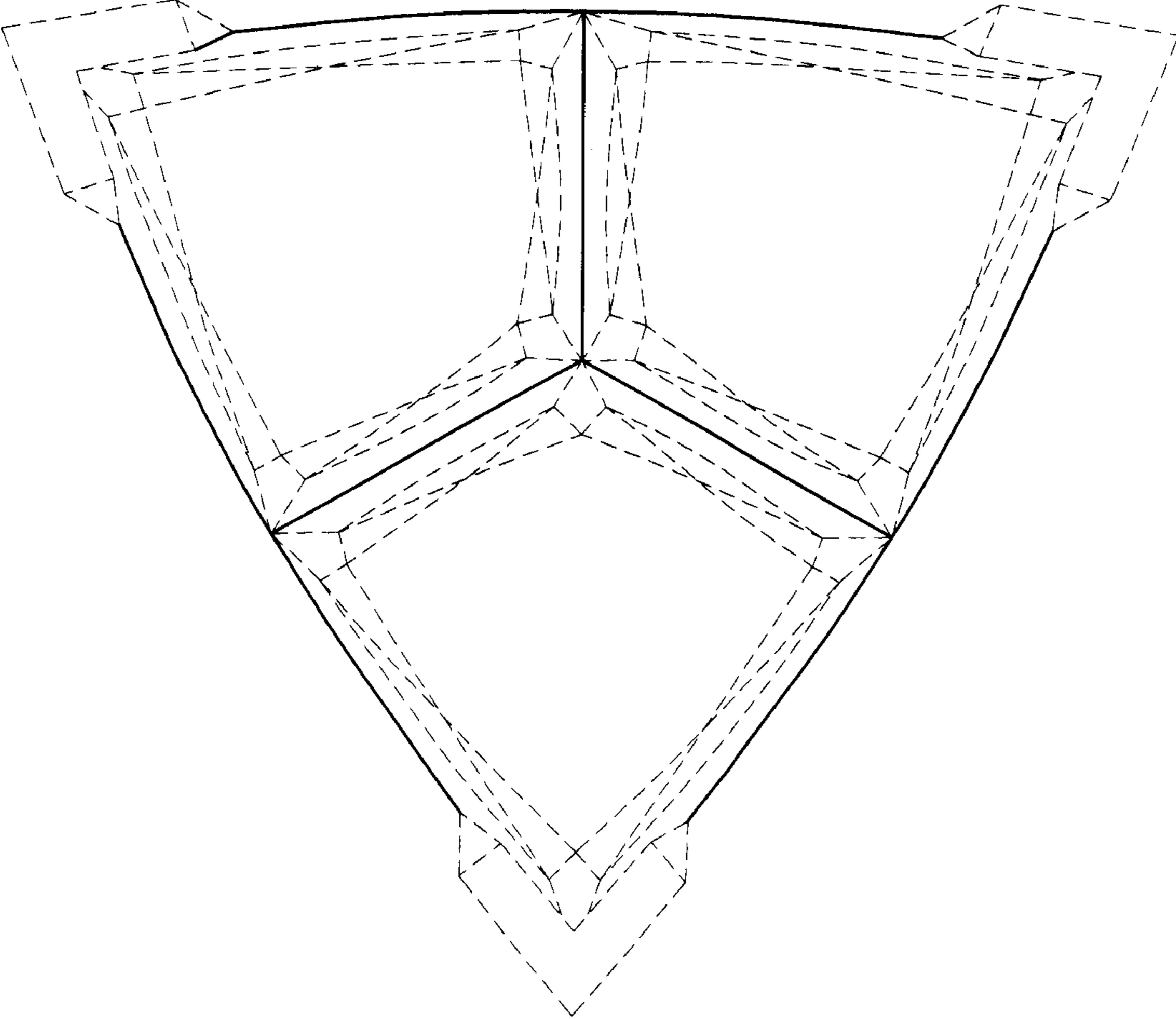

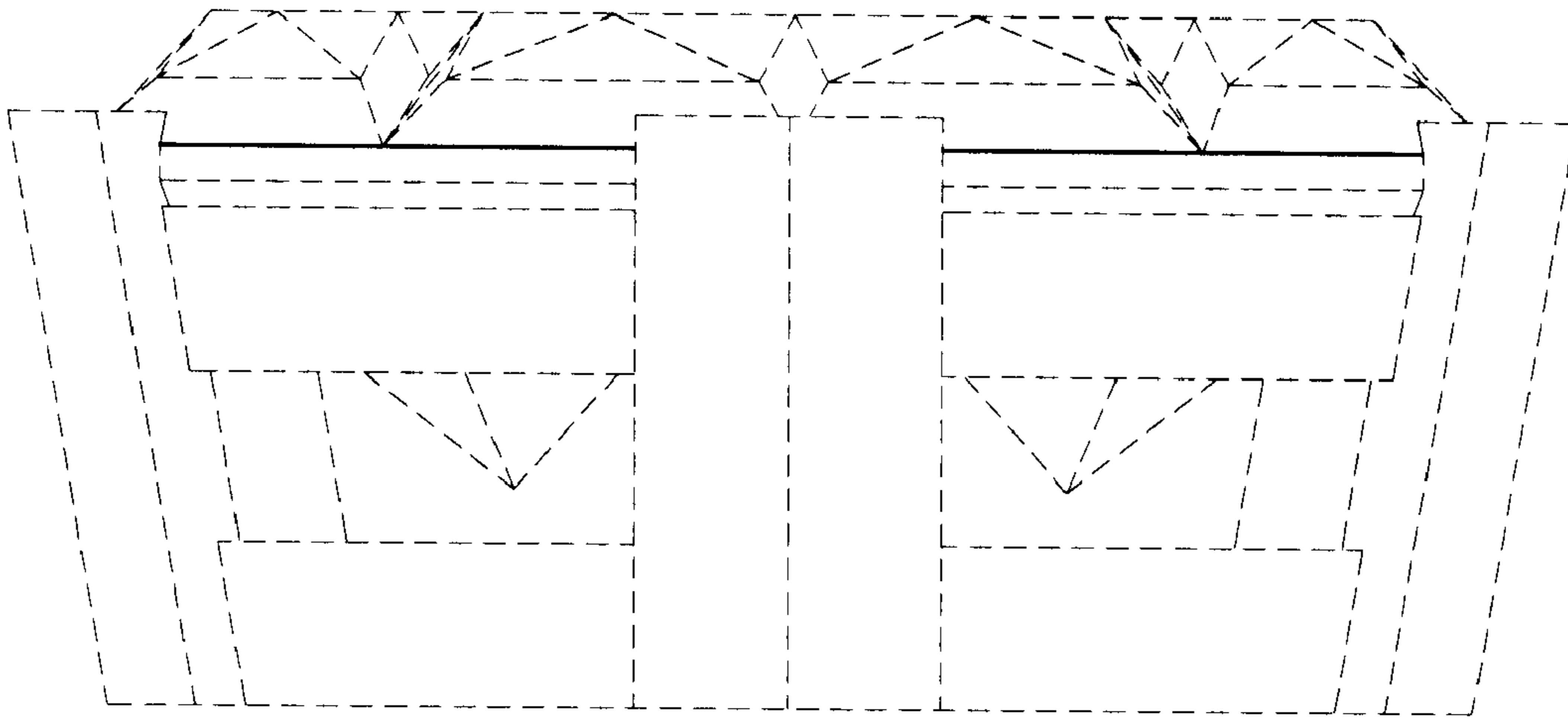

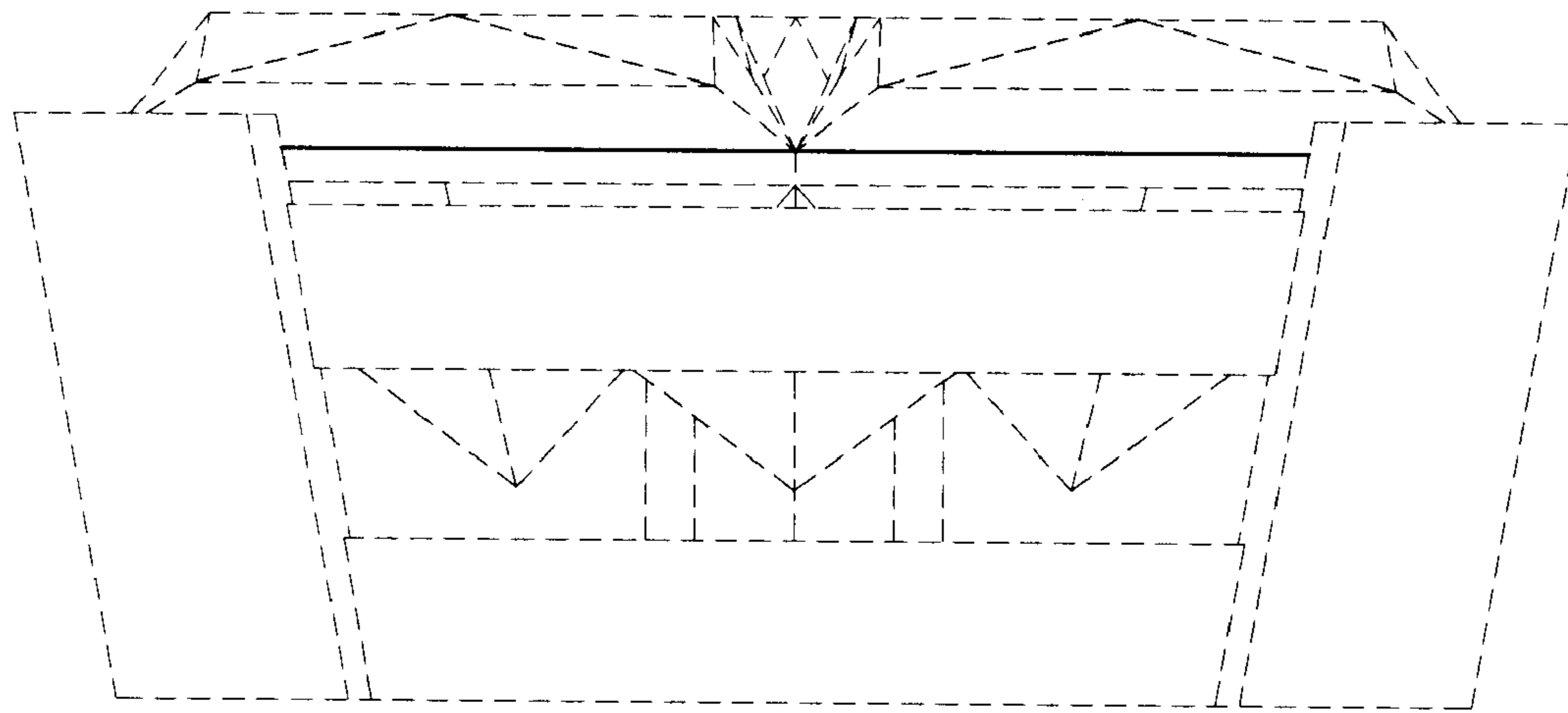

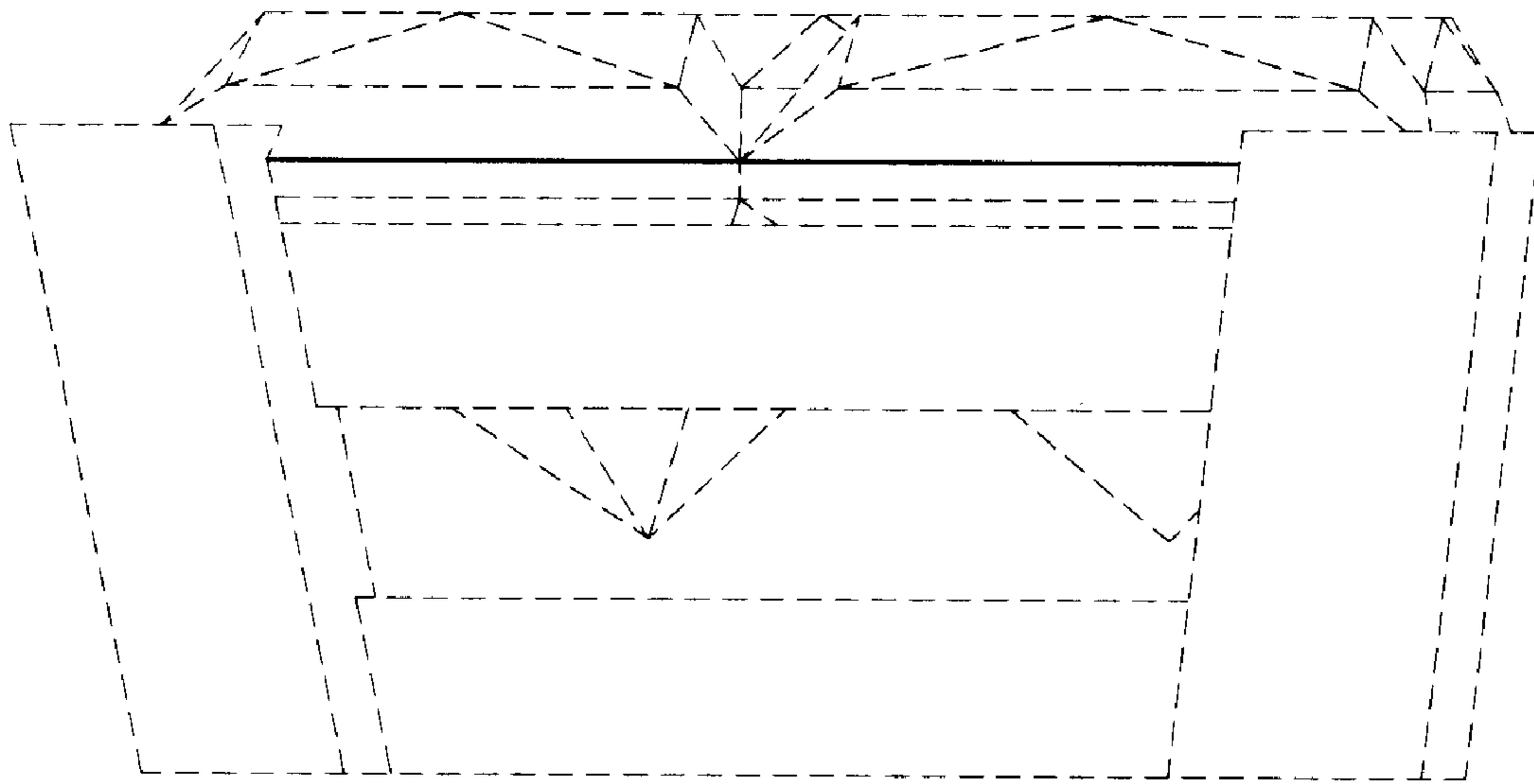

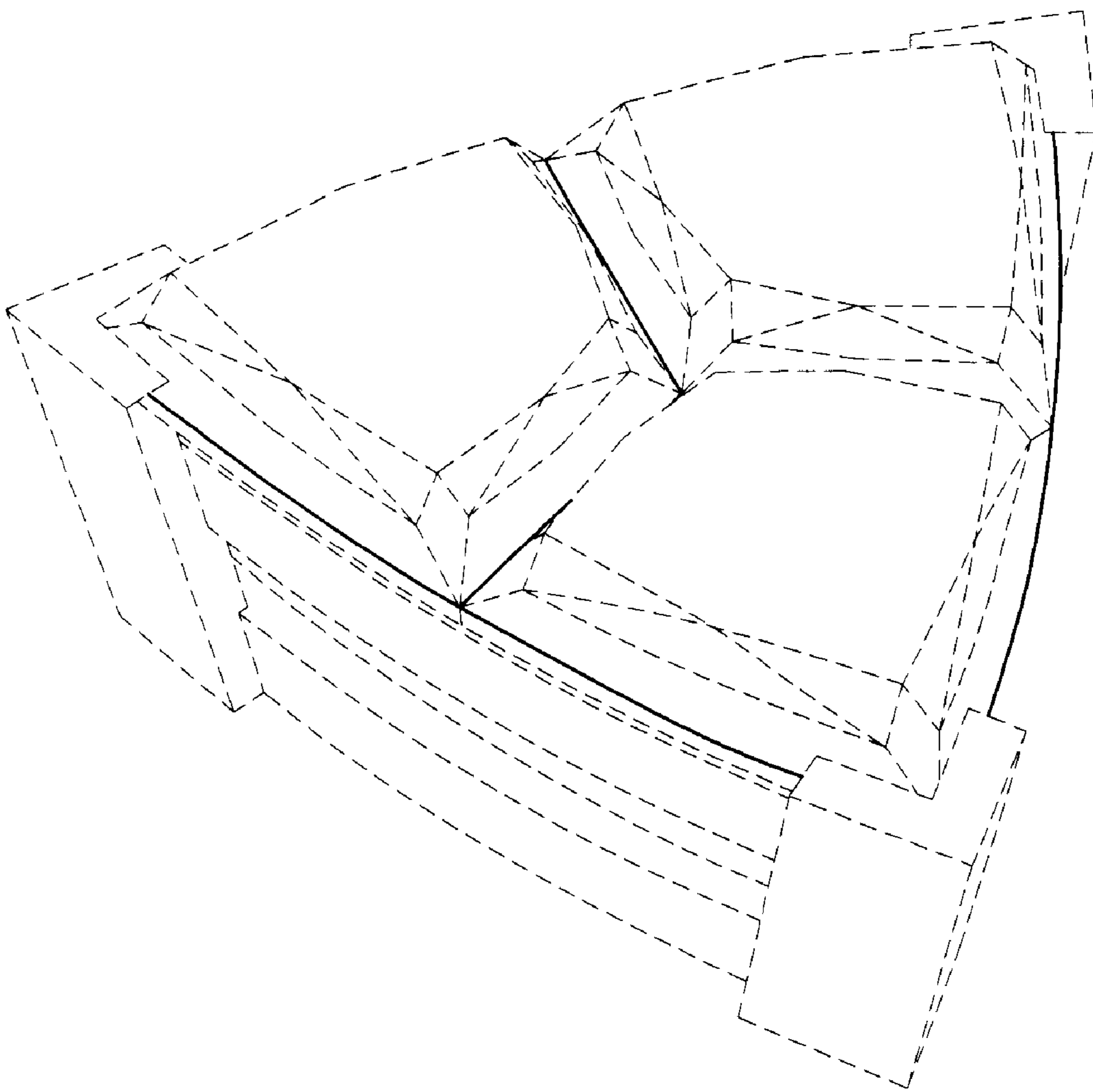
