(57) **CLAIM**

I claim the ornamental design for a handset for cordless telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a handset for cordless telephone of the present invention; FIG. 2 is a front view thereof; FIG. 3 is a top view thereof; FIG. 4 is a first side view thereof; FIG. 5 is a second side view thereof; FIG. 6 is a bottom view thereof; and, FIG. 7 is a rear view thereof.

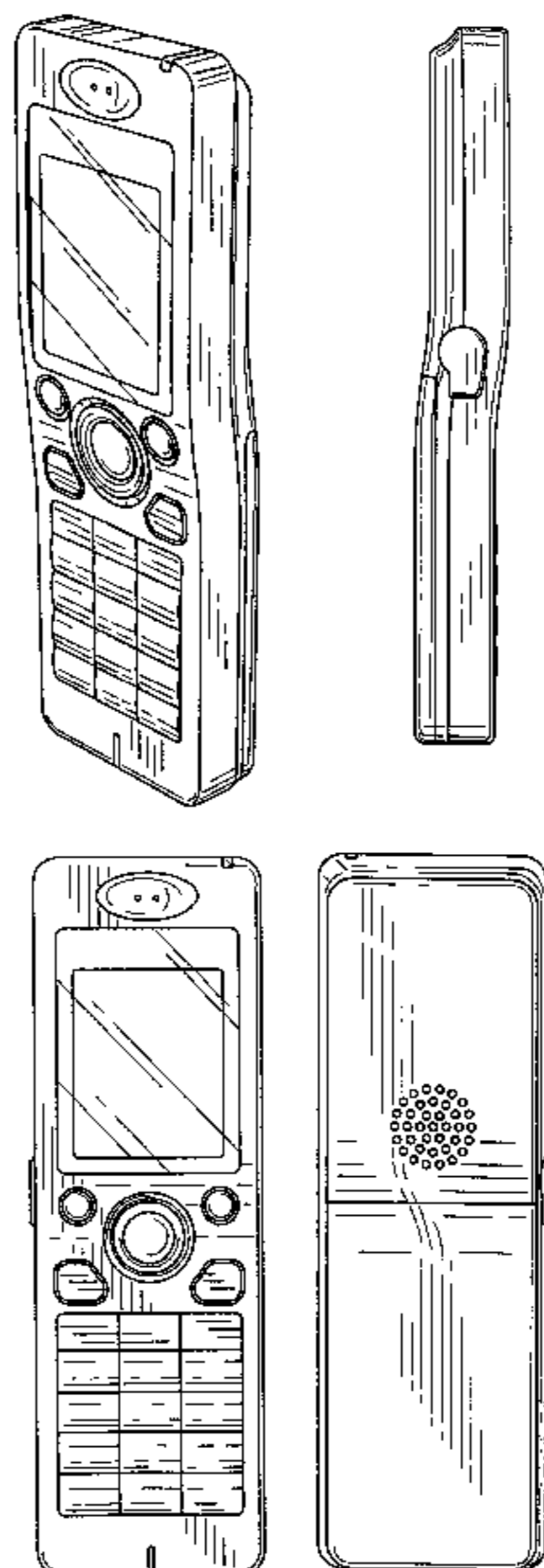

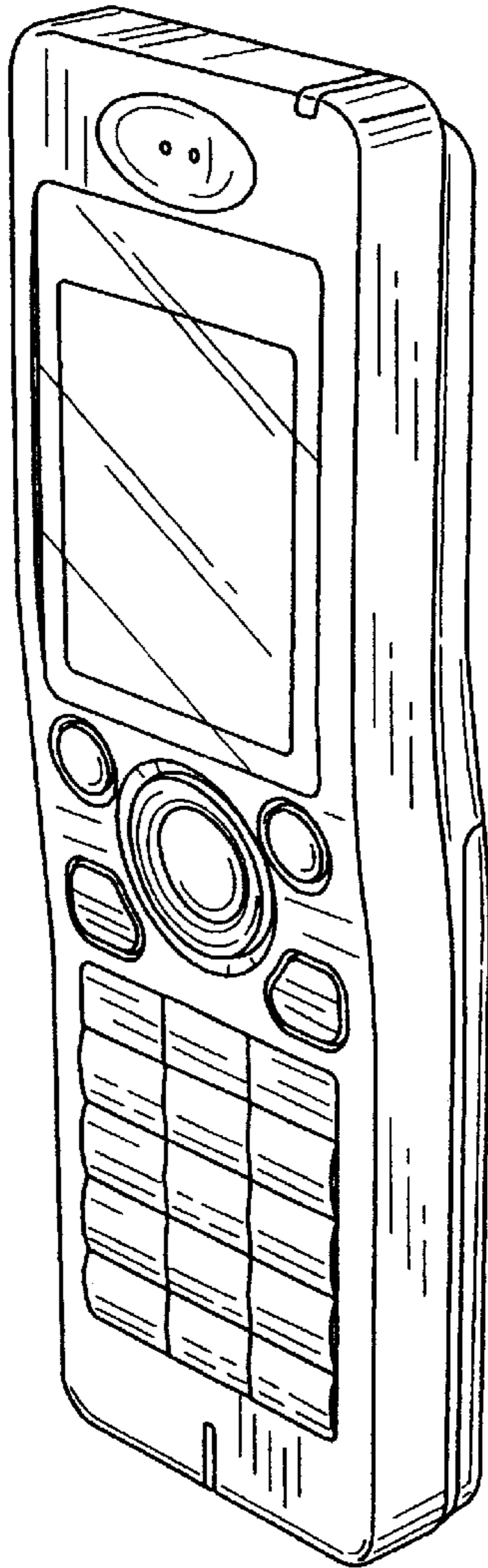

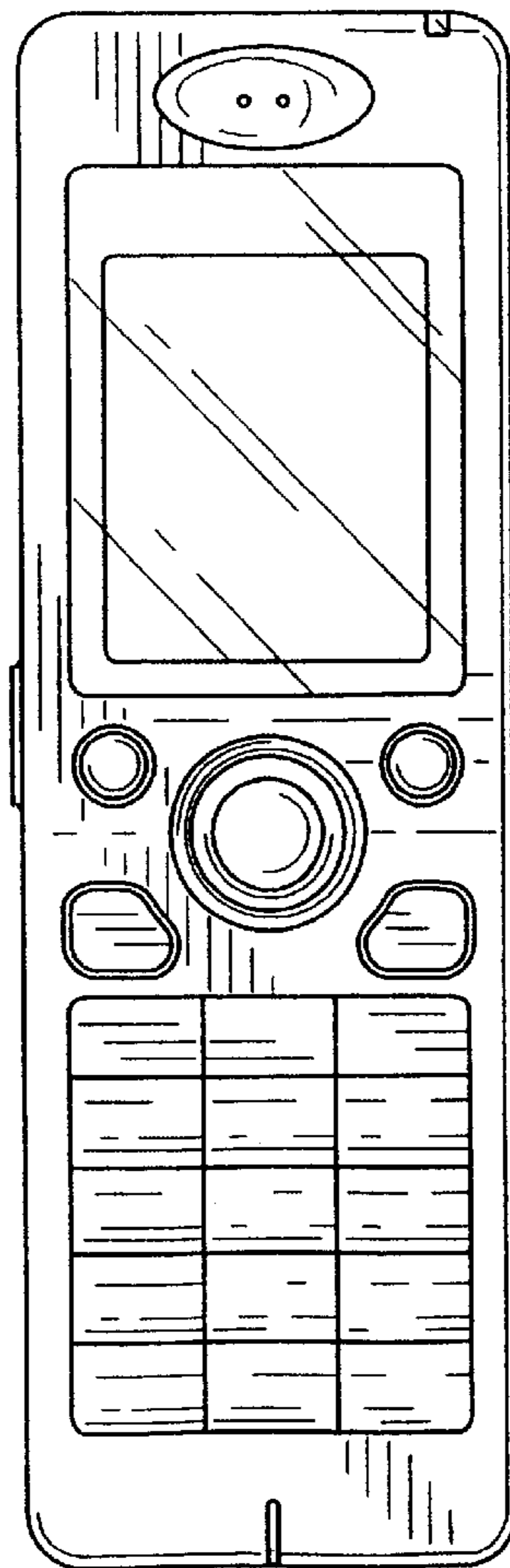

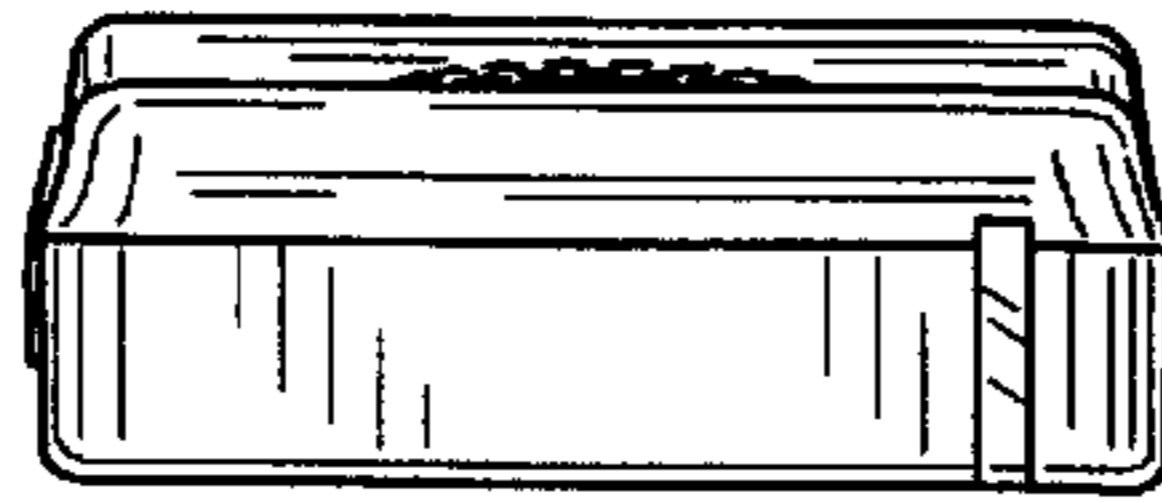

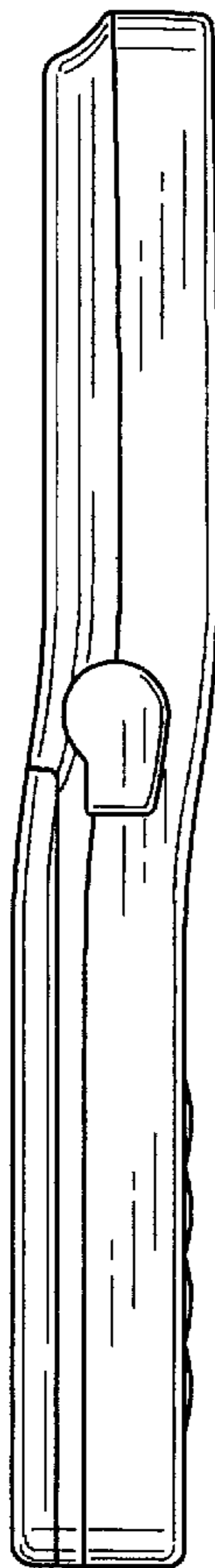
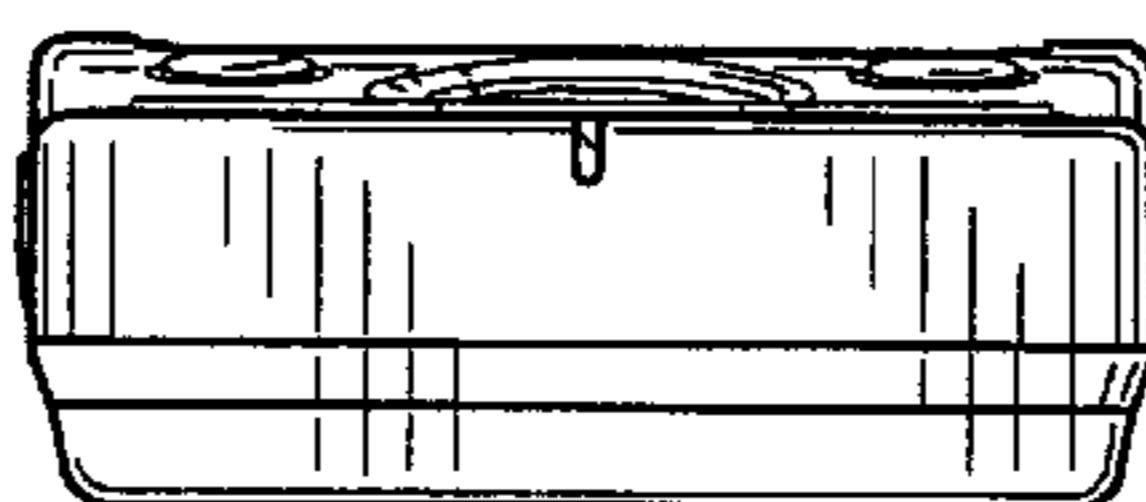
