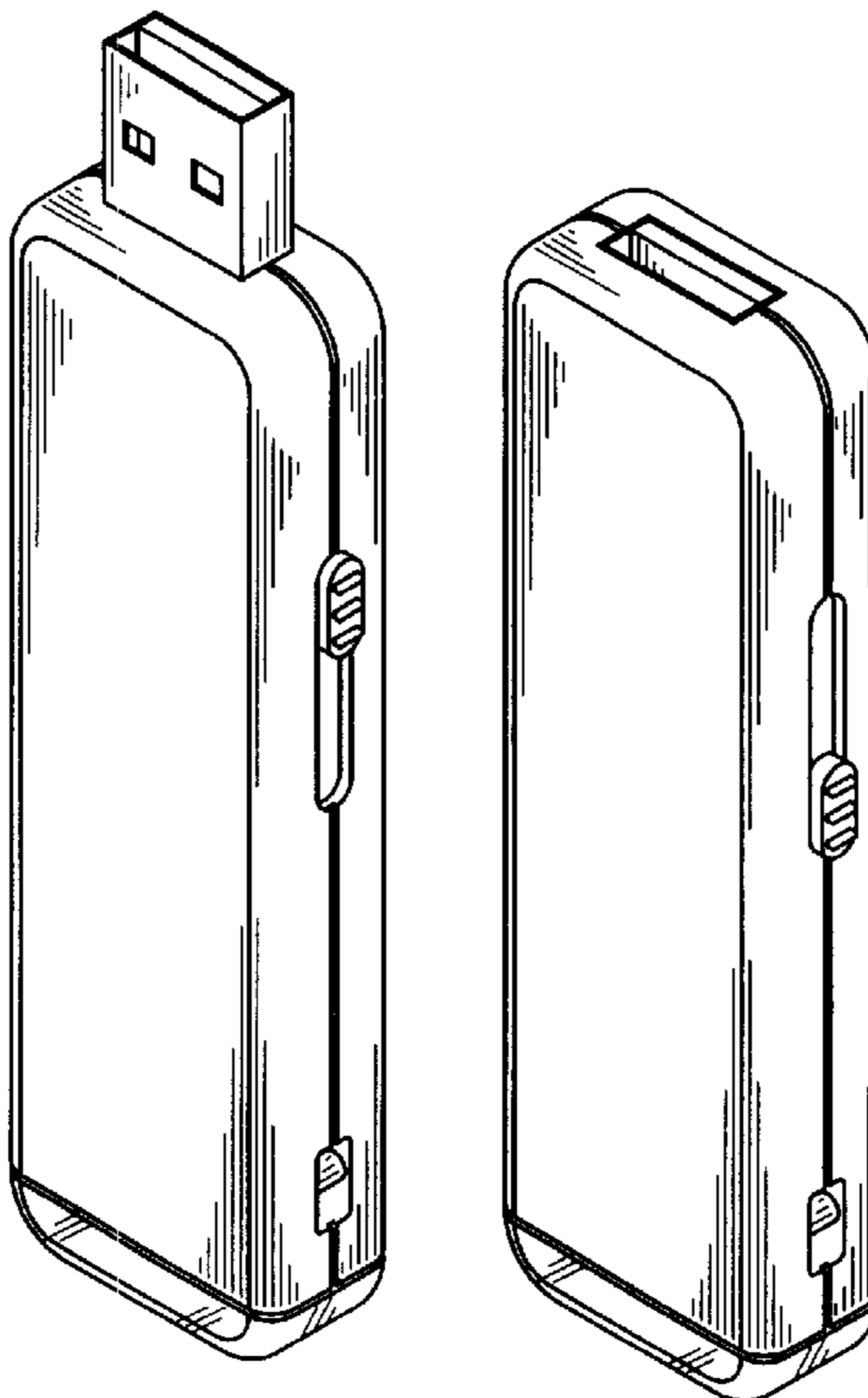

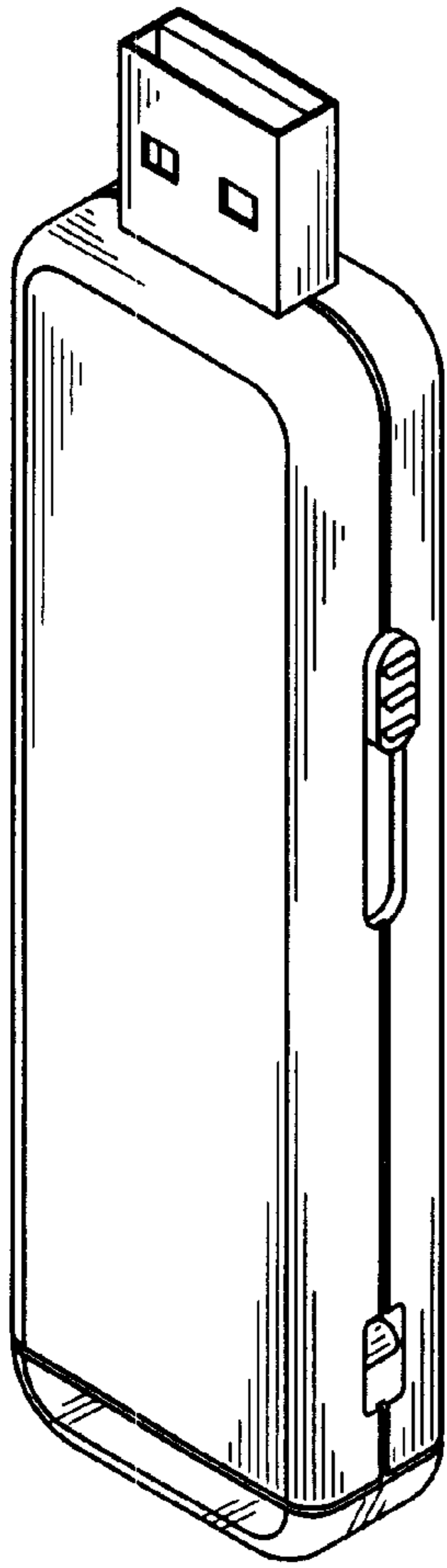
The ornamental design for a memory stick with flashlight and retractable USB plug, as shown and described.

**DESCRIPTION**

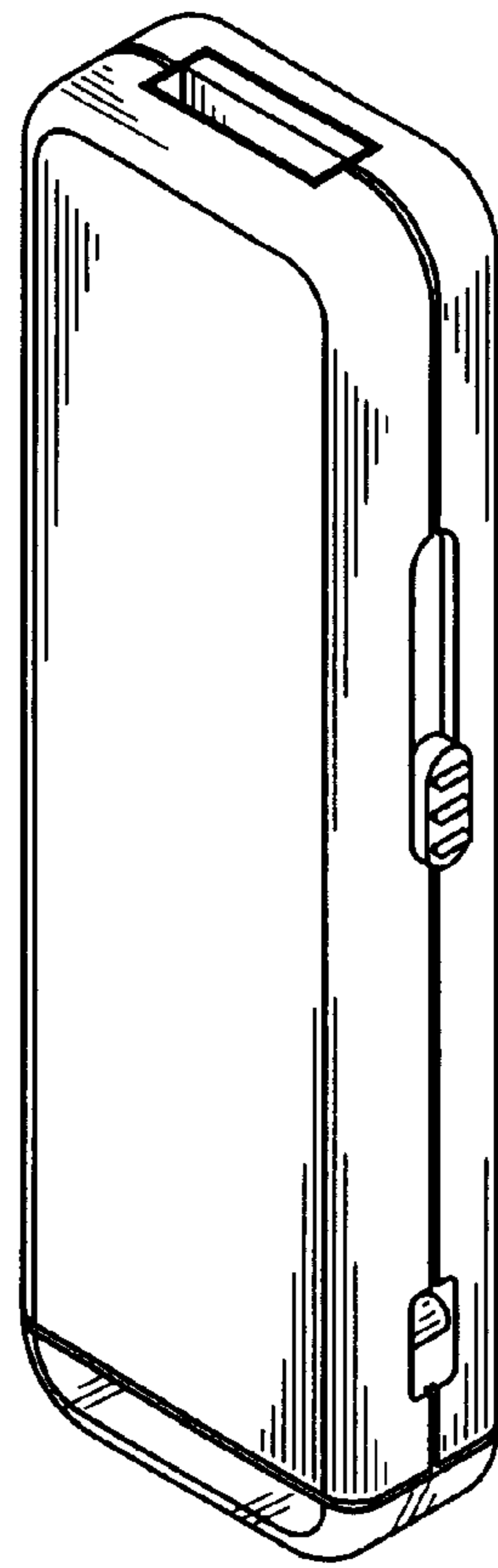

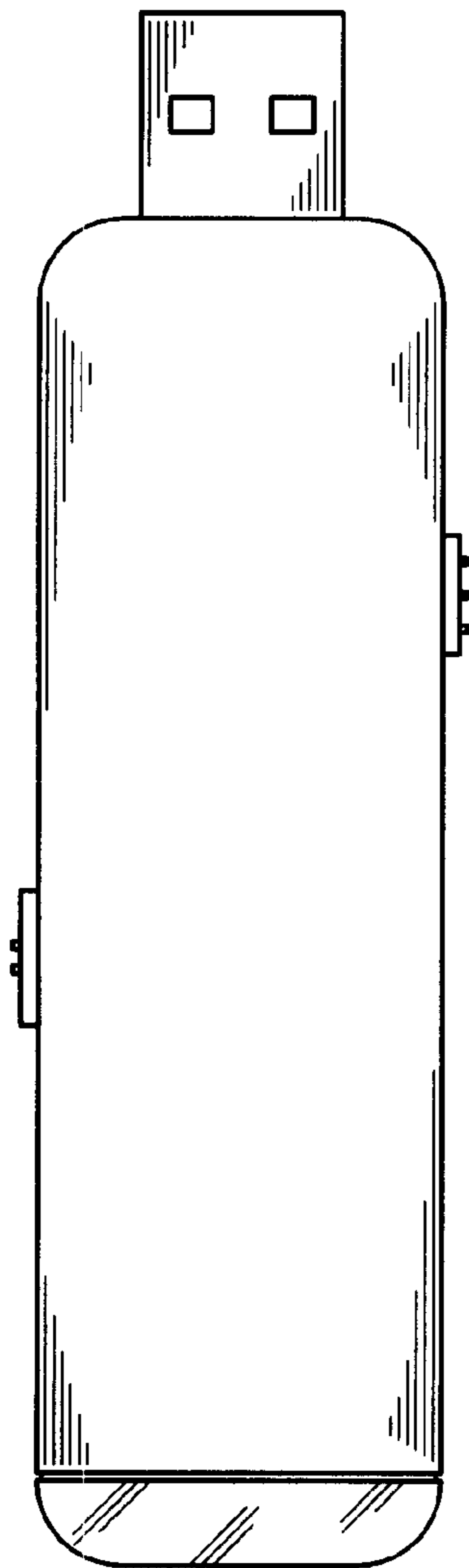




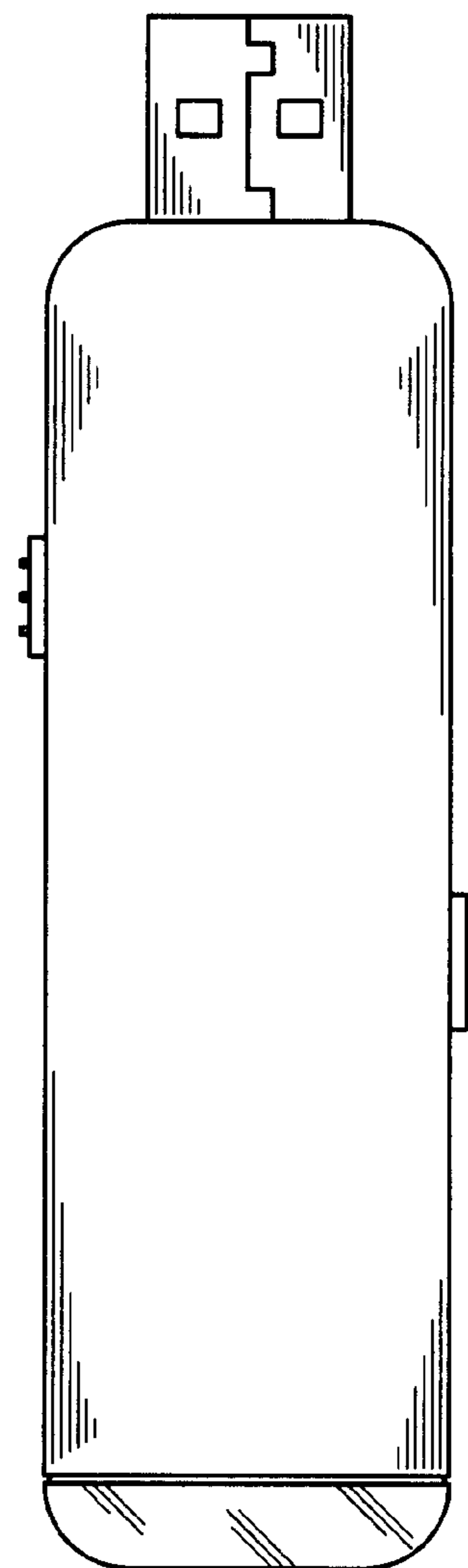

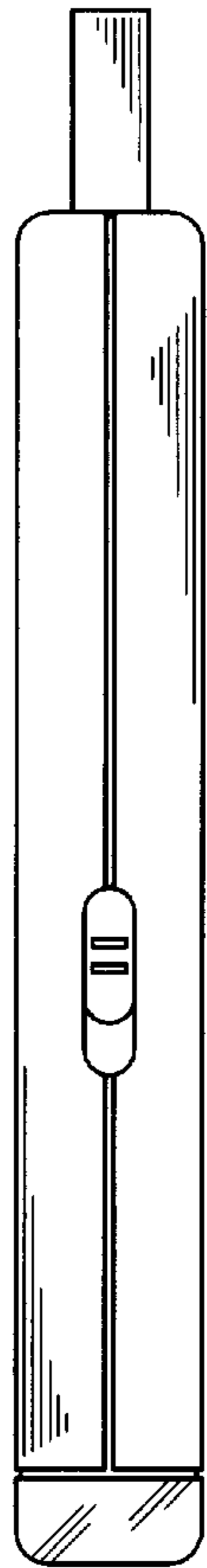

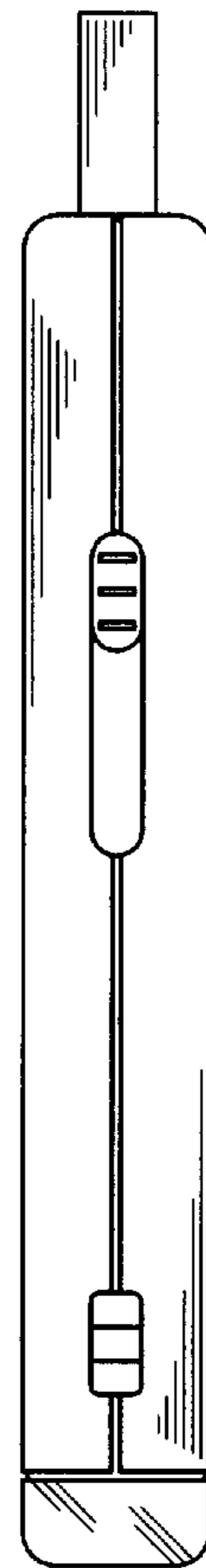

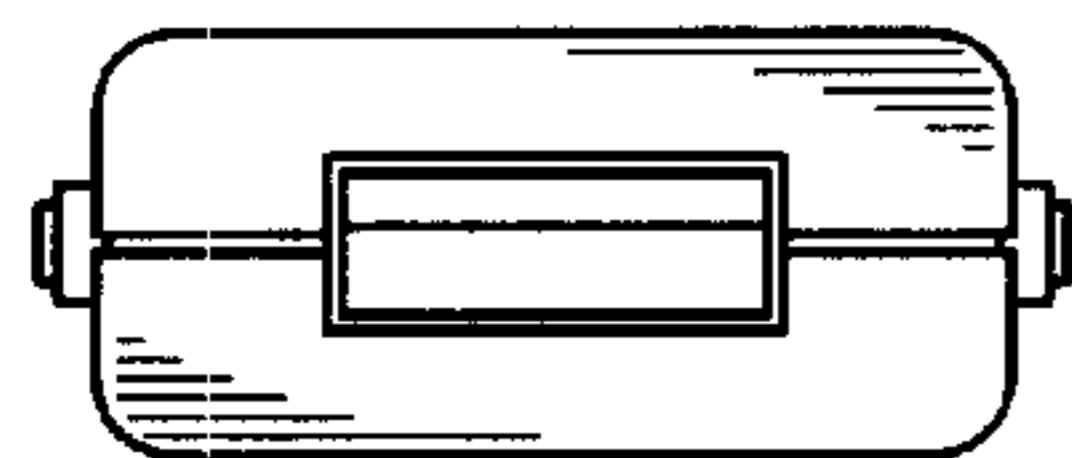

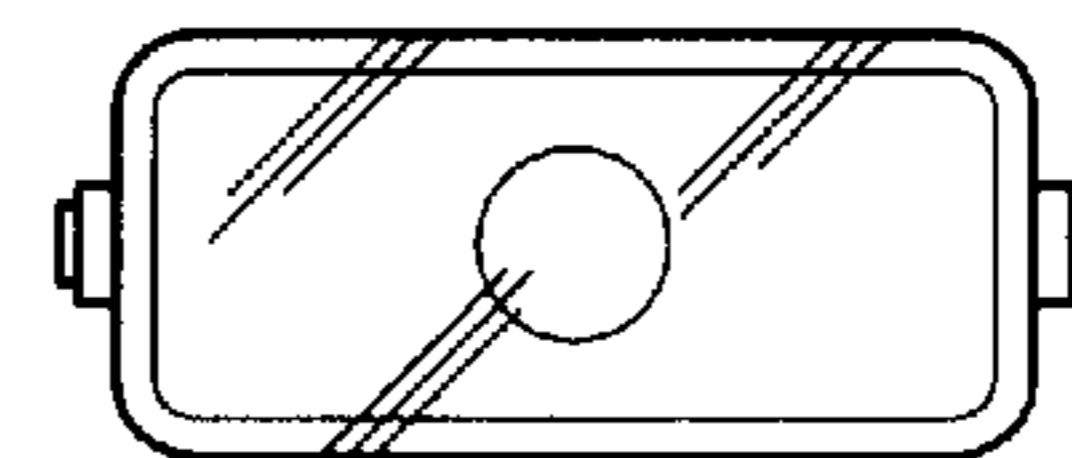
