I claim the ornamental design for mating housing components for forming pump housing, as shown and described.

DESCRIPTION

FIG. 17 is a left side elevational view thereof;

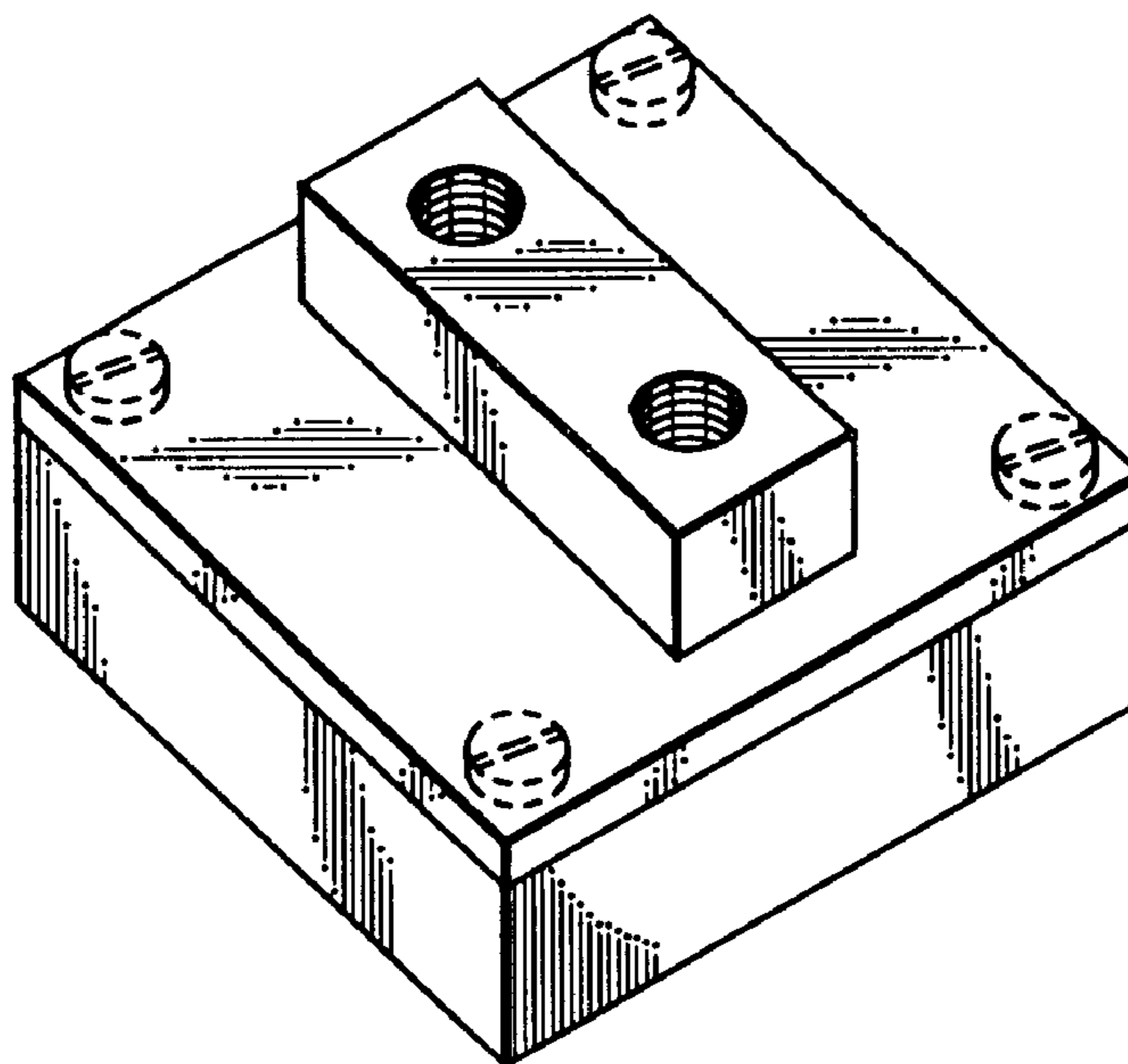
FIG. 18 is a right side elevational view thereof;

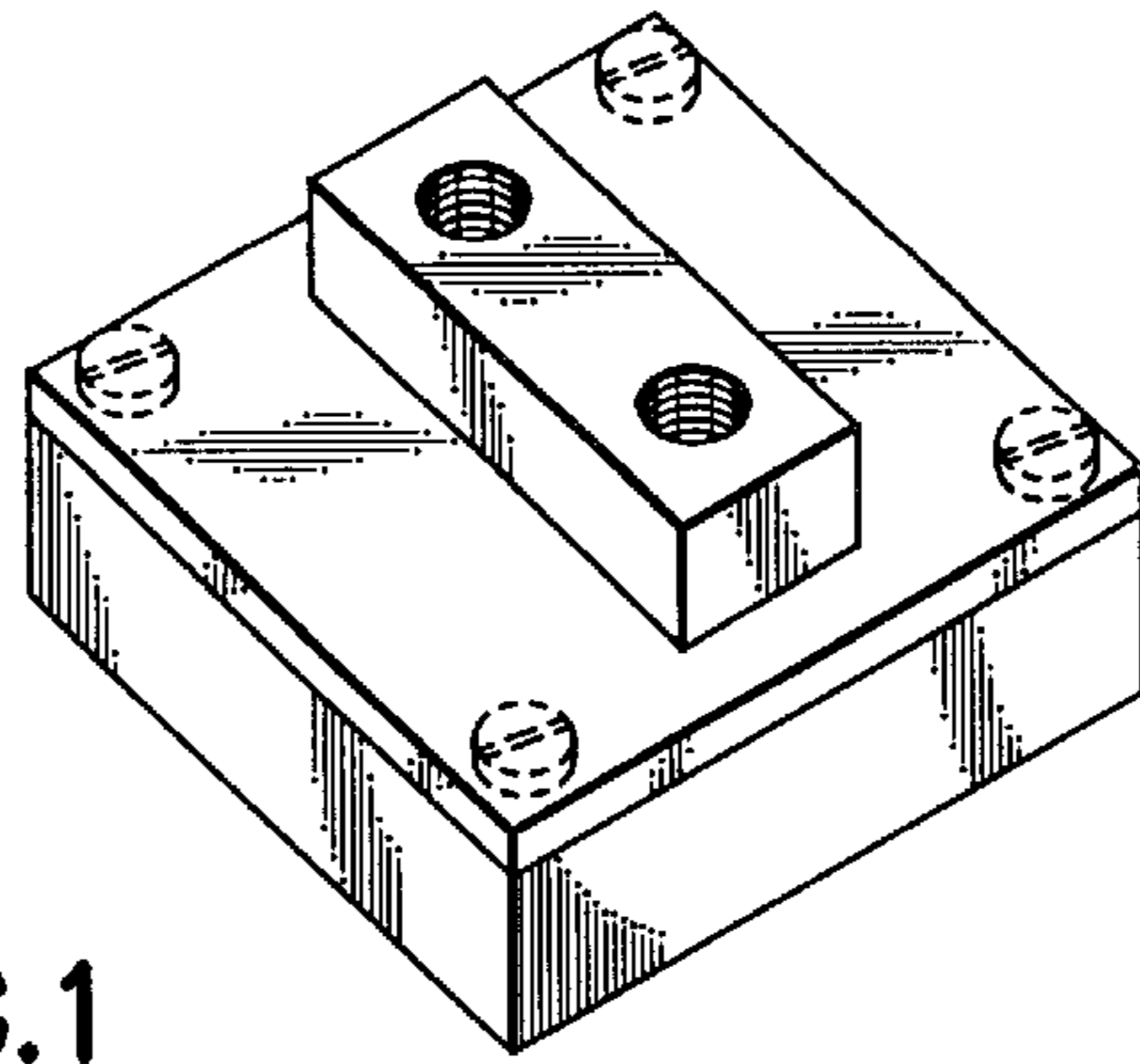

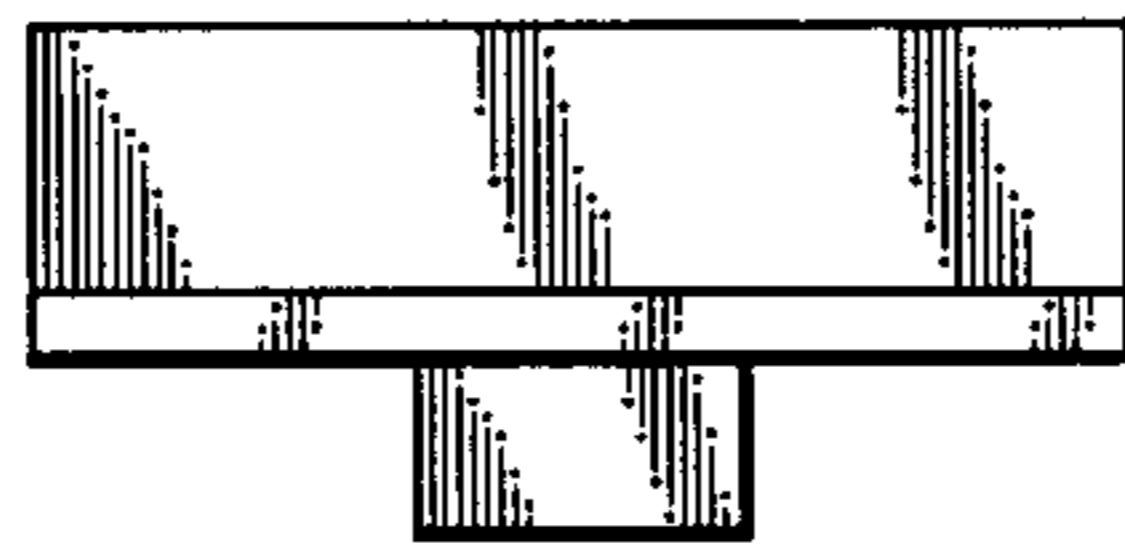

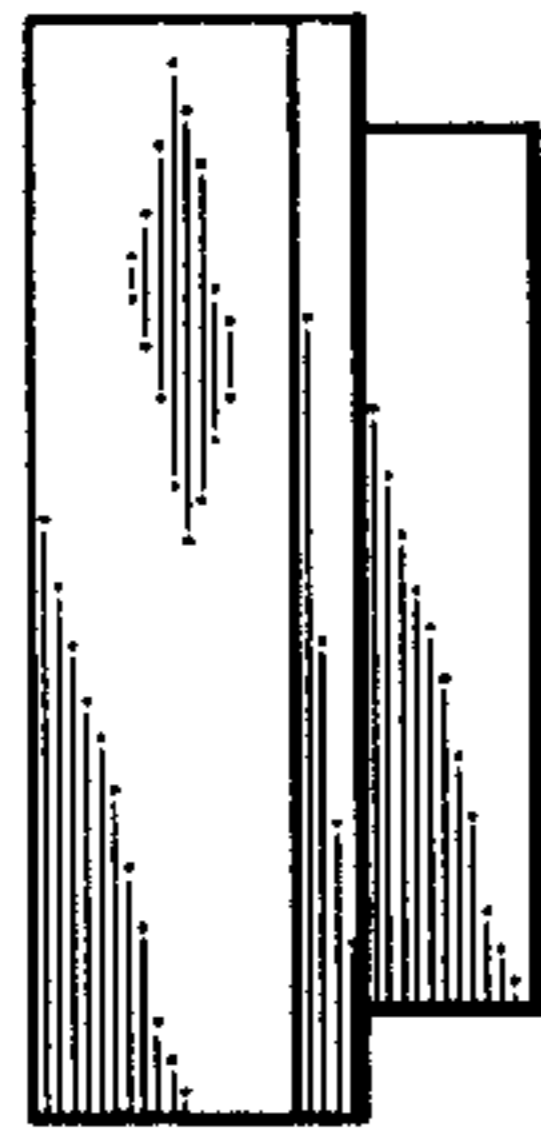

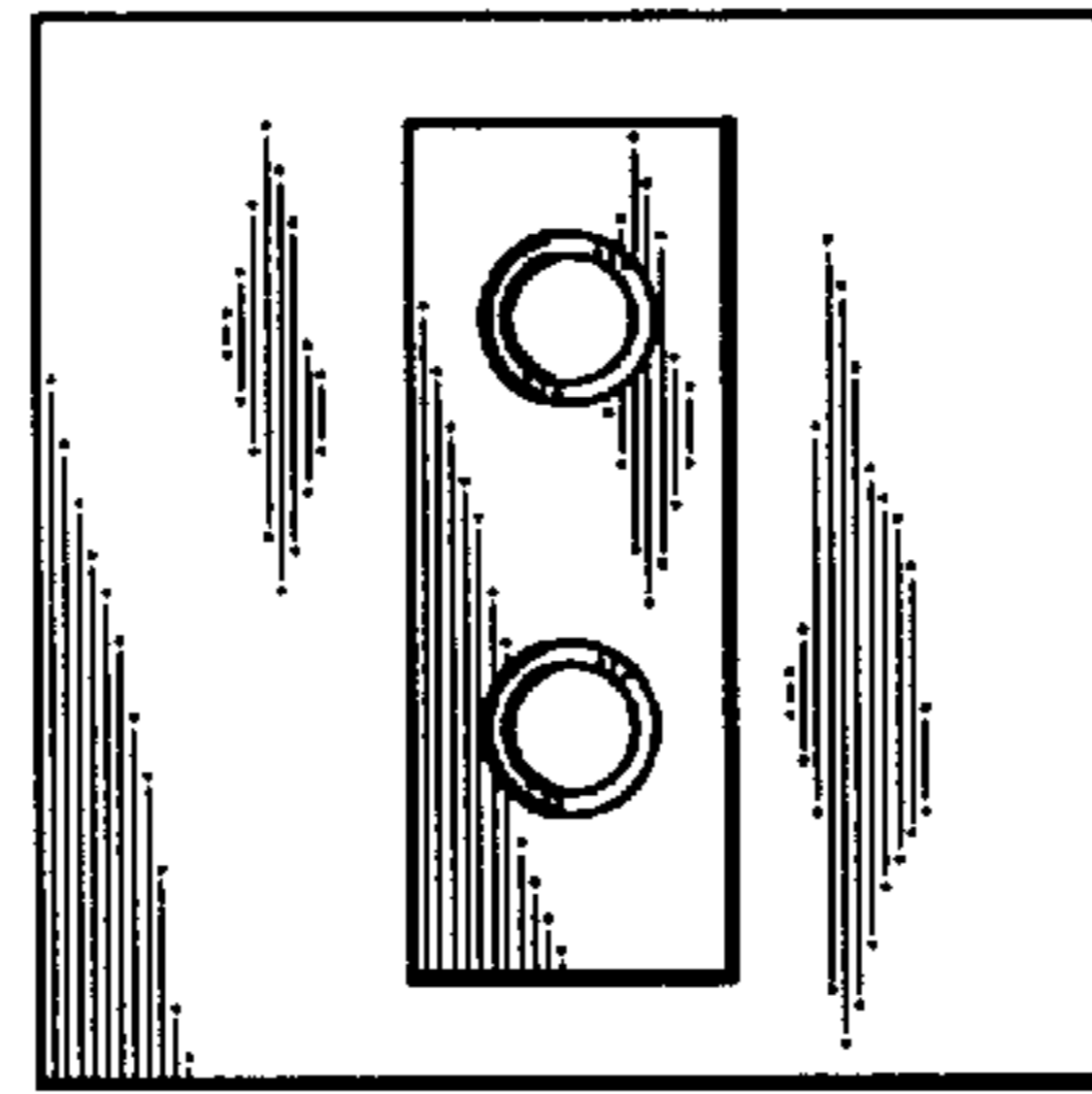

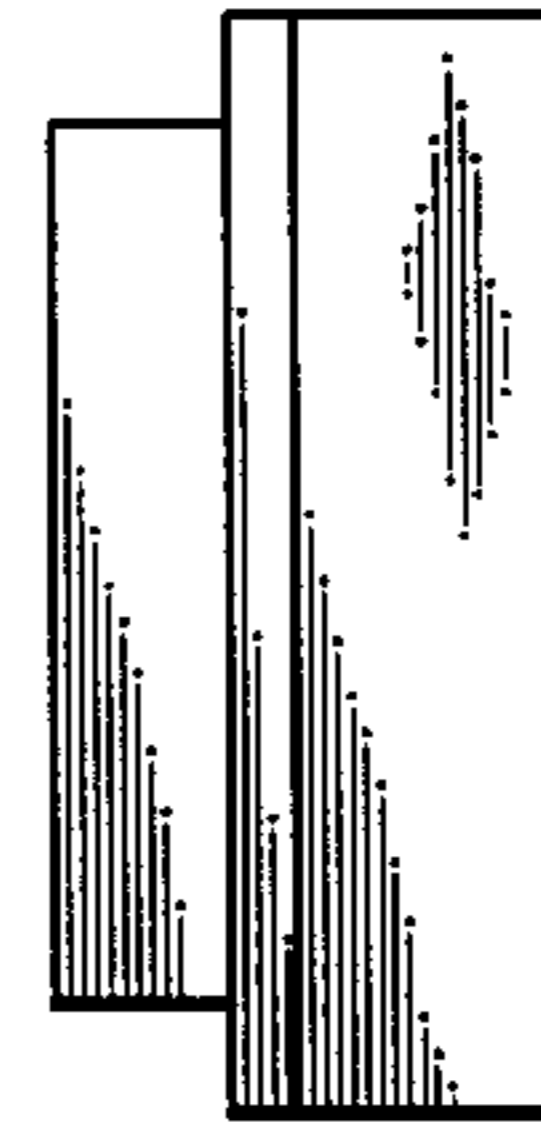

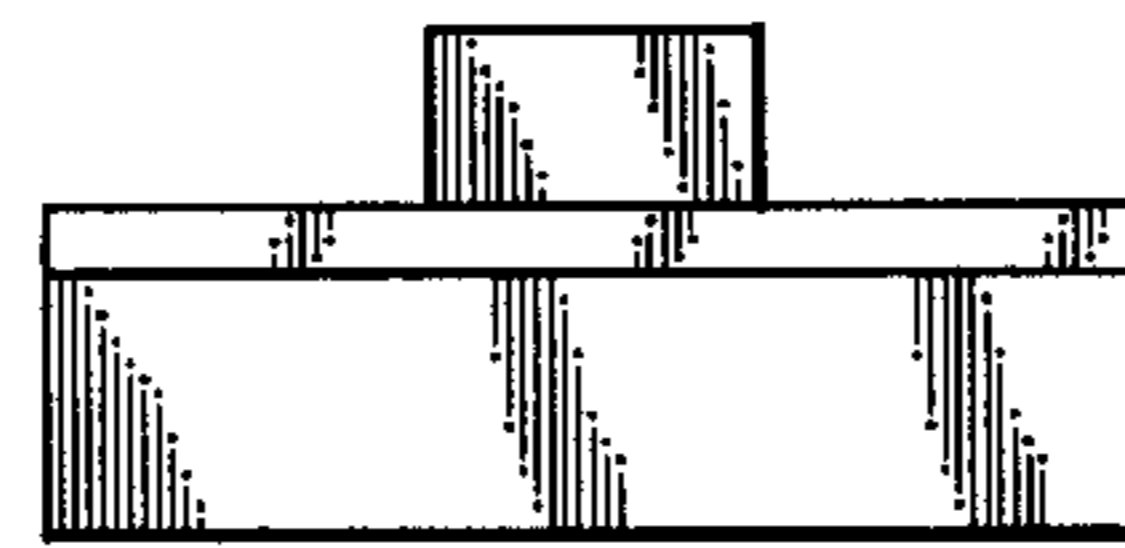

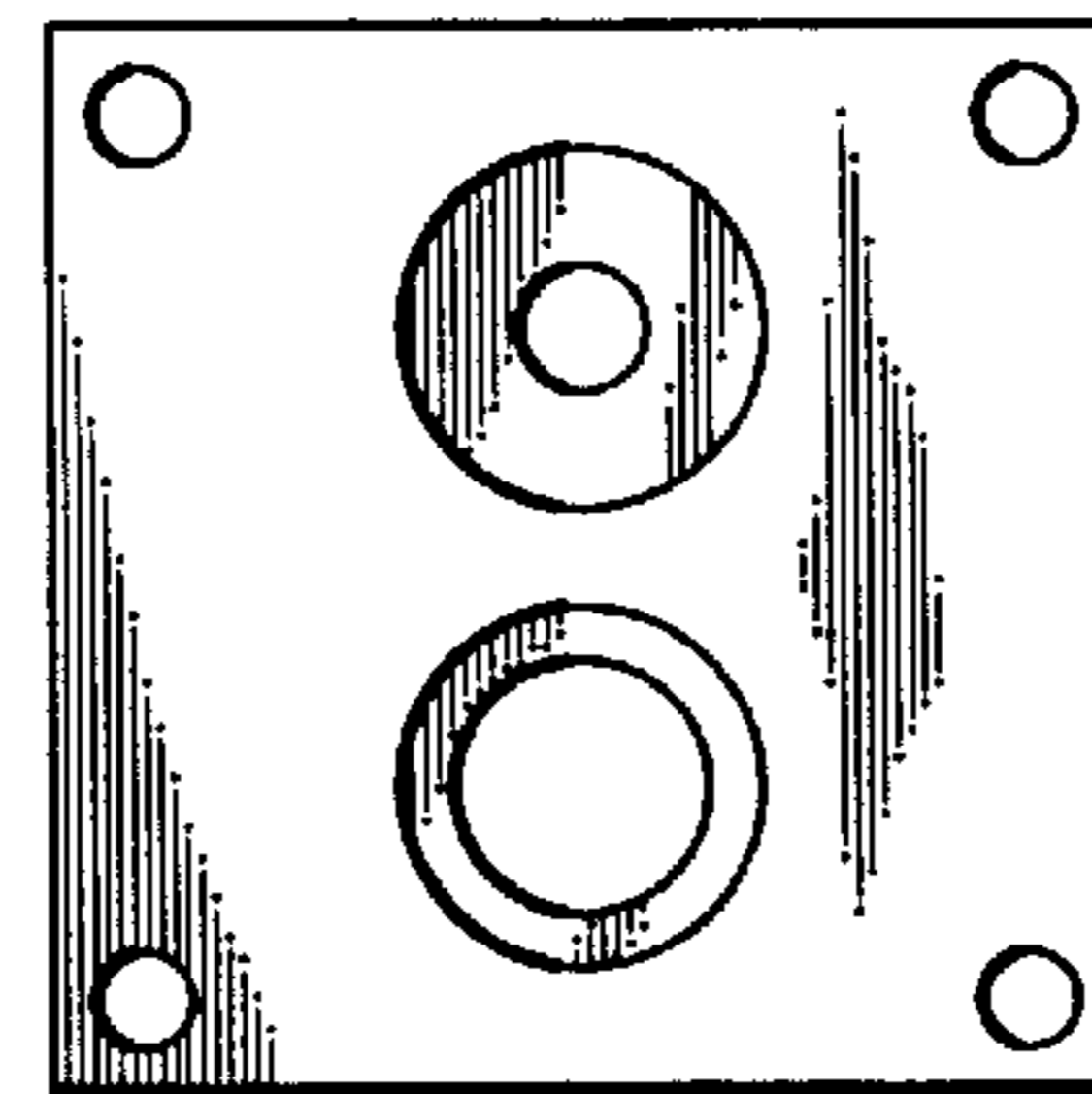

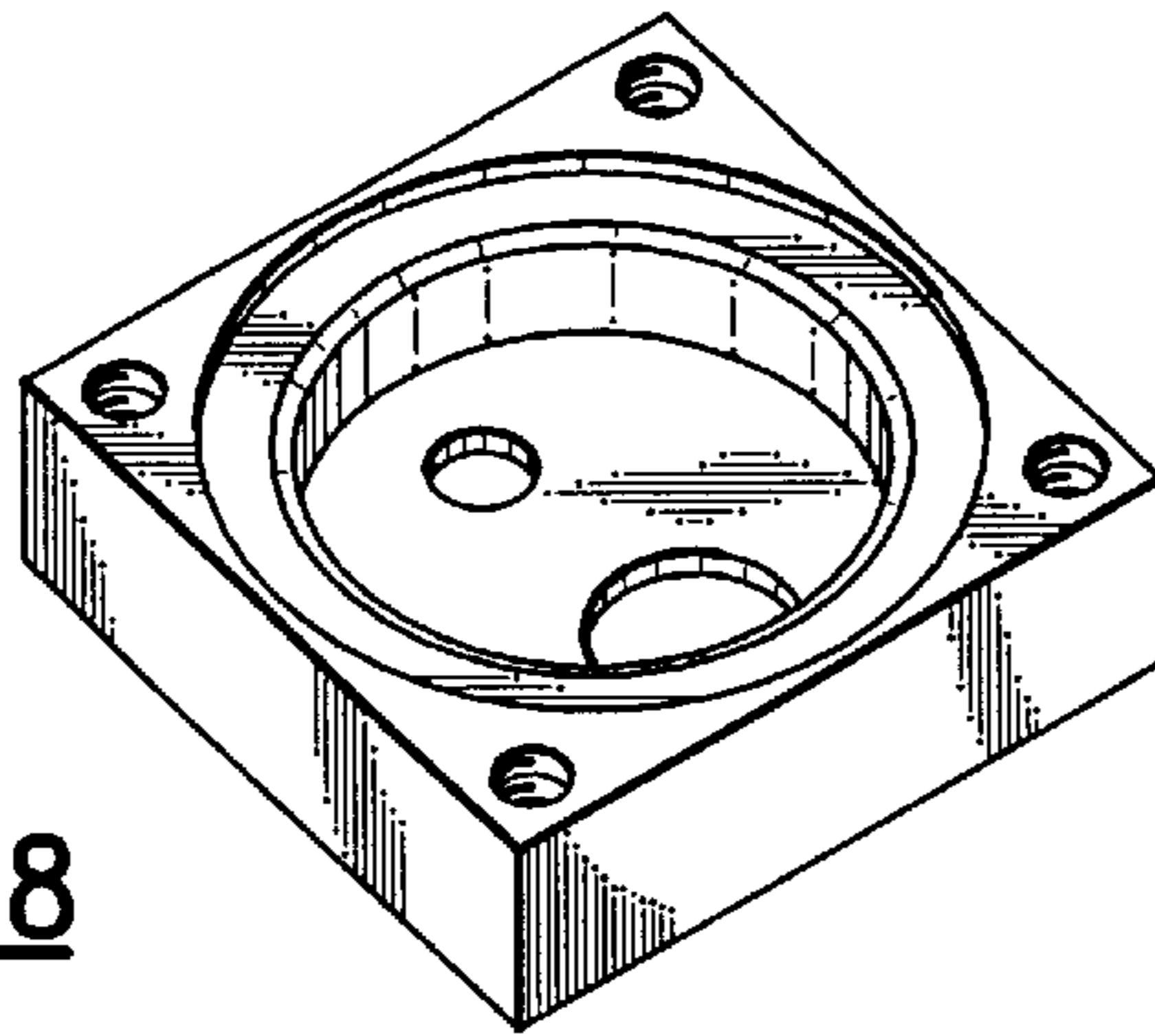

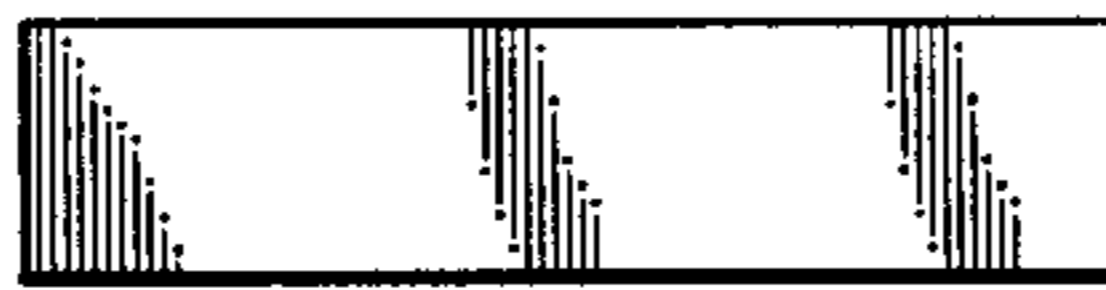

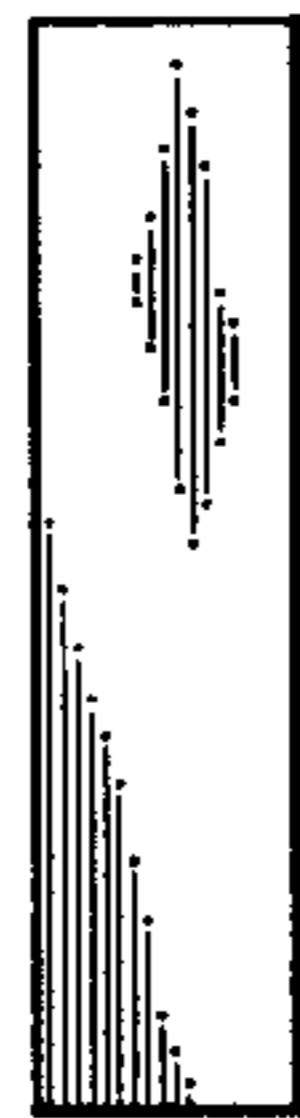

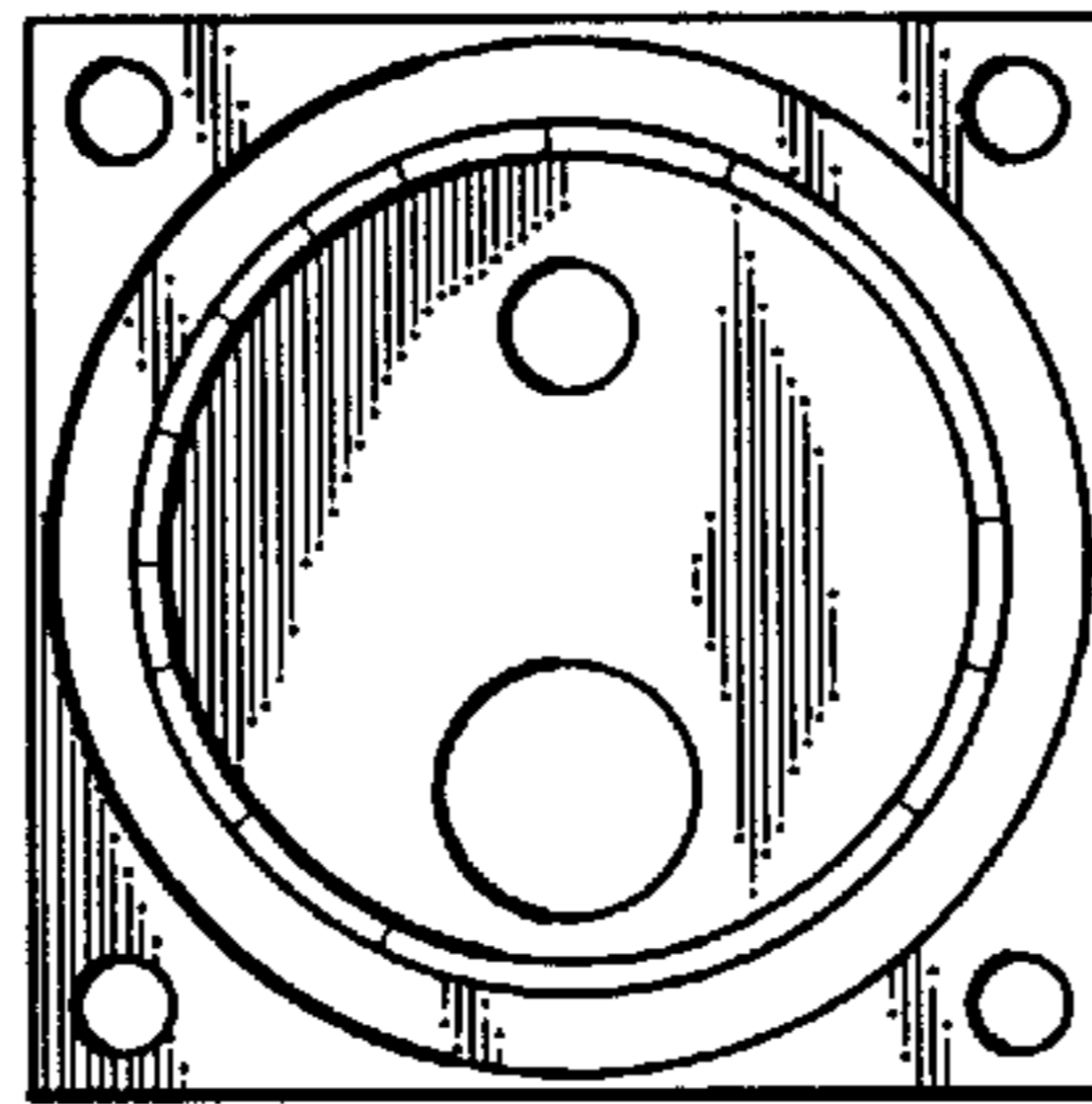

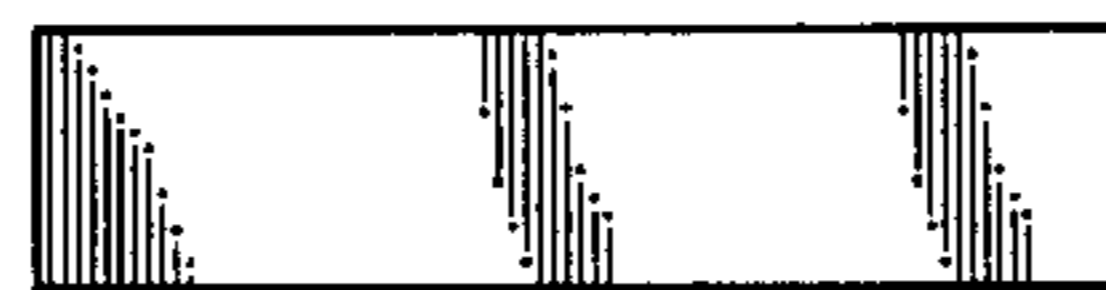

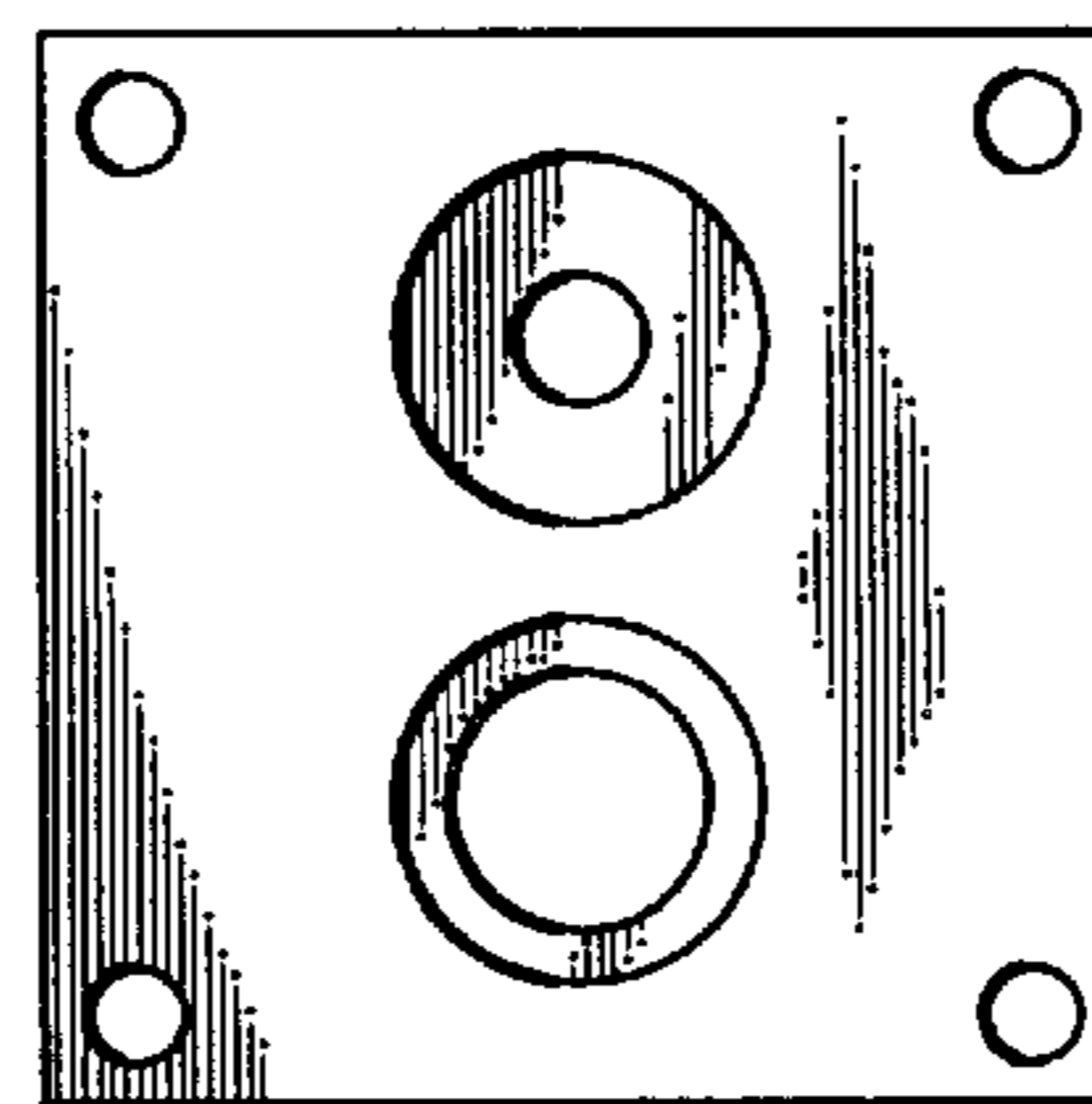

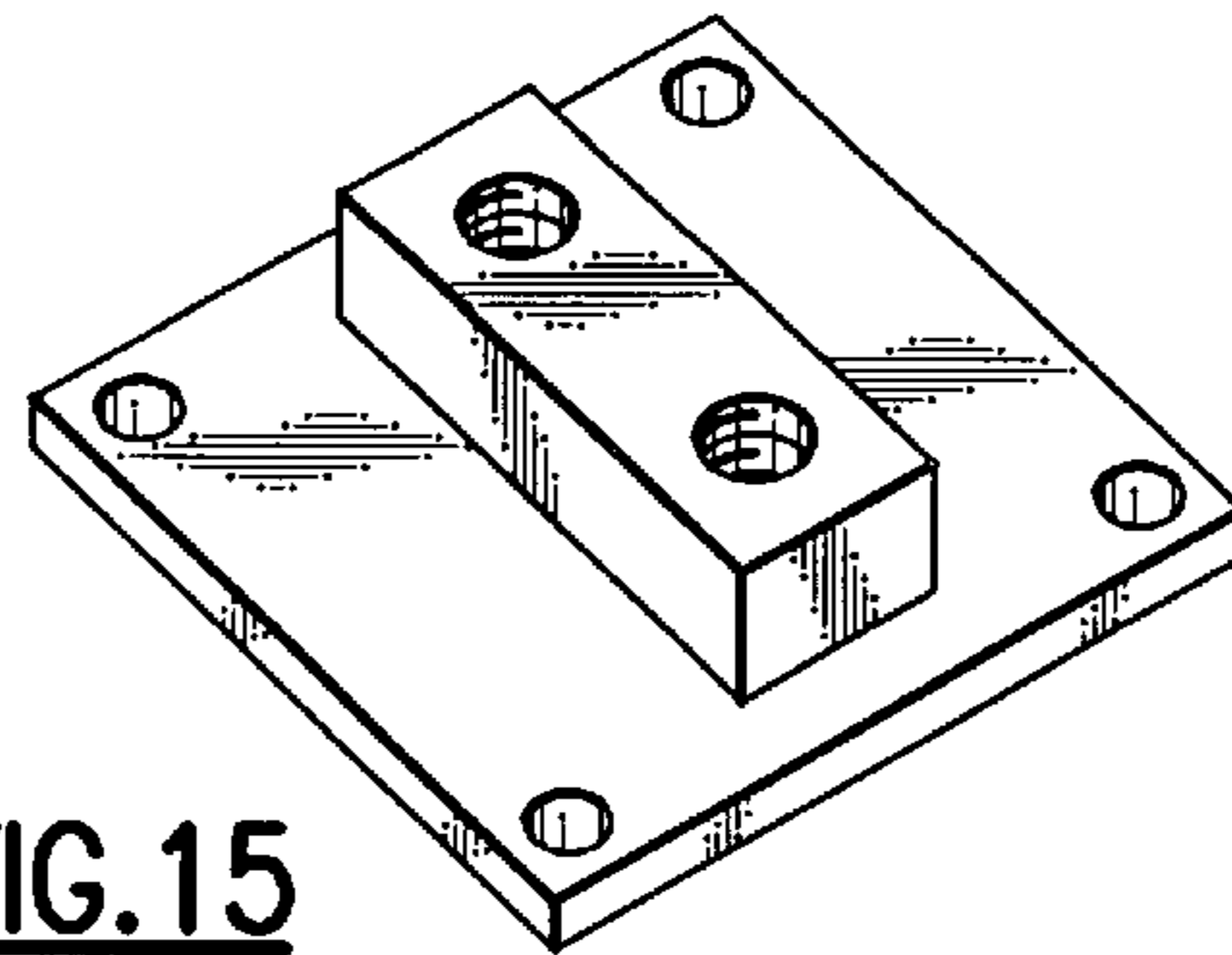

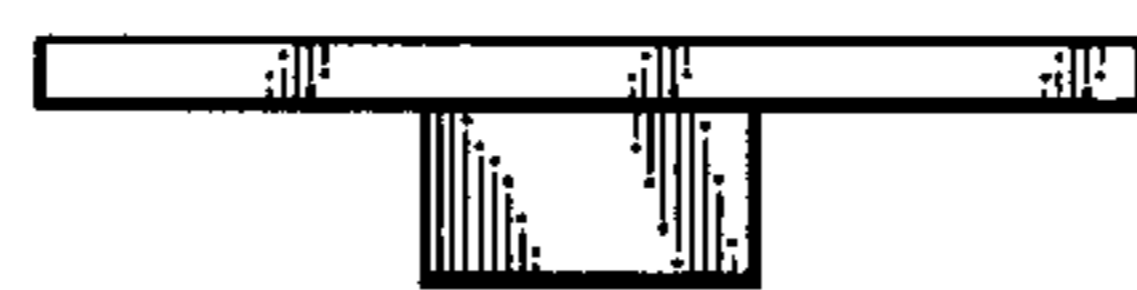

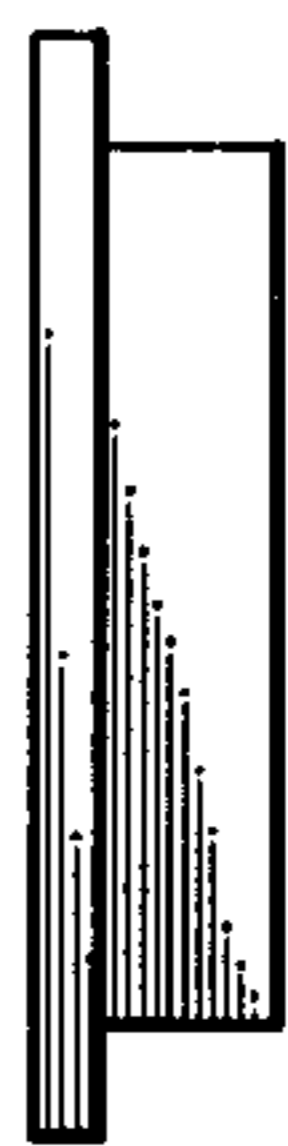

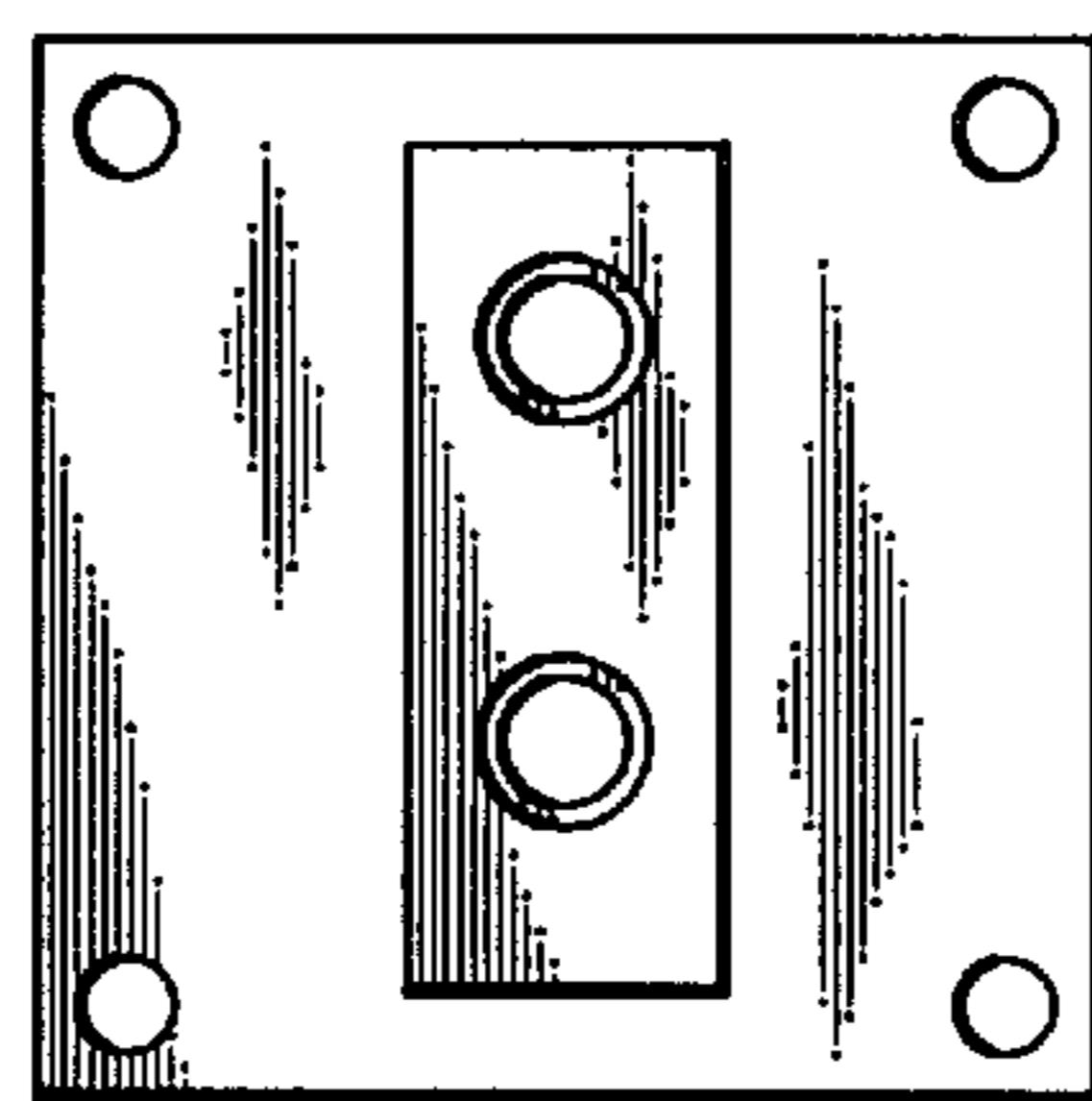

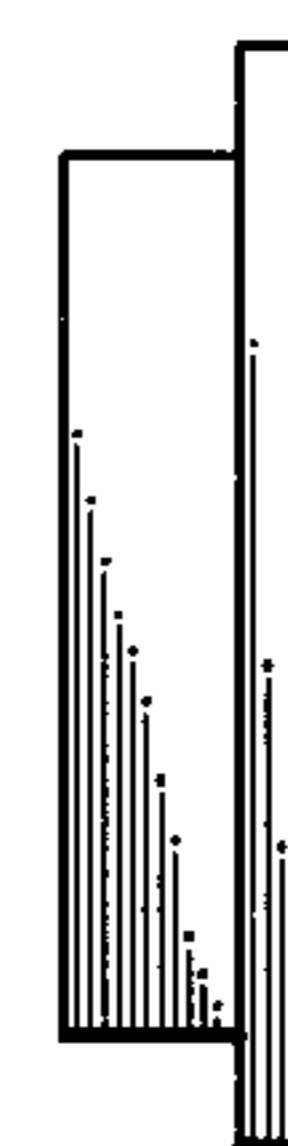

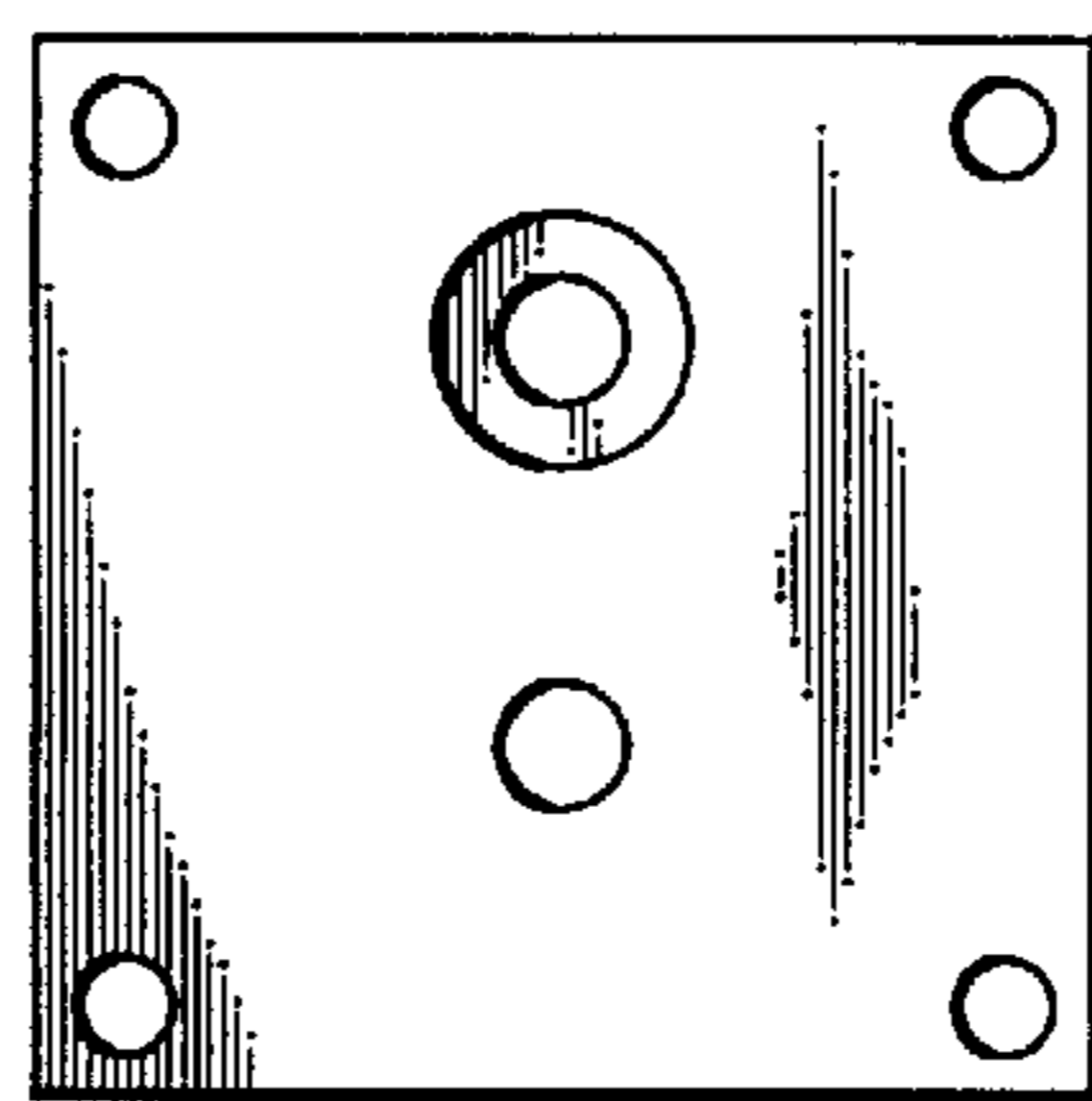
