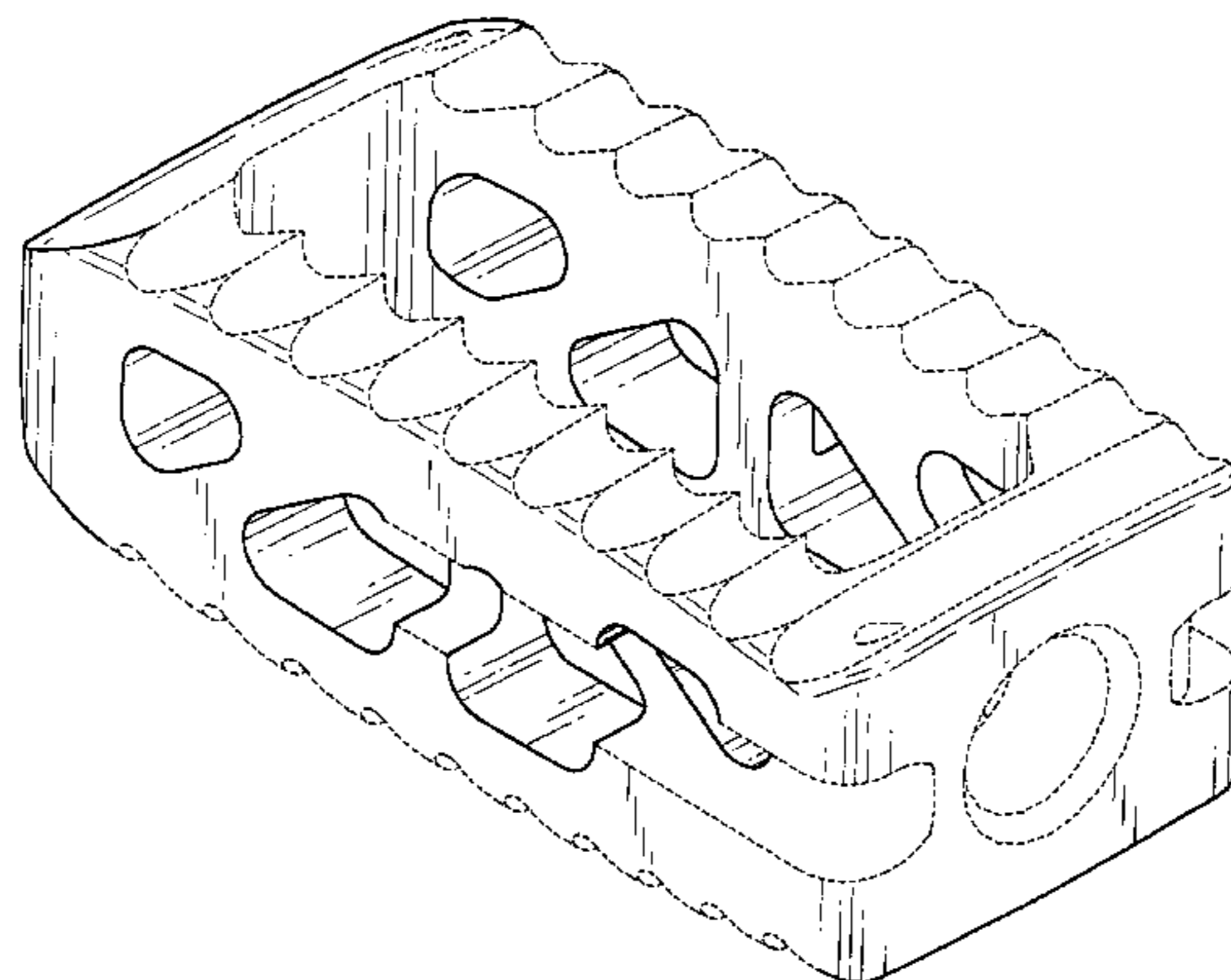
(57) **CLAIM**

The ornamental design for an interbody fusion device, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of an interbody fusion device showing my new design;  
FIG. 2 is a front elevation thereof;  
FIG. 3 is a rear elevation thereof;  
FIG. 4 is a right-side elevation thereof; the side opposite being a mirror-image;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.  
The broken lines which define the bounds of the claimed design form no part thereof.

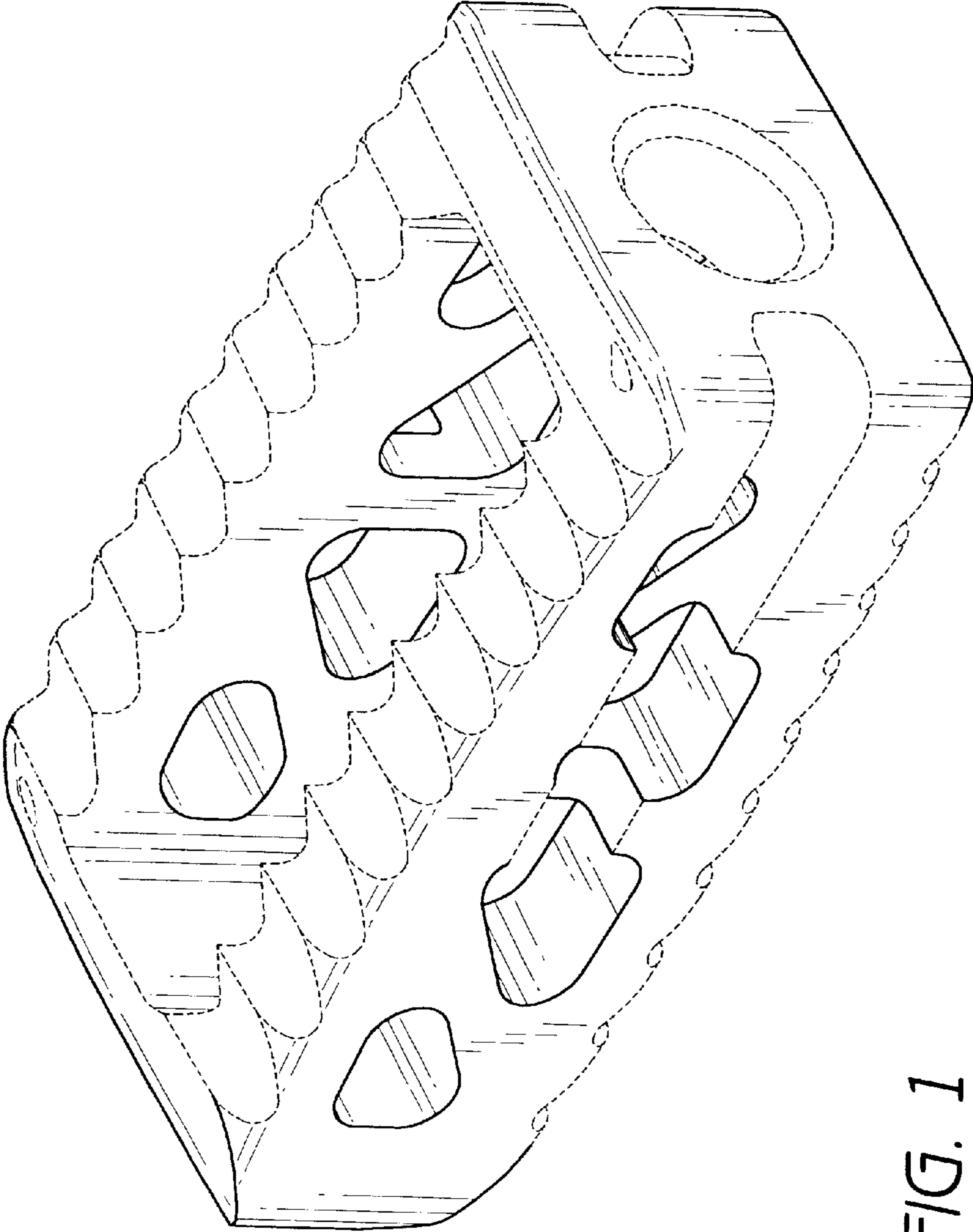
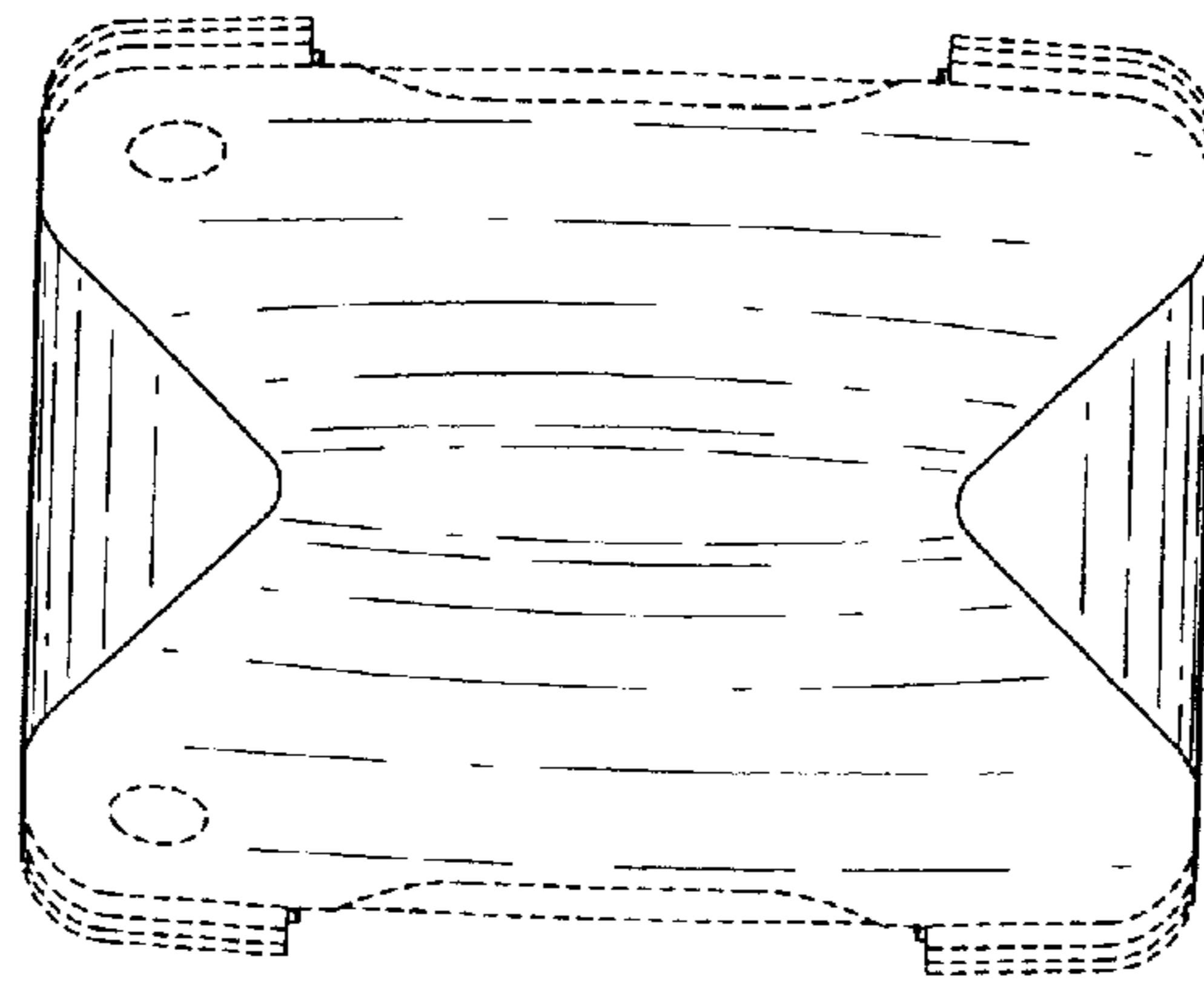
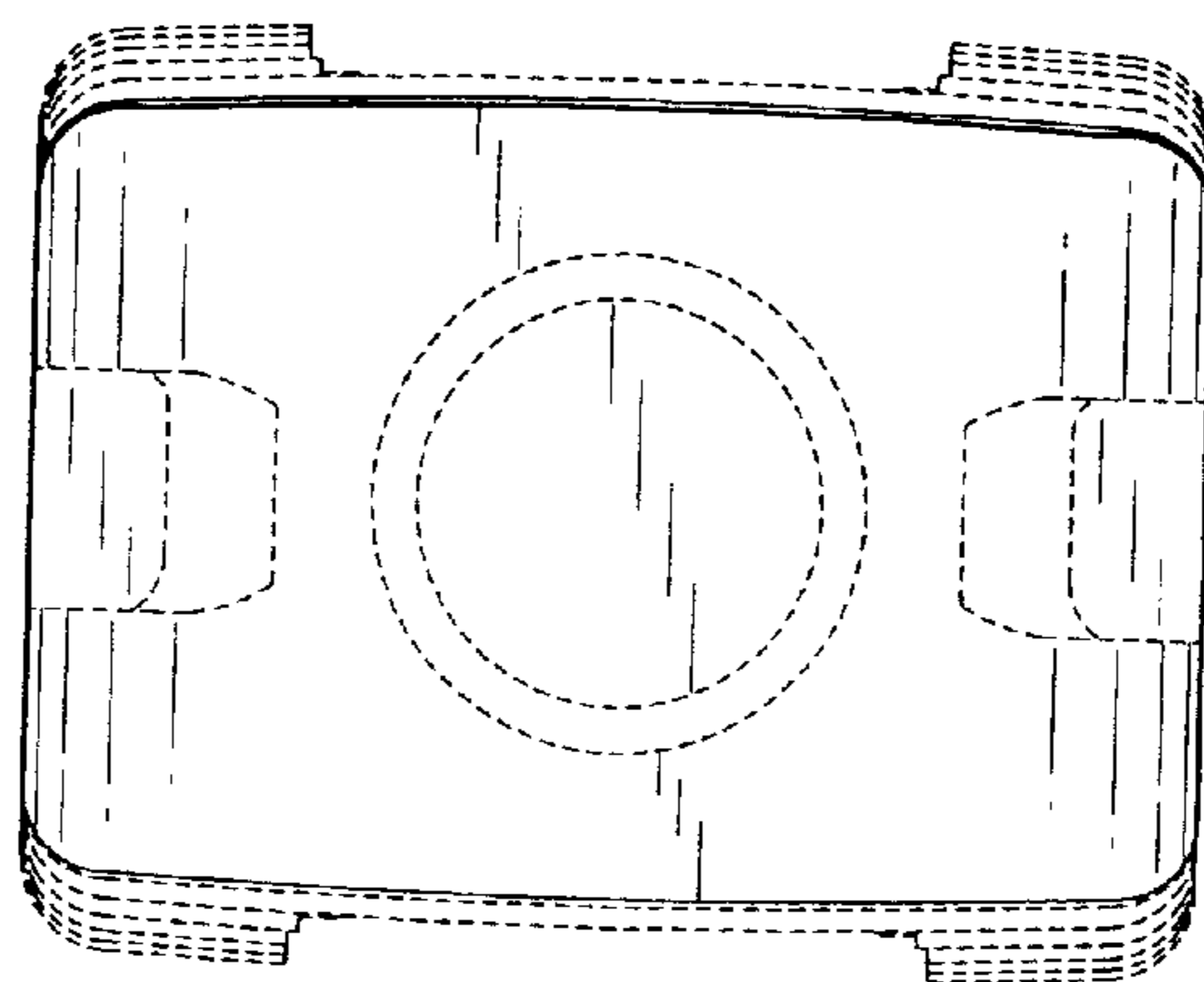

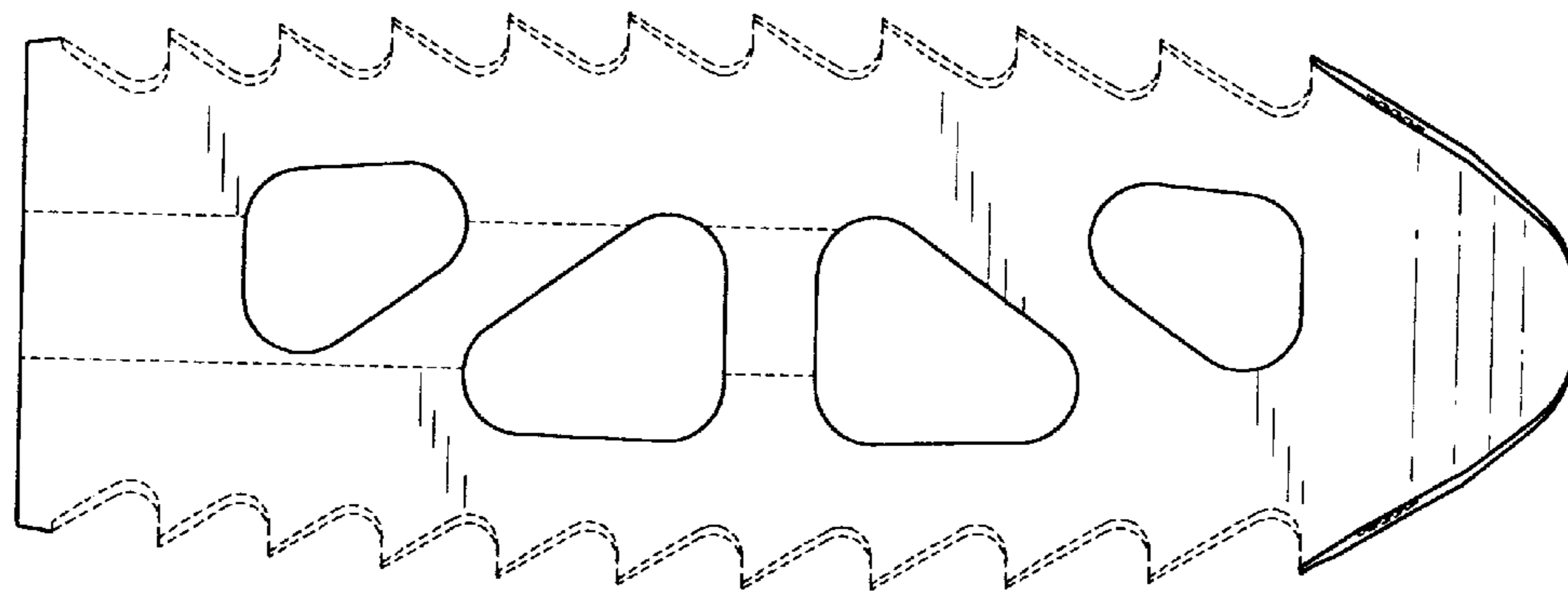

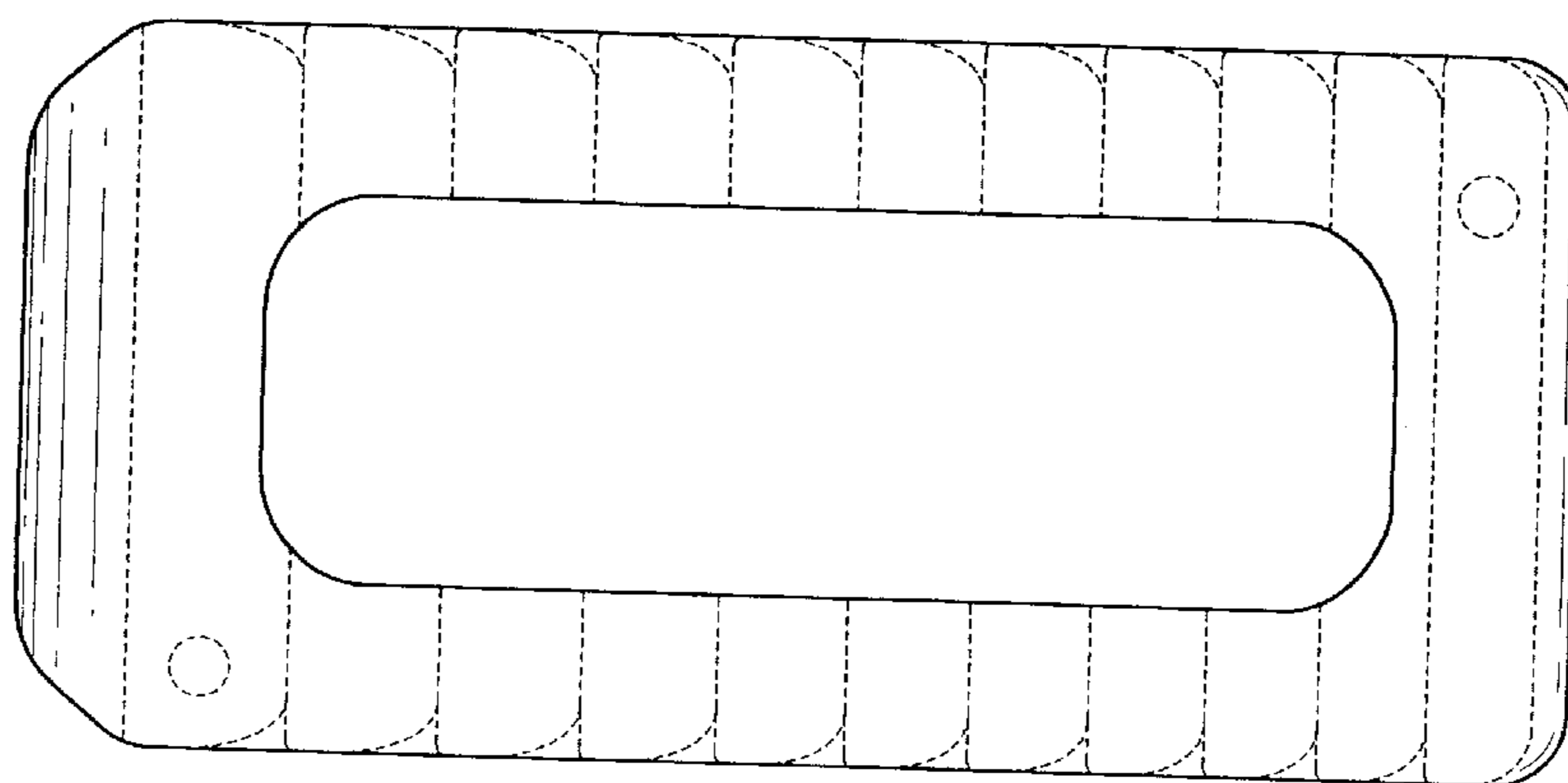

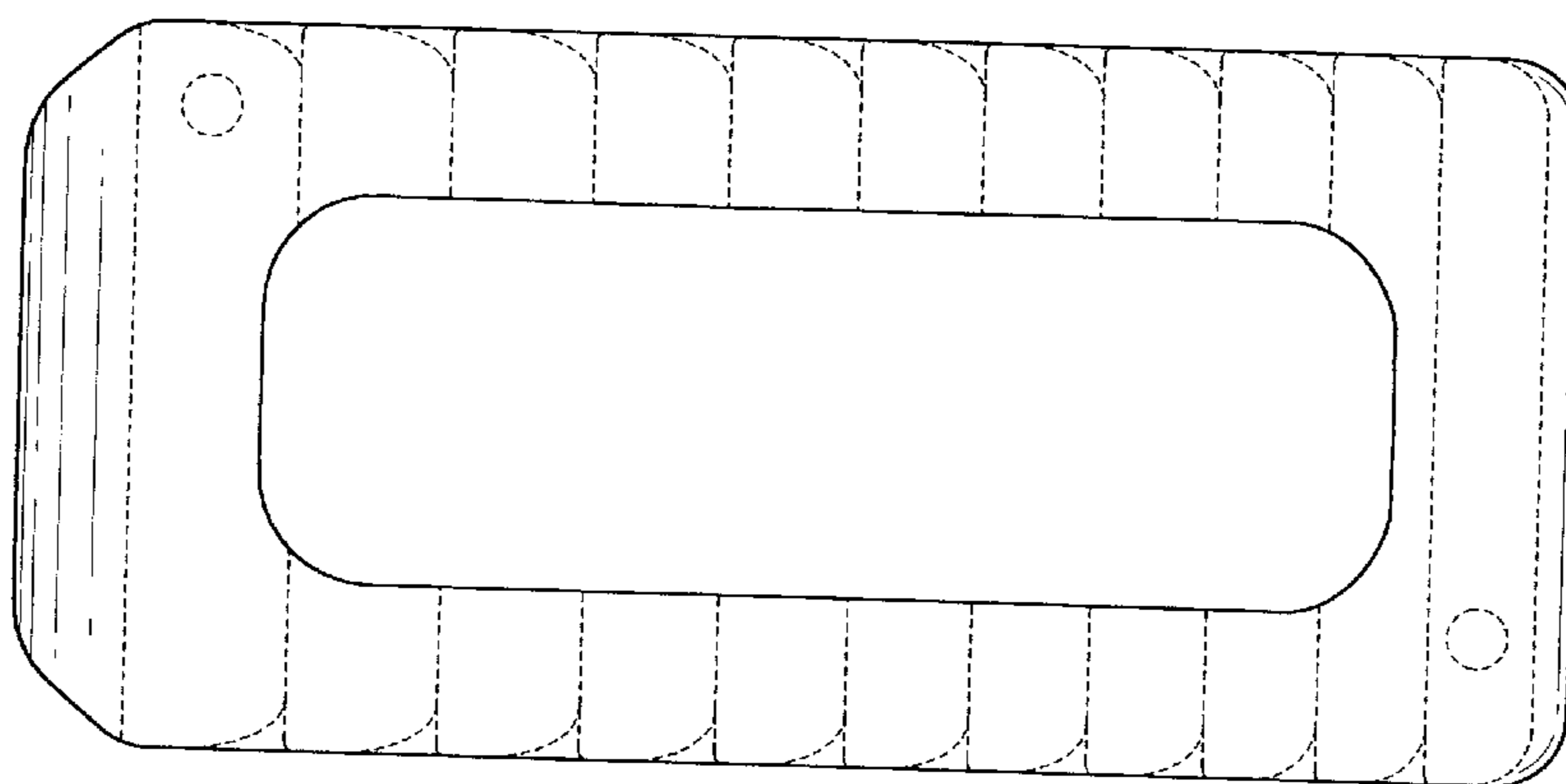
