FIG. 3 is a right side view, the left side view being a mirror image;

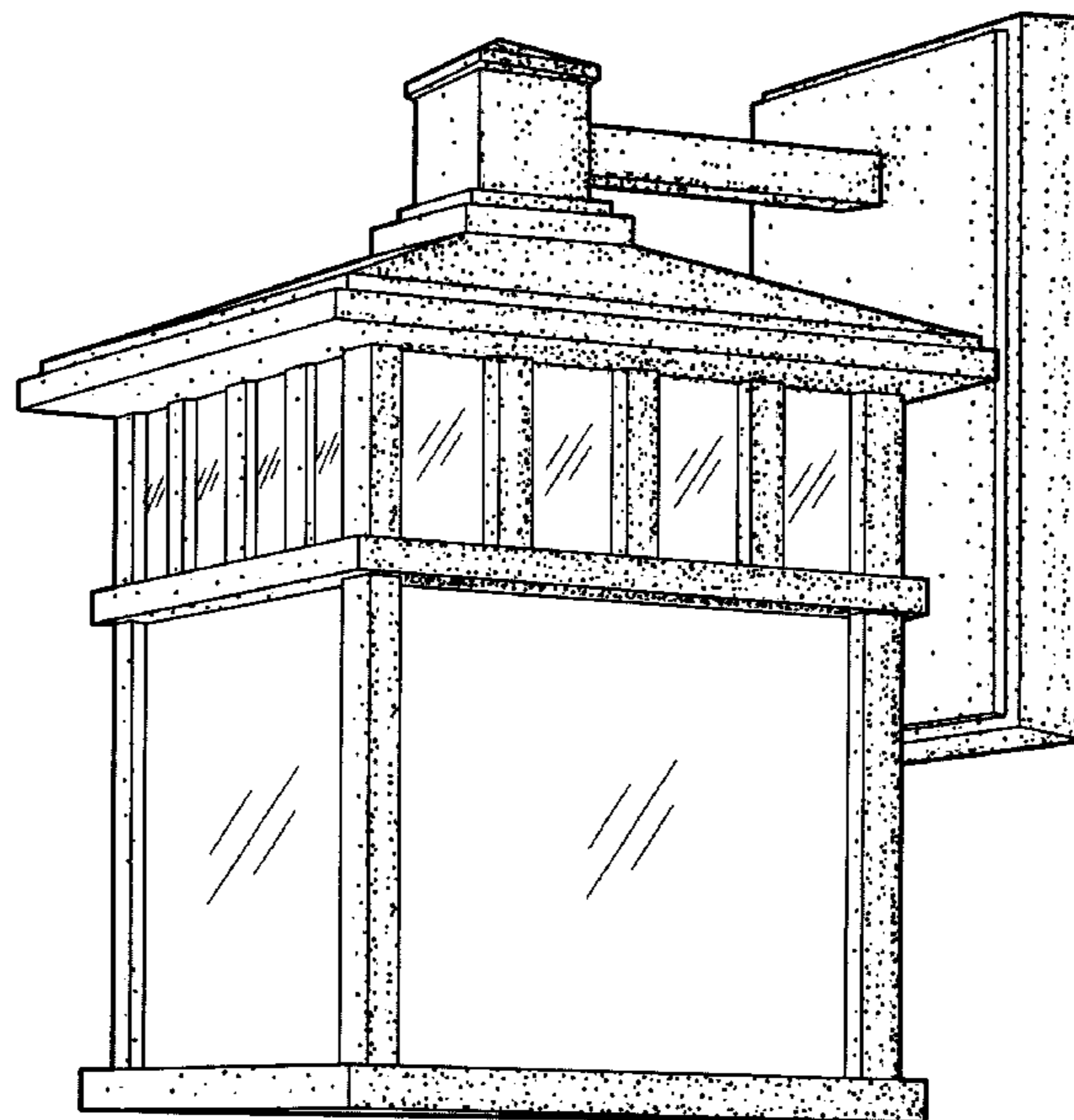
FIG. 4 is a back view thereof;

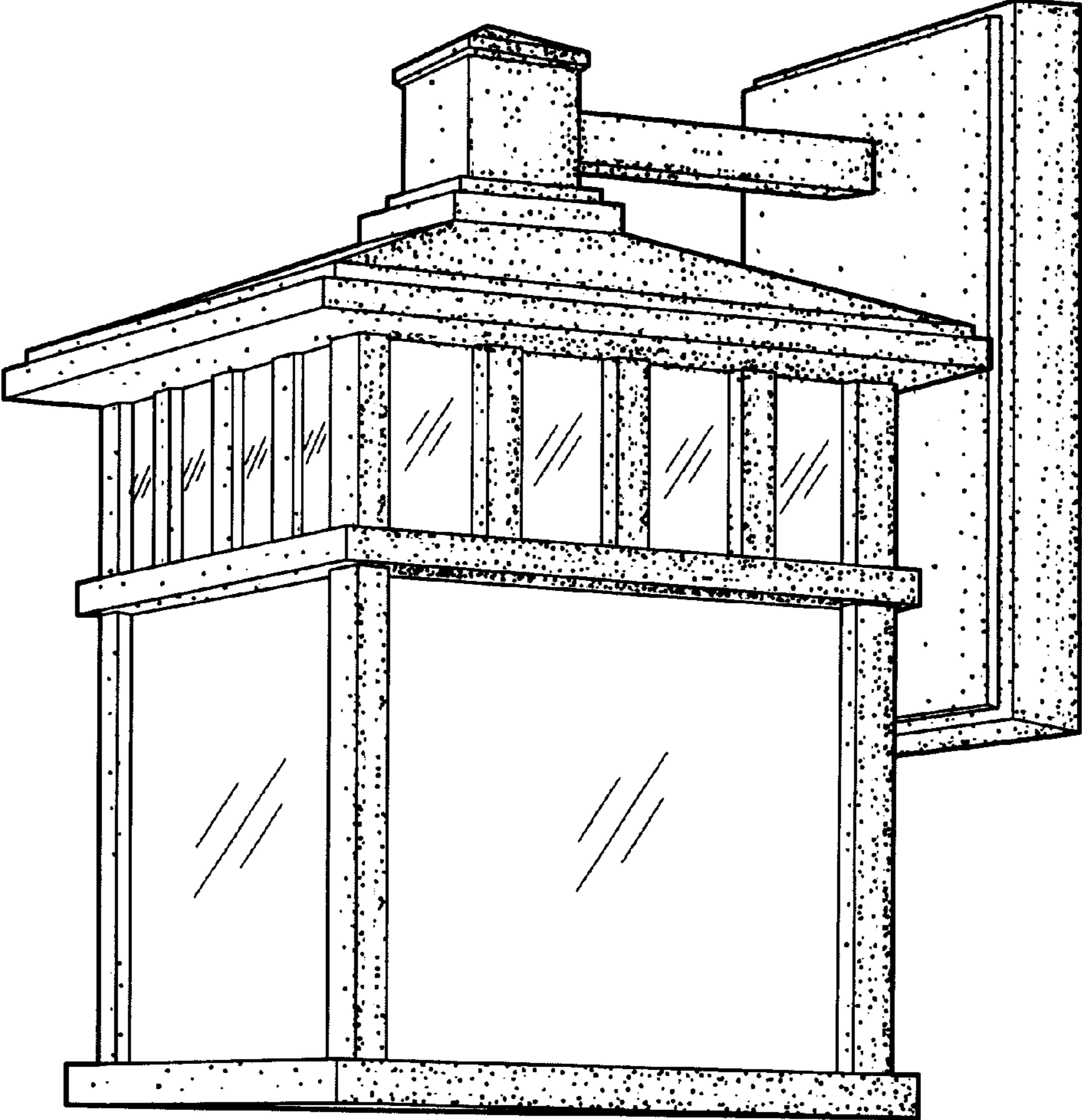

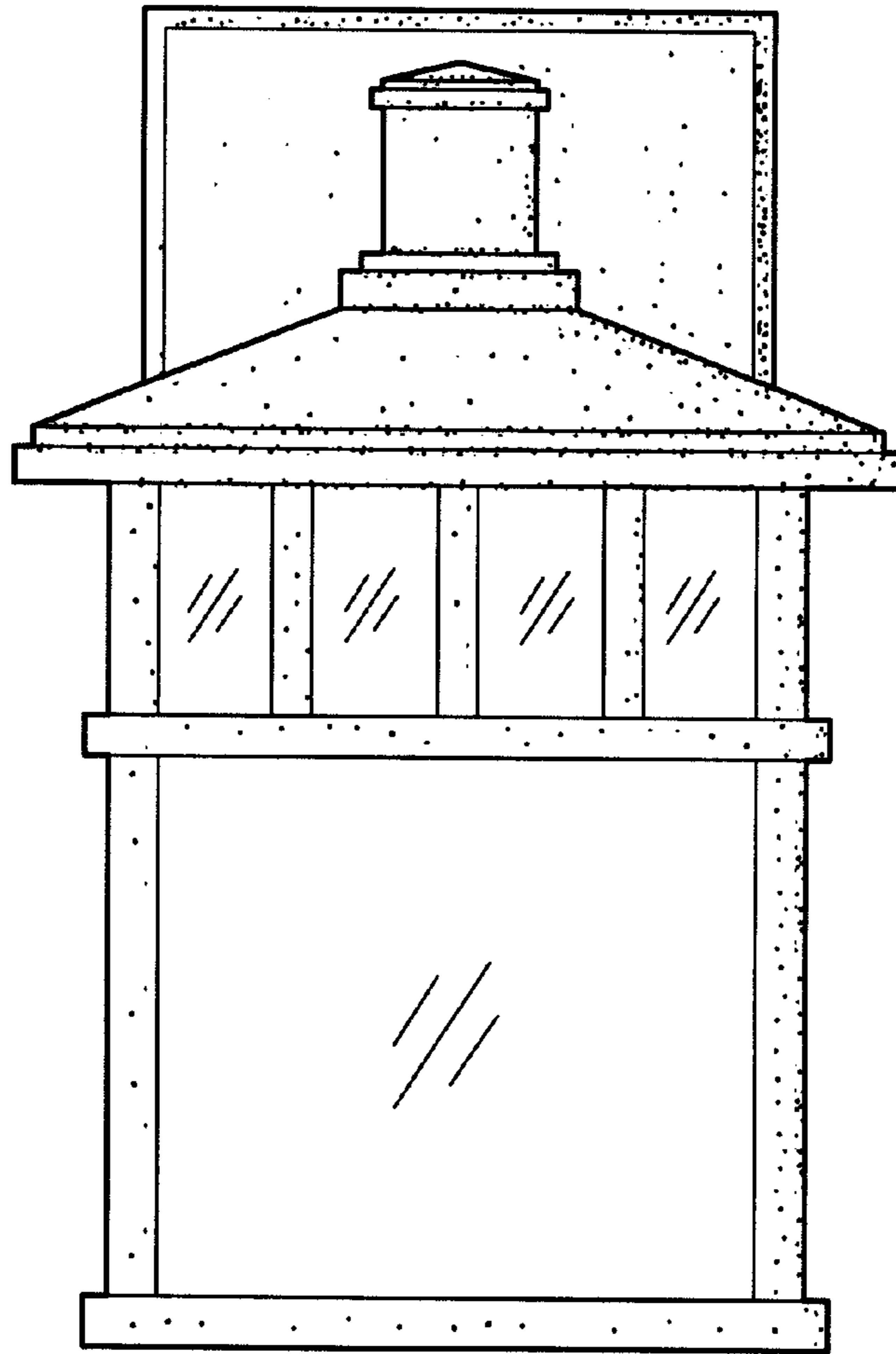

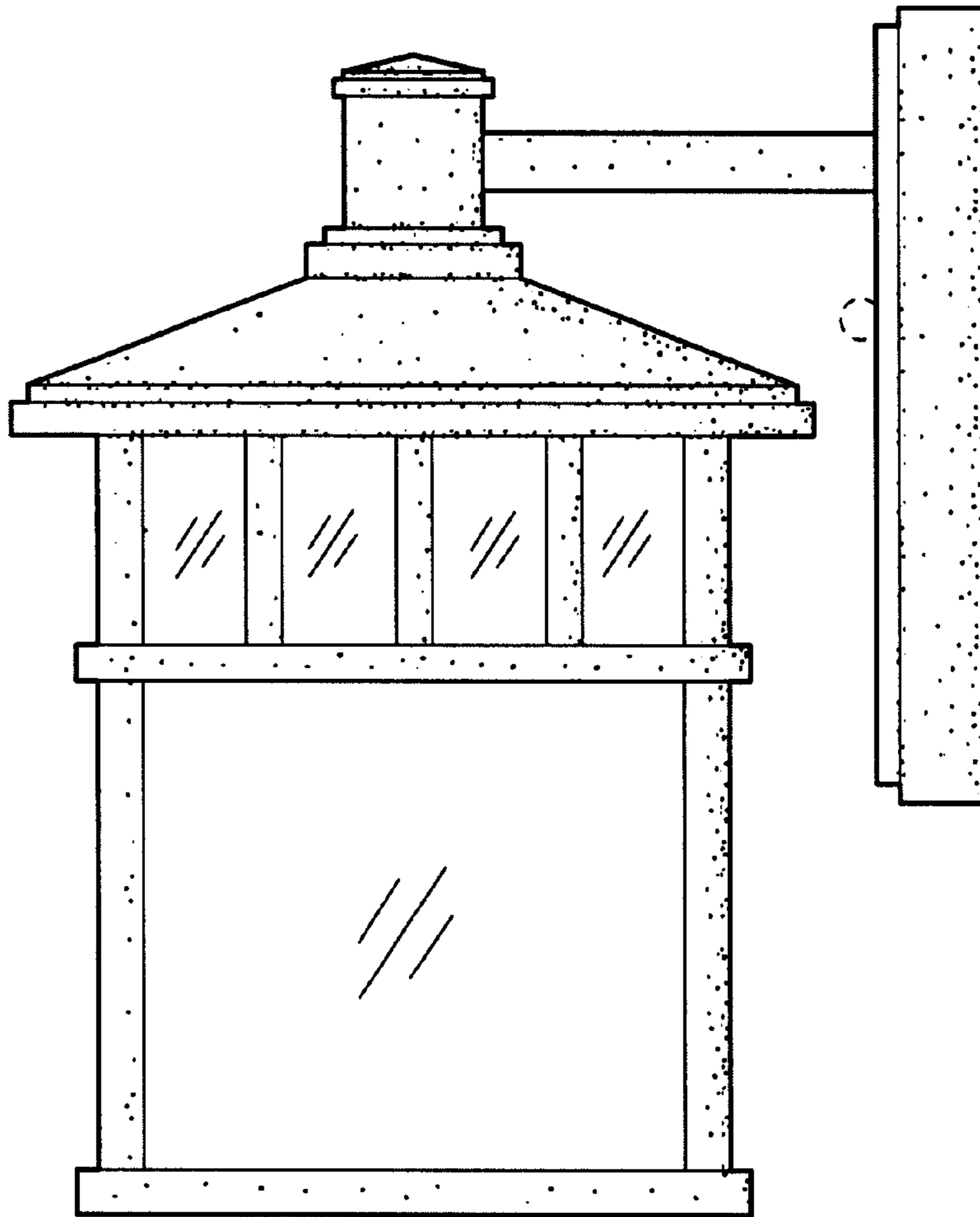

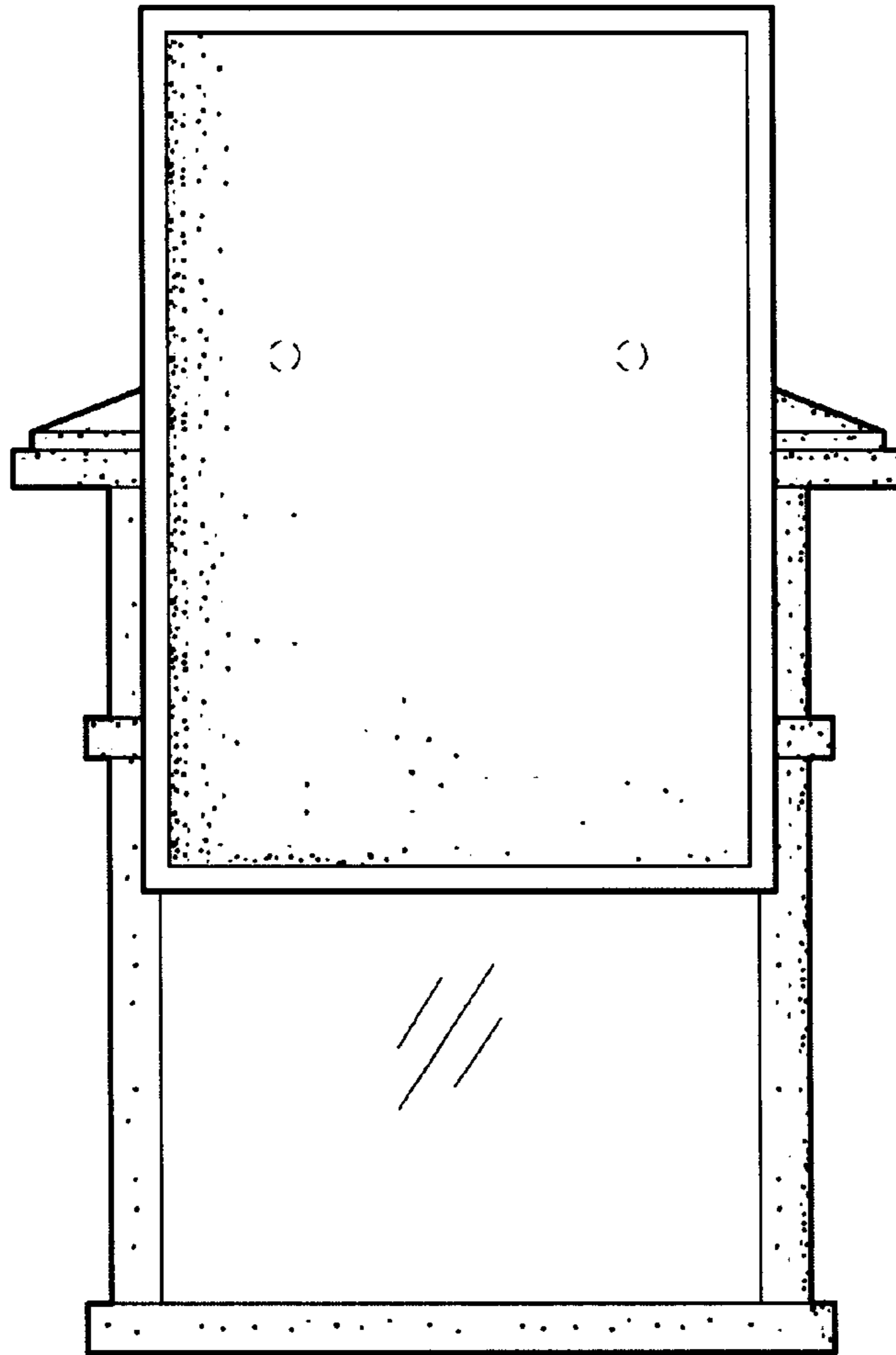

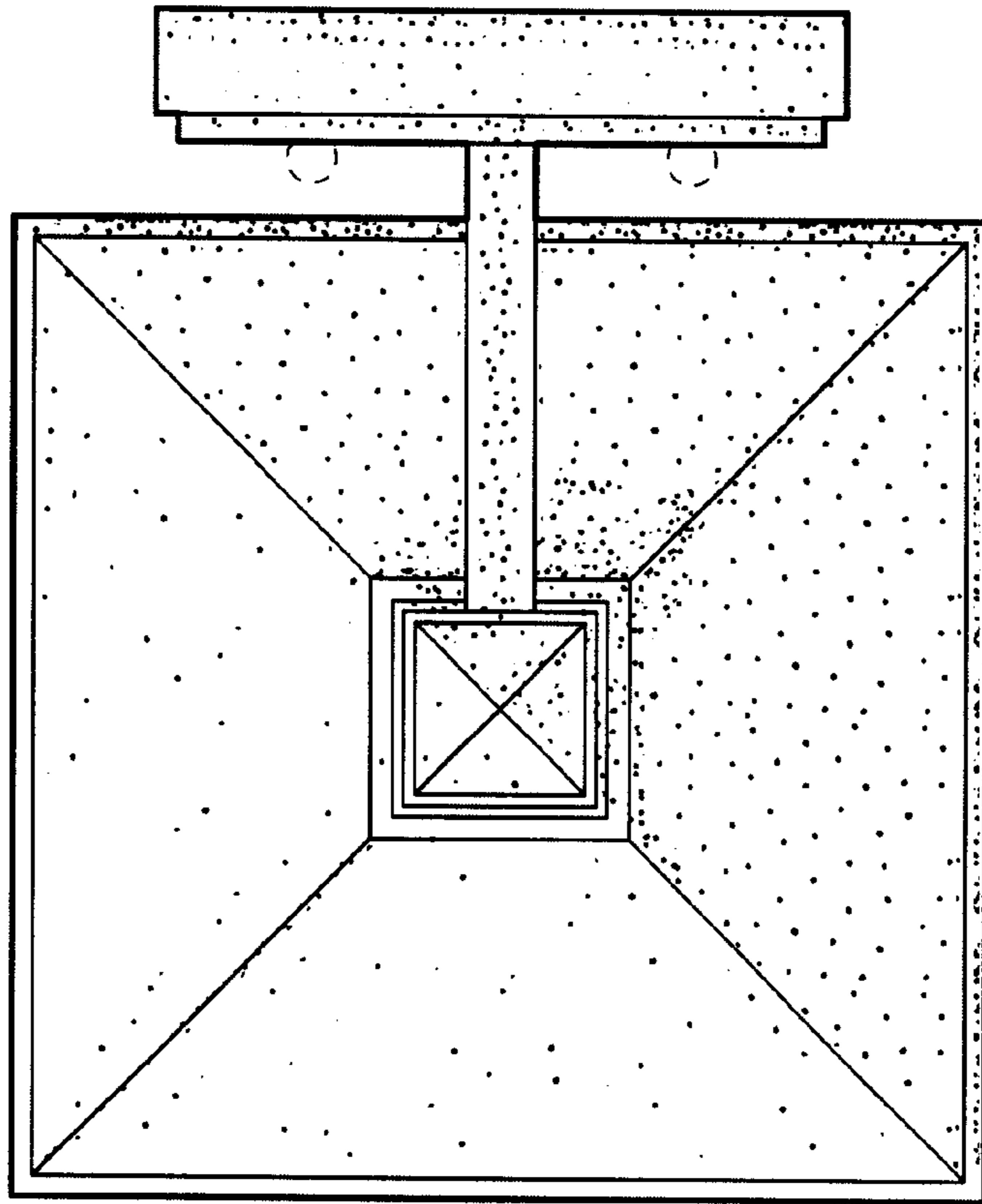

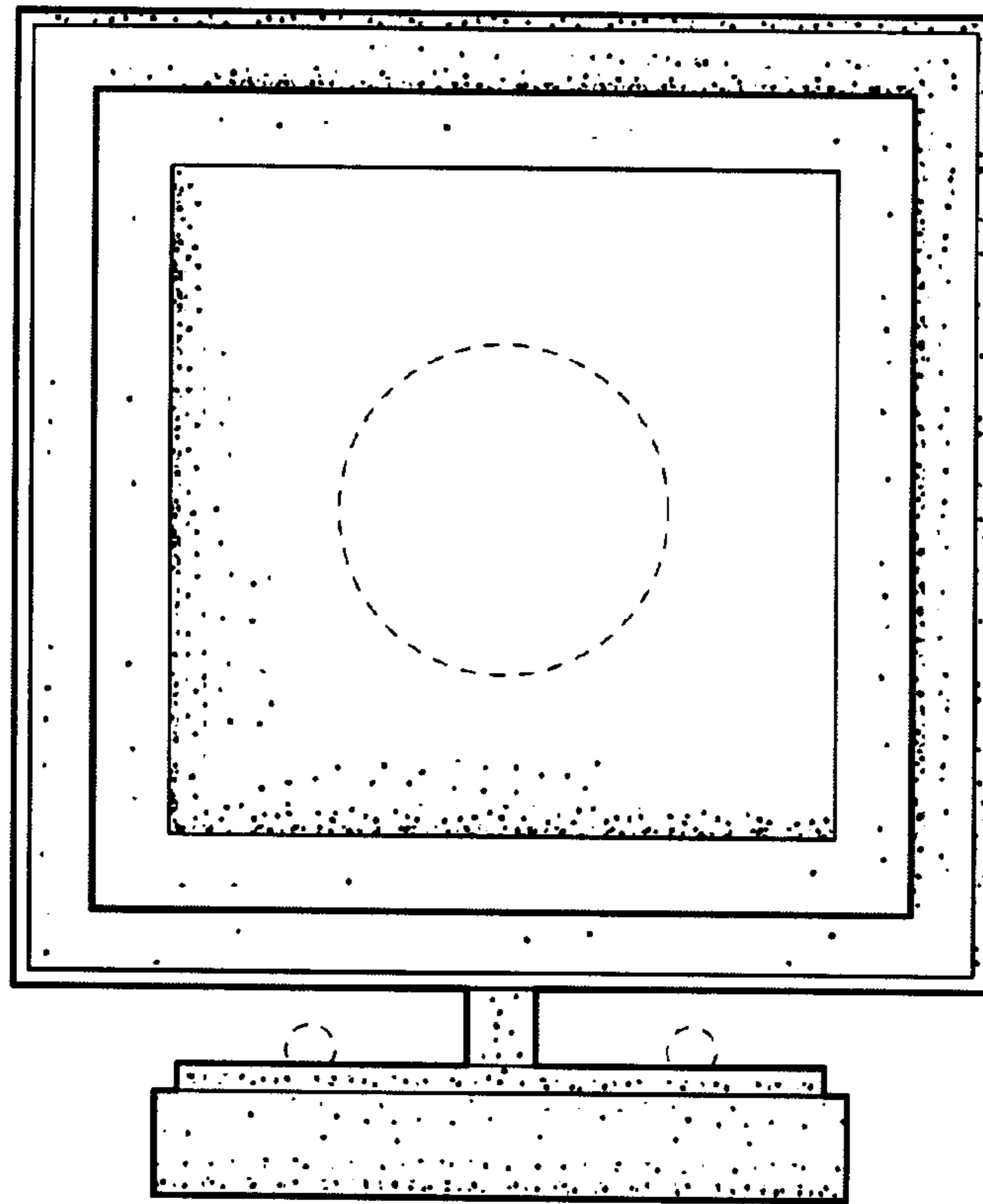
