(57) **CLAIM**

The ornamental design for the cigar or cigarette holder, as shown and described.

DESCRIPTION

FIG. 1 is an environmental front perspective view of a cigar or cigarette holder illustrating a ball and a tee in a stowed position,

FIG. 2 is another environmental front perspective view of the cigar or cigarette holder of FIG. 1 illustrating the ball and the tee in an extended position,

FIG. 3 is a back view of the cigar or cigarette holder without the ball and the tee of FIGS. 1 or 2,

FIG. 4 is a front view of the cigar or cigarette holder without the ball and the tee of FIGS. 1 or 2,

FIG. 5 is a bottom view of the cigar or cigarette holder without the ball and the tee of FIGS. 1 or 2,

FIG. 6 is a top view of the cigar or cigarette holder without the ball and the tee of FIGS. 1 or 2,

FIG. 7 is a right view of the cigar or cigarette holder without the ball and the tee of FIGS. 1 or 2,

FIG. 8 is a left view of the cigar or cigarette holder without the ball and the tee of FIGS. 1 or 2,

FIG. 9 is a back view of the cigar or cigarette holder with the ball and the tee of FIGS. 1 or 2,

FIG. 10 is a front view of the cigar or cigarette holder with the ball and the tee of FIGS. 1 or 2,

FIG. 11 is a bottom view of the cigar or cigarette holder with the ball and the tee of FIGS. 1 or 2,

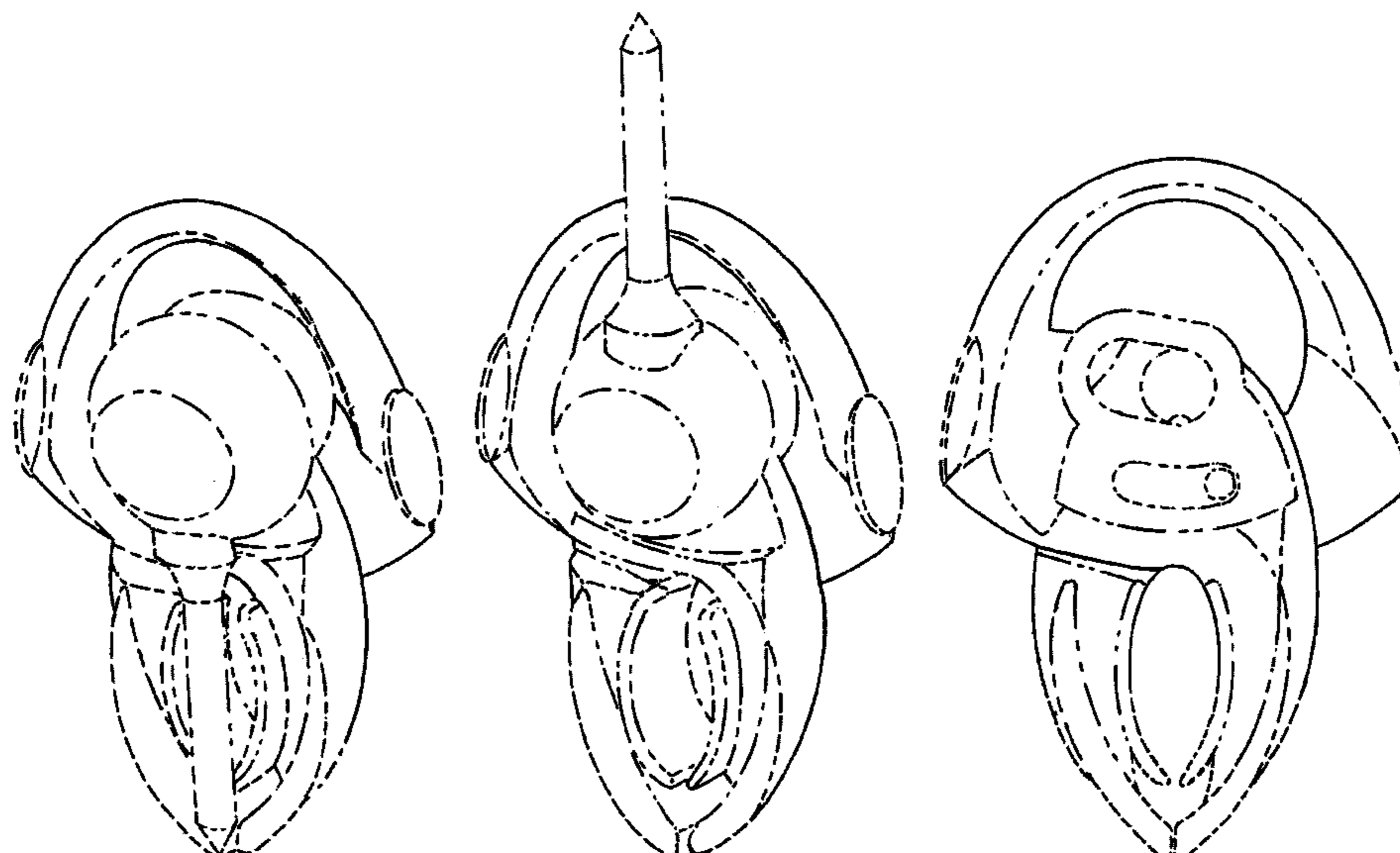
FIG. 12 is a top view of the cigar or cigarette holder with the ball and the tee of FIGS. 1 or 2,

FIG. 13 is a right view of the cigar or cigarette holder with the ball and the tee of FIGS. 1 or 2; and,

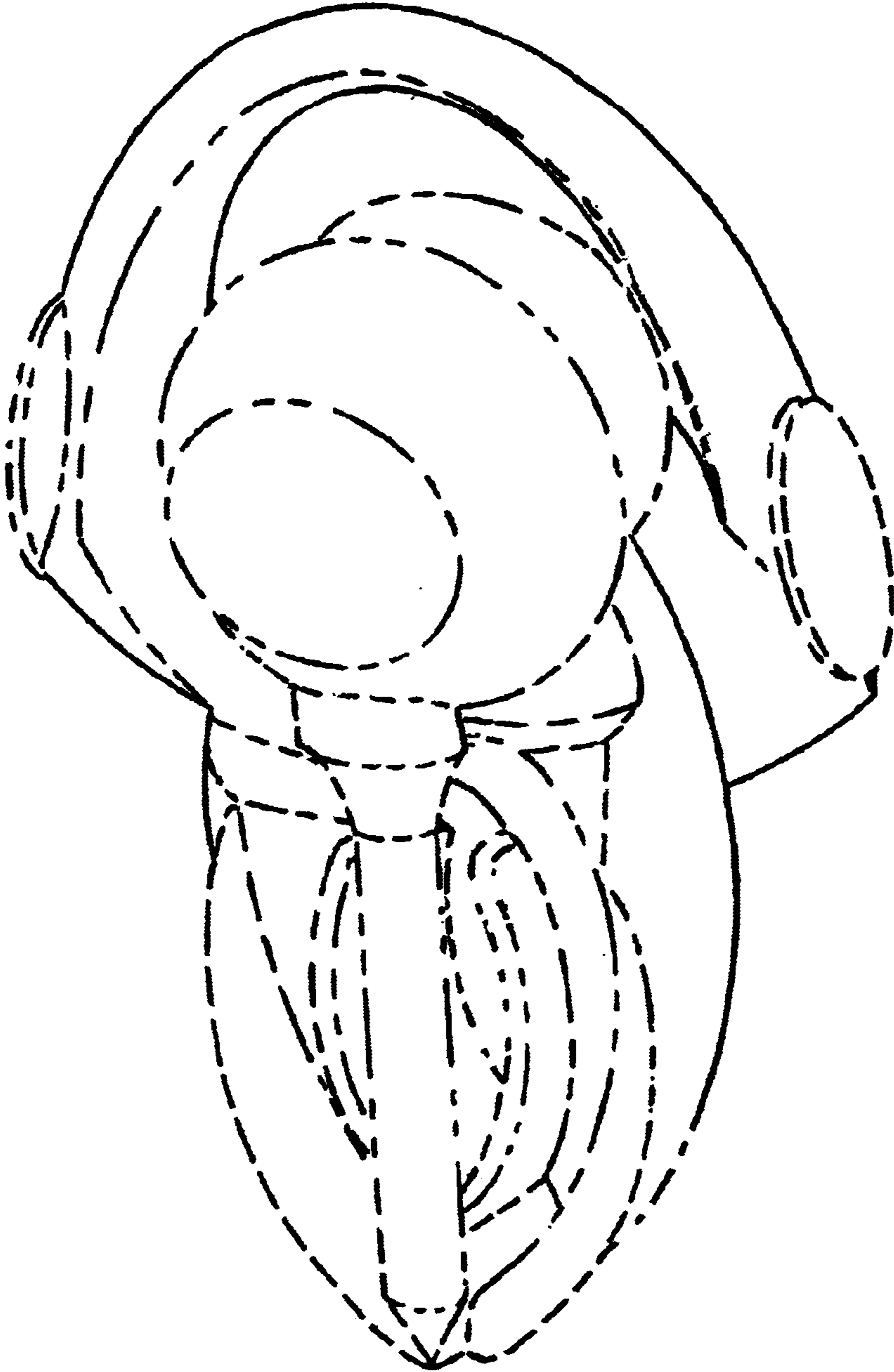

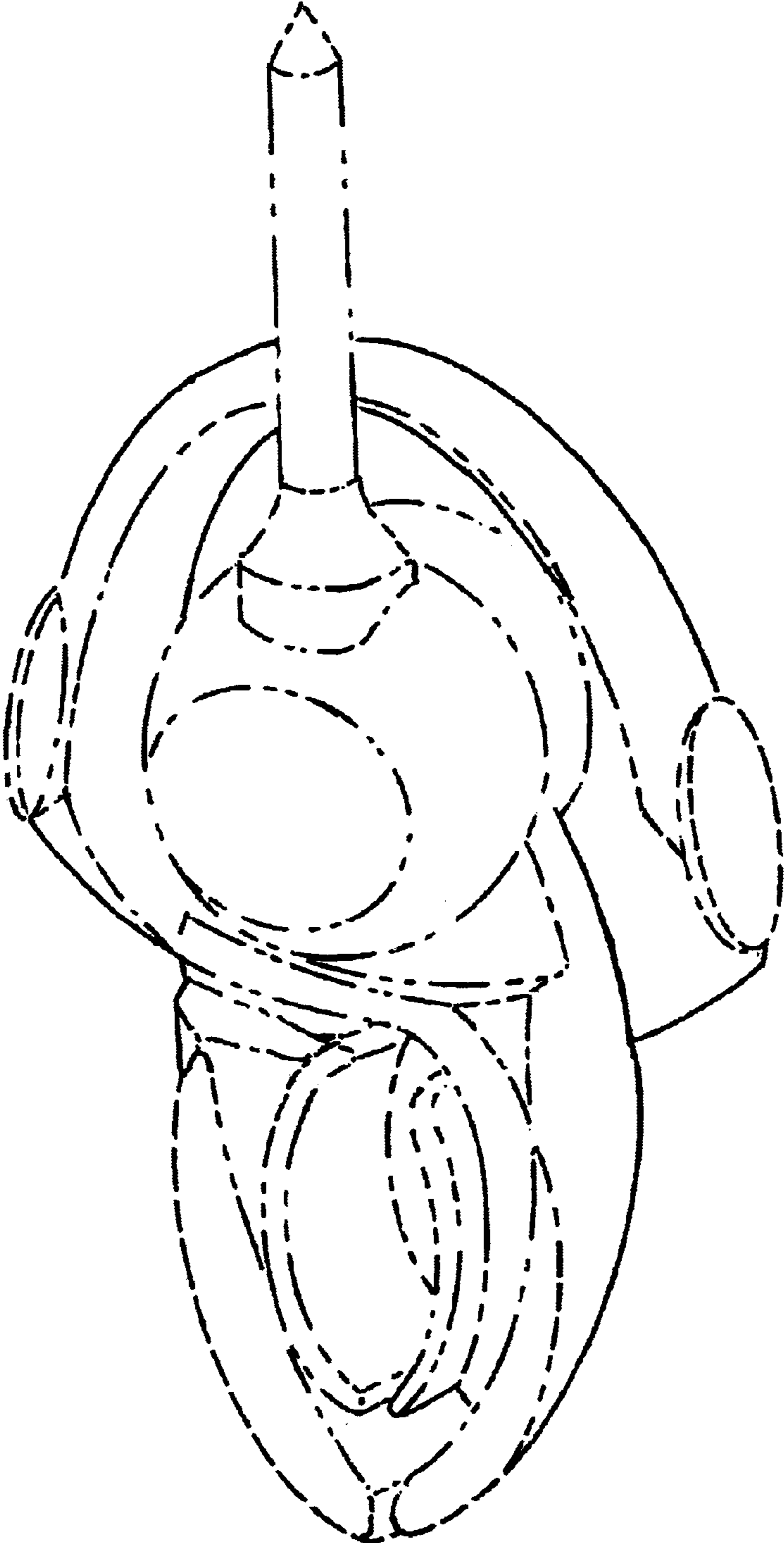

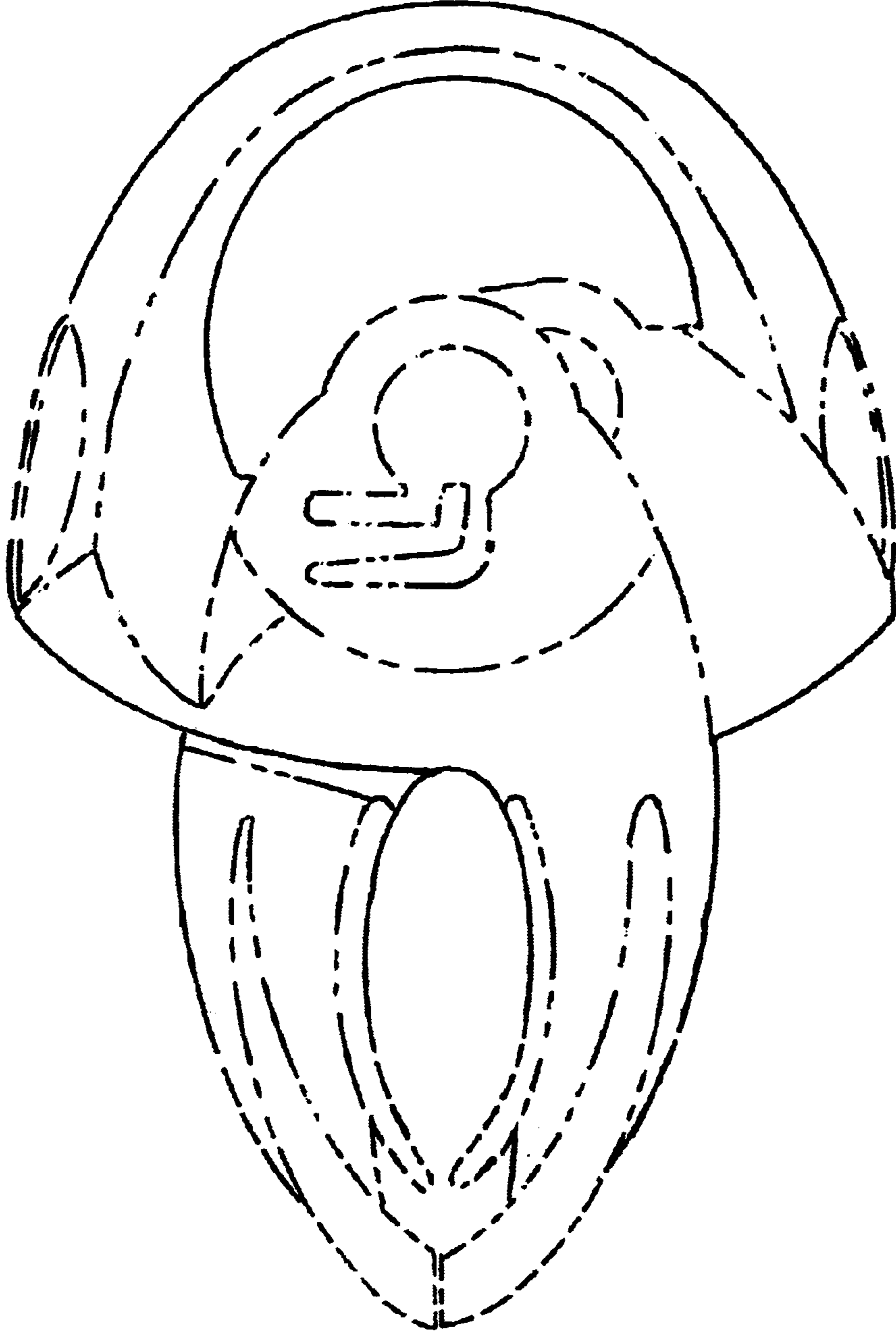

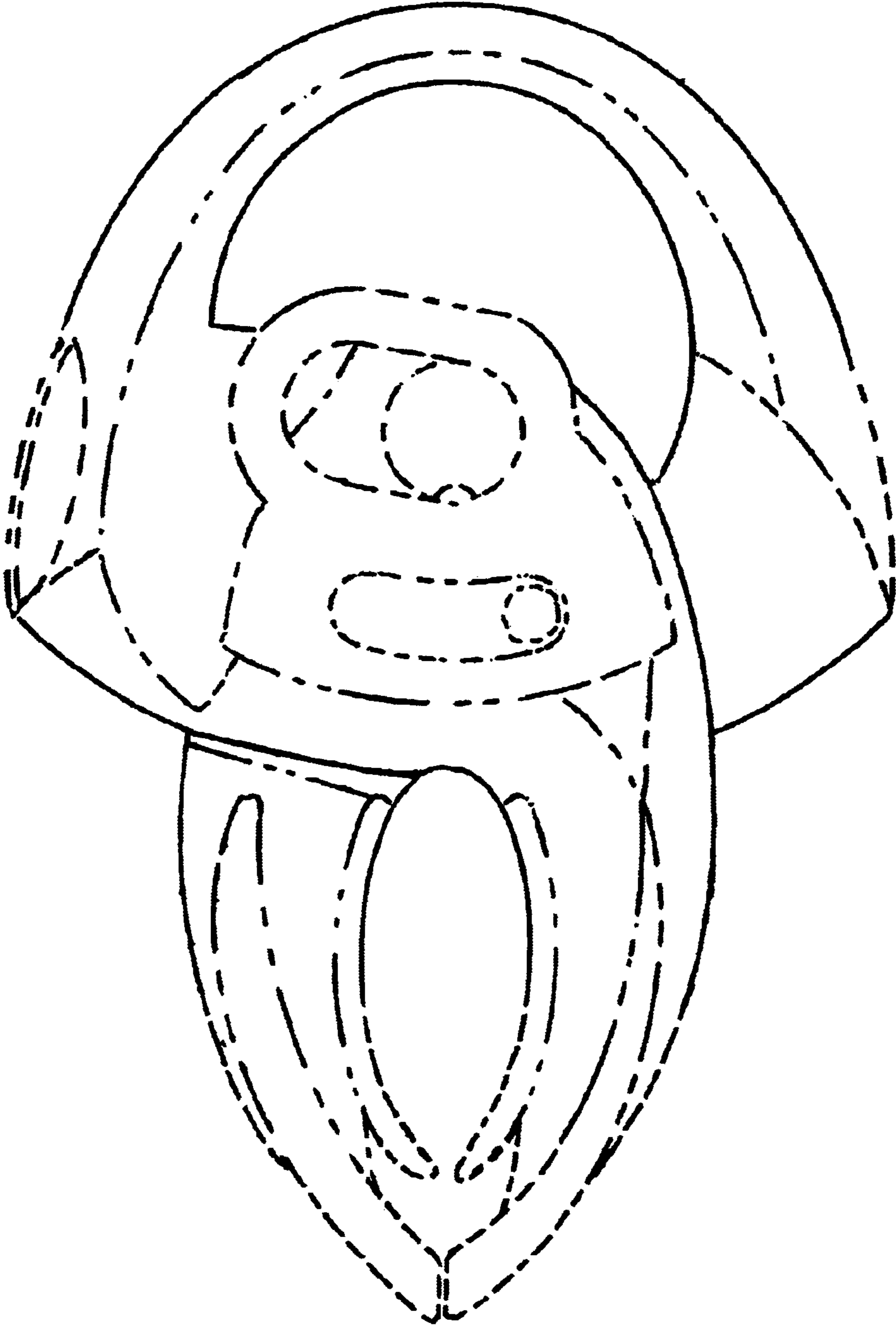

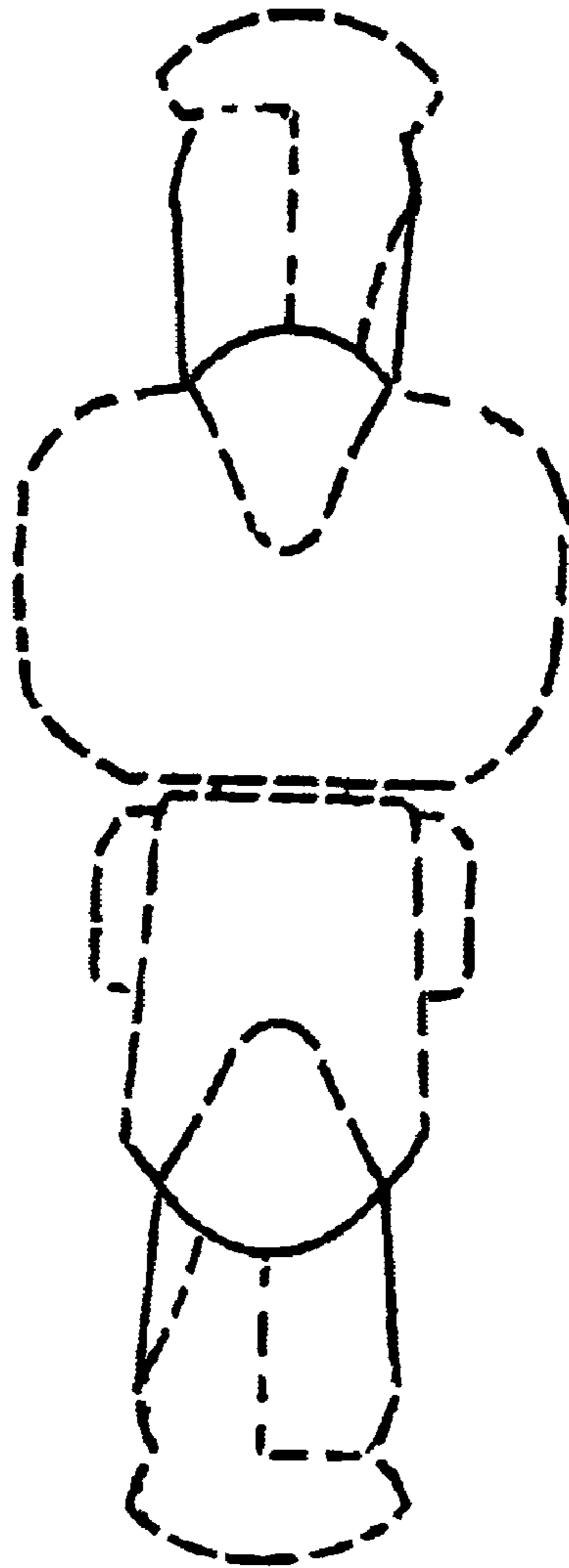

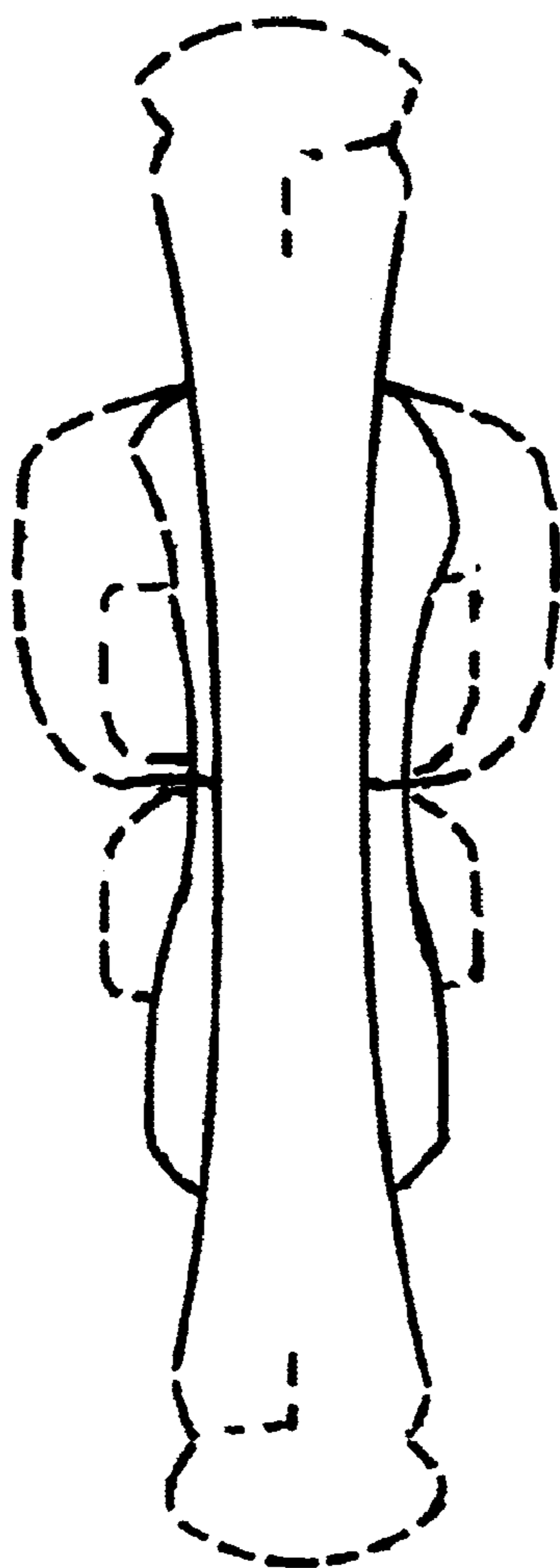

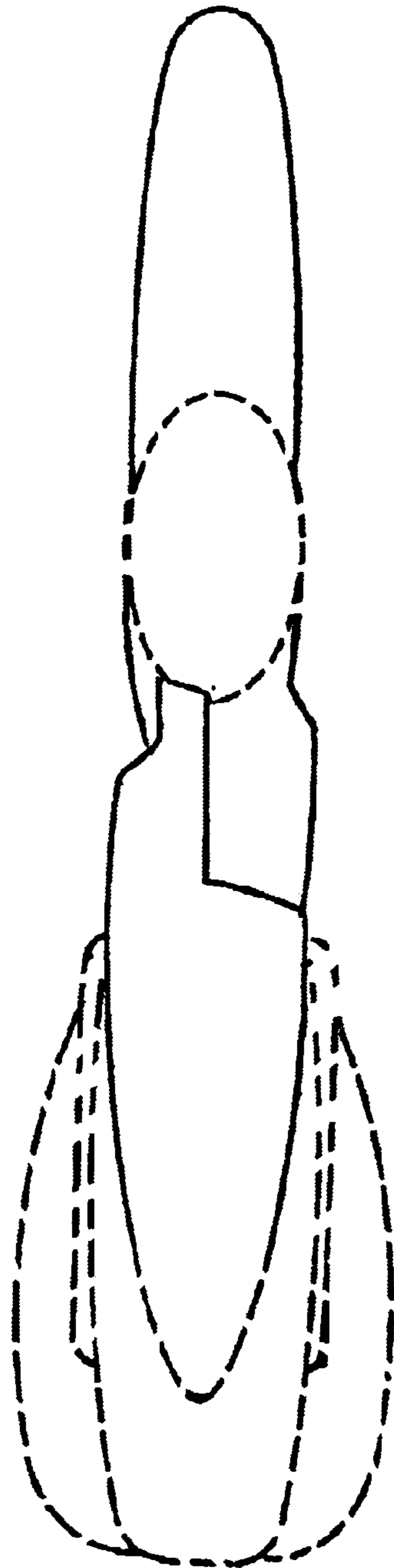

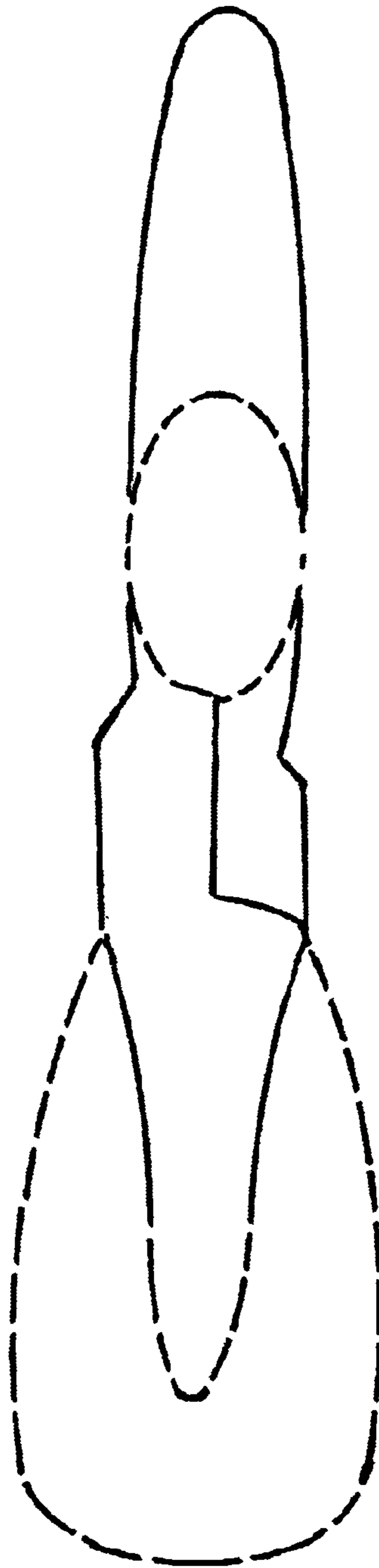

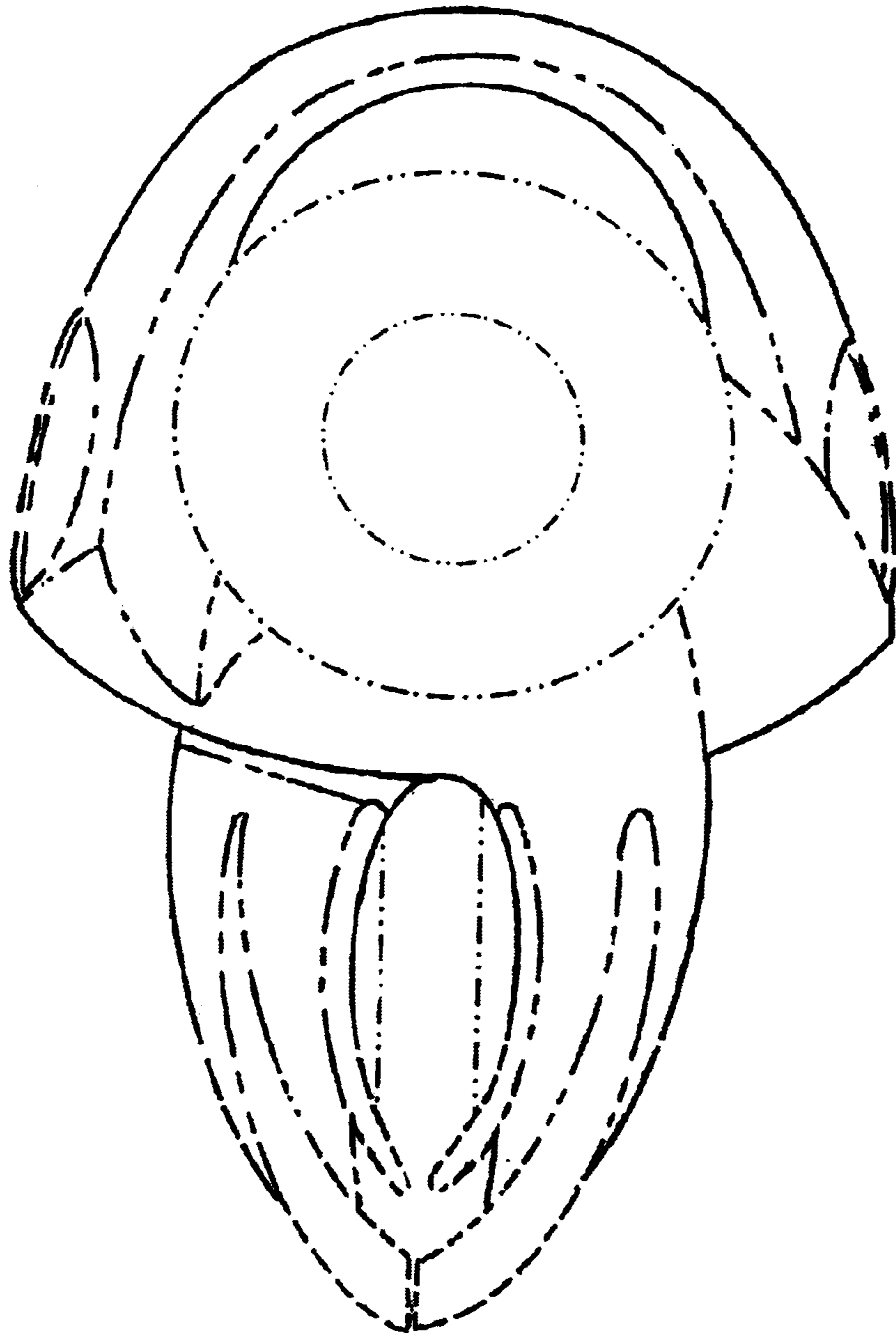

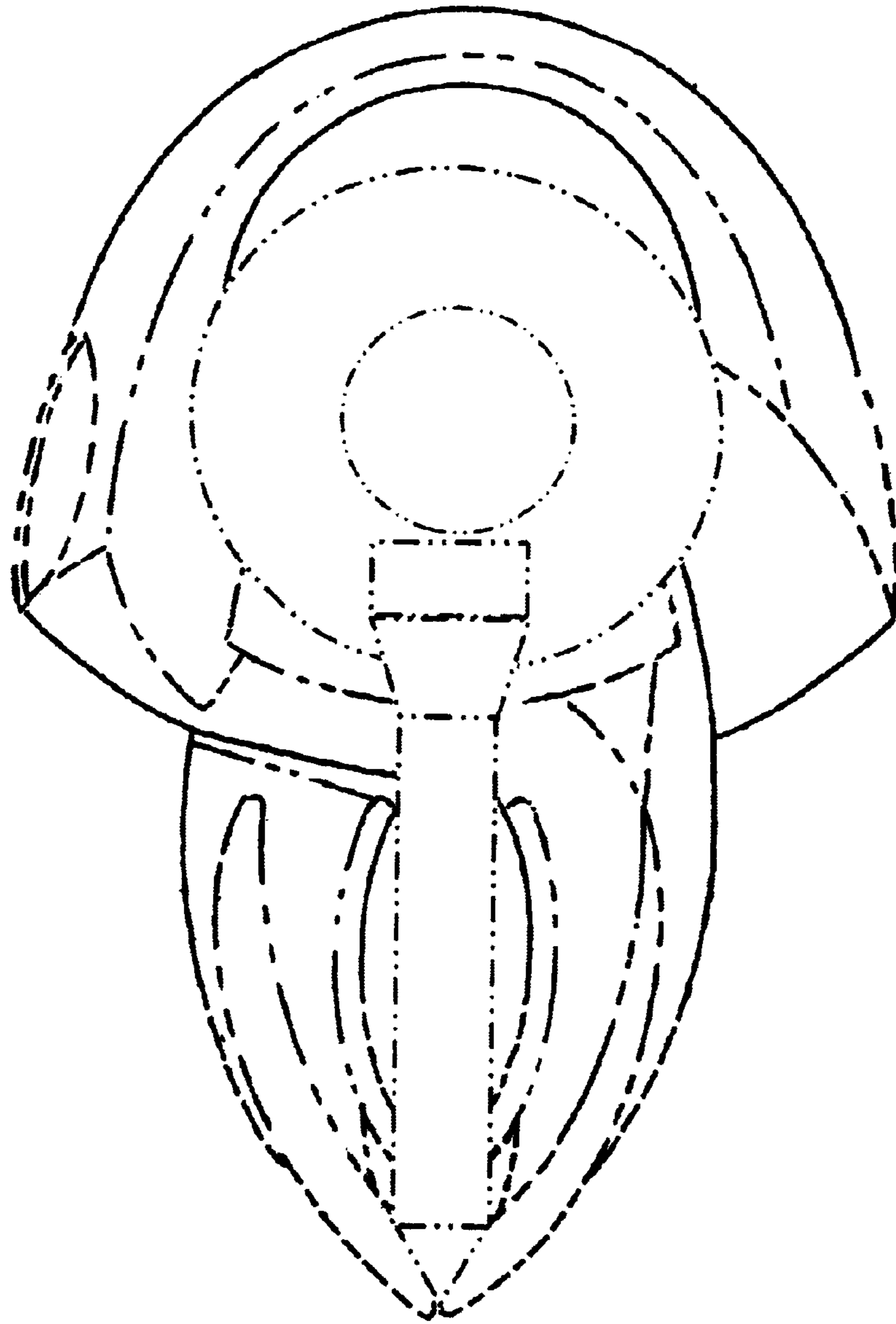

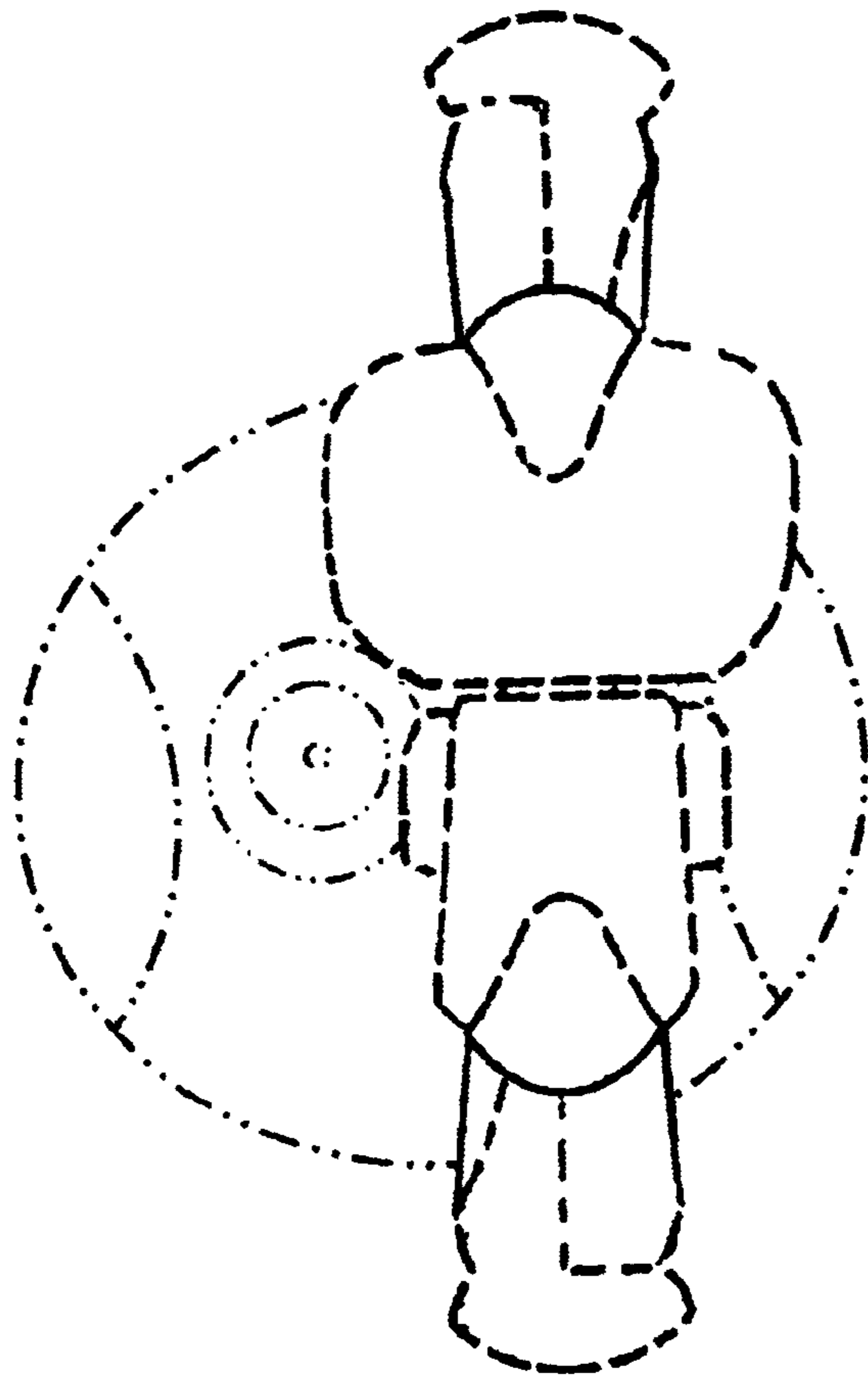

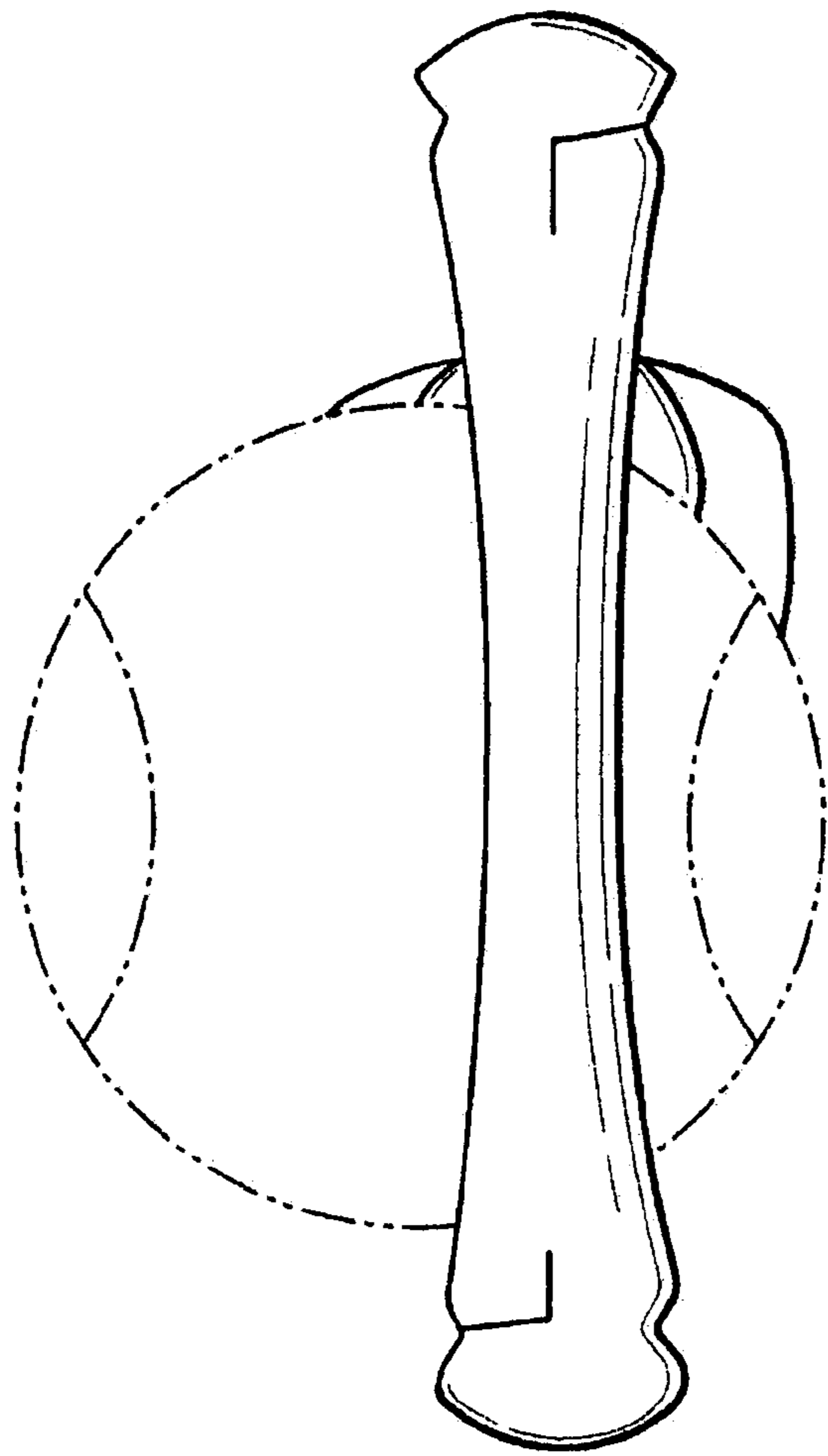

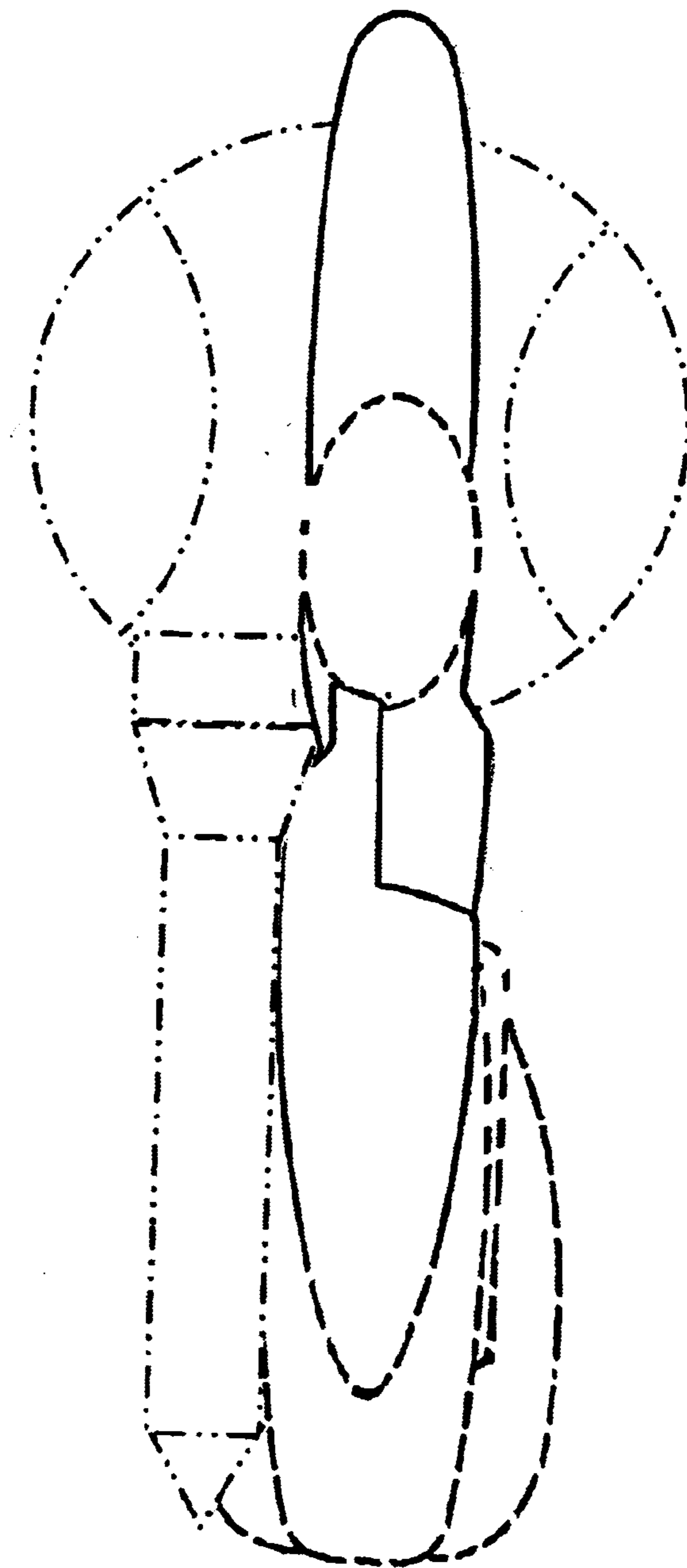

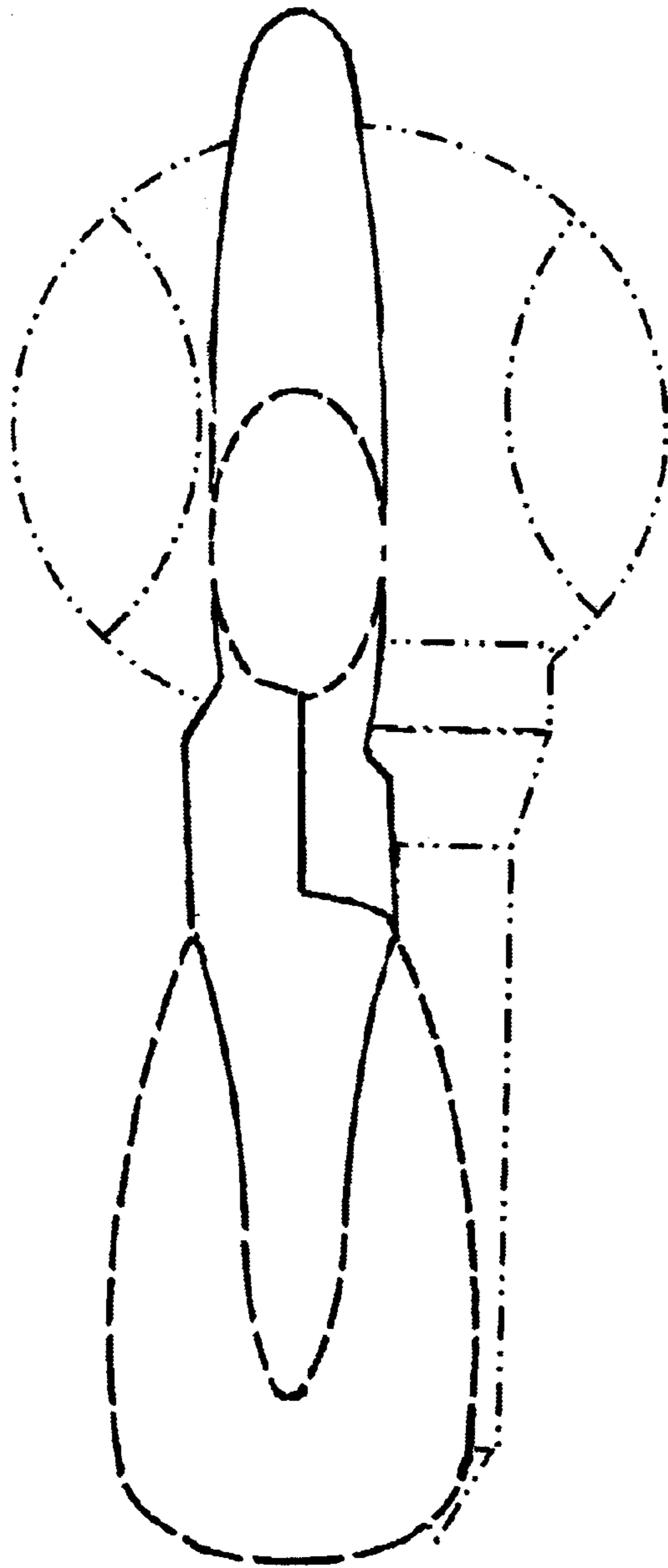
