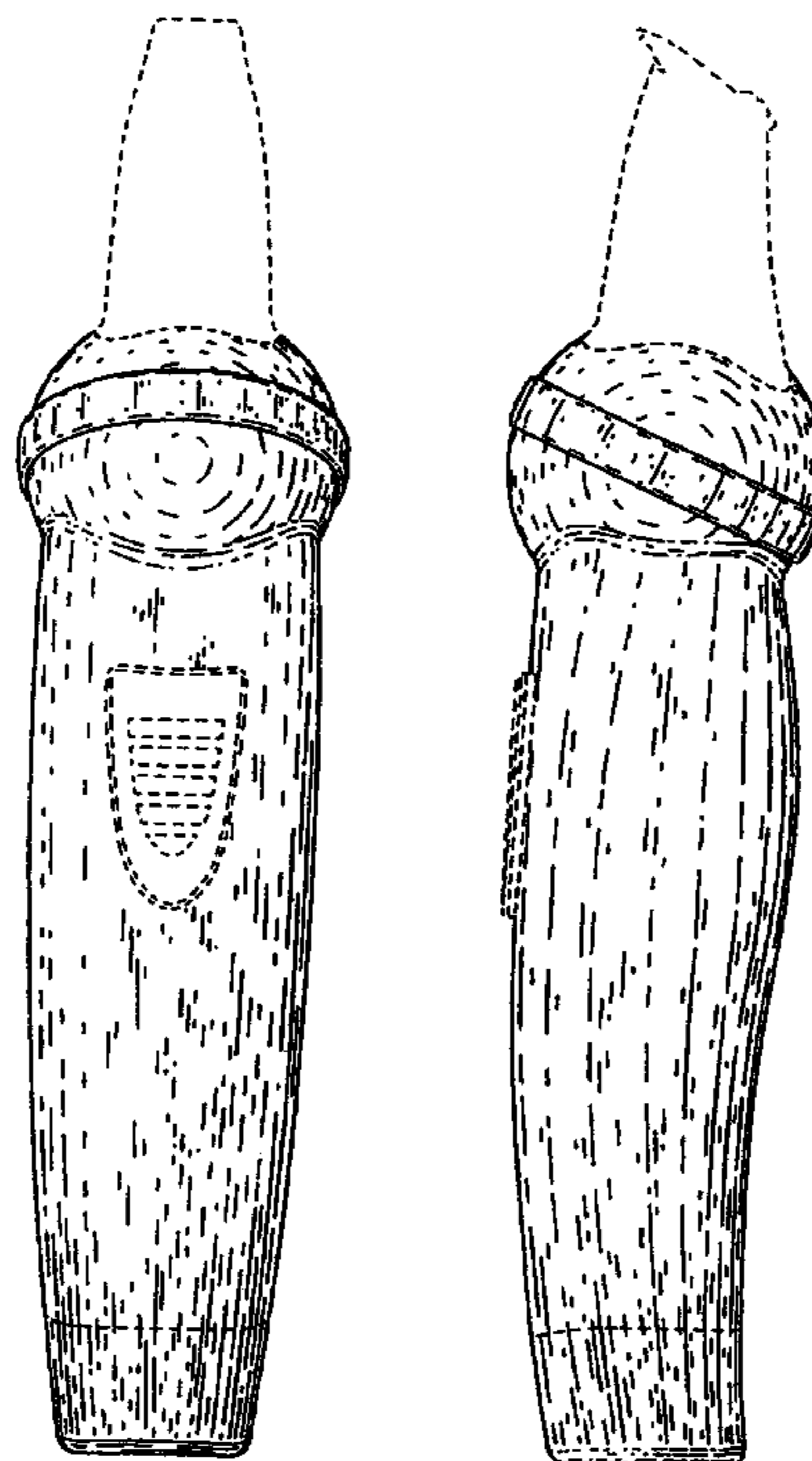
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of a body of a hair trimmer; FIG. 2 is a front view of the same; FIG. 3 is a right side view of the same; FIG. 4 is a rear view of the same; FIG. 5 is a top view of the same; and, FIG. 6 is a bottom view of the same. The broken line showing of the head of the trimmer is shown for illustrative purposes only and form no part of the claimed design.

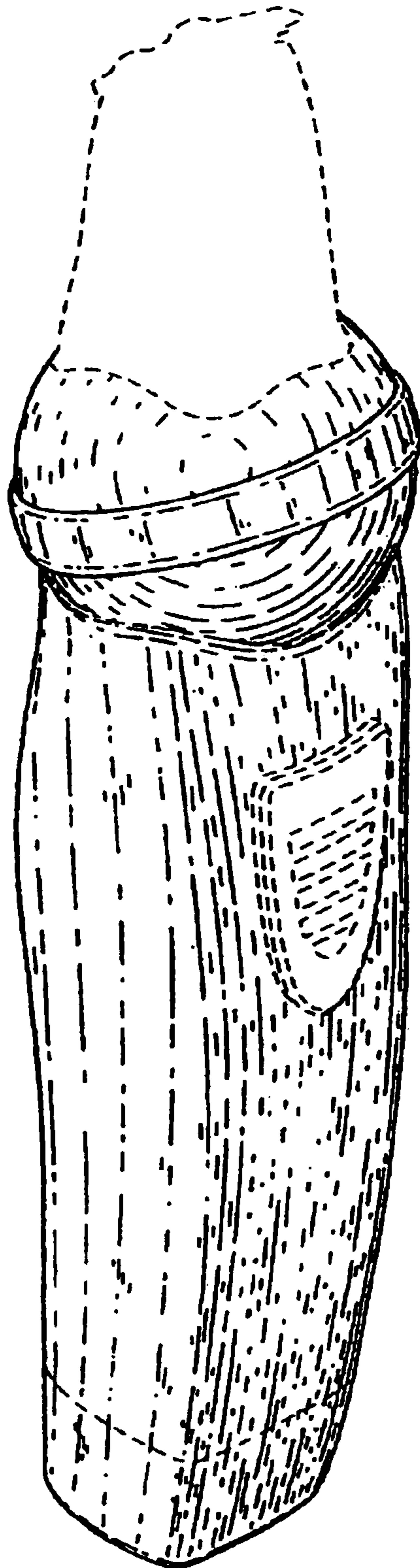

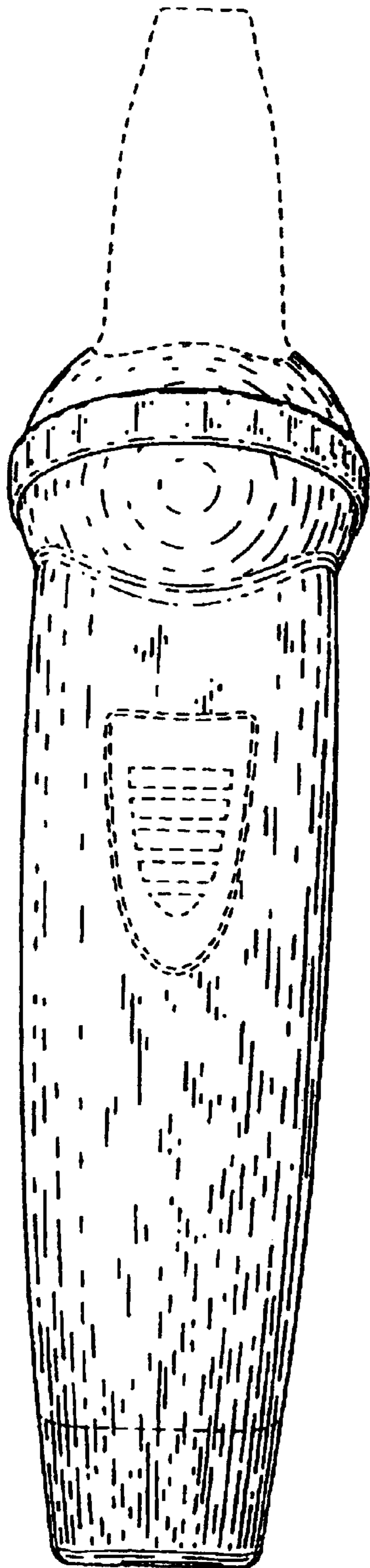

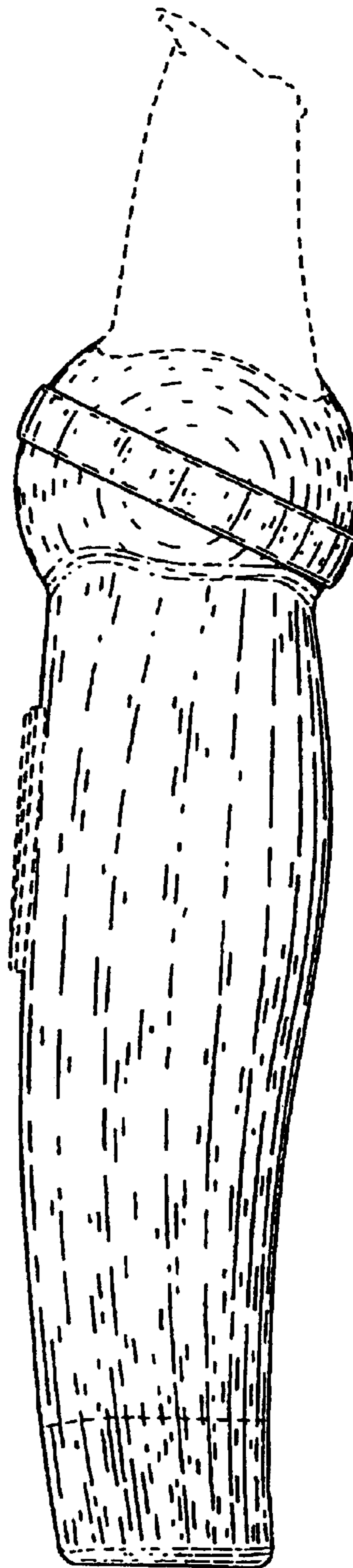

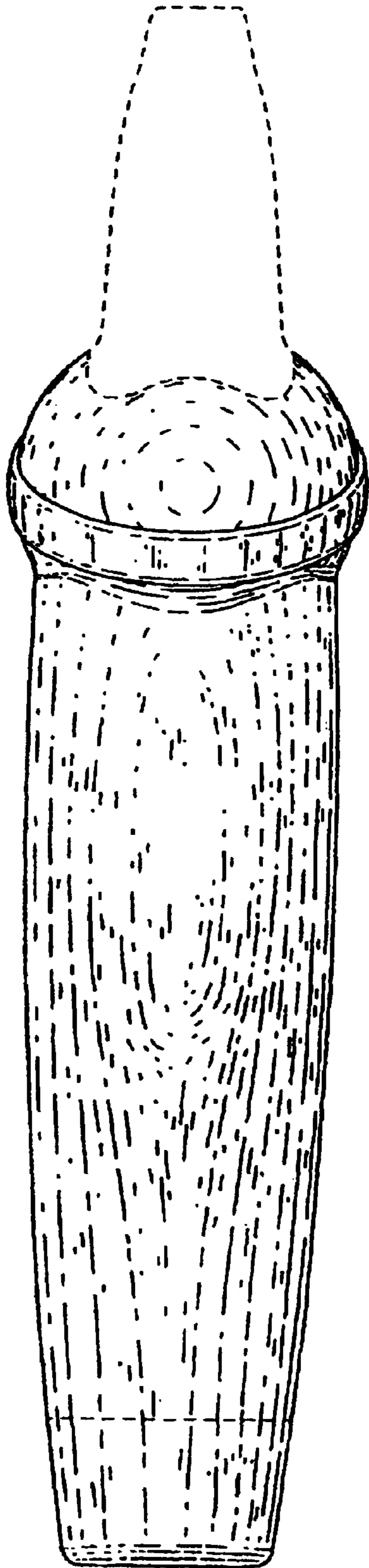

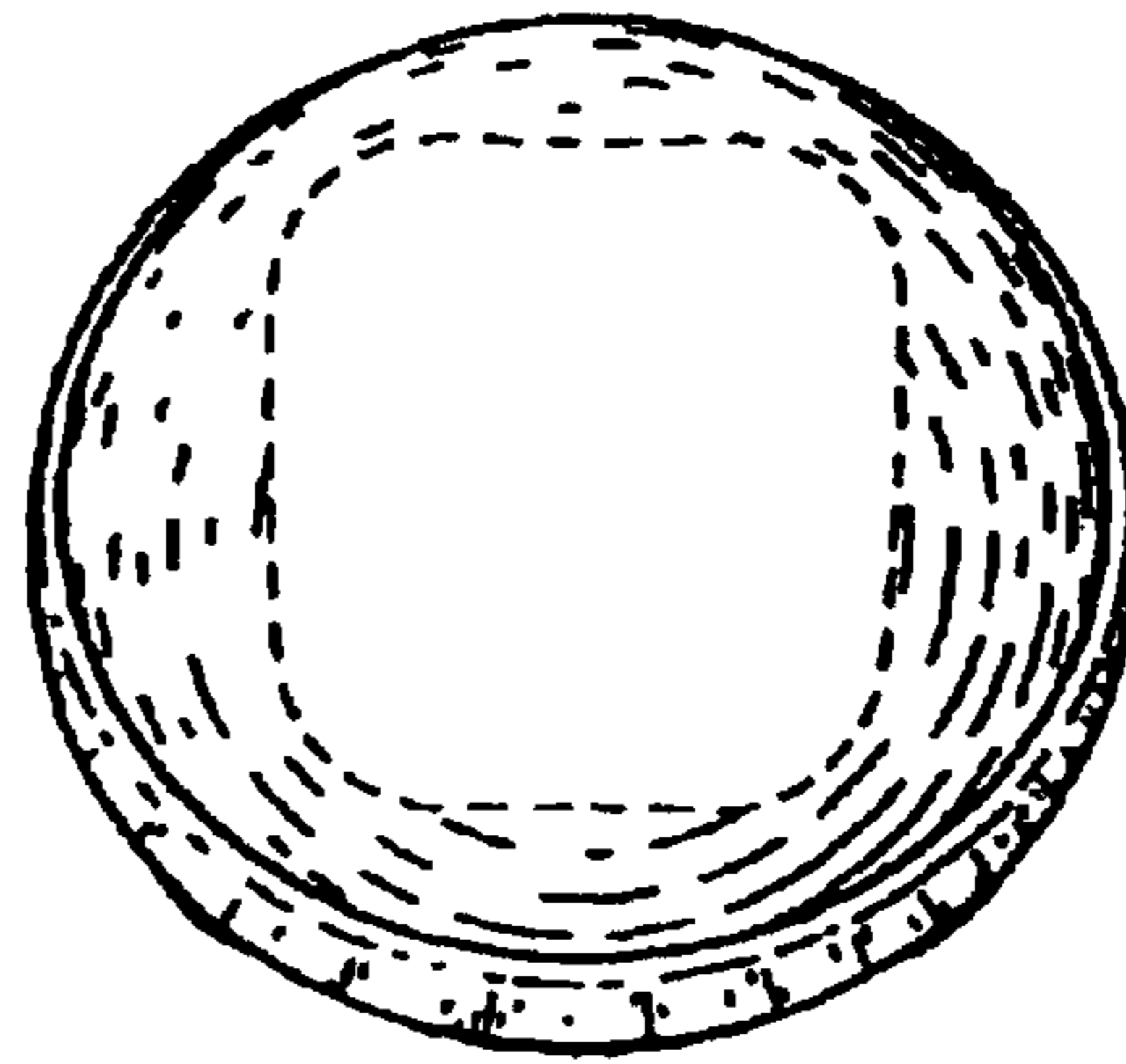

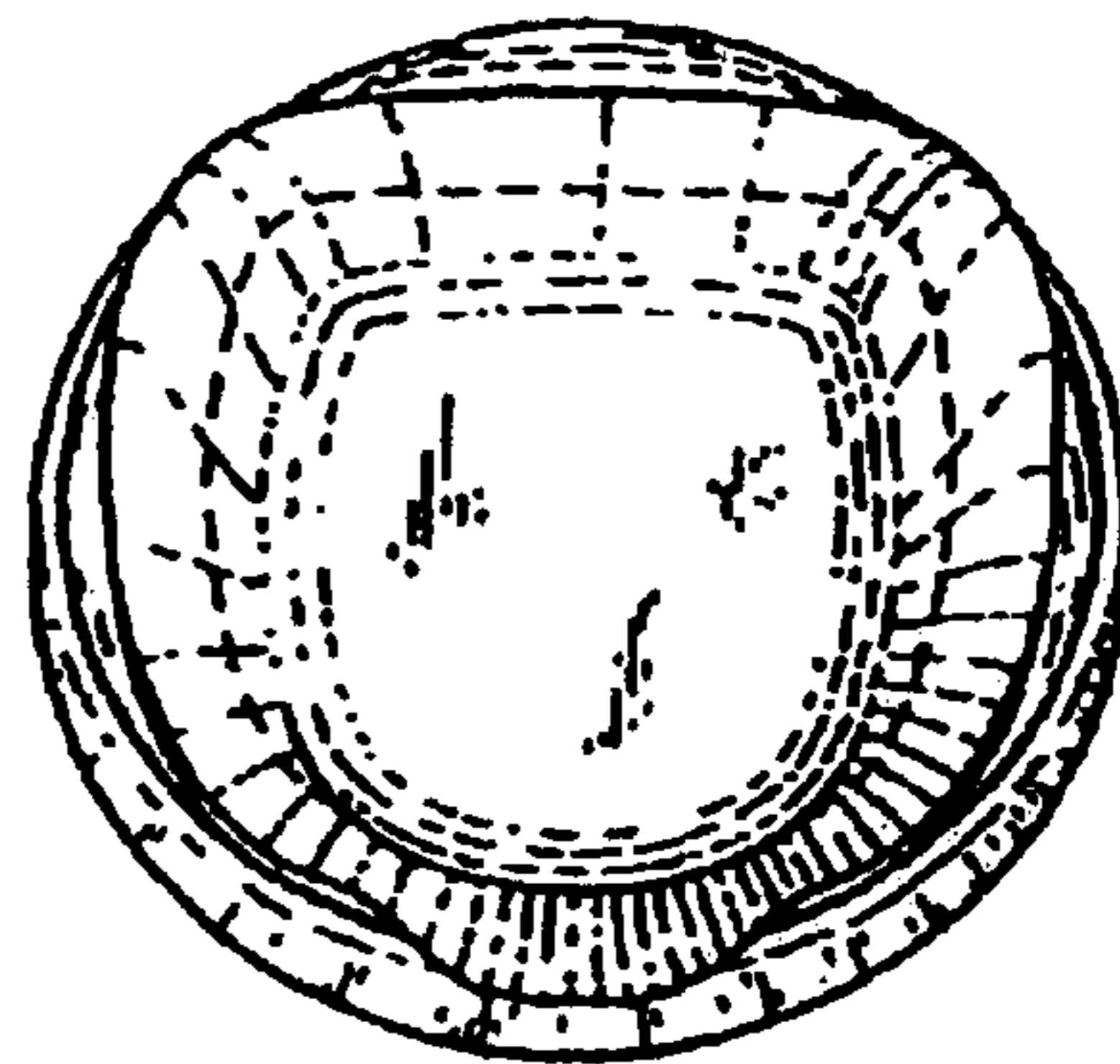
