FIG. 4 is a top plan view of FIG. 2;

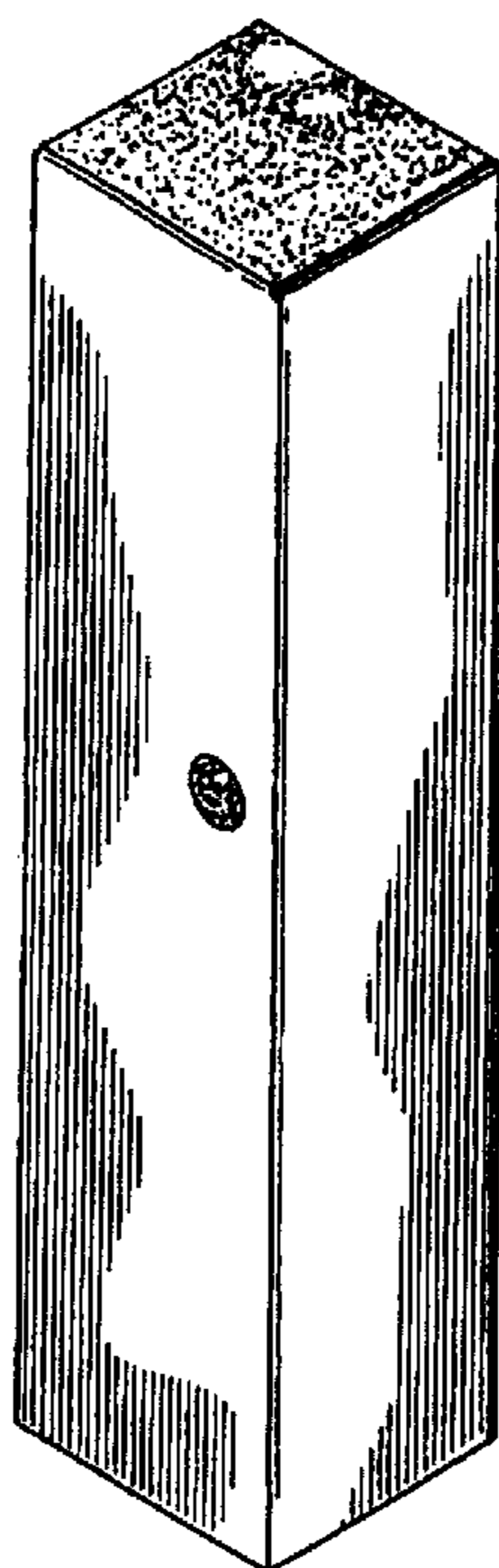
FIG. 5 is a bottom plan view of FIG. 2;

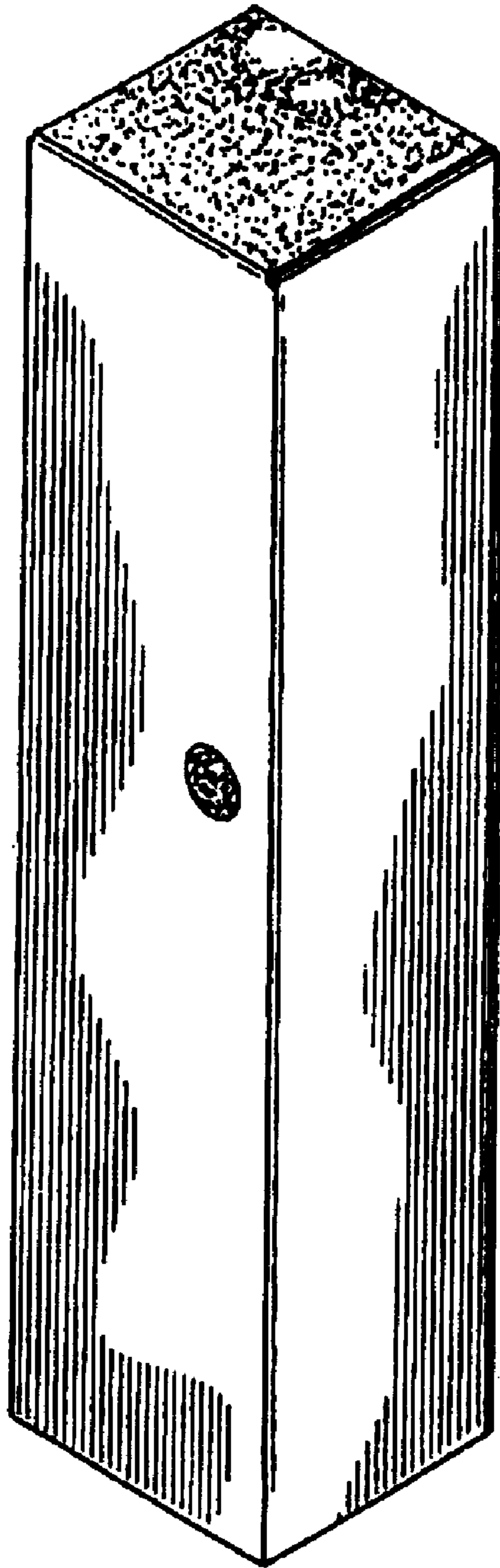
FIG. 6 is right side elevational view of FIG. 2; and,

FIG. 7 is a left side elevational view of FIG. 2.

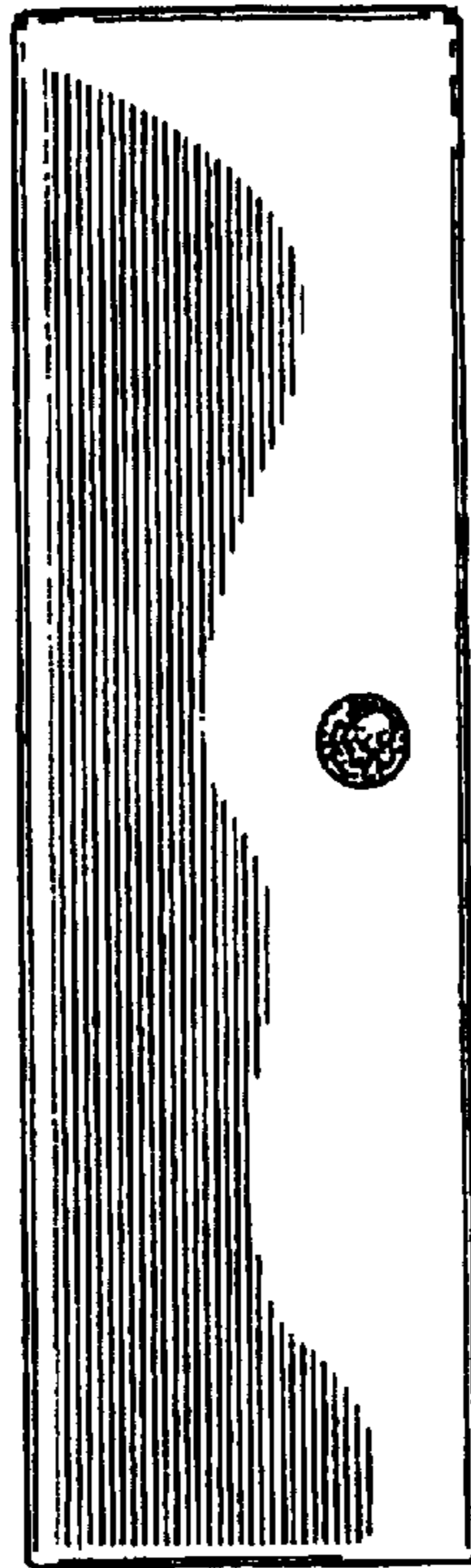

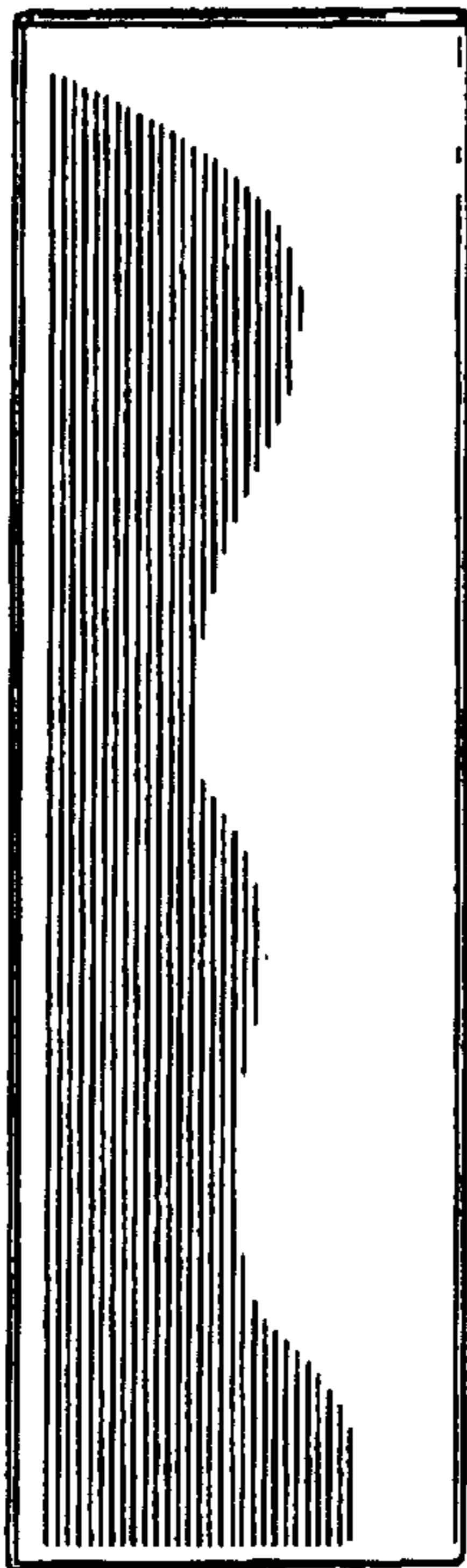




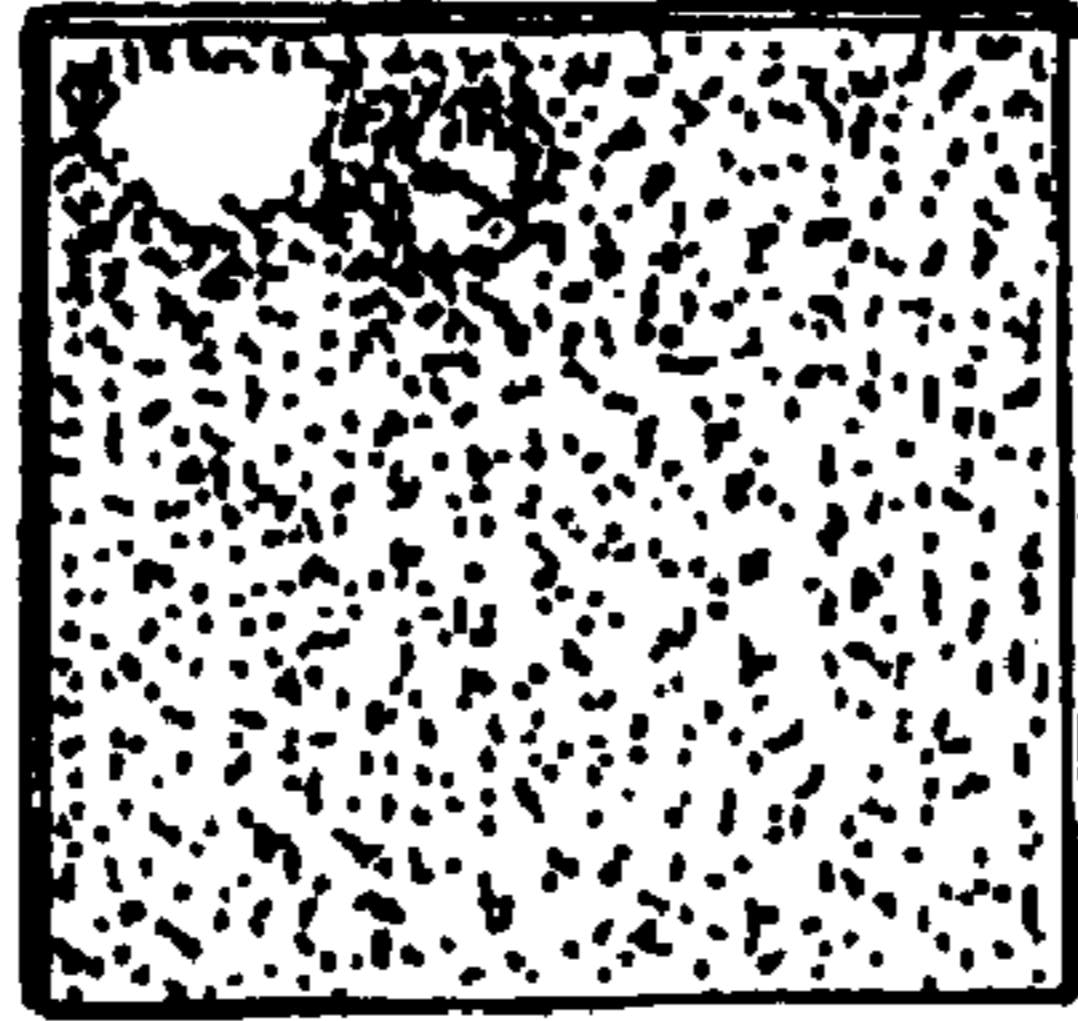

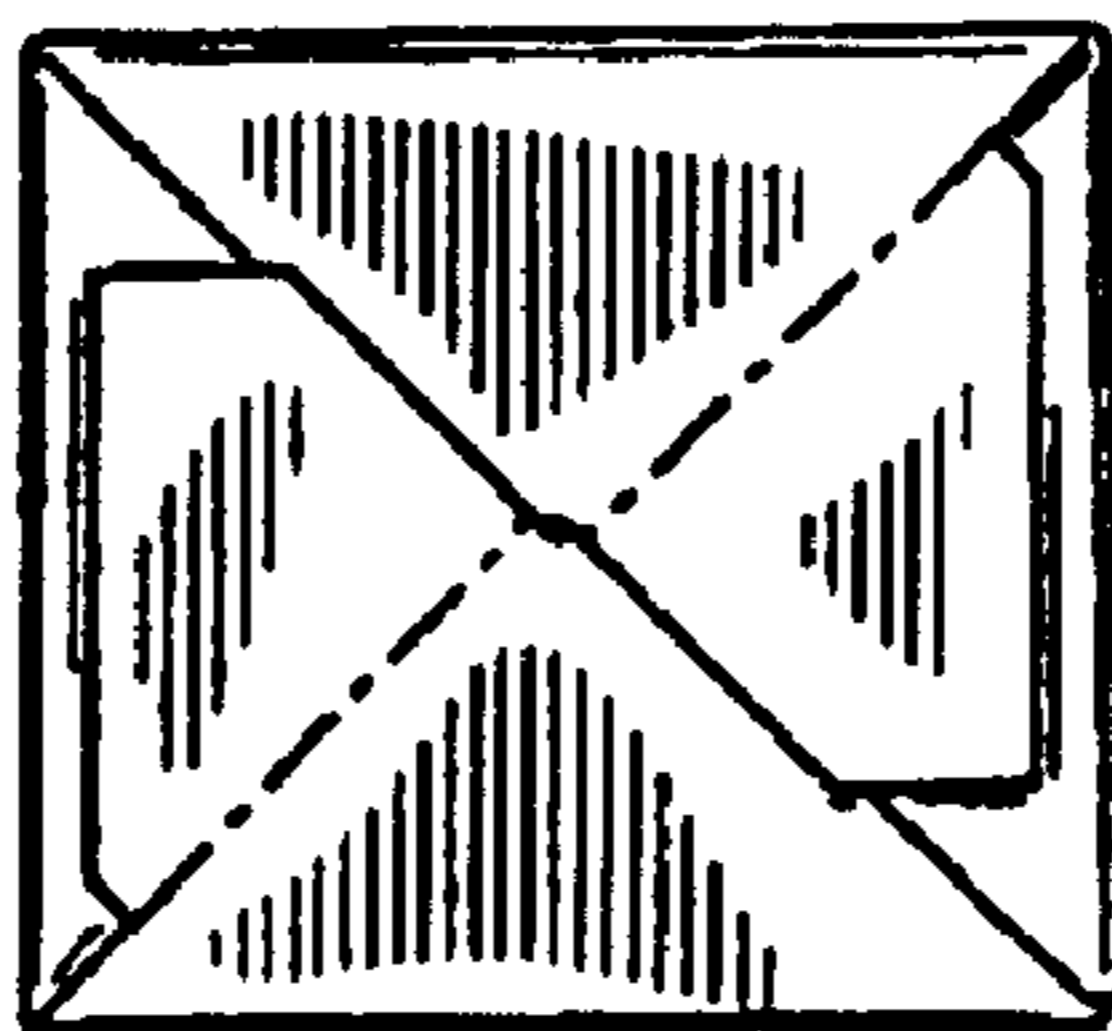

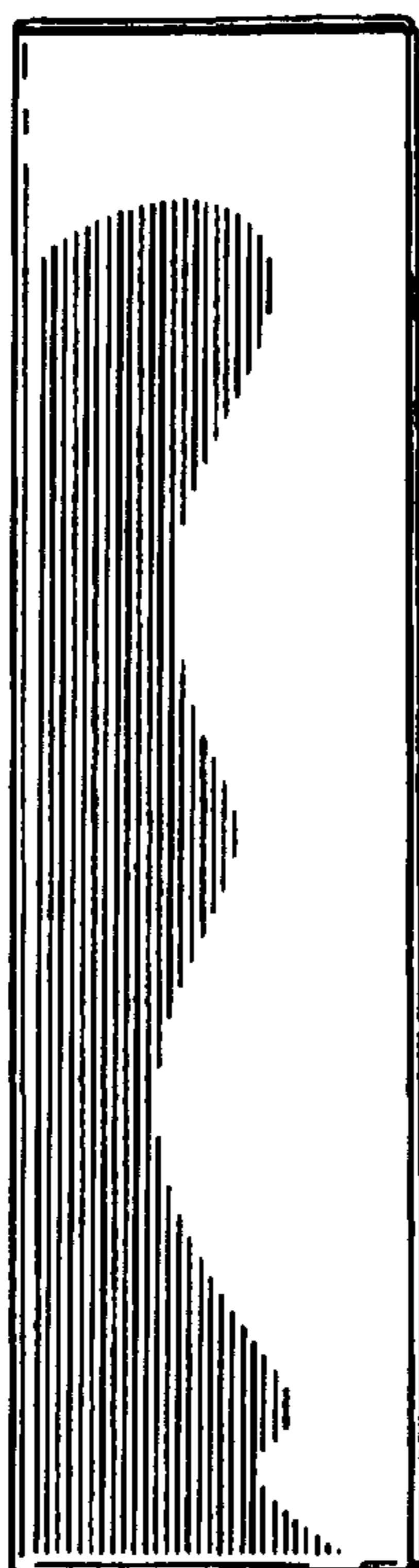

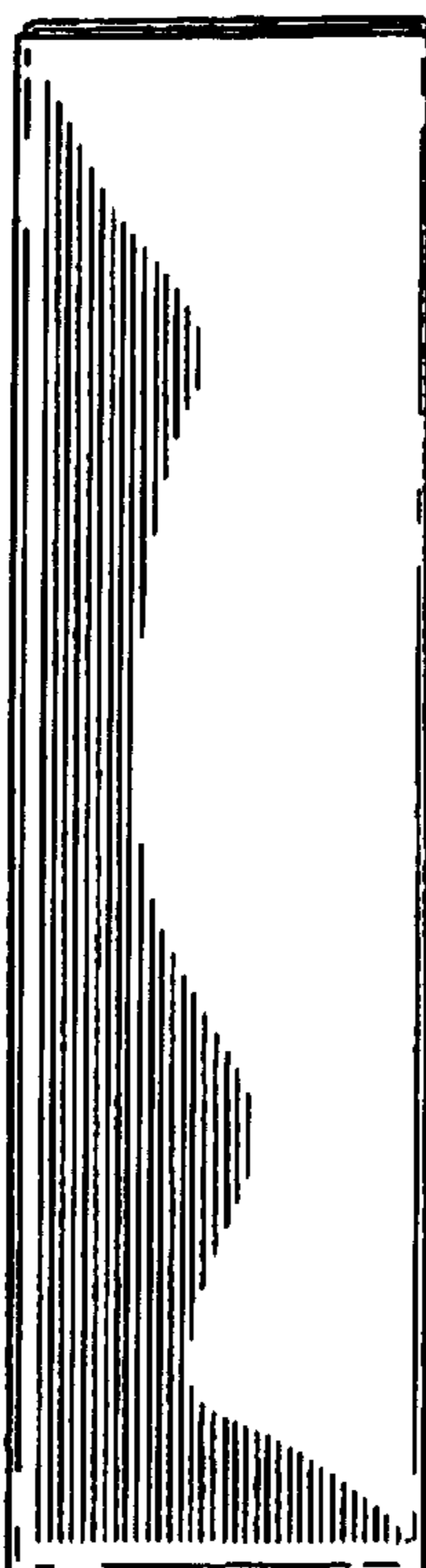
