The ornamental design for a aerosol container cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an aerosol container cap, showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 7 is a front elevation view thereof;

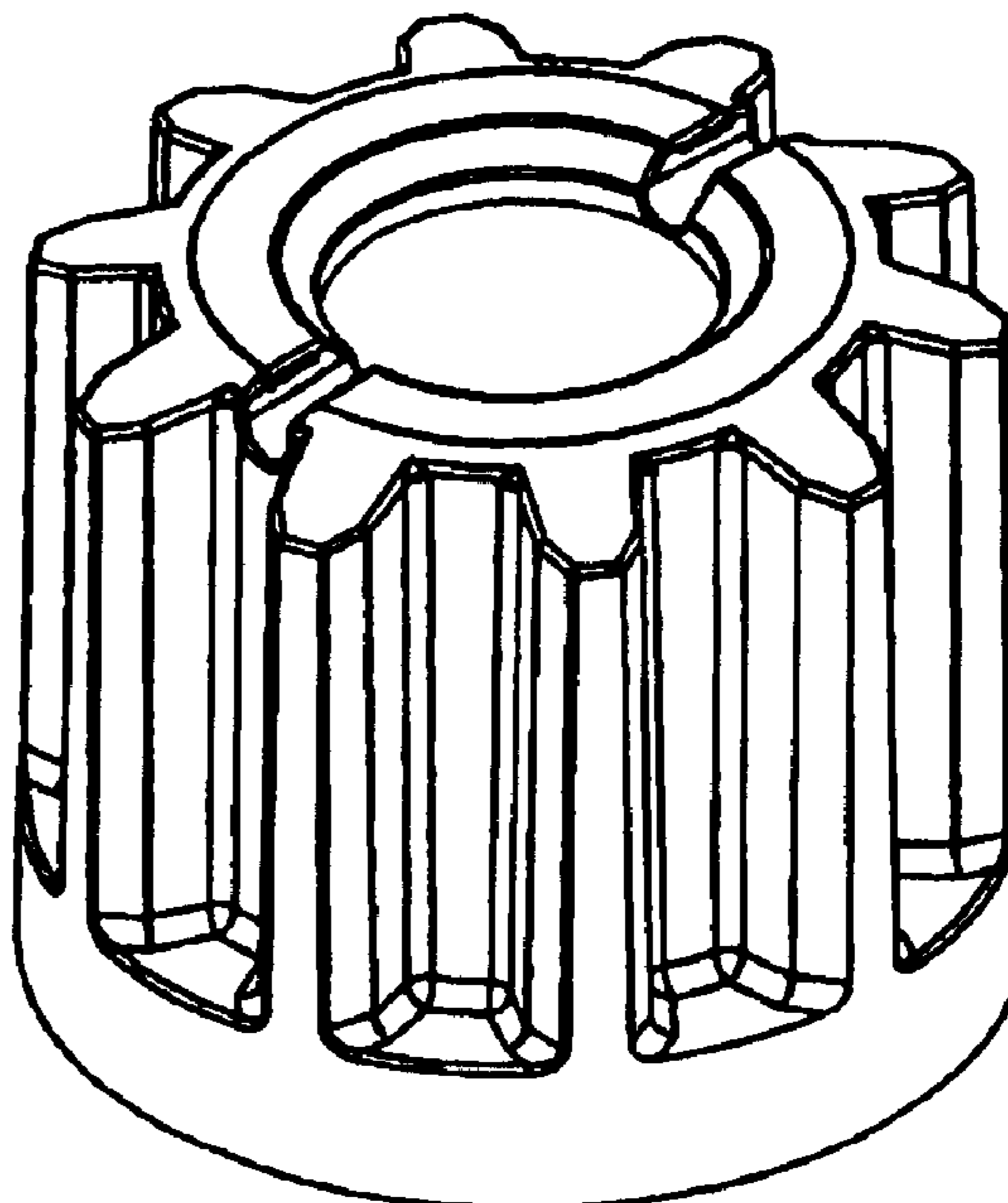
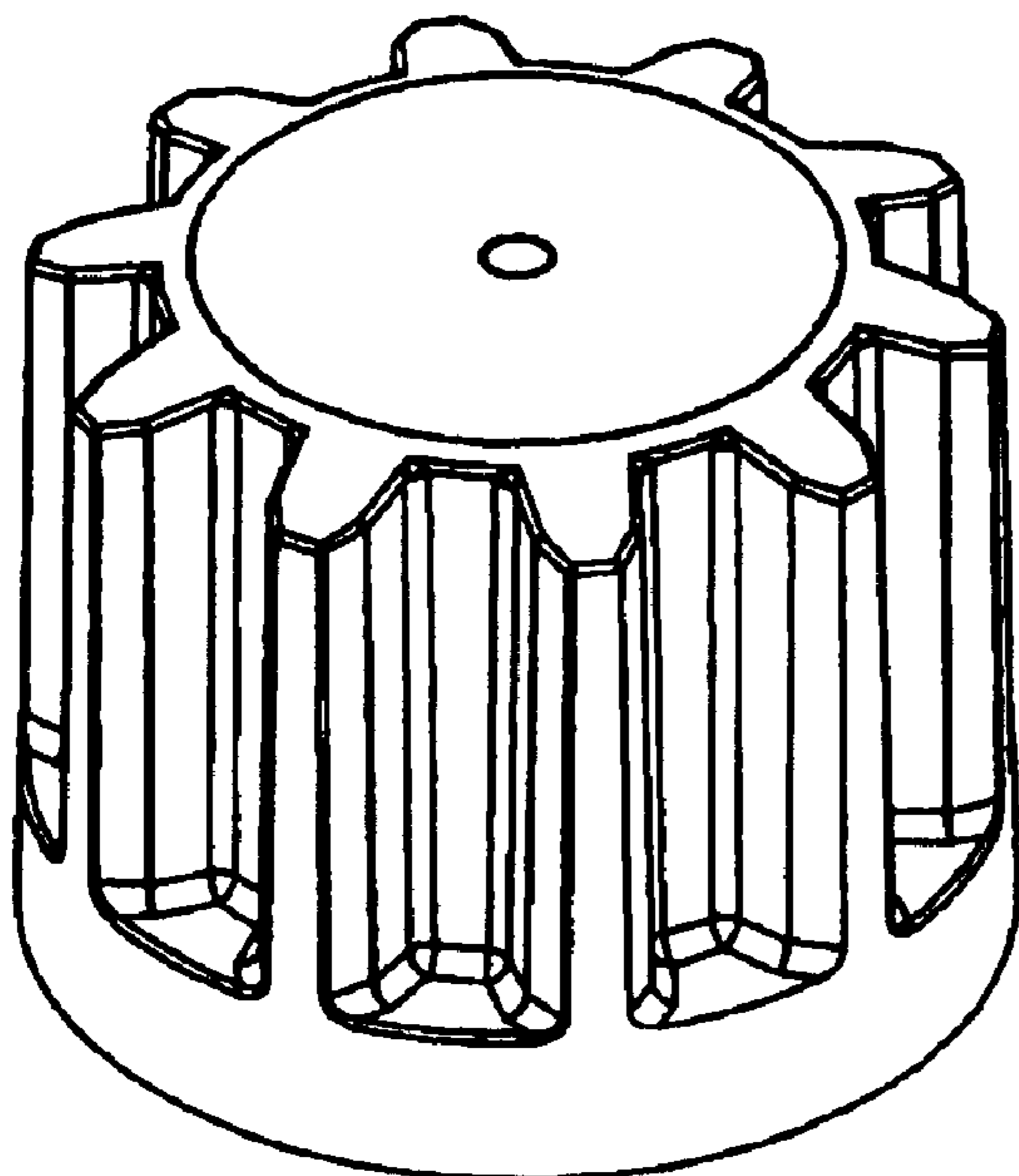
FIG. 8 is a right side elevation view thereof;

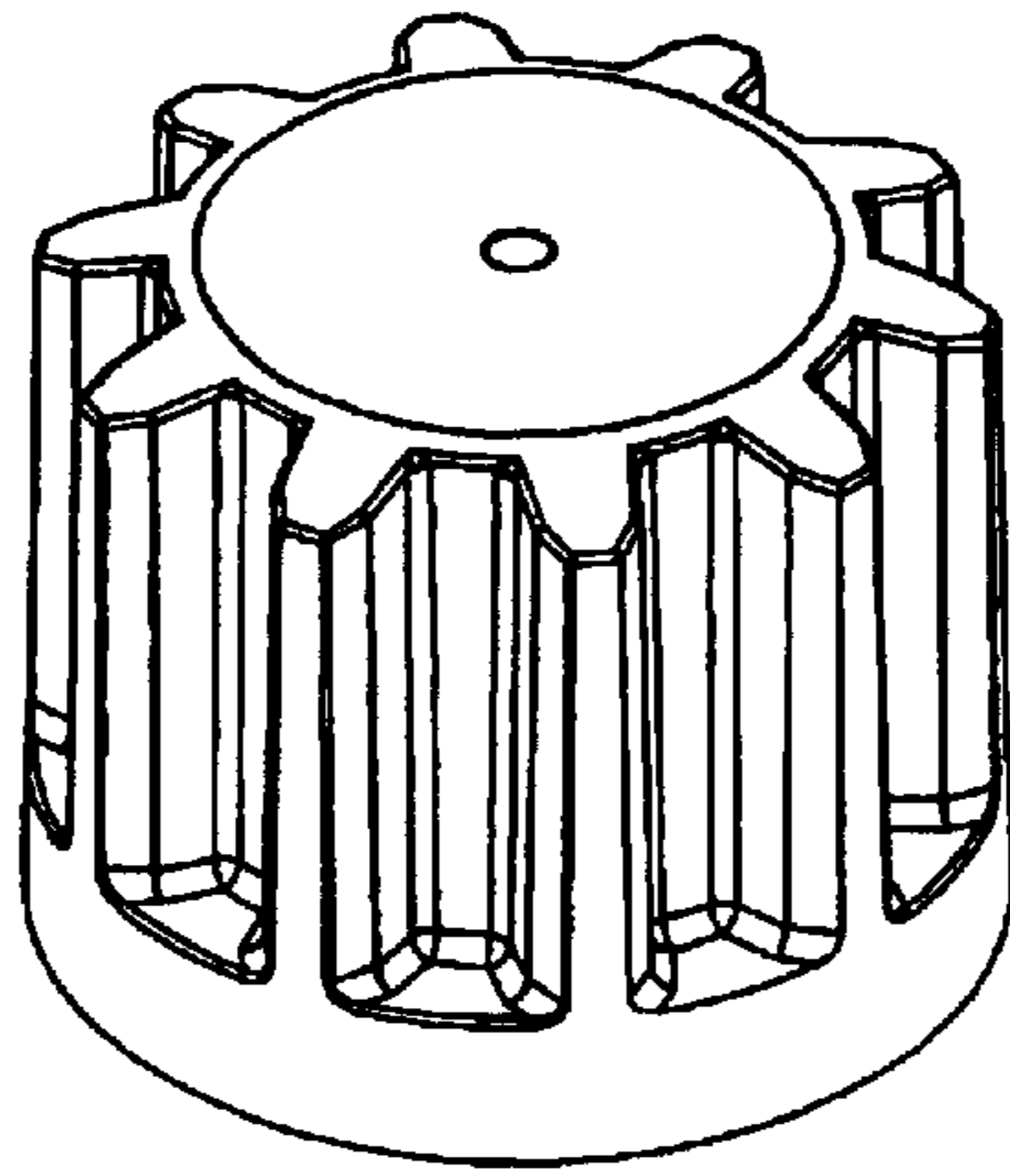

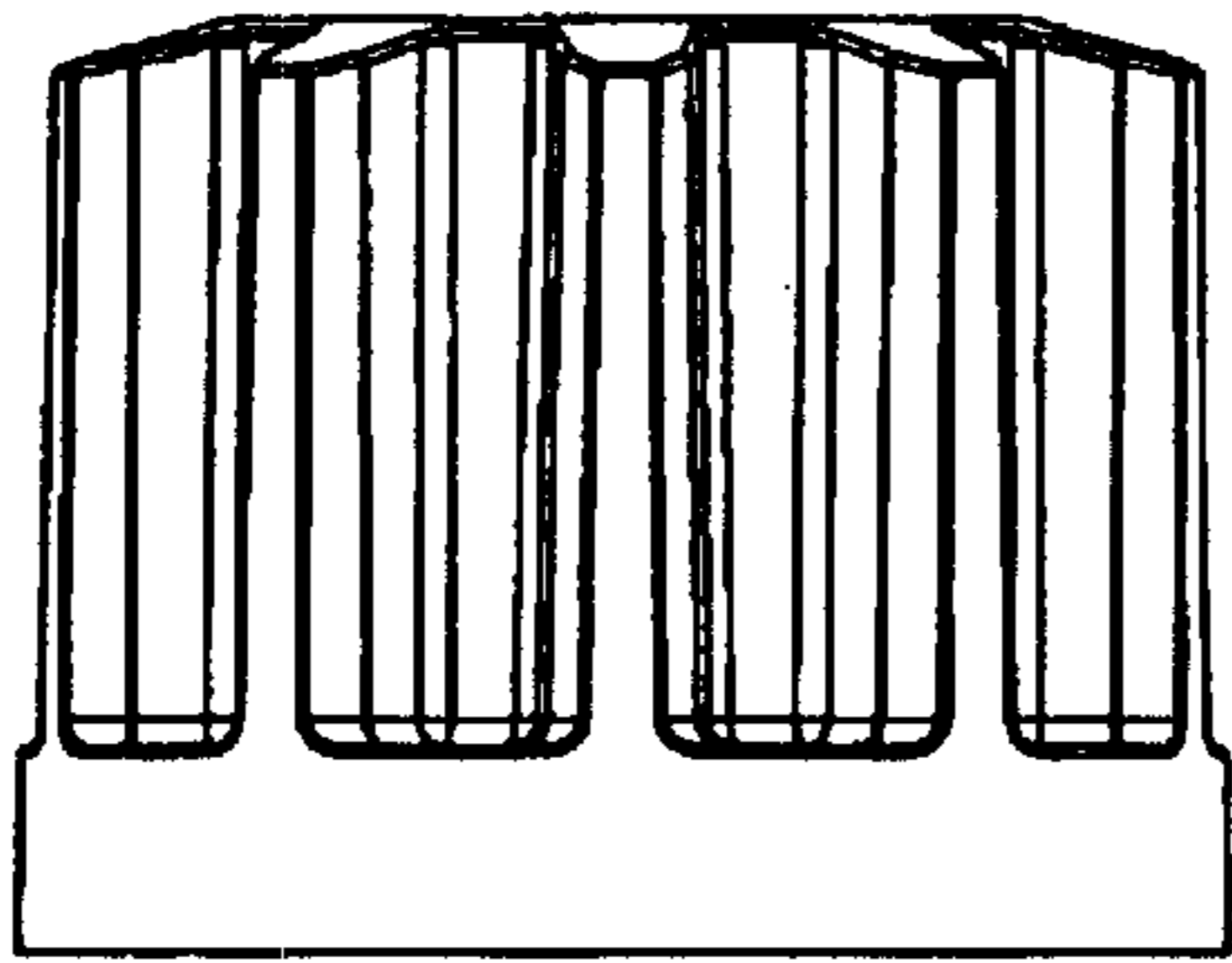

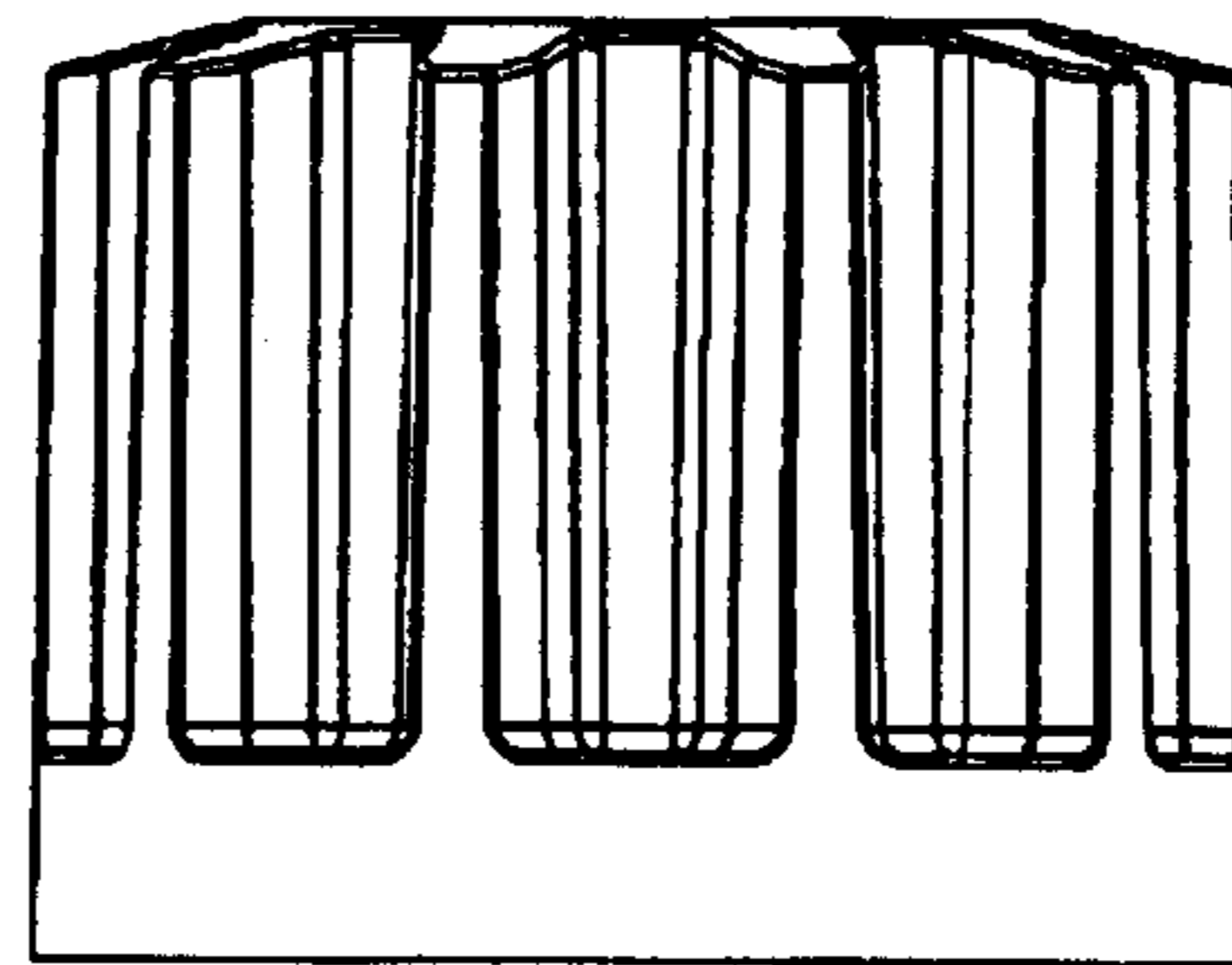

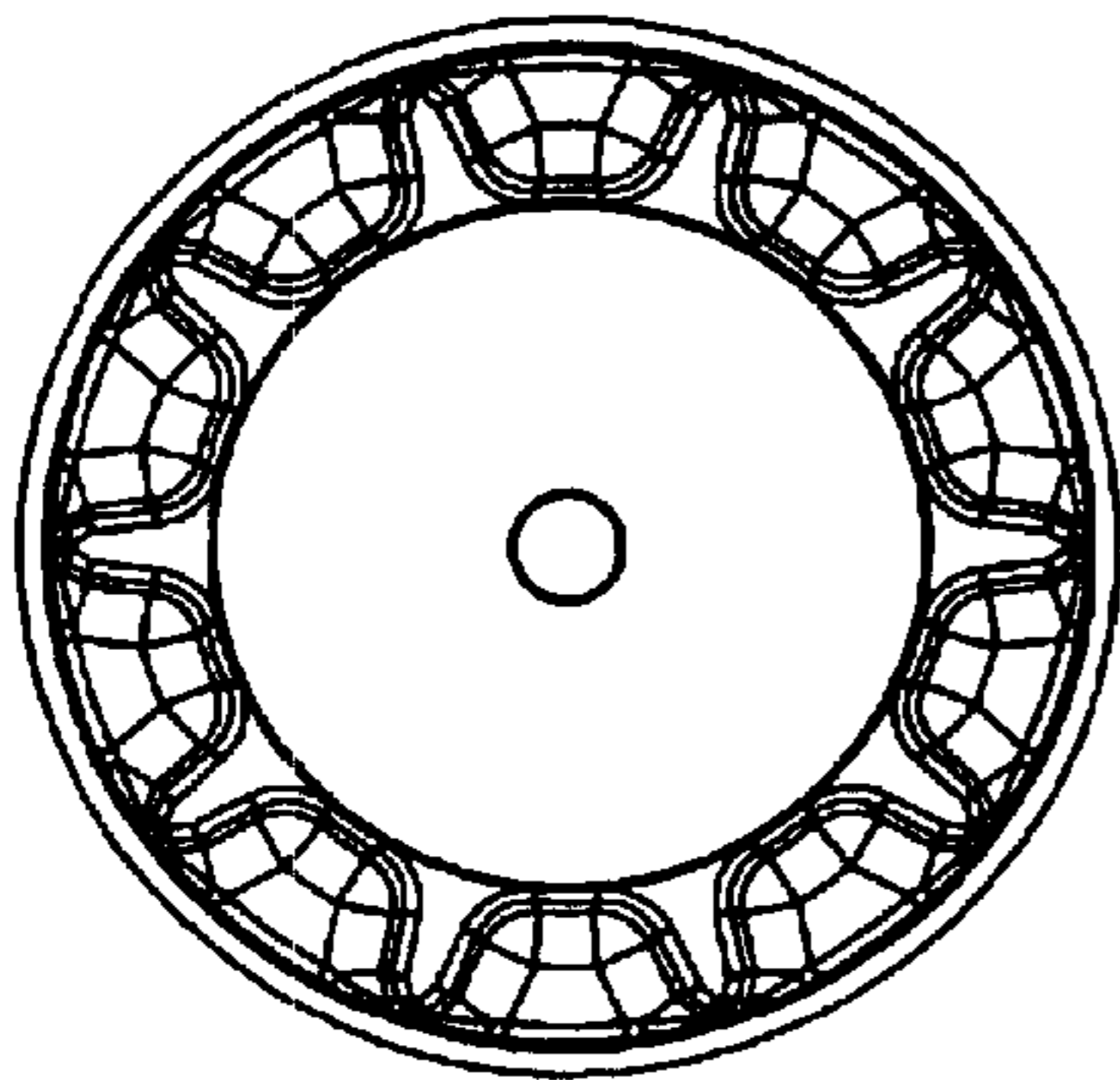

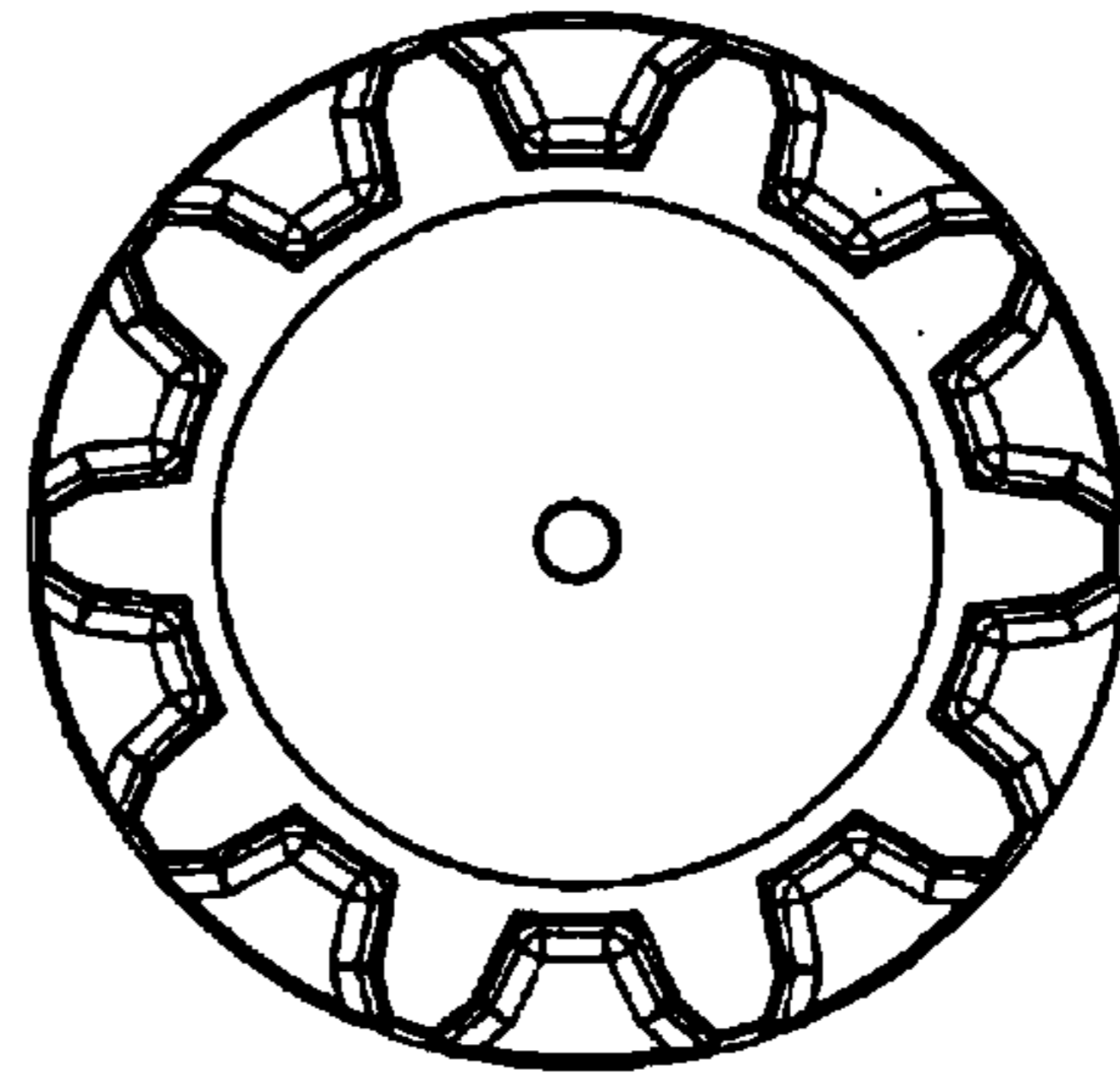

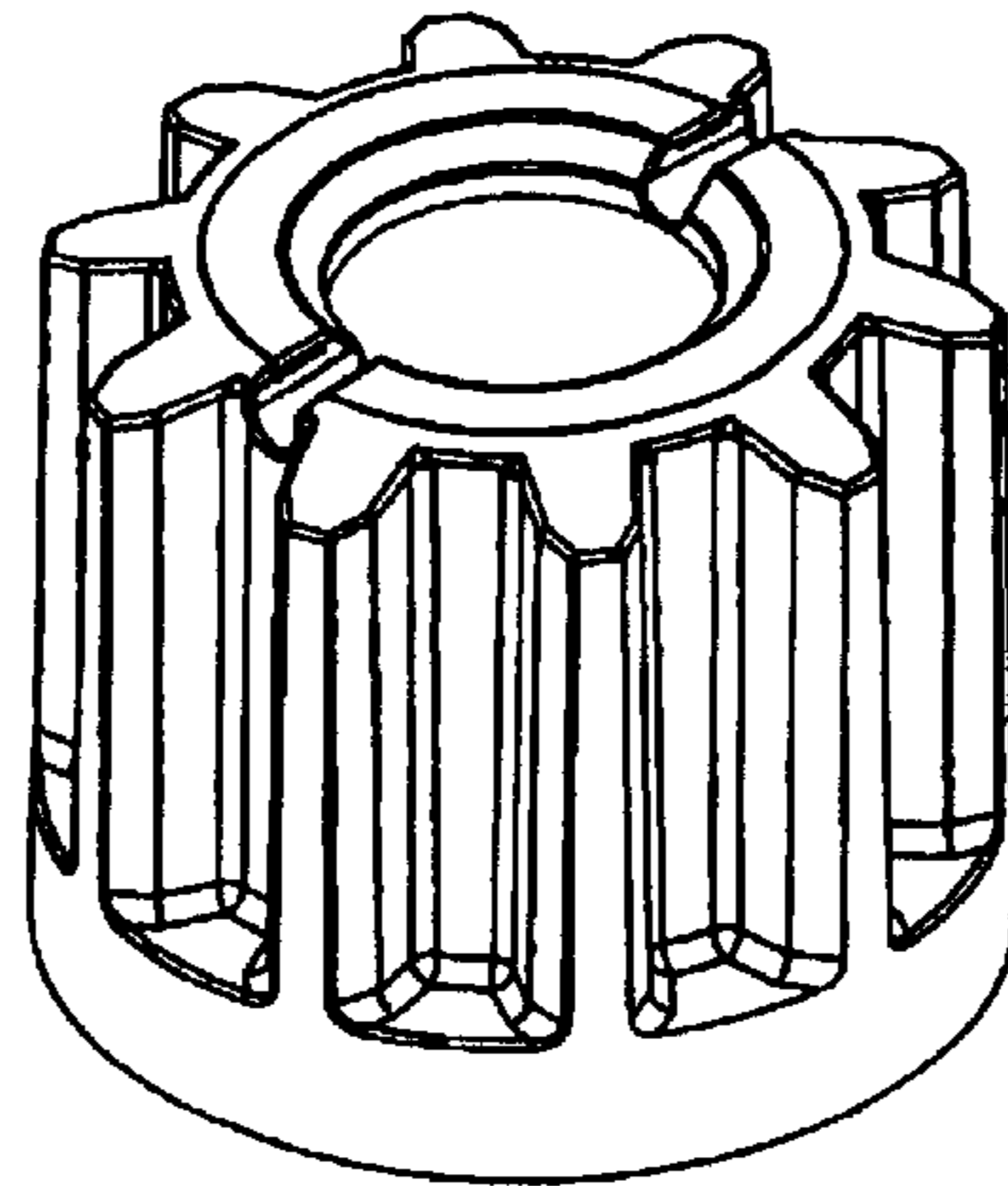

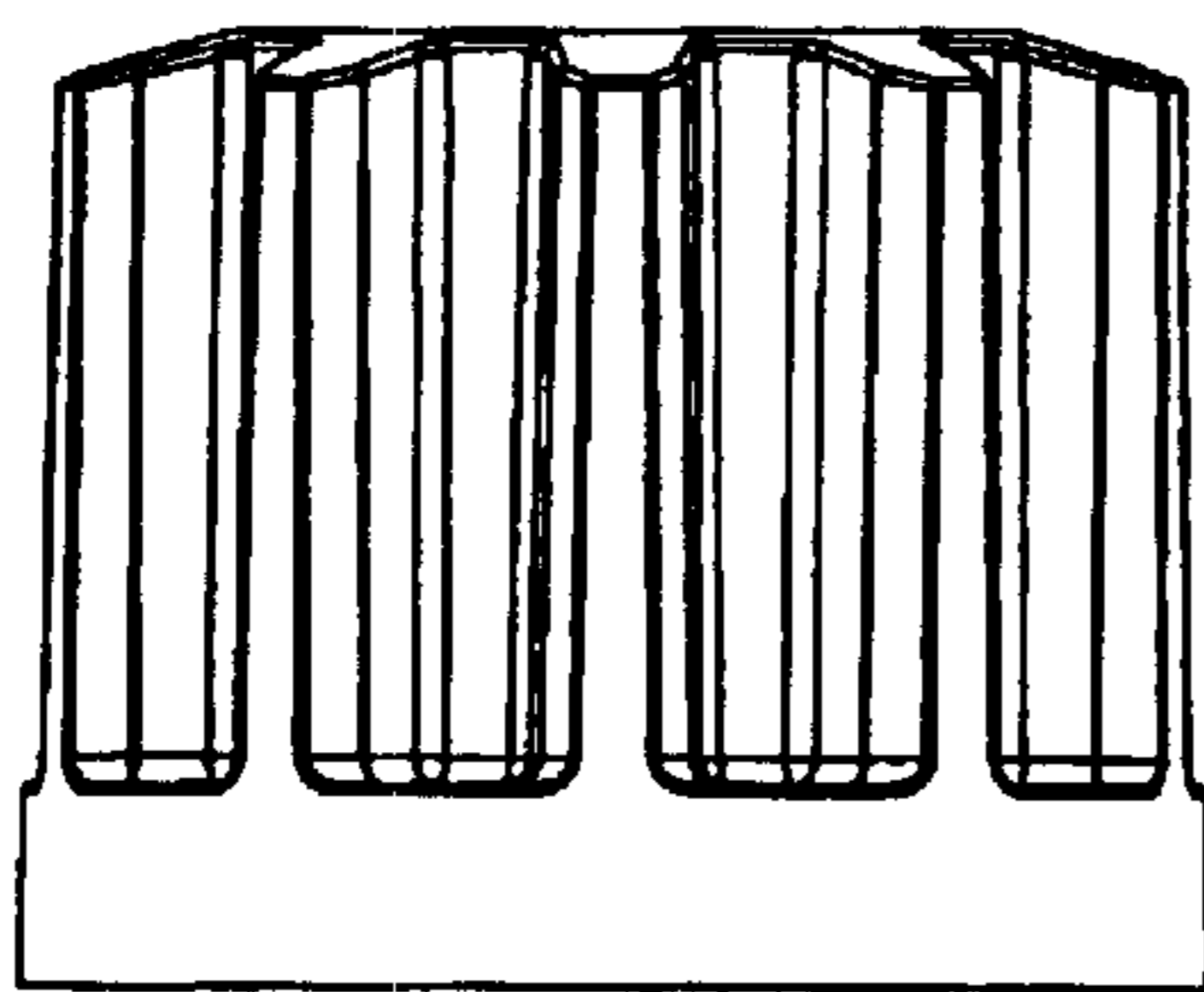

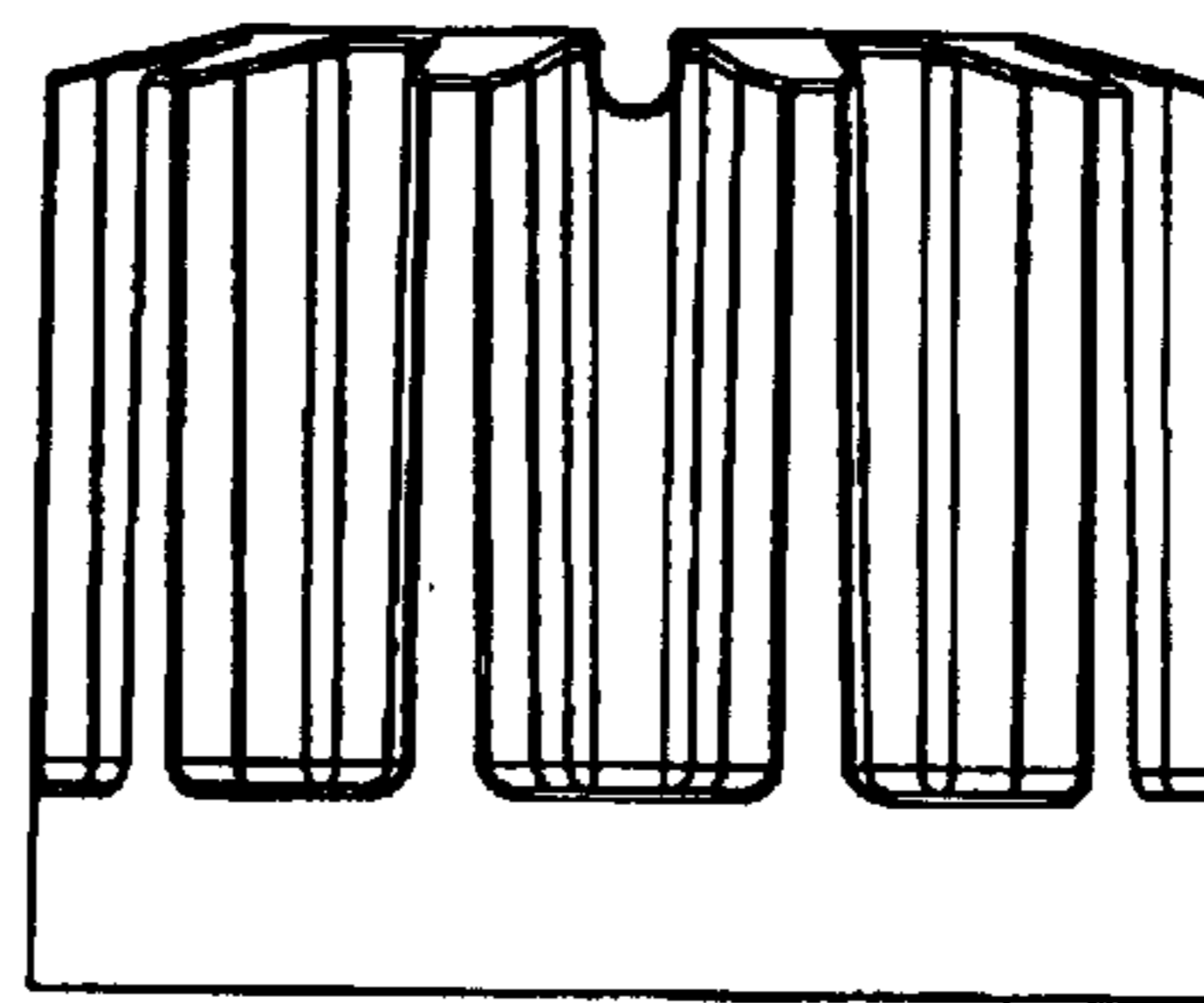

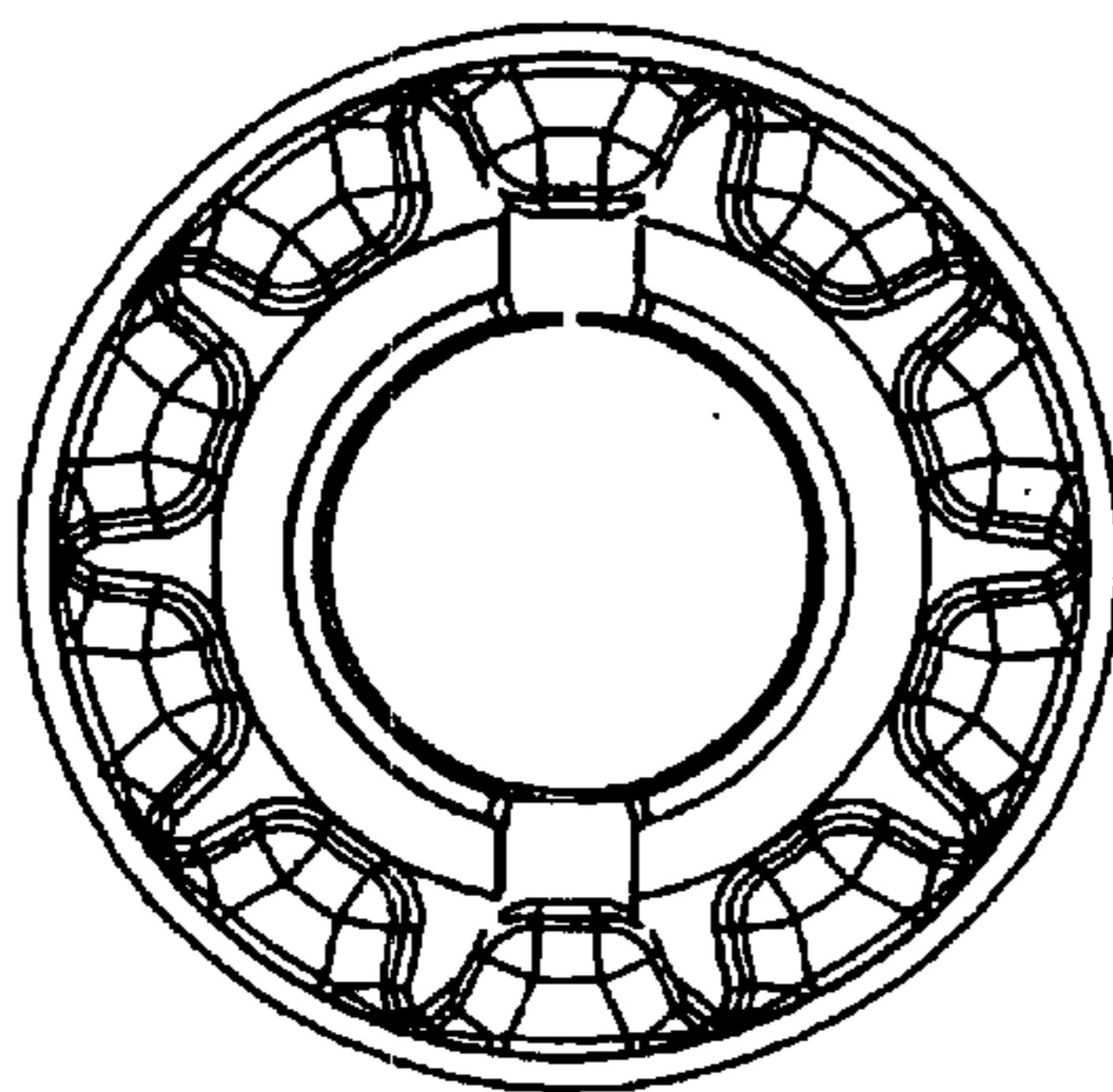

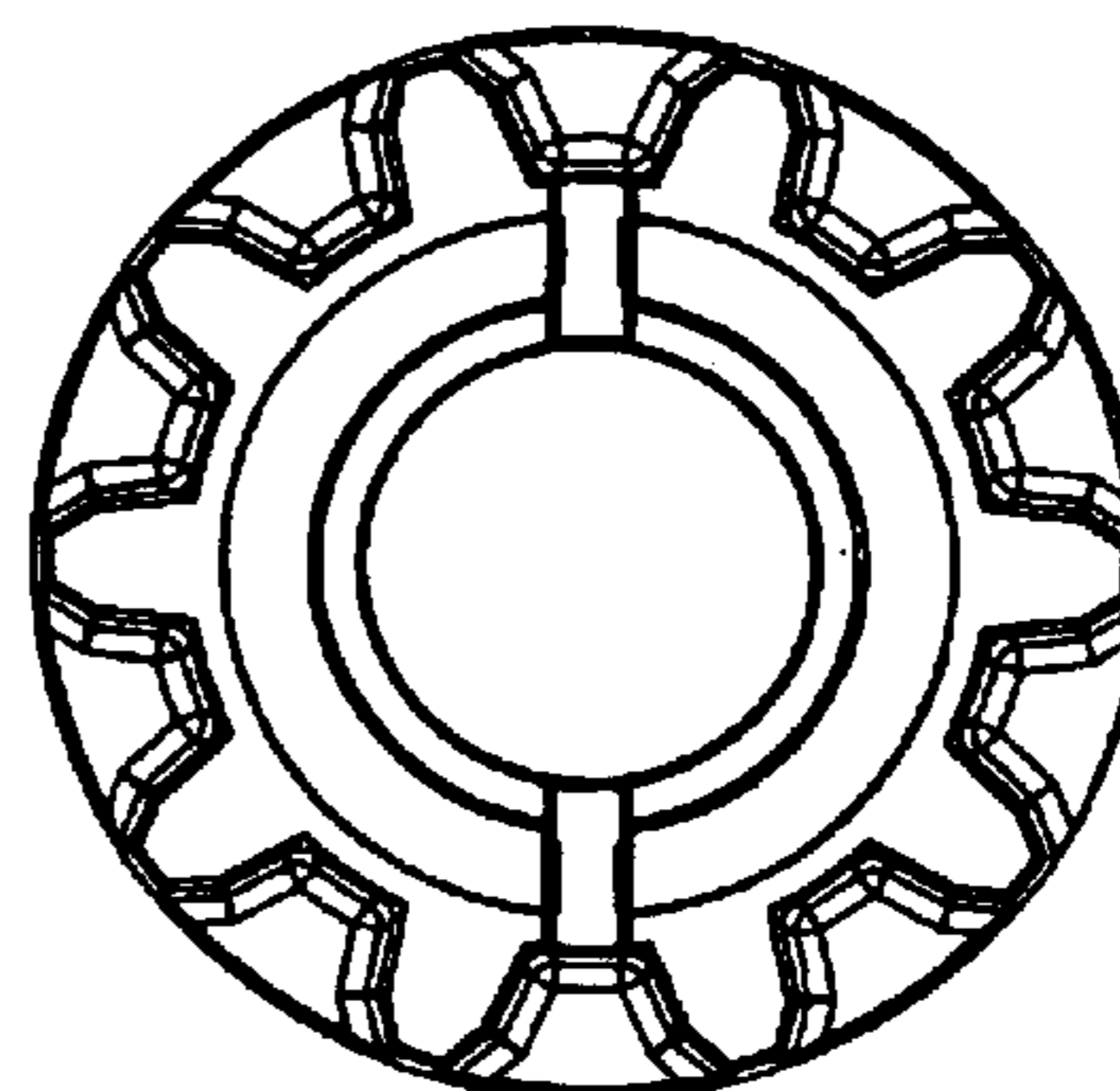
