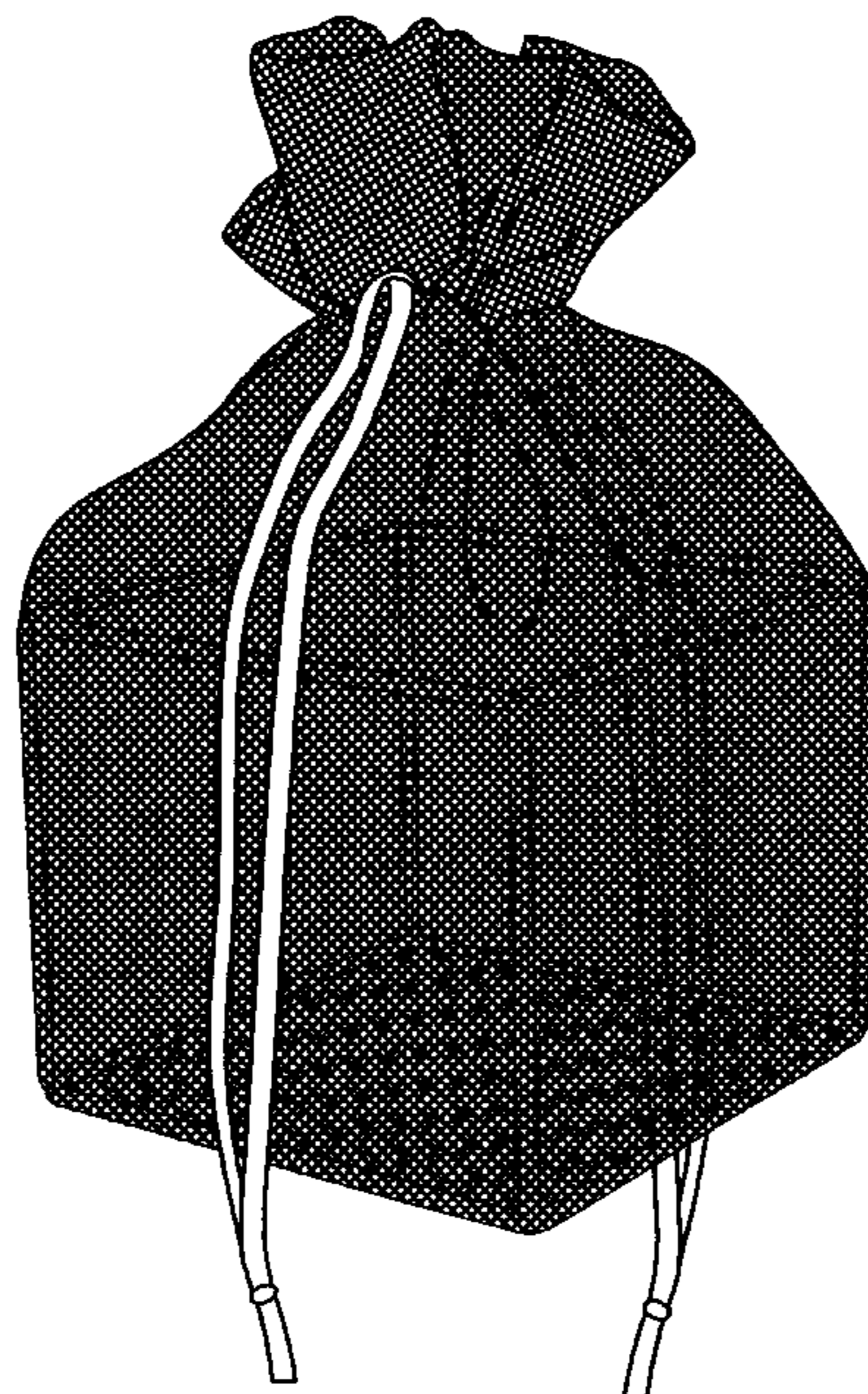
(57) **CLAIM**

The ornamental design for a decorative package with a mesh covering, as shown and described.

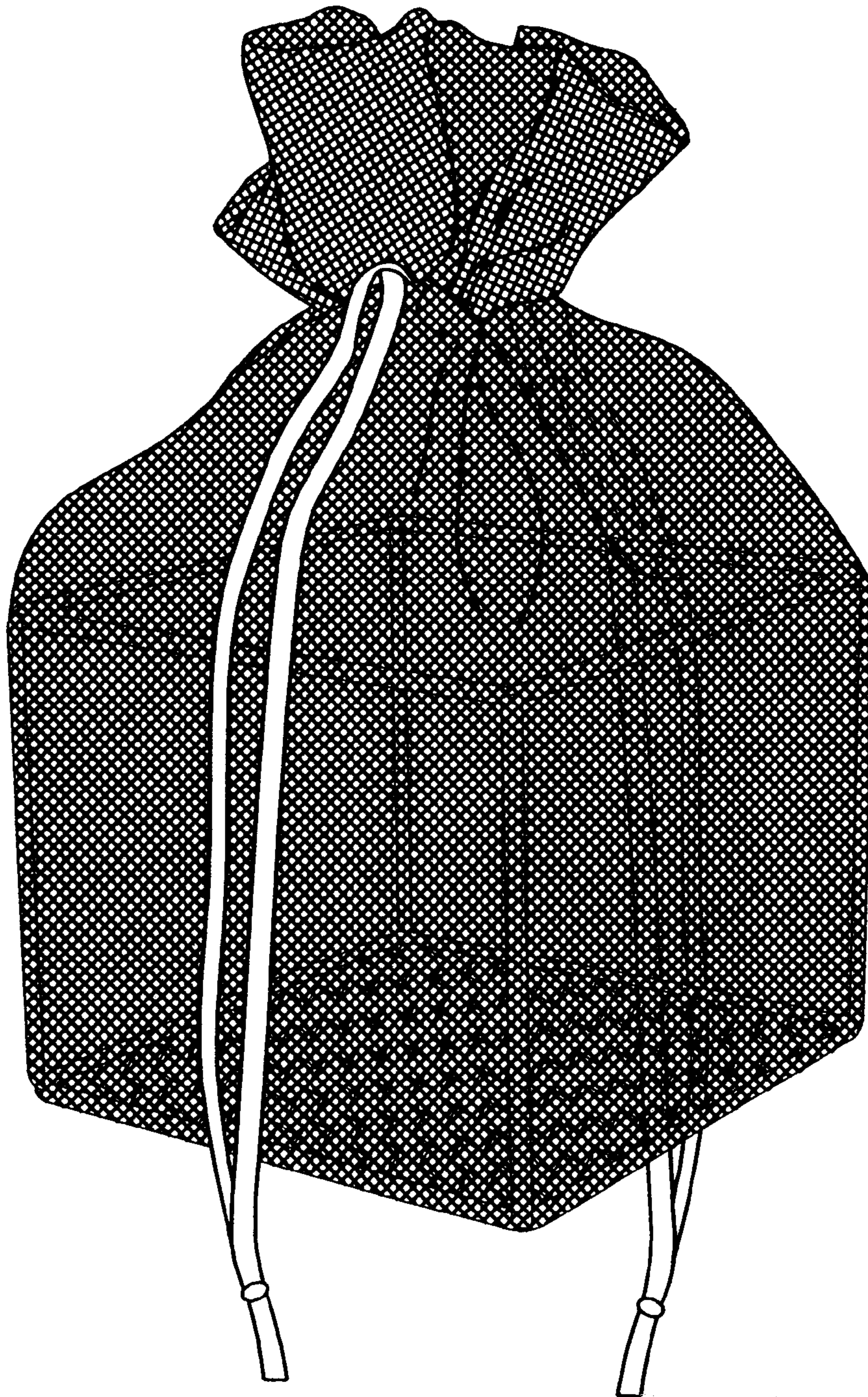
**DESCRIPTION**

FIG. 1 is a top perspective view of decorative package with a mesh covering embodying my new design;  
FIG. 2 is a bottom perspective view of the decorative package with a mesh covering embodying my new design;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a front elevational view thereof; and the rear elevational view being a mirror image thereof; and,

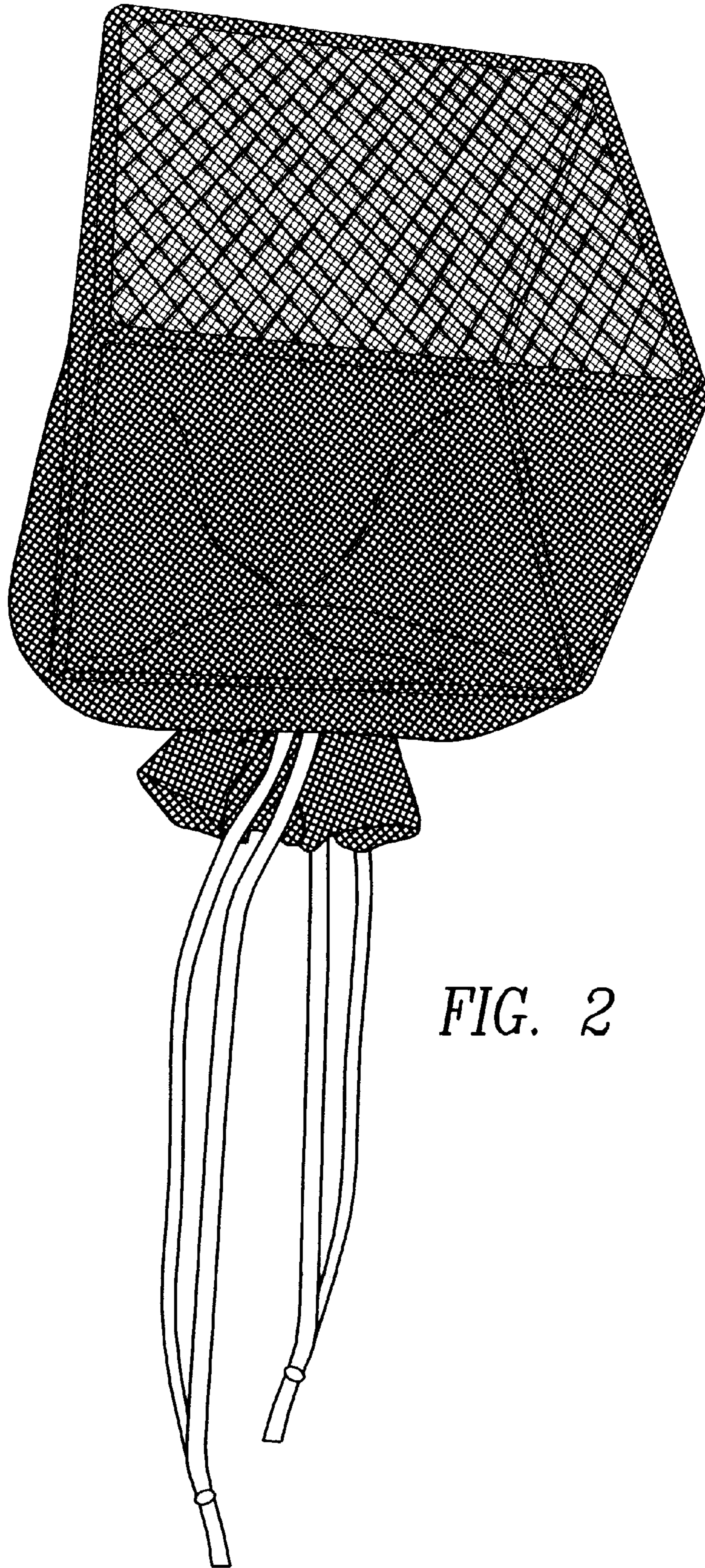






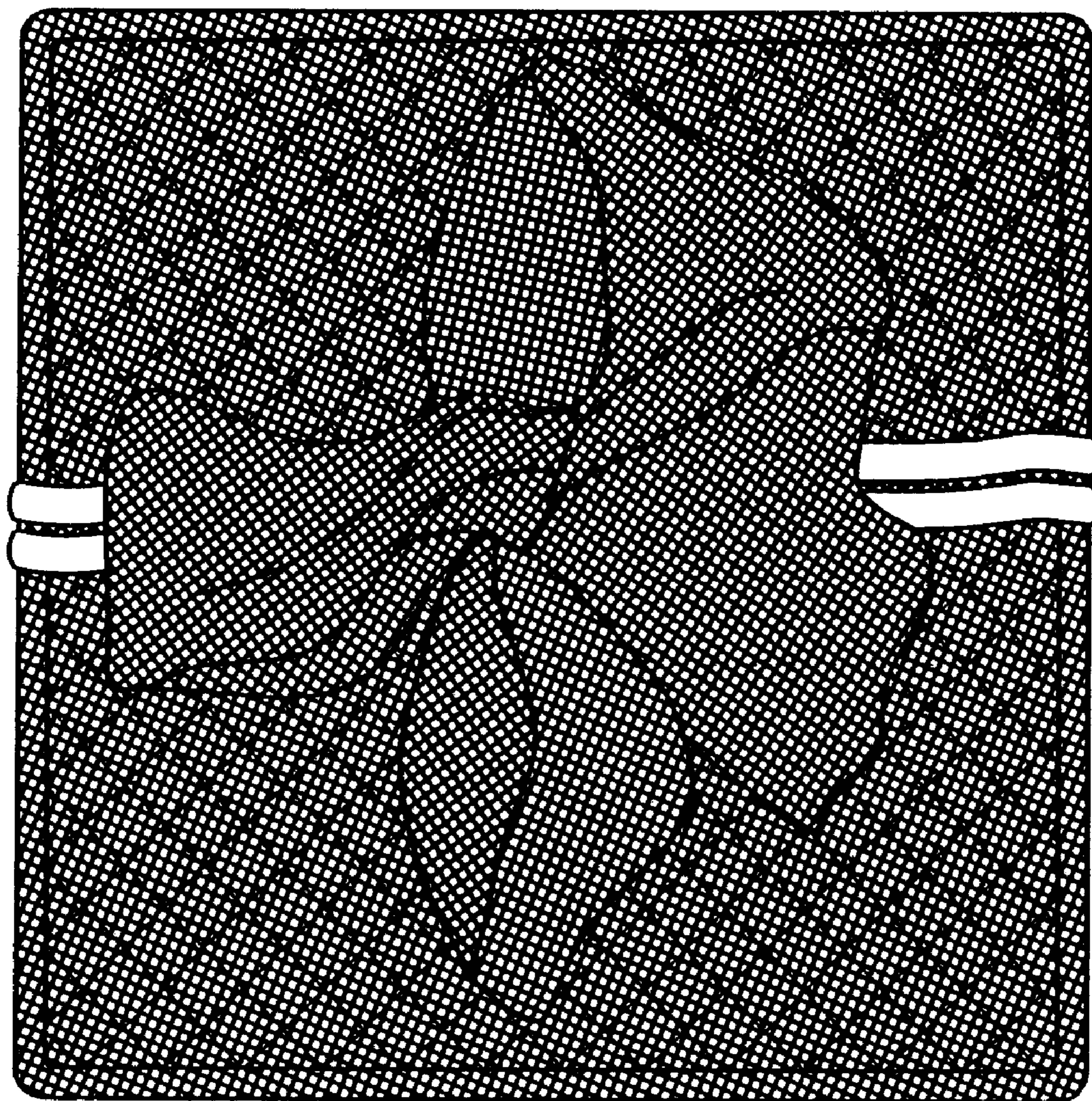

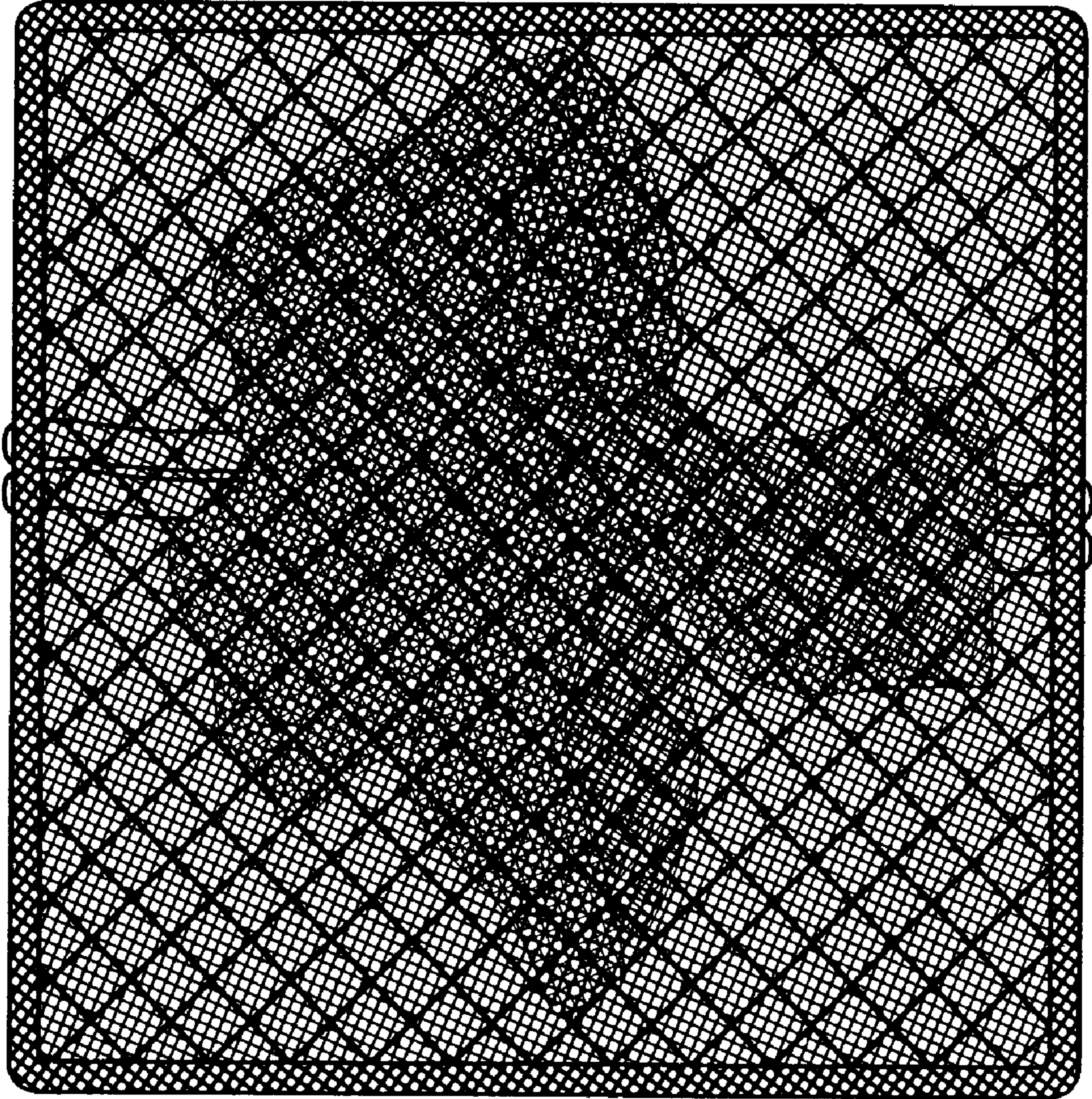

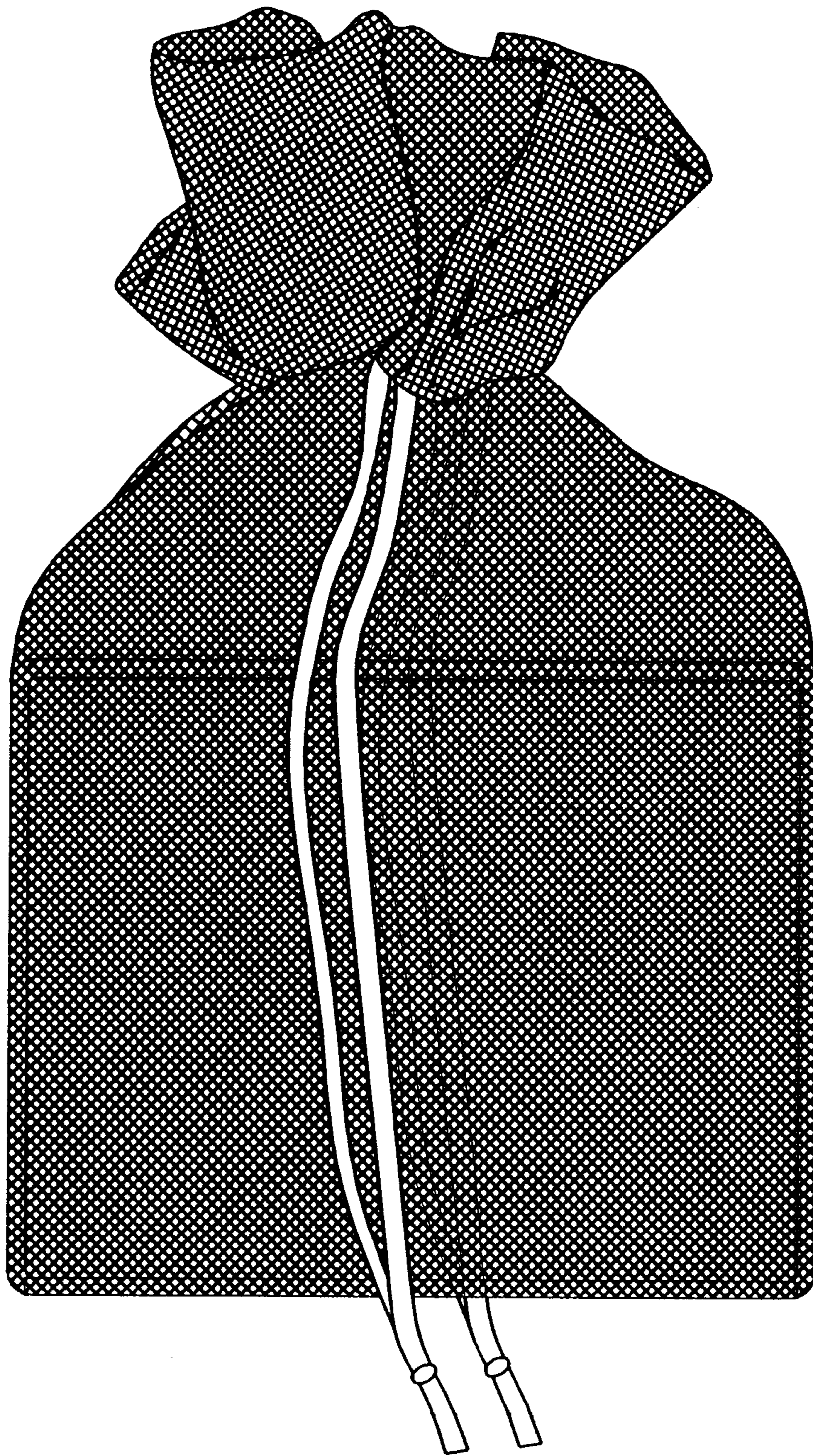

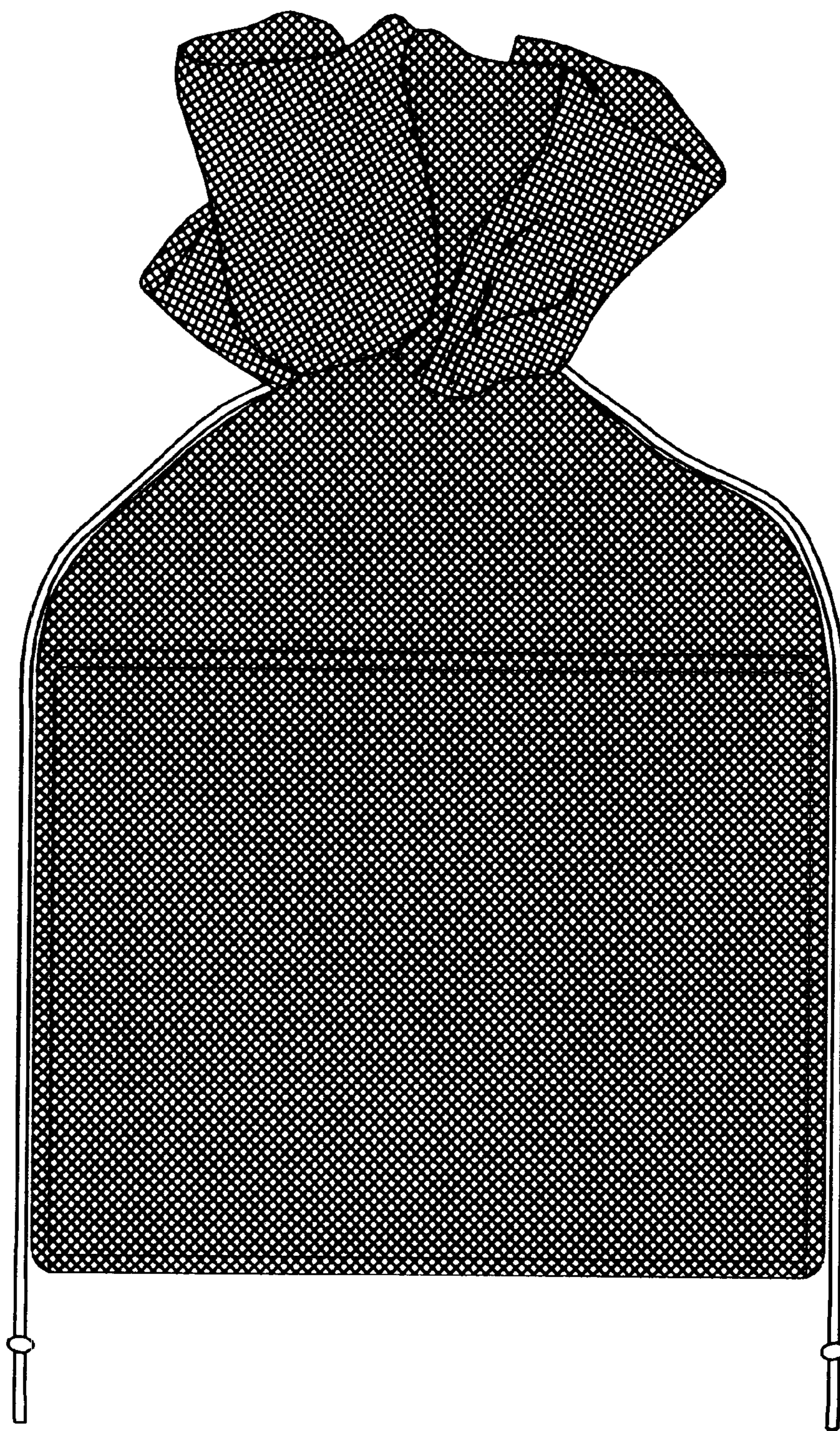
