FIG. 1 is an elevated front view of the female hog head figurine;

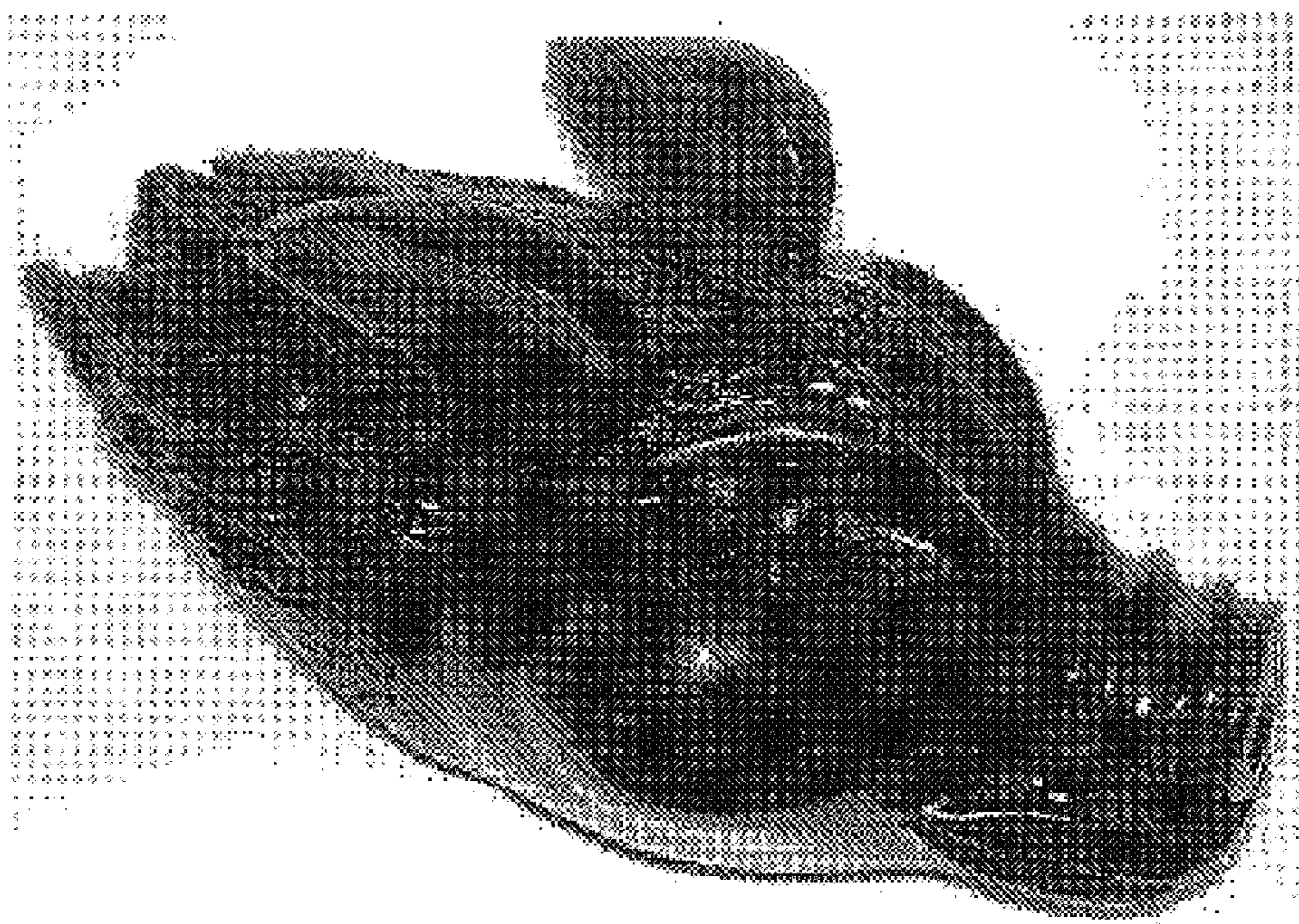
FIG. 2 is an elevated rear view of the female hog head figurine;

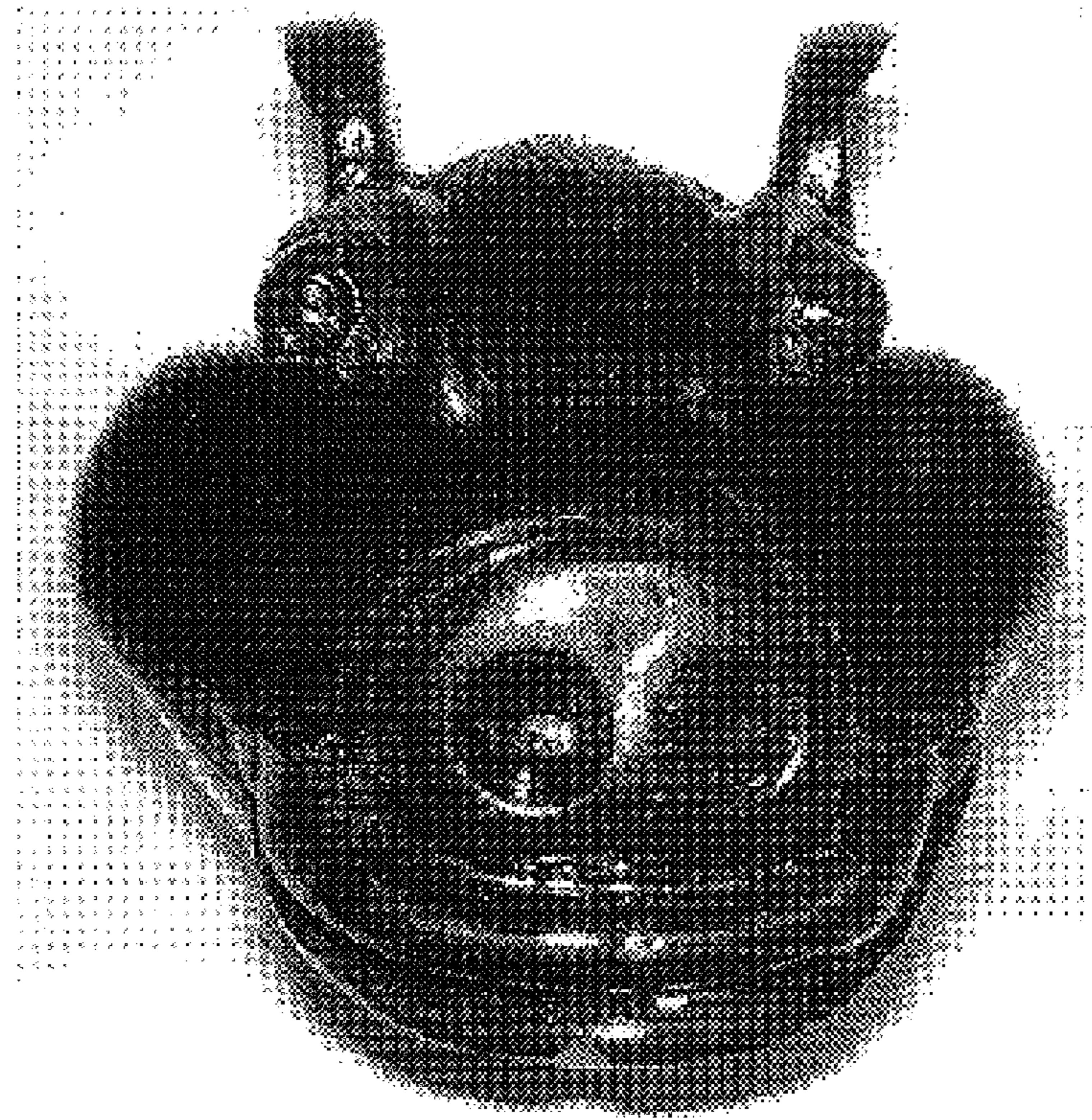

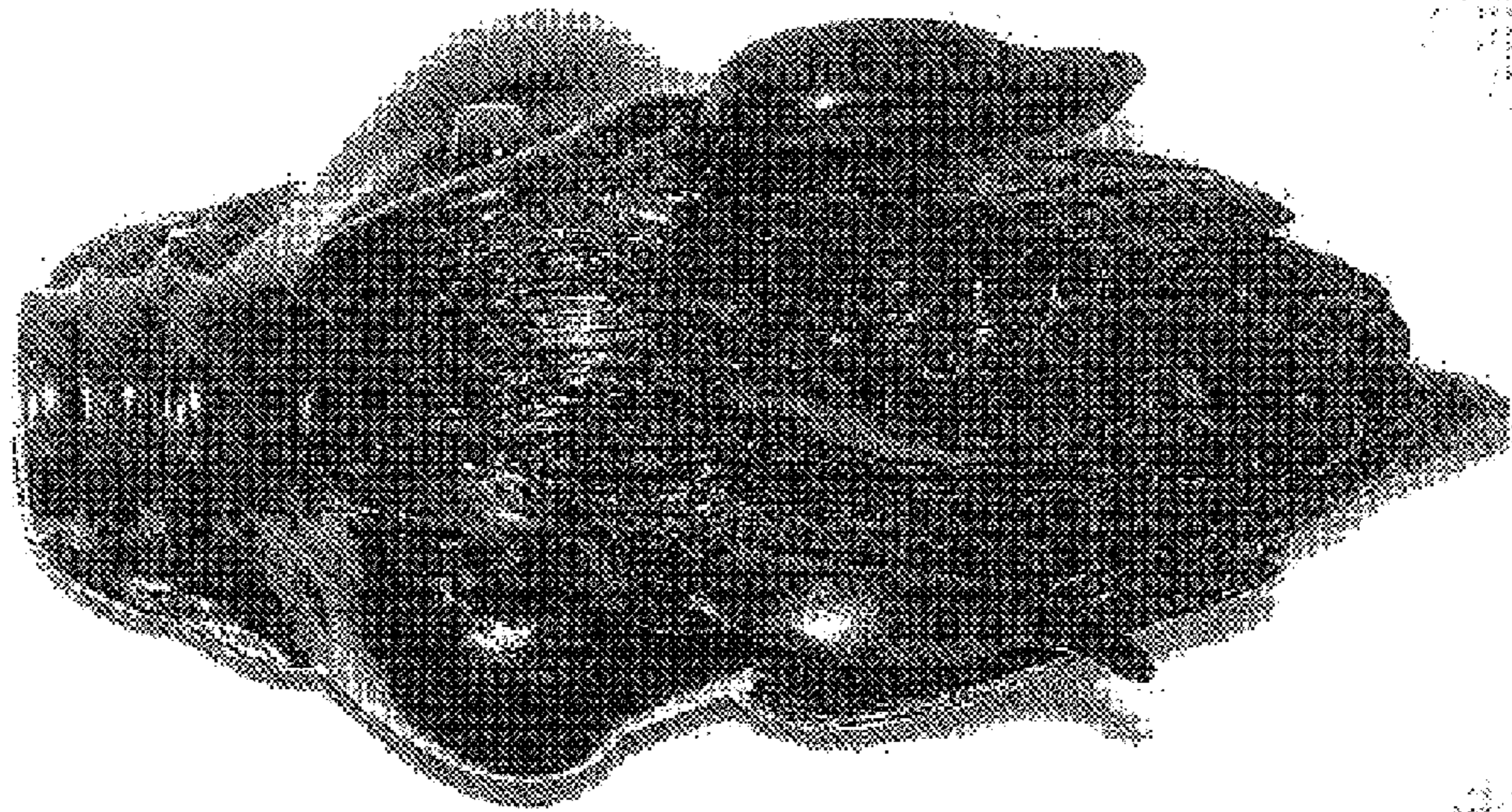

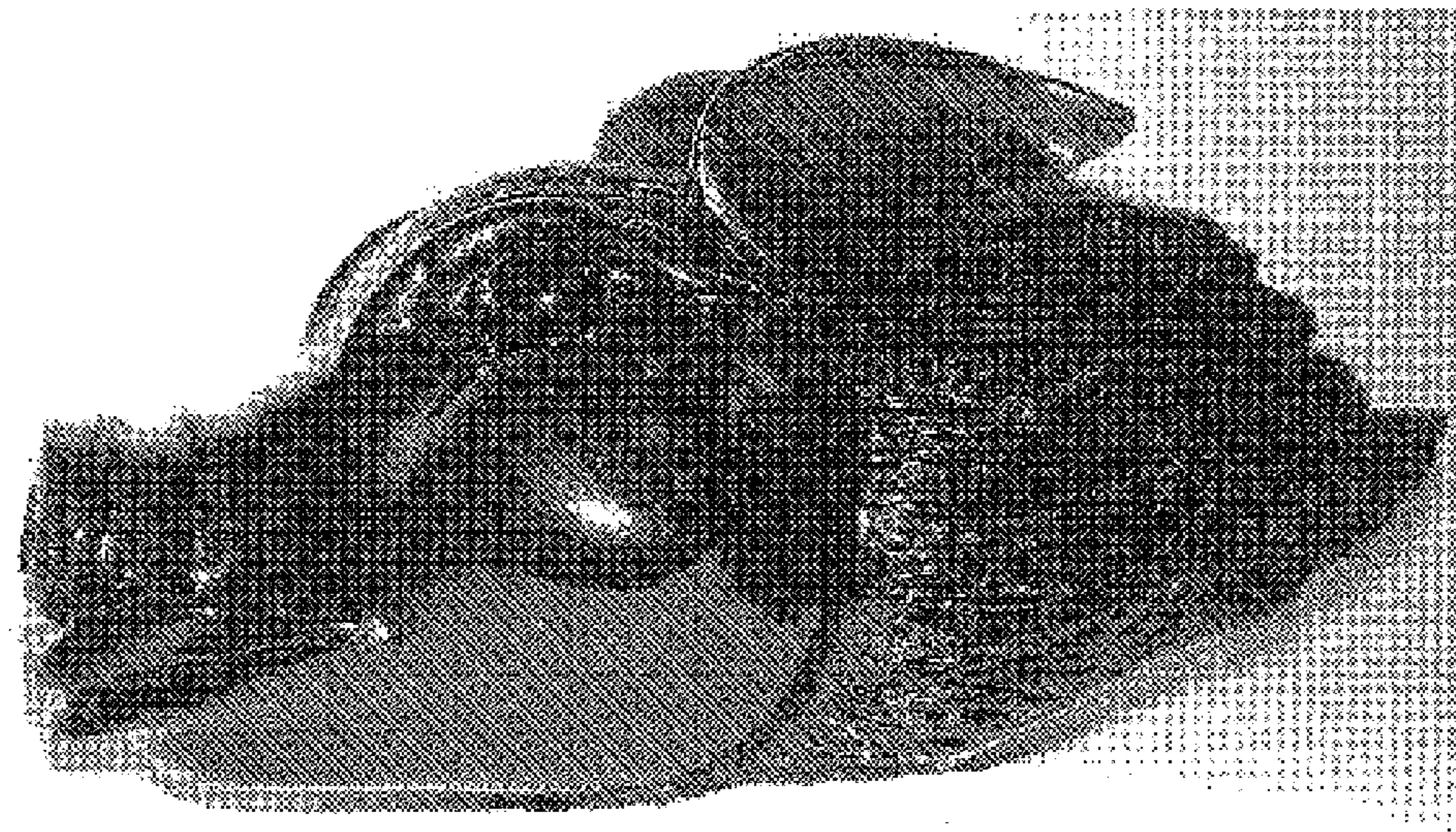

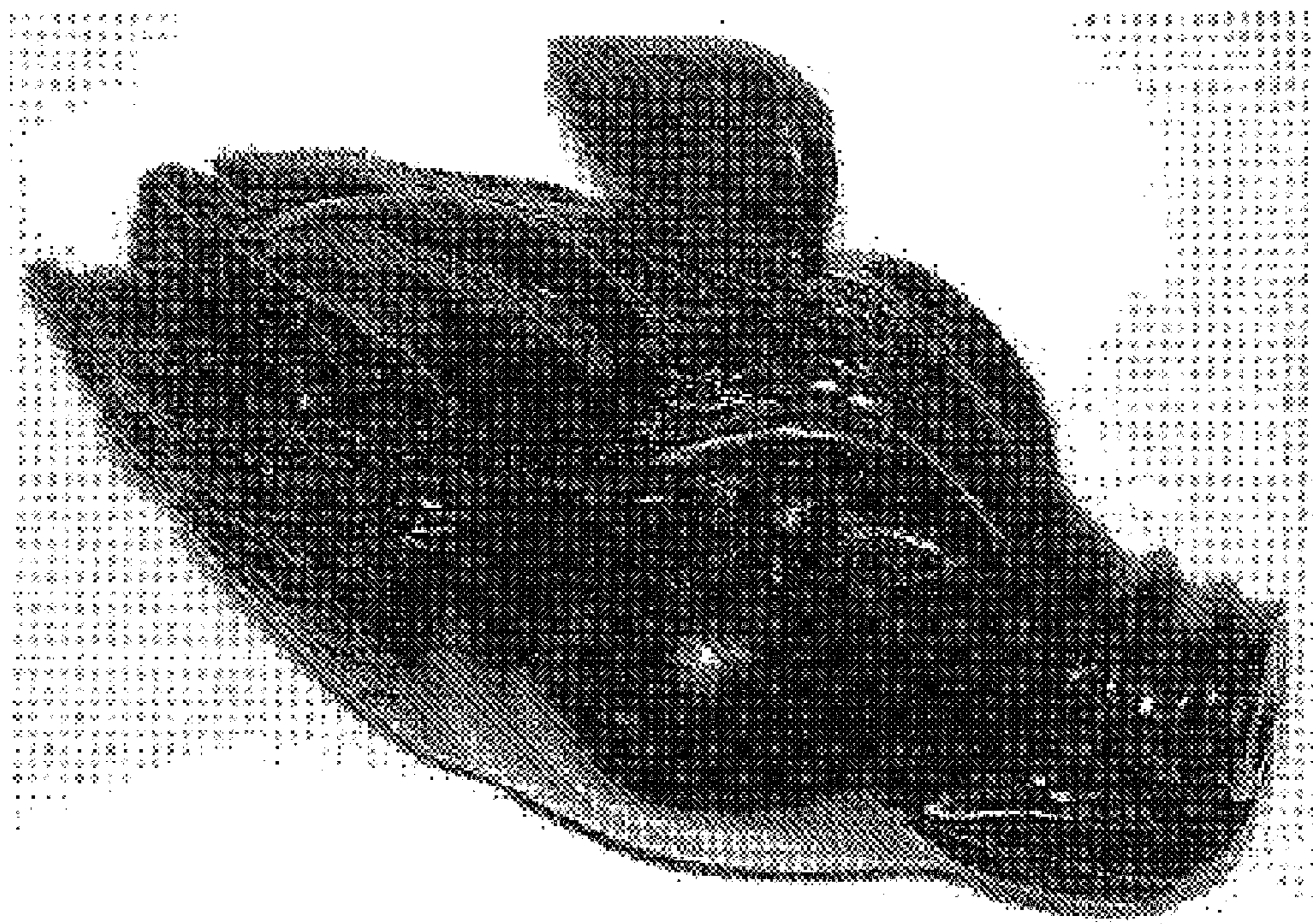
