(57) **CLAIM**

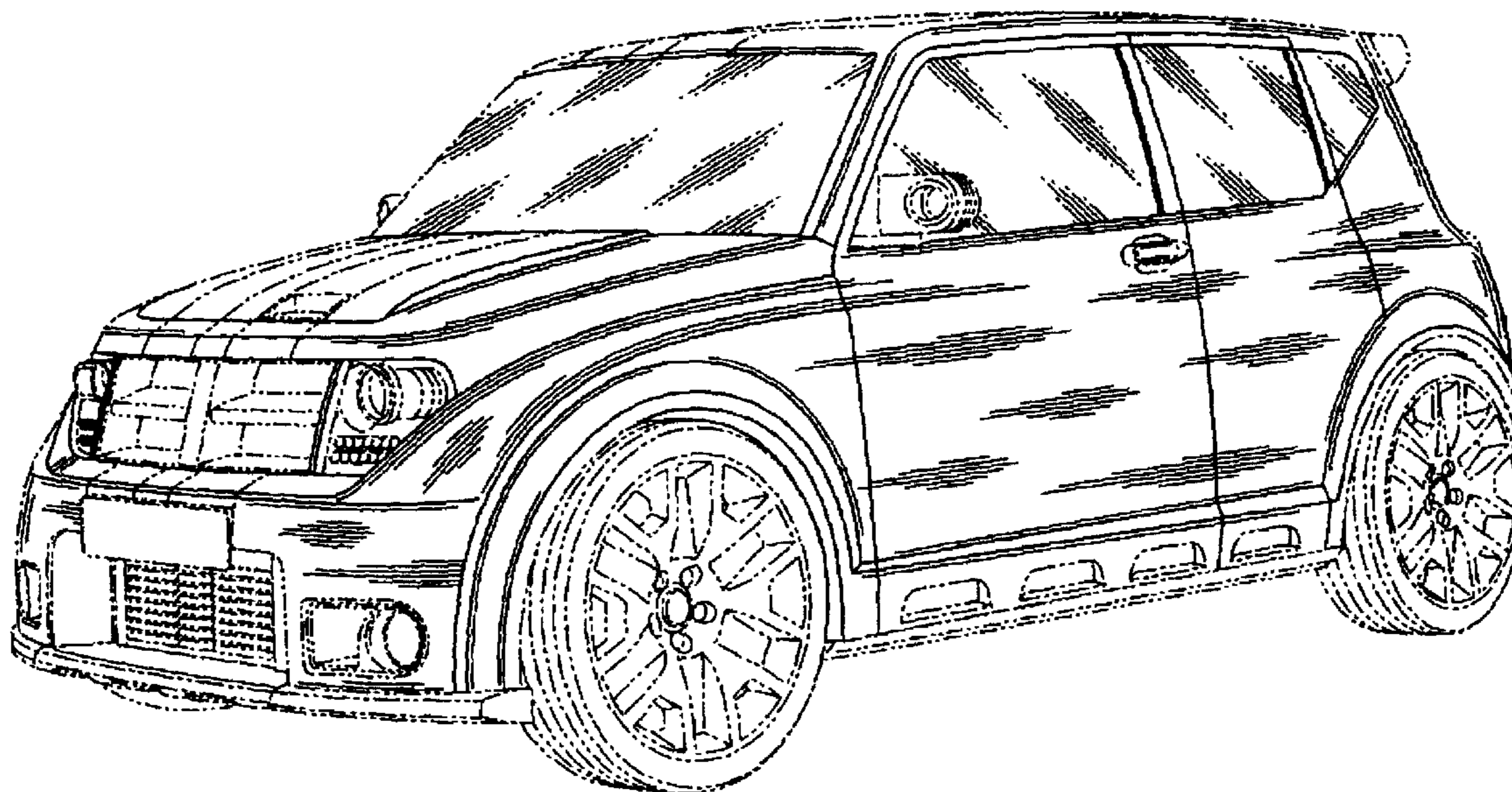
The ornamental design for an automobile body, as shown

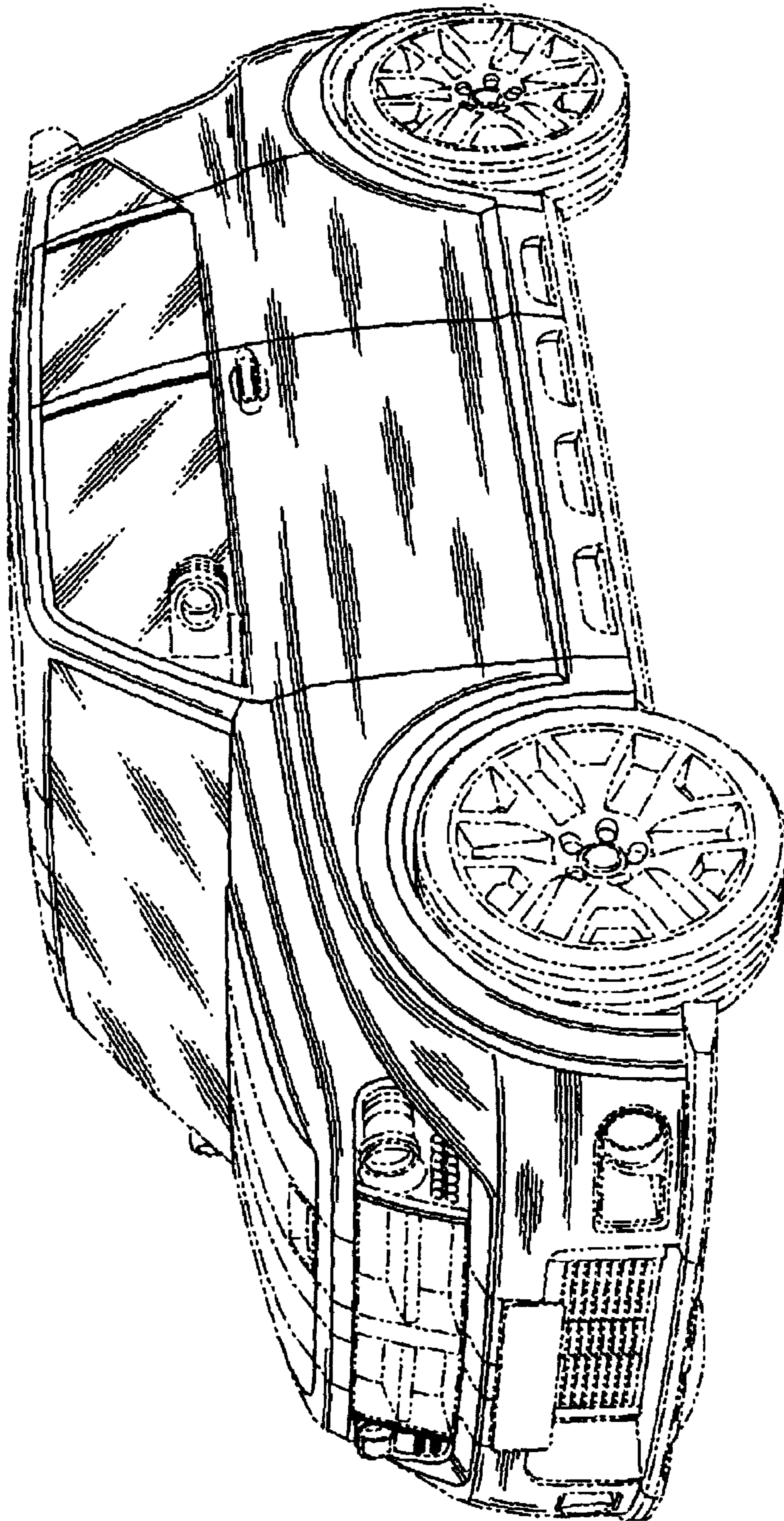

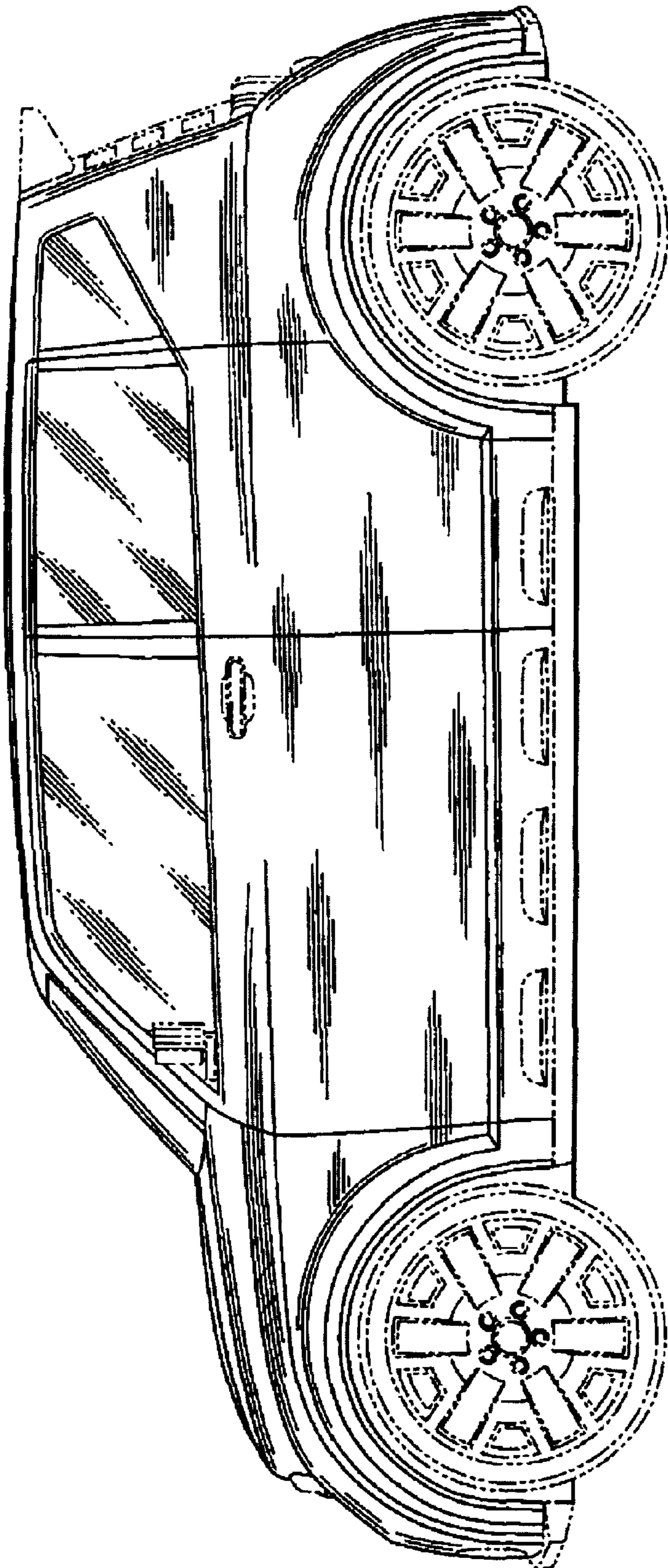

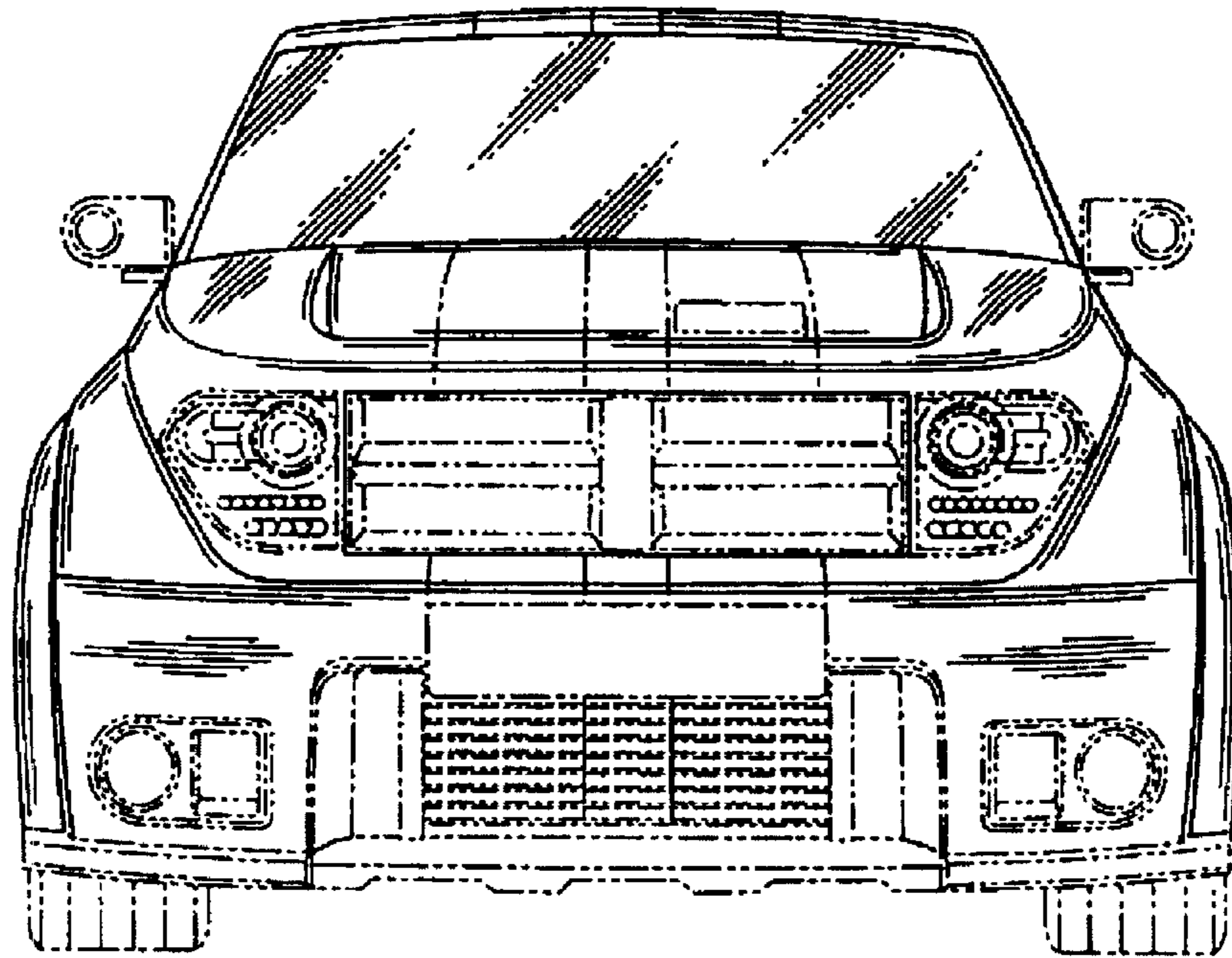

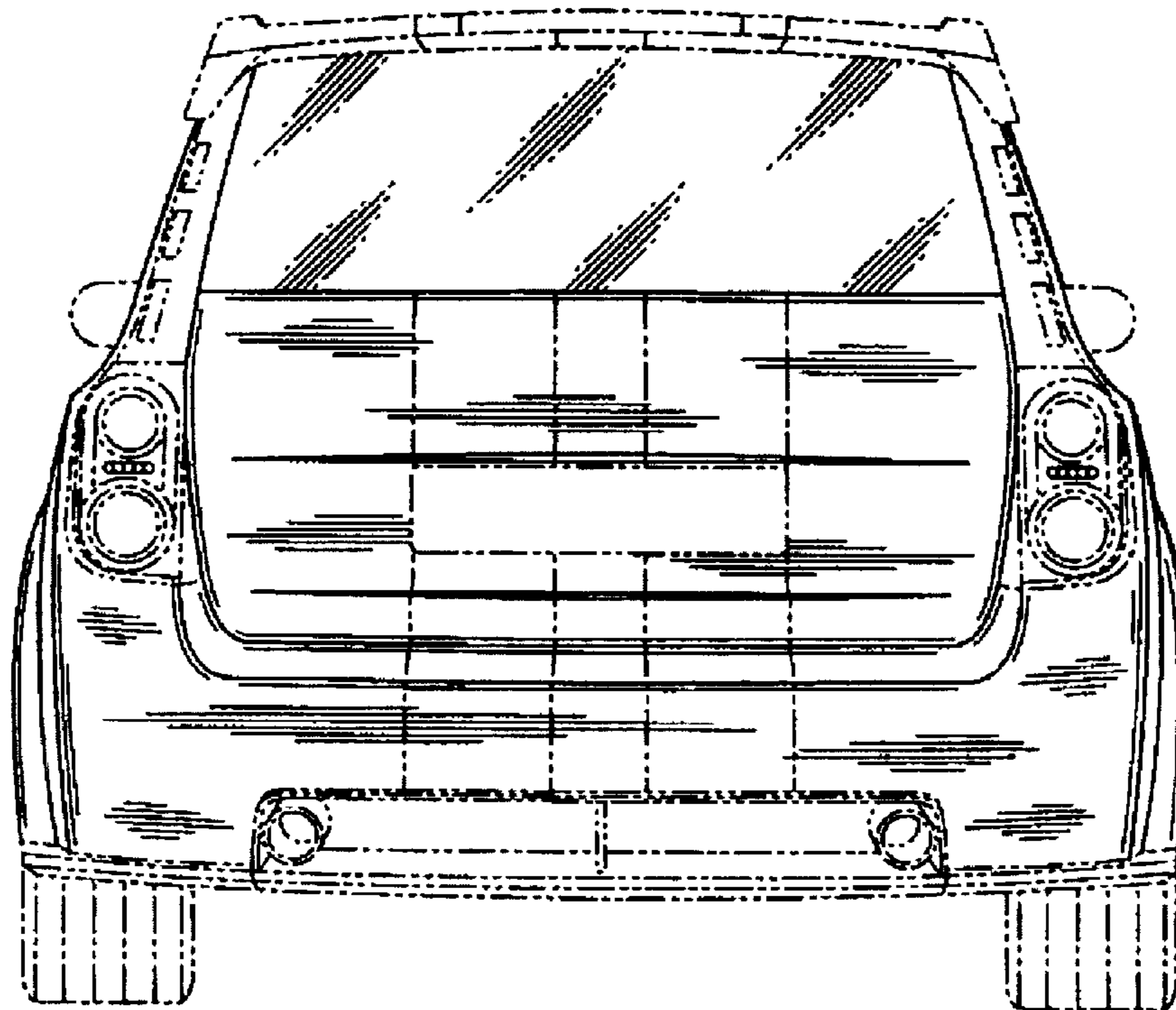

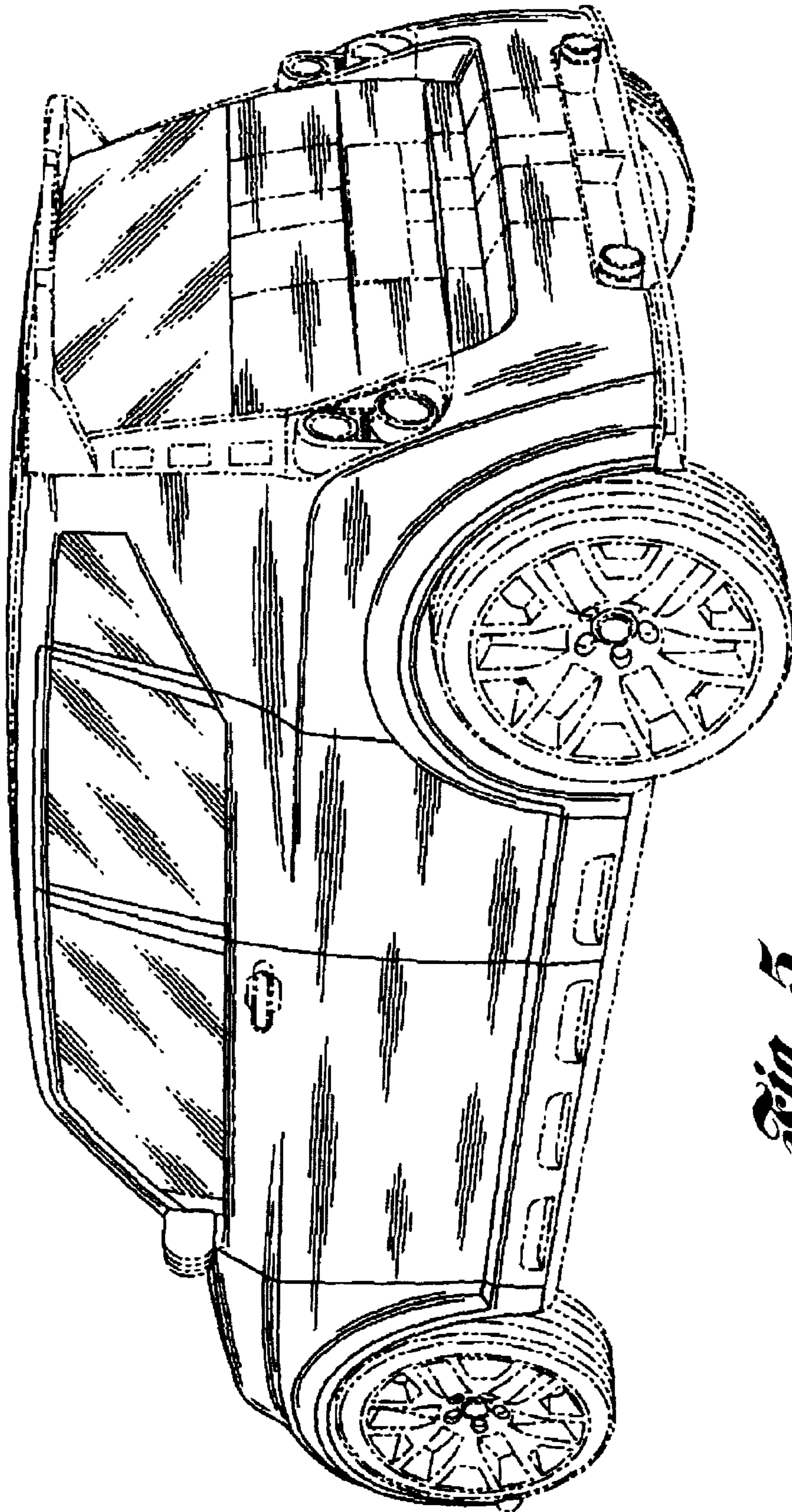

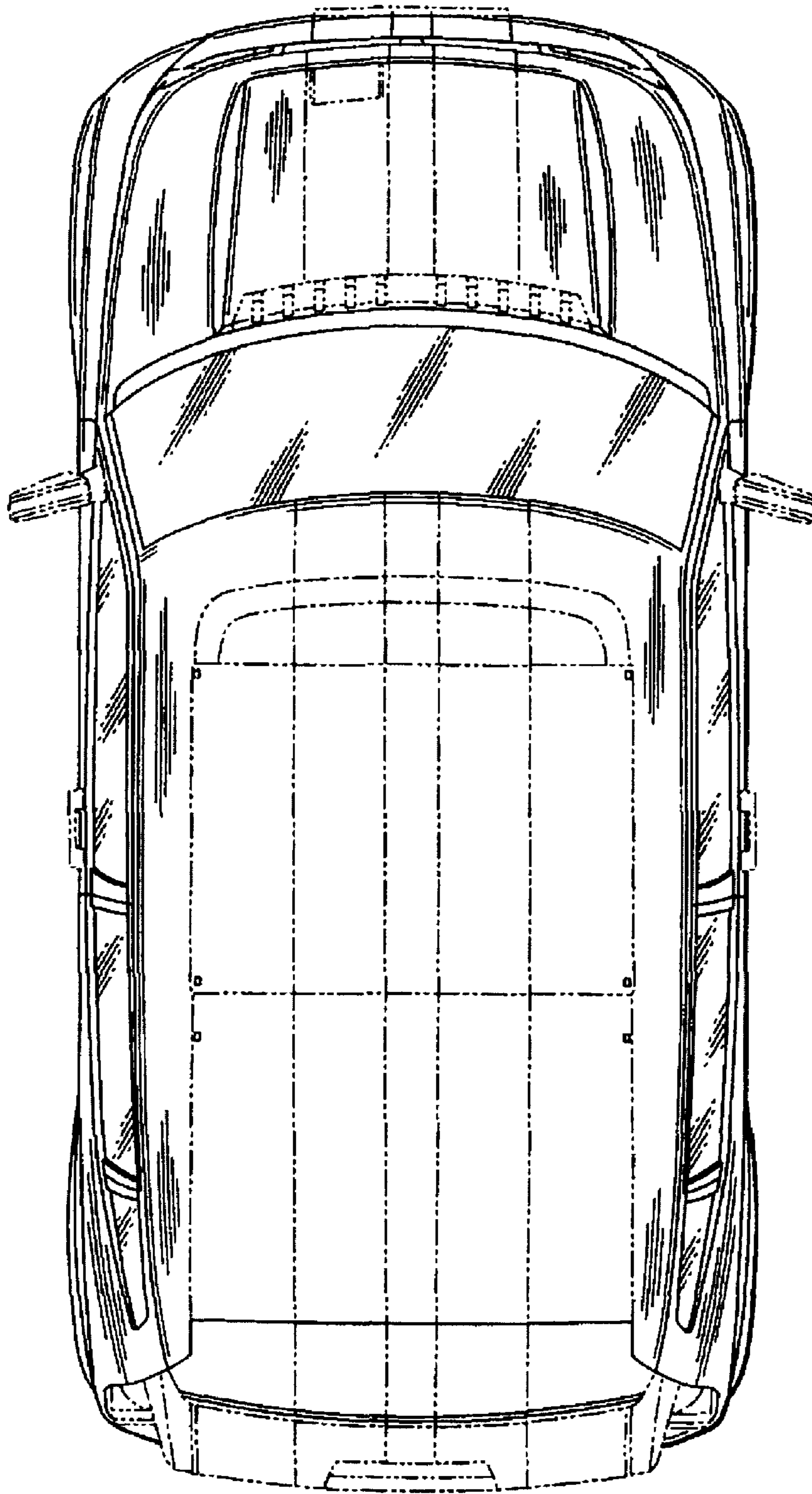
