FIG. 3 is a front view thereof;

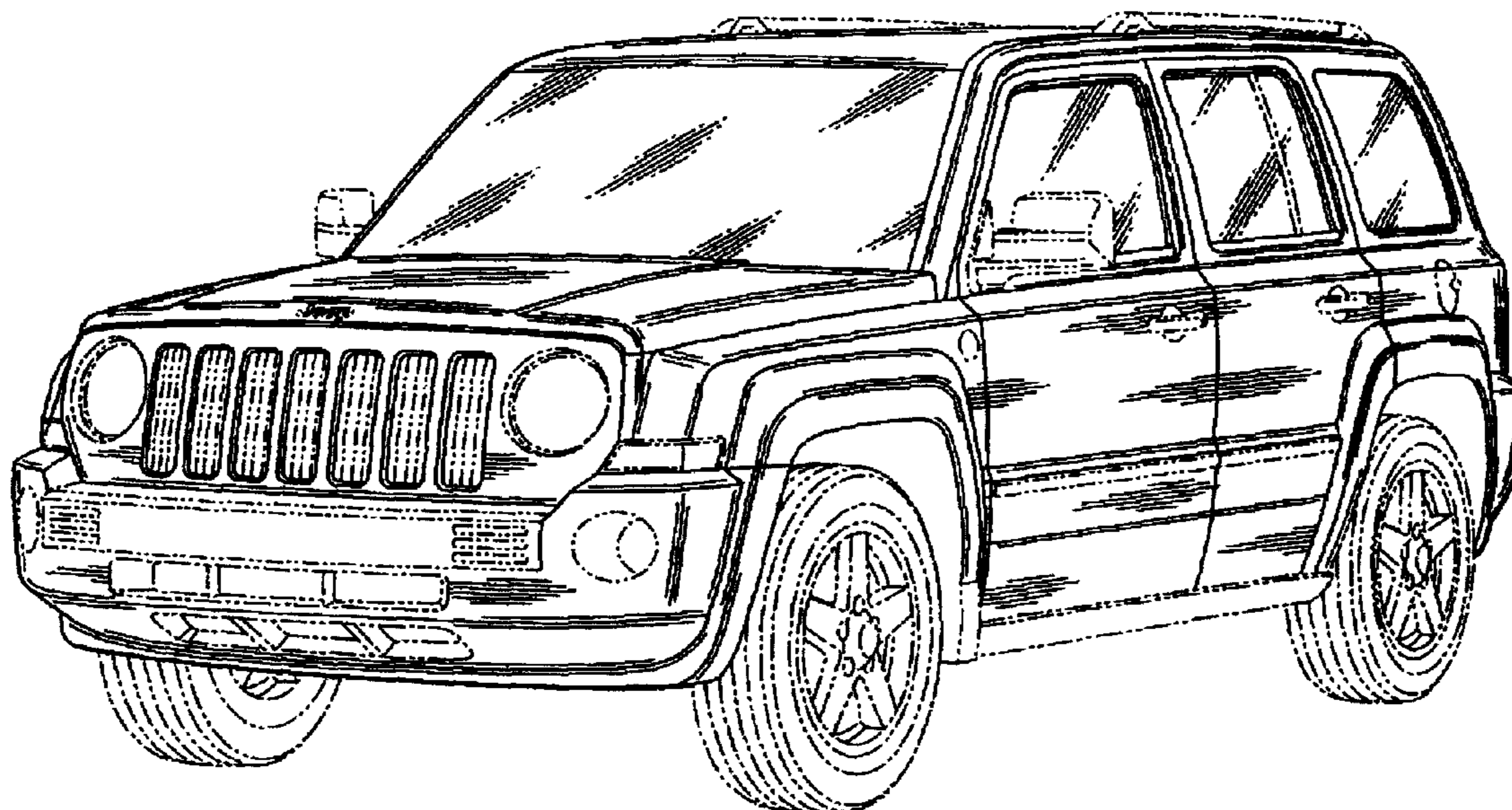
FIG. 4 is a rear view thereof;

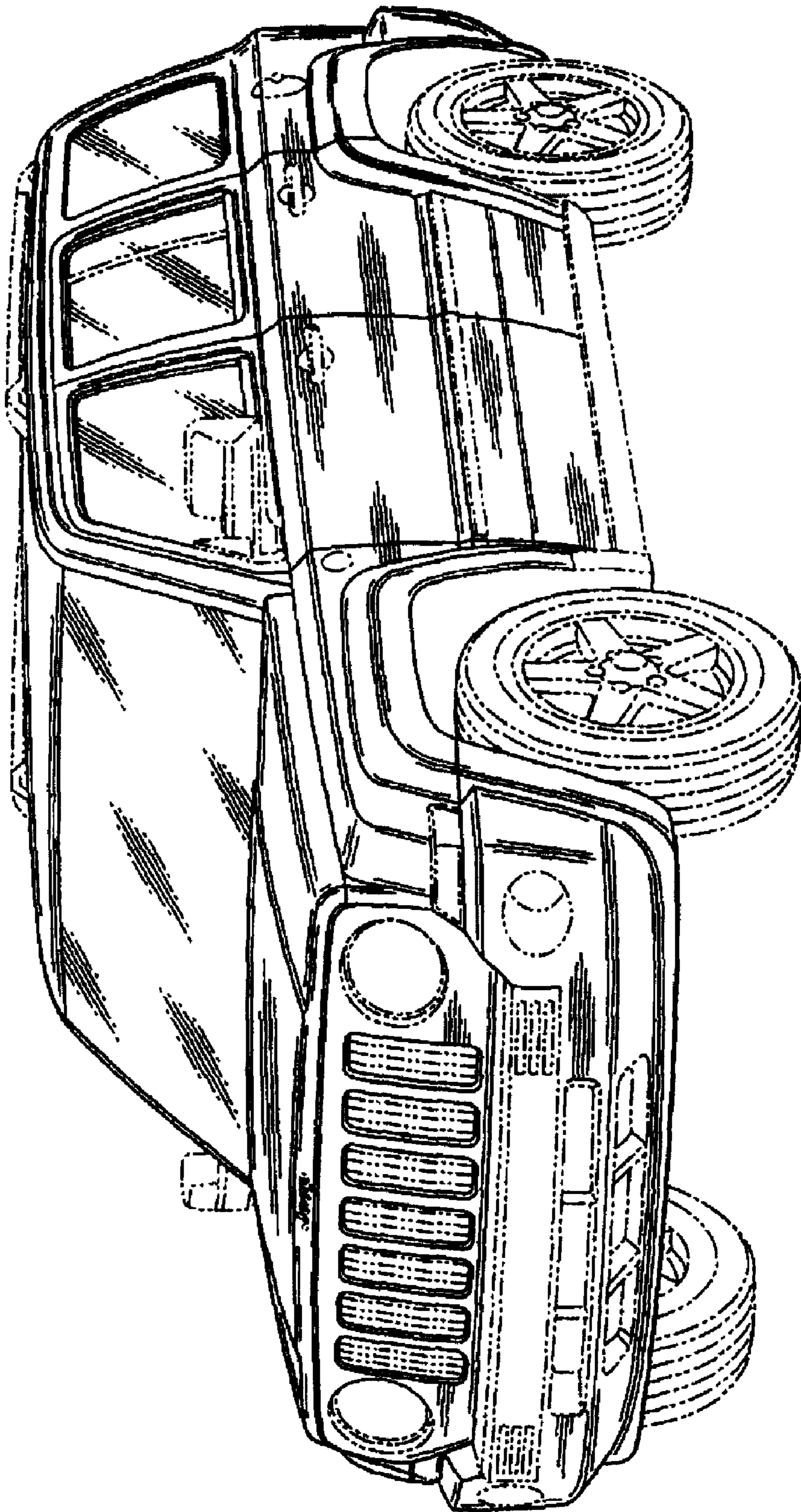
FIG. 5 is a rear perspective view thereof; and,

FIG. 6 is a top plan view thereof.

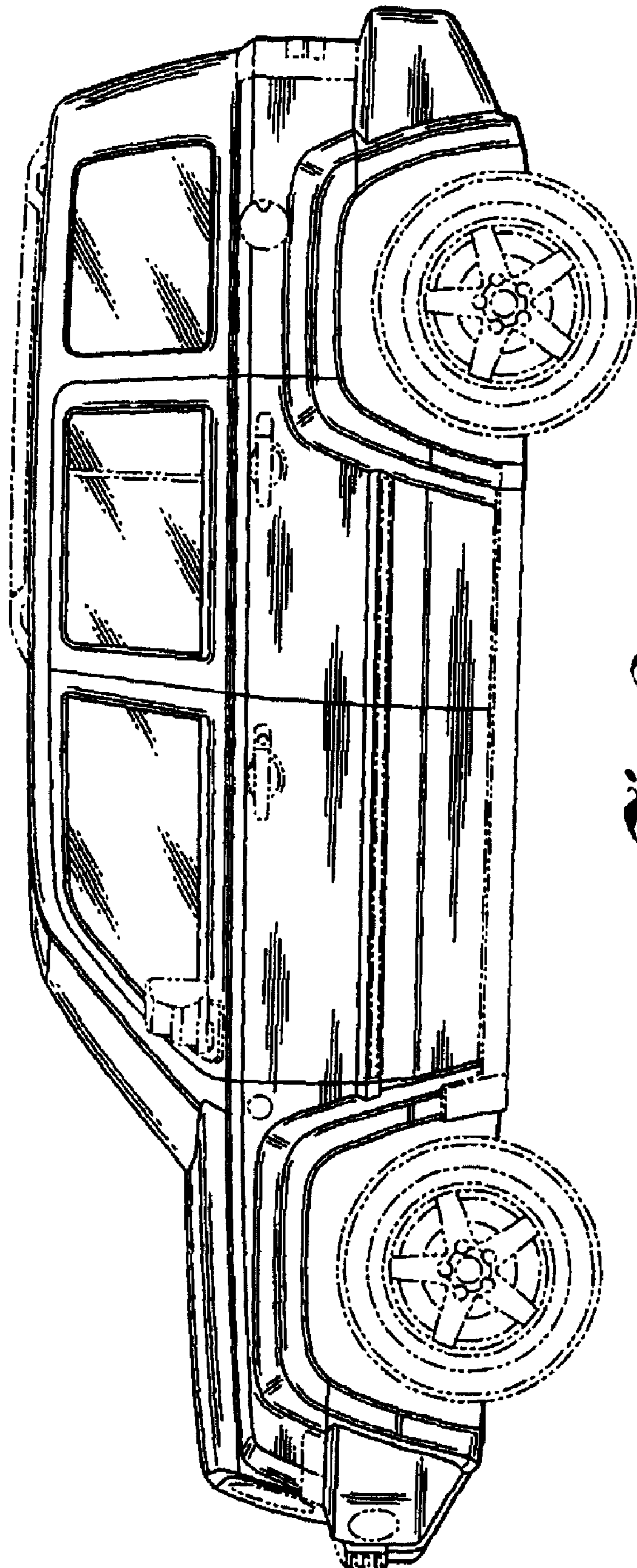

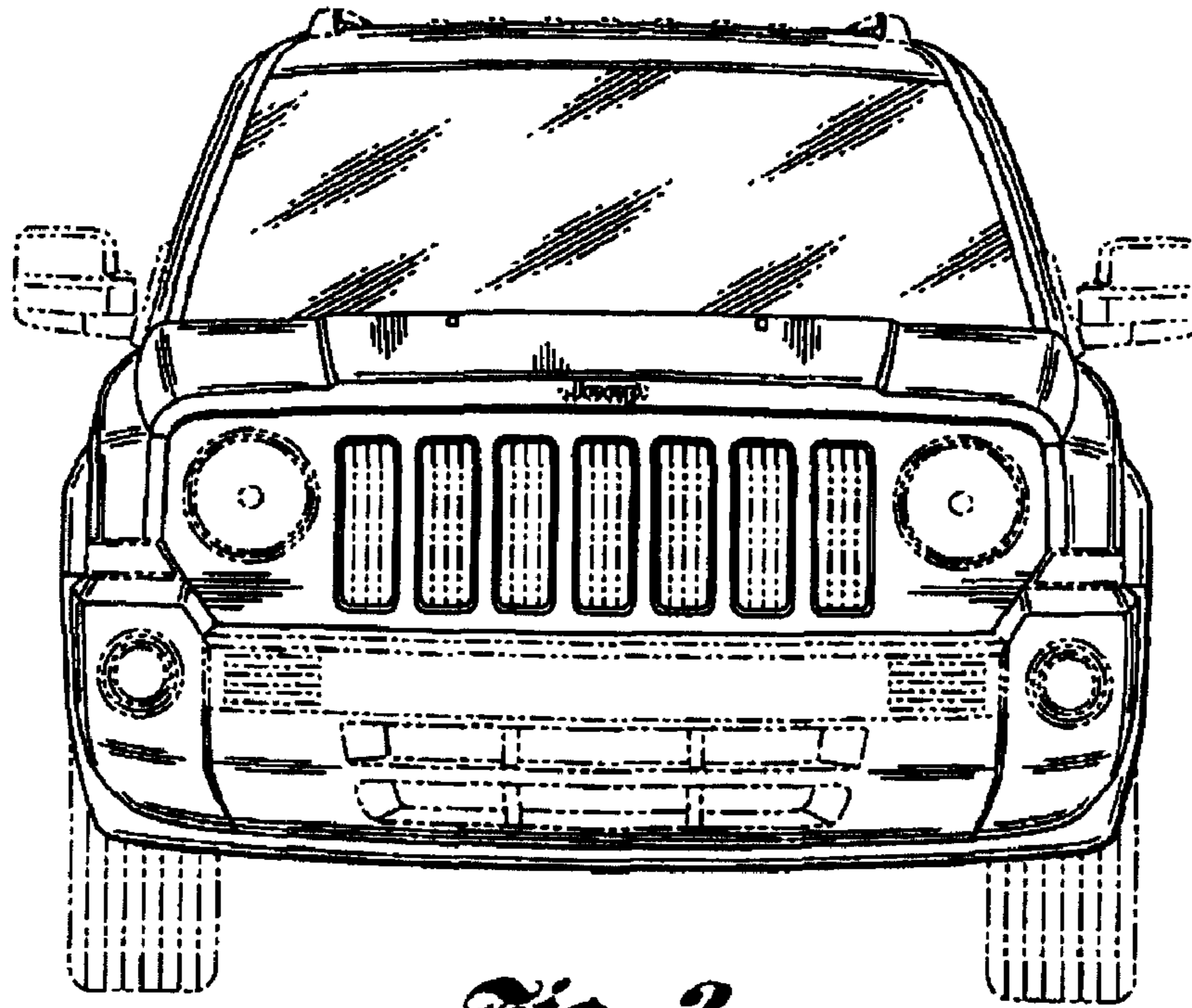




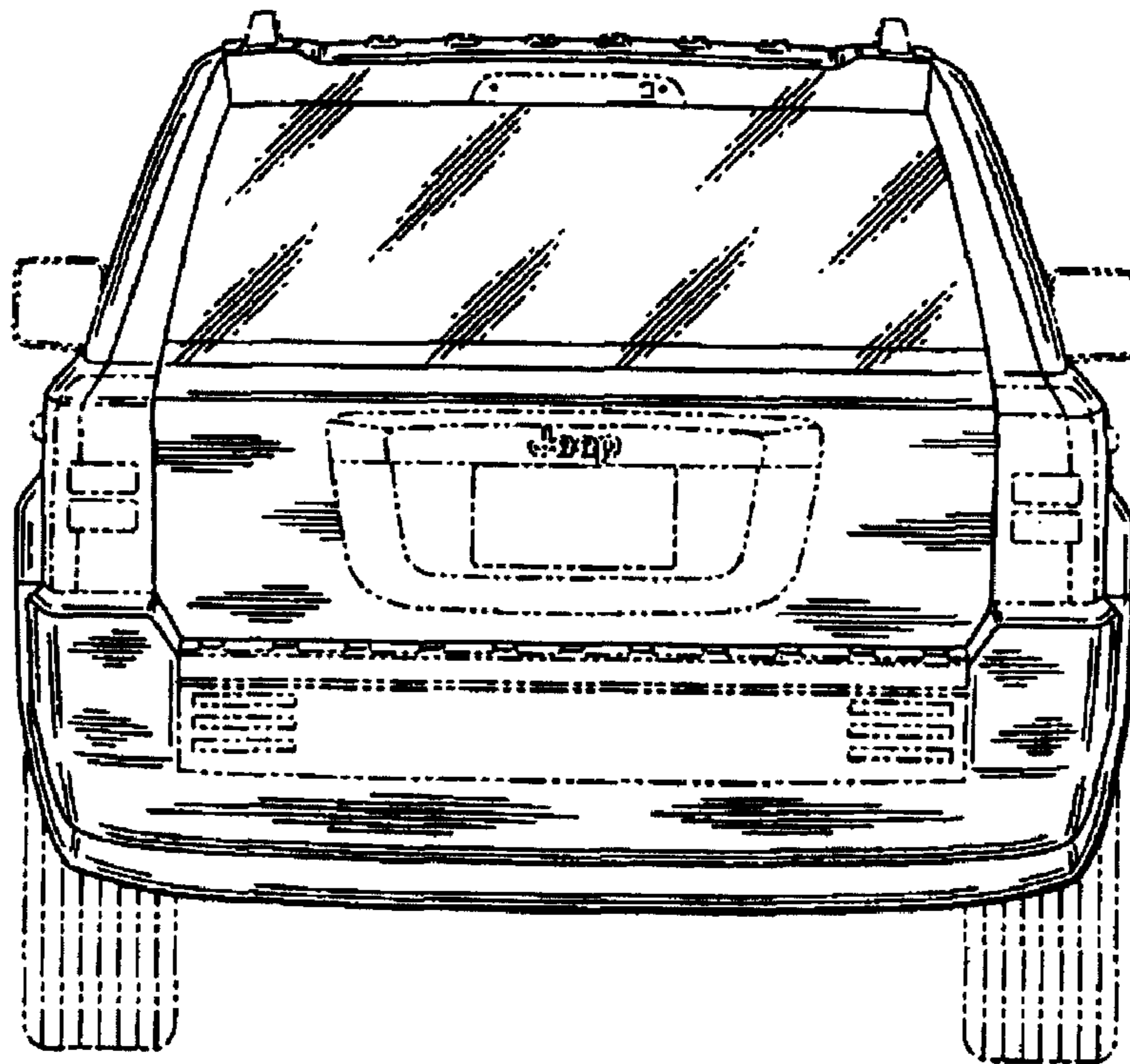

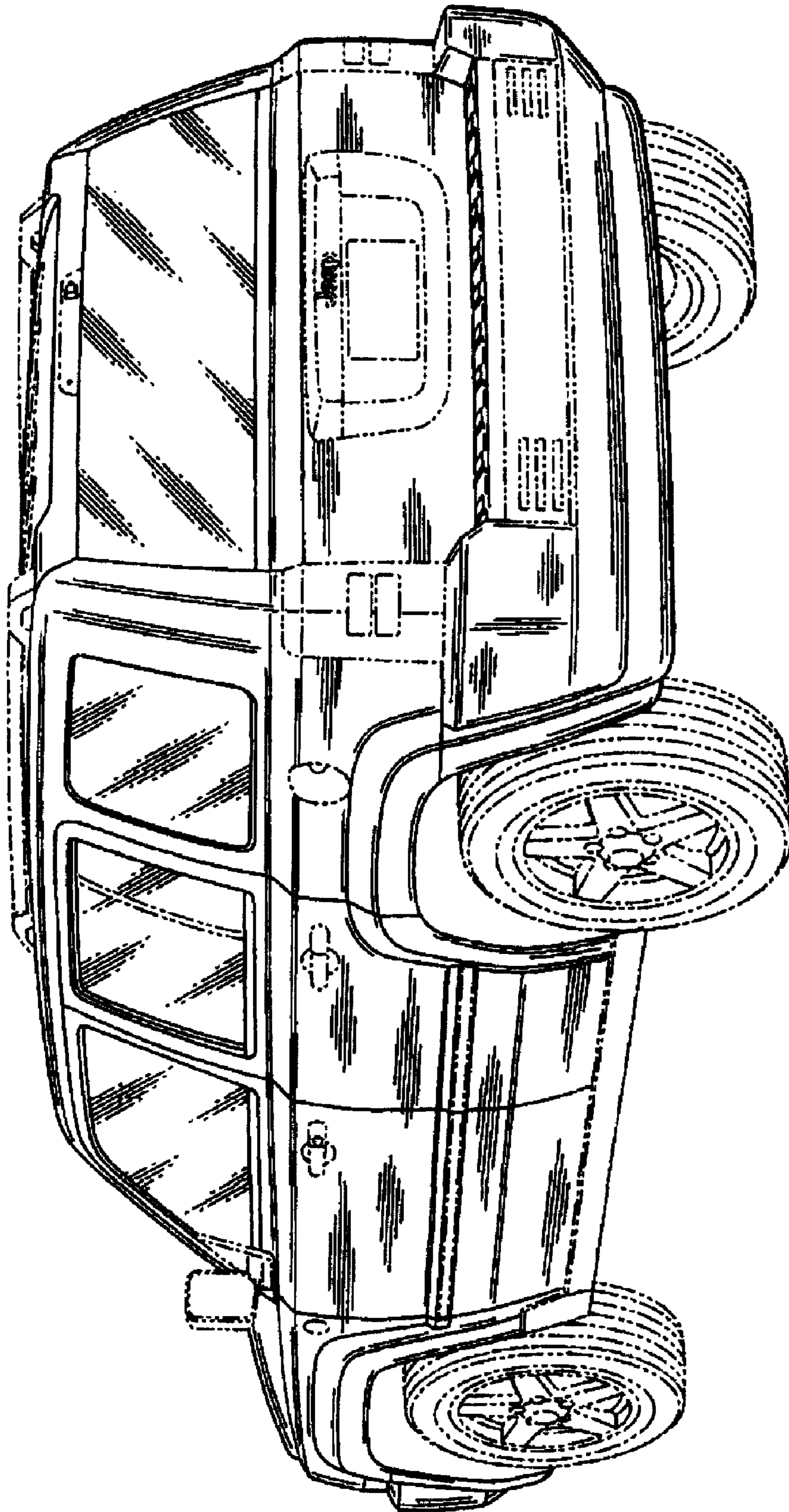

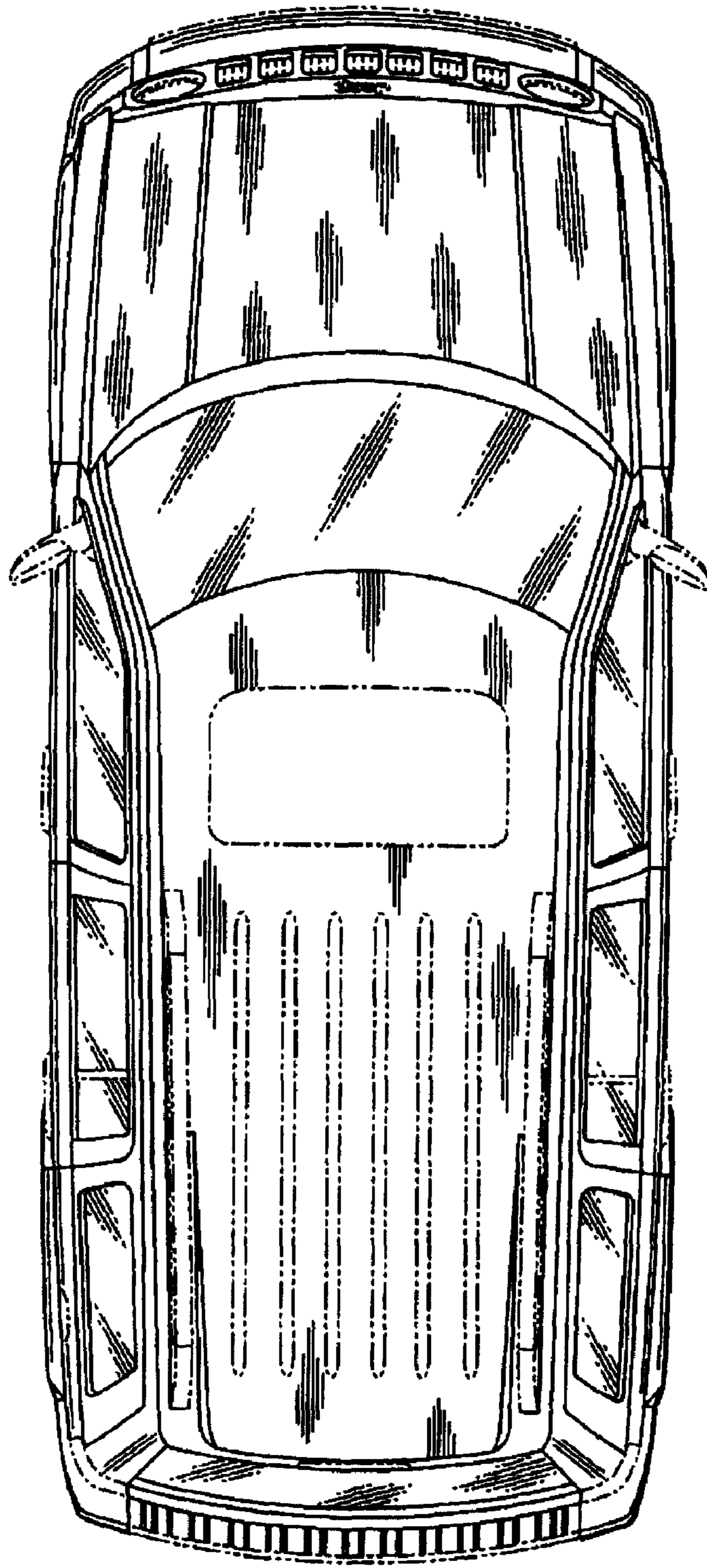
