**DESCRIPTION**

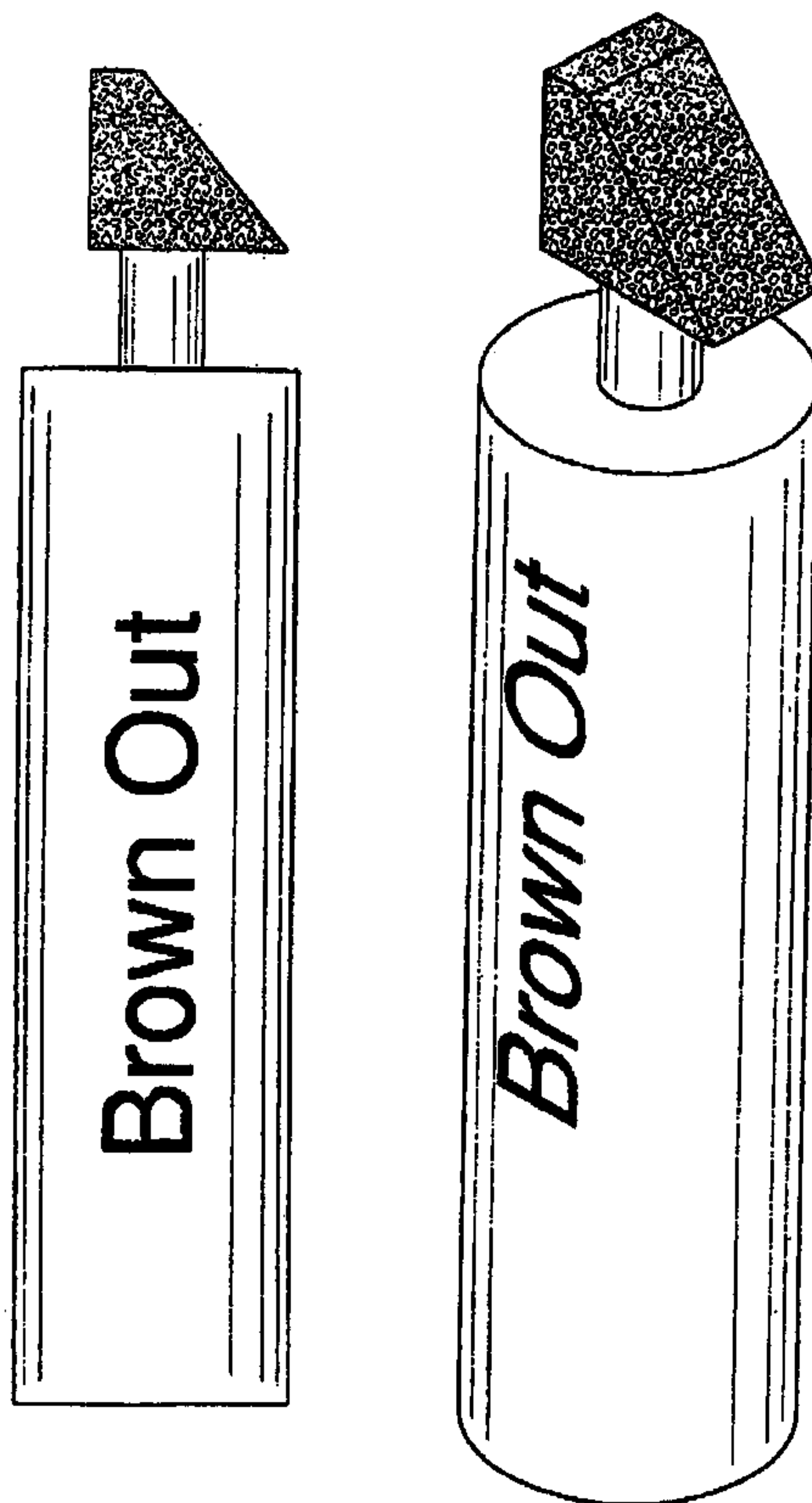
FIG. 1 is a front view of the brown out stick;

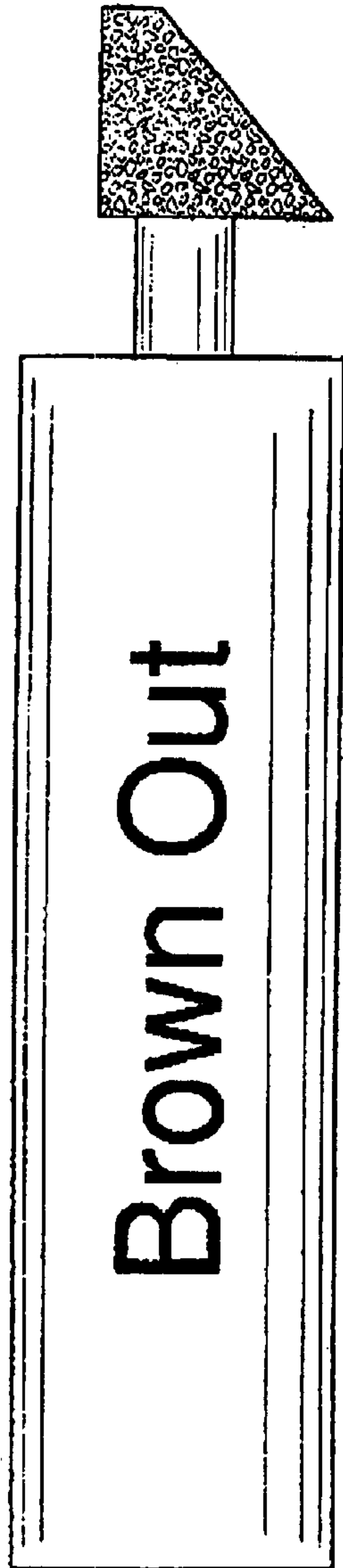

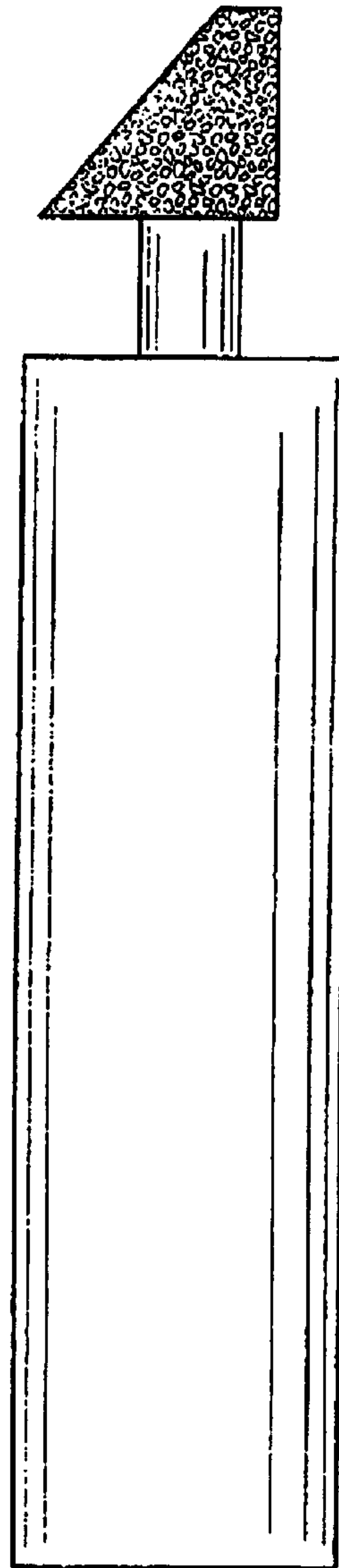

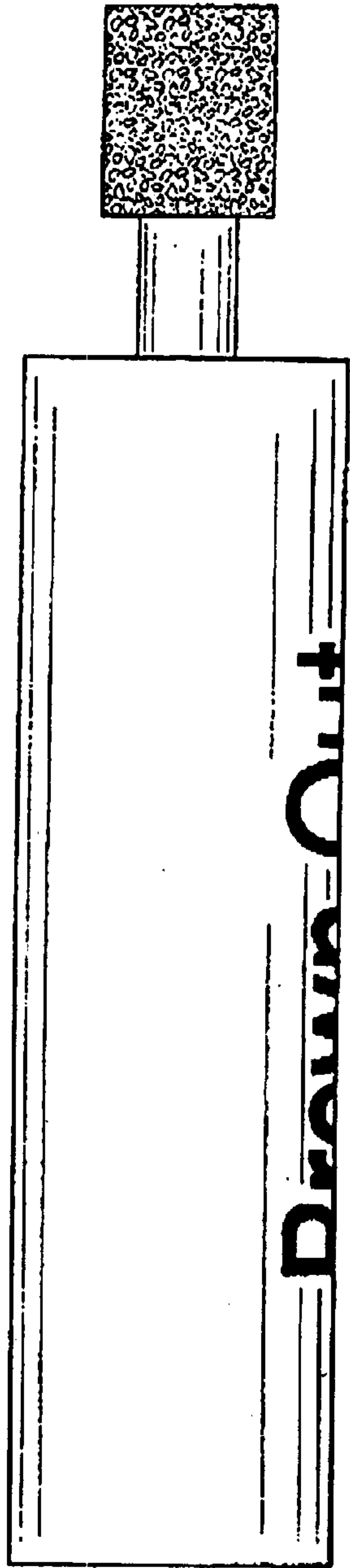

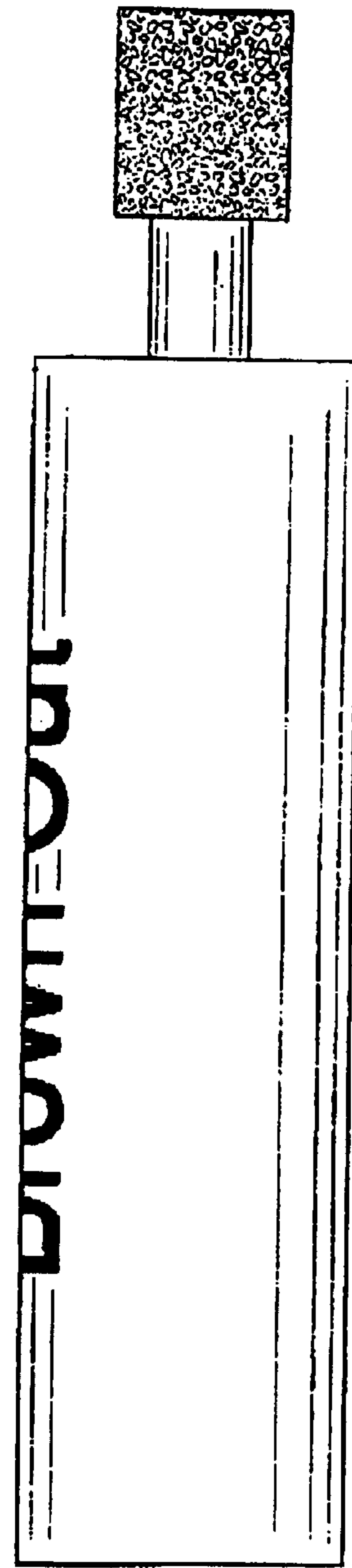

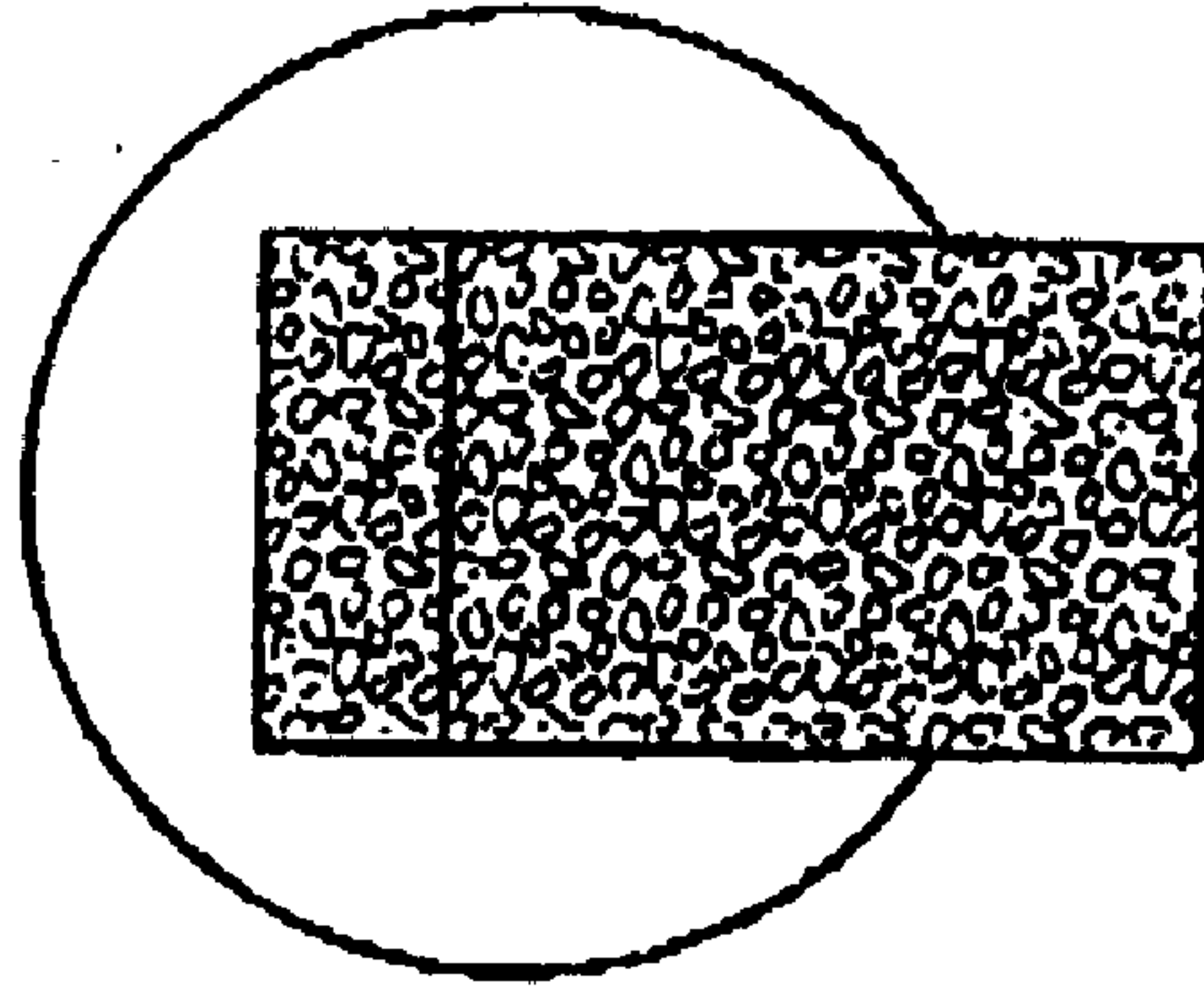

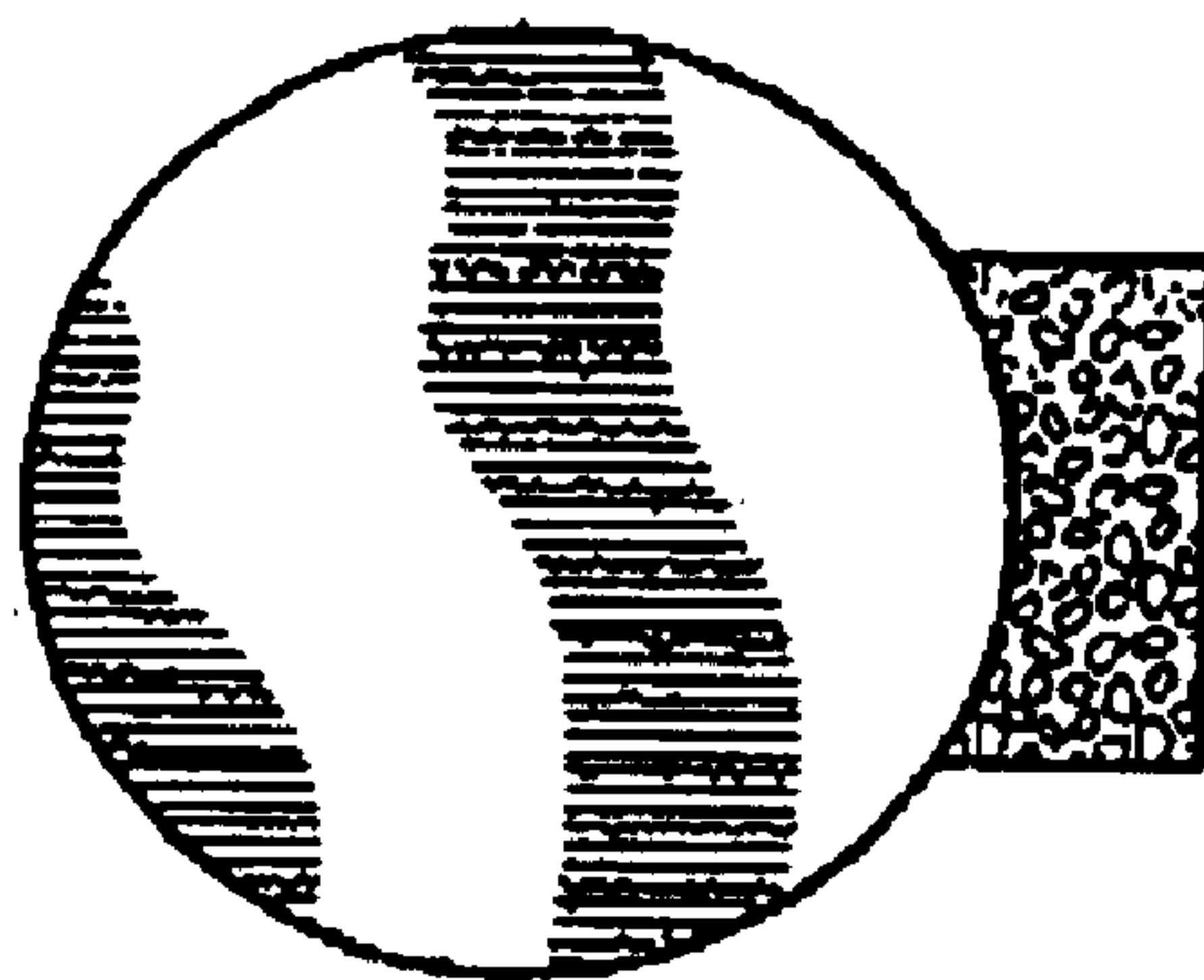
