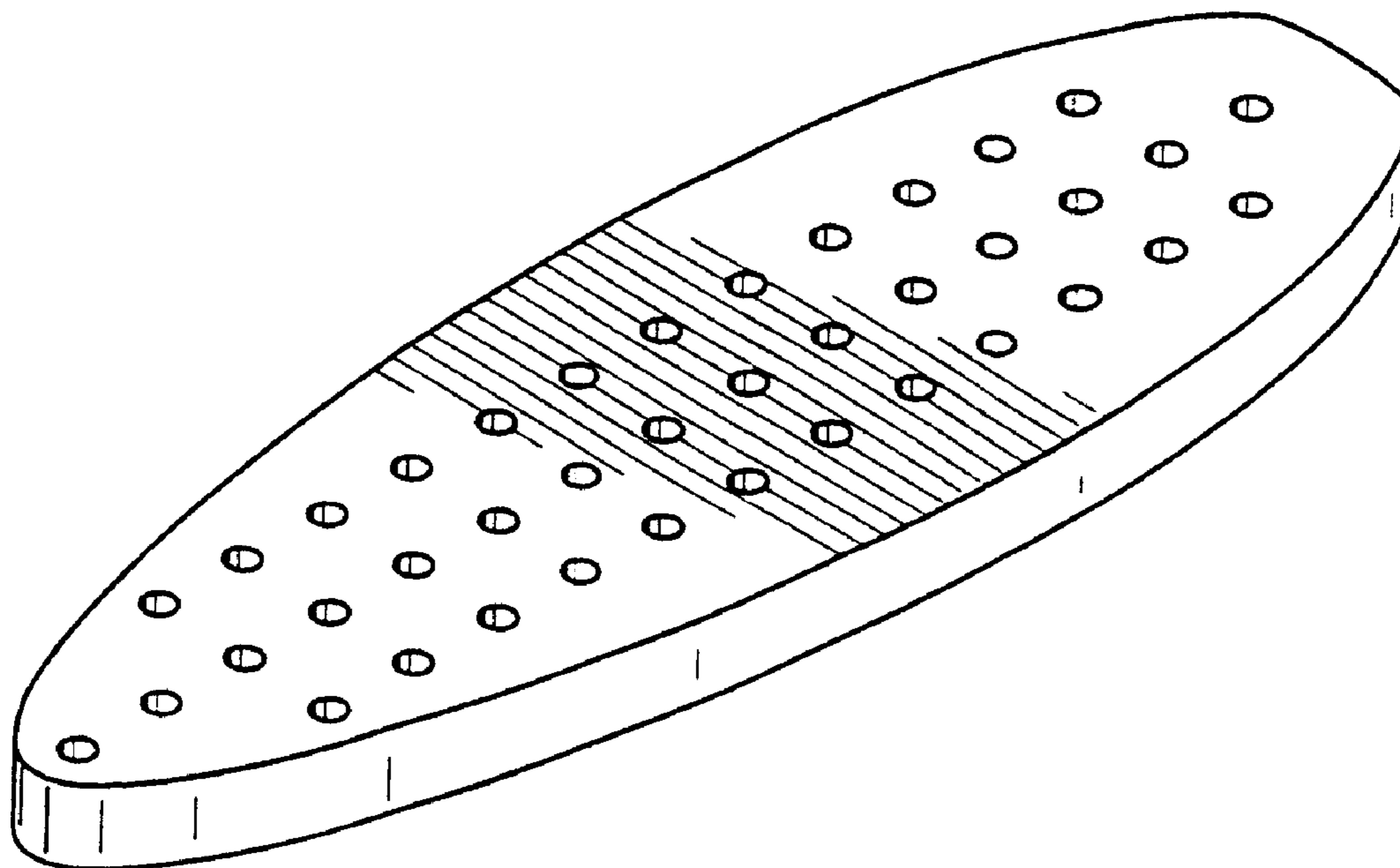
(57) **CLAIM**

The ornamental design for a vent for a respiratory mask, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a vent for a respiratory mask according to our design;

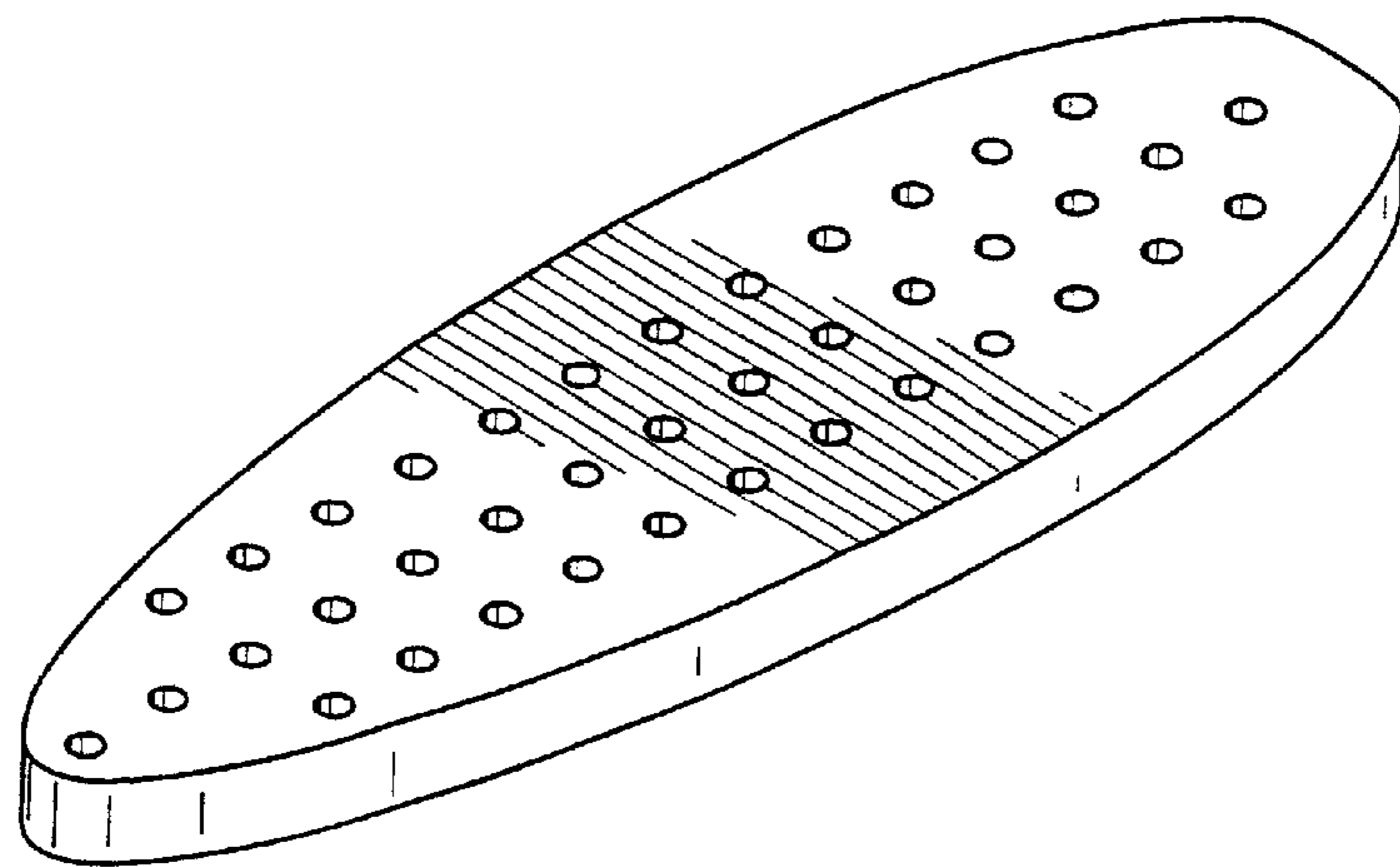

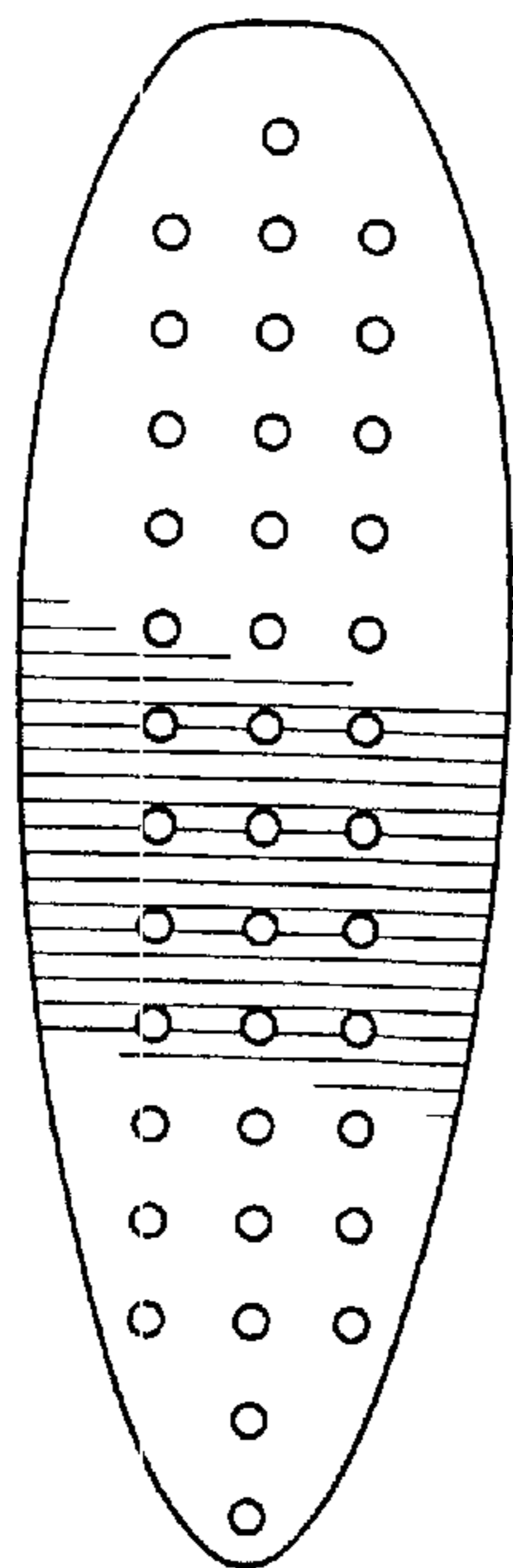

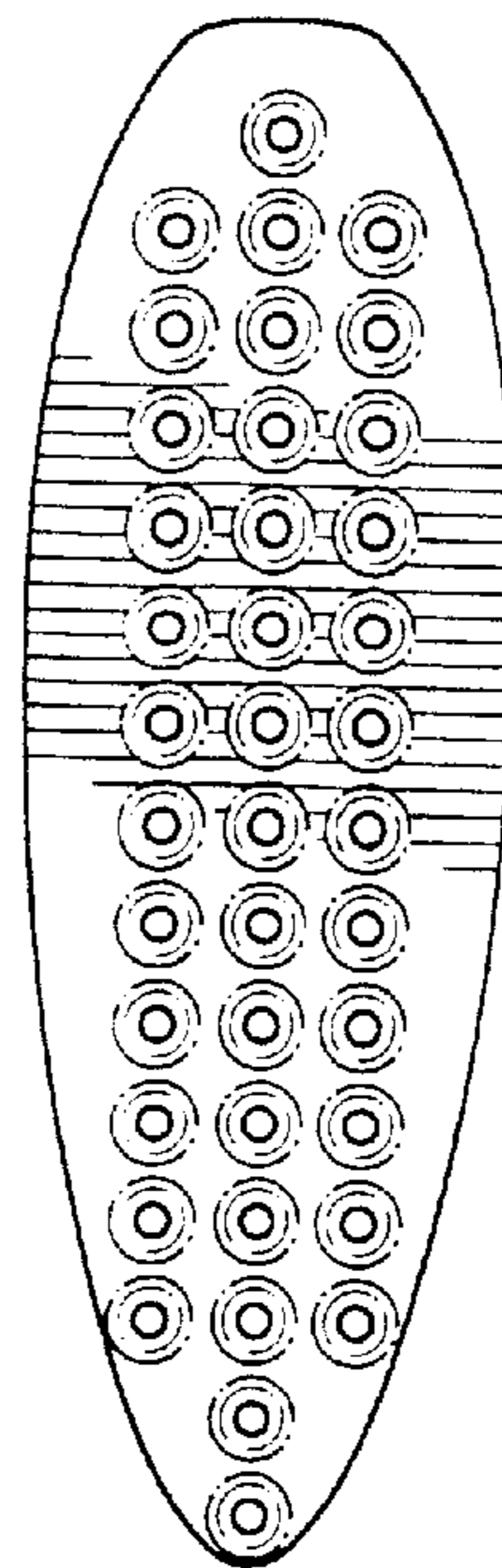

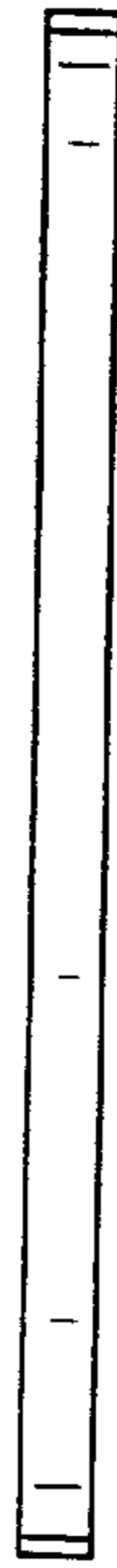

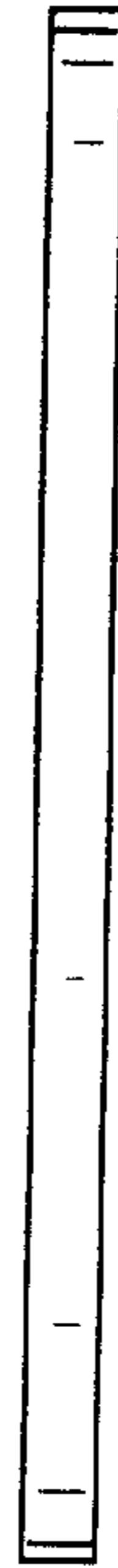

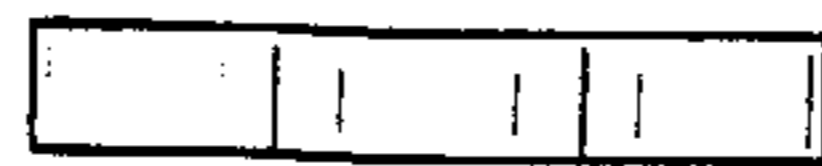
