FIG. 6 is a right side elevational view thereof, the left side elevational view being a mirror image of FIG. 6.

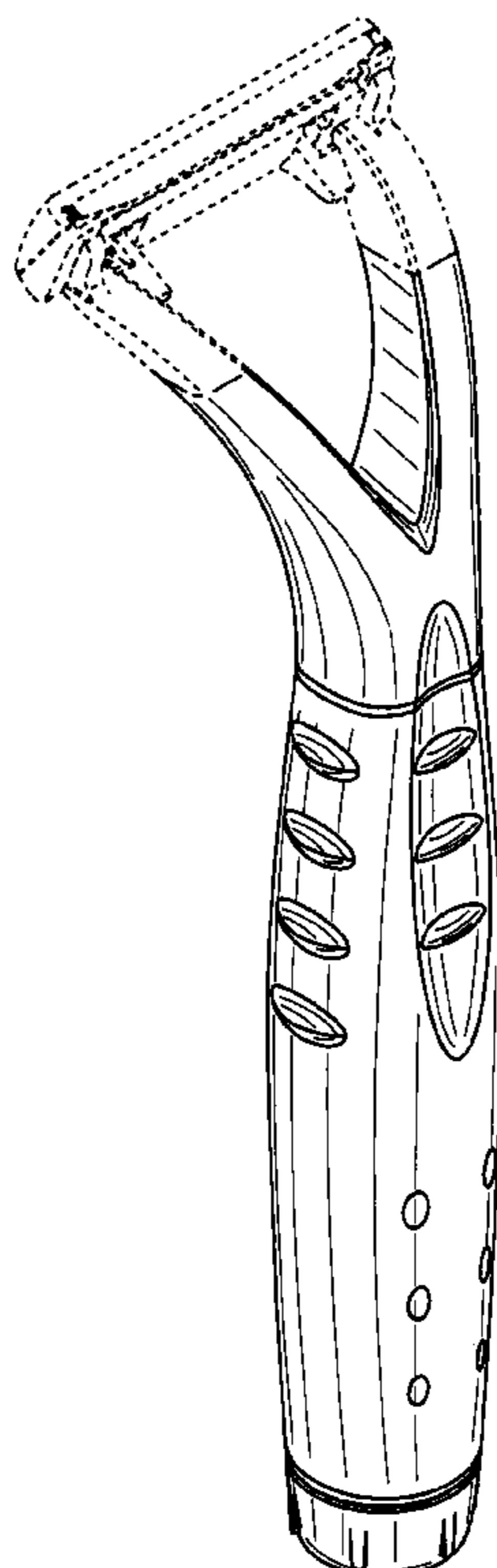

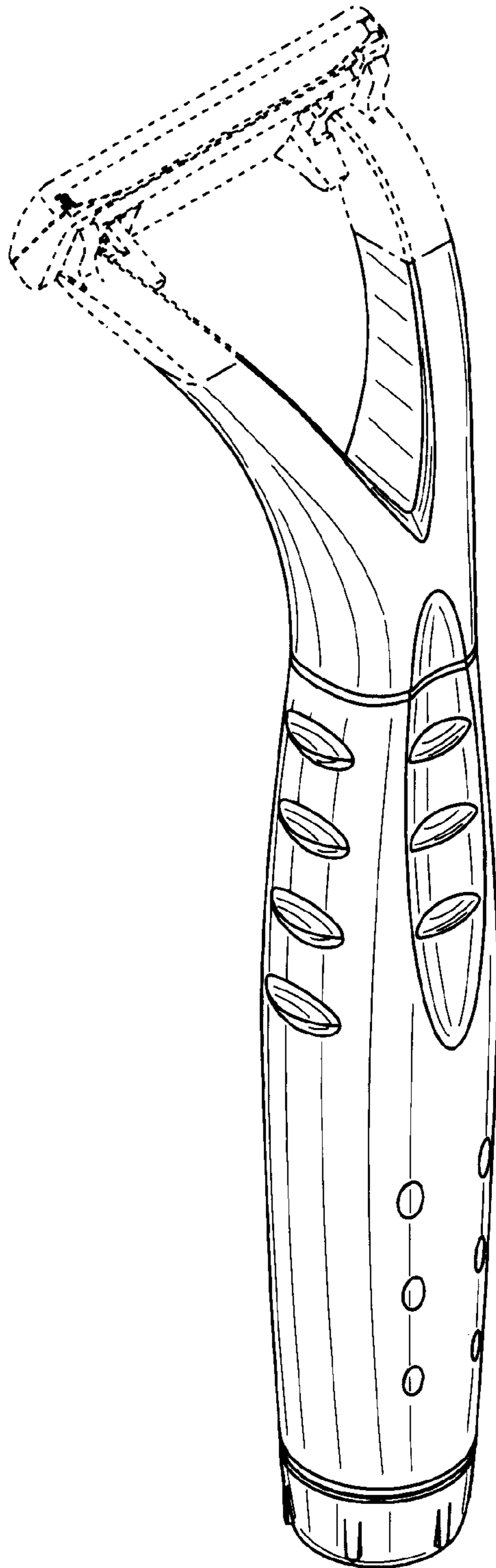

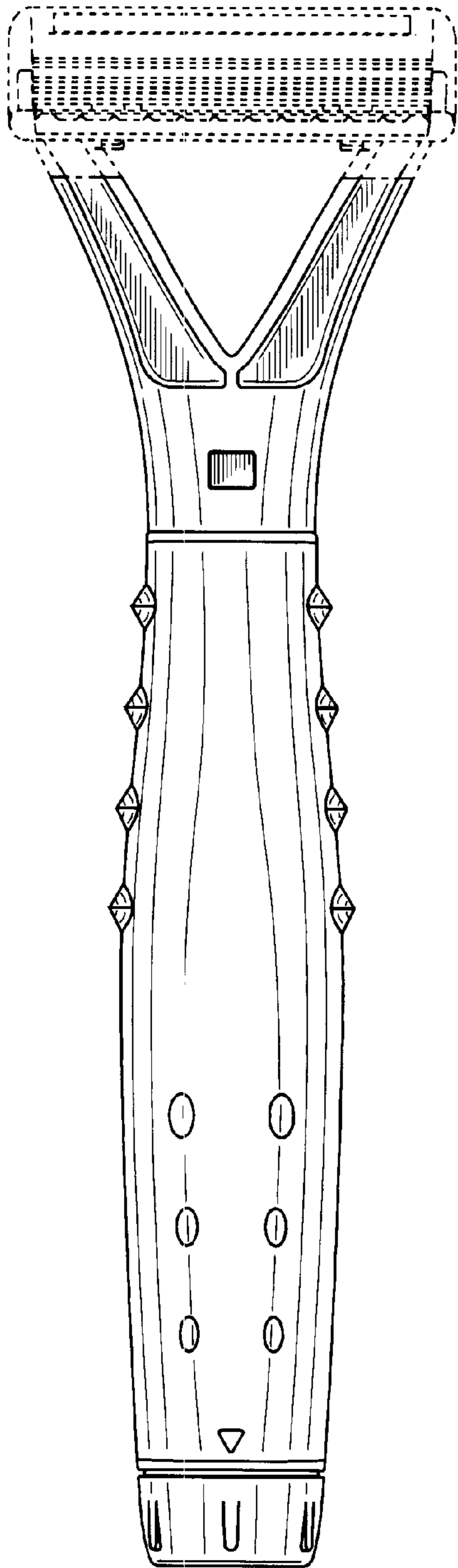

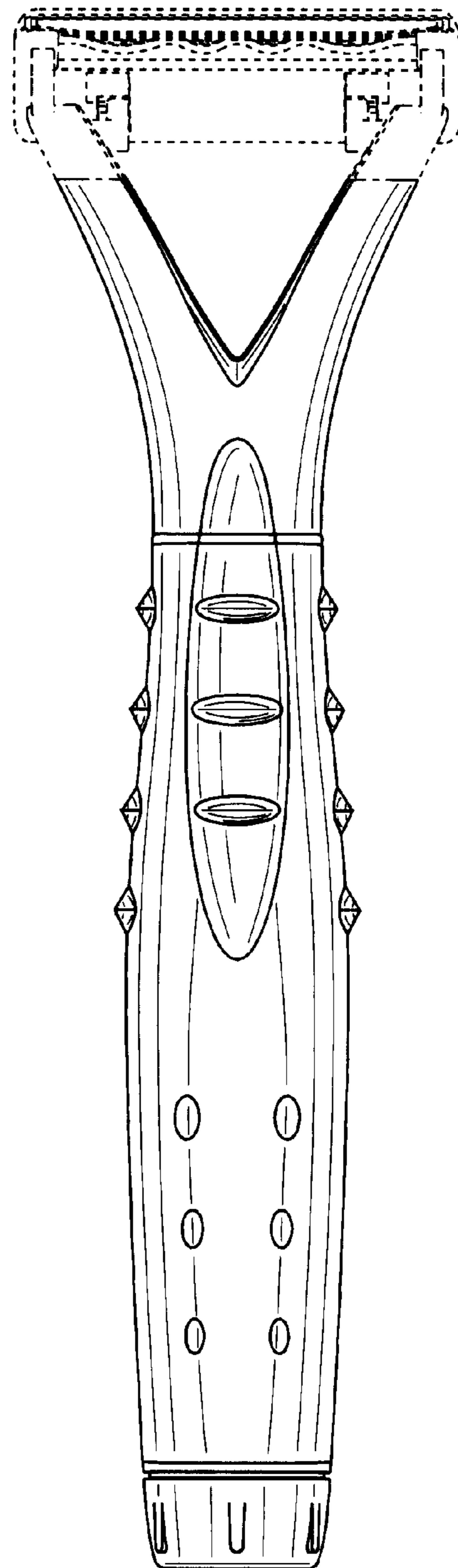

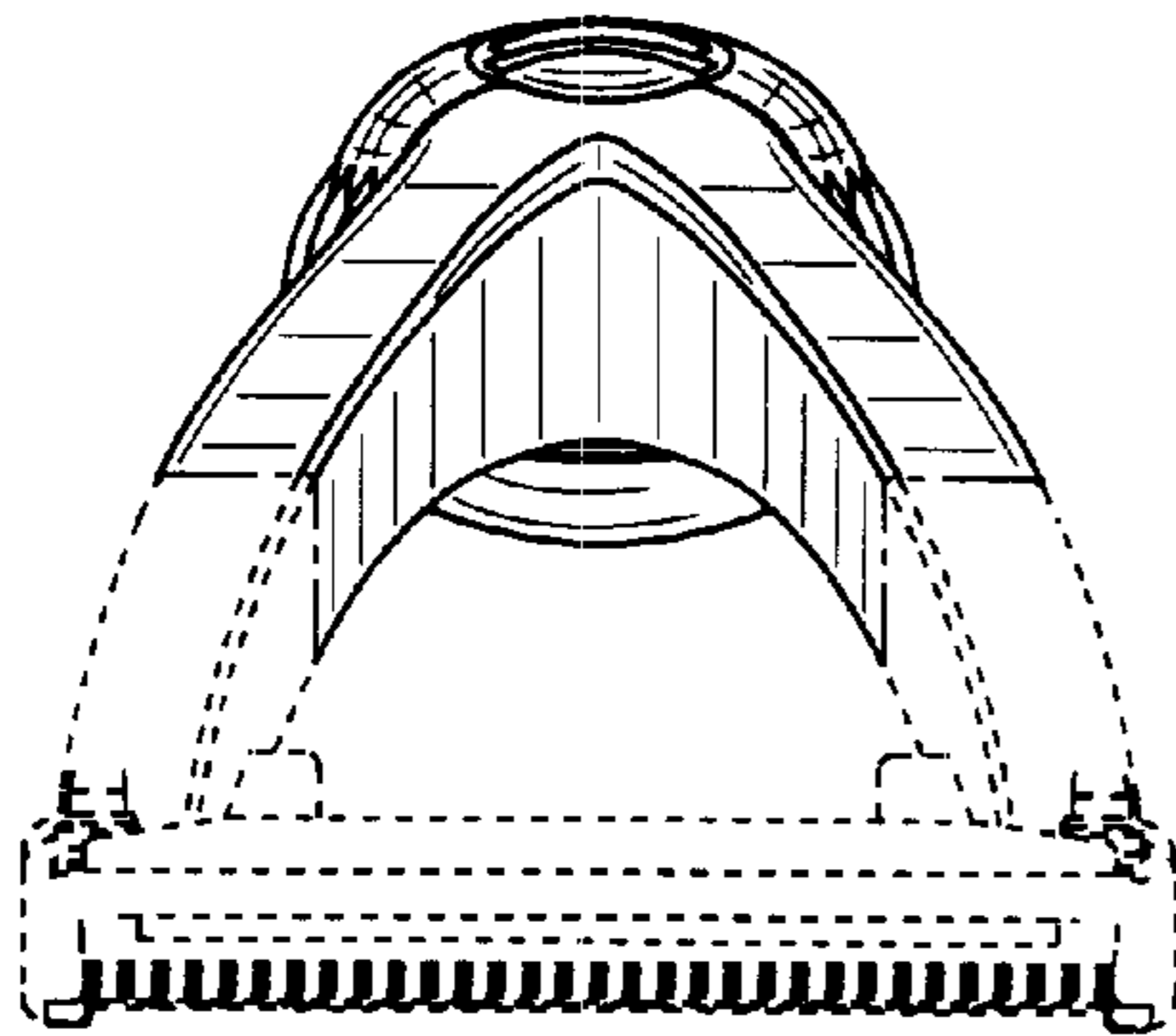

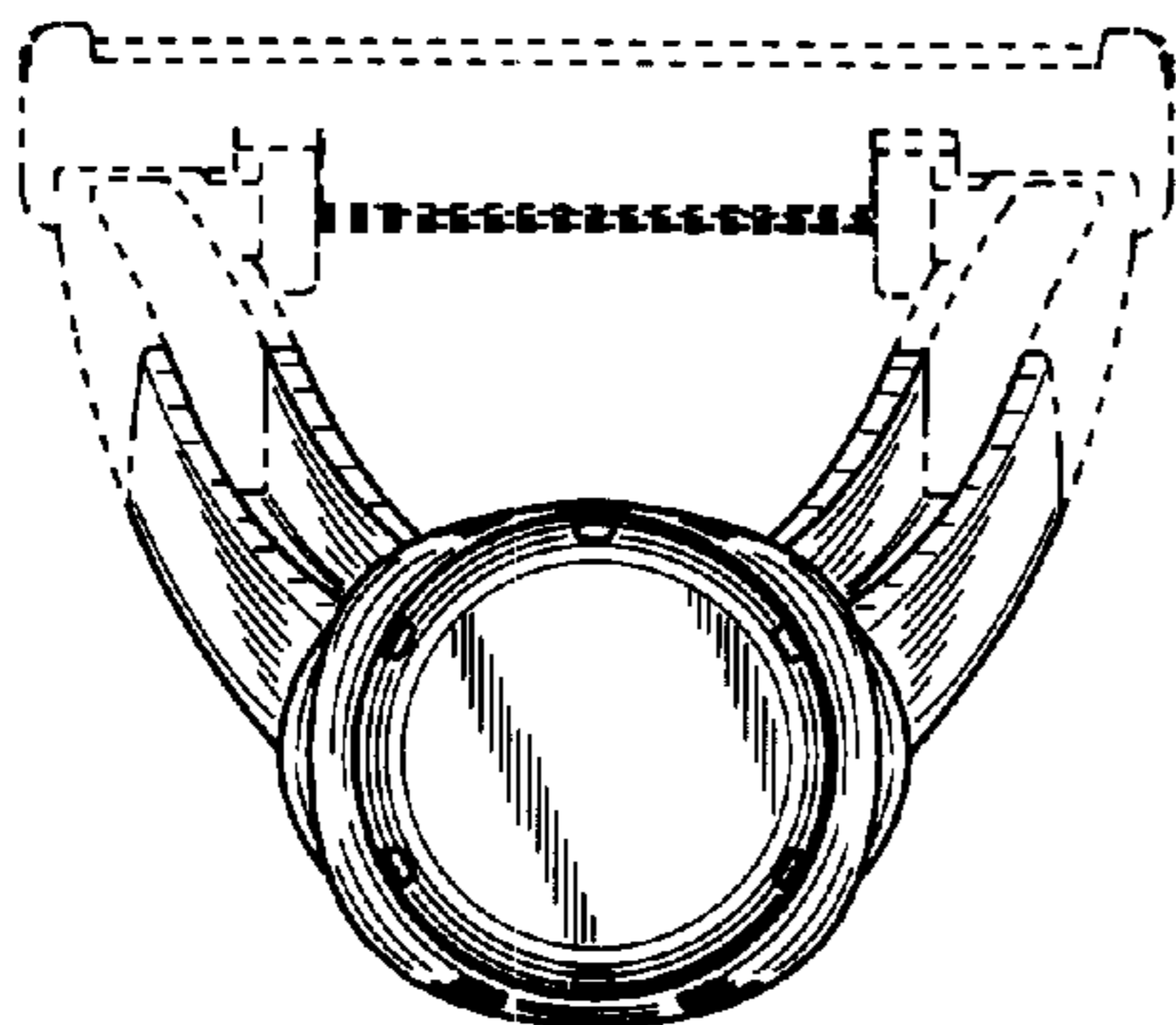
