FIG. 6 is a front view of a hand drying apparatus of the design according to this invention; and,

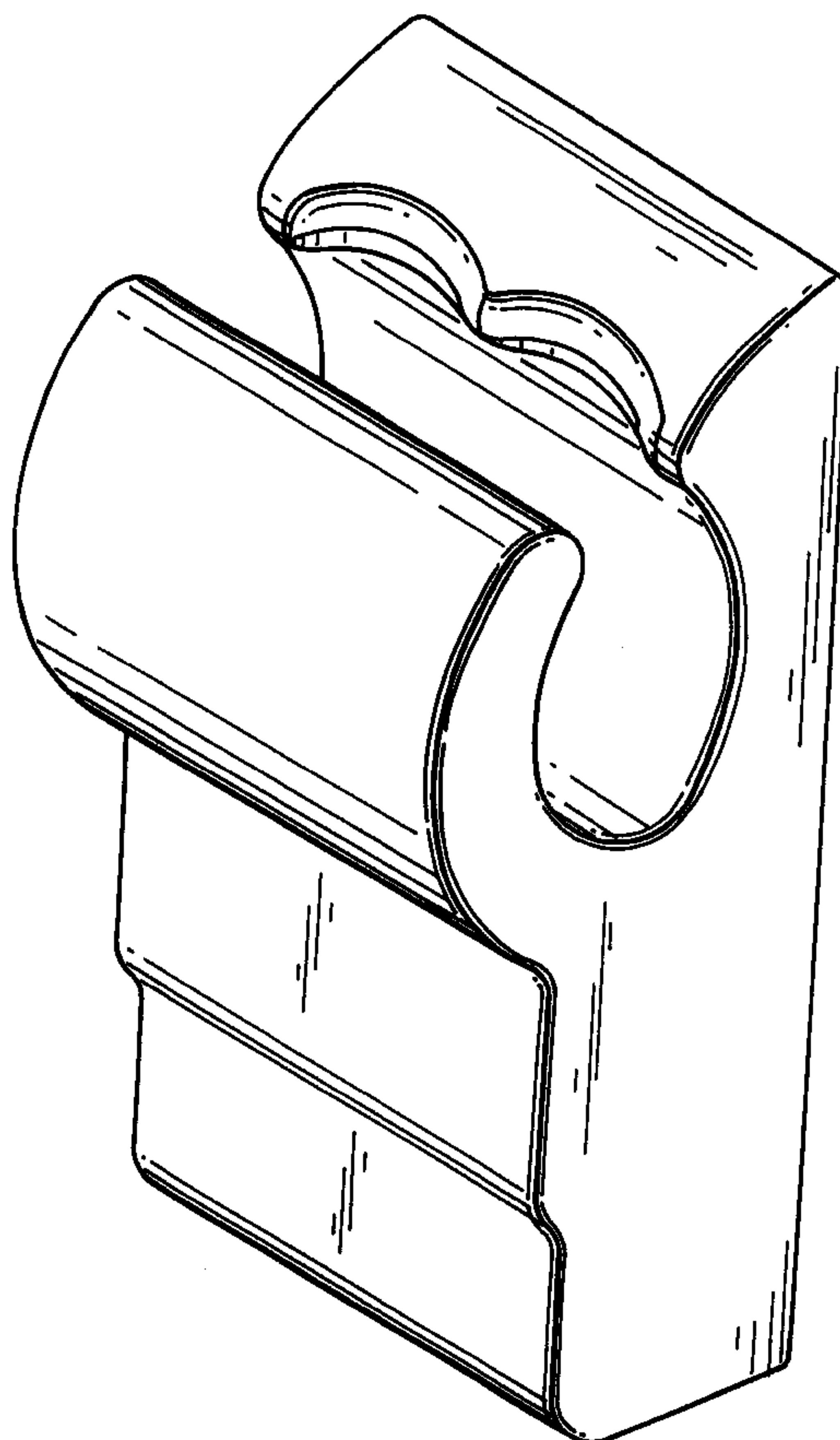
FIG. 7 is a rear view of a hand drying apparatus of the design according to this invention.

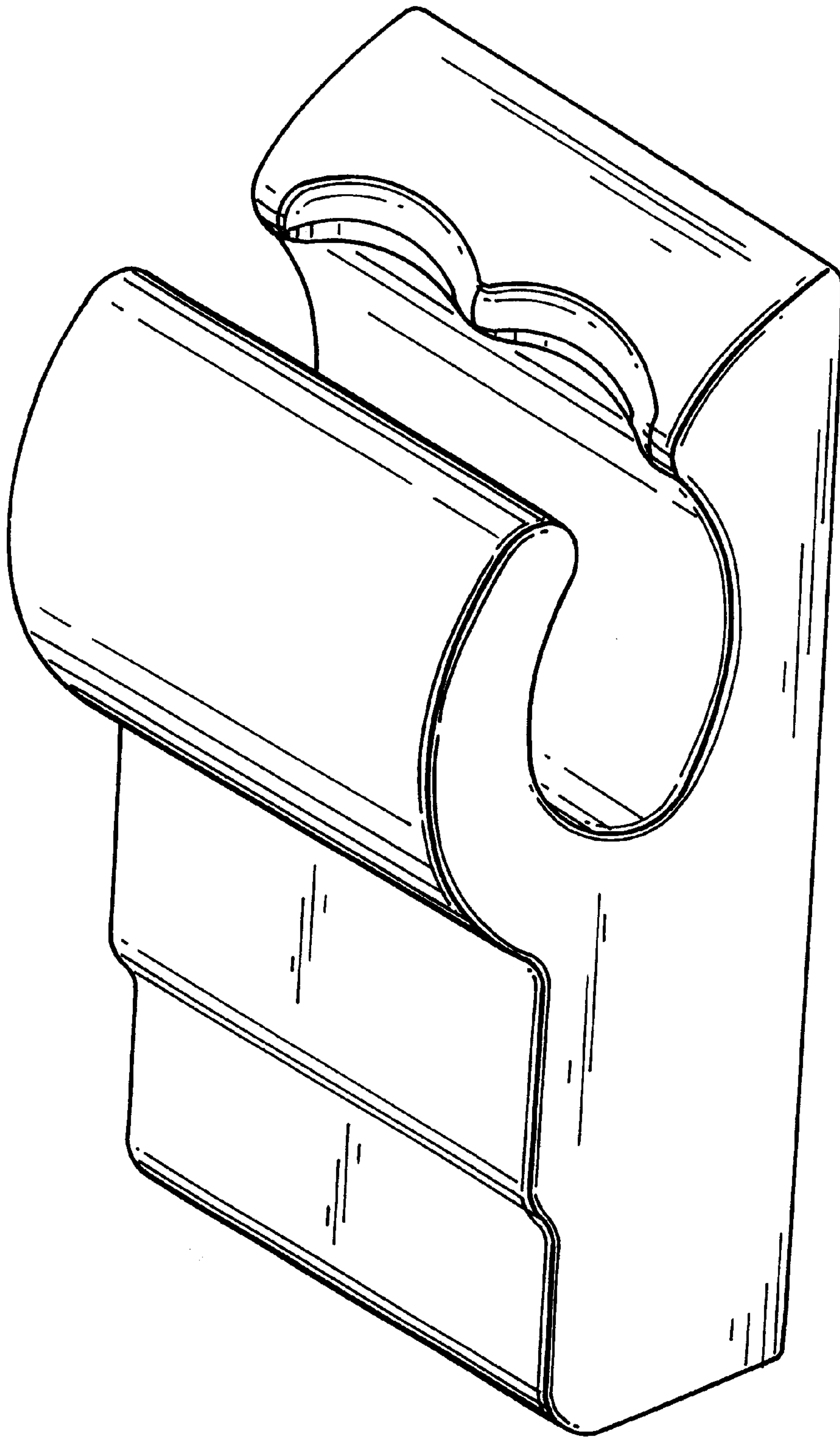

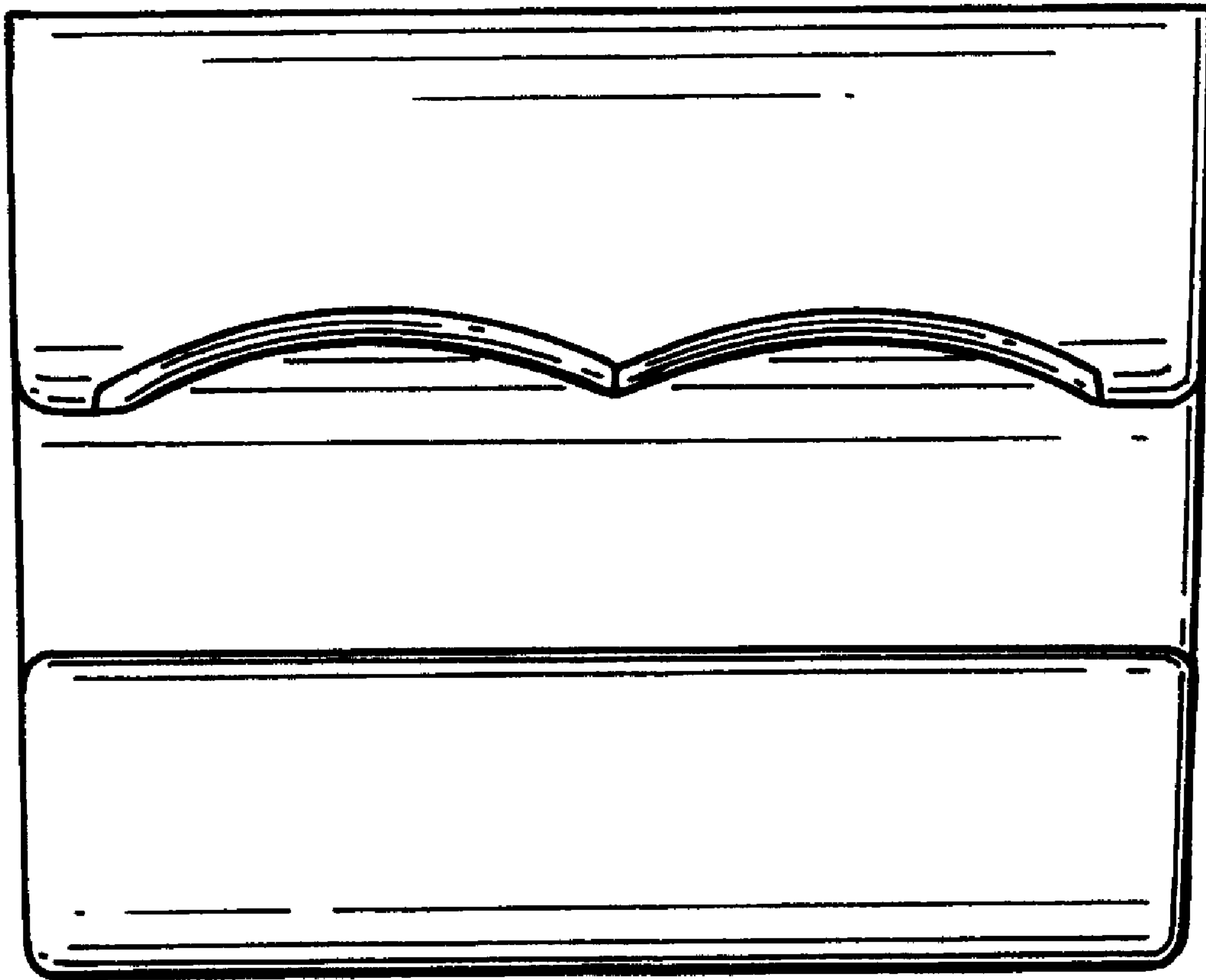

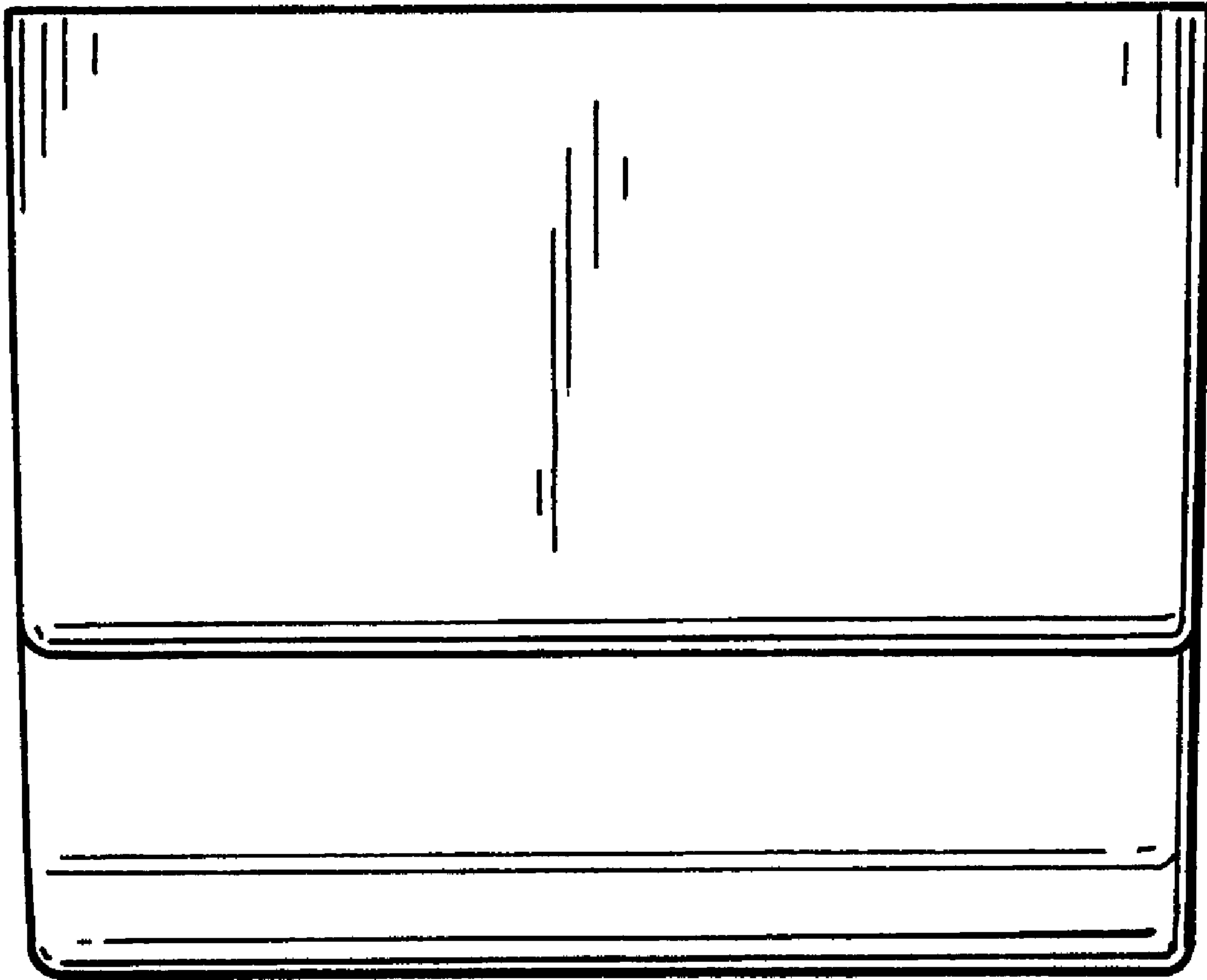

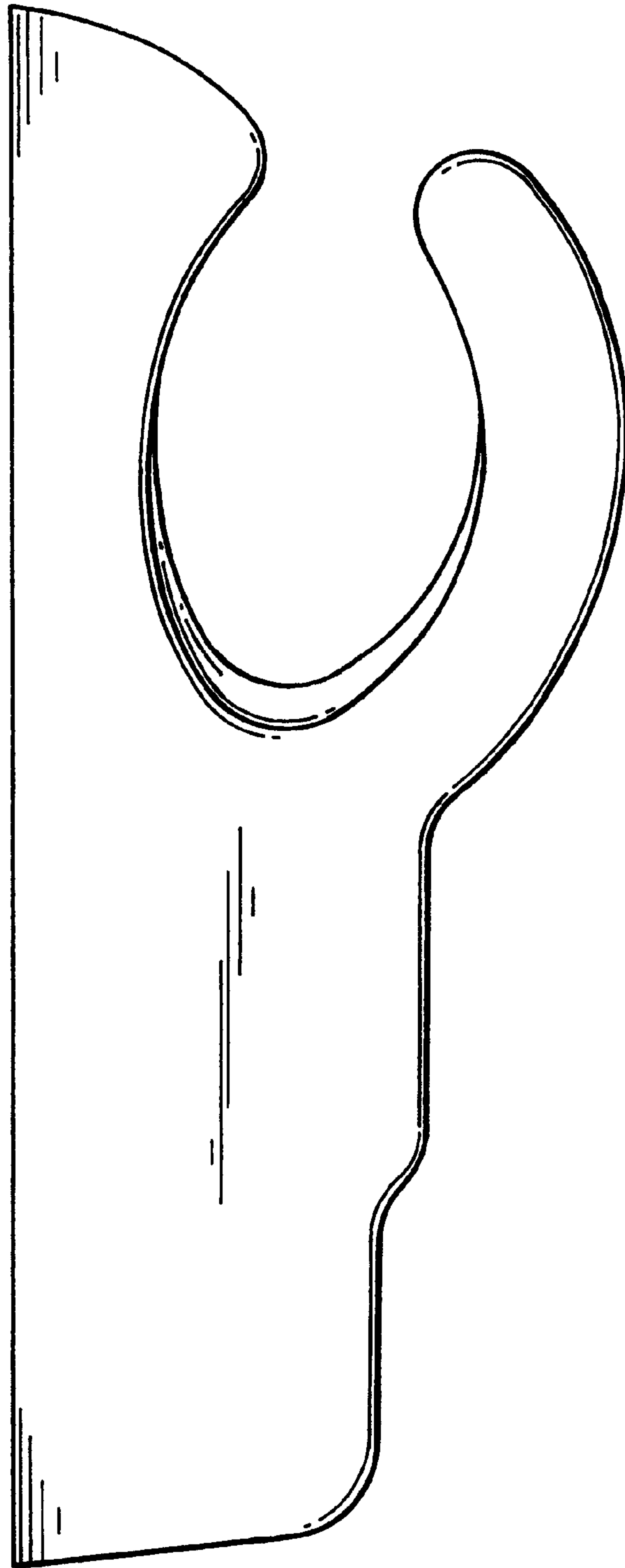

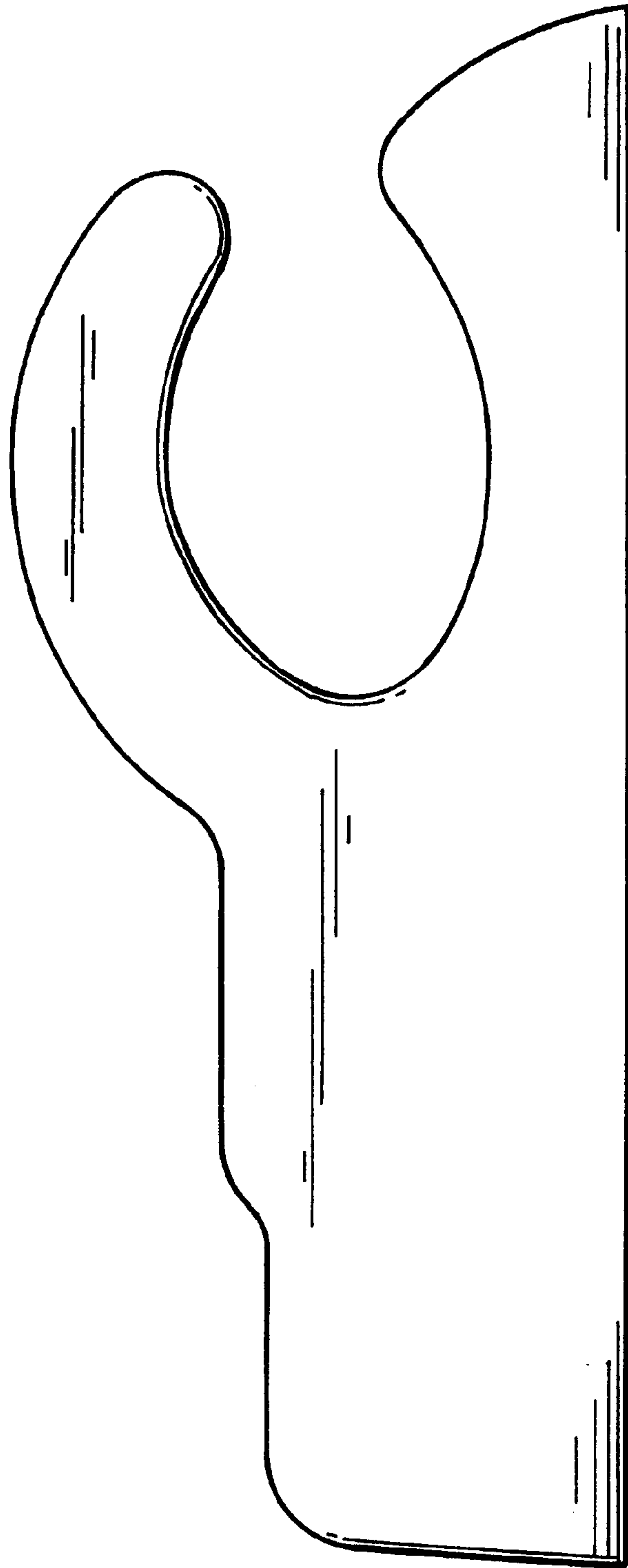

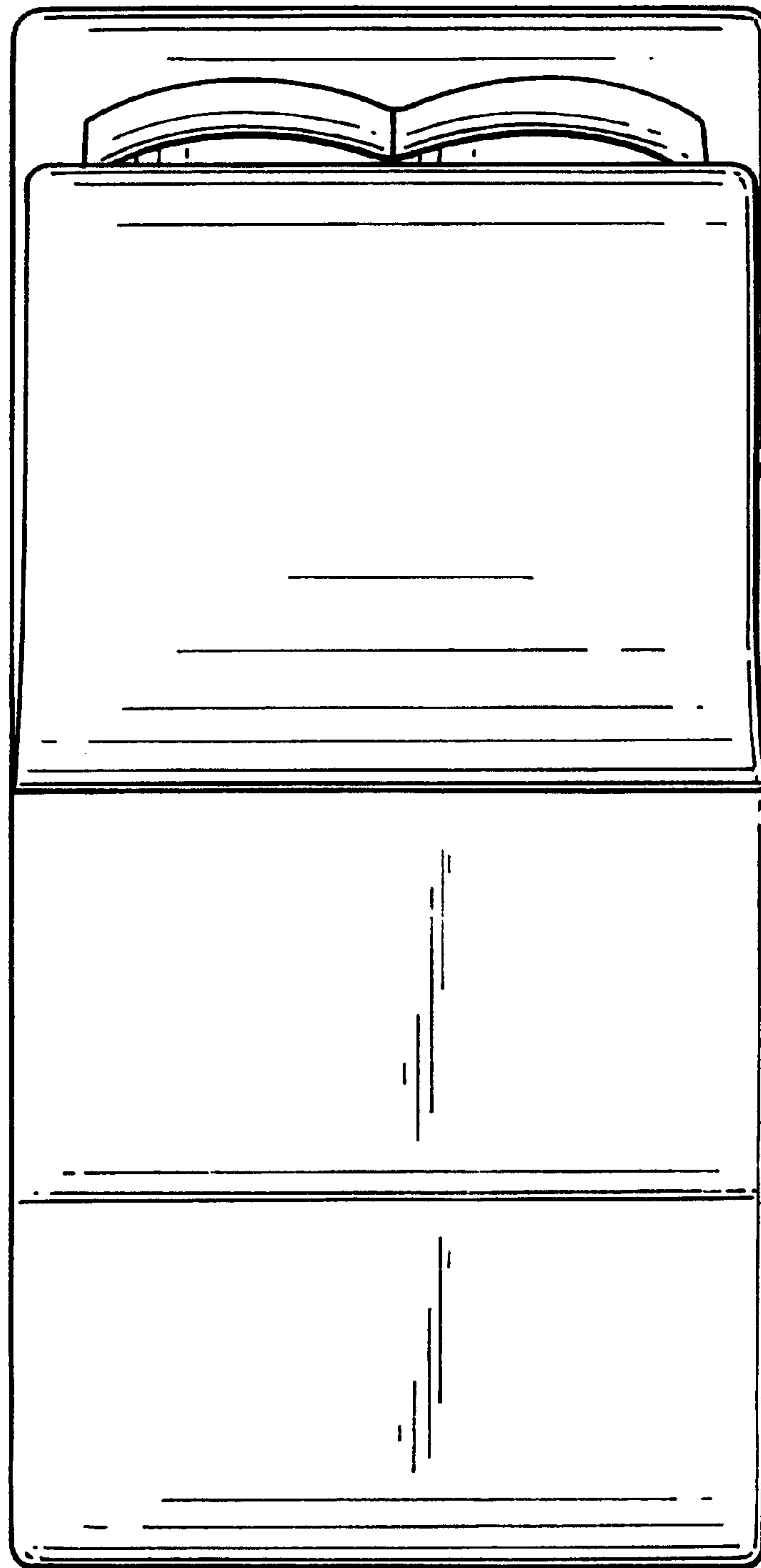

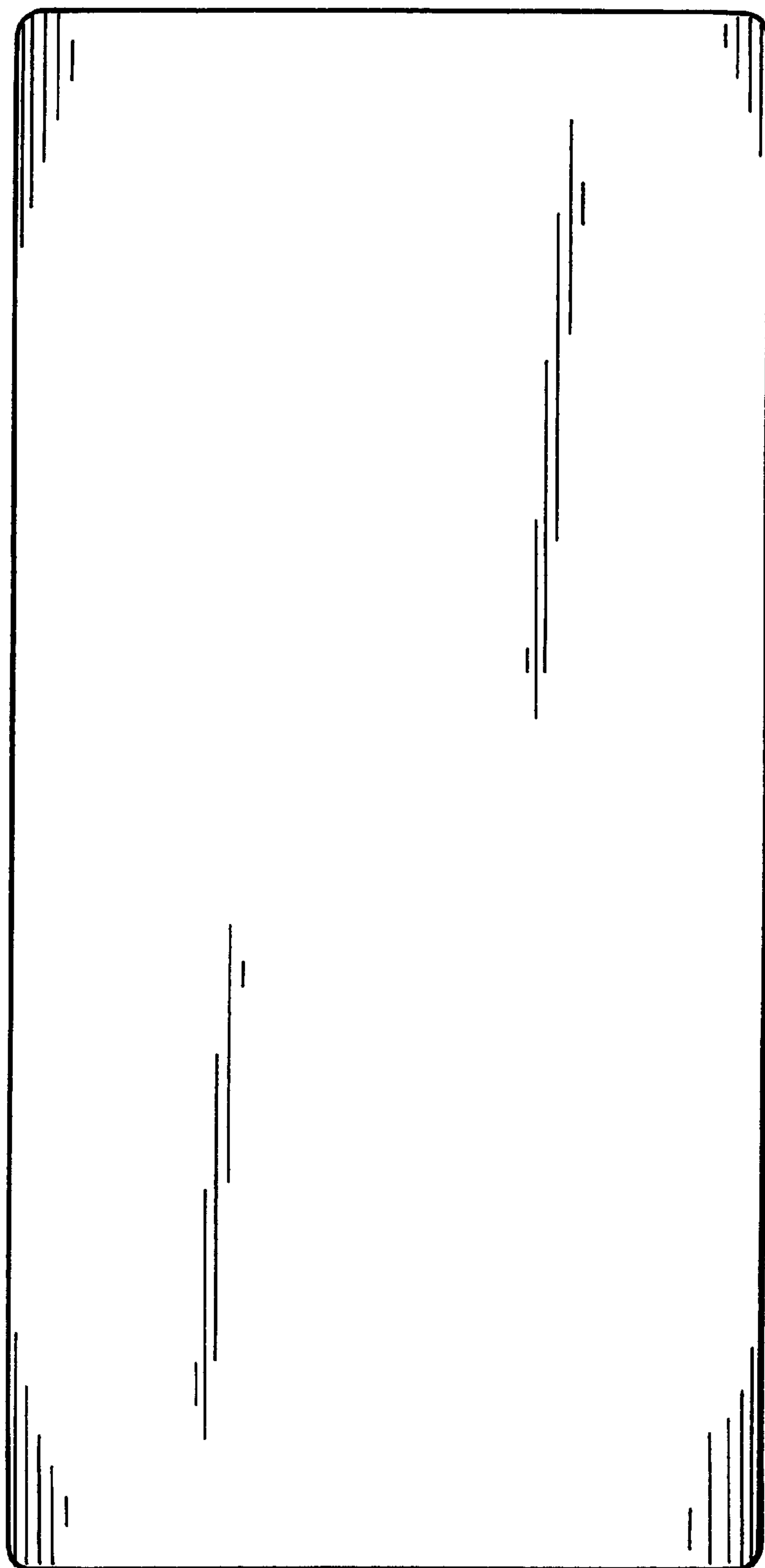
