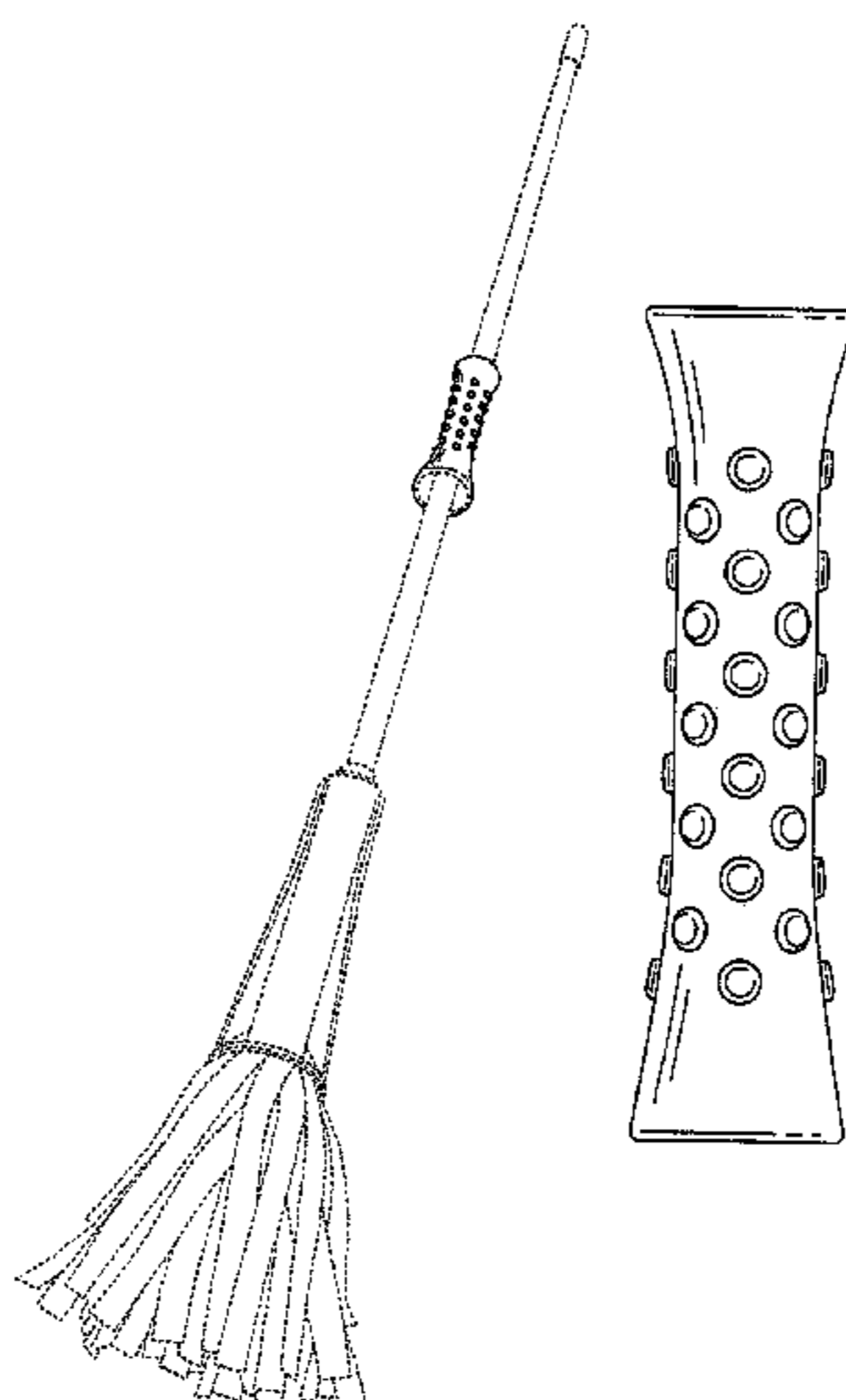
(57) **CLAIM**

An ornamental design for a hand grip for a mop, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mop showing our new design of a hand grip for a mop;
FIG. 2 is an enlarged side elevation view of the hand grip for a mop;
FIG. 3 is an enlarged top view thereof; and,
FIG. 4 is an enlarged bottom view thereof.
The broken line showings in FIGS. 1 and 3-4 are for illustrative purposes only and form no part of the claimed design.

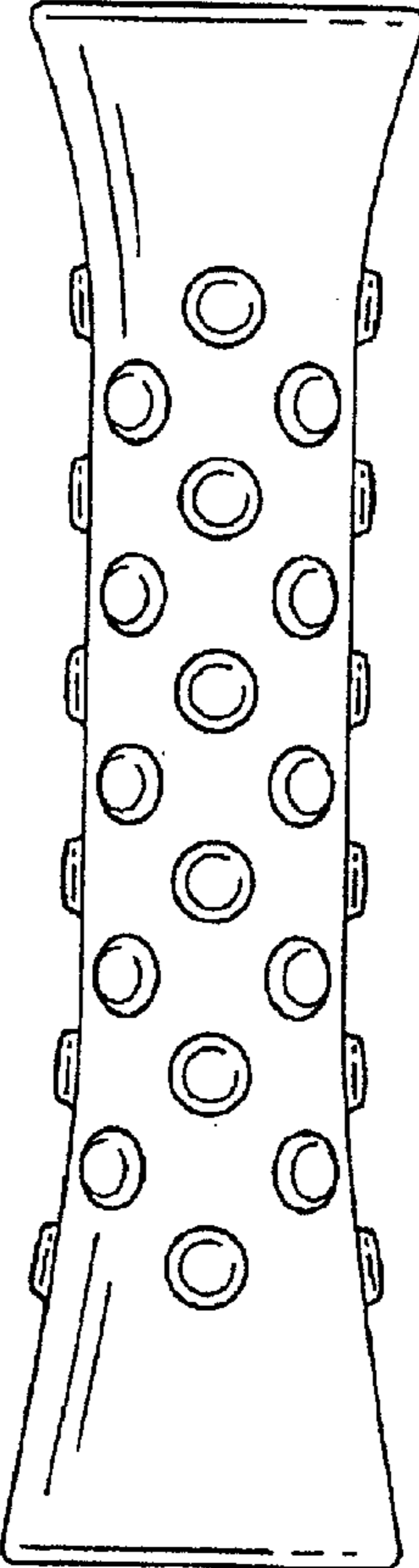
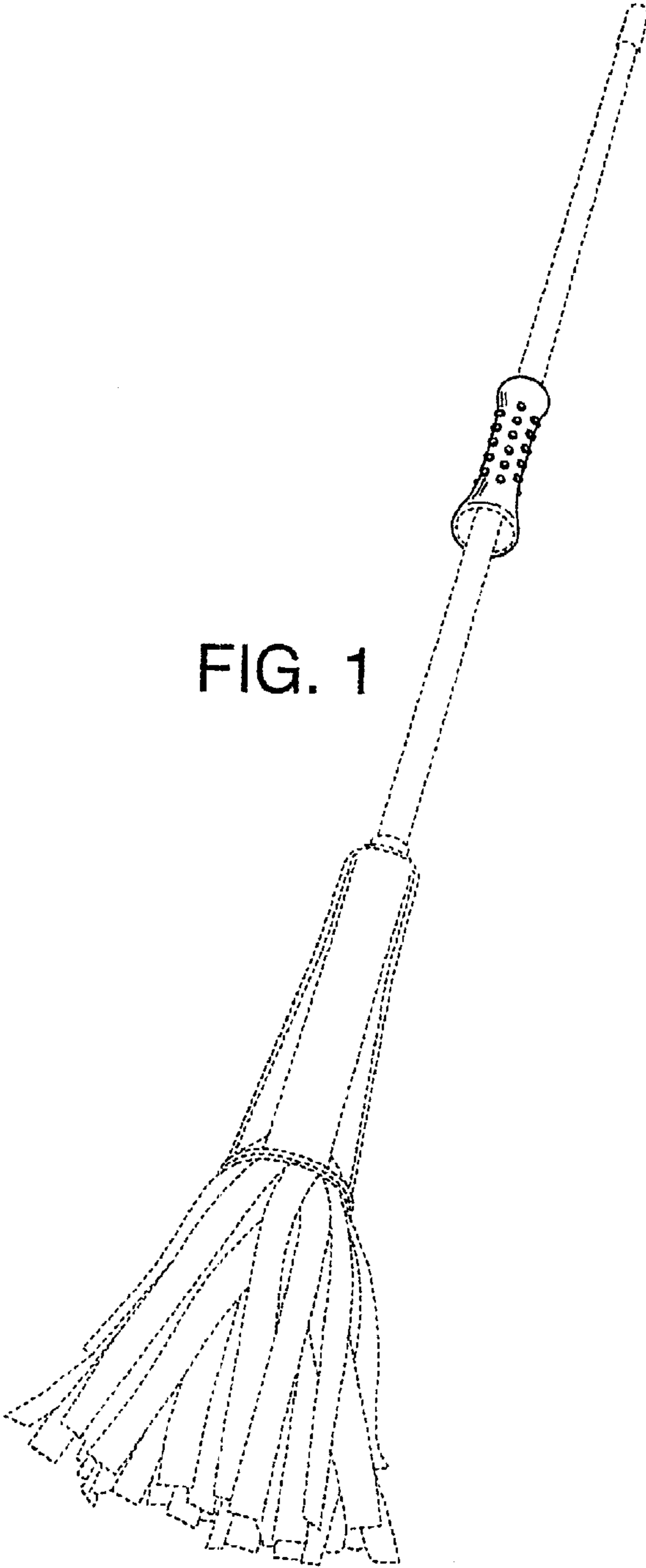

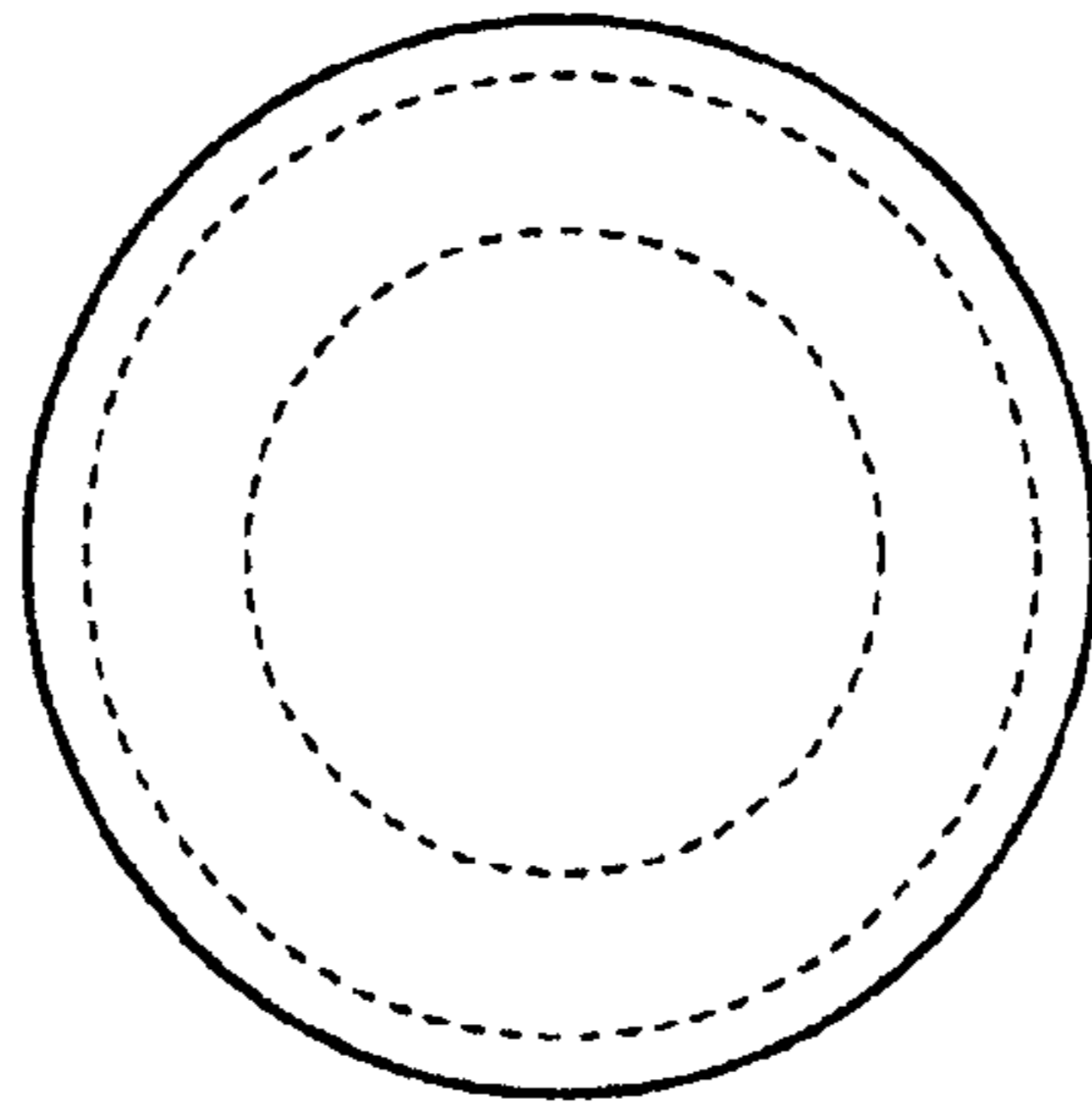

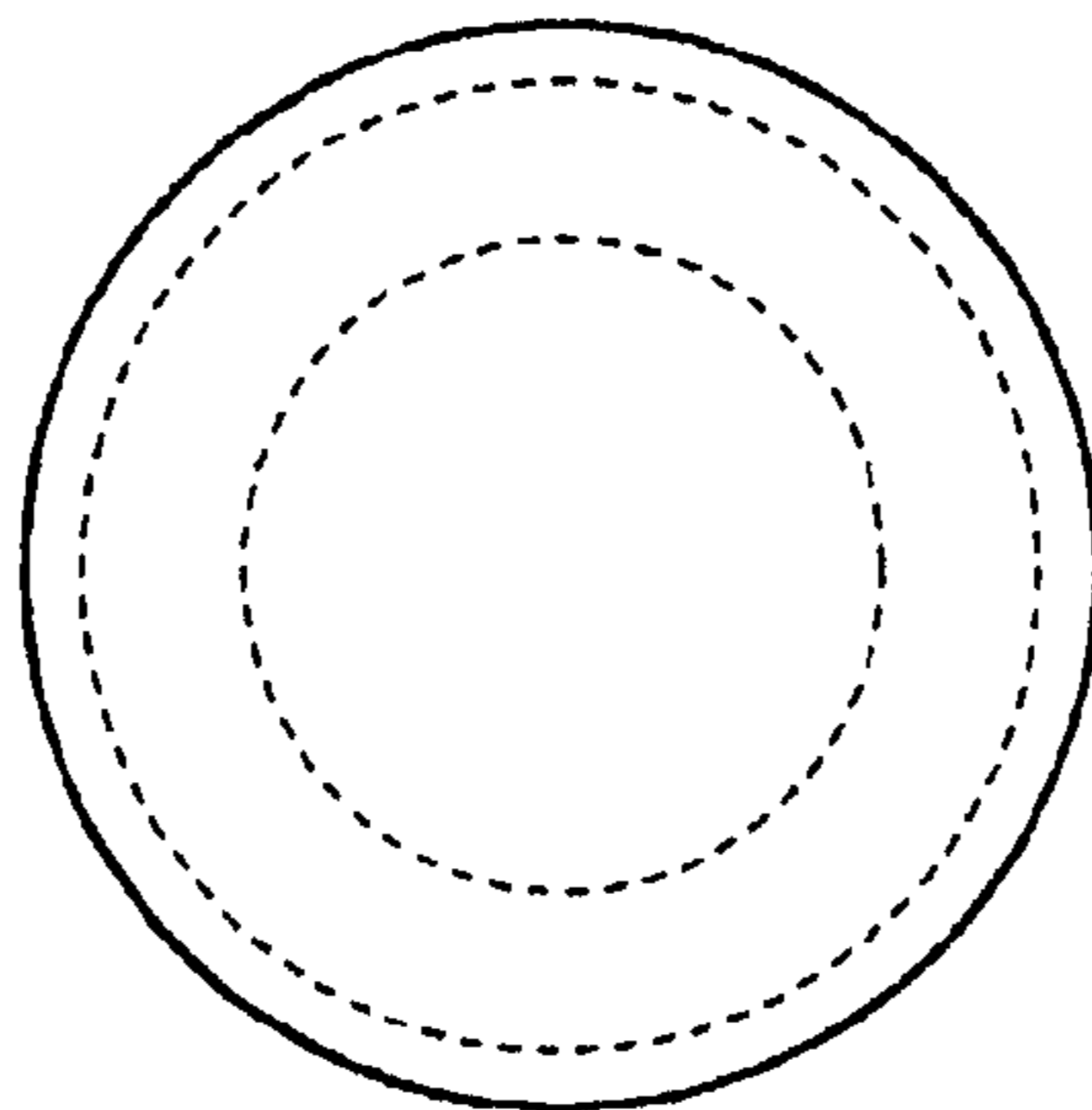
