(57) **CLAIM**

The ornamental design for a down press mop wringer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top frontal perspective view of a first embodiment of a down press mop wringer according to my new design; FIG. 2 is a front view of the down press mop wringer shown in FIG. 1;

FIG. 3 is a back view of the down press mop wringer shown in FIG. 1;

FIG. 4 is a left side view of the down press mop wringer shown in FIG. 1;

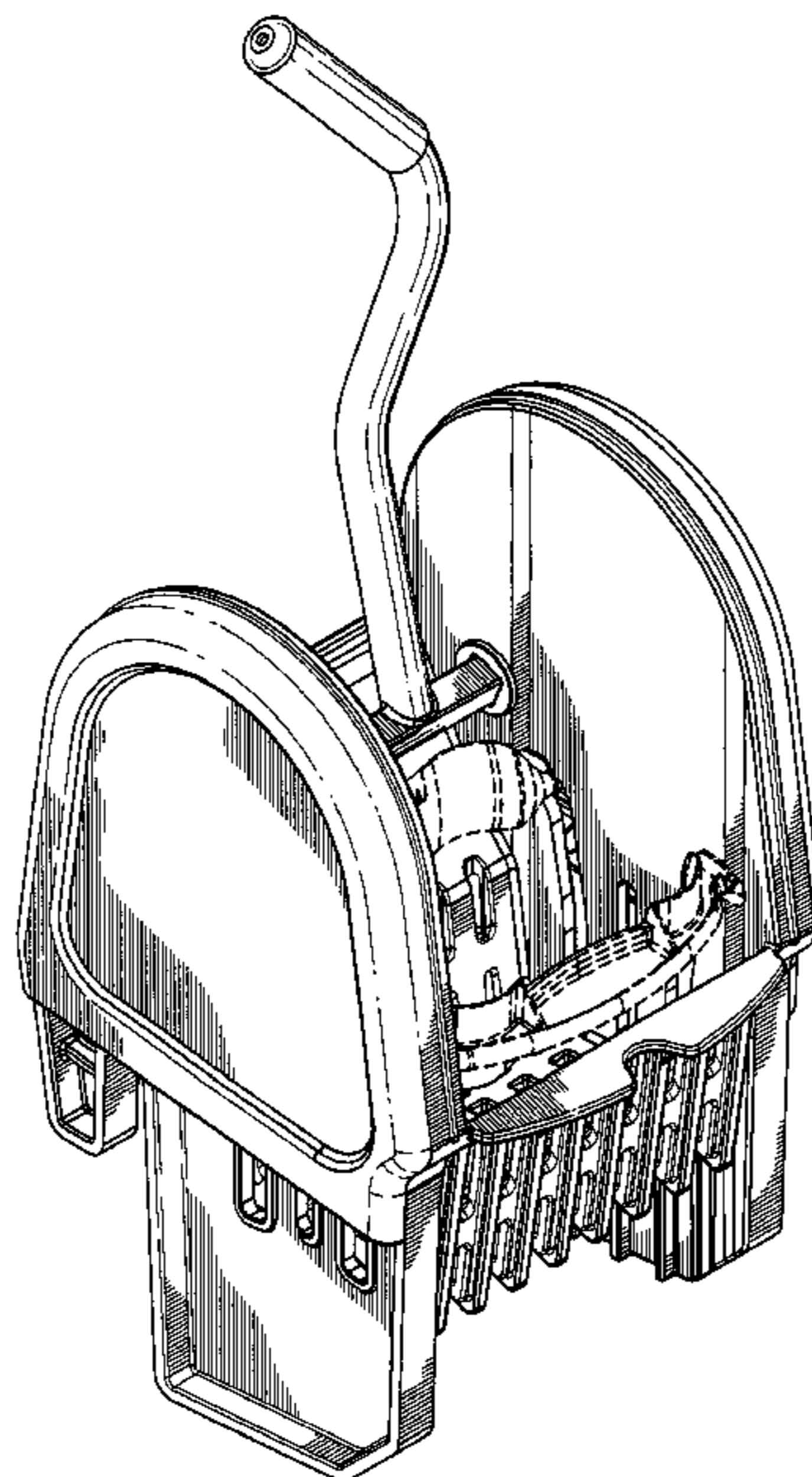
FIG. 5 is a right side view of the down press mop wringer shown in FIG. 1;

FIG. 6 is a top view of the down press mop wringer shown in FIG. 1; and,

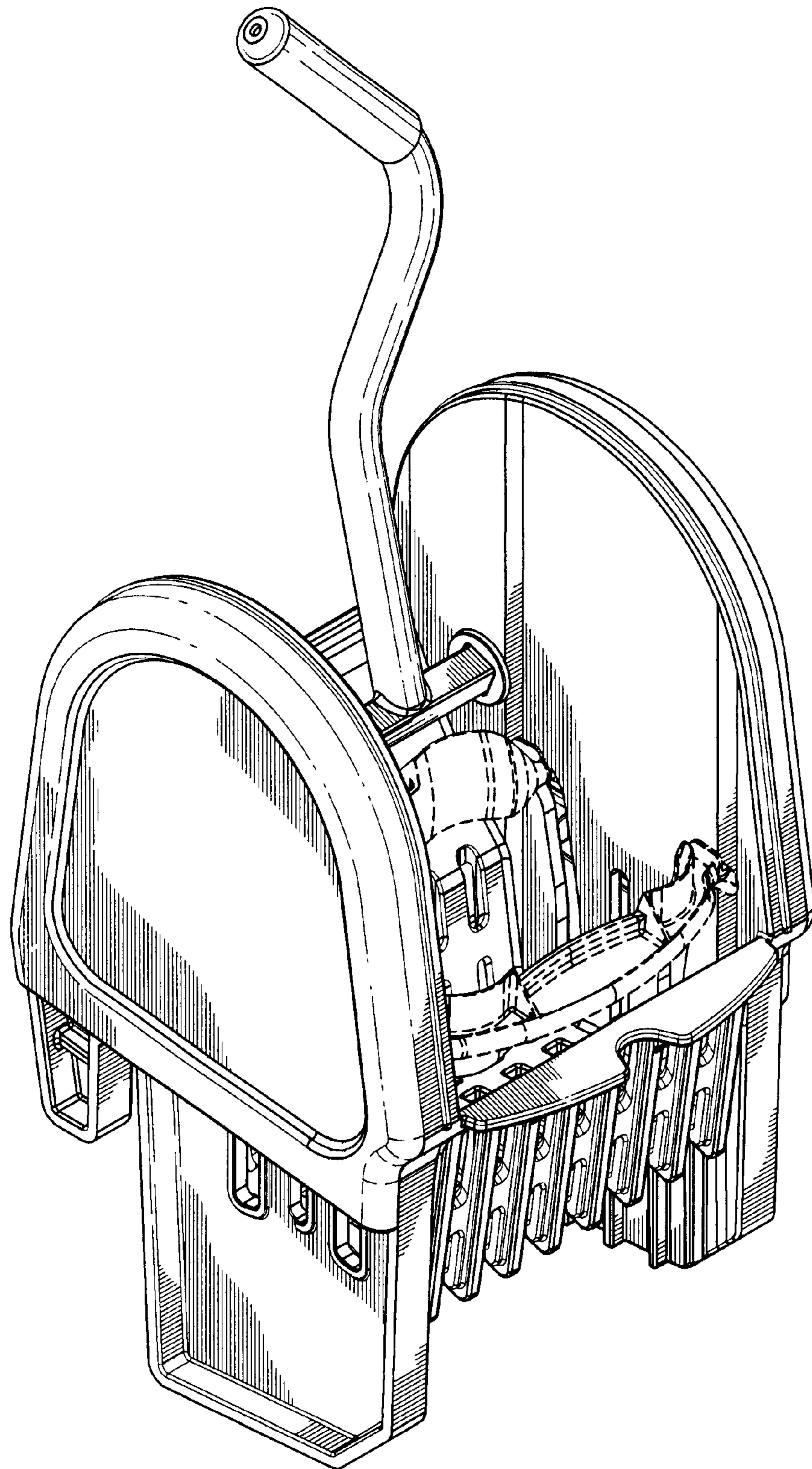

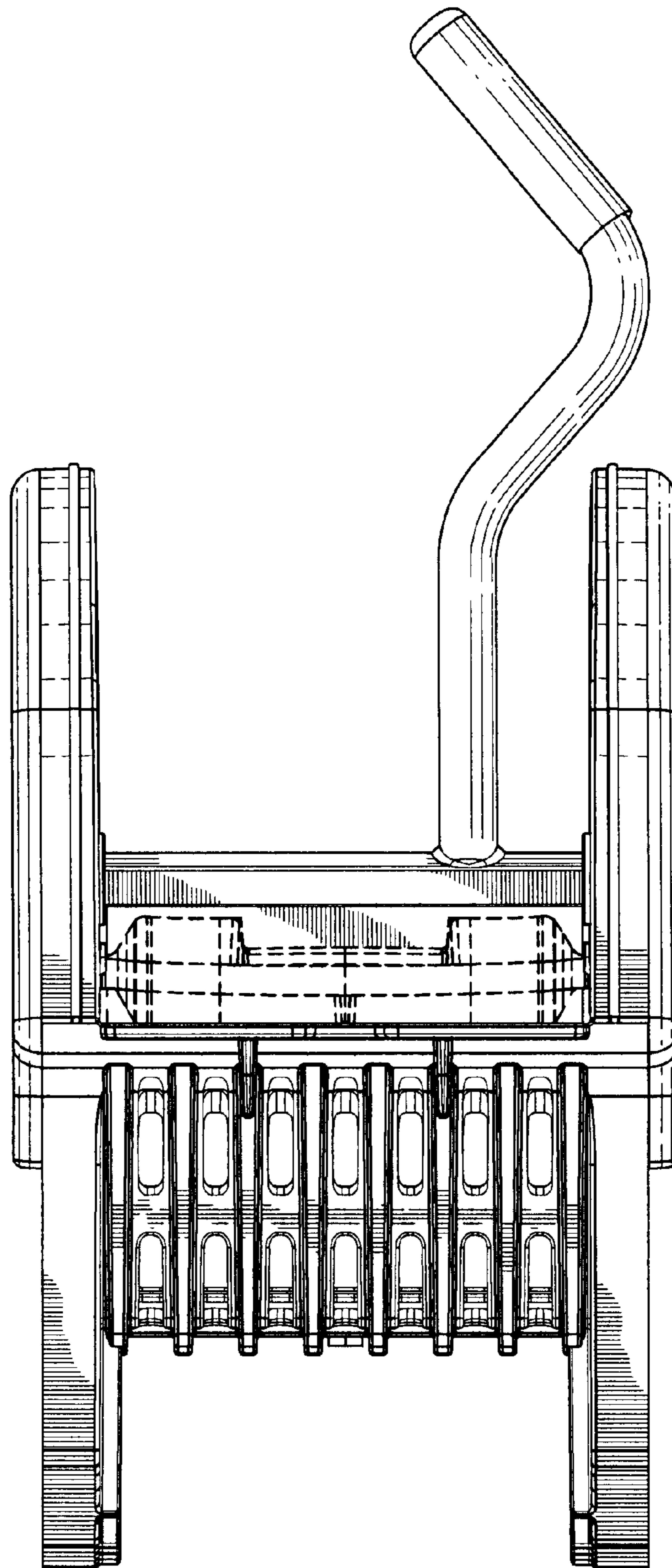

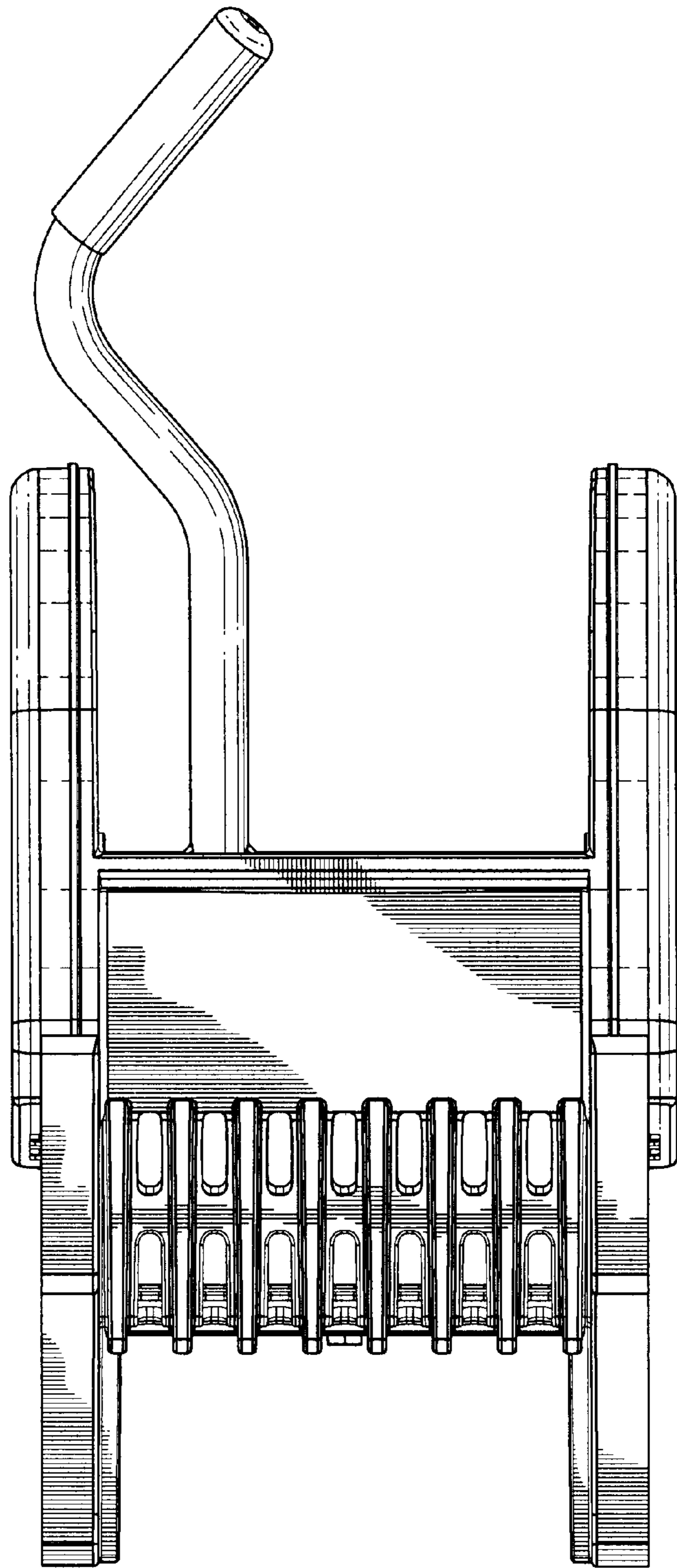

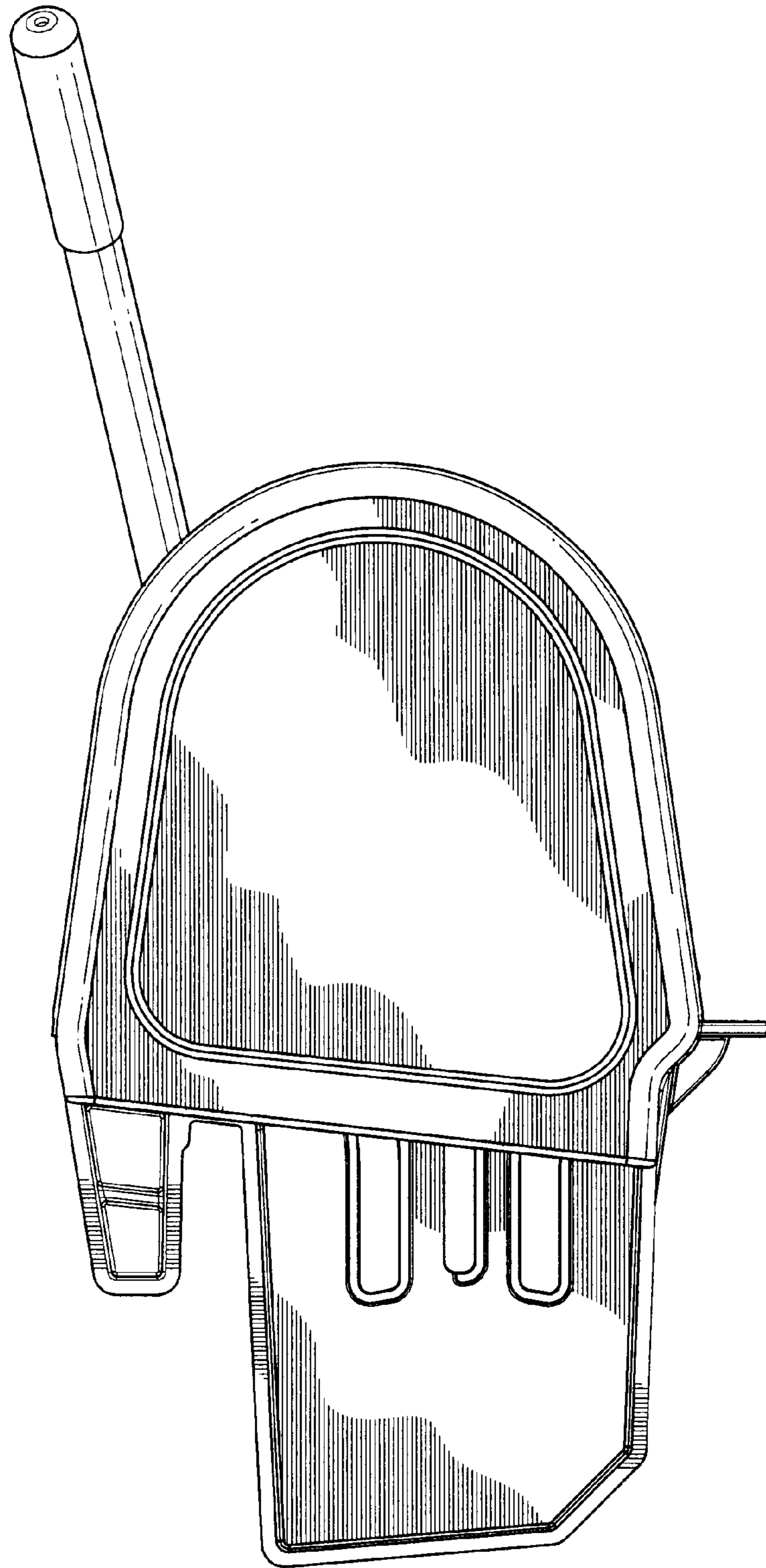

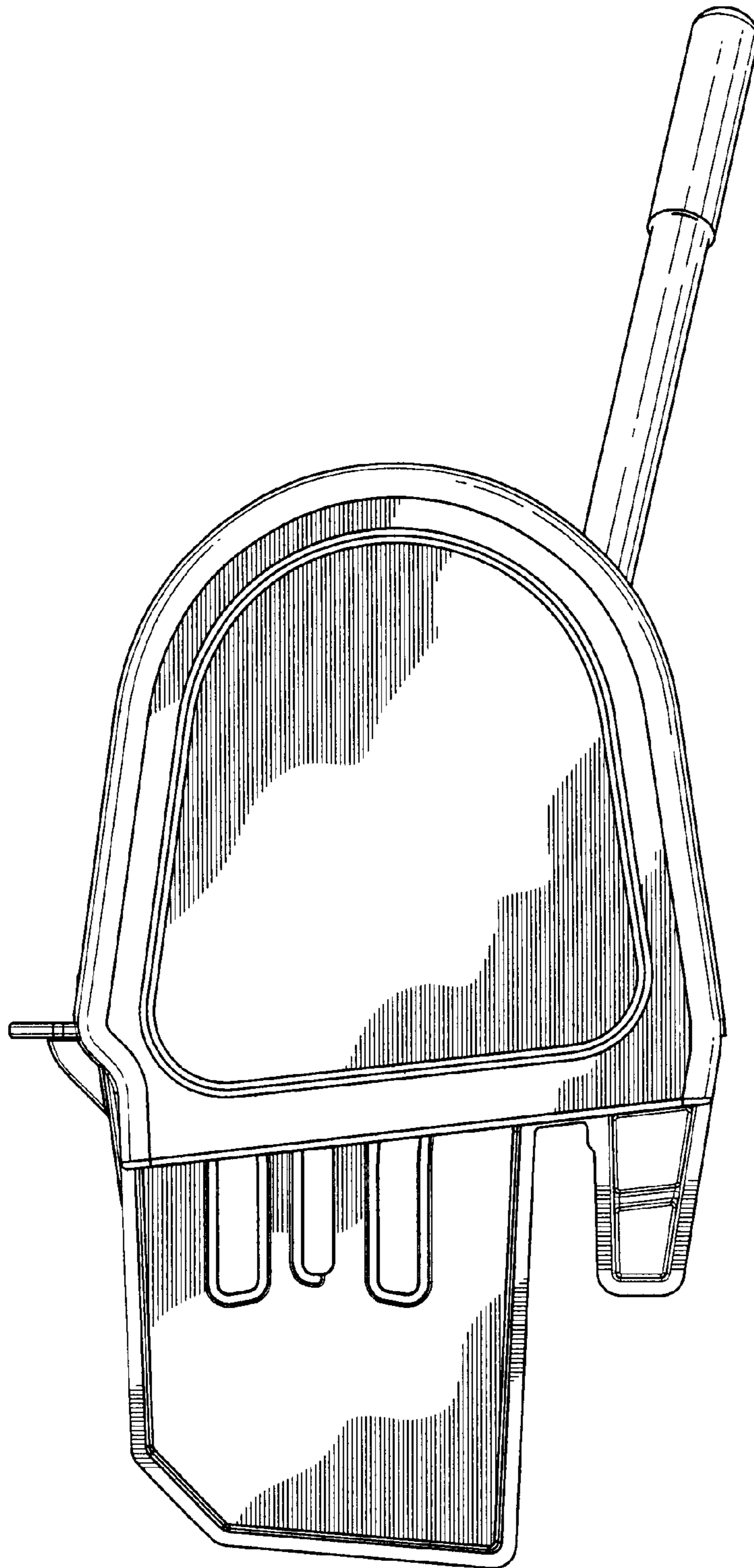

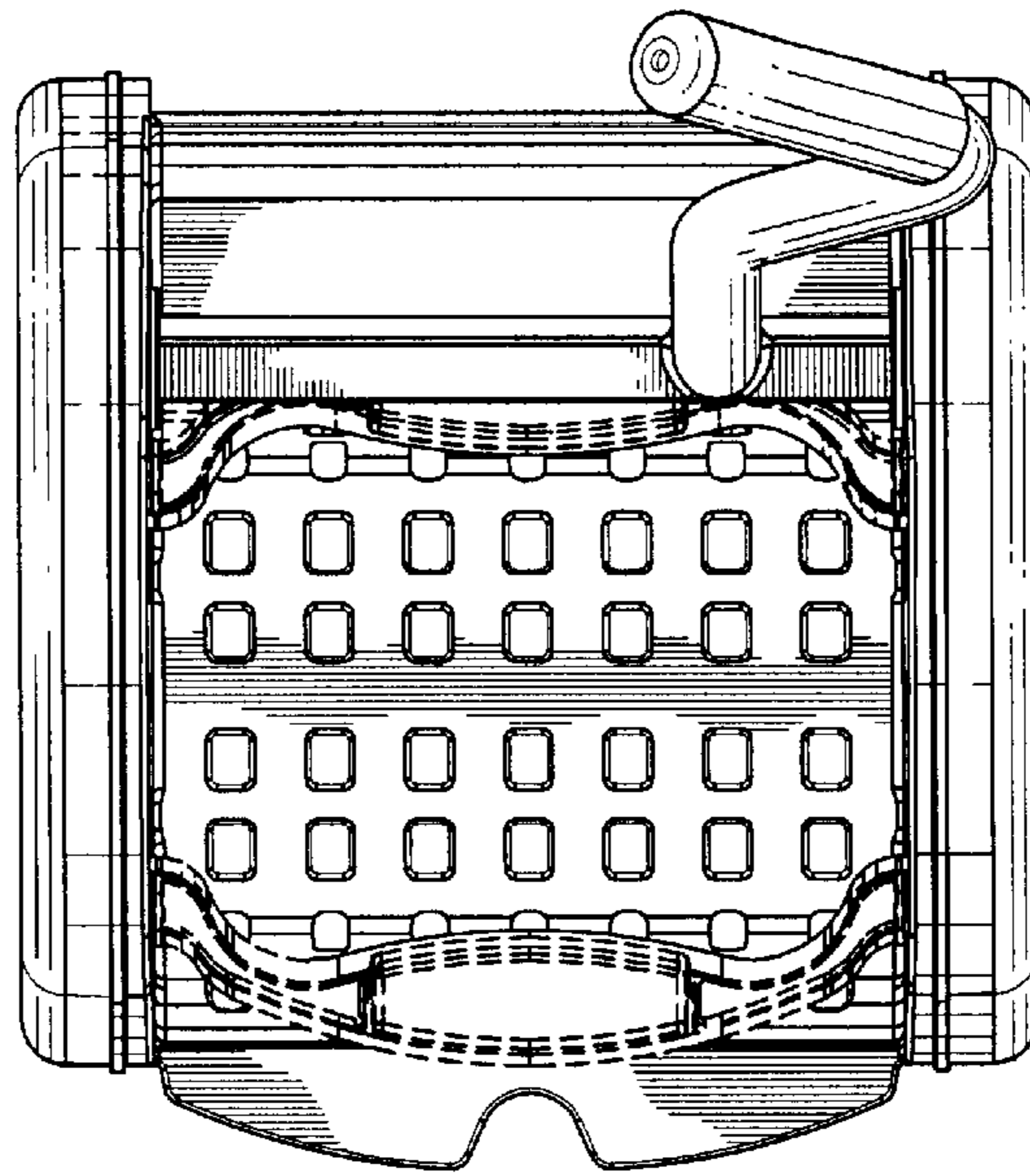

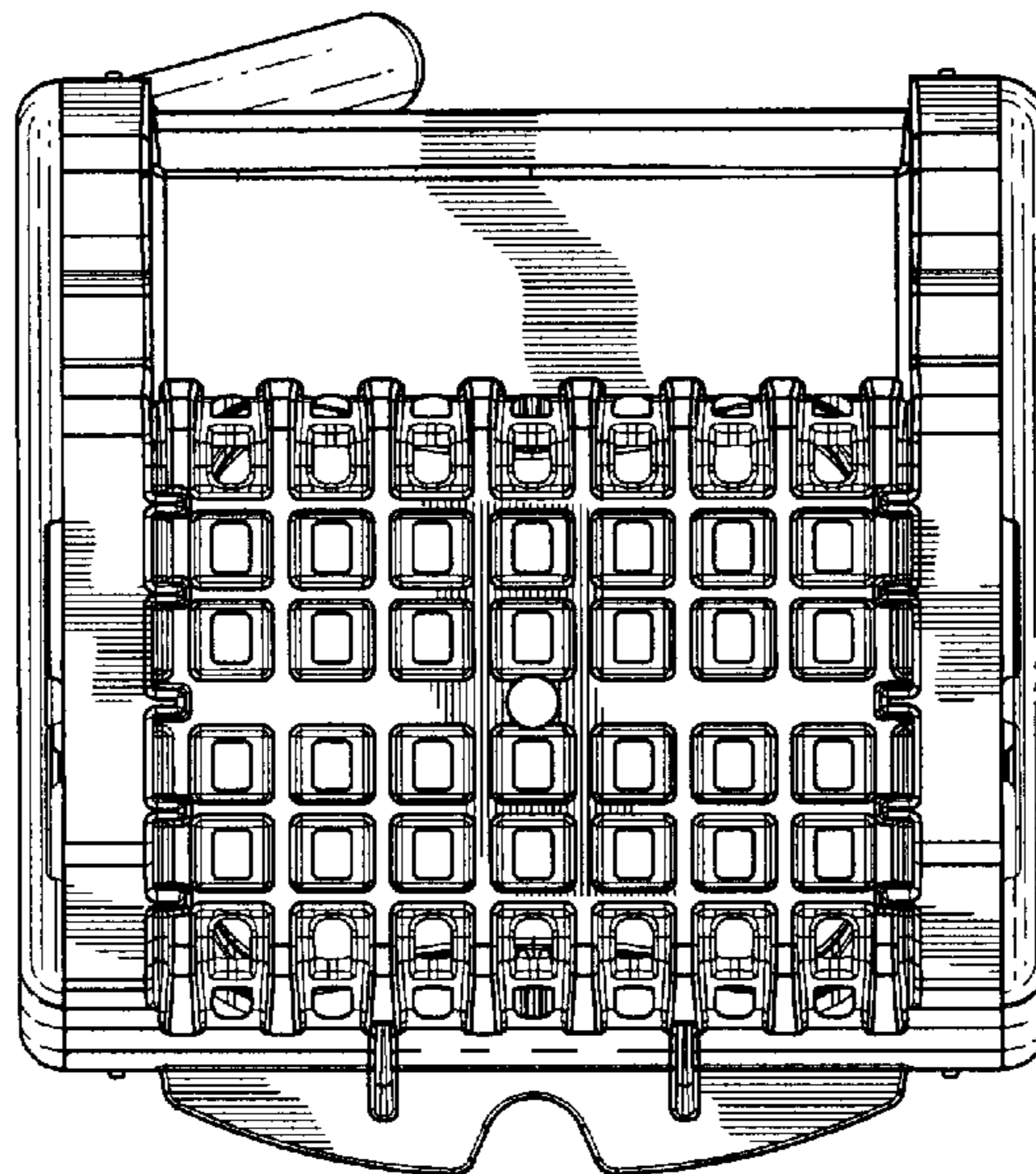
