(57) **CLAIM**

The ornamental design for breathable covering nursing blanket, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a breathable covering nursing blanket showing our new design; FIG. 2 is a back side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a top plan view thereof with the breathable covering nursing blanket spread out on a flat surface; and, FIG. 6 is a bottom plan view thereof with the breathable covering nursing blanket spread out on a flat surface. The broken lines in FIGS. 1, 2, 3, and 4 are for illustrative purposes only and form no part of the claimed design. The dashed lines shown directly on the surface of the claimed article, throughout the views, are understood to represent stitching.

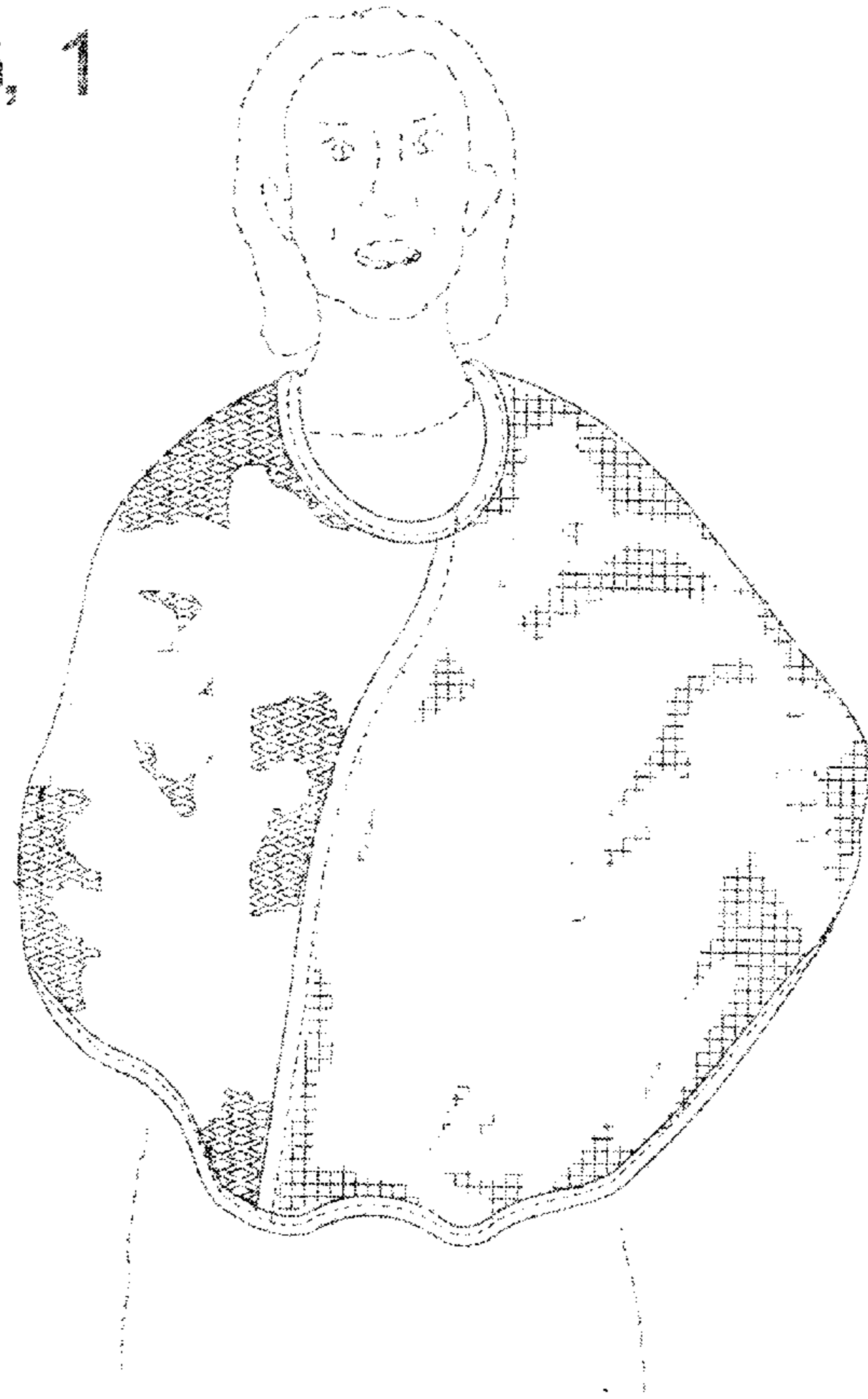

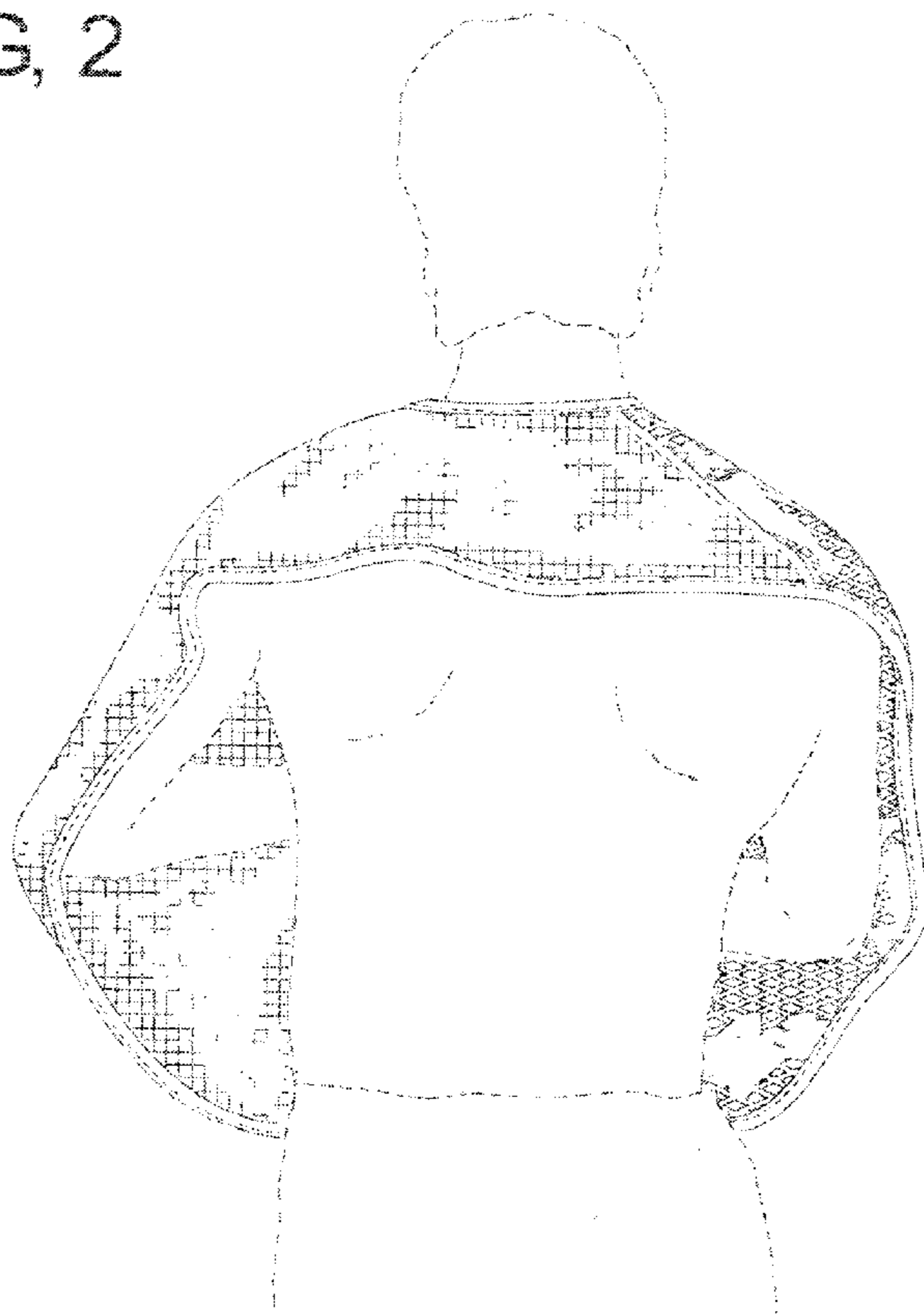

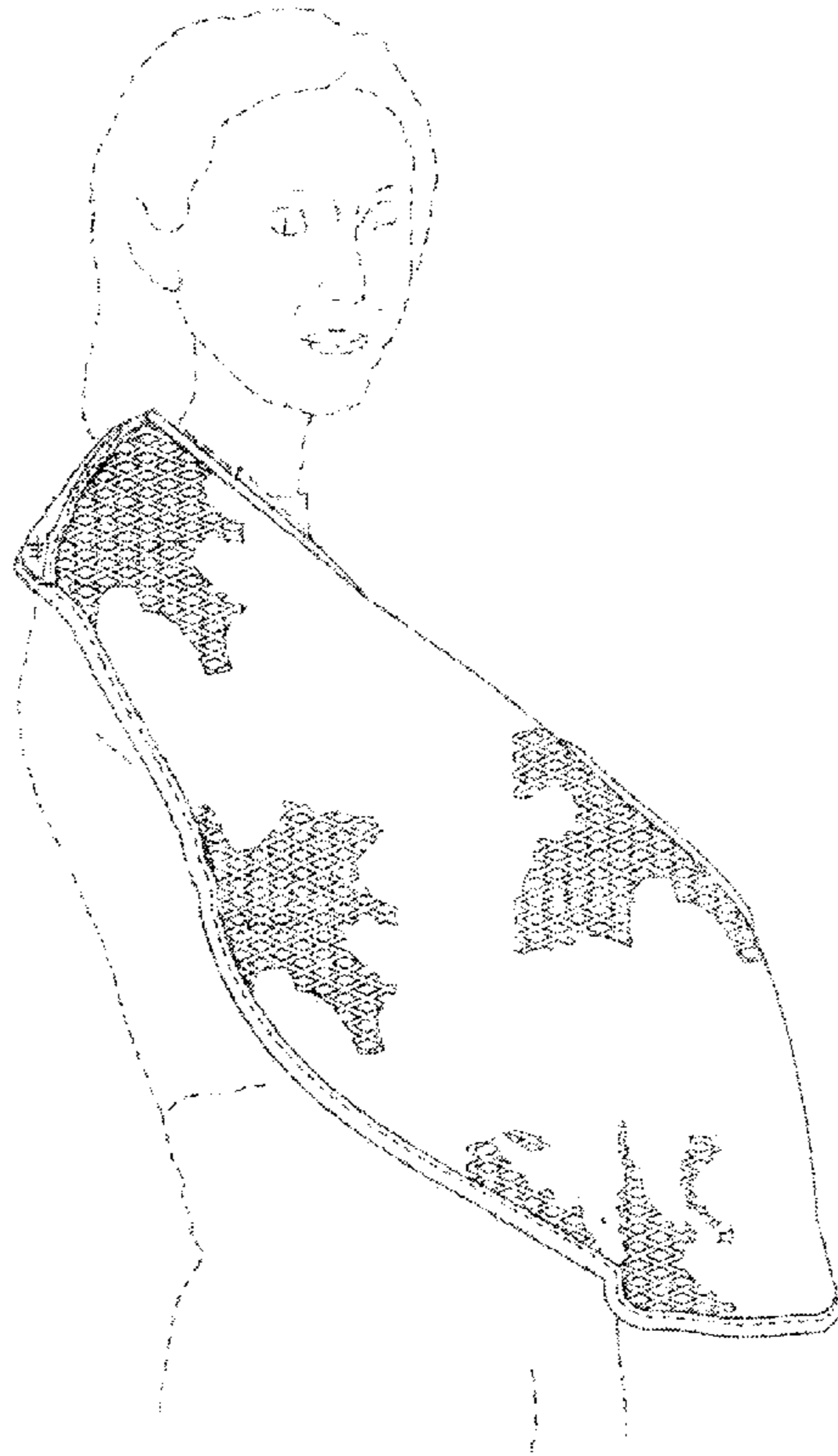

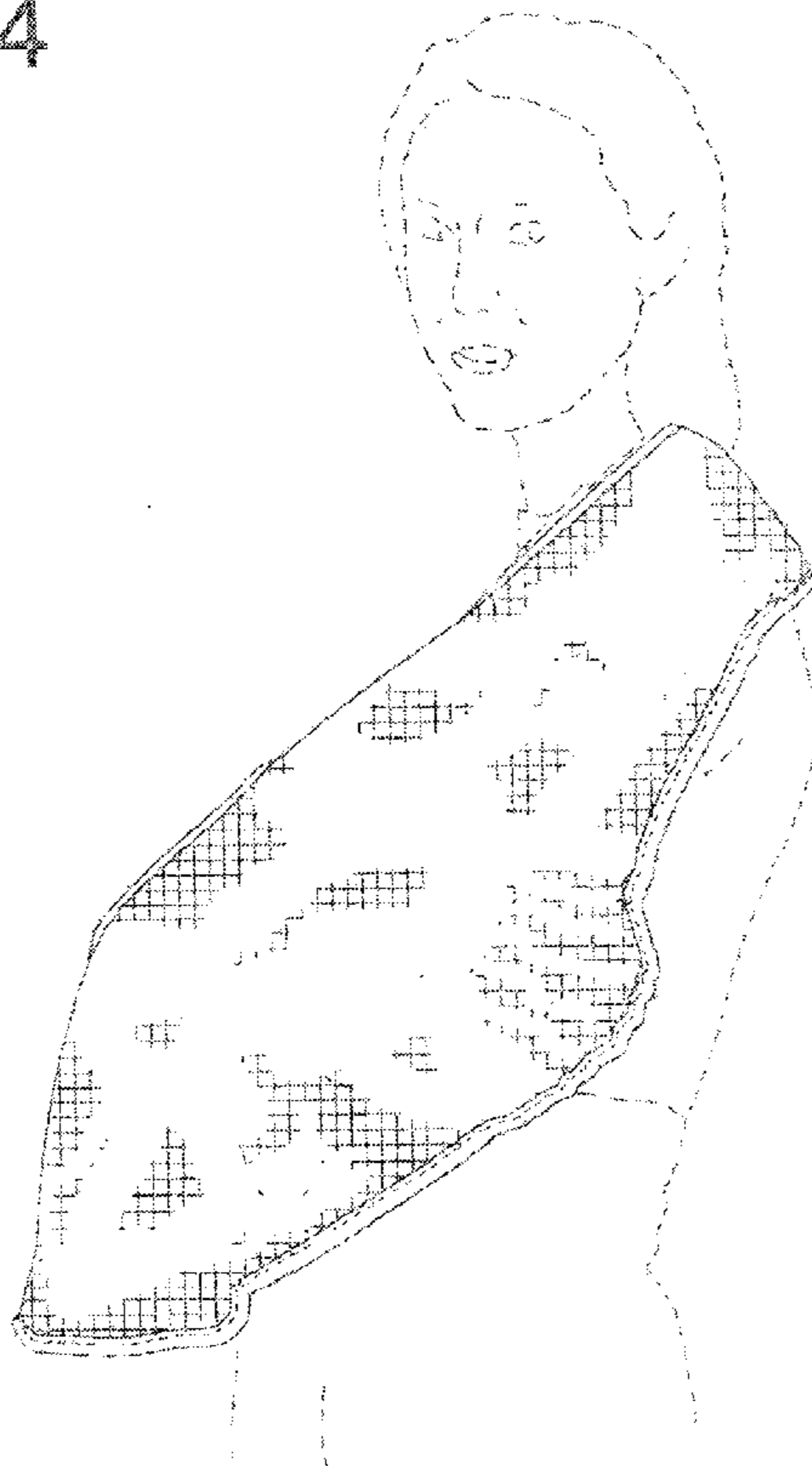

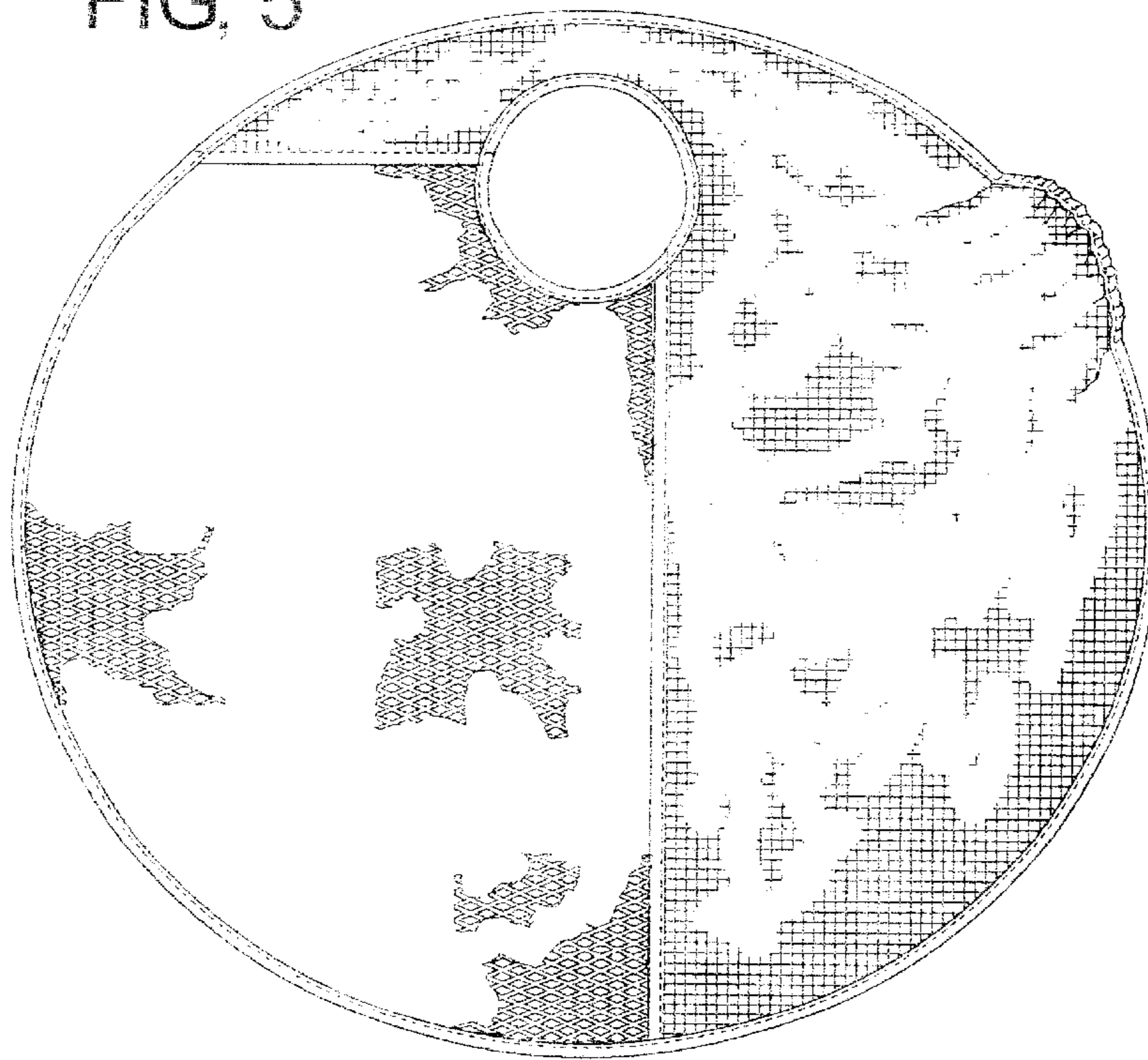
