(57) **CLAIM**

I claim the ornamental design for the shoe midsole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shoe midsole showing my new design, as seen from the front, top and right side, wherein the broken lines do not constitute a part of the claimed design;

FIG. 2 is a perspective view of the shoe midsole of this invention as seen from the rear, bottom and left side;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a top plan view thereof;

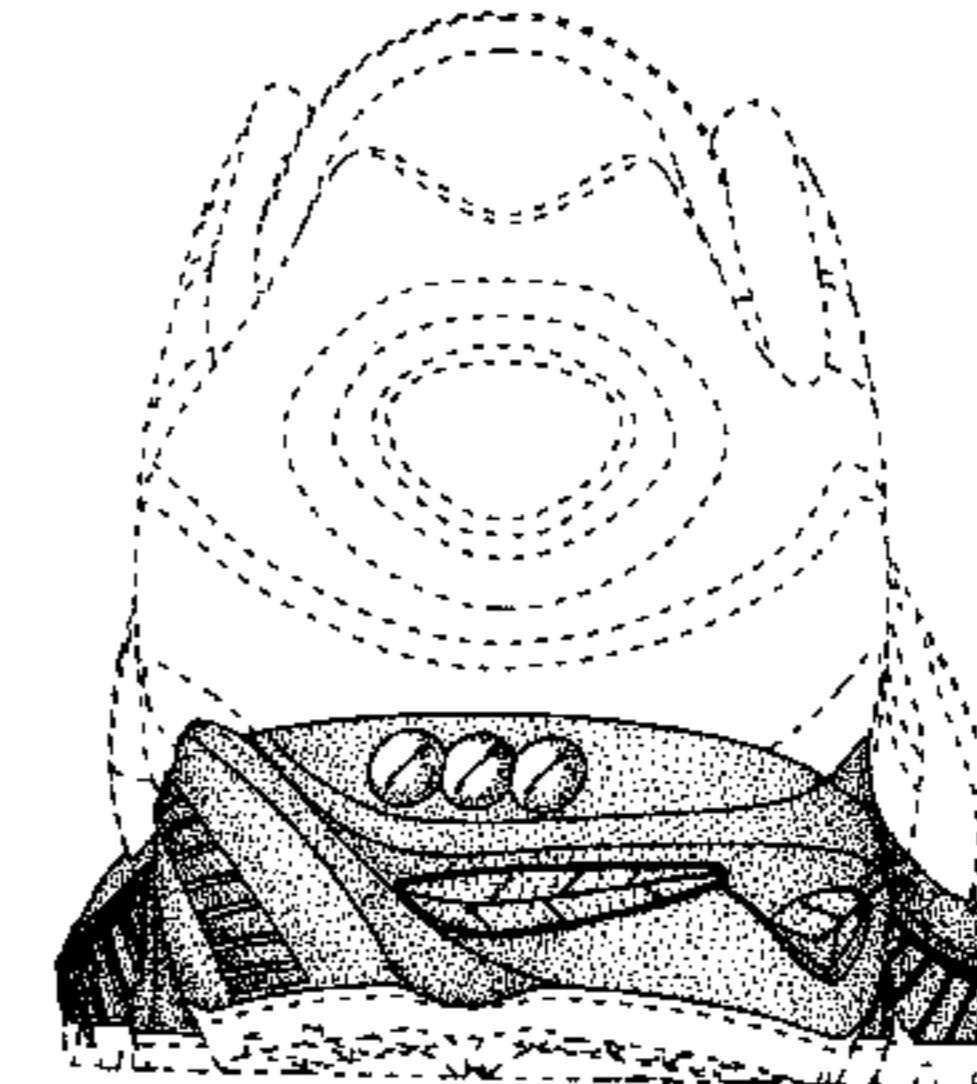
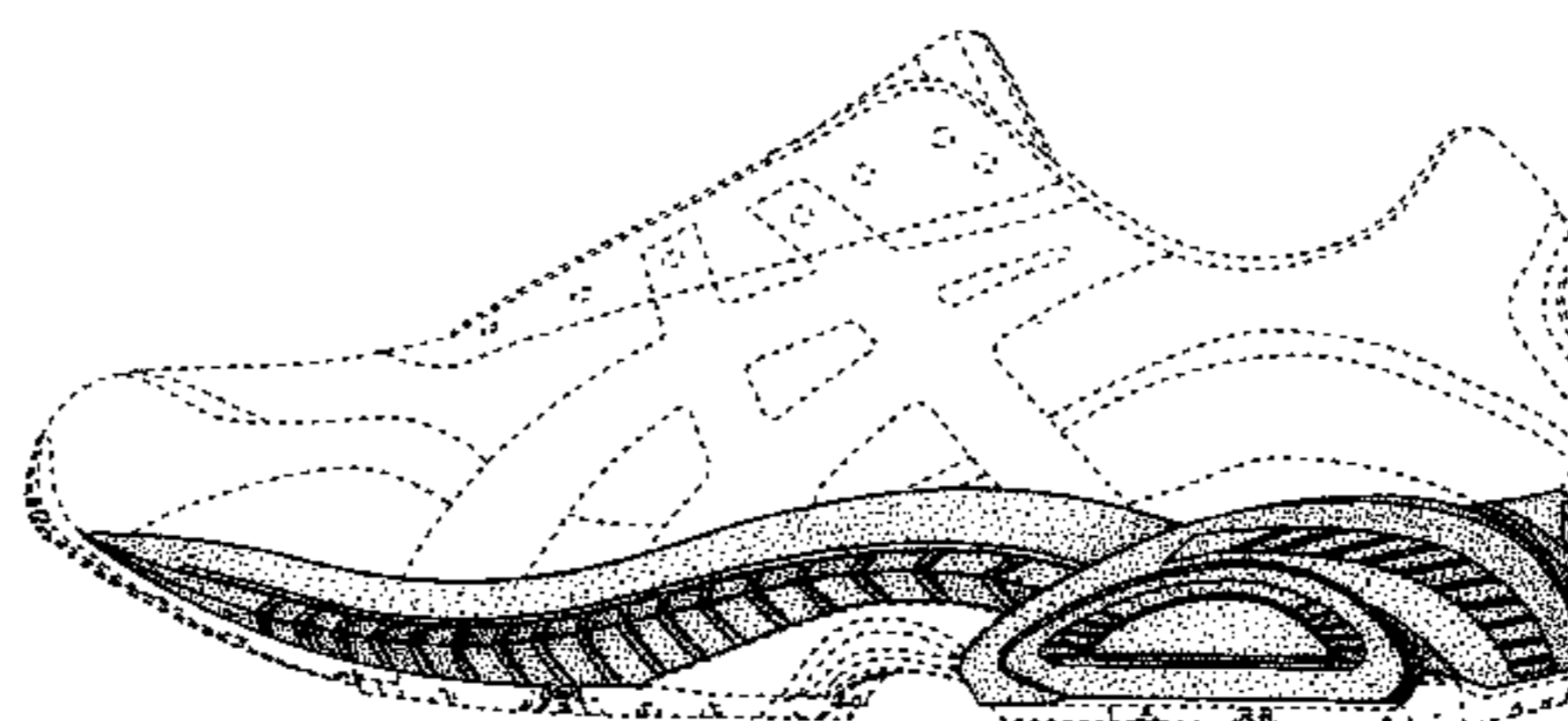
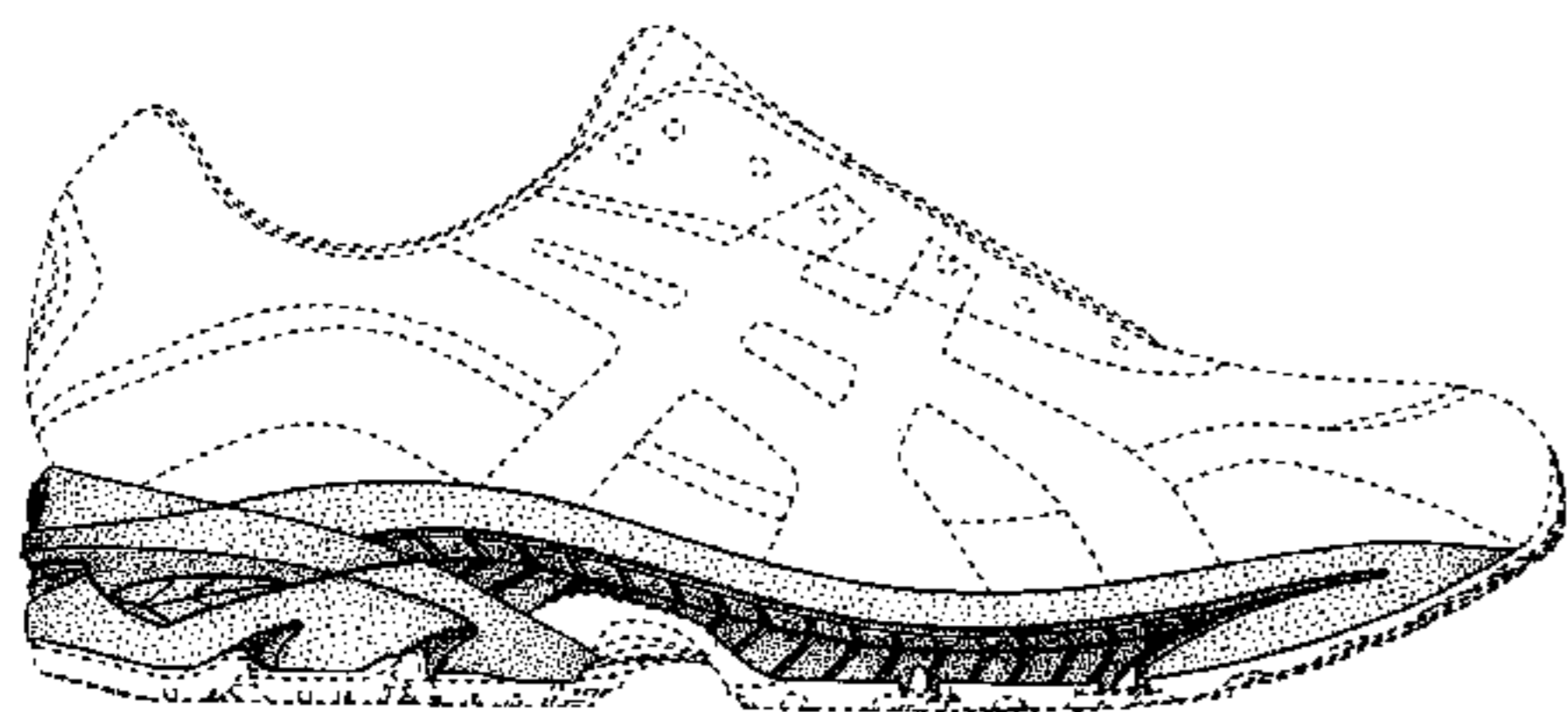
FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front elevational view thereof; and,

FIG. 8 is a rear elevational view thereof.

The shoe midsole for the other foot is the mirror image of the embodiment shown.

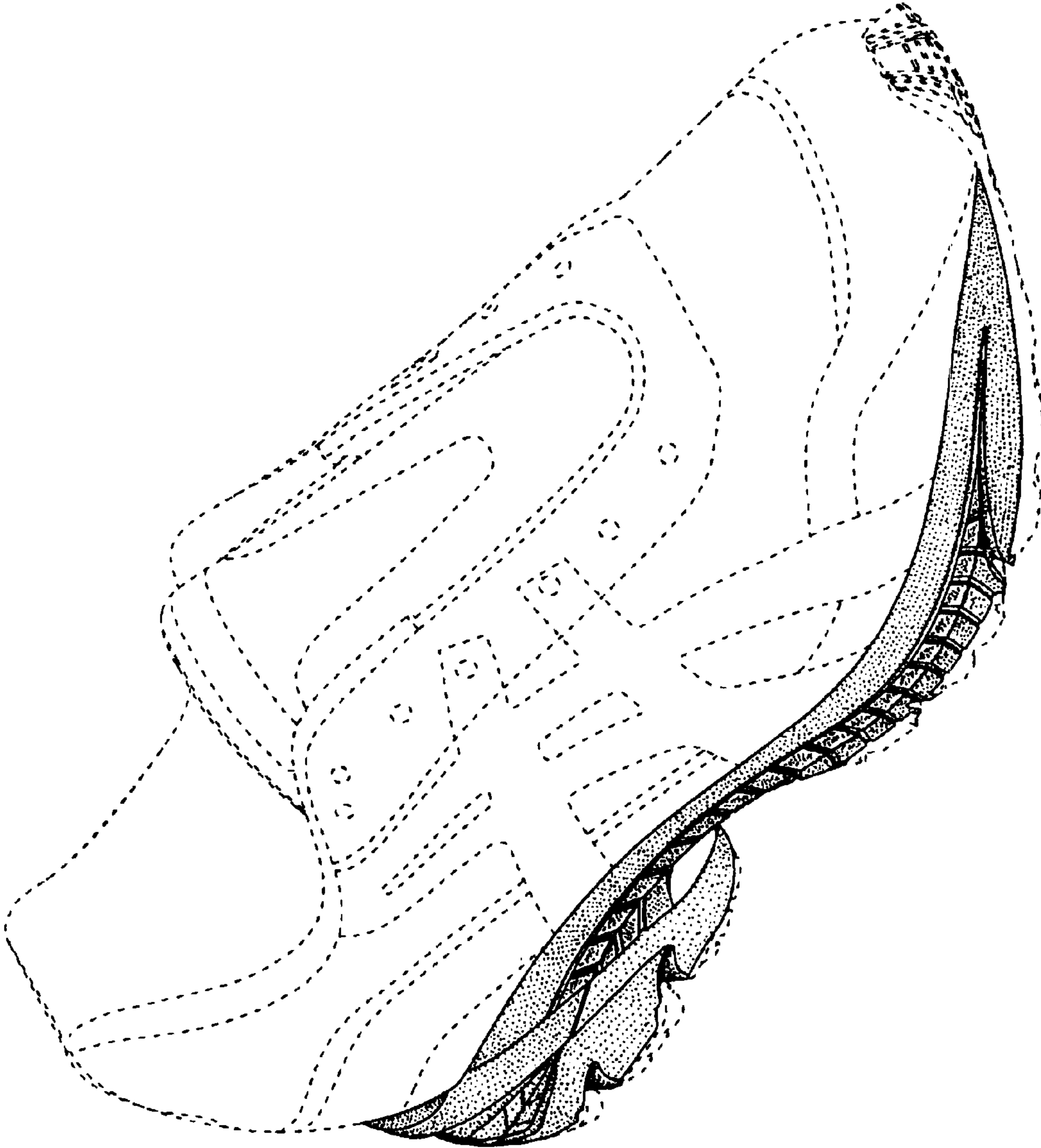

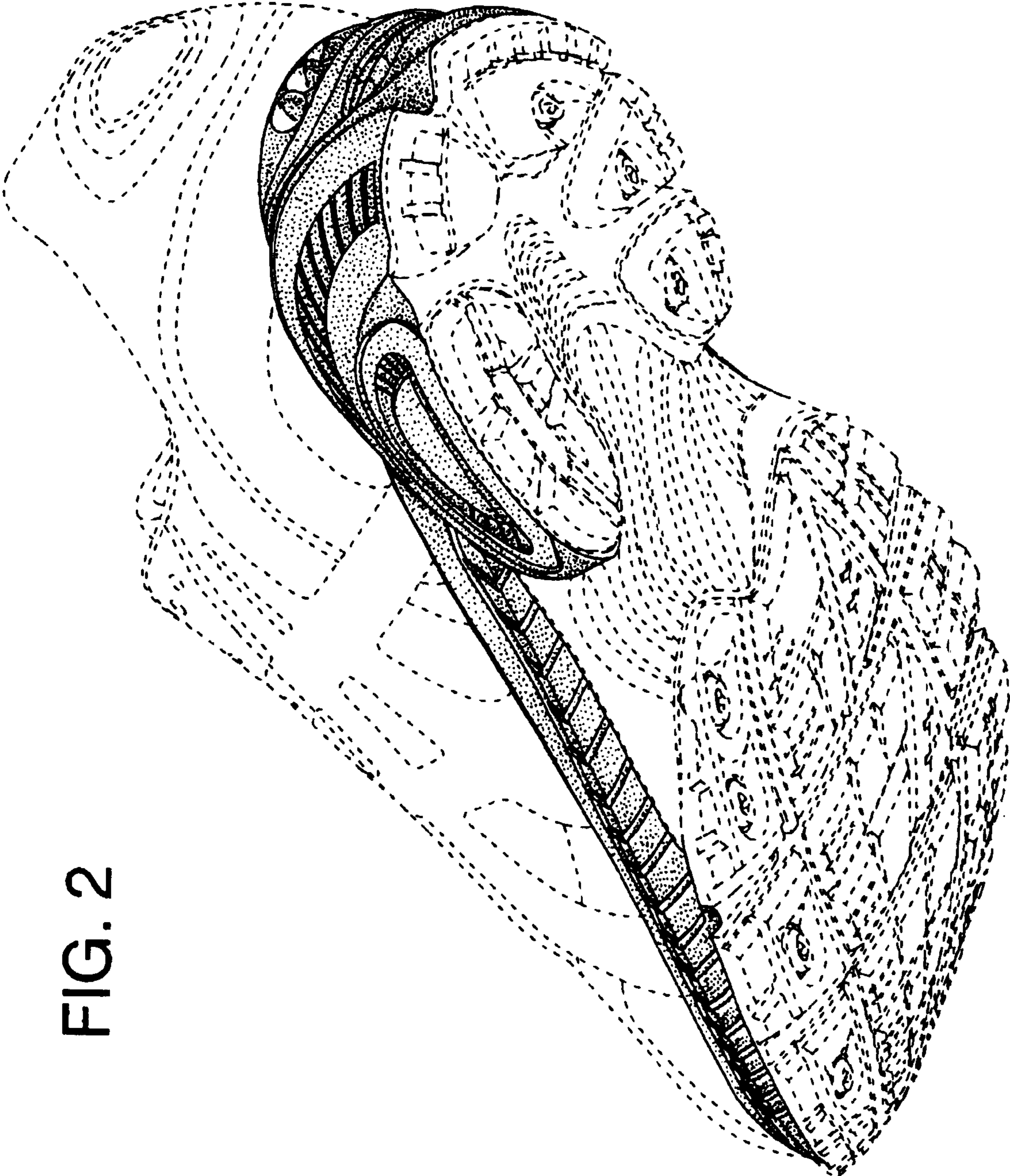

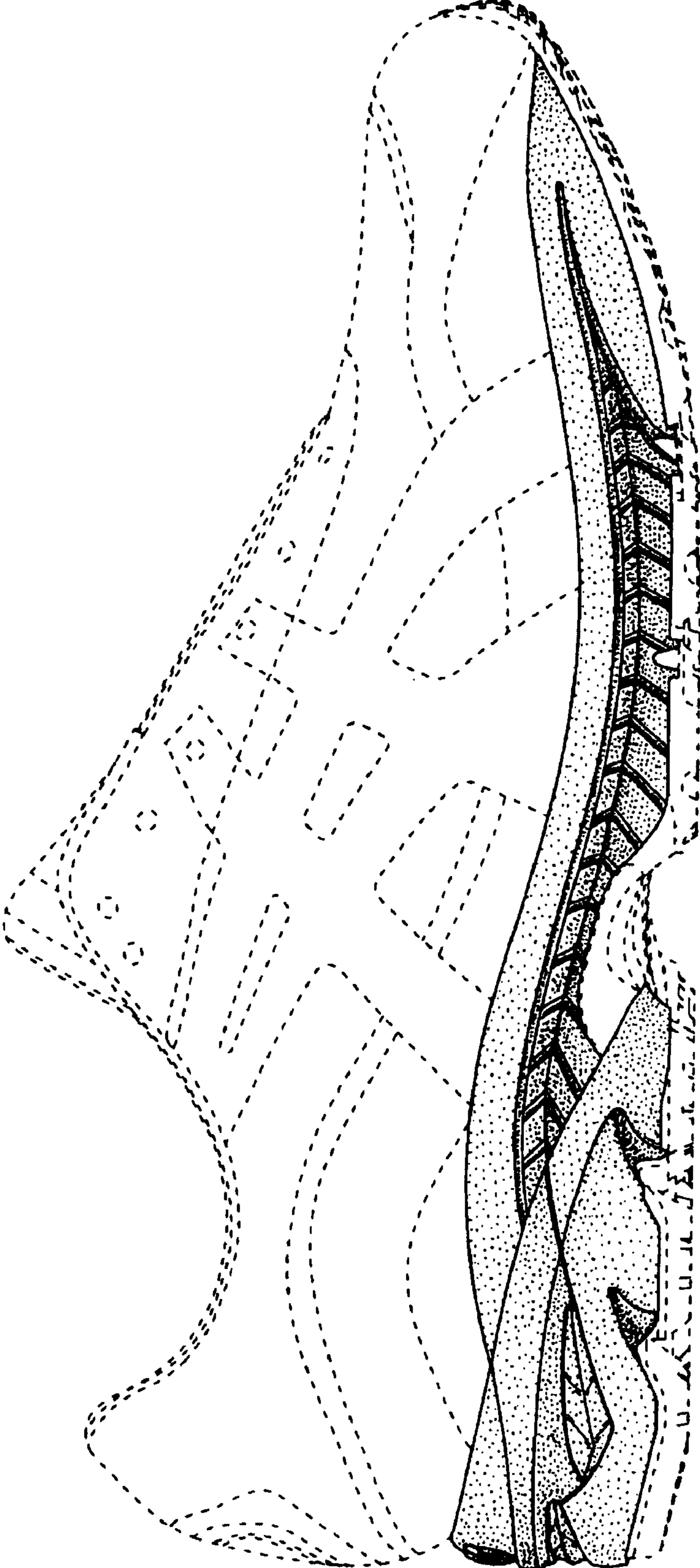

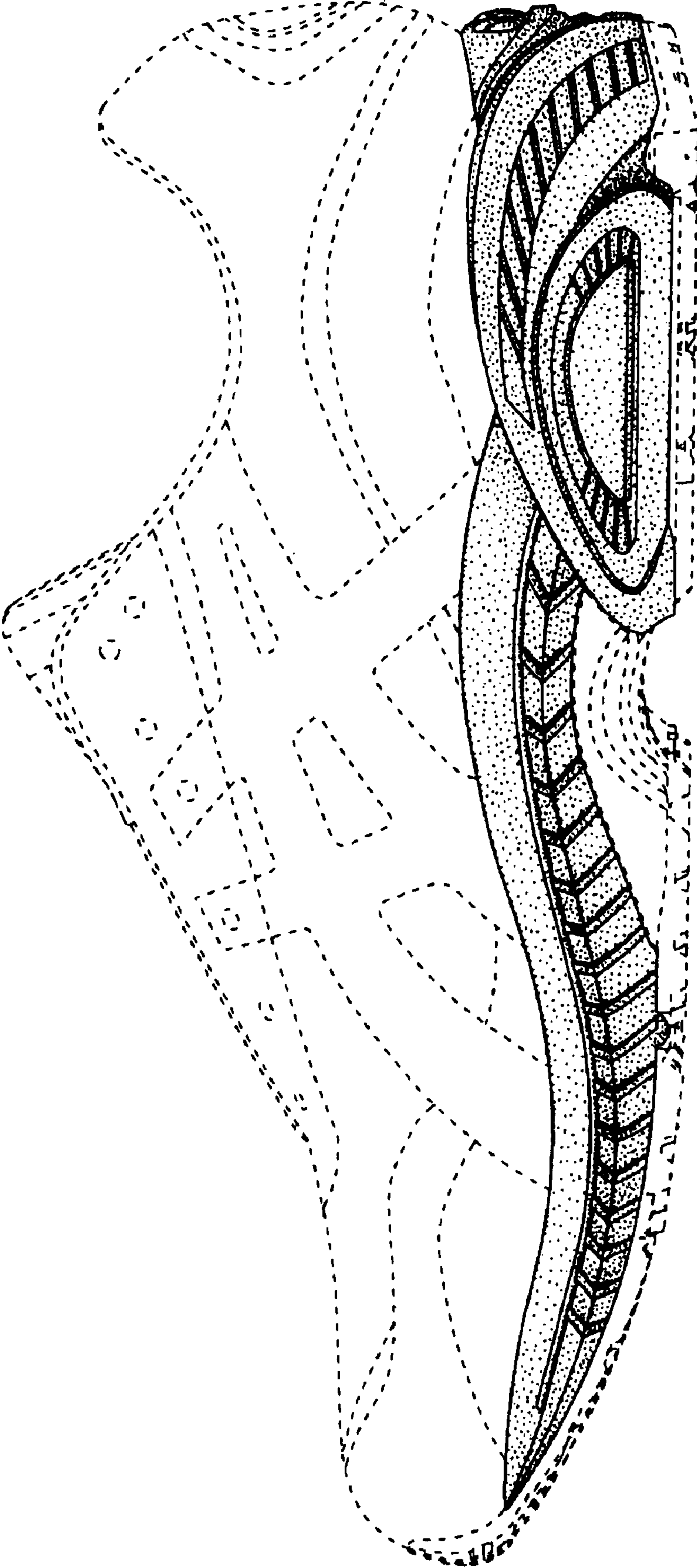

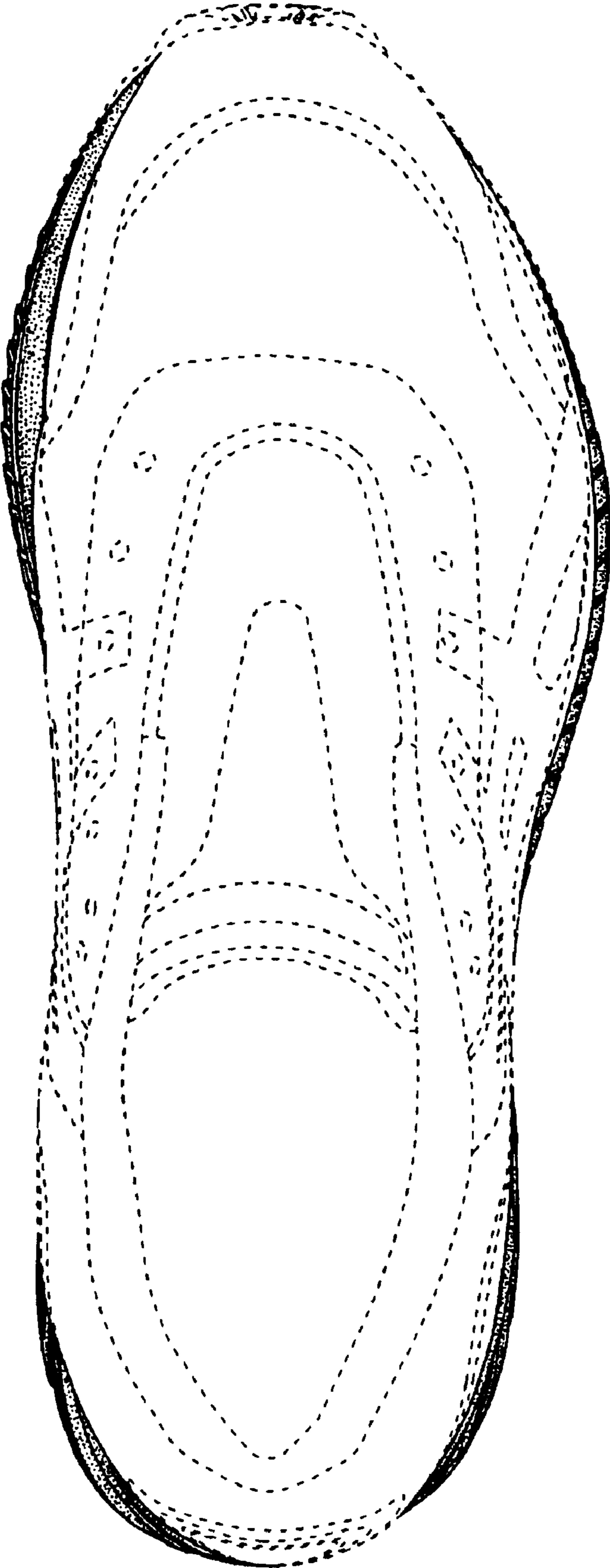

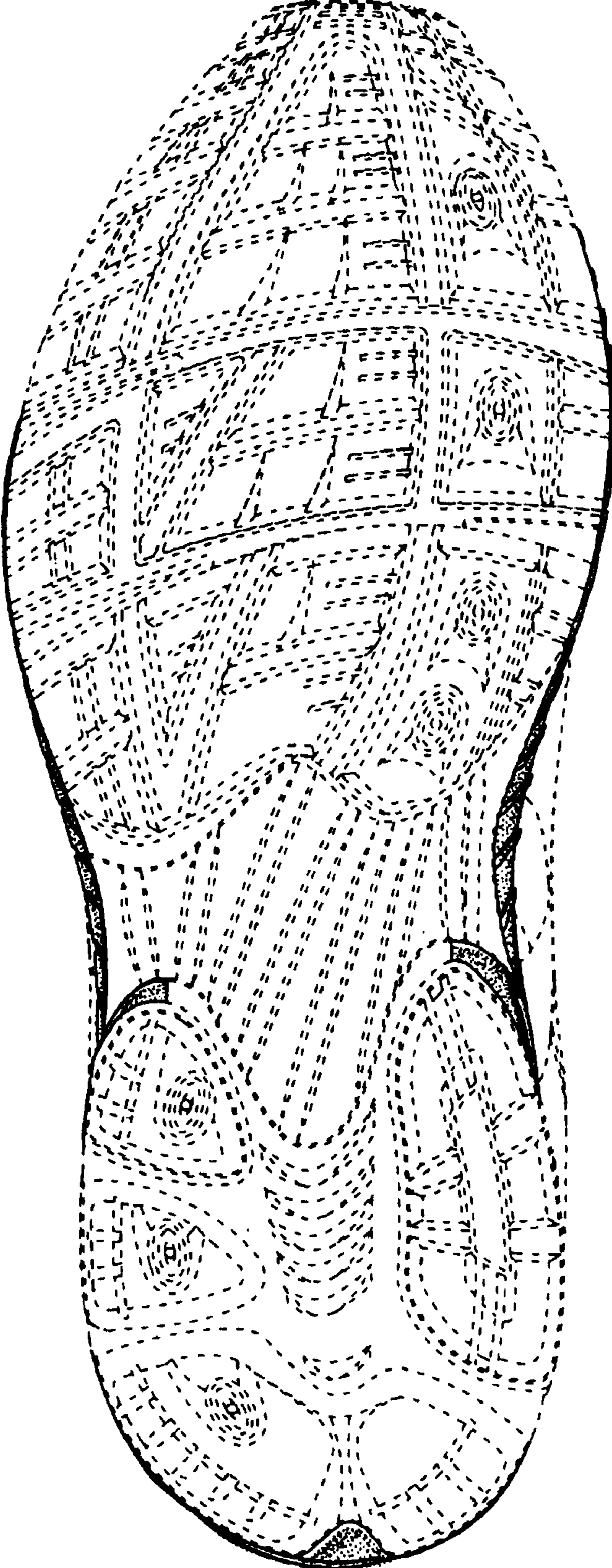

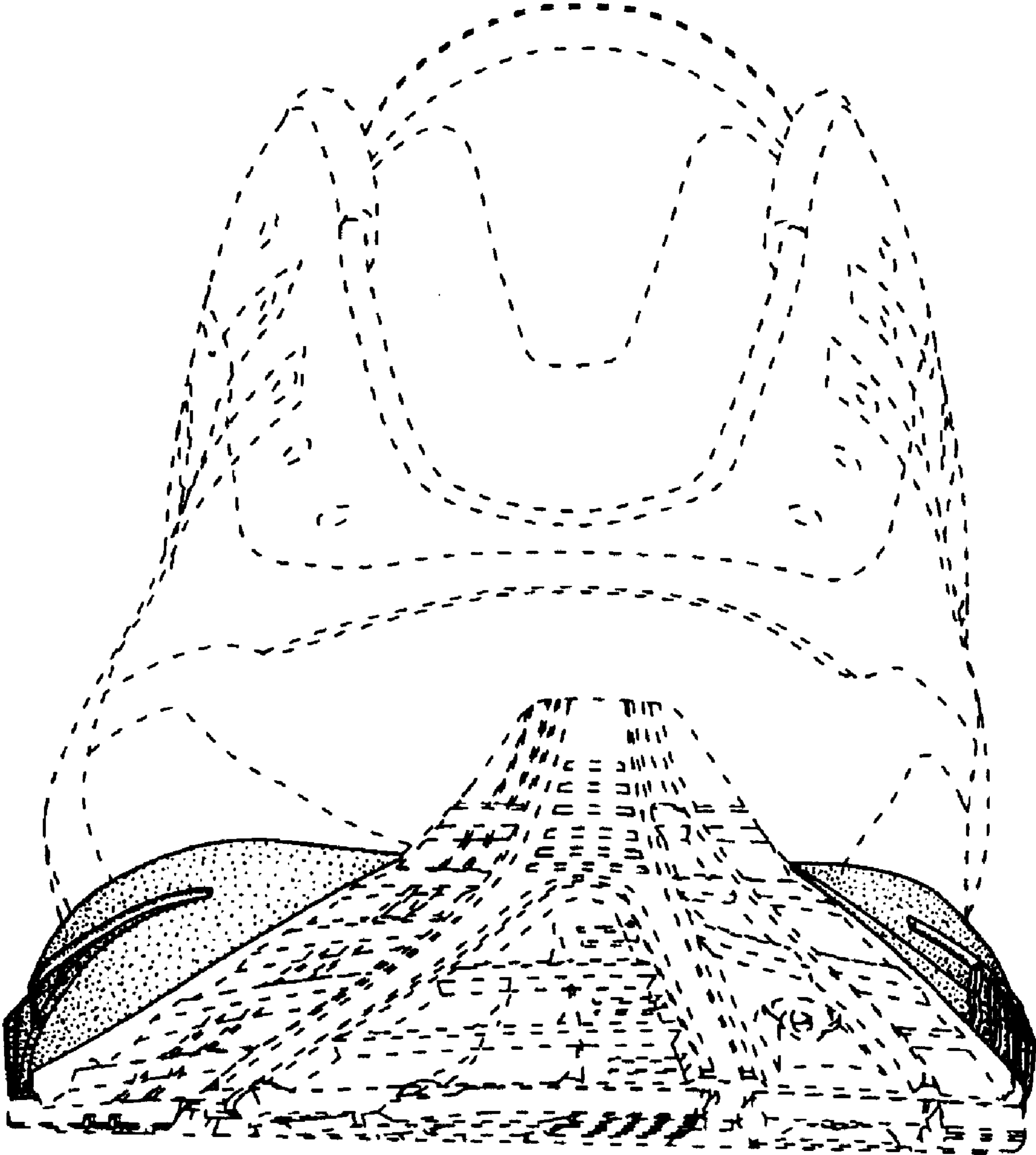
