The ornamental design for “camera bag,” as shown and described.

DESCRIPTION

FIG. 1 is a front view of a camera bag, showing my new design;
FIG. 2 is a front view of the bag depicted in FIG. 1;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side elevational view thereof; and,
FIG. 6 is a right side elevational view thereof.

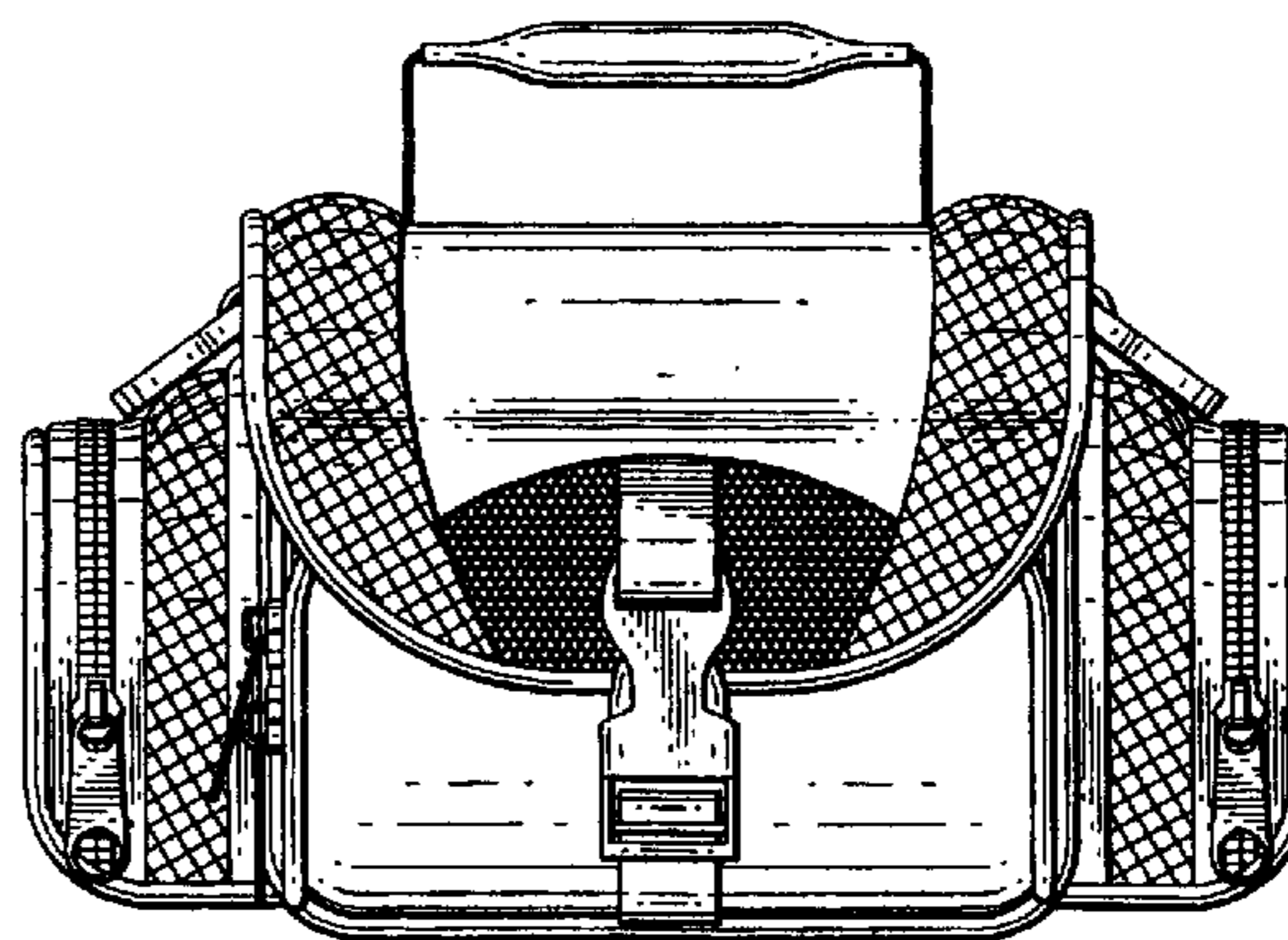
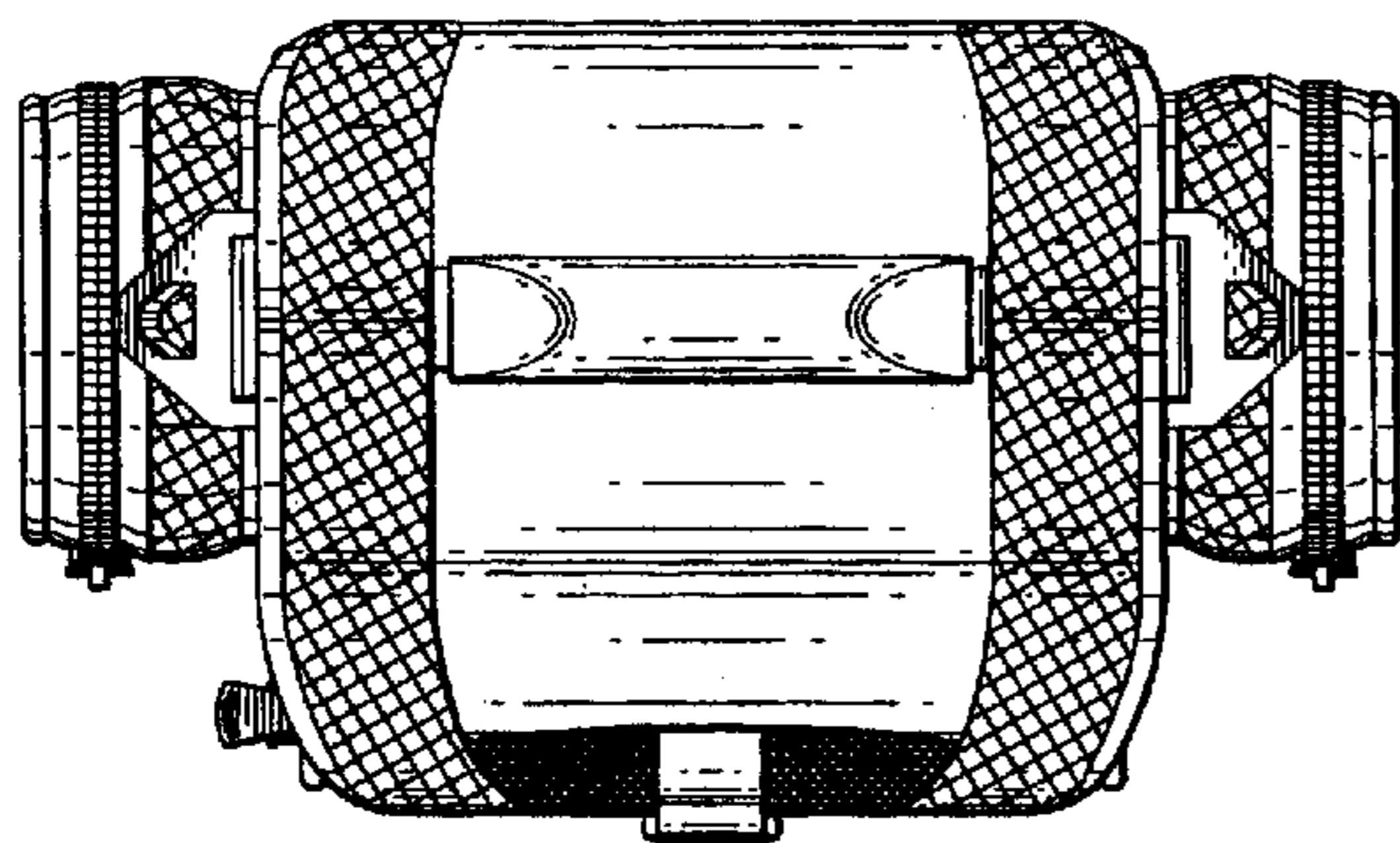

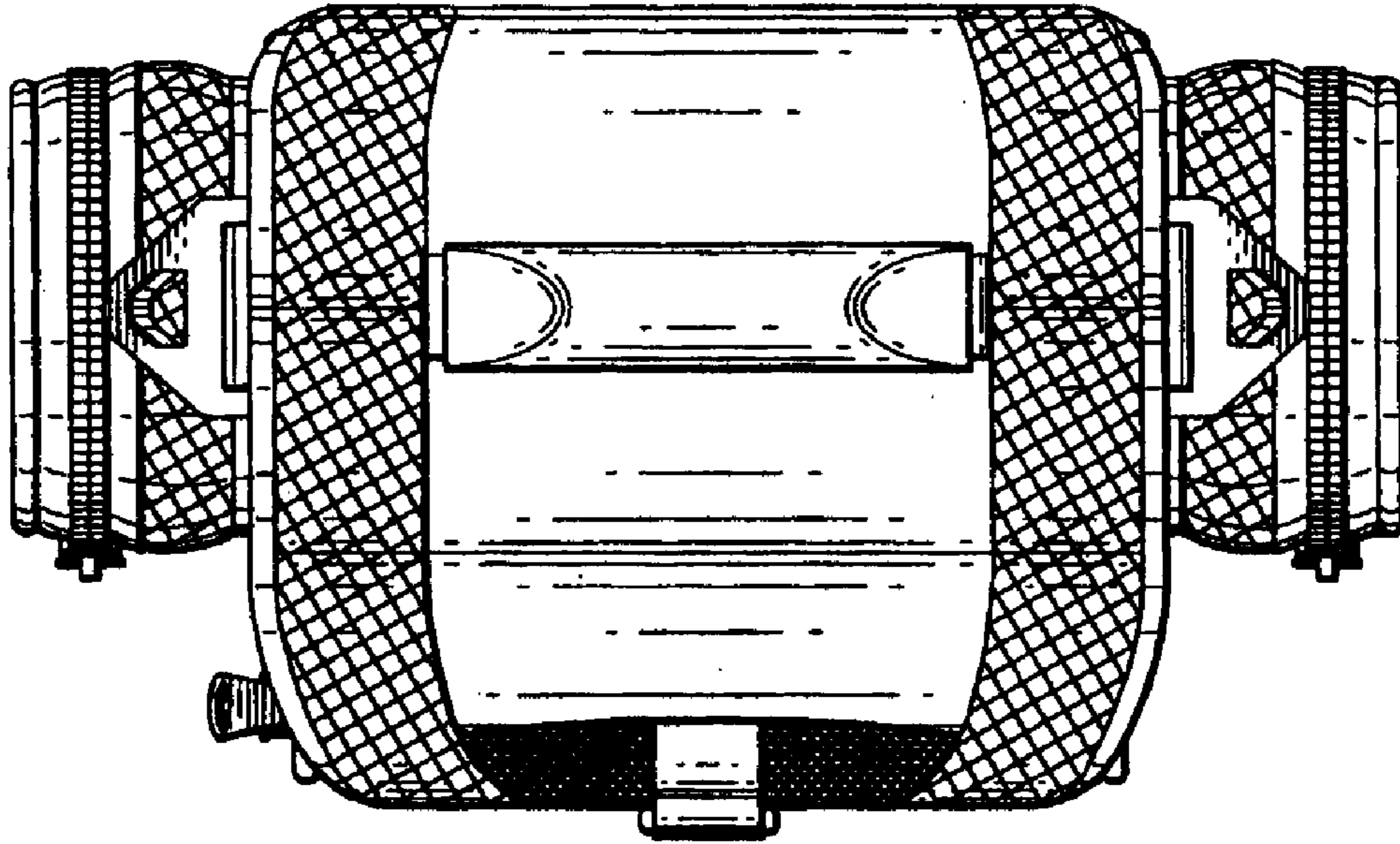

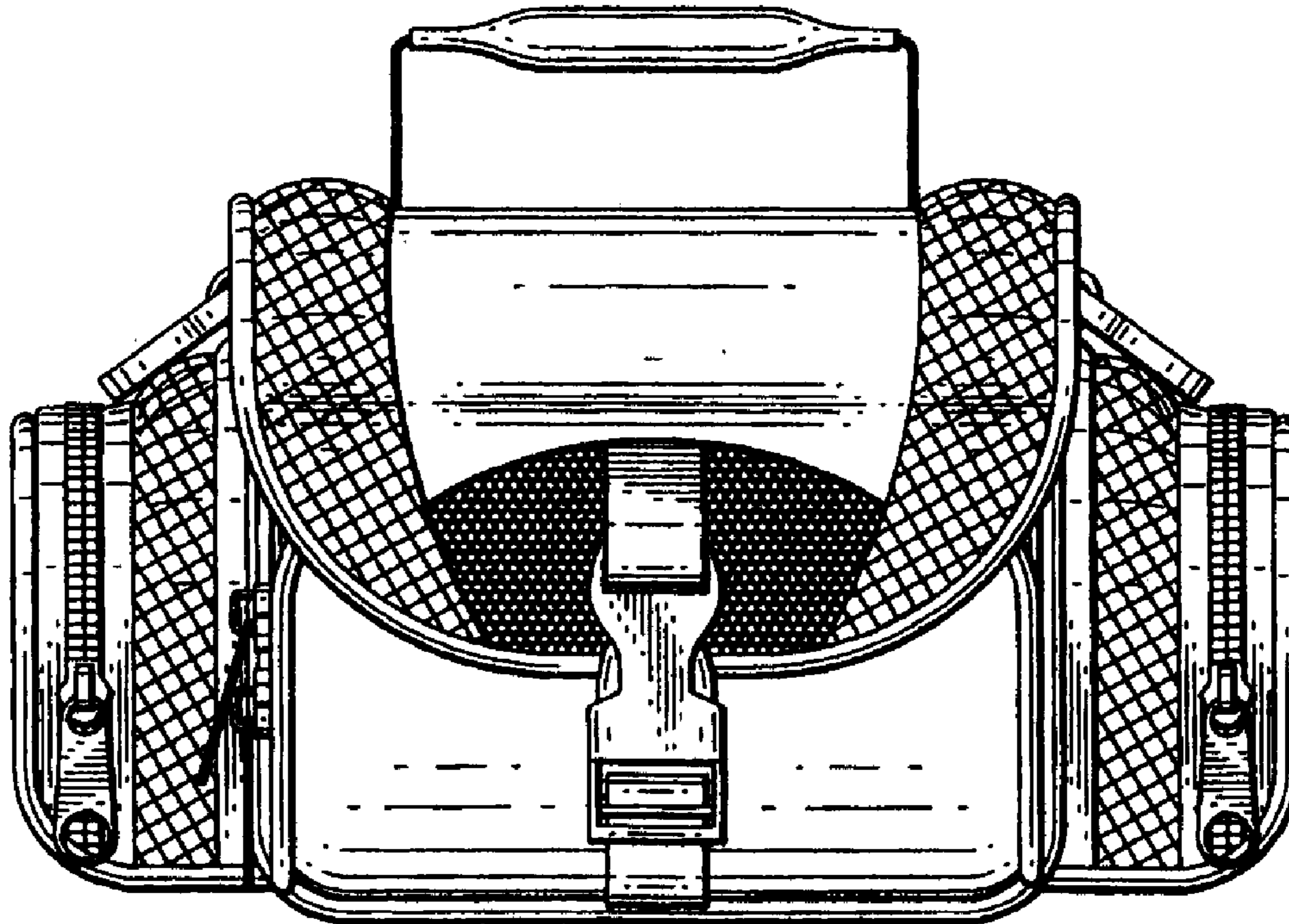

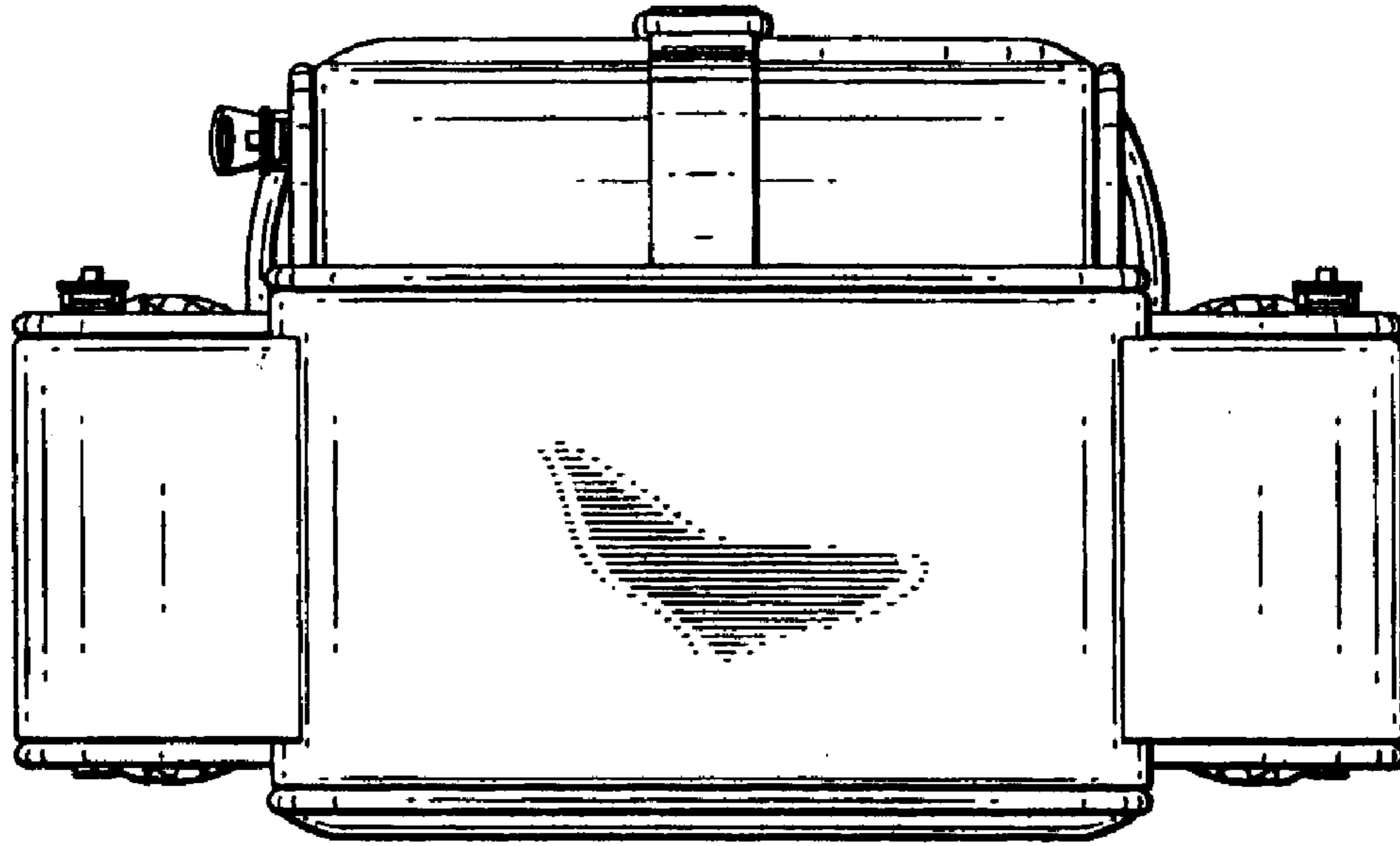

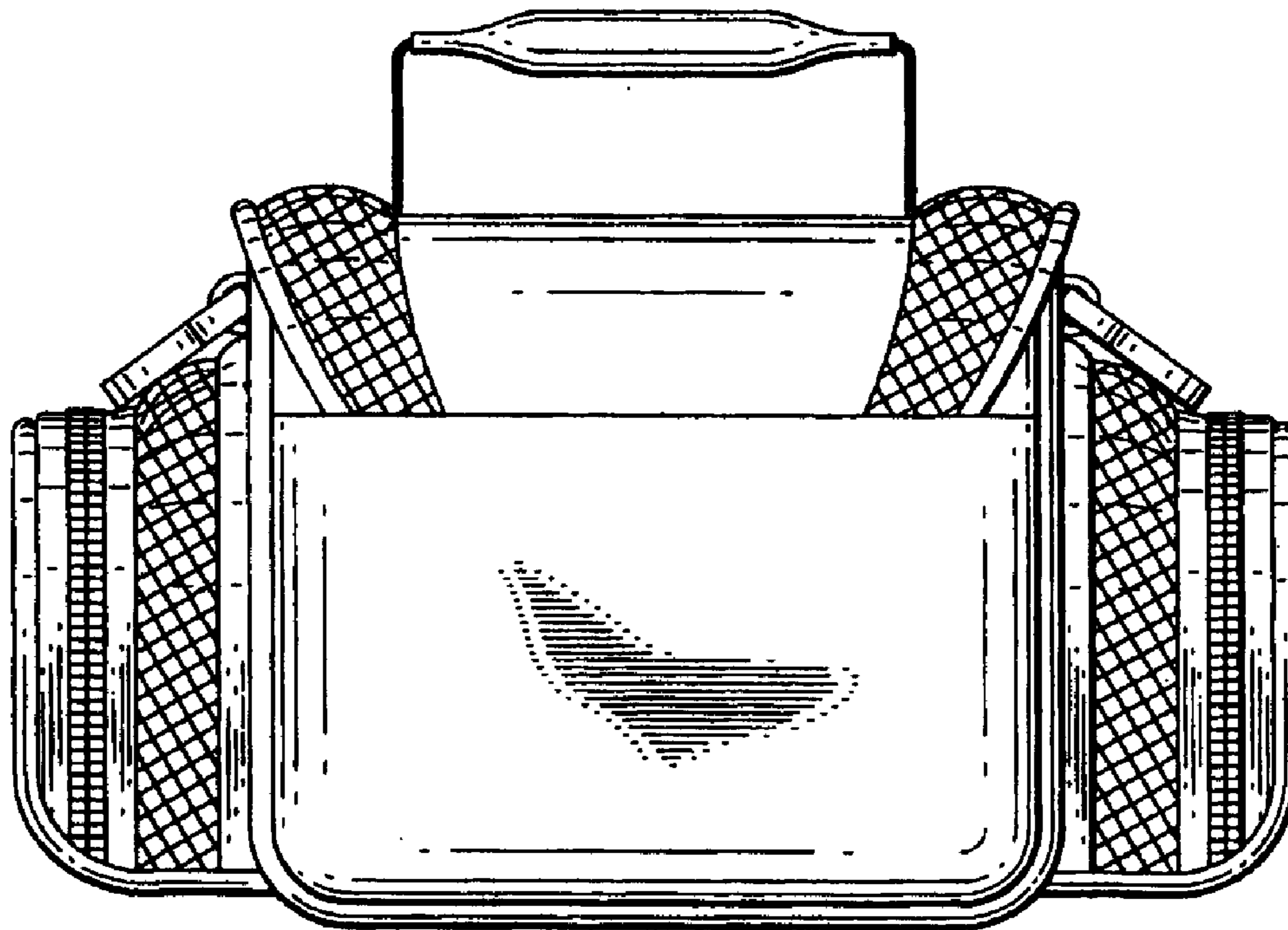

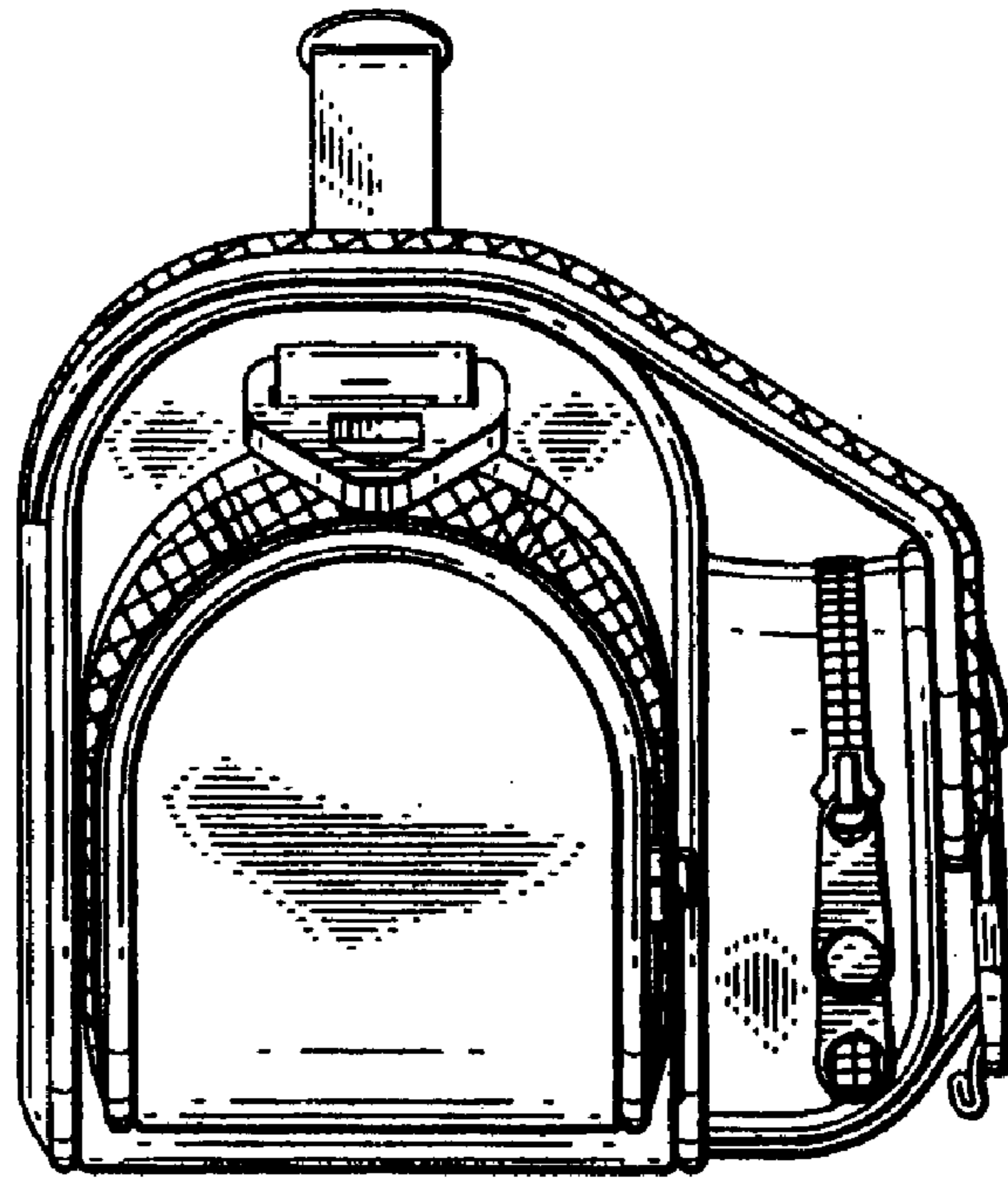
