The ornamental design for furniture, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of a sectional sofa showing my new design;

FIG. 2 is a front view of the first embodiment of a sectional sofa as shown in FIG. 1;

FIG. 3 is a side view of the first embodiment of a sectional sofa as shown in FIG. 1;

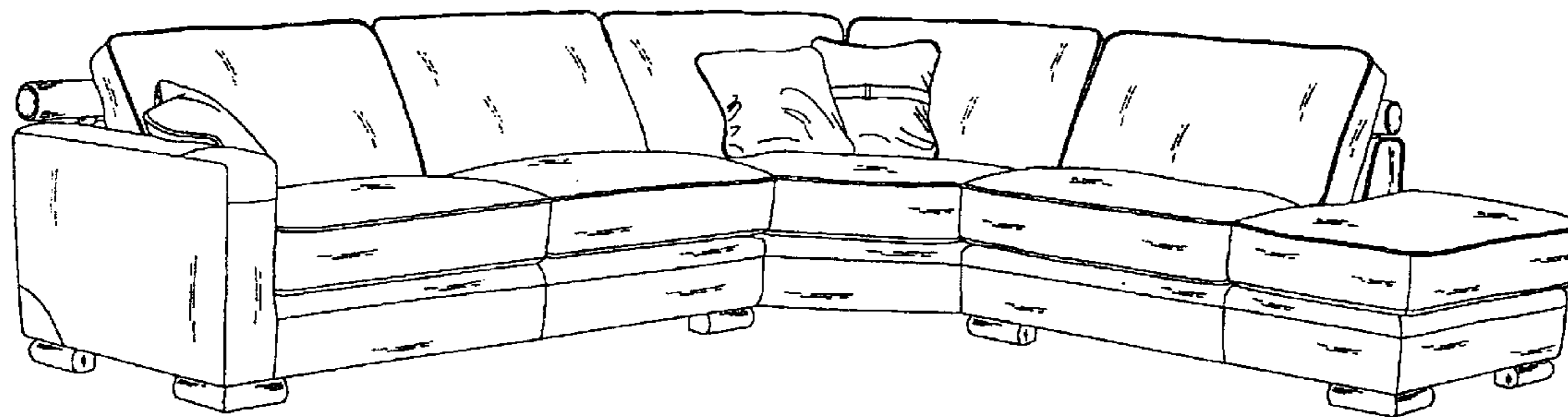
FIG. 4 is a perspective view of a second embodiment of a sectional sofa showing my new design;

FIG. 5 is a front view of the second embodiment of a sectional sofa as shown as FIG. 4; and,

FIG. 6 is a side view of the second embodiment of a sectional sofa as shown in FIG. 4.

Each piece is characterized by a cylindrical back cushion support and belt and flap design.

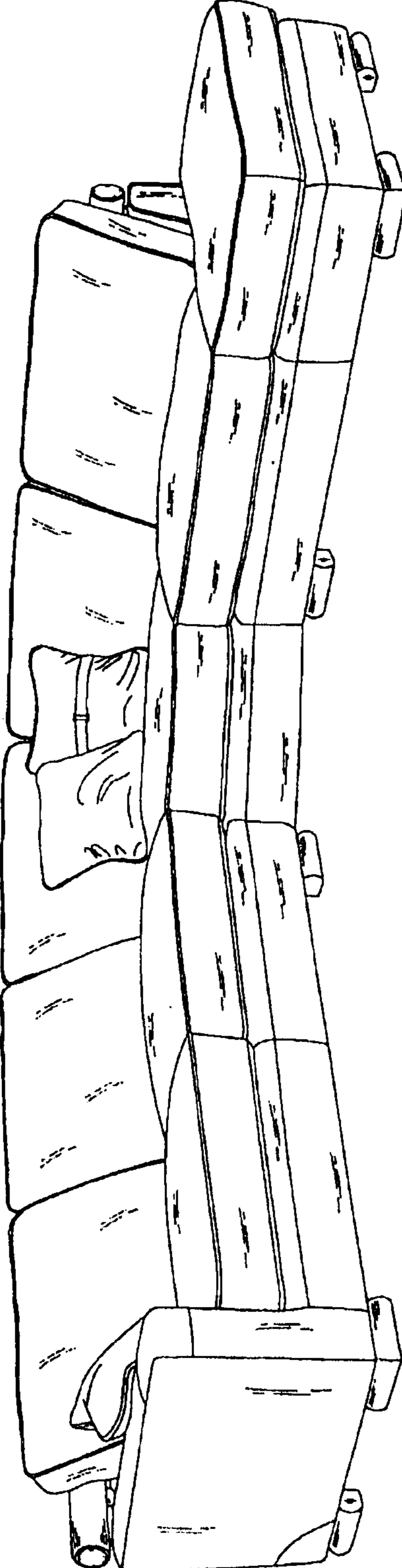

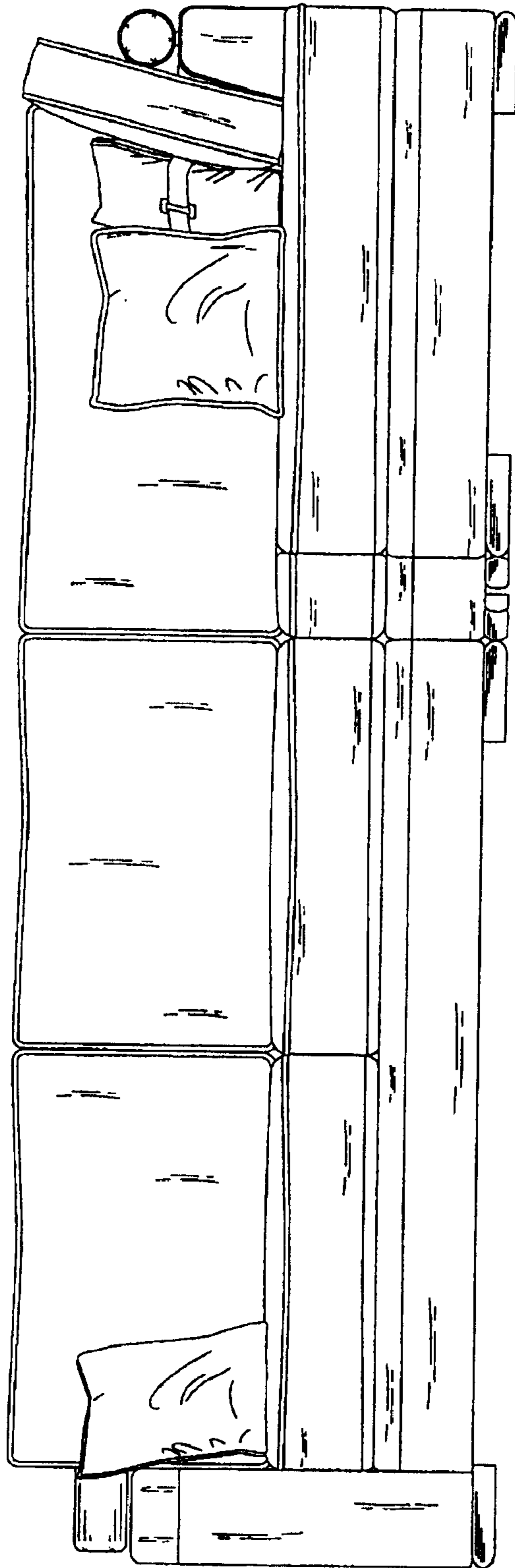

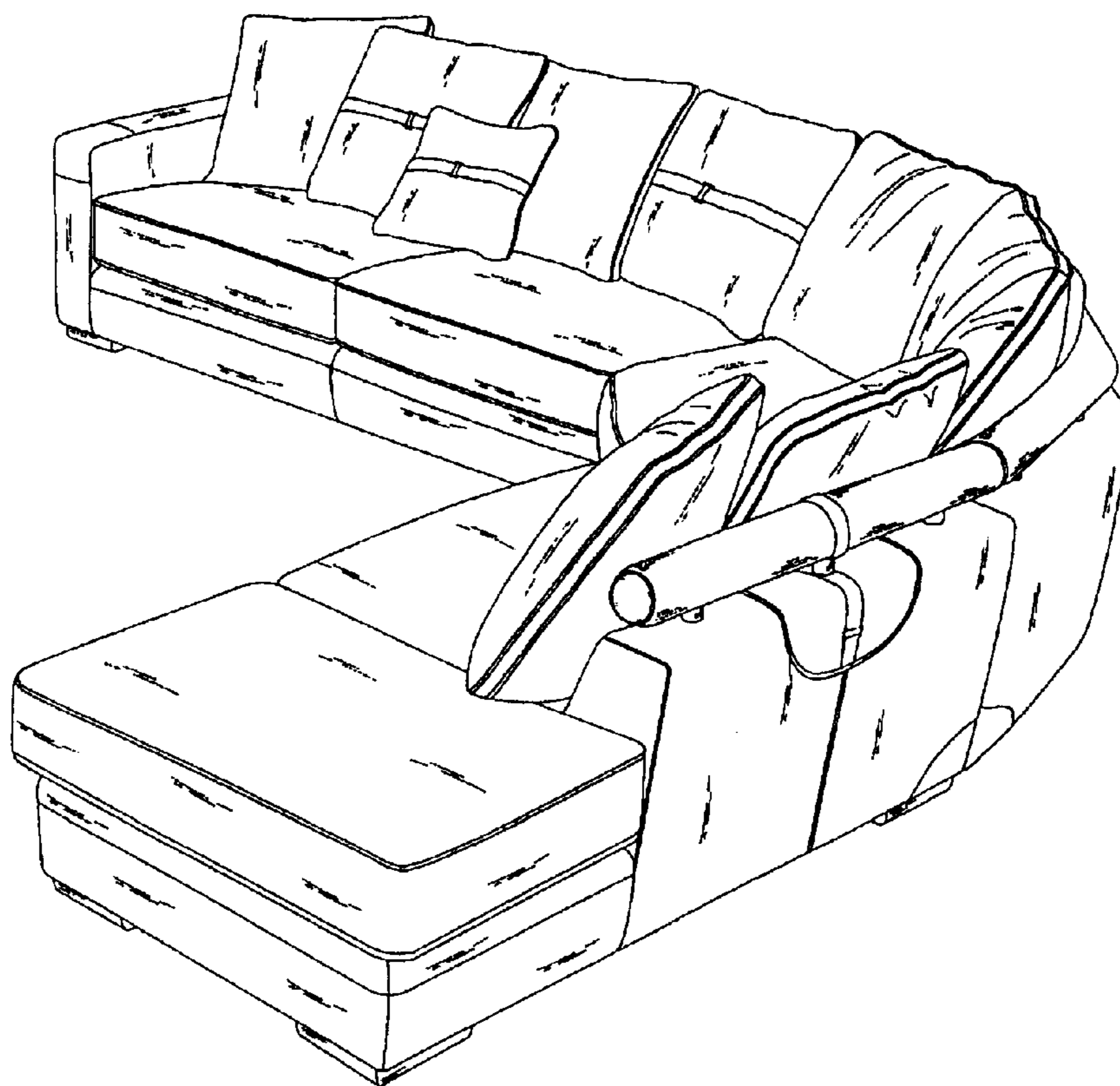

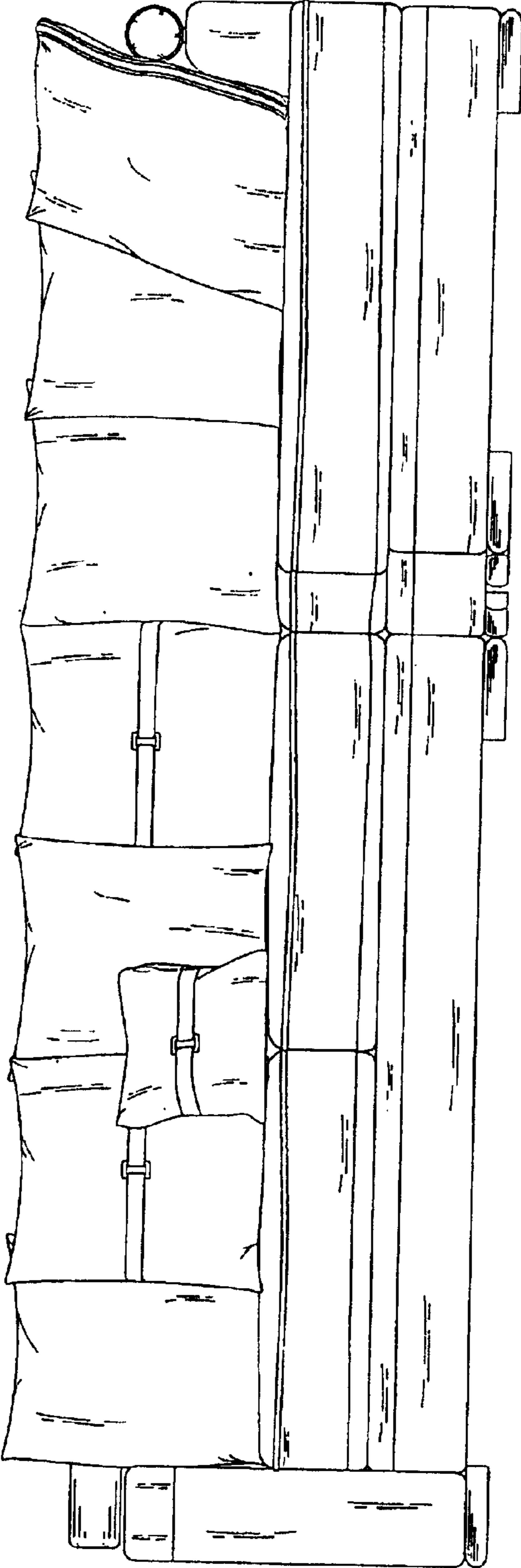

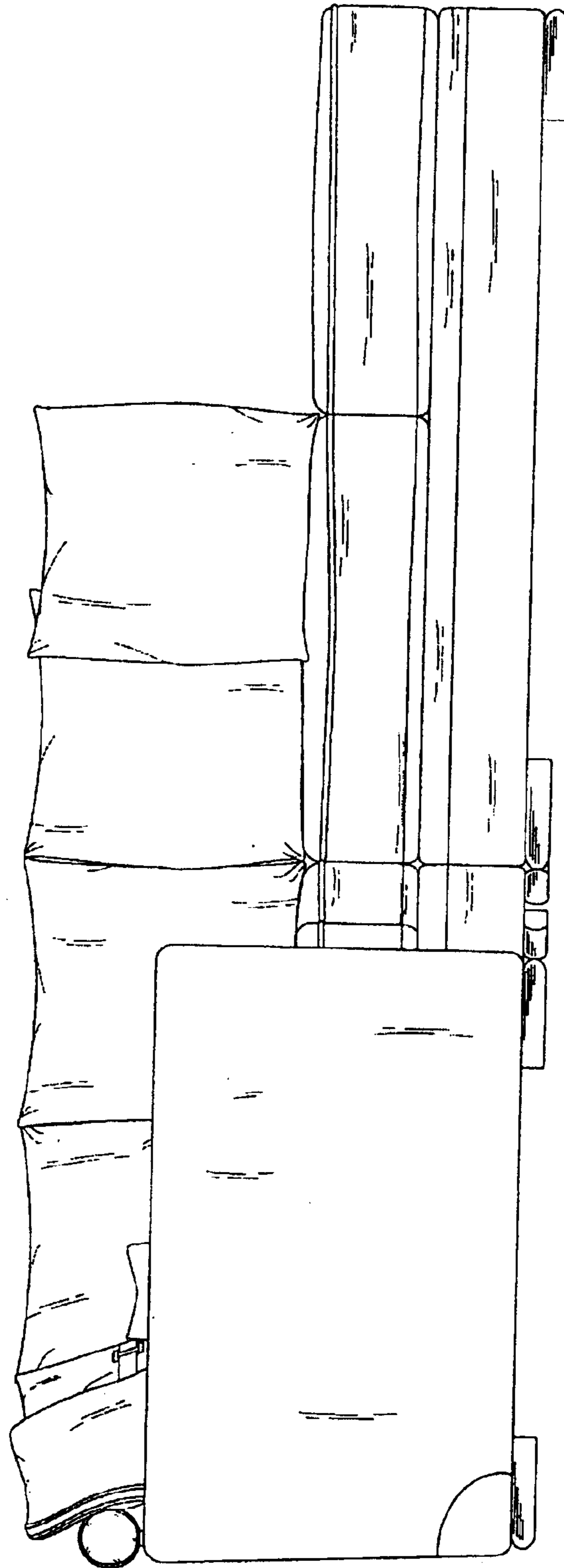
