(57) **CLAIM**

The ornamental design for a combined sleeping bag with inflatable mattress, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the combined sleeping bag with inflatable mattress of the present invention in an elongated position;

FIG. 2 is a rear view of the combined sleeping bag with inflatable mattress of the present invention in the elongated position;

FIG. 3 is a top view of the combined sleeping bag with inflatable mattress of the present invention in the elongated position shown with the top partially opened;

FIG. 4 is a bottom view of the combined sleeping bag with inflatable mattress of the present invention in the elongated position;

FIG. 5 is a right view of the combined sleeping bag with inflatable mattress of the present invention in the elongated position;

FIG. 6 is a left view of the combined sleeping bag with inflatable mattress of the present invention in the elongated position;

FIG. 7 is a front view of the combined sleeping bag with inflatable mattress of the present invention in an alternate reclined position;

FIG. 8 is a rear view of the combined sleeping bag with inflatable mattress of the present invention in the reclined position;

FIG. 9 is a top view of the combined sleeping bag with inflatable mattress of the present invention in the reclined position;

FIG. 10 is a bottom view of the combined sleeping bag with inflatable mattress of the present invention in the reclined position;

FIG. 11 is a left view of the combined sleeping bag with inflatable mattress of the present invention in the reclined position;

FIG. 12 is a right view of the combined sleeping bag with inflatable mattress of the present invention in the reclined position;




FIG. 13 is a front view of the combined sleeping bag with inflatable mattress of the present invention in an alternate sitting position;


































