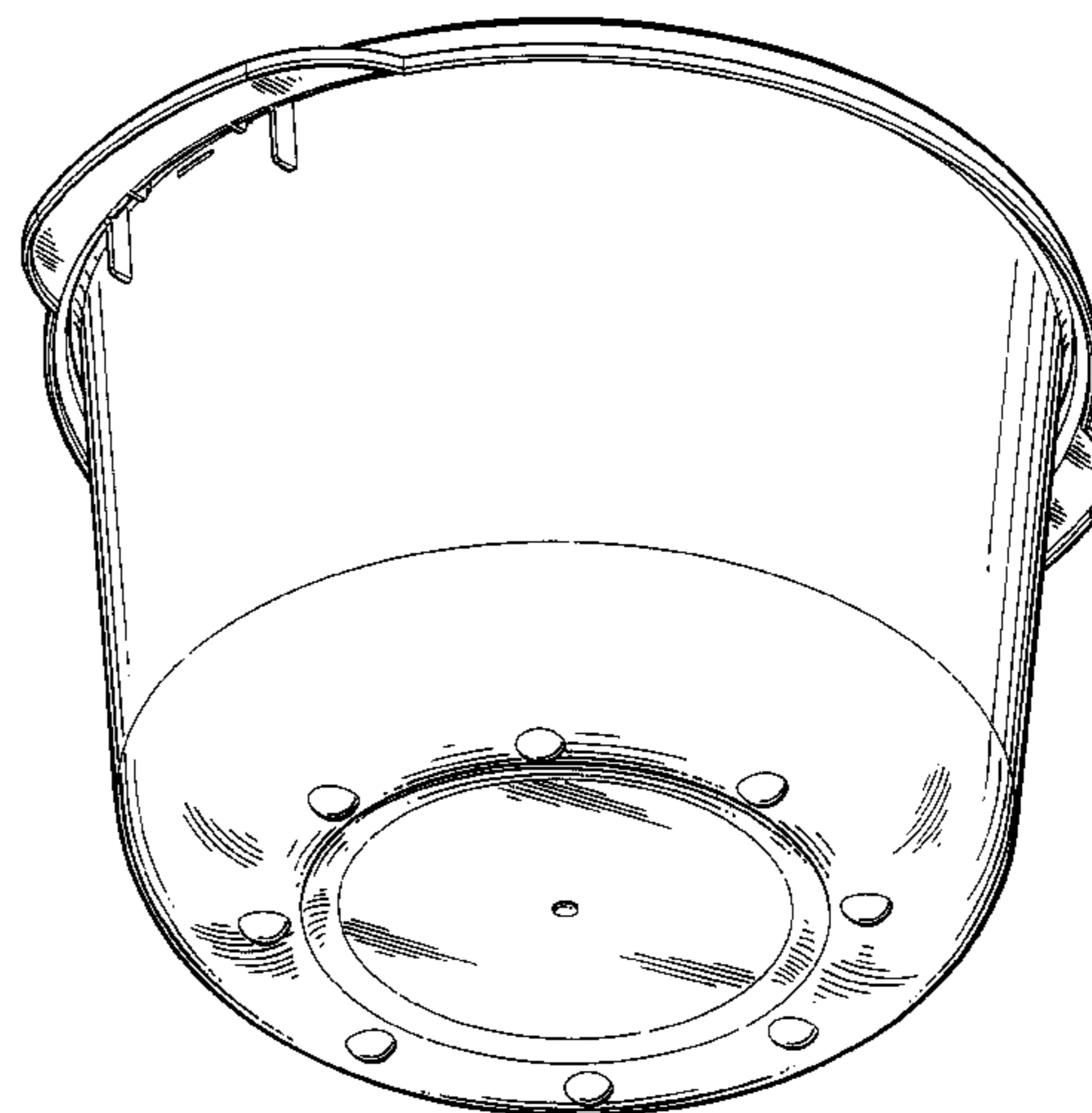
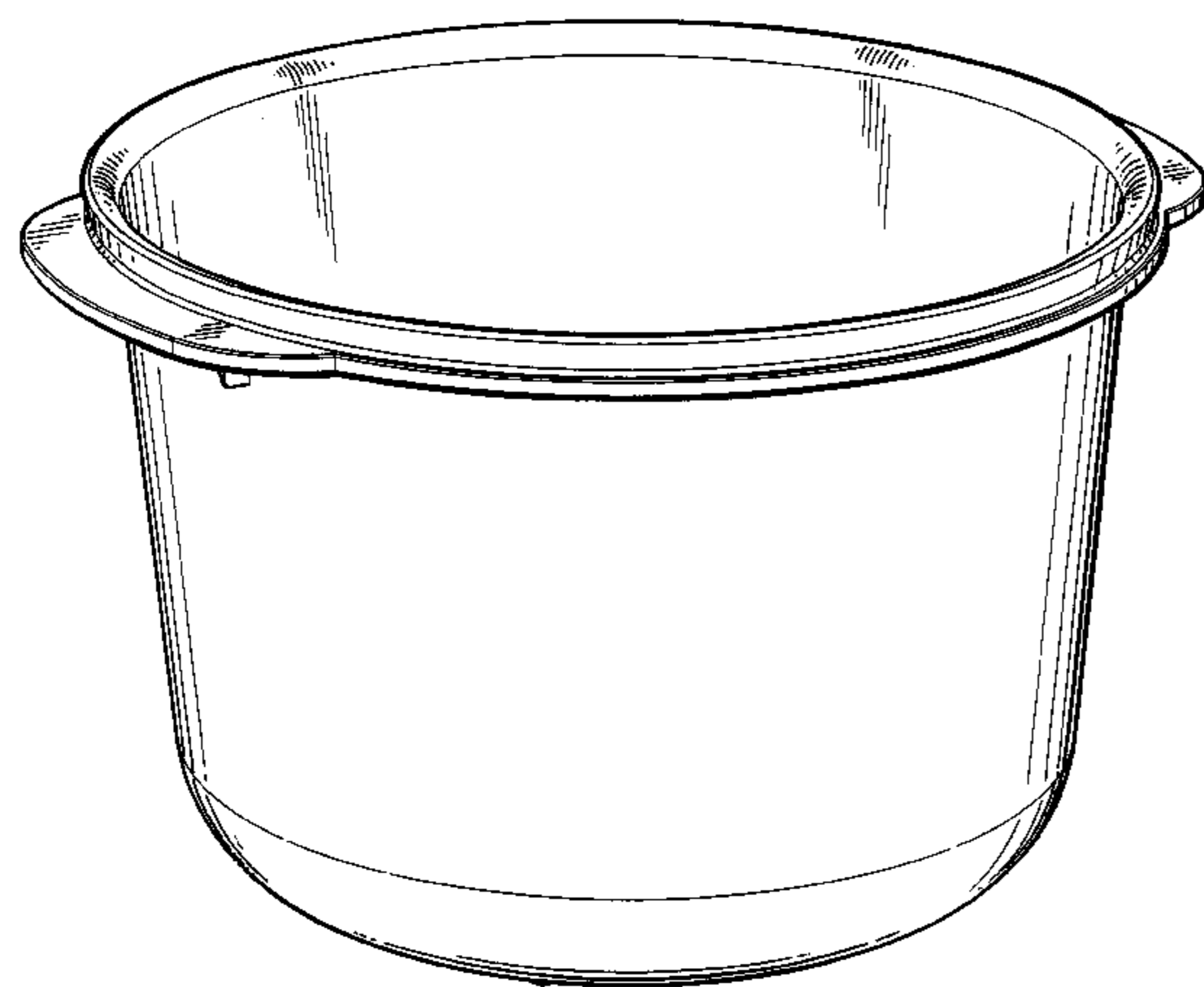
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of the rice cooker; FIG. 2 is a bottom perspective view of the rice cooker; FIG. 3 is a front view of the rice cooker. The rear view is identical. FIG. 4 is a right side view of the rice cooker. The left side view is identical. FIG. 5 is a top view of the rice cooker; and, FIG. 6 is a bottom view of the rice cooker.

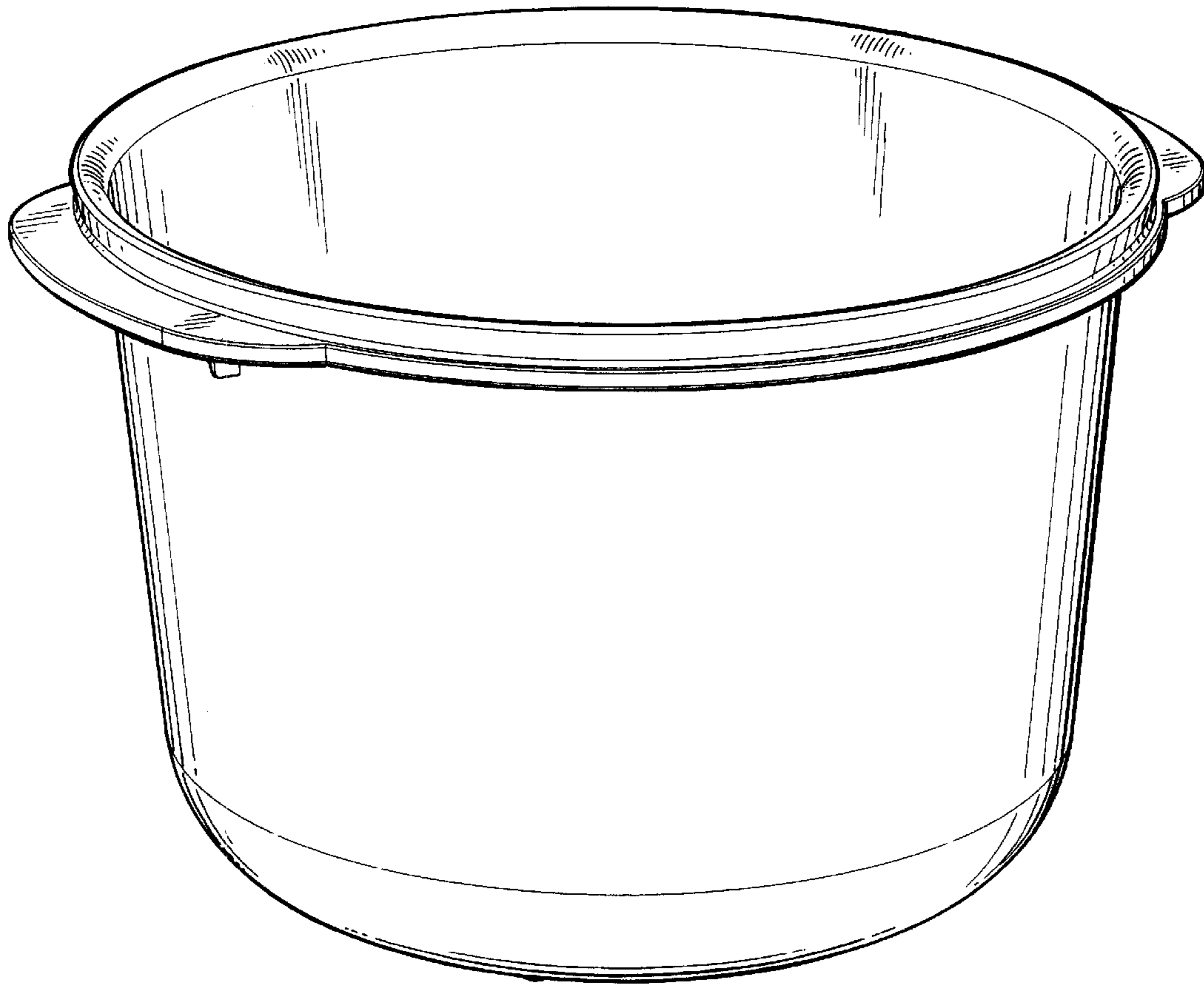

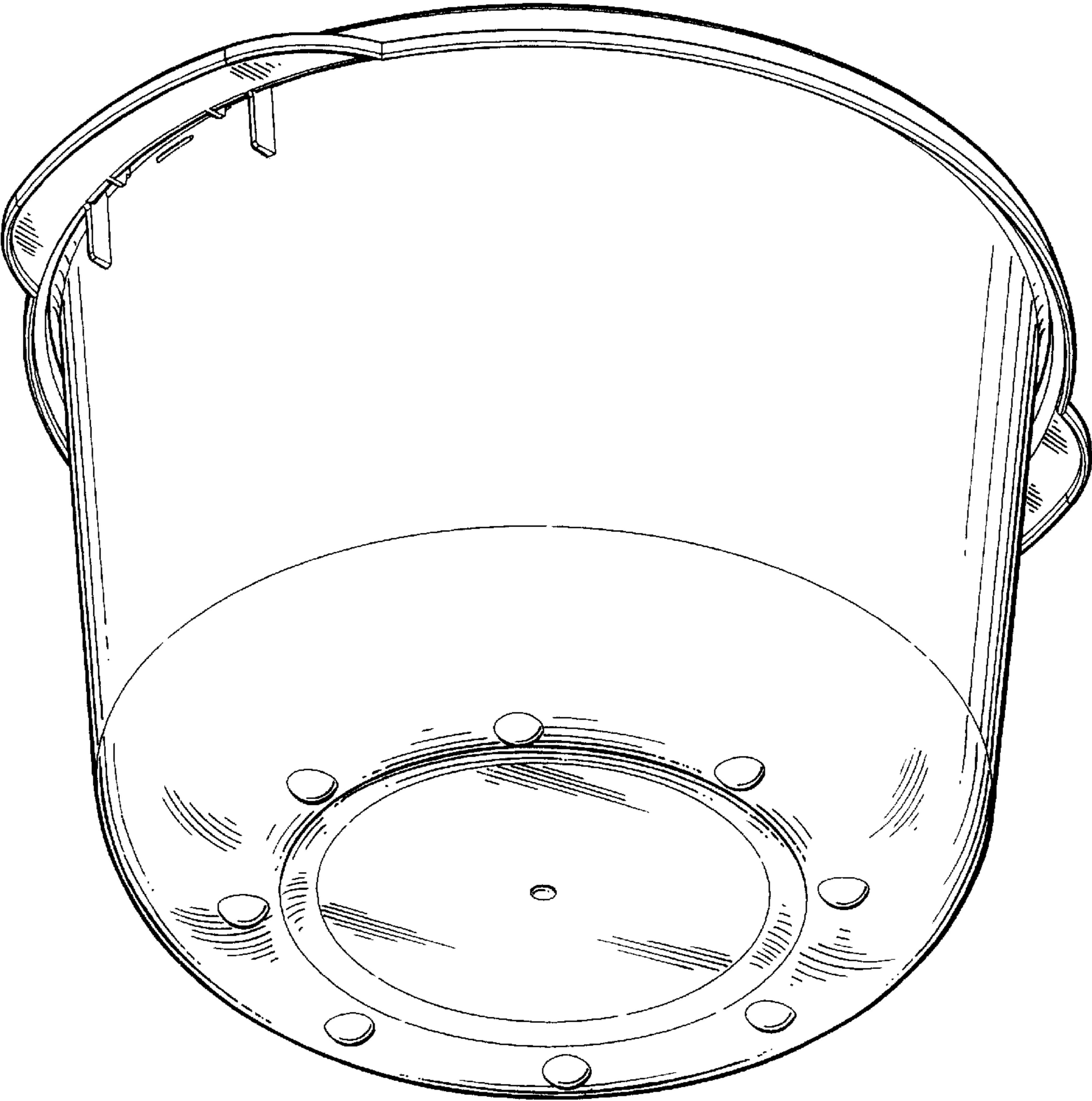

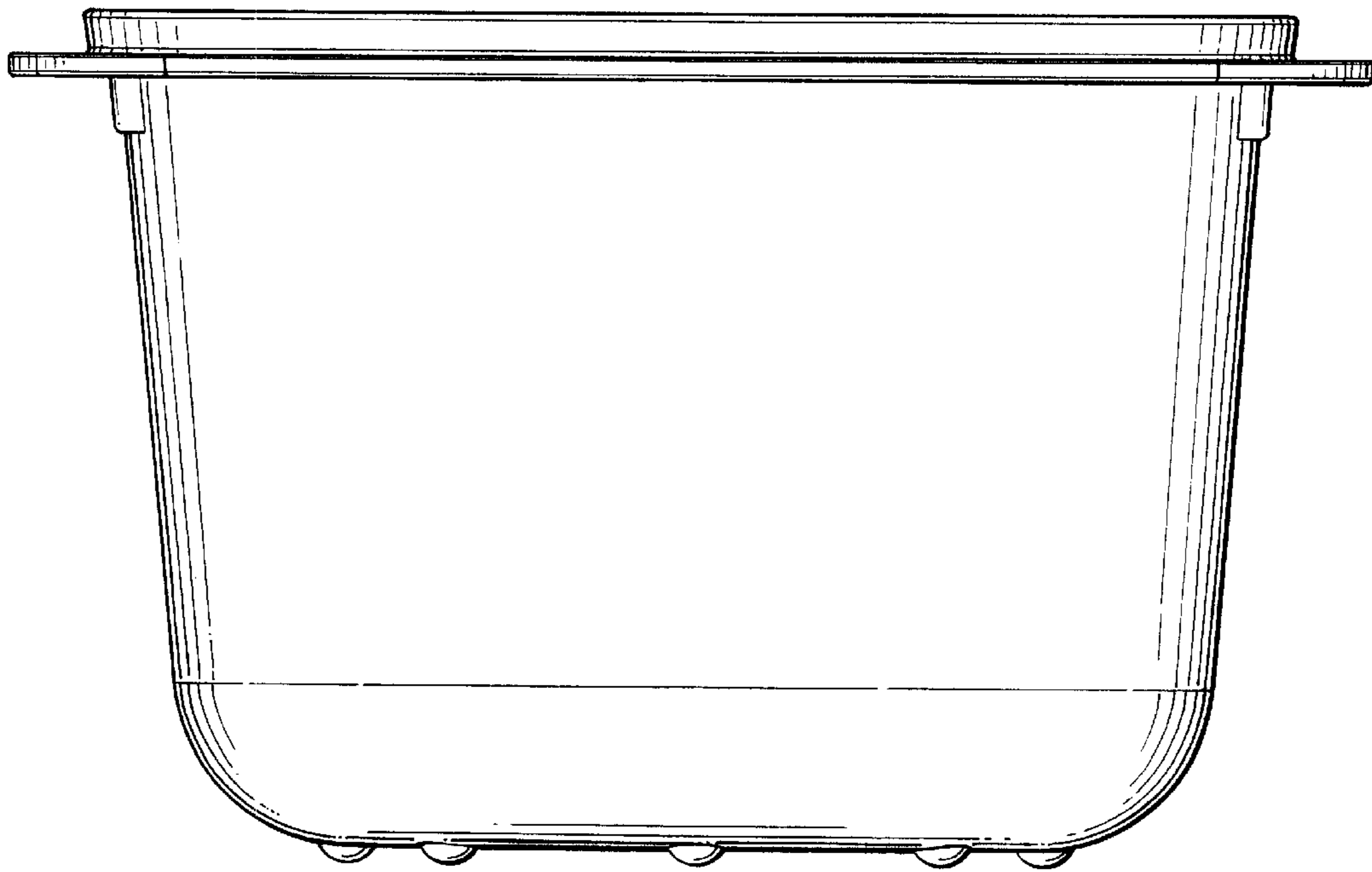

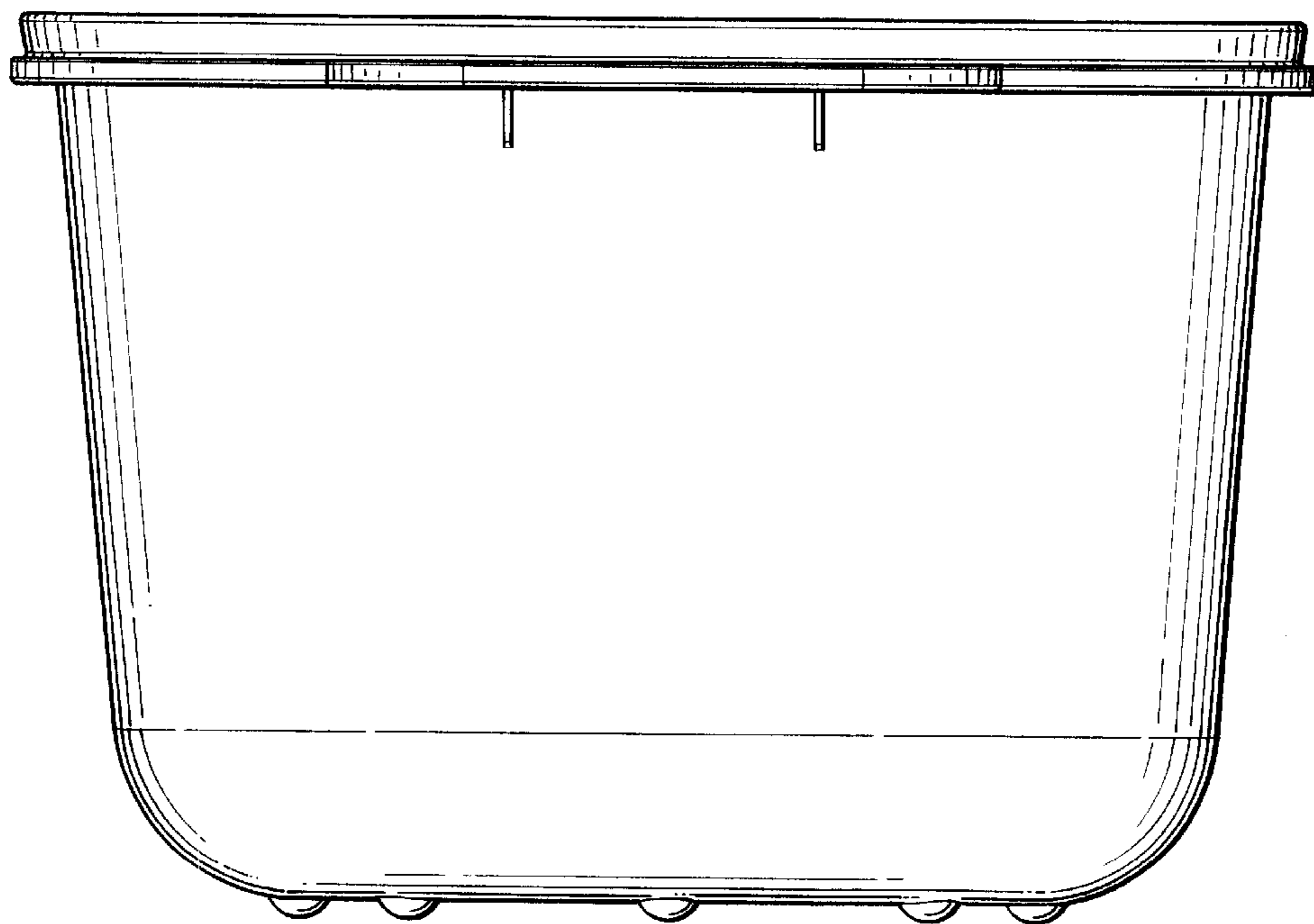

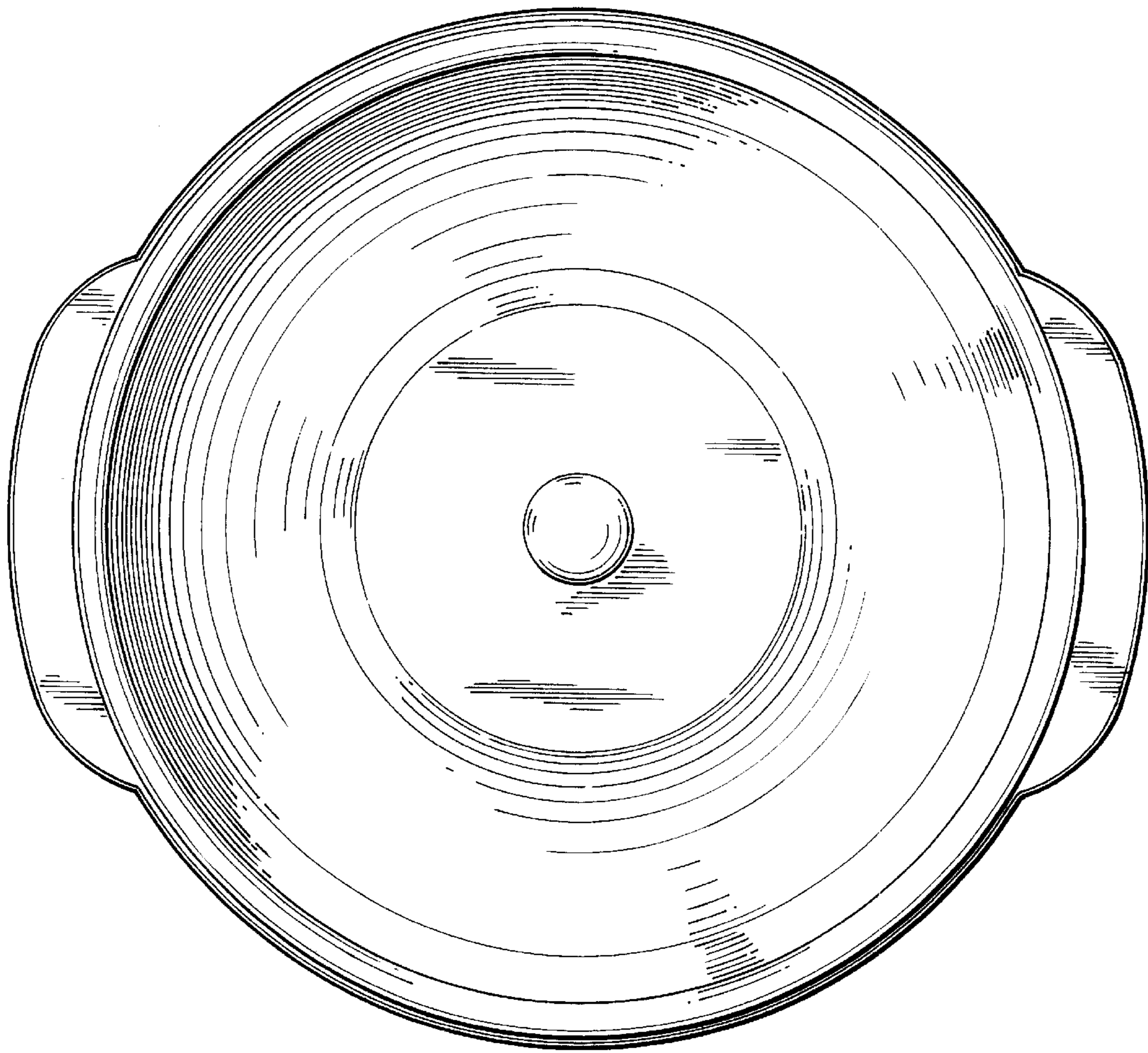

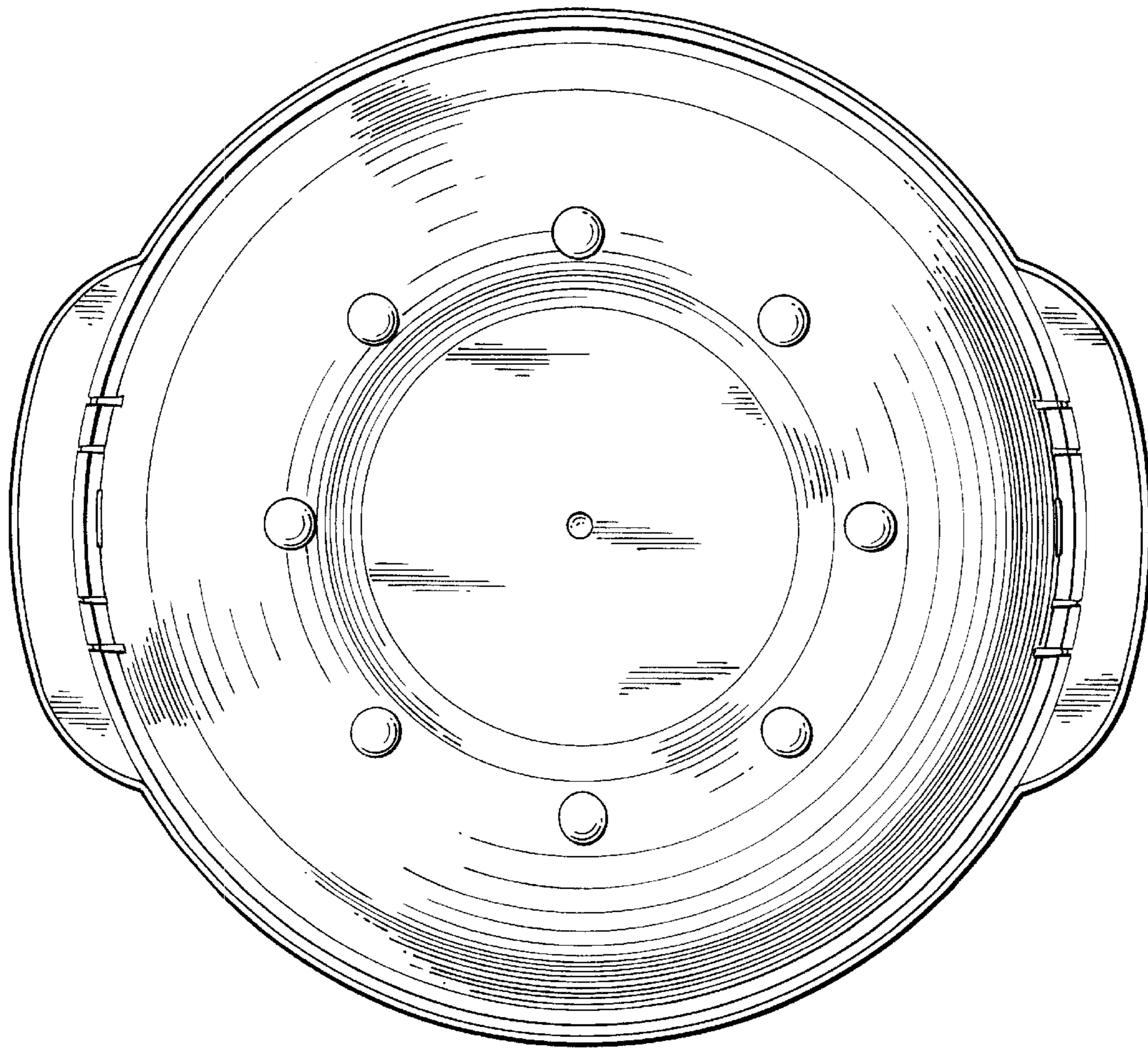
