FIG. 3 is a front view of the beverage container of FIG. 1;

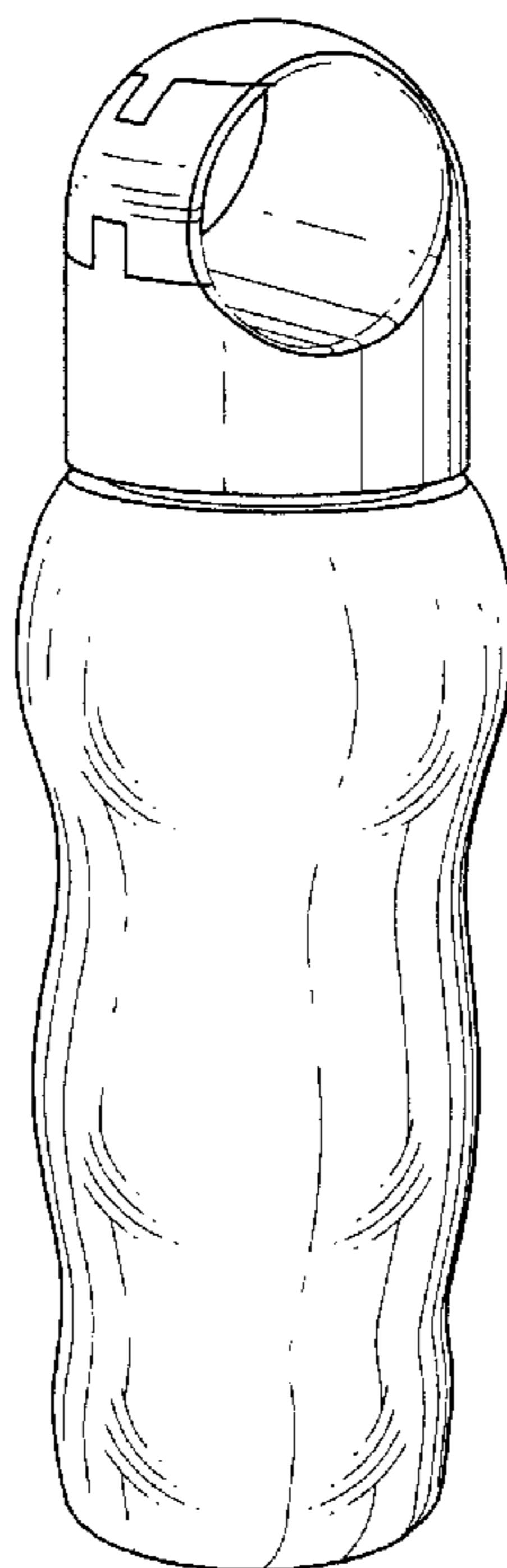
FIG. 4 is a right side view of the beverage container of FIG. 1;

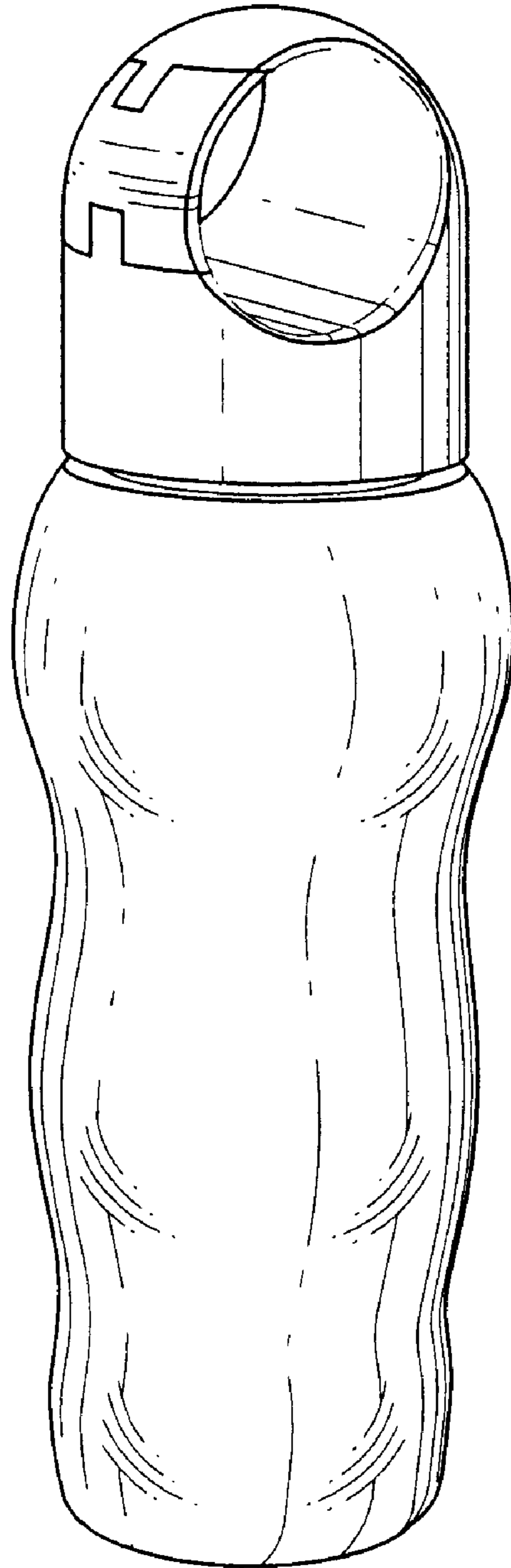

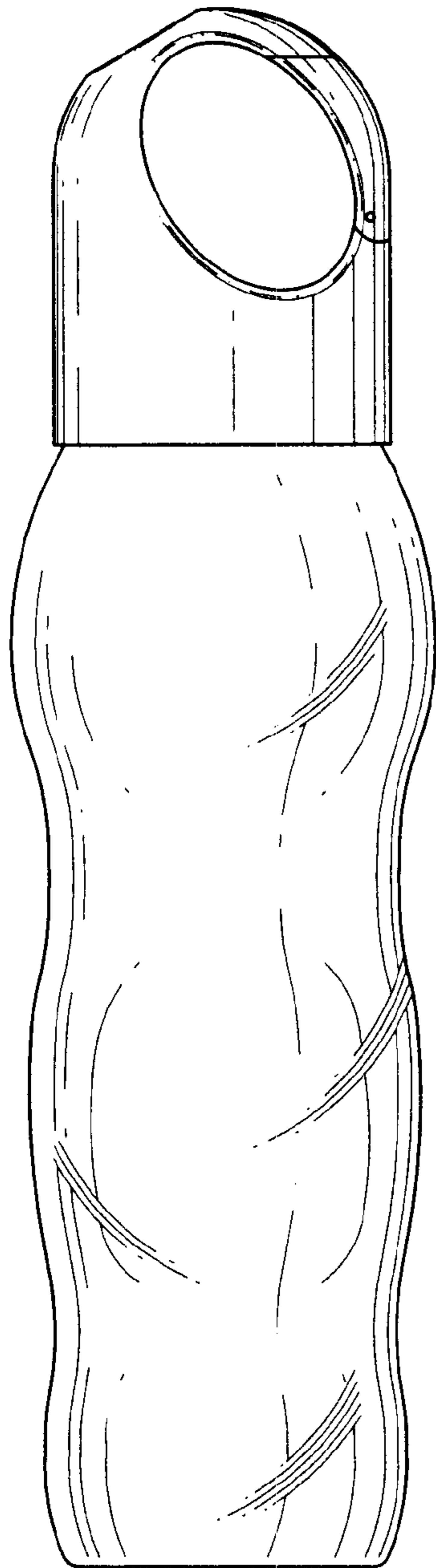

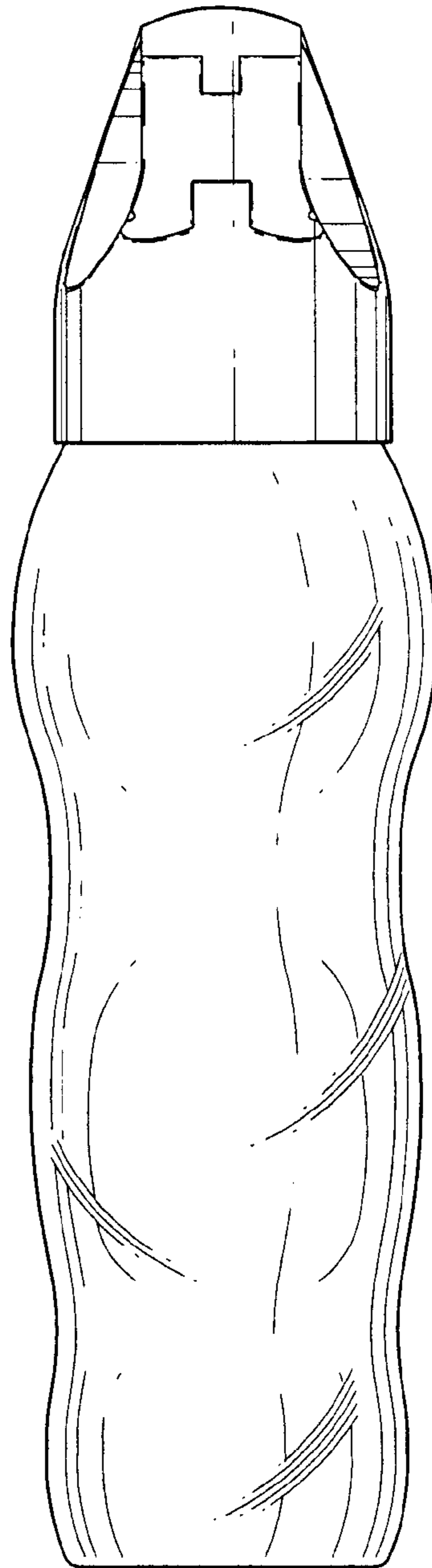

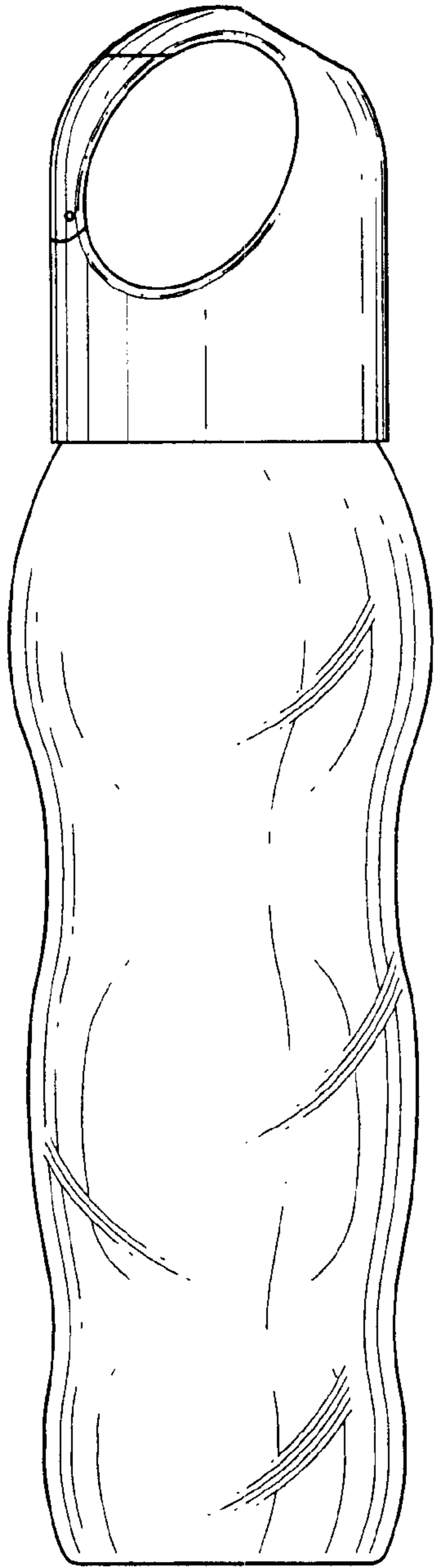

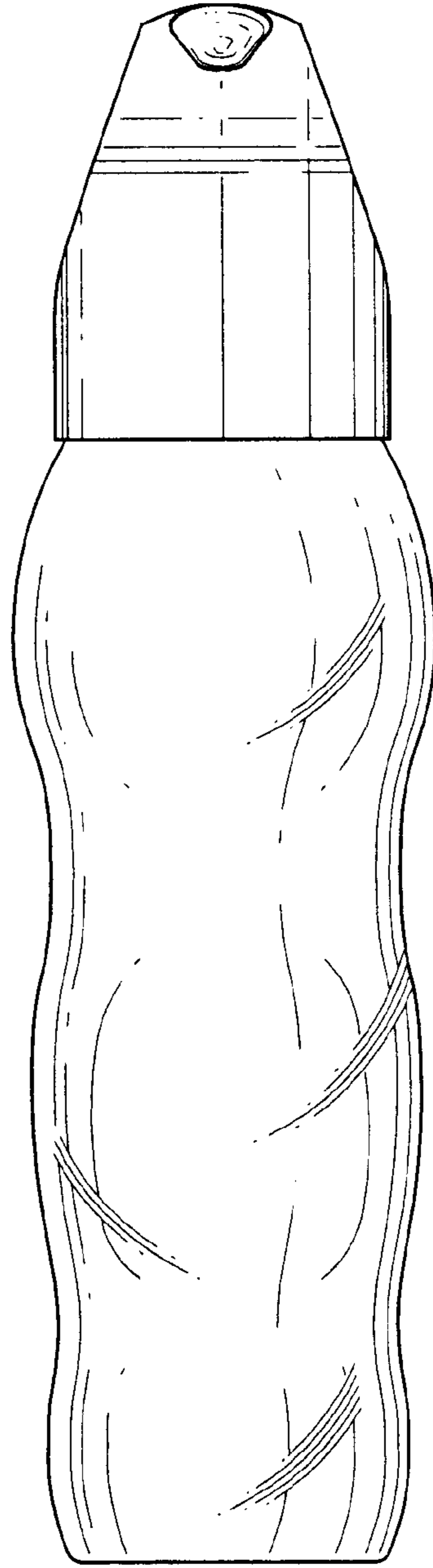

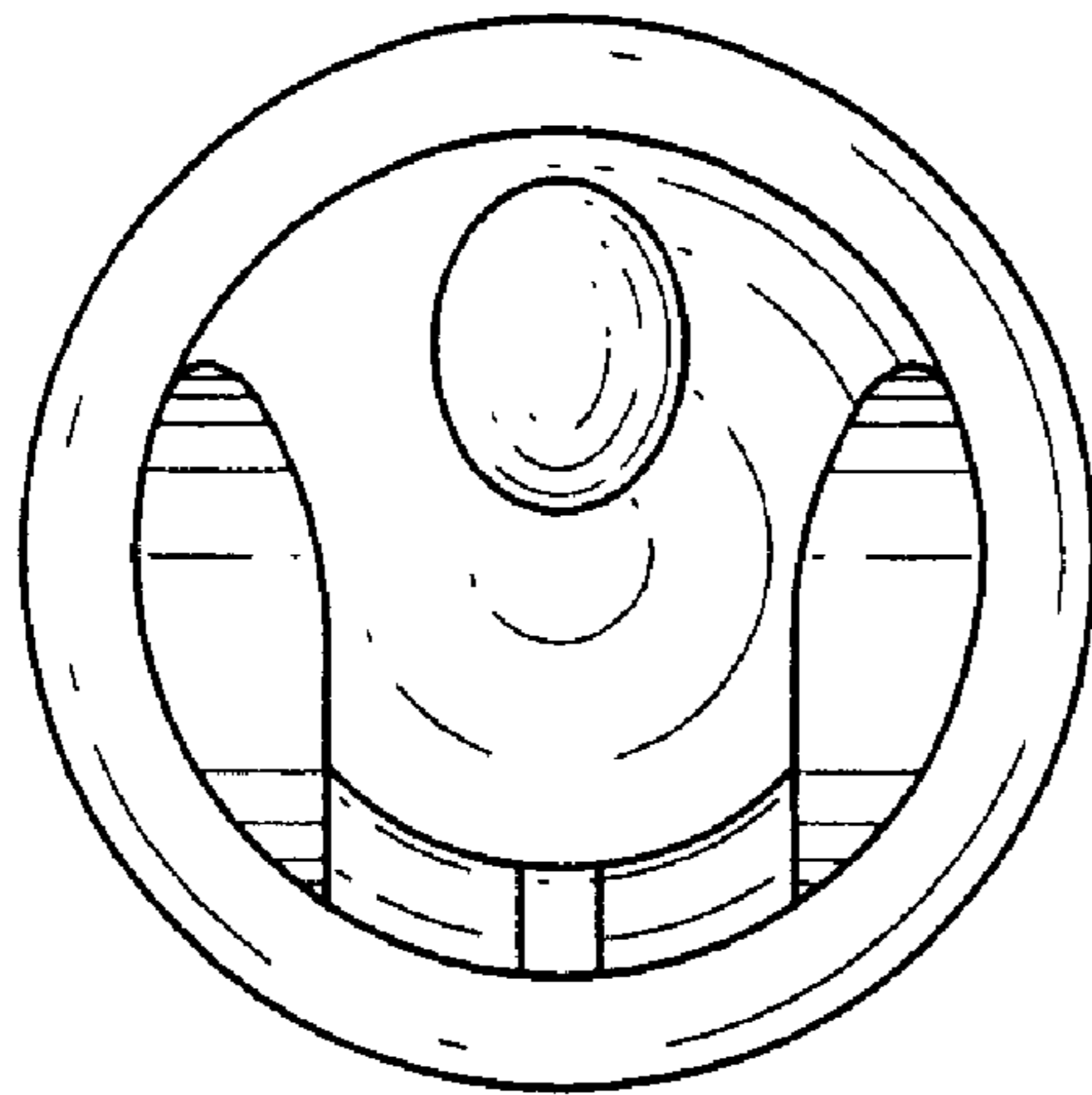

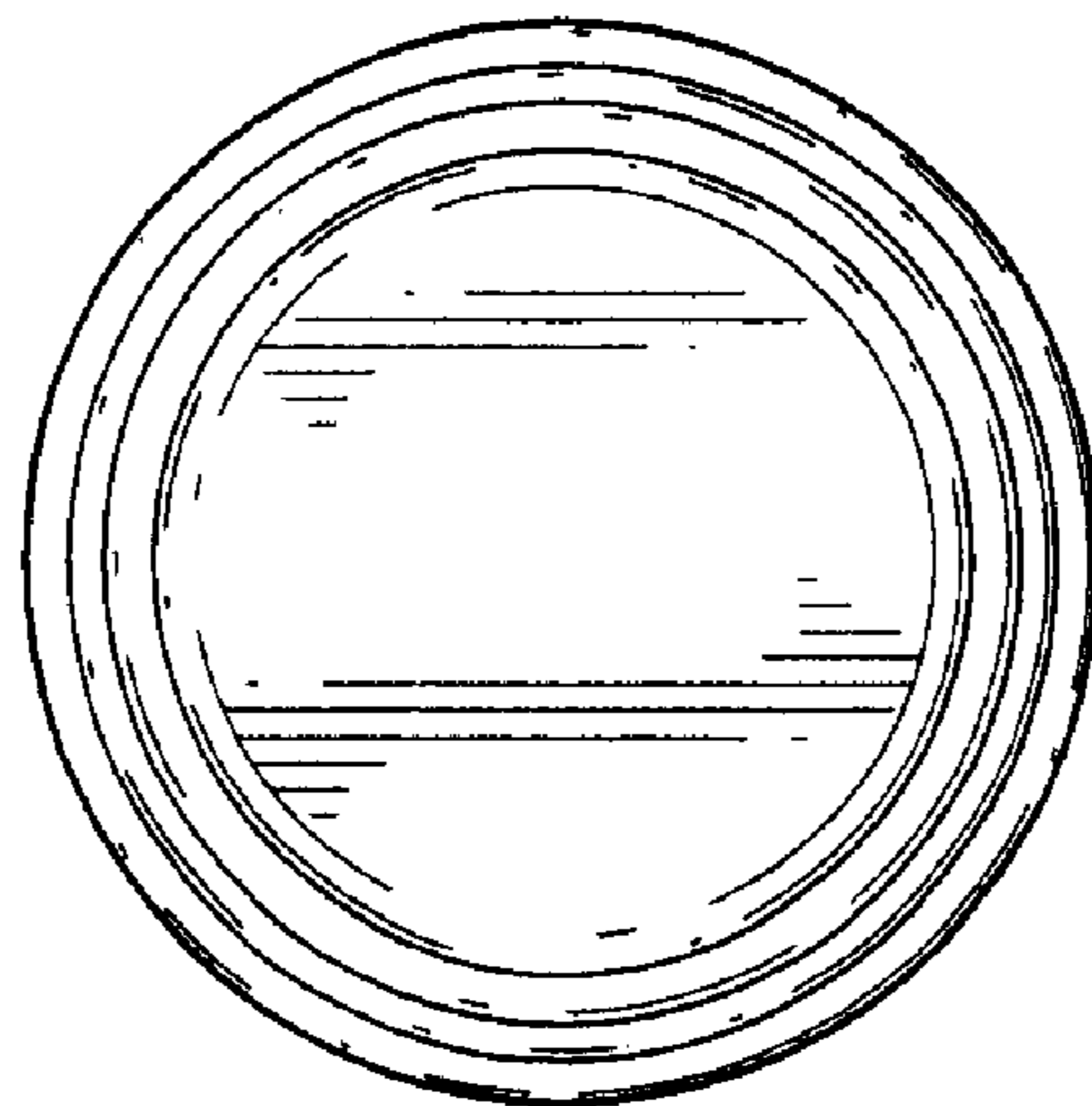
