The ornamental design for a paddle latch, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a paddle latch showing a first embodiment of our new design.

FIG. 26 is a left side elevational view of the paddle latch of FIG. 22.

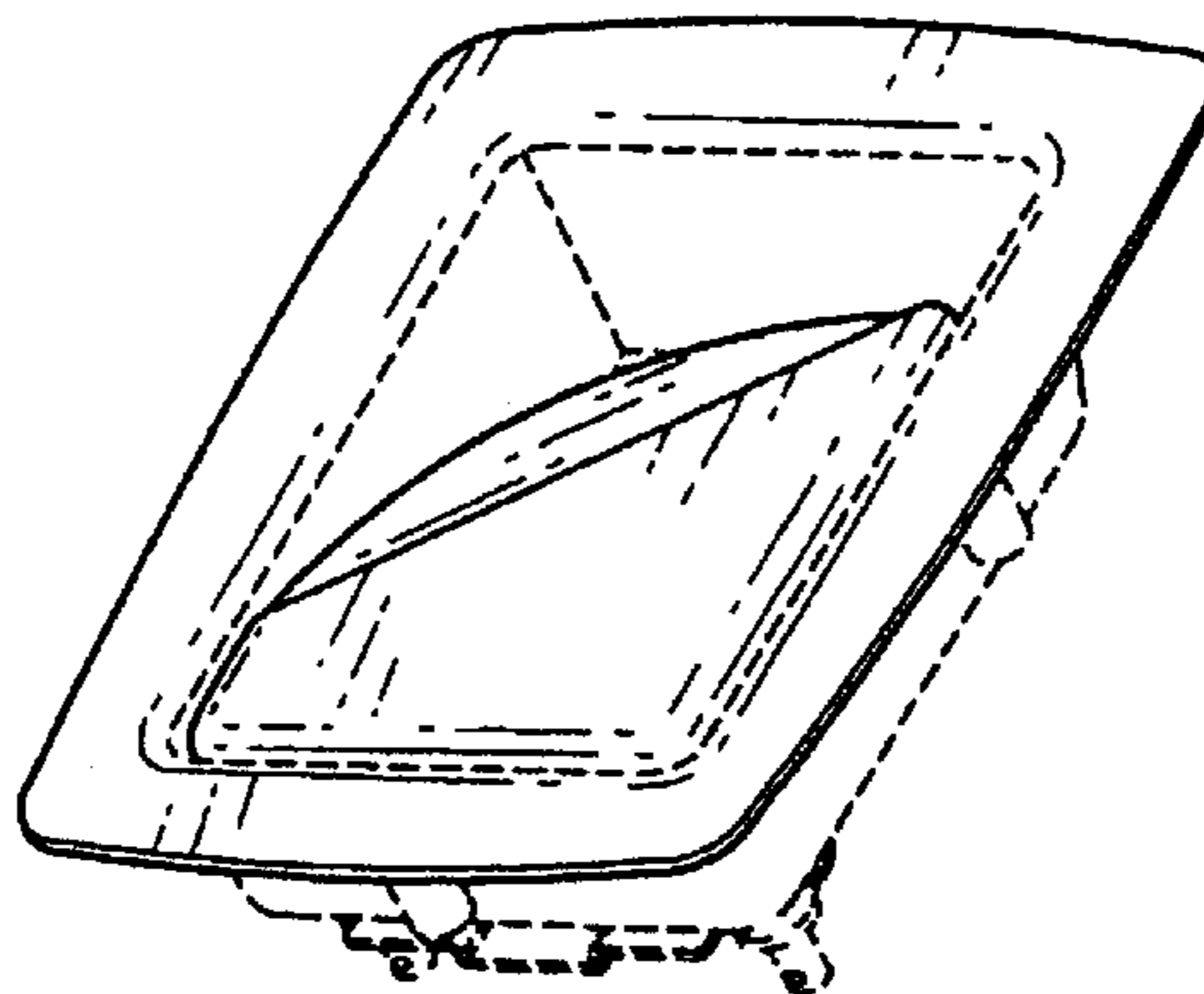
FIG. 27 is a bottom plan view of the paddle latch of FIG. 22; and,

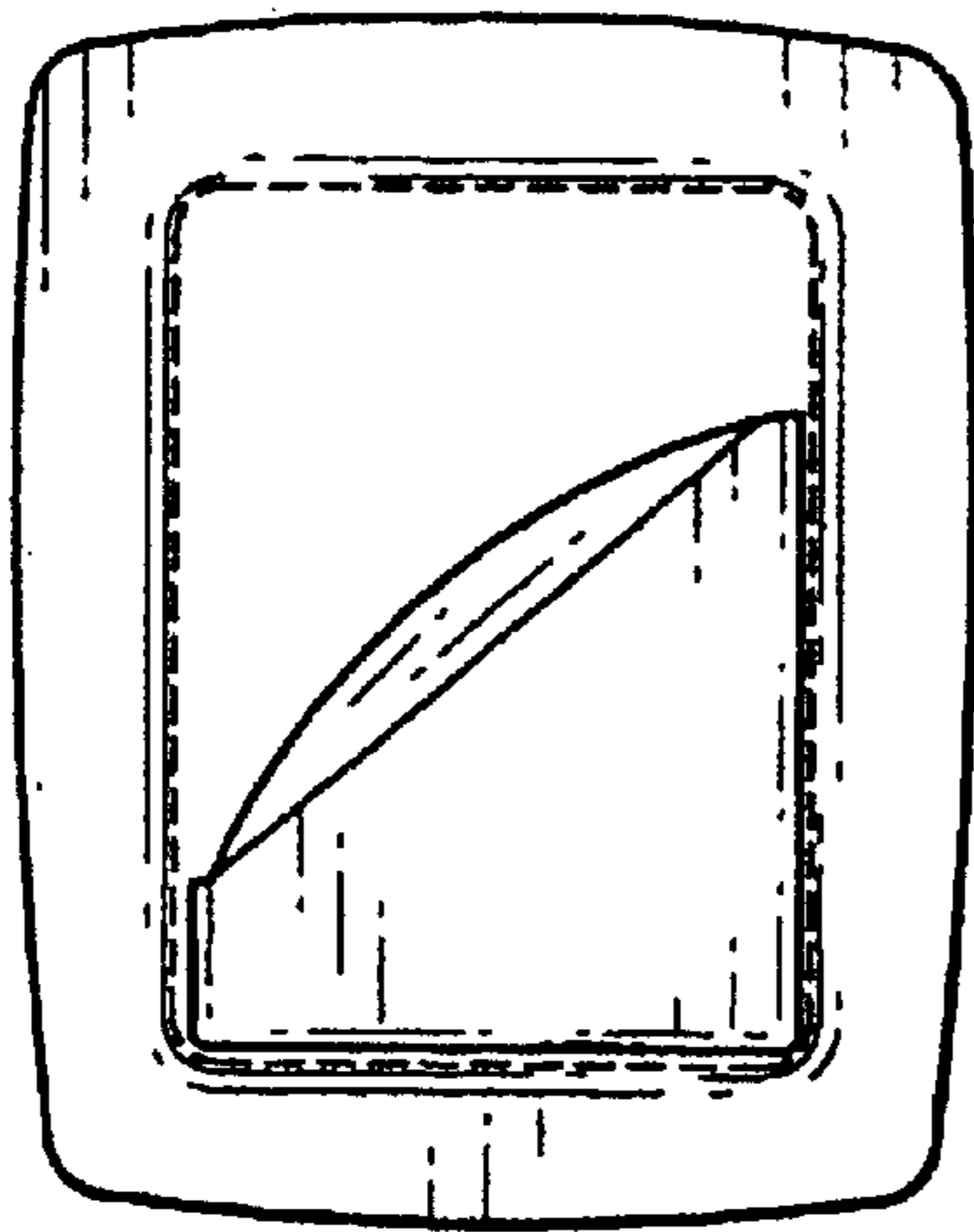

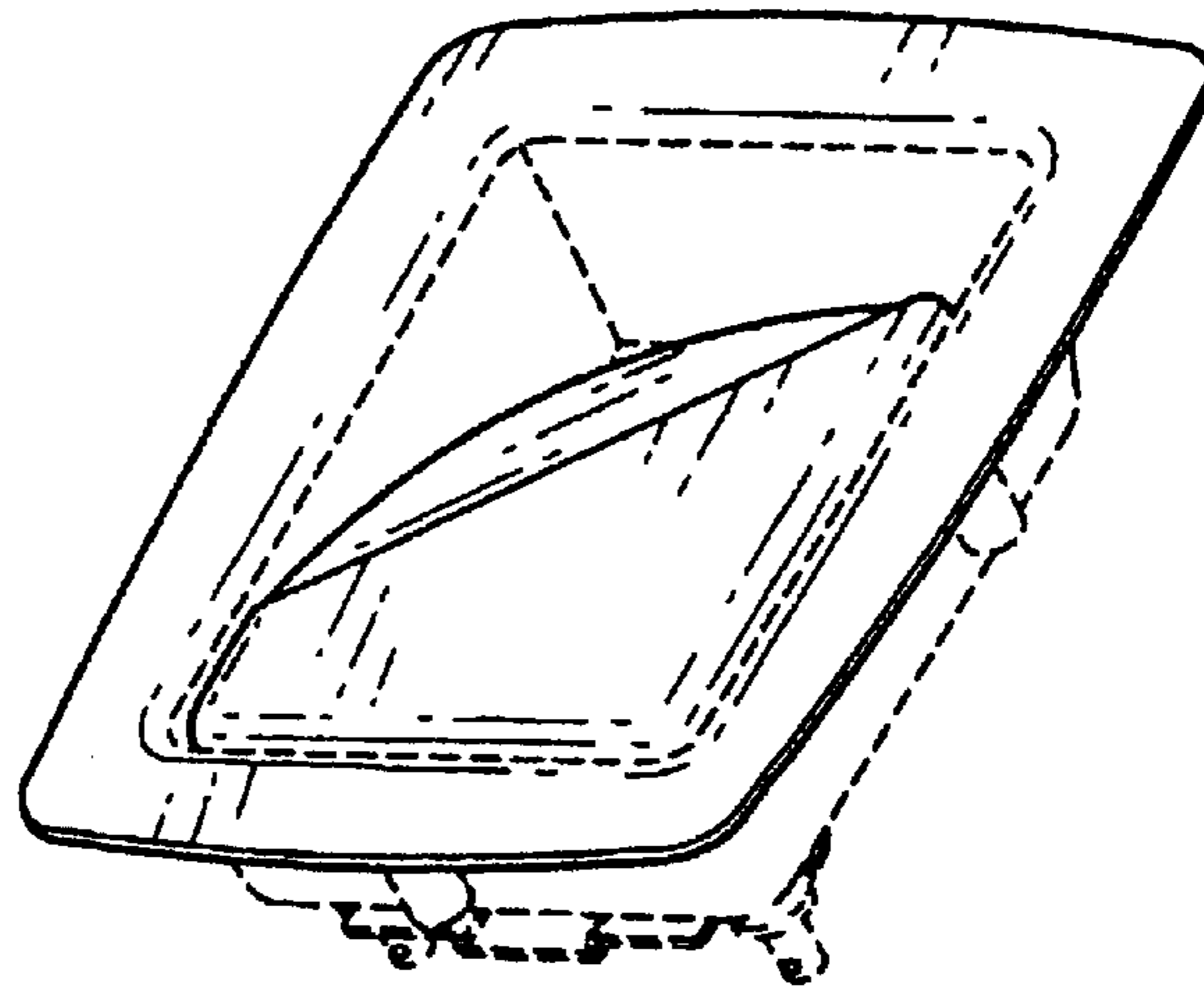

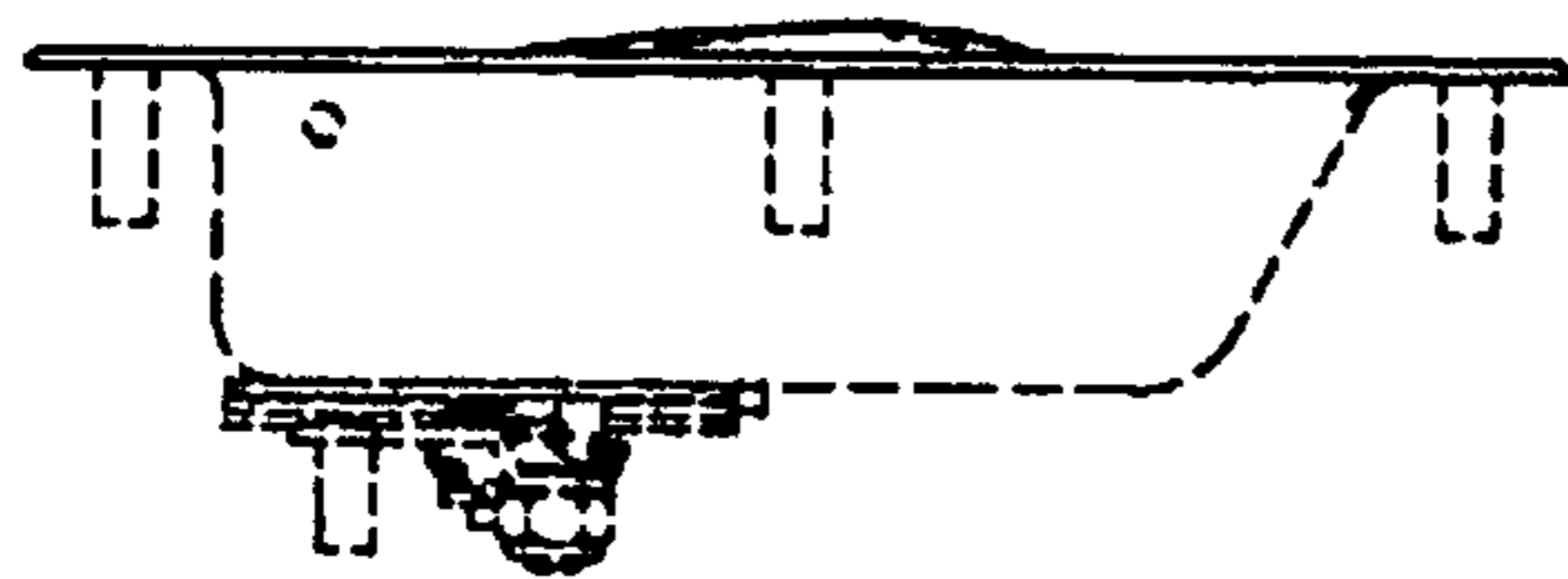

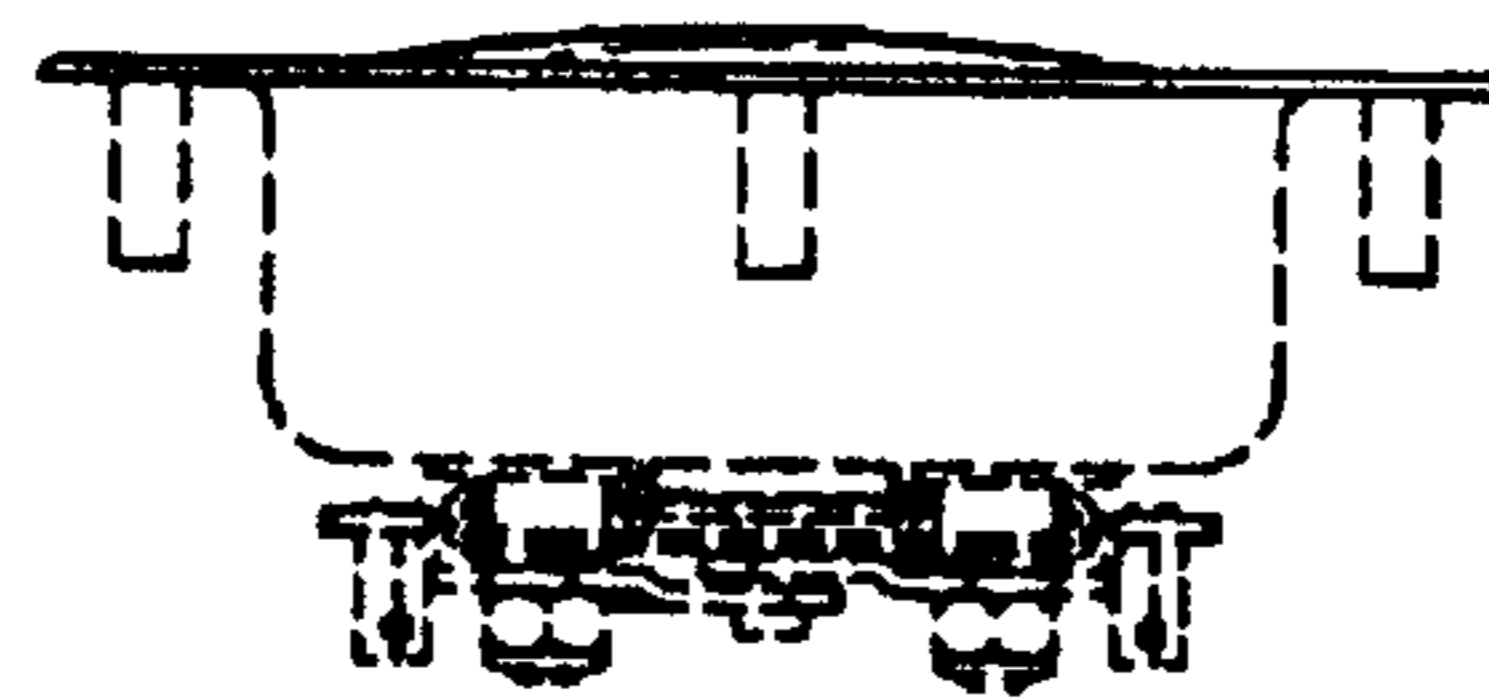

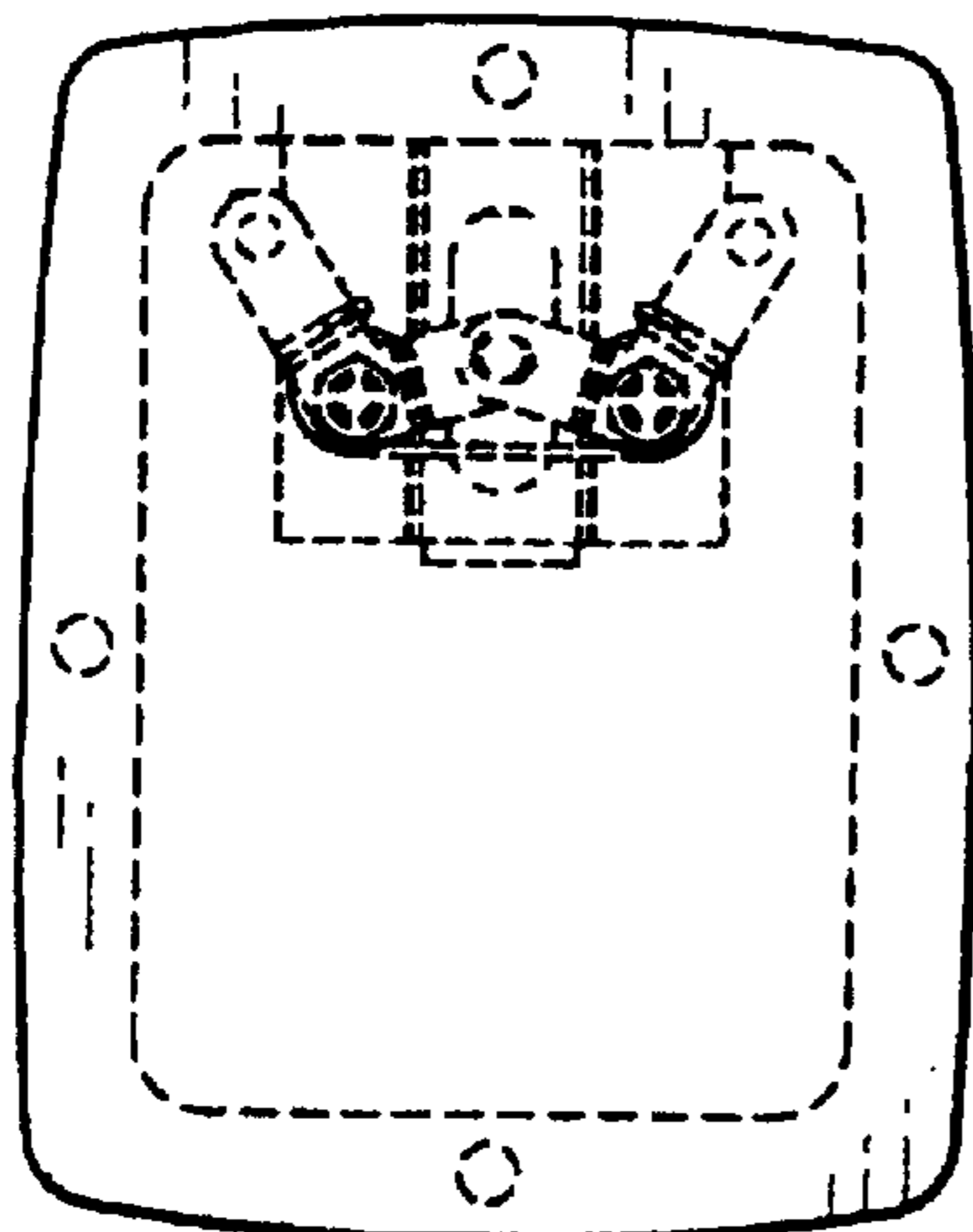

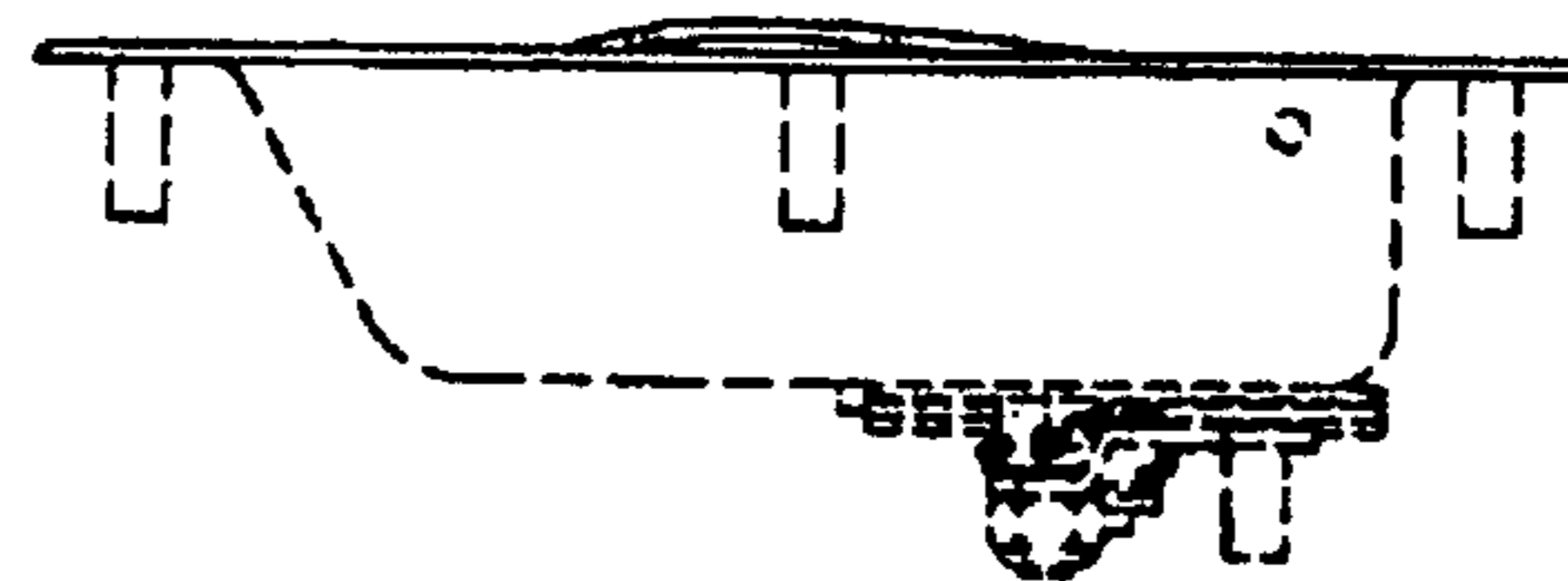

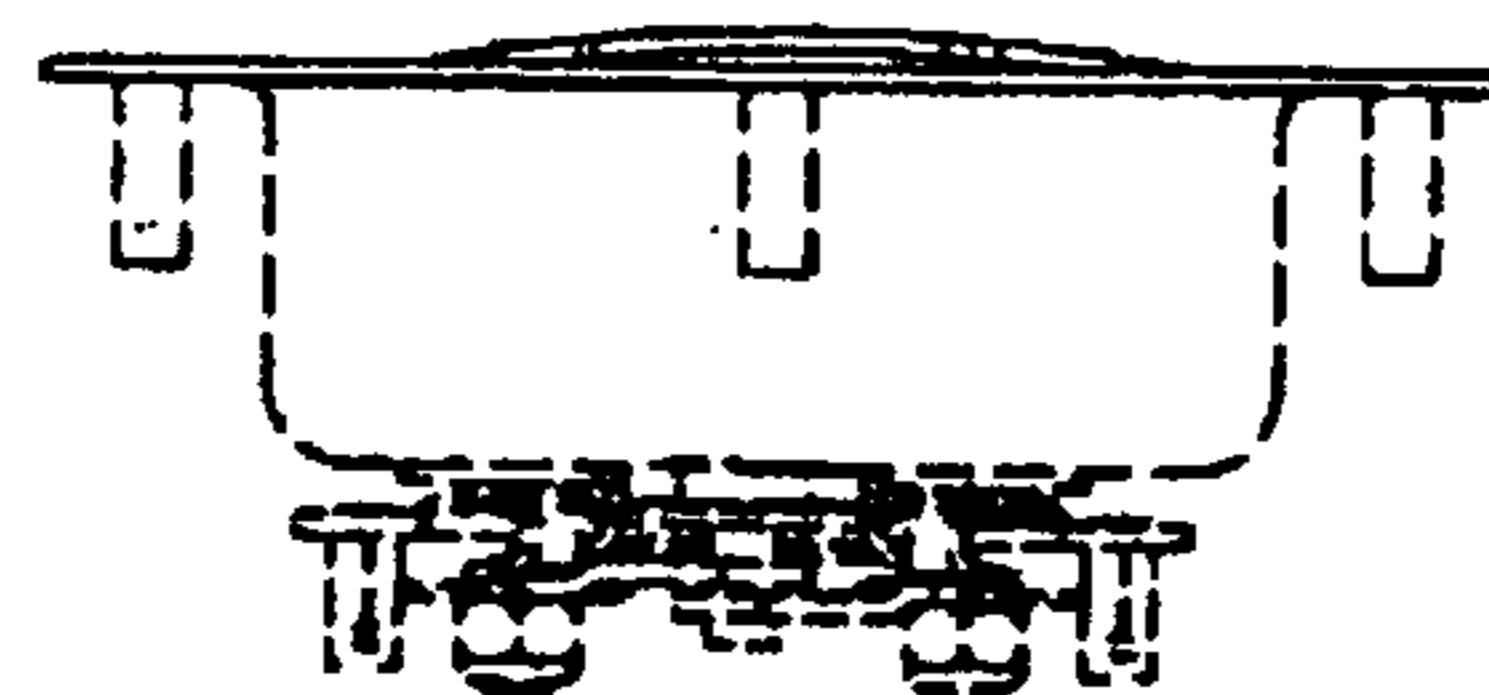

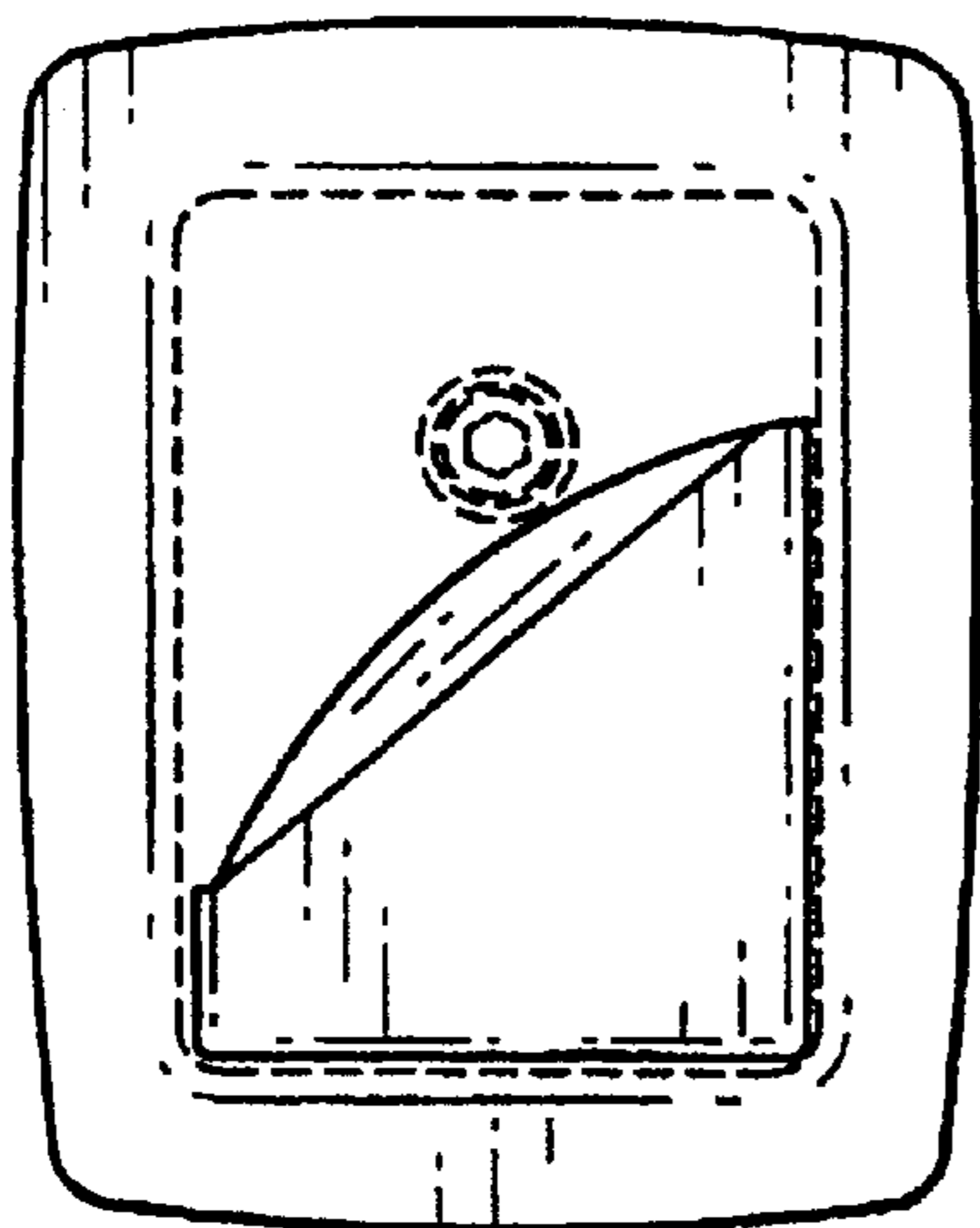

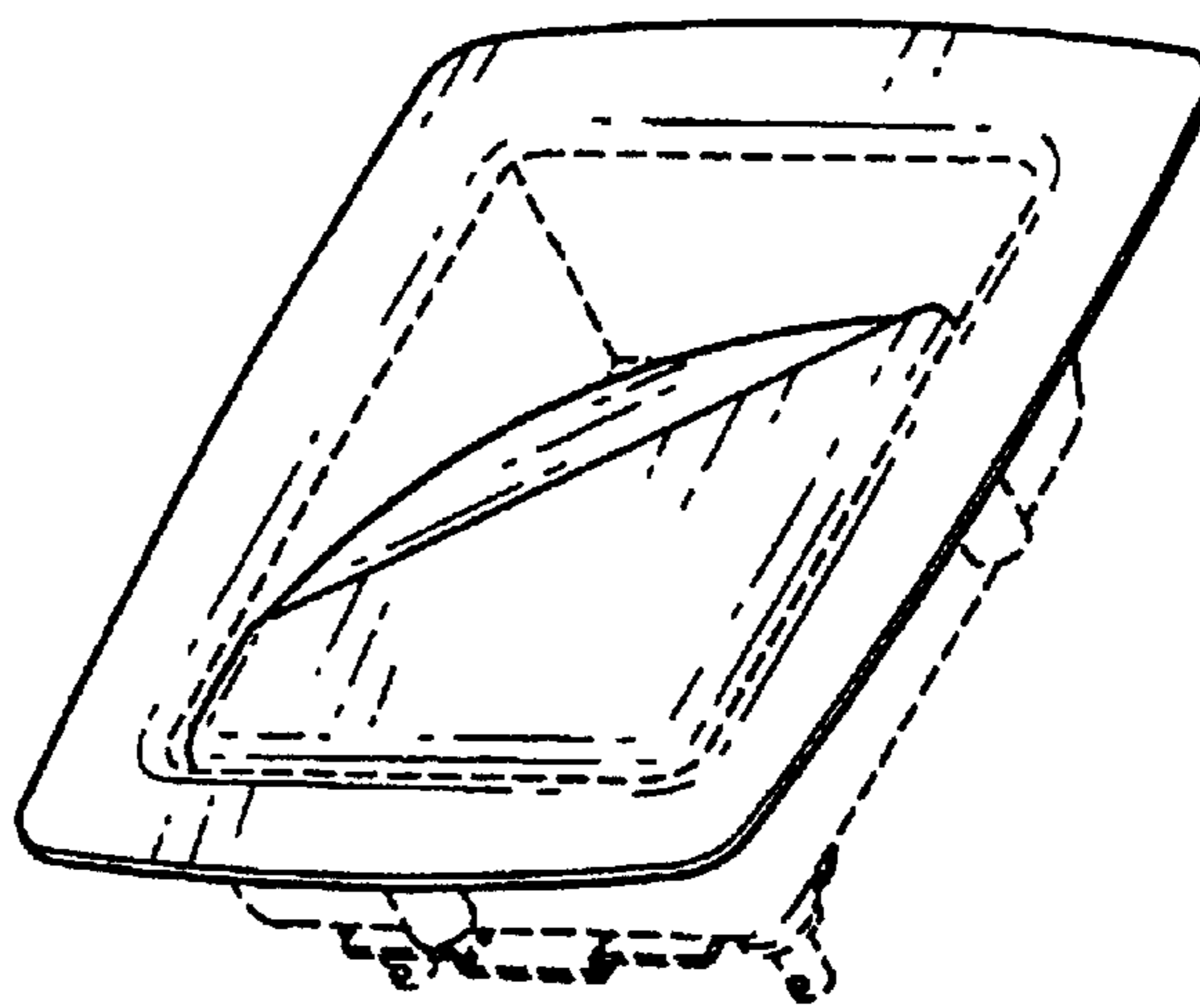

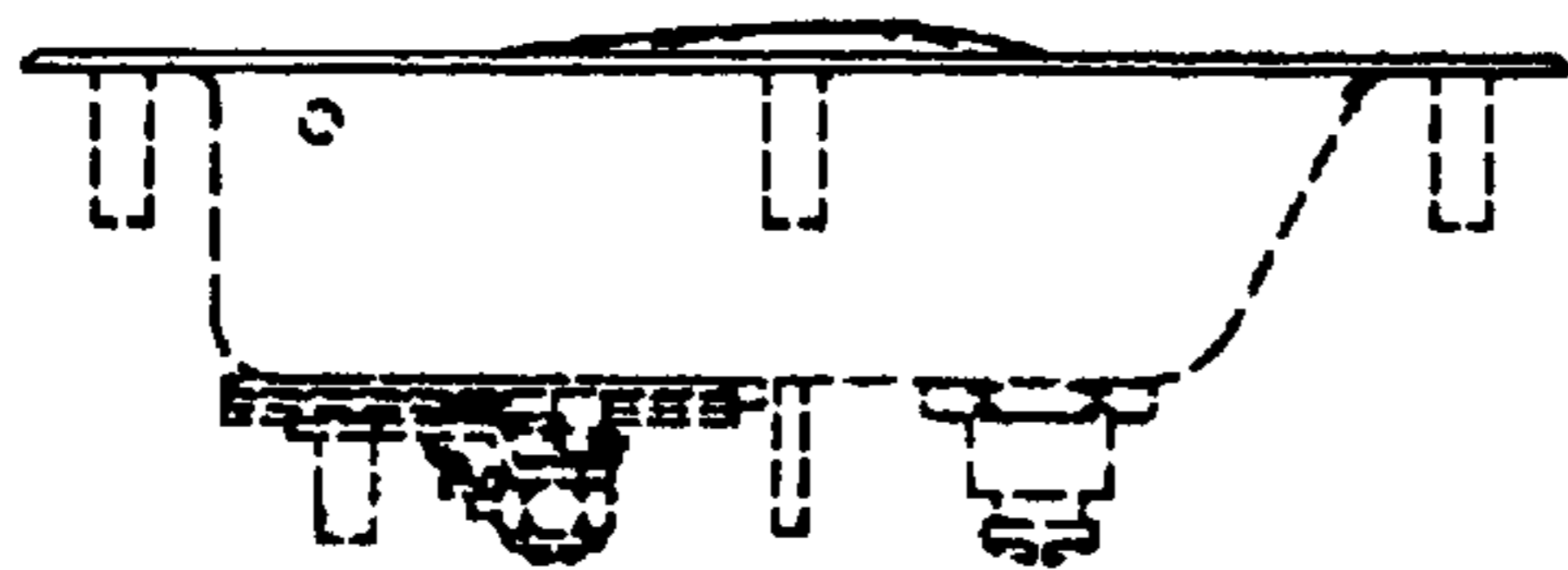

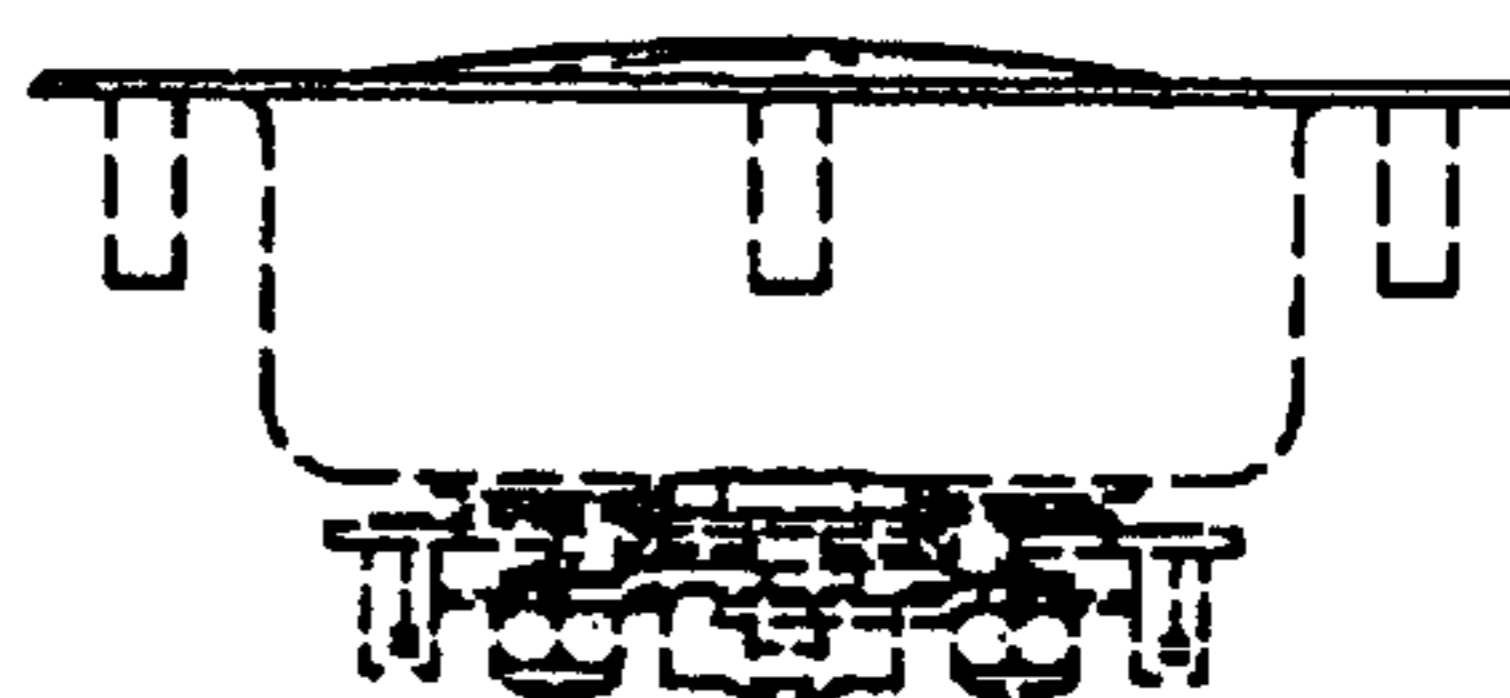

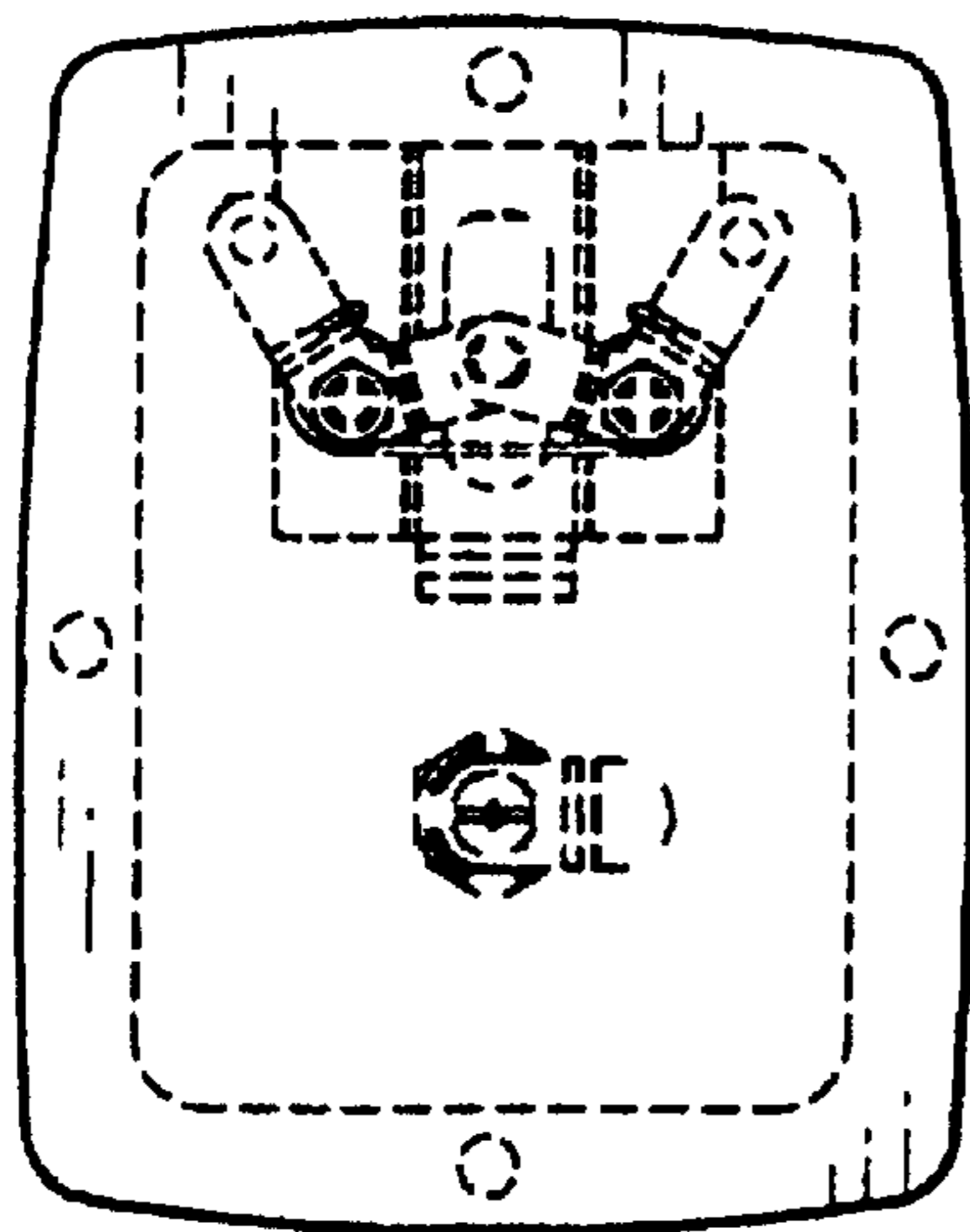

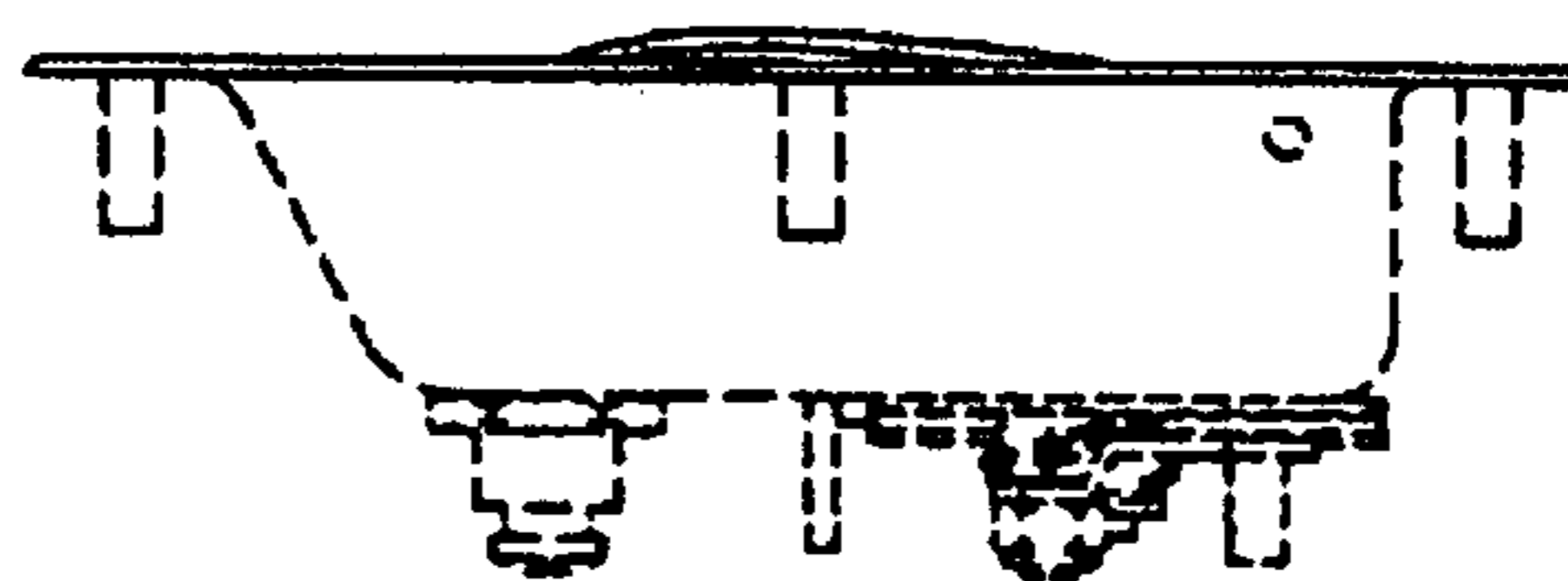

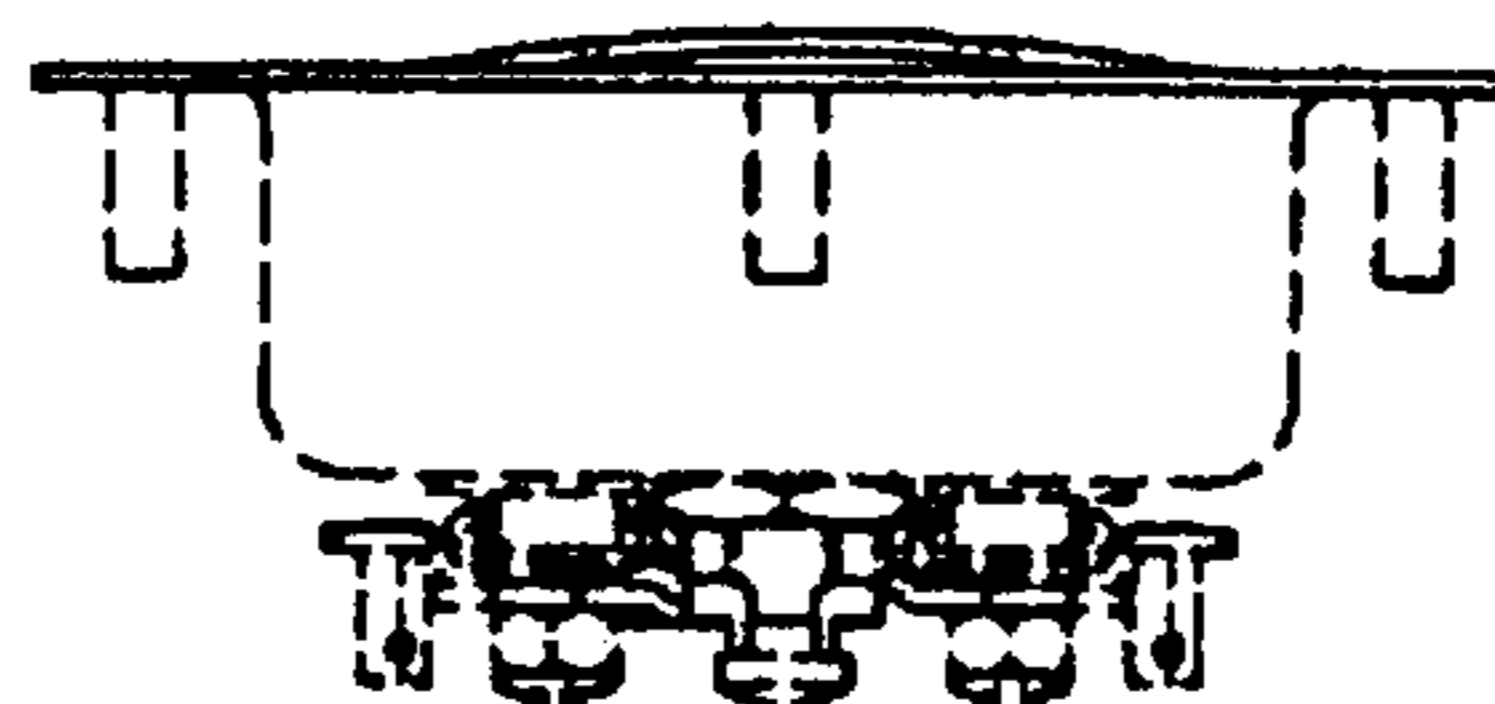
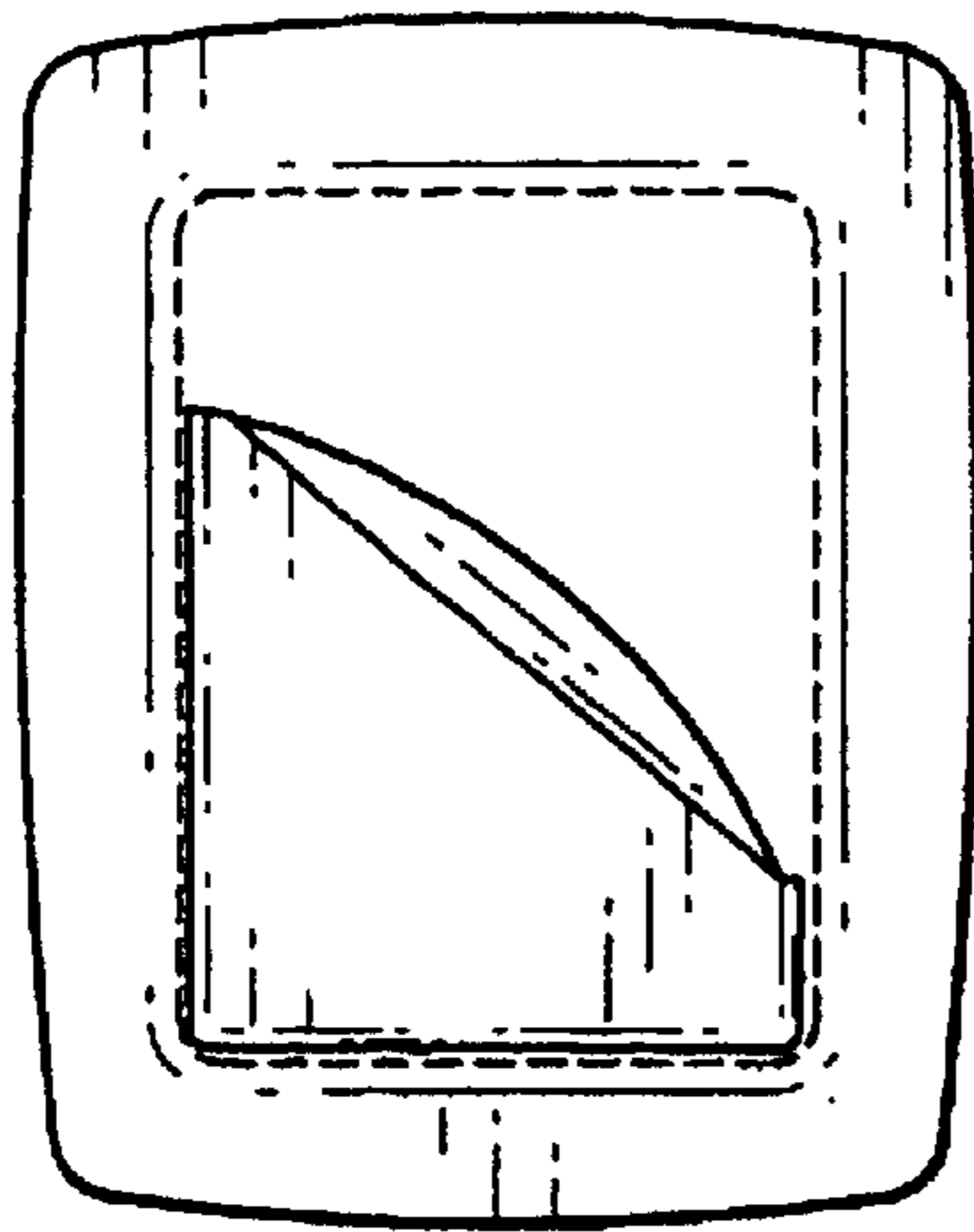
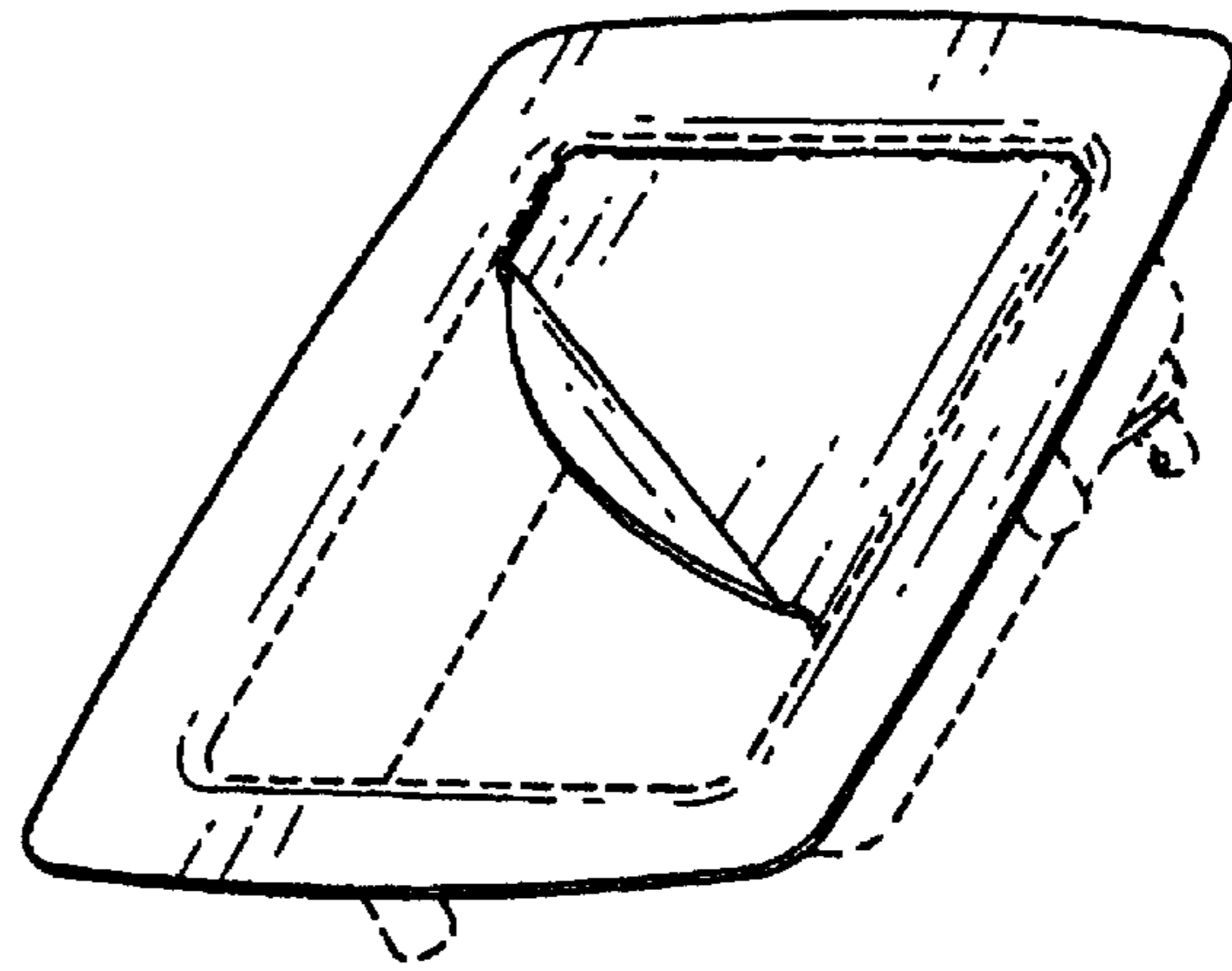


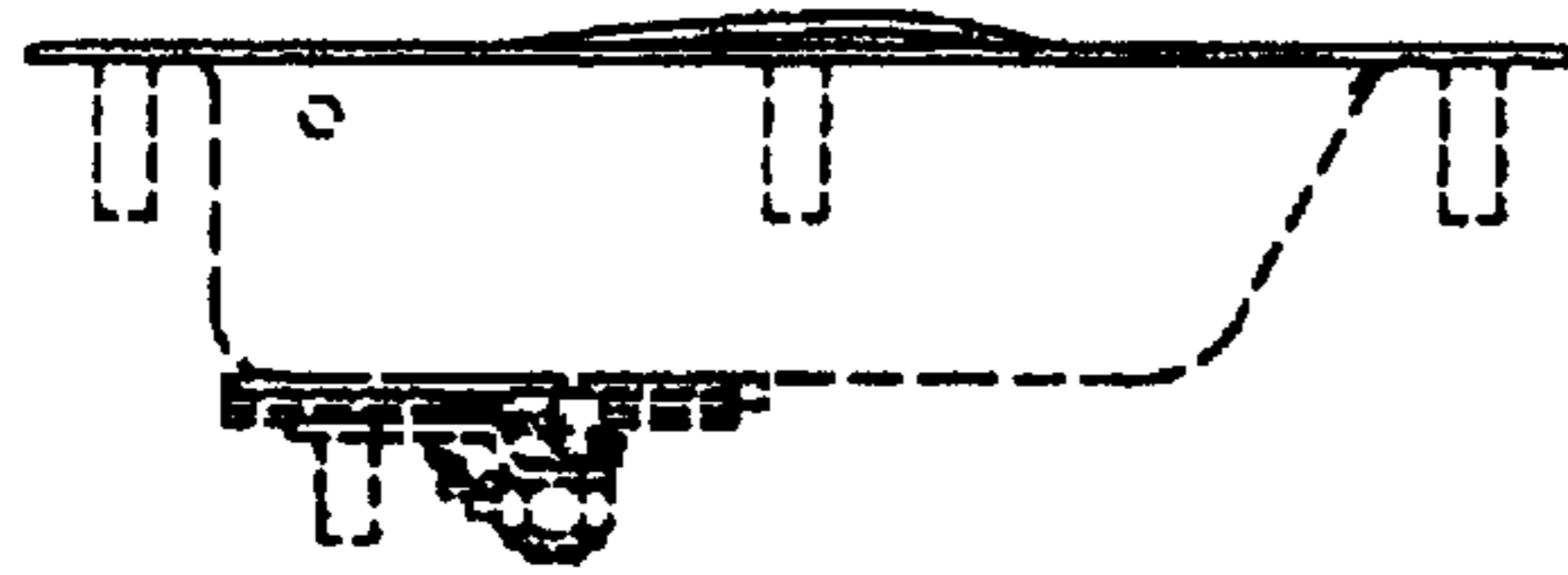

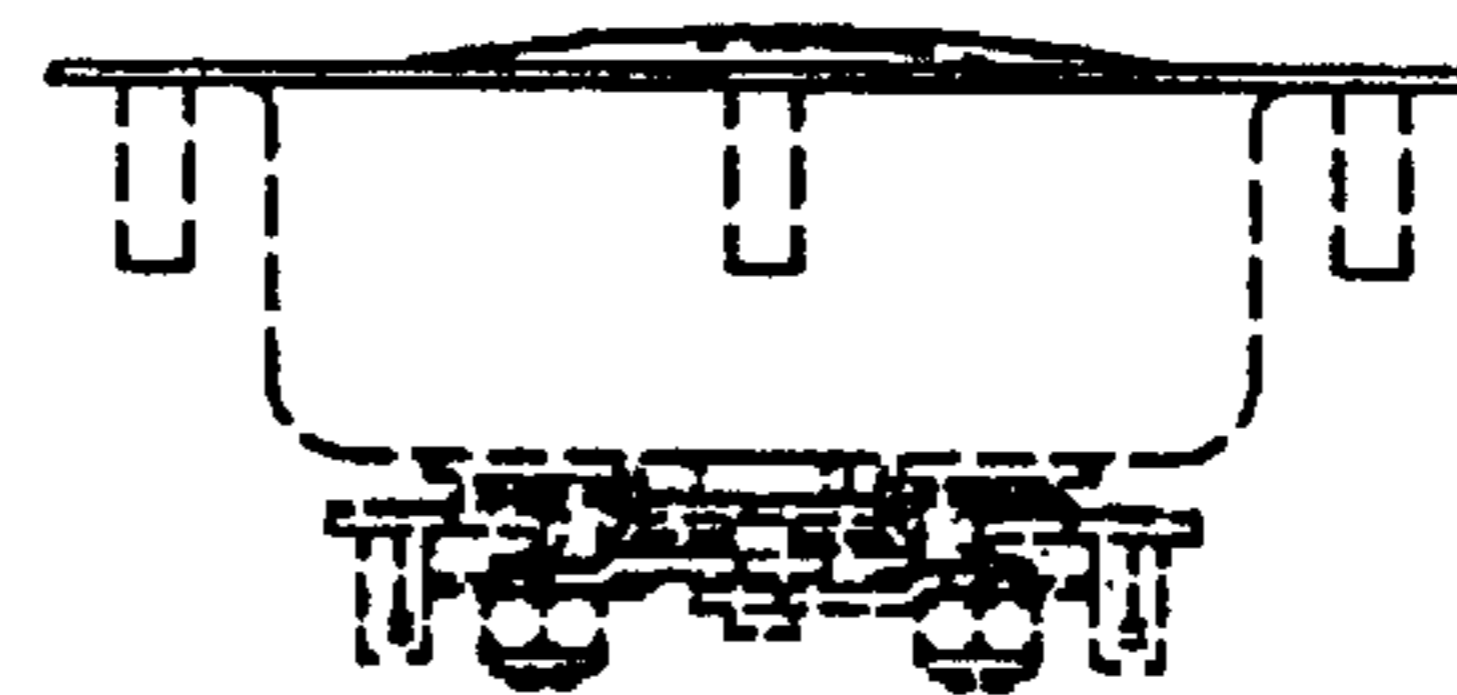

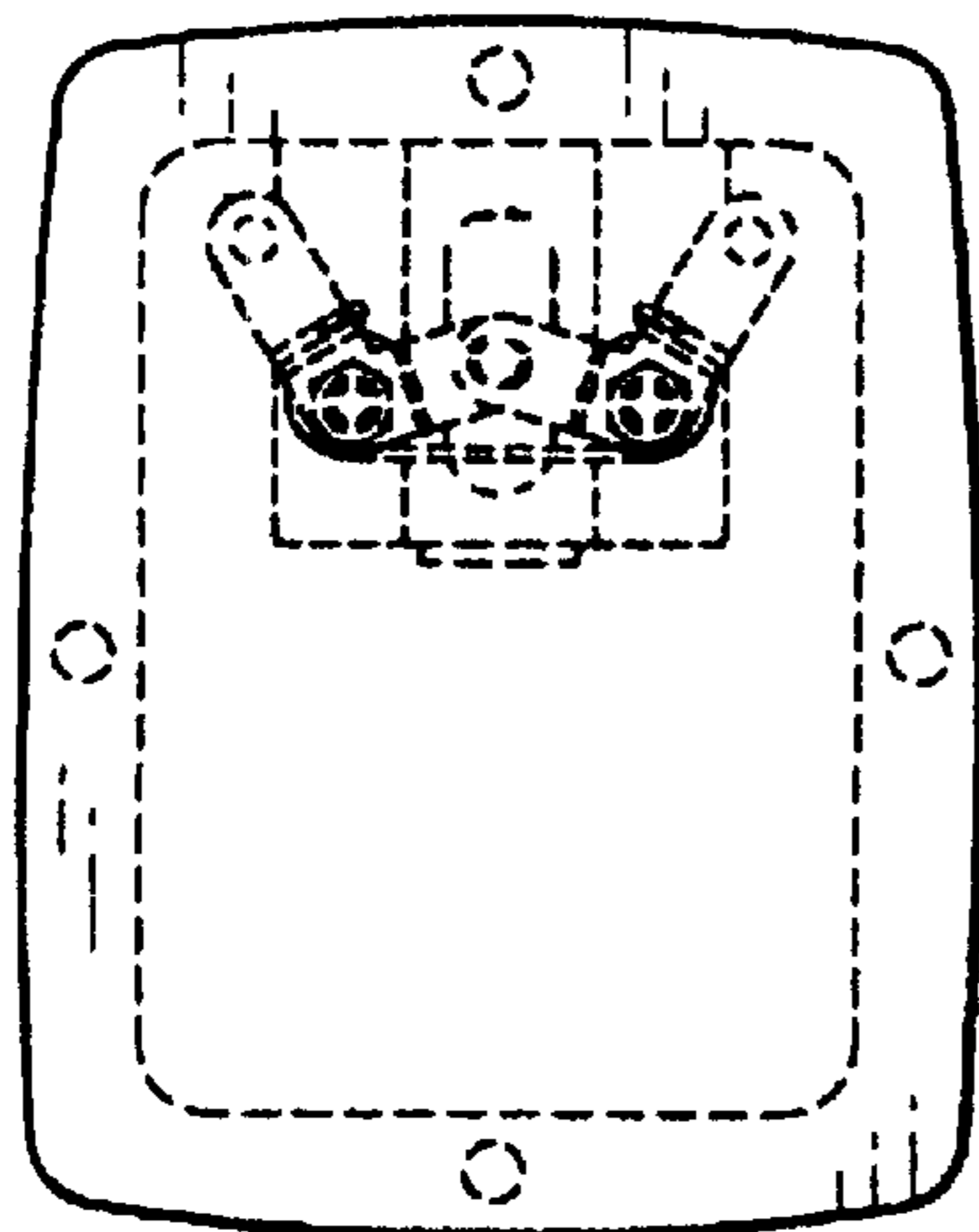

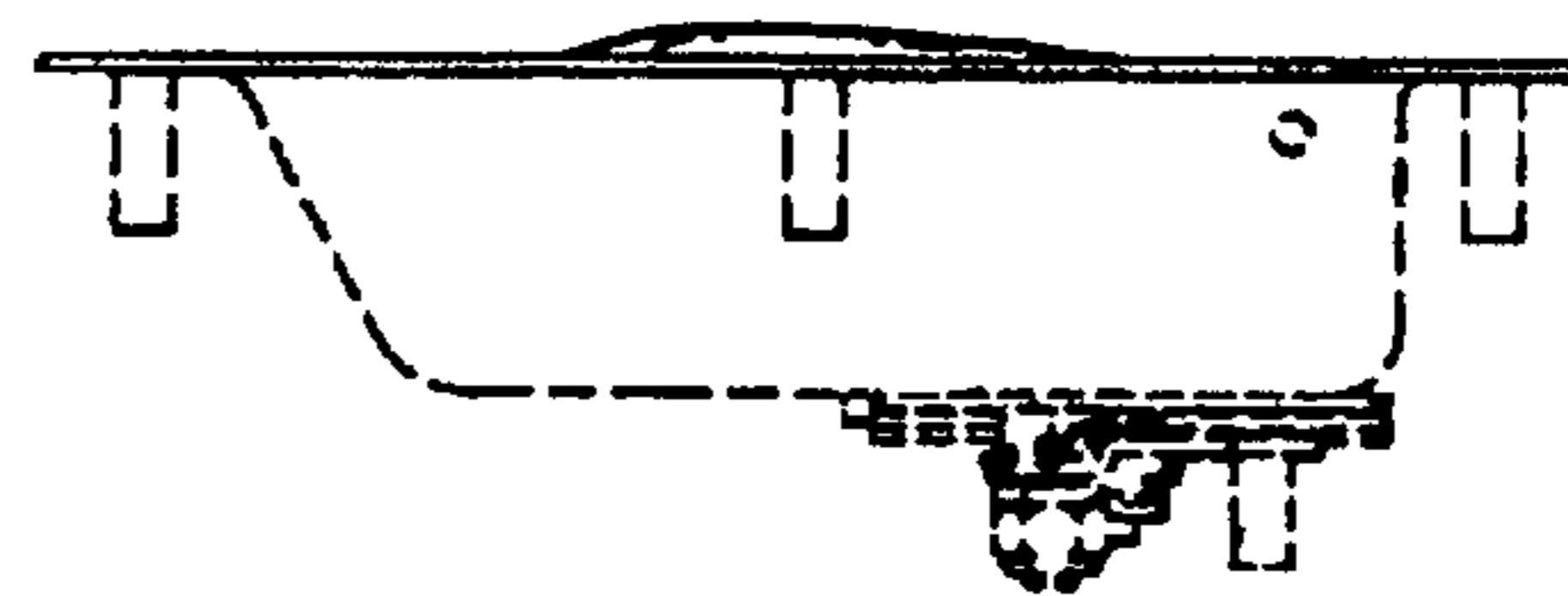

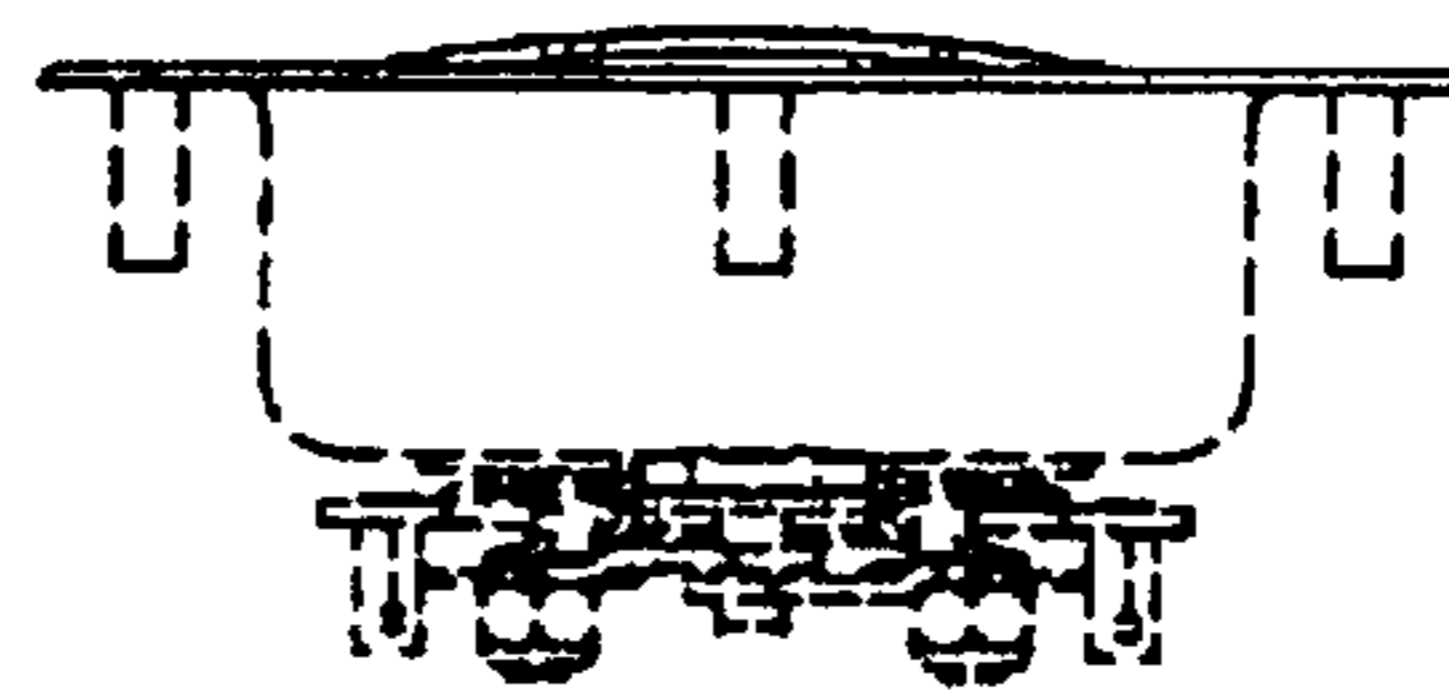

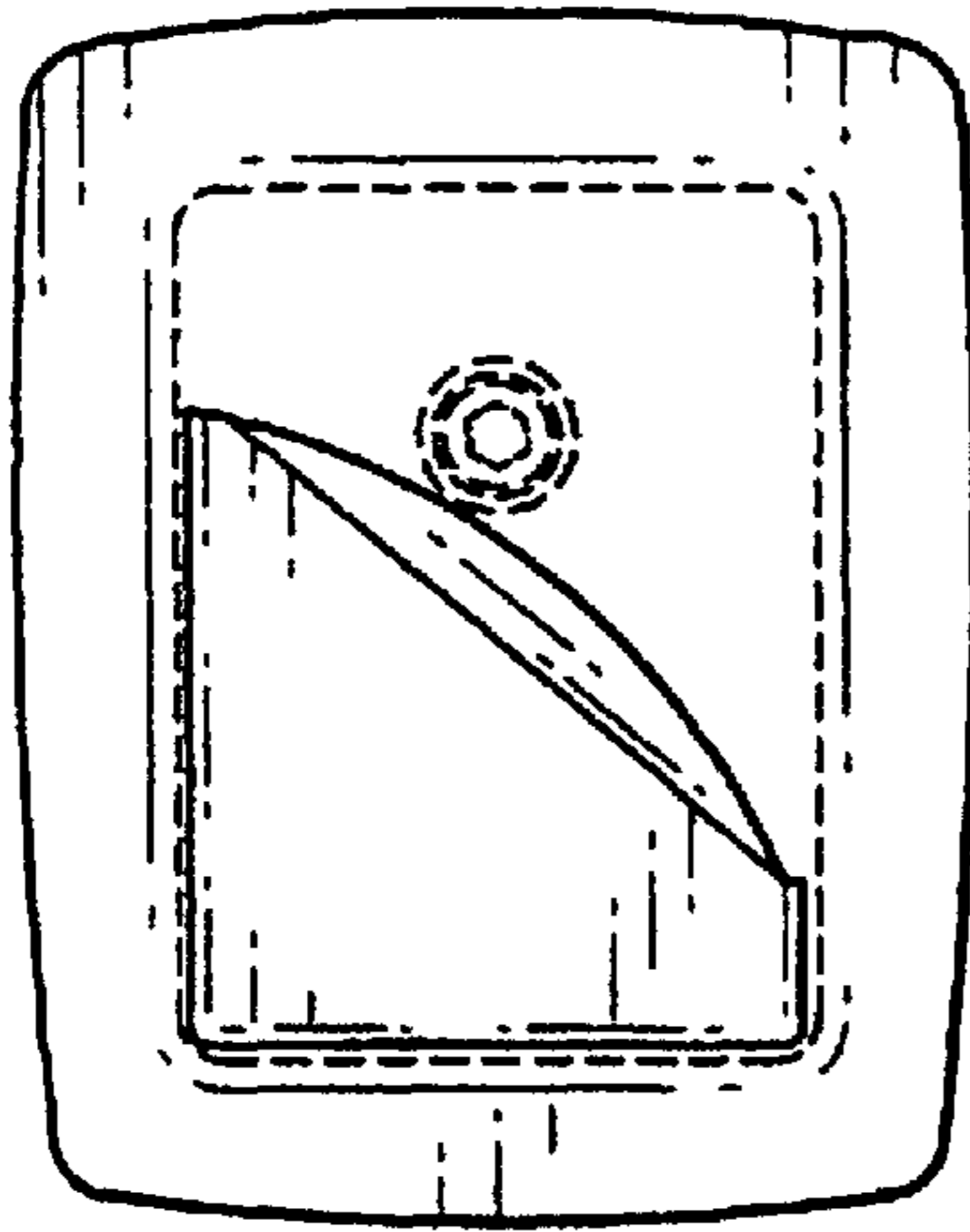

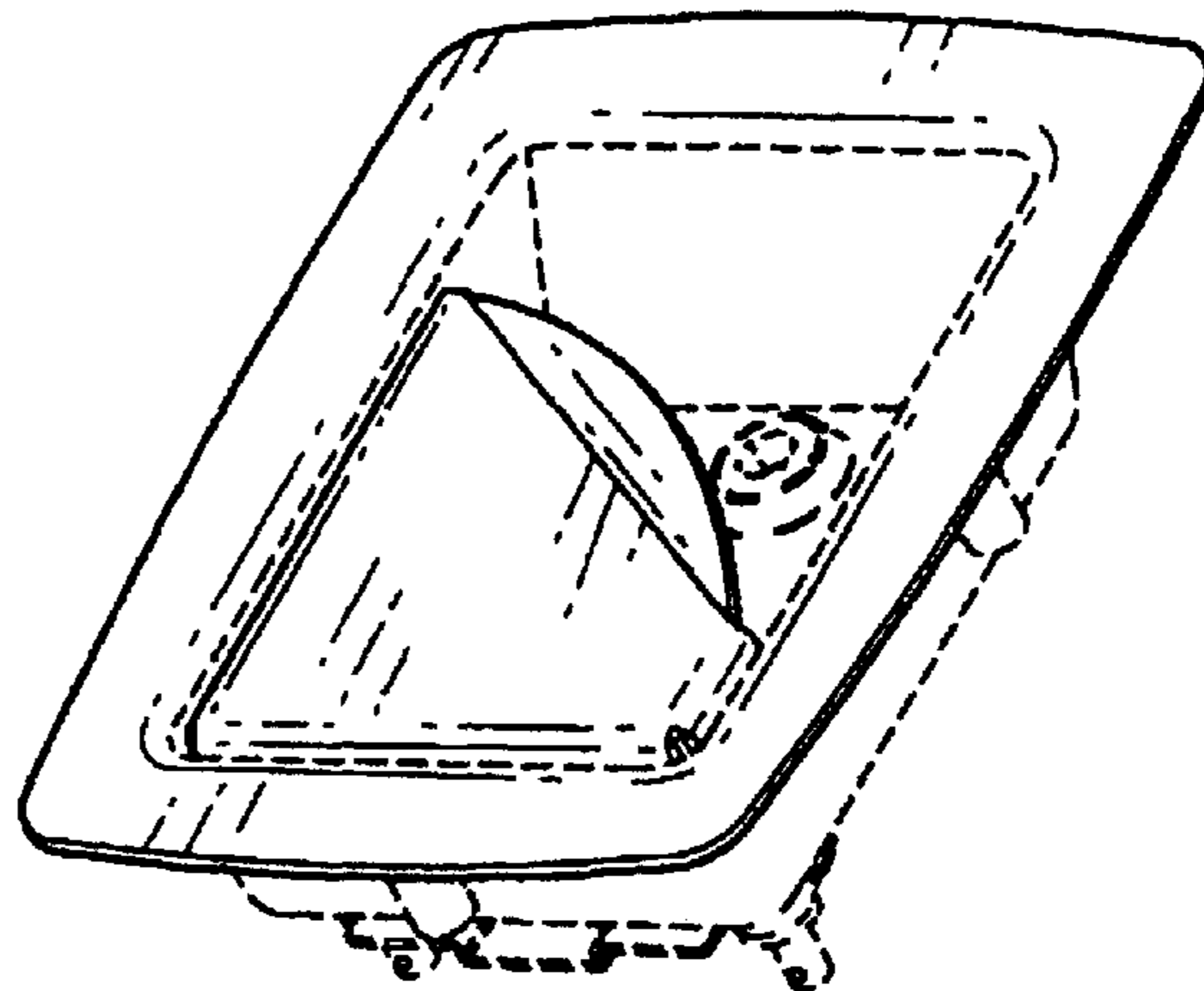

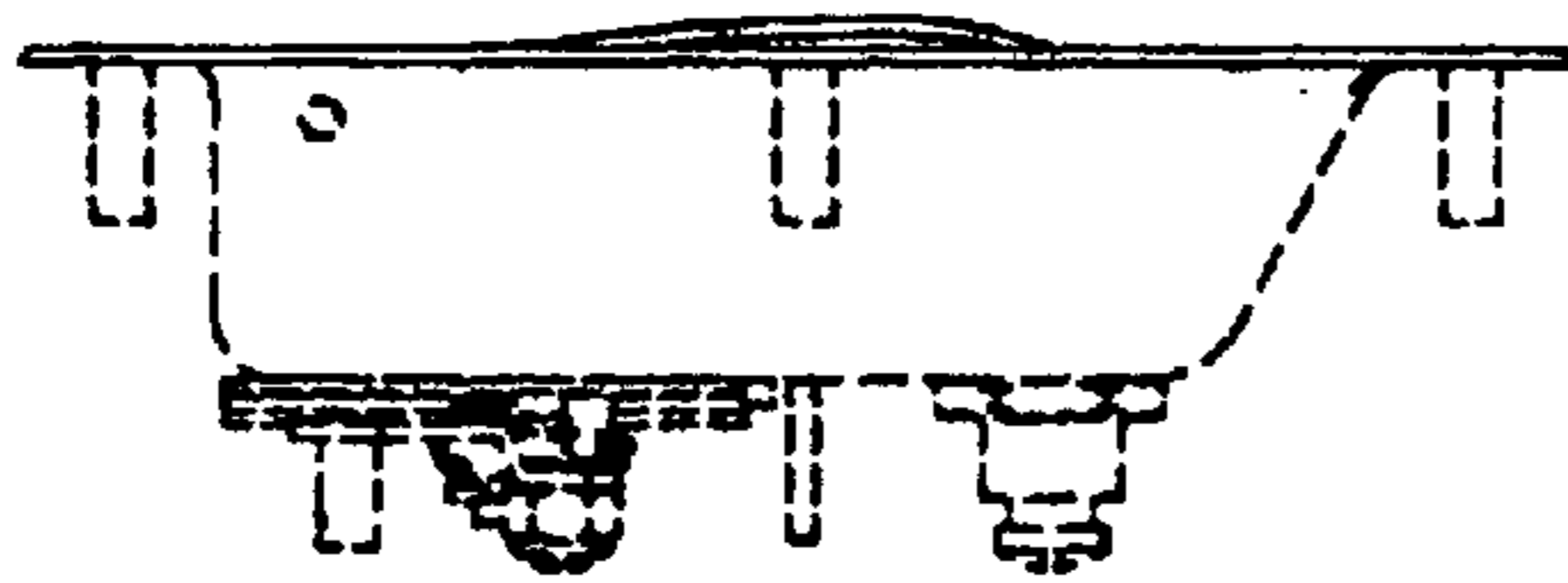

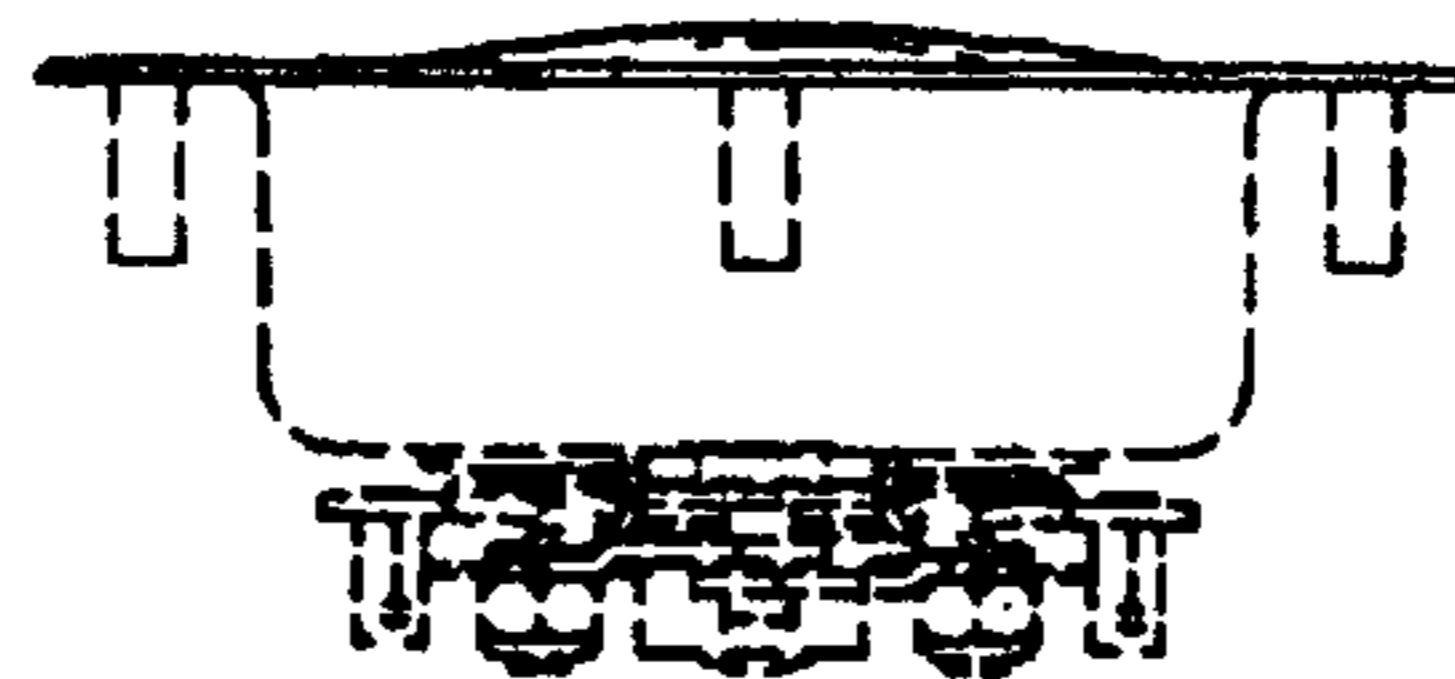

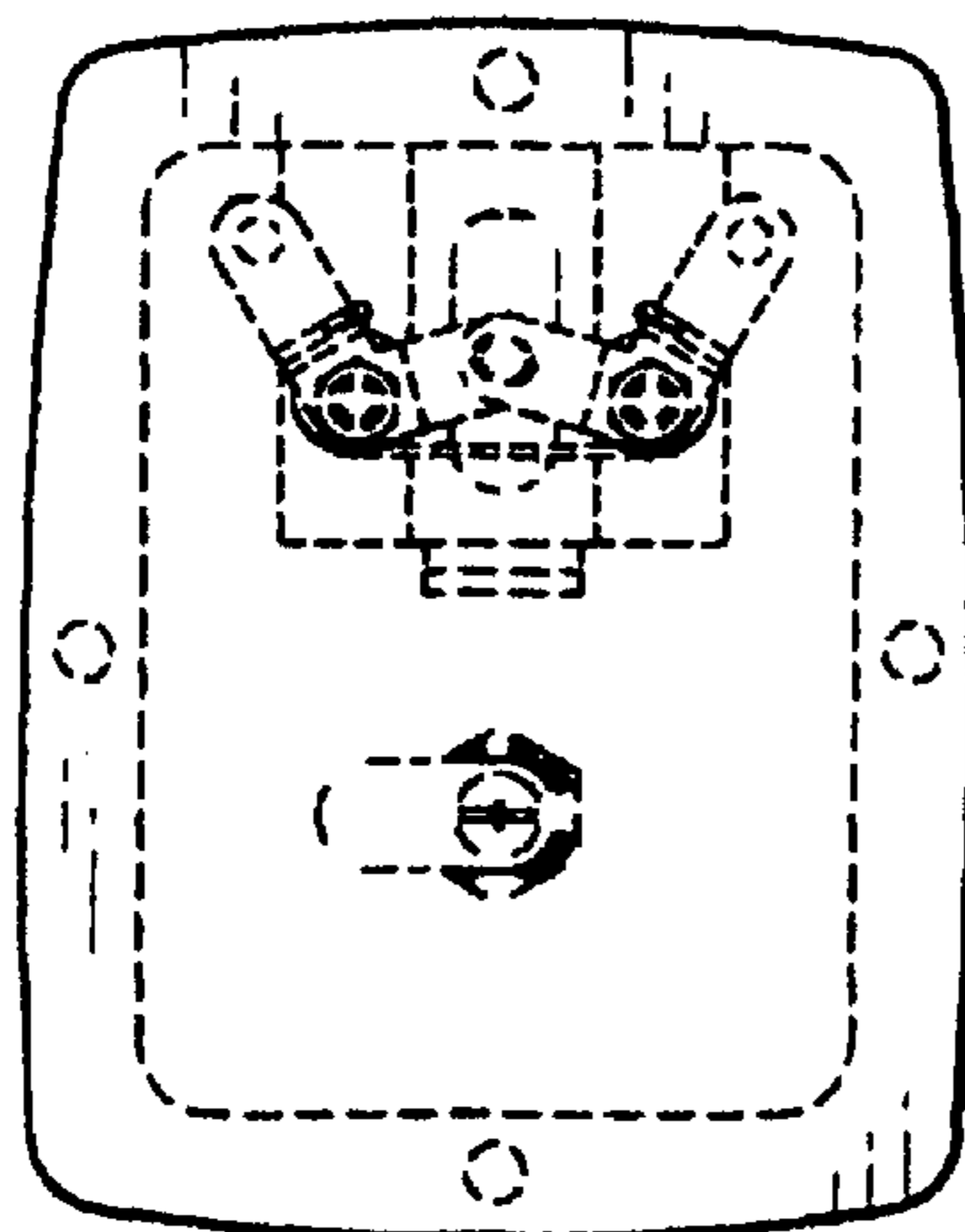

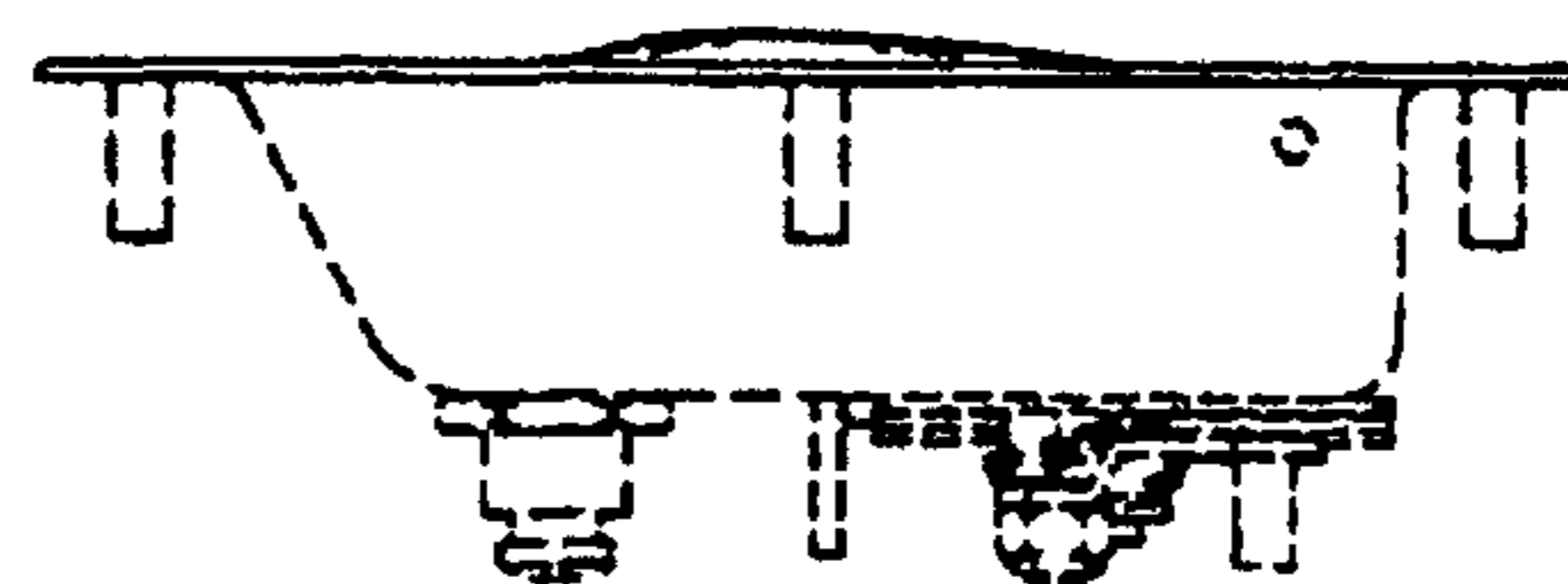

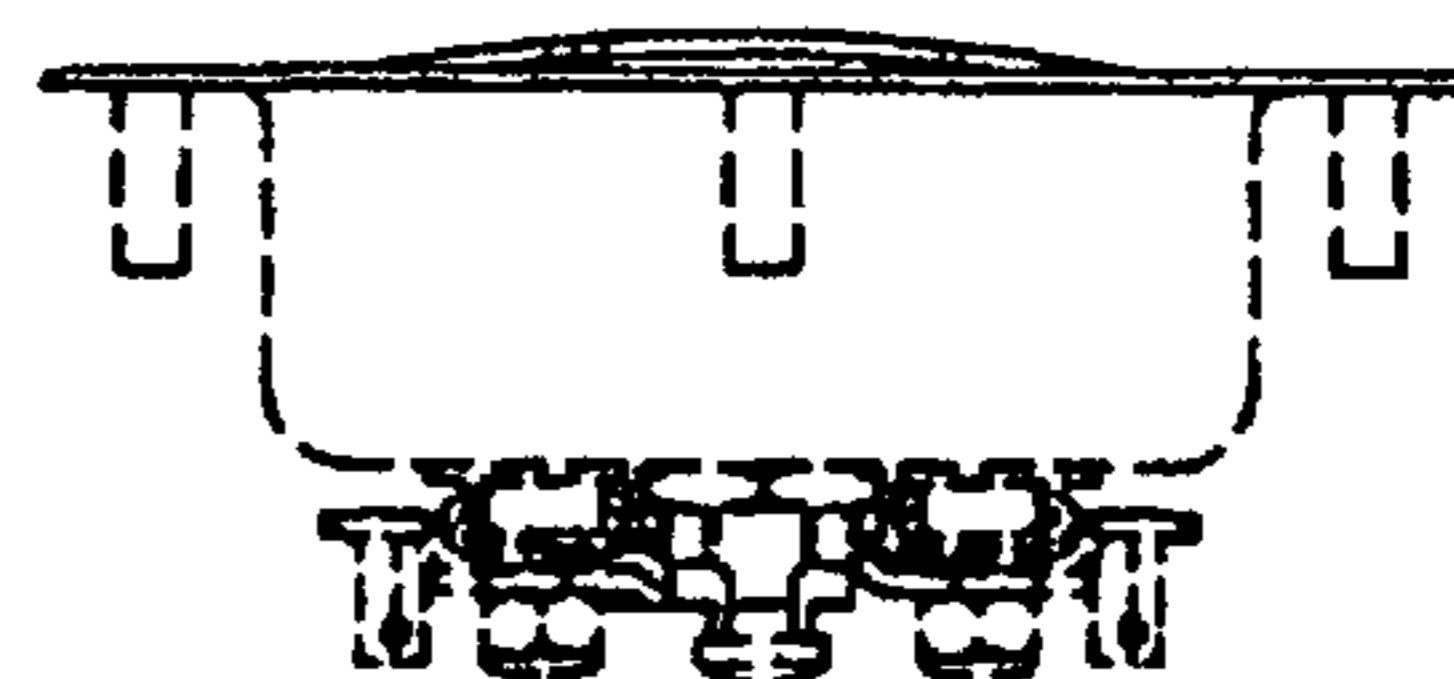
