(57) **CLAIM**

The ornamental design for an electrical device faceplate, as shown and described.

**DESCRIPTION**

The electrical device faceplate mounts to and surrounds an electrical device assembly.

FIG. 1 is a perspective view of the electrical device faceplate showing our new design;

FIG. 2 is a front elevation view of the electrical device faceplate shown in FIG. 1;

FIG. 3 is a top plan view of the electrical device faceplate shown in FIG. 2;

FIG. 4 is a bottom plan view of the electrical device faceplate shown in FIG. 2;

FIG. 5 is a left side elevation view of the electrical device faceplate shown in FIG. 2;

FIG. 6 is a right side elevation view of the electrical device faceplate shown in FIG. 2;

FIG. 7 is a perspective view of a second embodiment of the electrical device faceplate showing our new design;

FIG. 8 is a front elevation view of the electrical device faceplate shown in FIG. 7;

FIG. 9 is a top plan view of the electrical device faceplate shown in FIG. 8;

FIG. 13 is a perspective view of a third embodiment of the electrical device faceplate showing our new design;

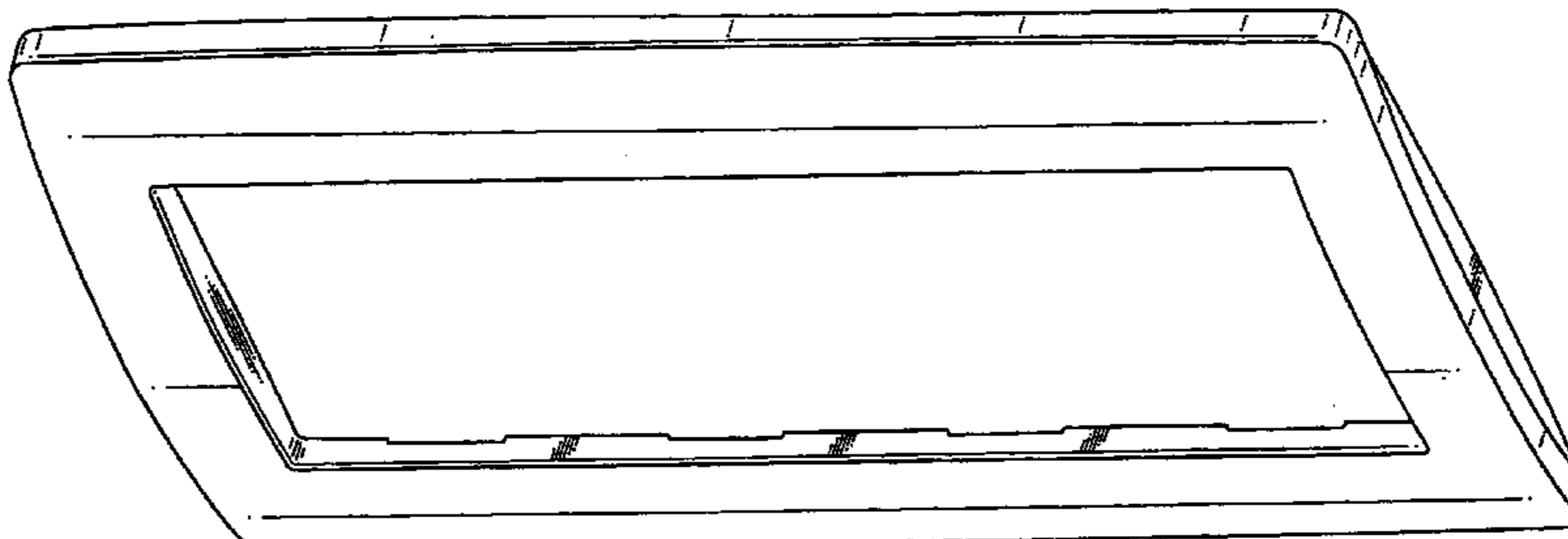
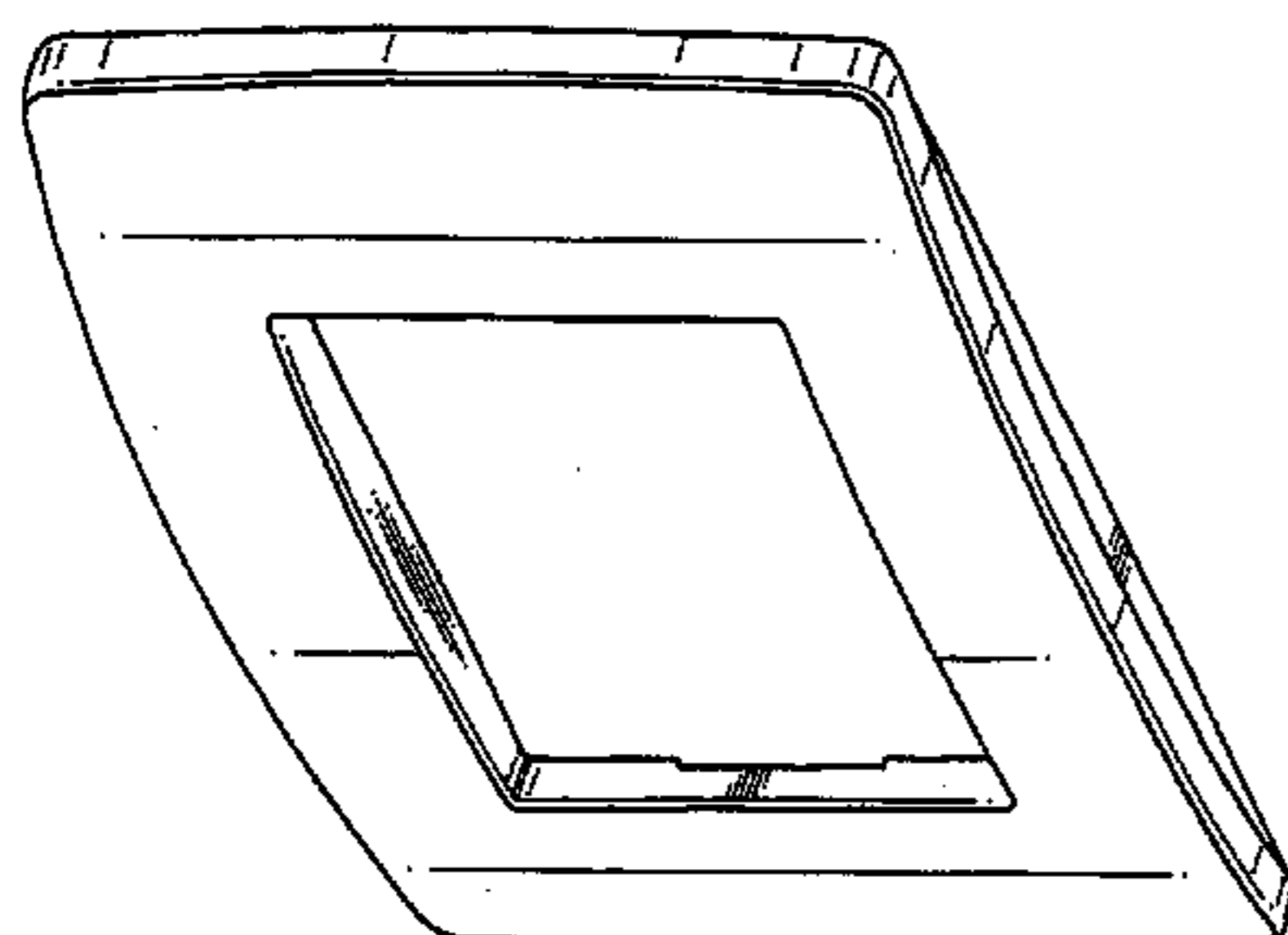


FIG. 14 is a front elevation view of the electrical device faceplate shown in FIG. 13;

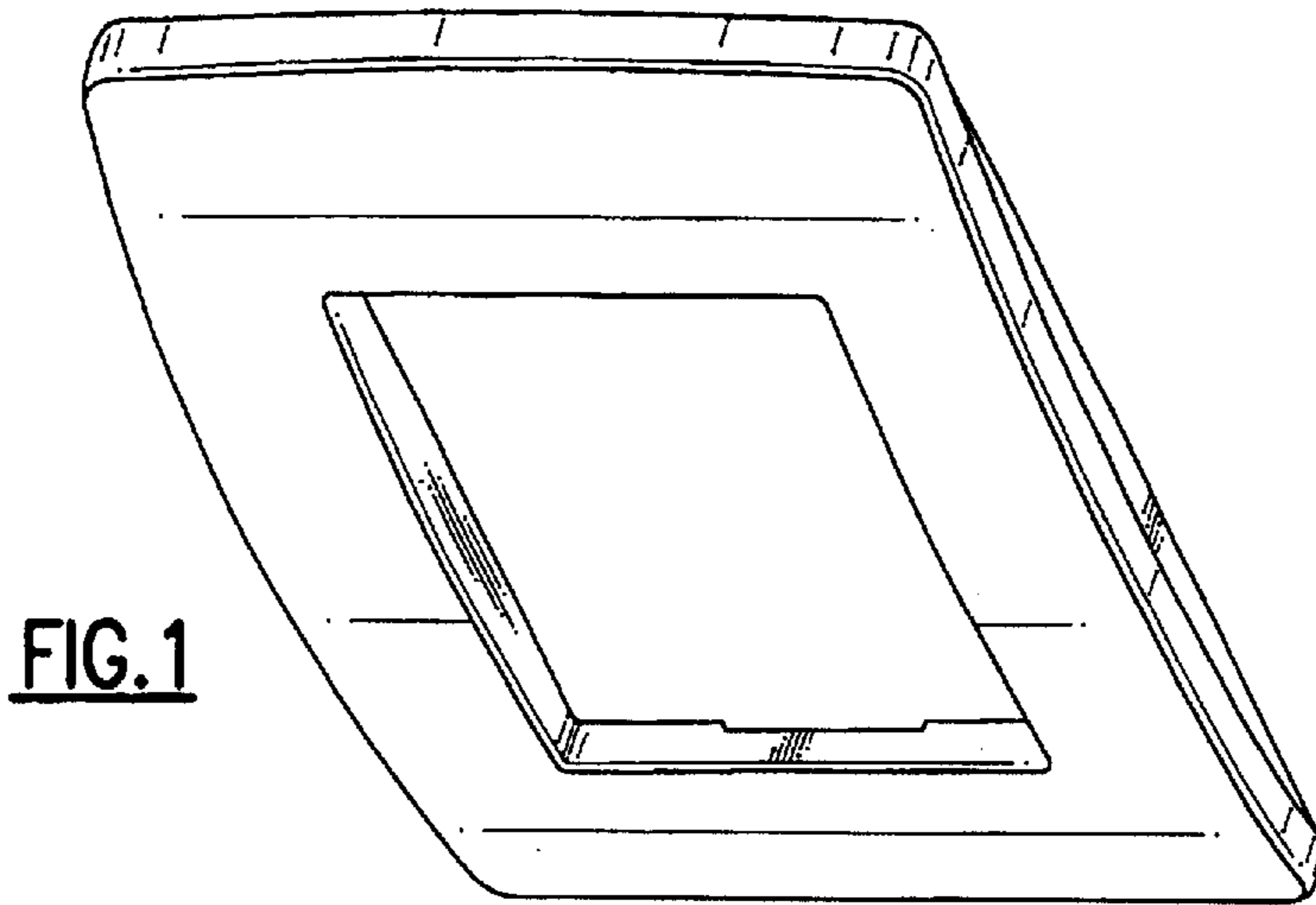

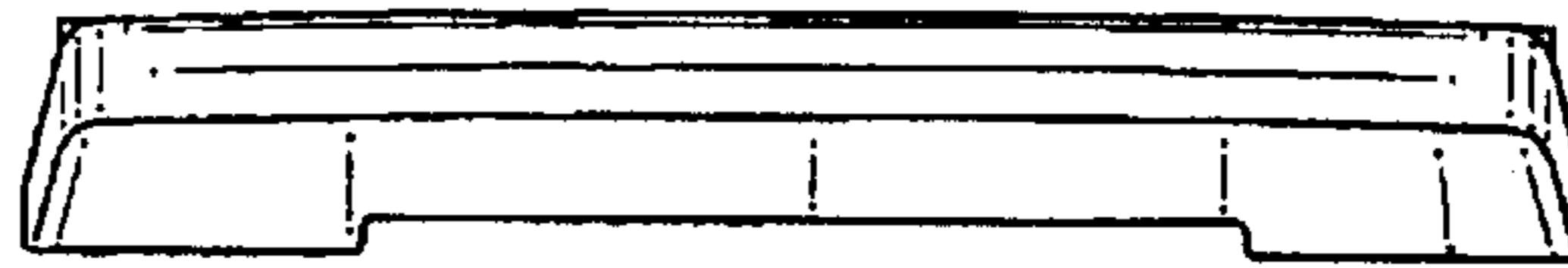

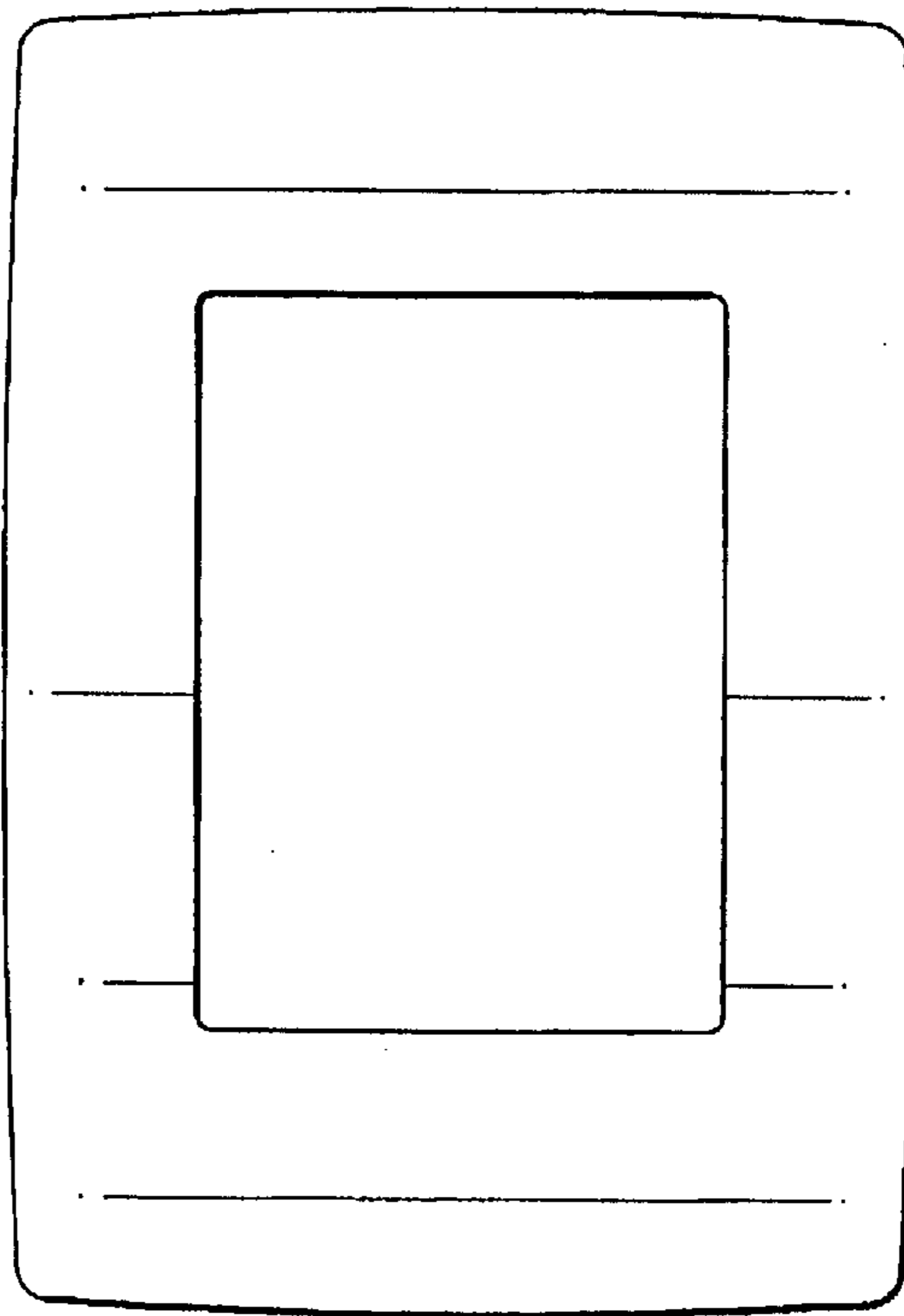

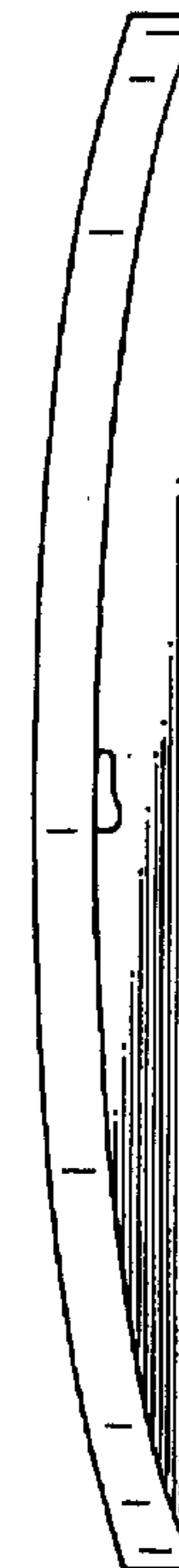

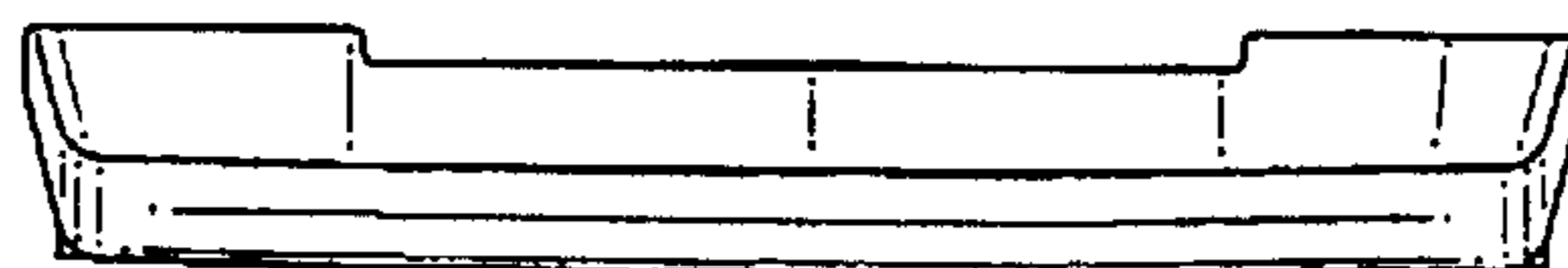

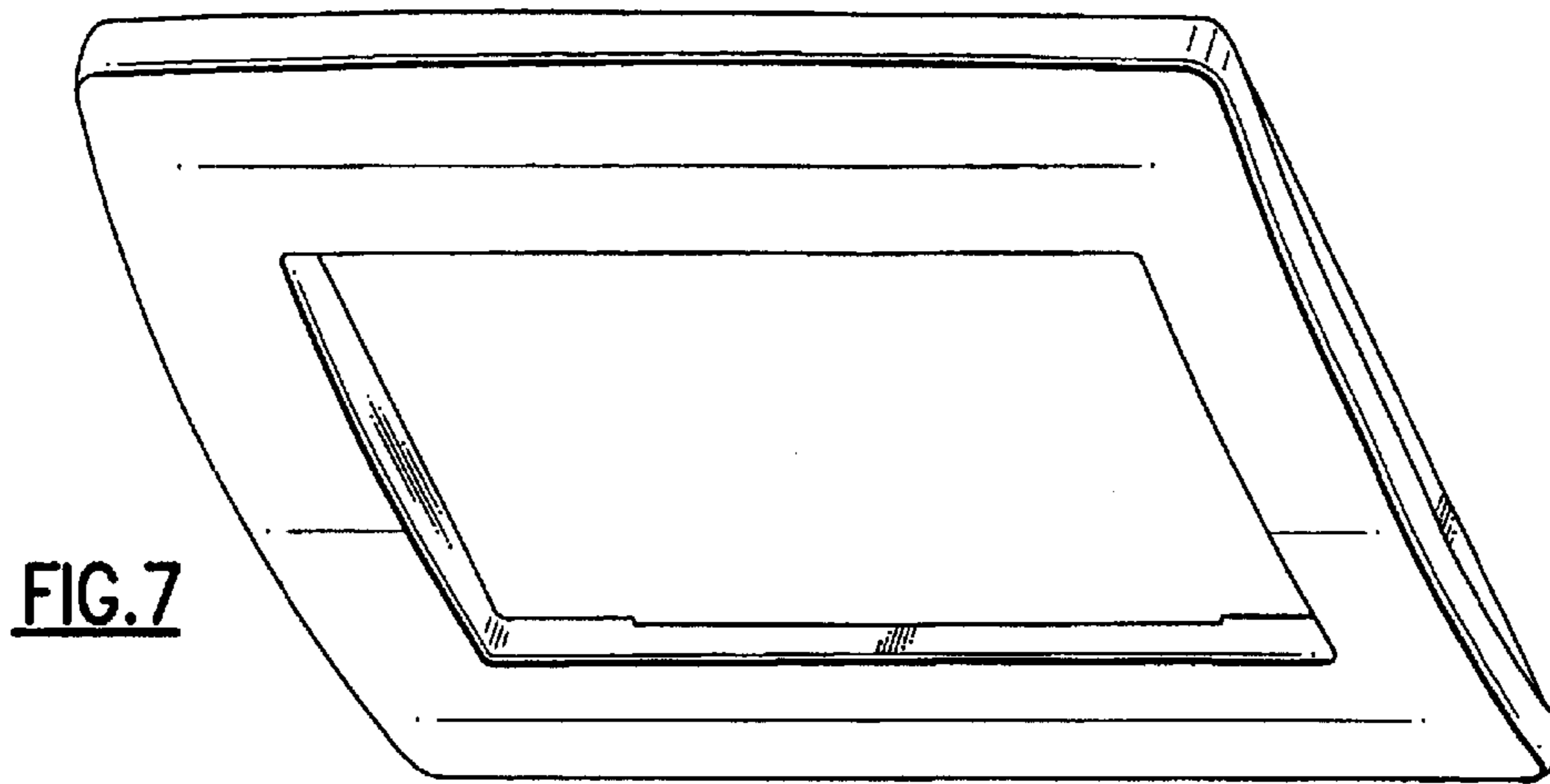

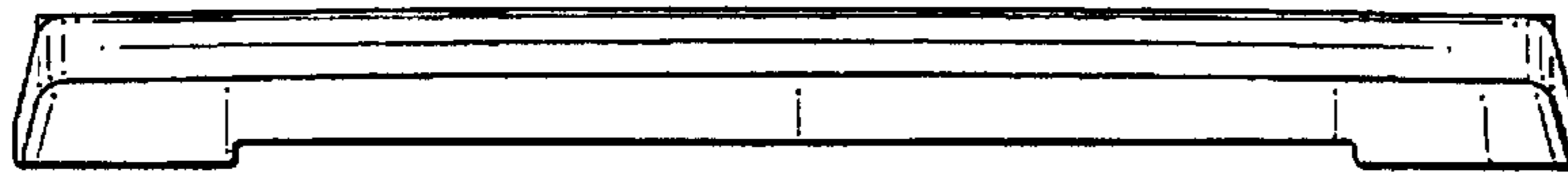

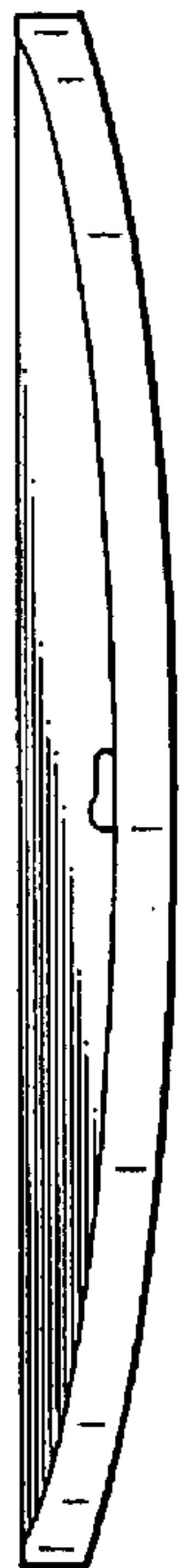

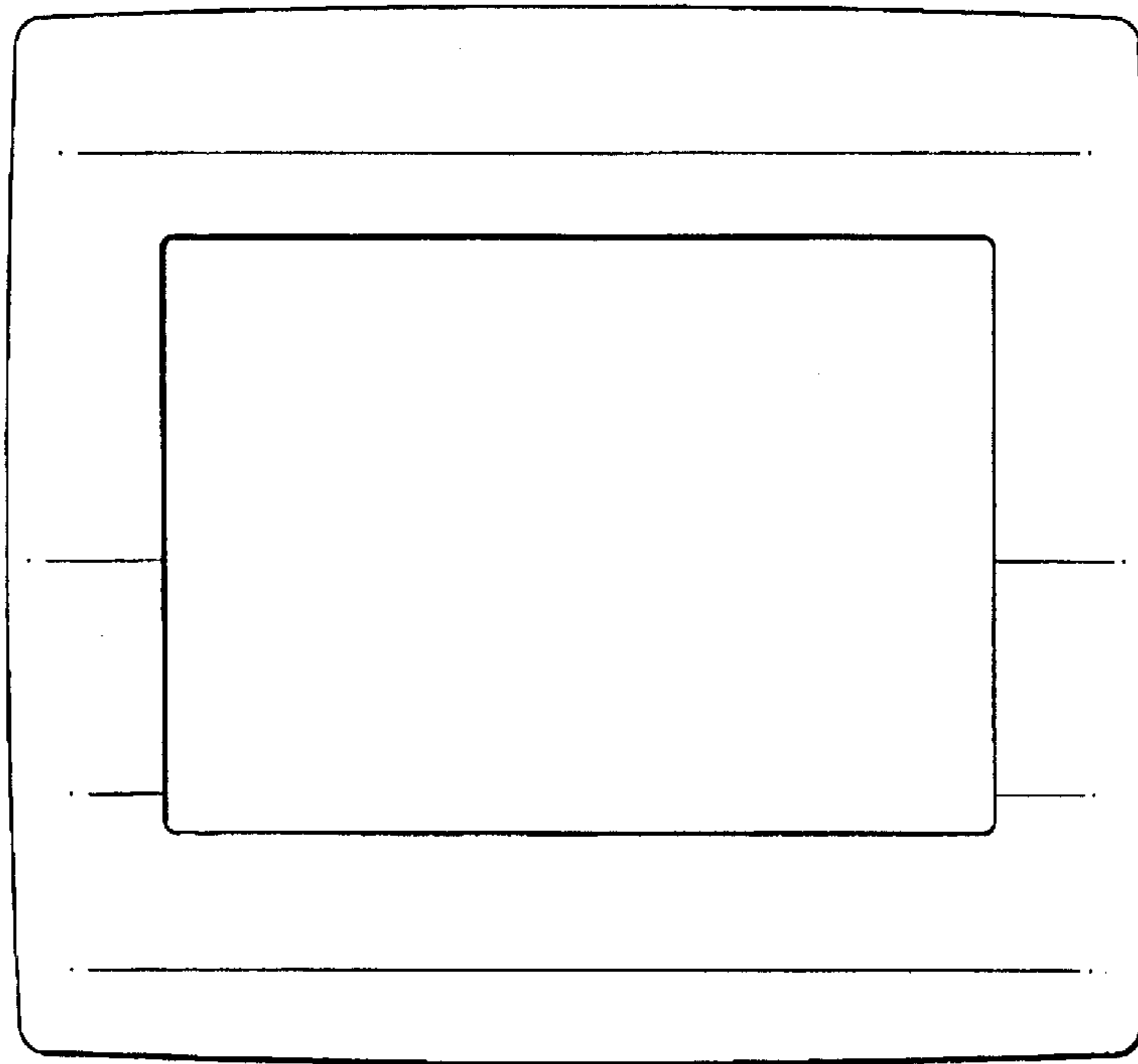

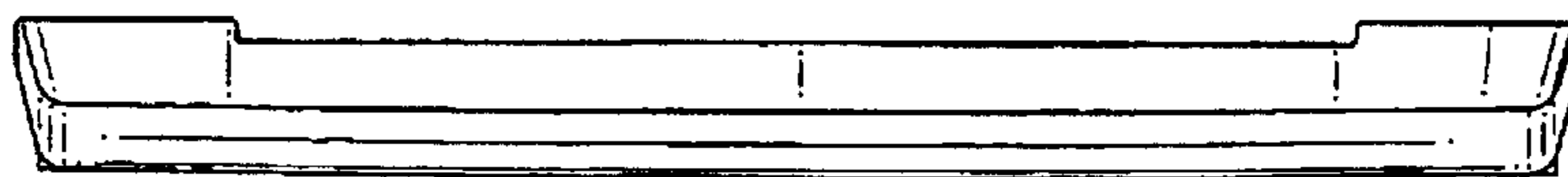
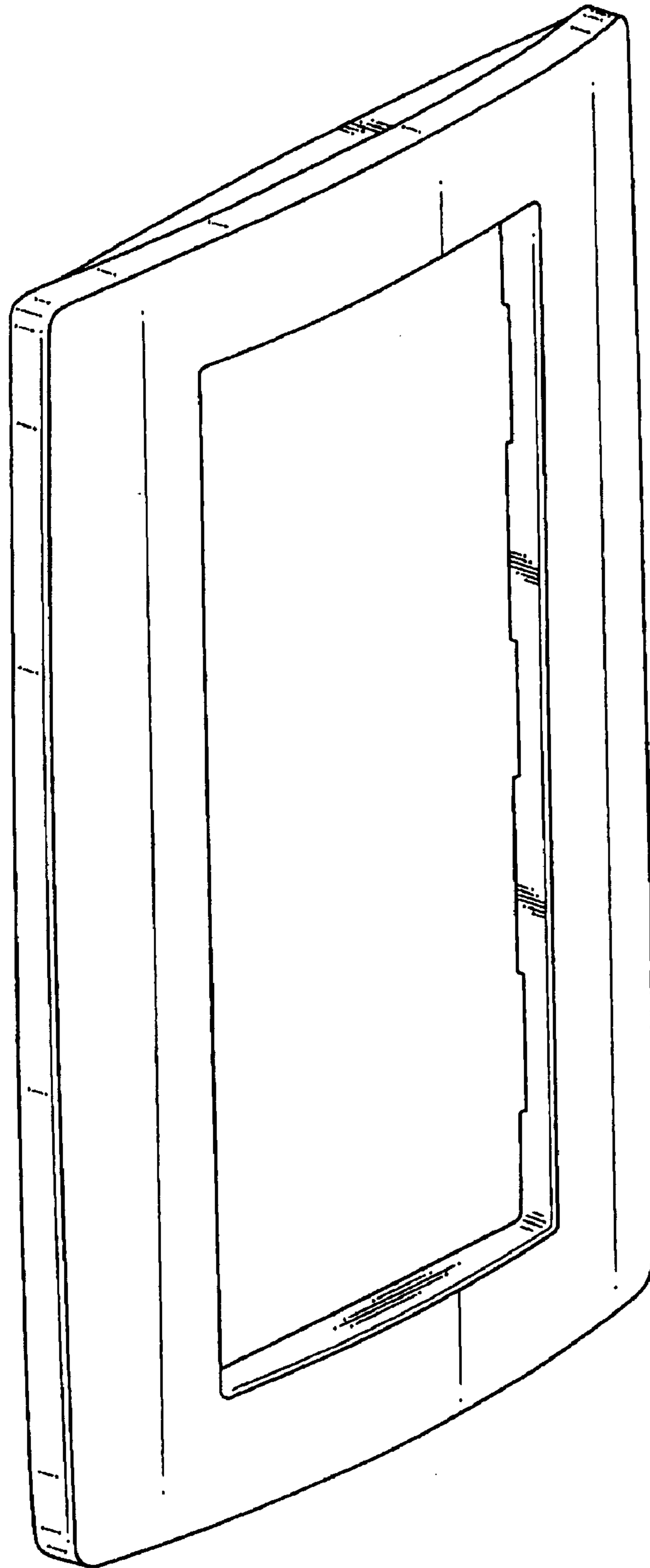

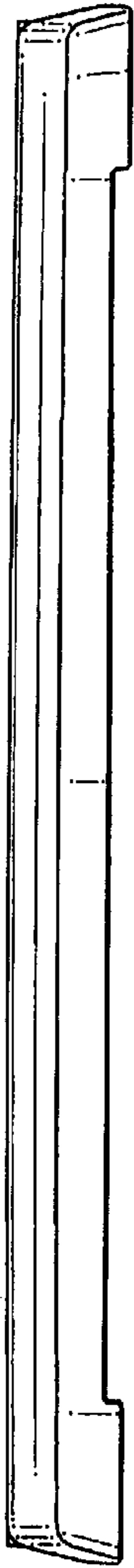

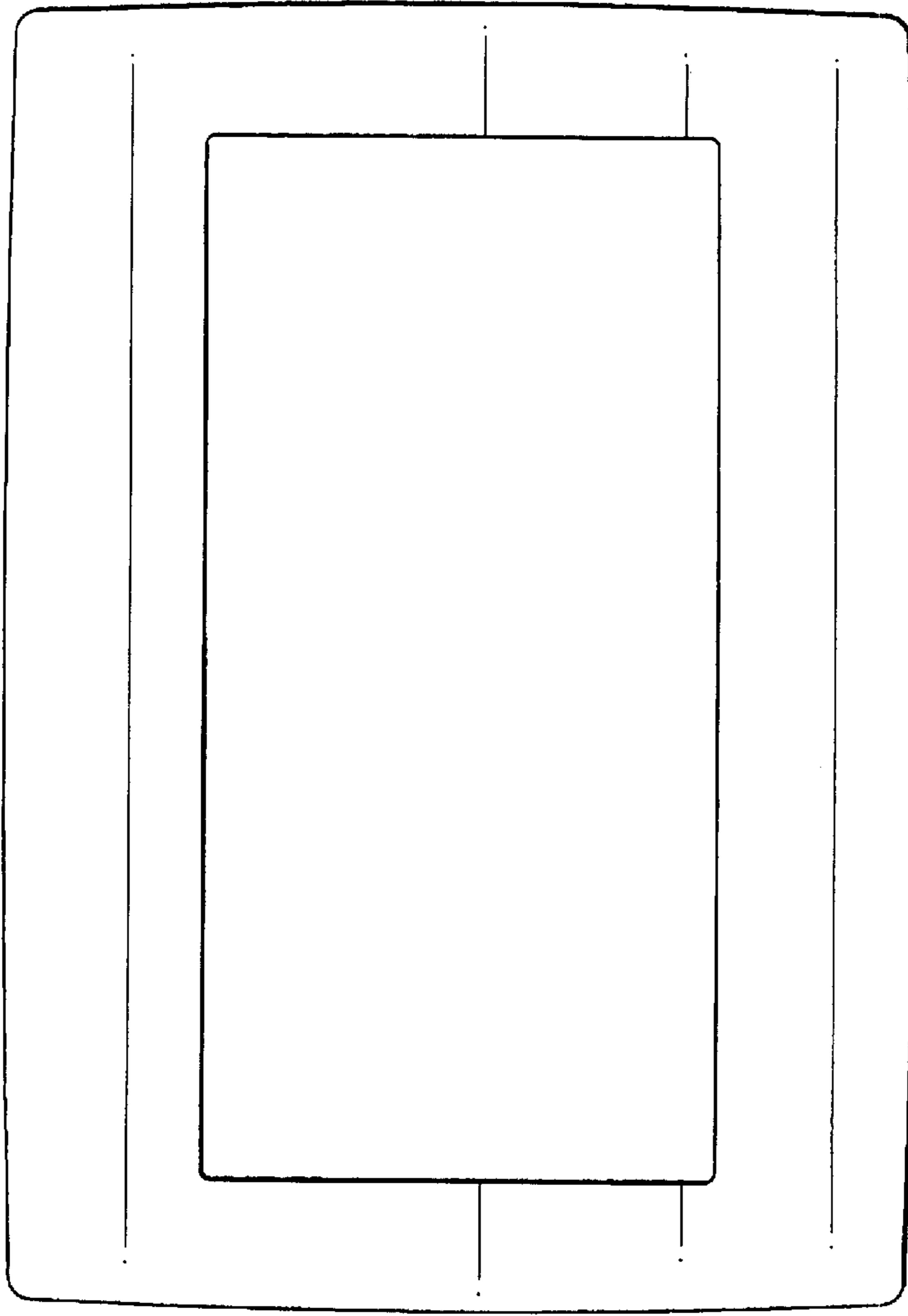

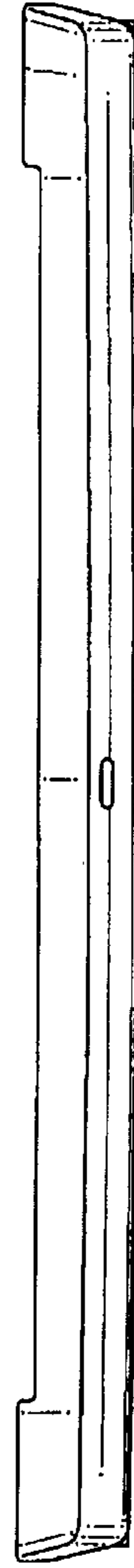

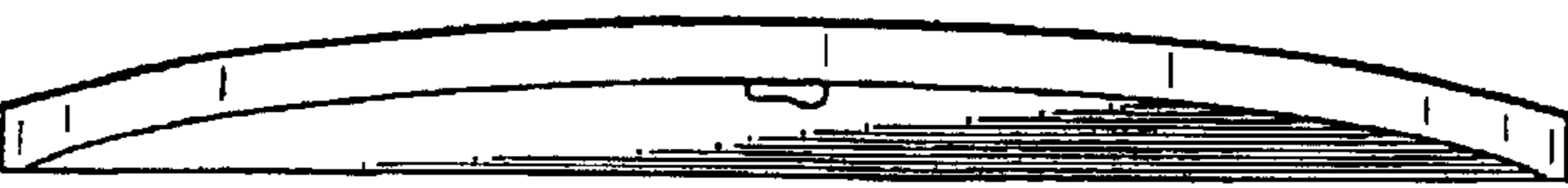

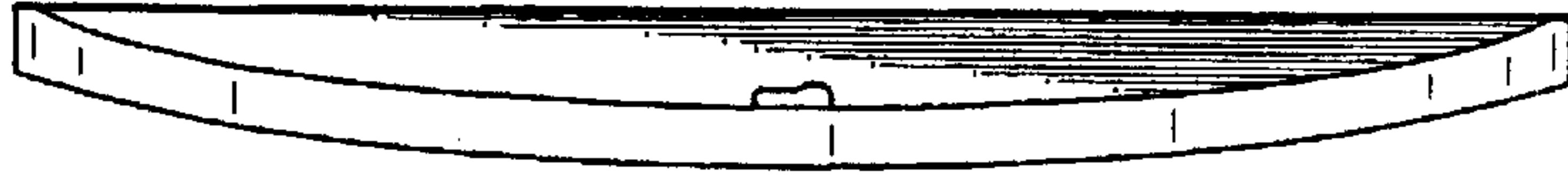

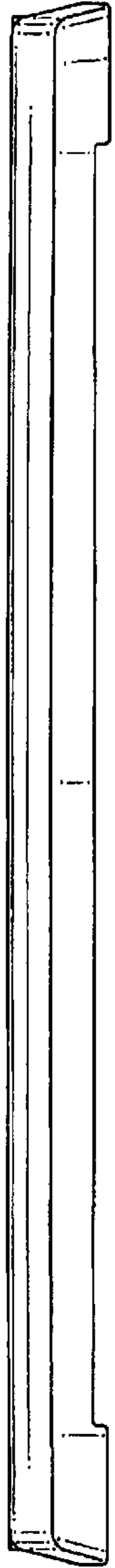

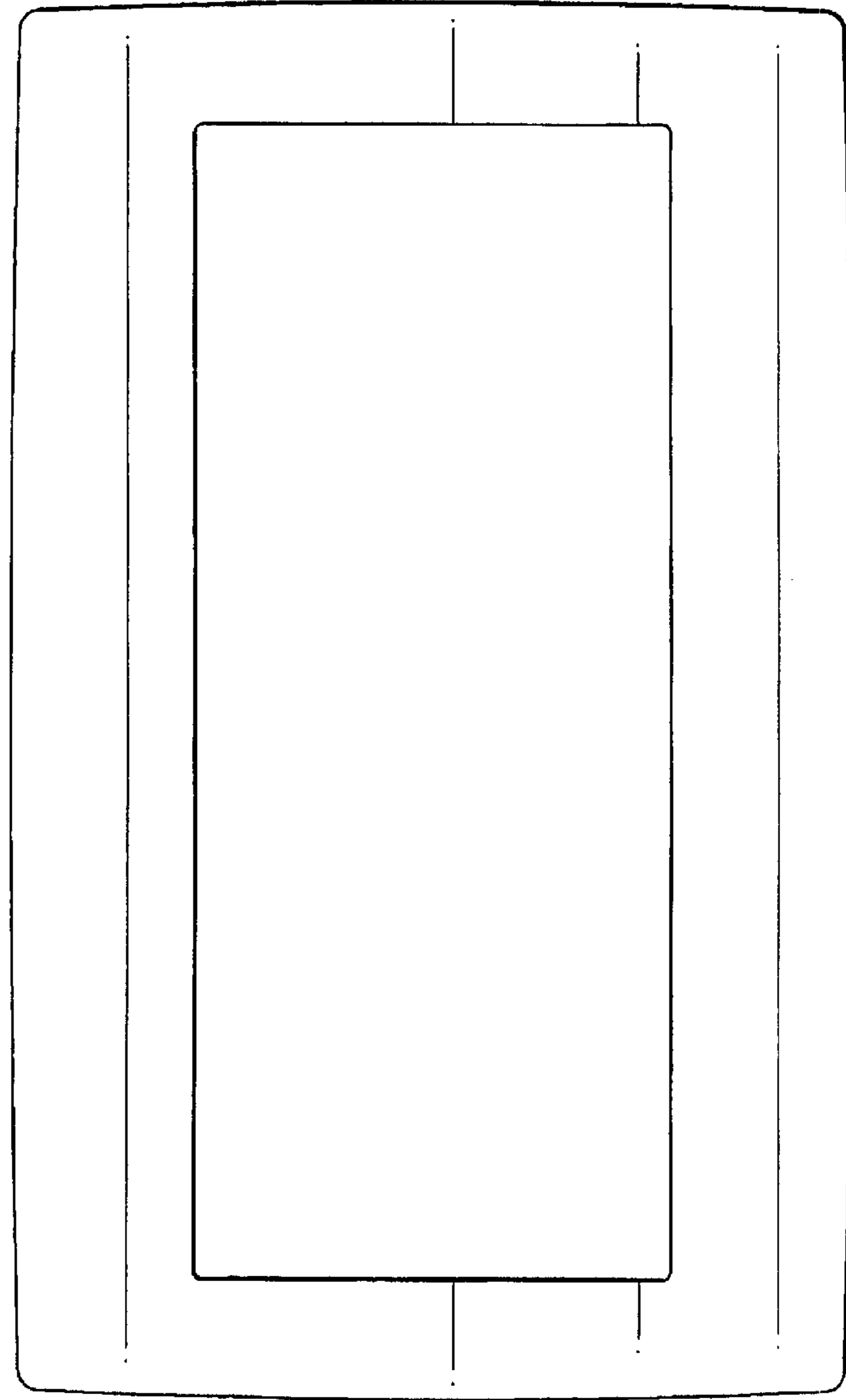

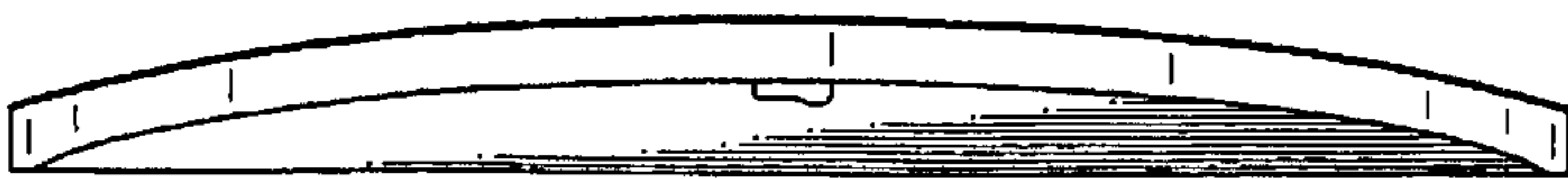

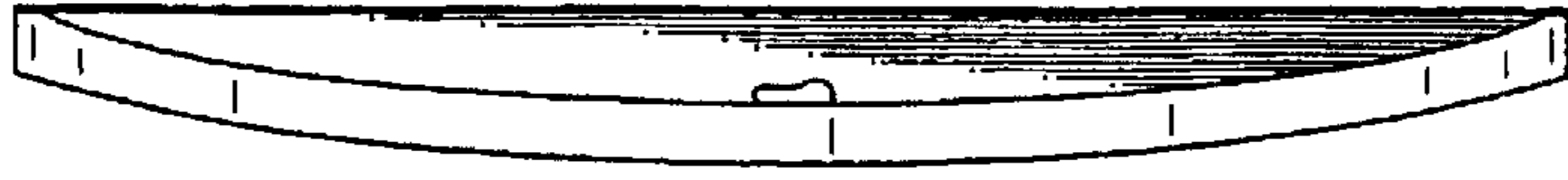
