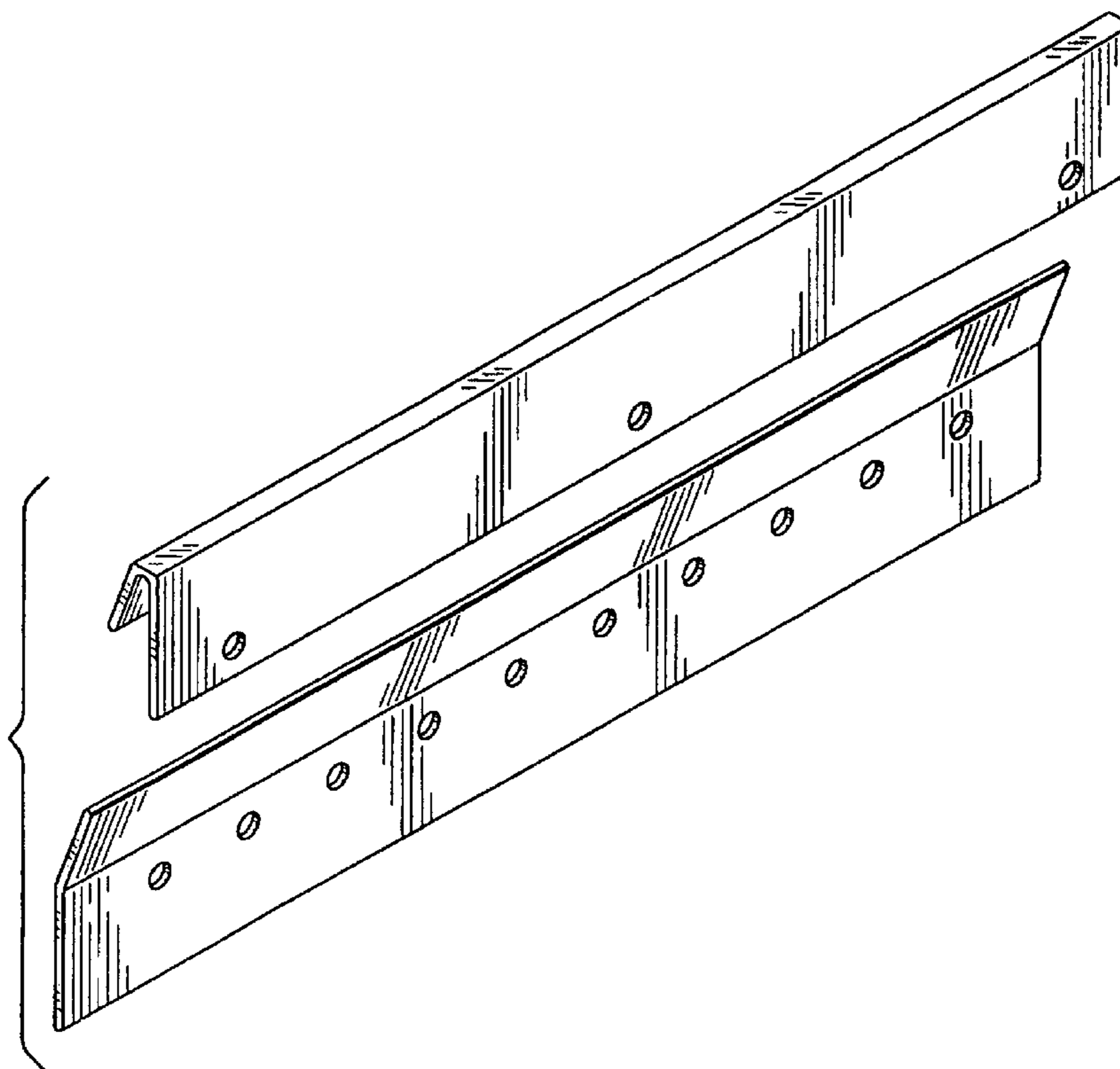

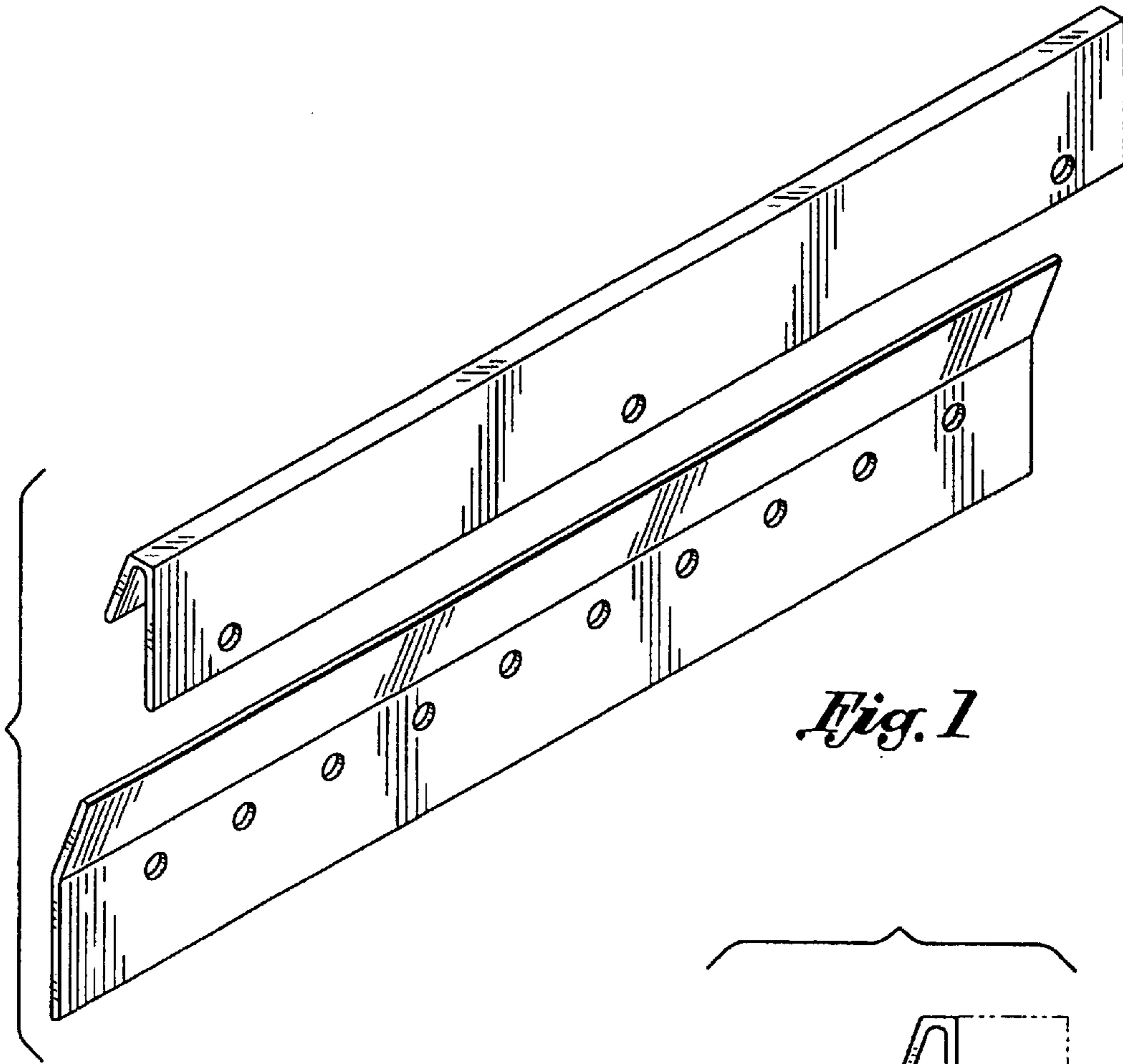
The ornamental design for a wall hanger, as shown and described.

**DESCRIPTION**

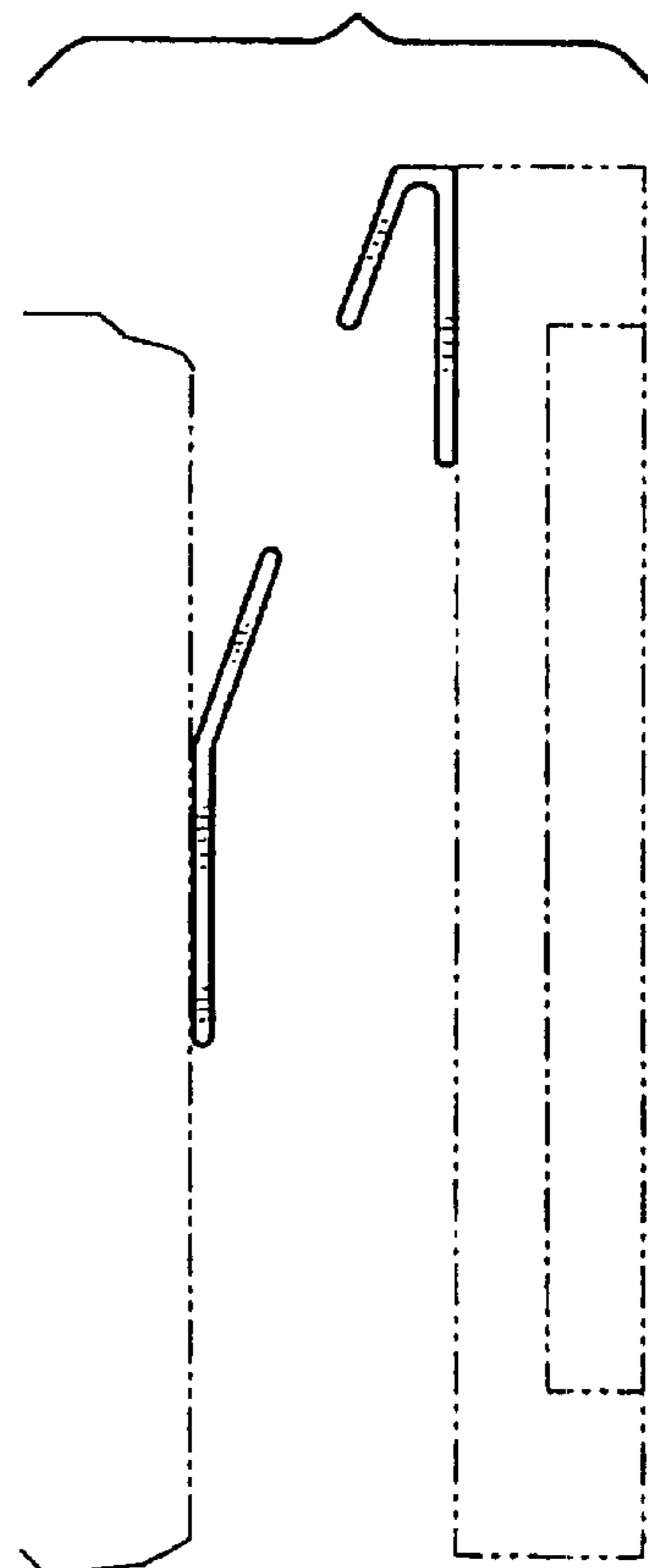
FIG. 1 is an exploded perspective view of the wall hanger of the present invention showing our new design; FIG. 2 is a side elevational view thereof with the phantom lines depicting solely environmental structure and forming no part of the claimed design; FIG. 3 is a top plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a bottom plan view thereof.

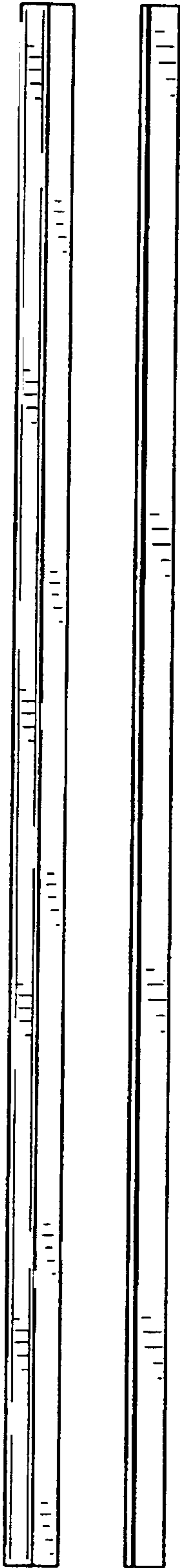




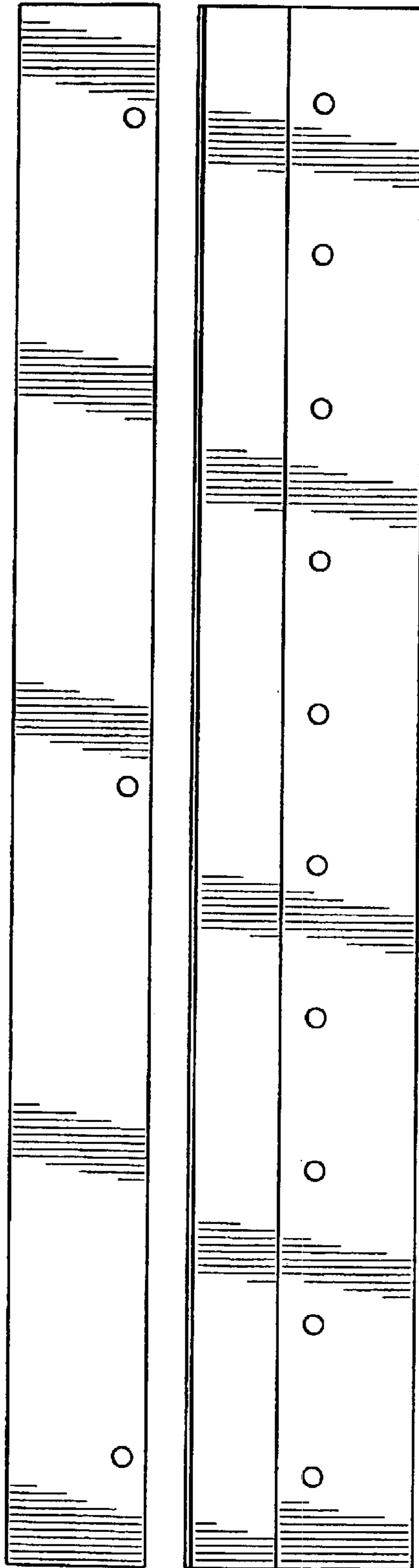

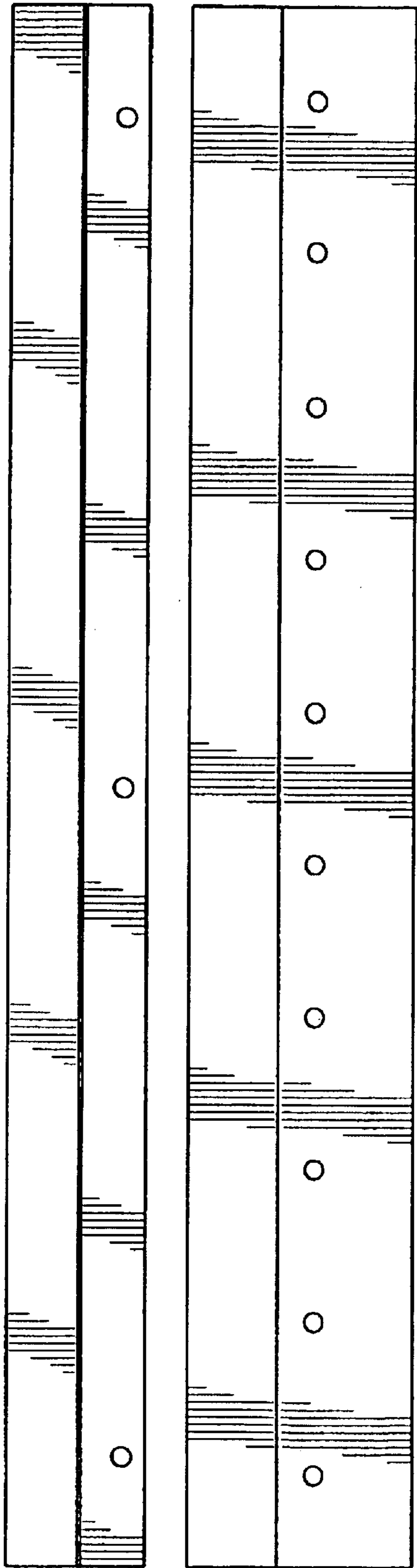

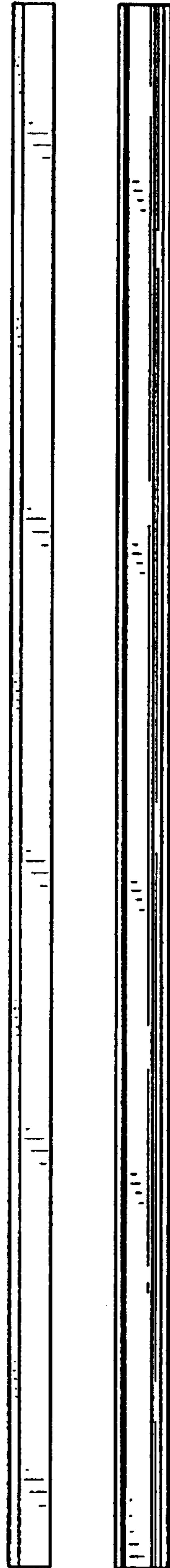
