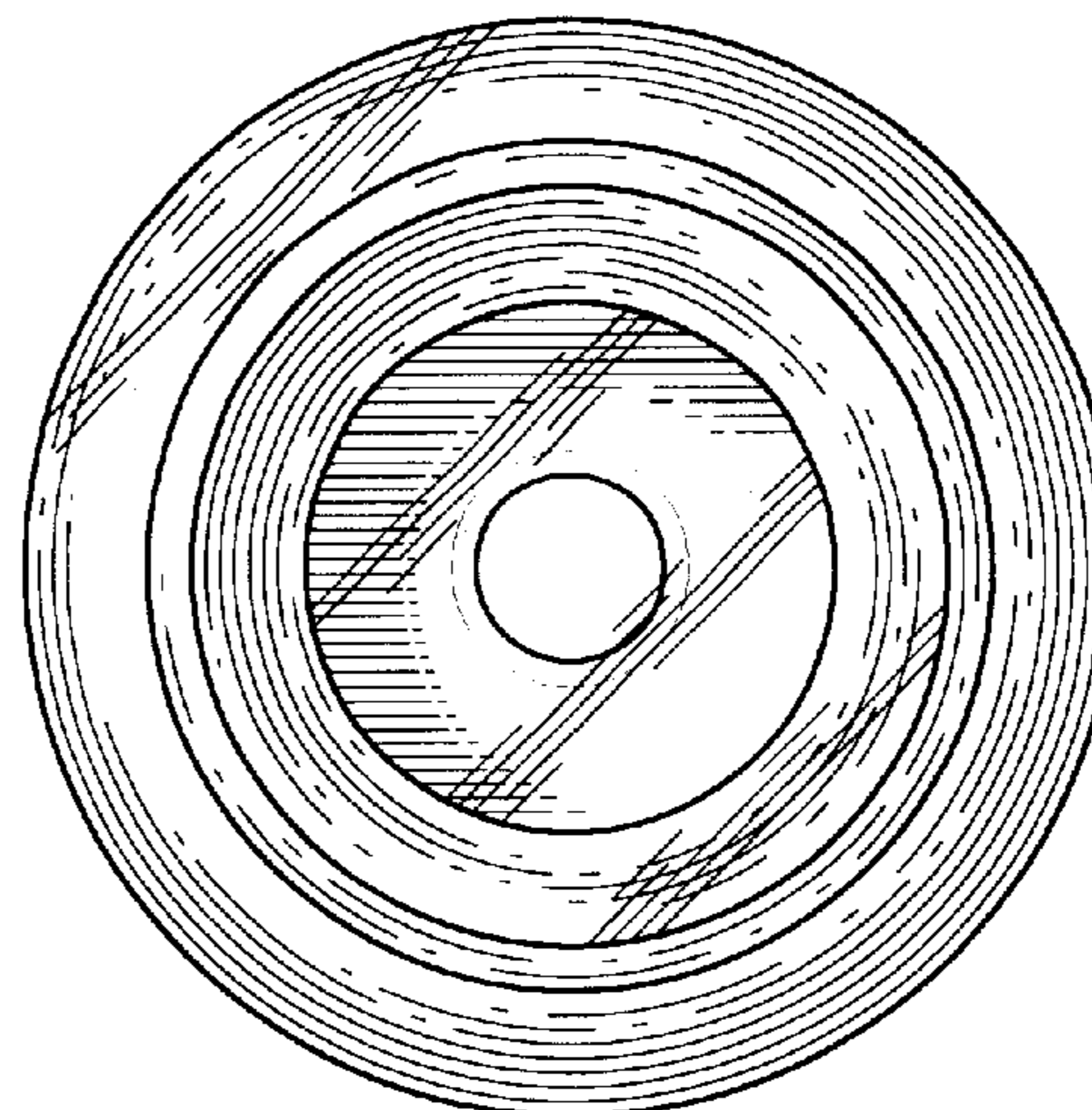
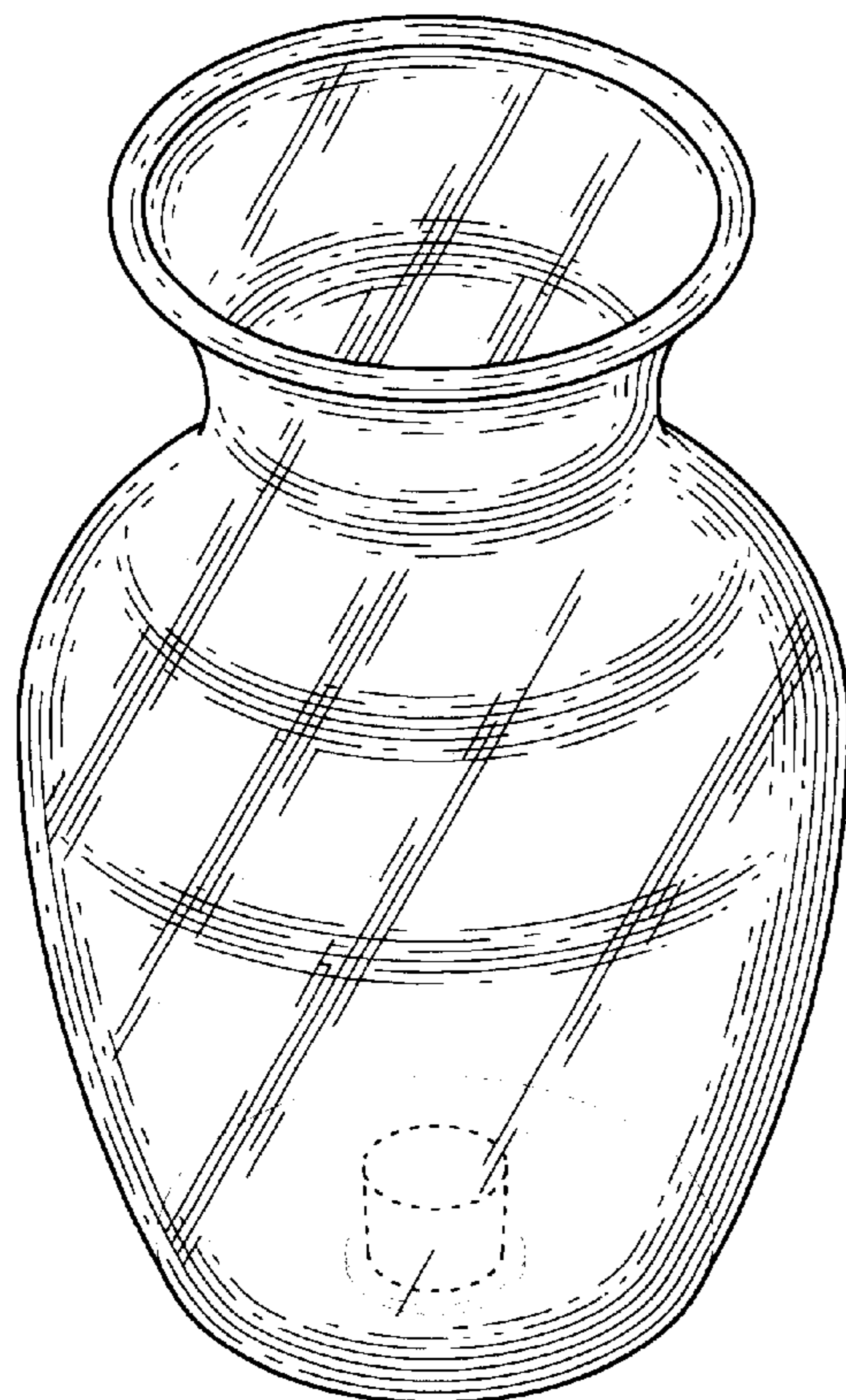
(57) **CLAIM**

The ornamental design for a vase including a drain, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a vase including a drain;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a front elevation view thereof, the rear, left side,  
and right side elevations being identical thereto; and,  
FIG. 5 is a bottom perspective view thereof.

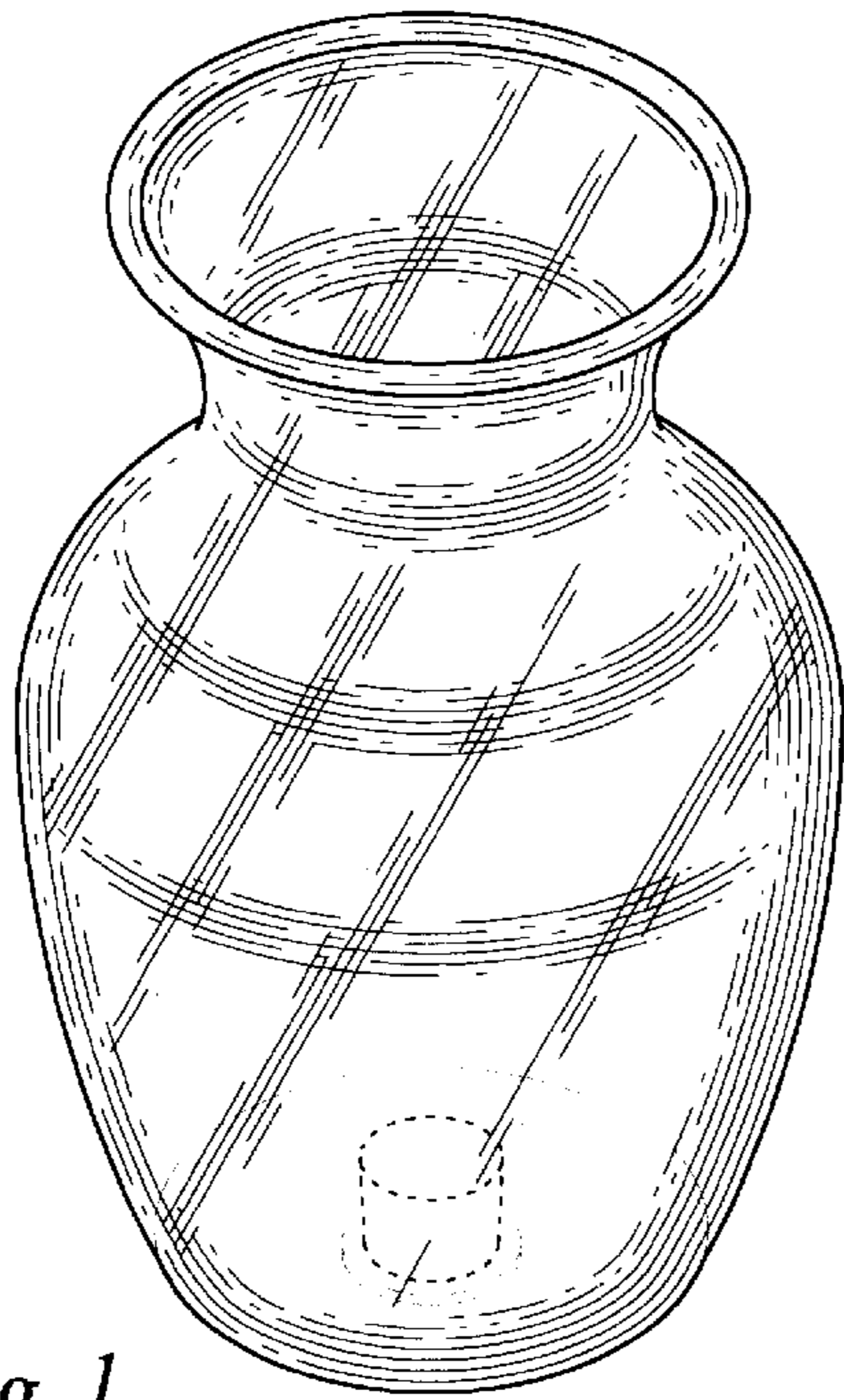

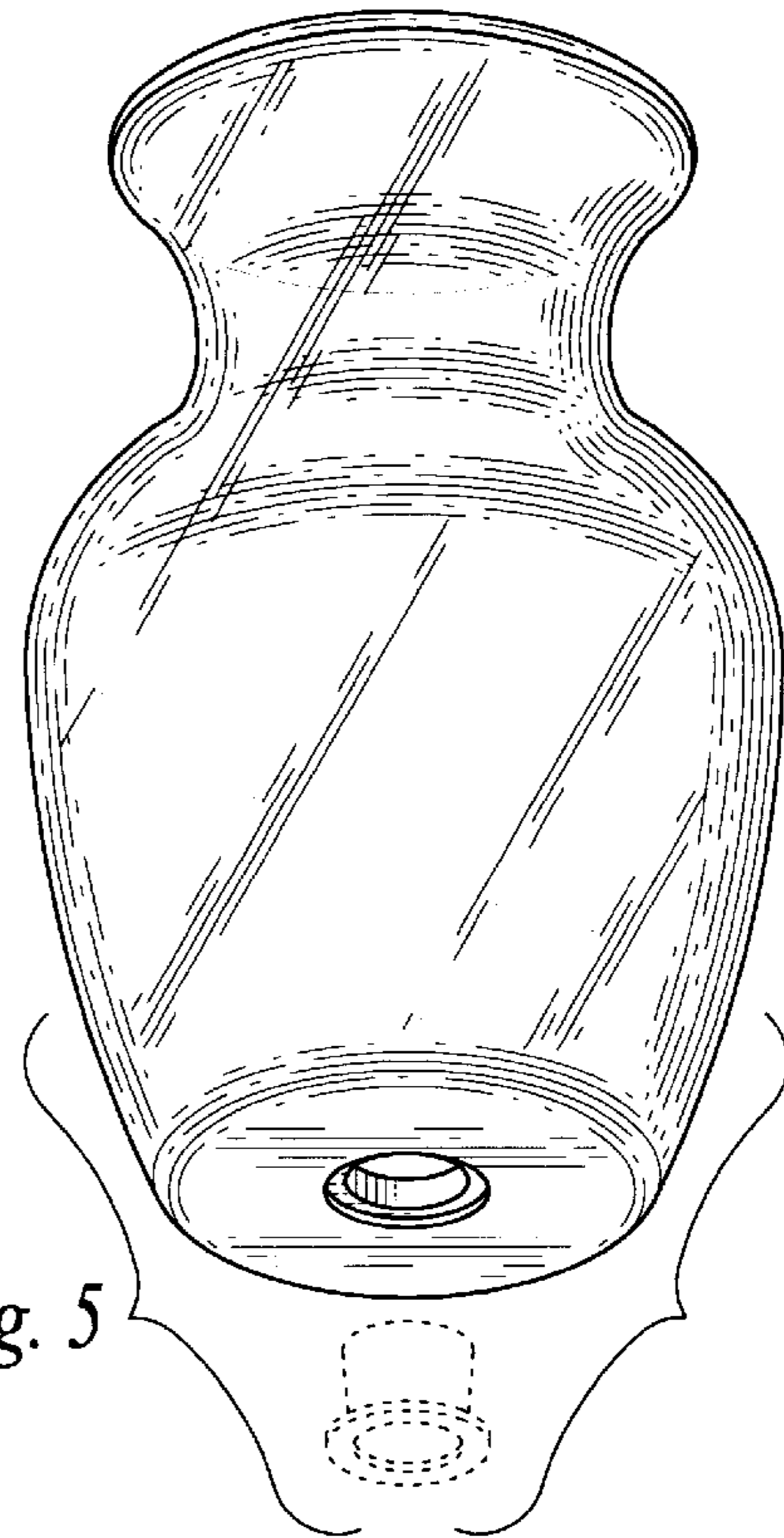

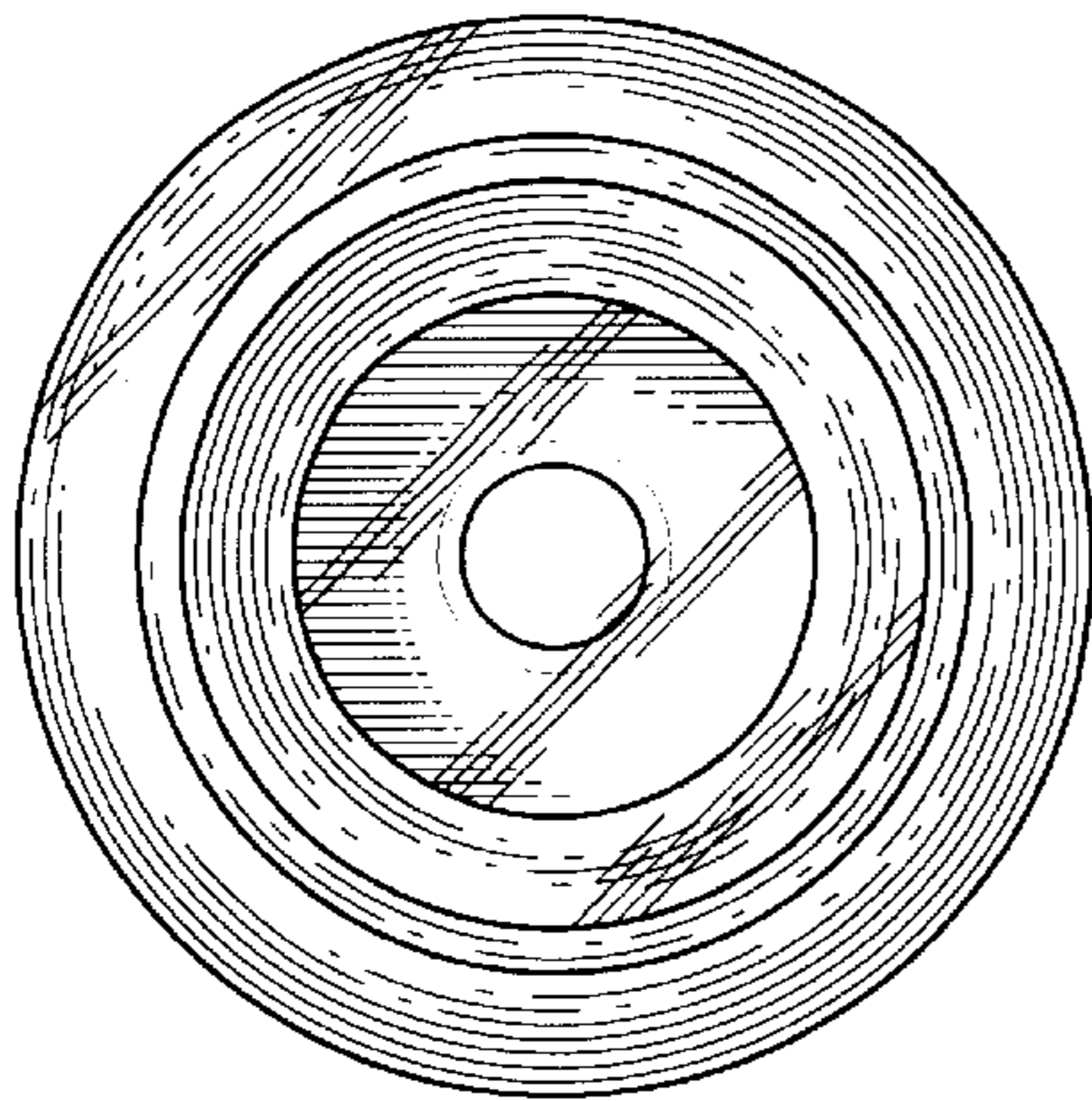

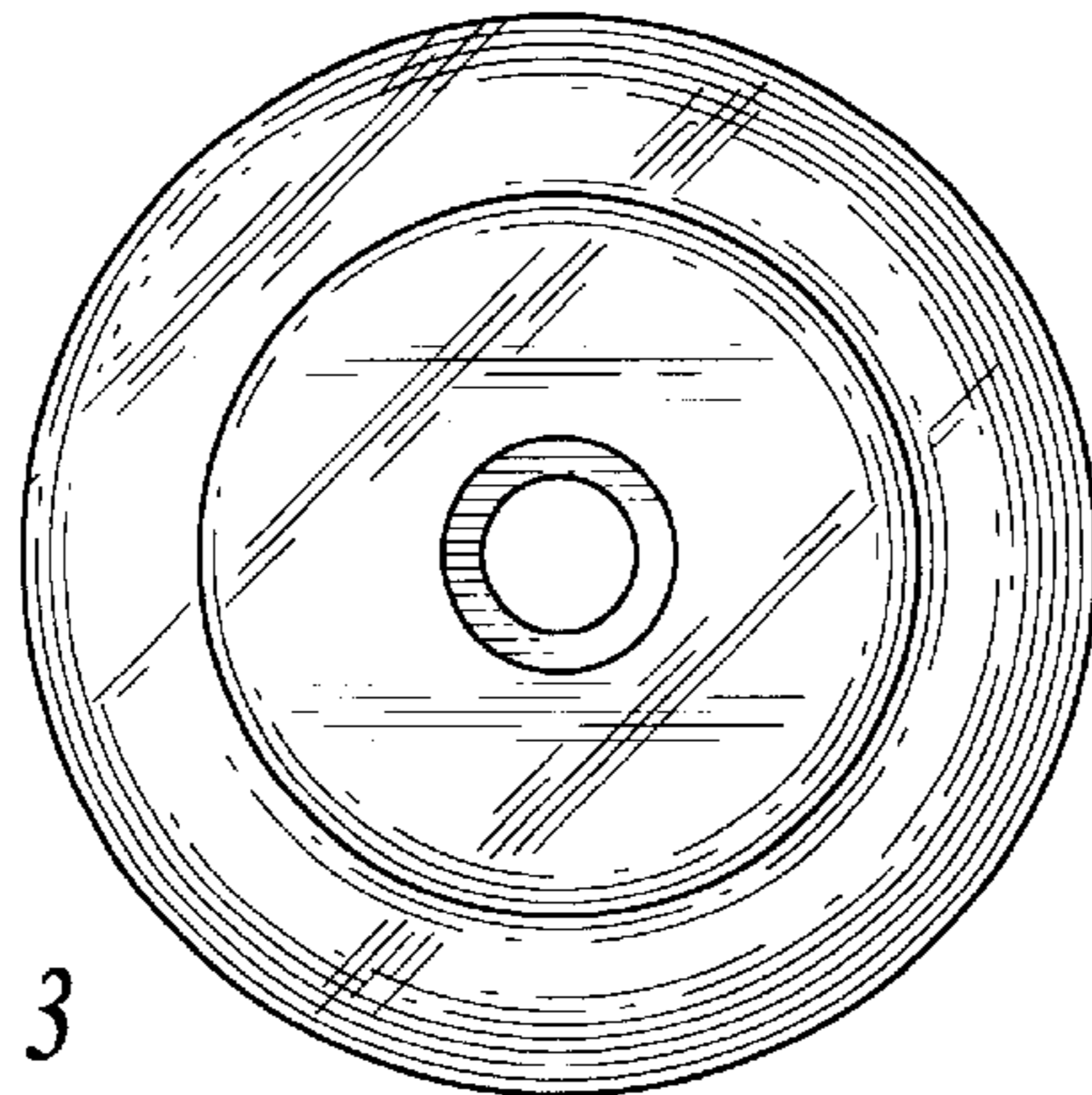

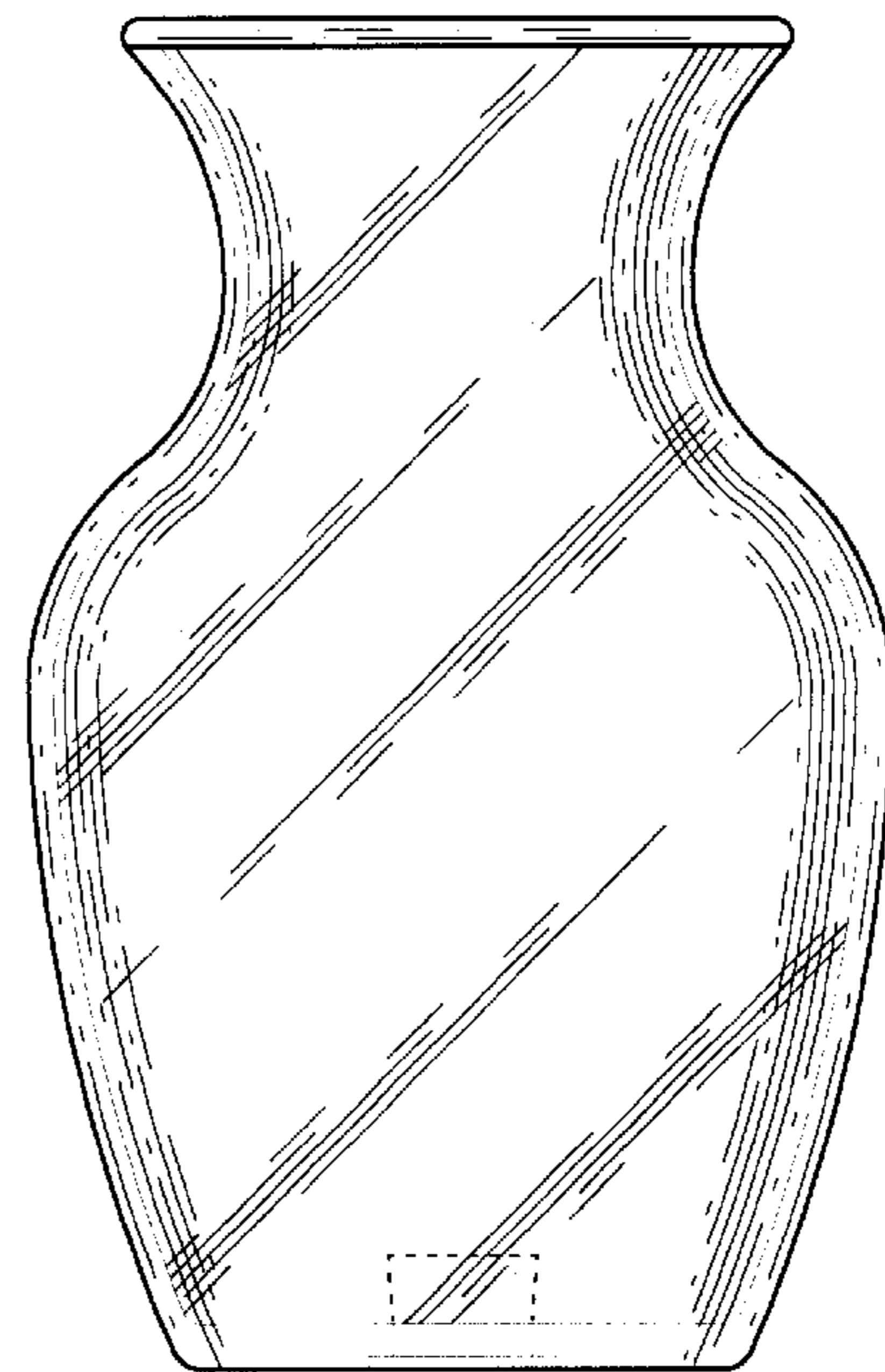
