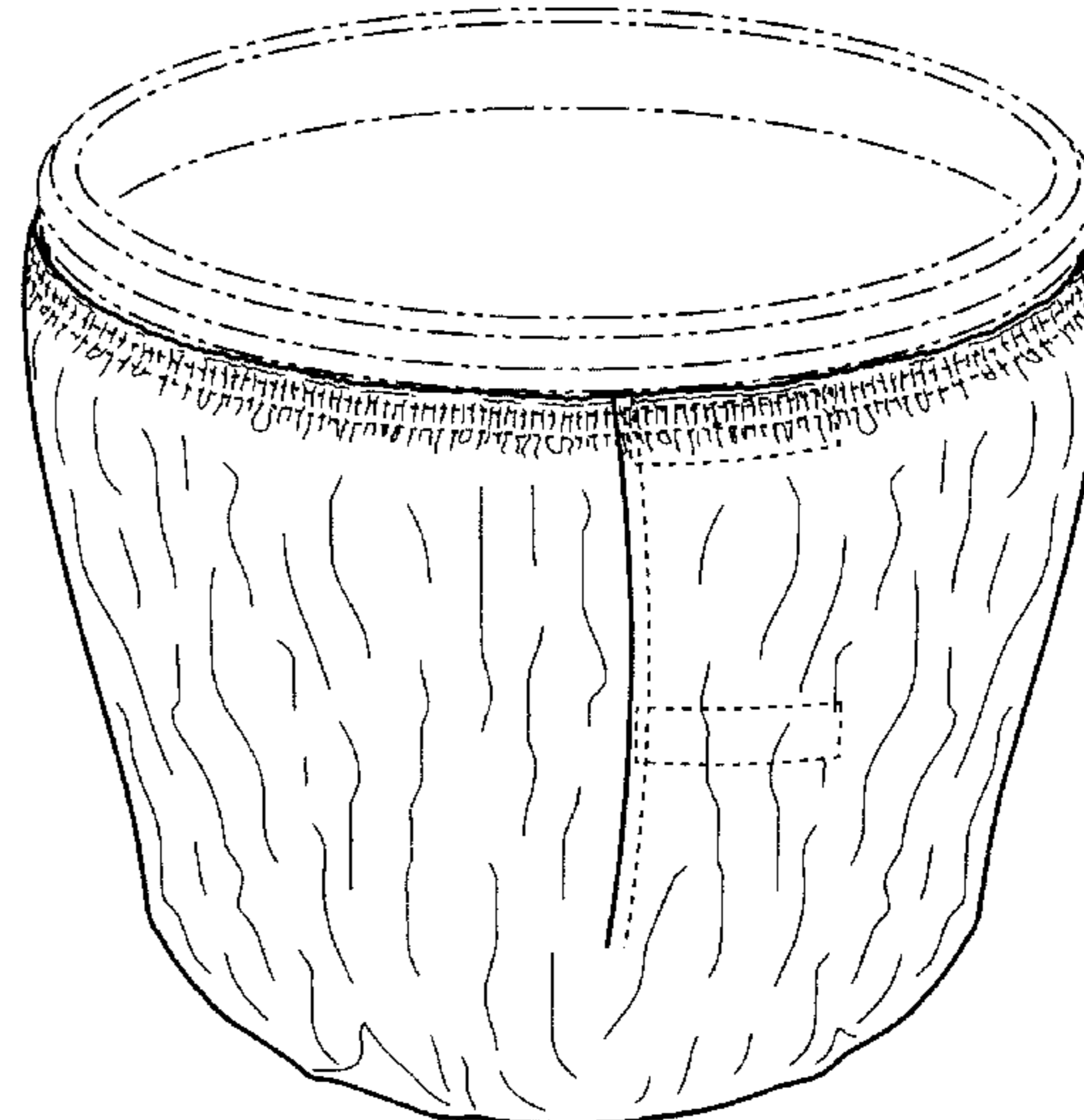
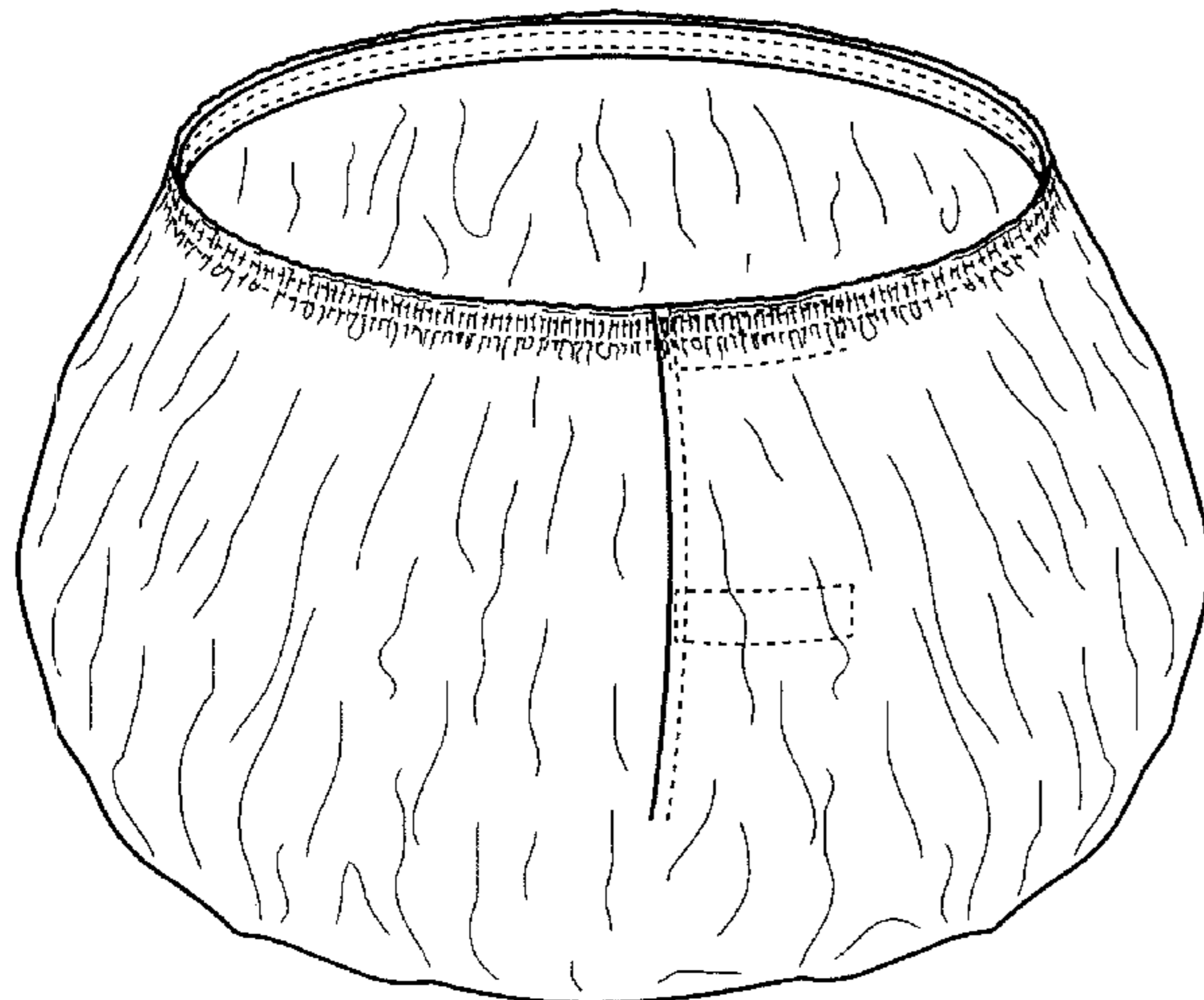
(57) **CLAIM**

The ornamental design for a plant container bag, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a plant container bag of the present invention in a closed position;
FIG. 2 is a front elevational view of the plant container bag of FIG. 1;
FIG. 3 is a left side elevational view of the plant container bag of FIG. 1;
FIG. 4 is a right side elevational view of the plant container bag of FIG. 1;
FIG. 5 is a back elevational view of the plant container bag of FIG. 1;
FIG. 6 is a top plan view of the plant container bag of FIG. 1;
FIG. 7 is a bottom plan view of the plant container bag of FIG. 1; and,
FIG. 8 is a top perspective view showing the plant container bag positioned for use surrounding a plant container.
The broken lines shown are for illustrative purposes only and form no part of the claimed design.

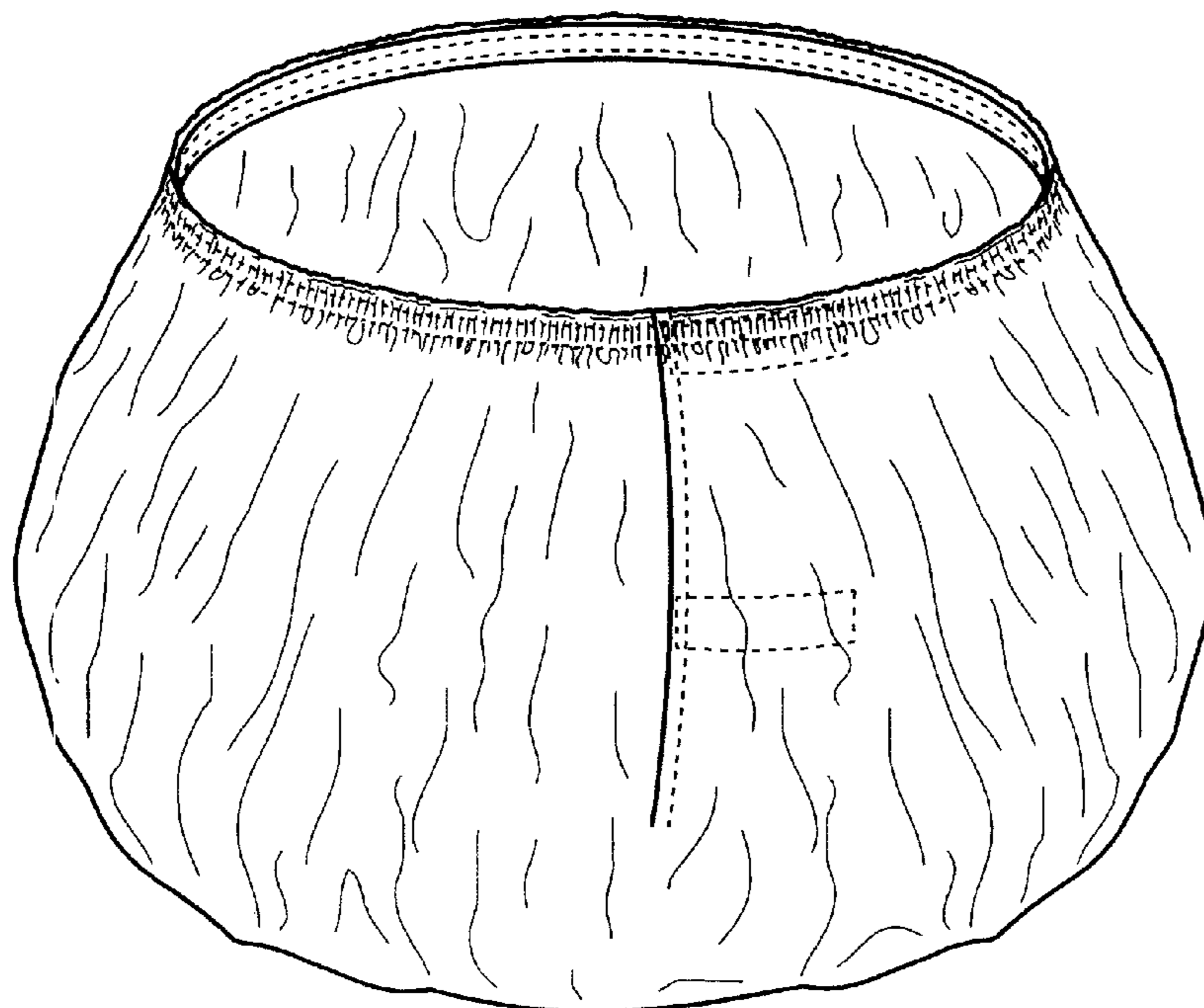

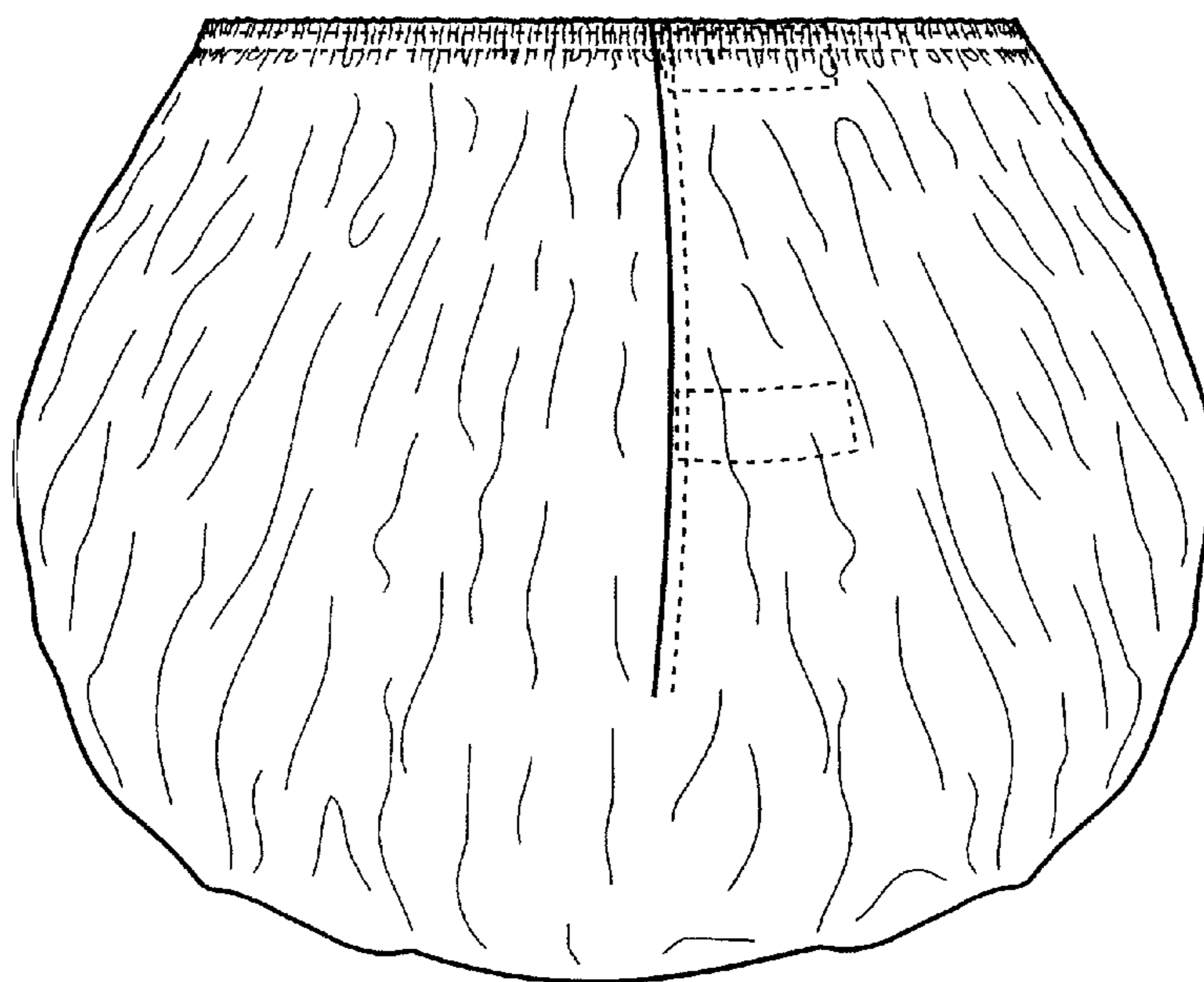

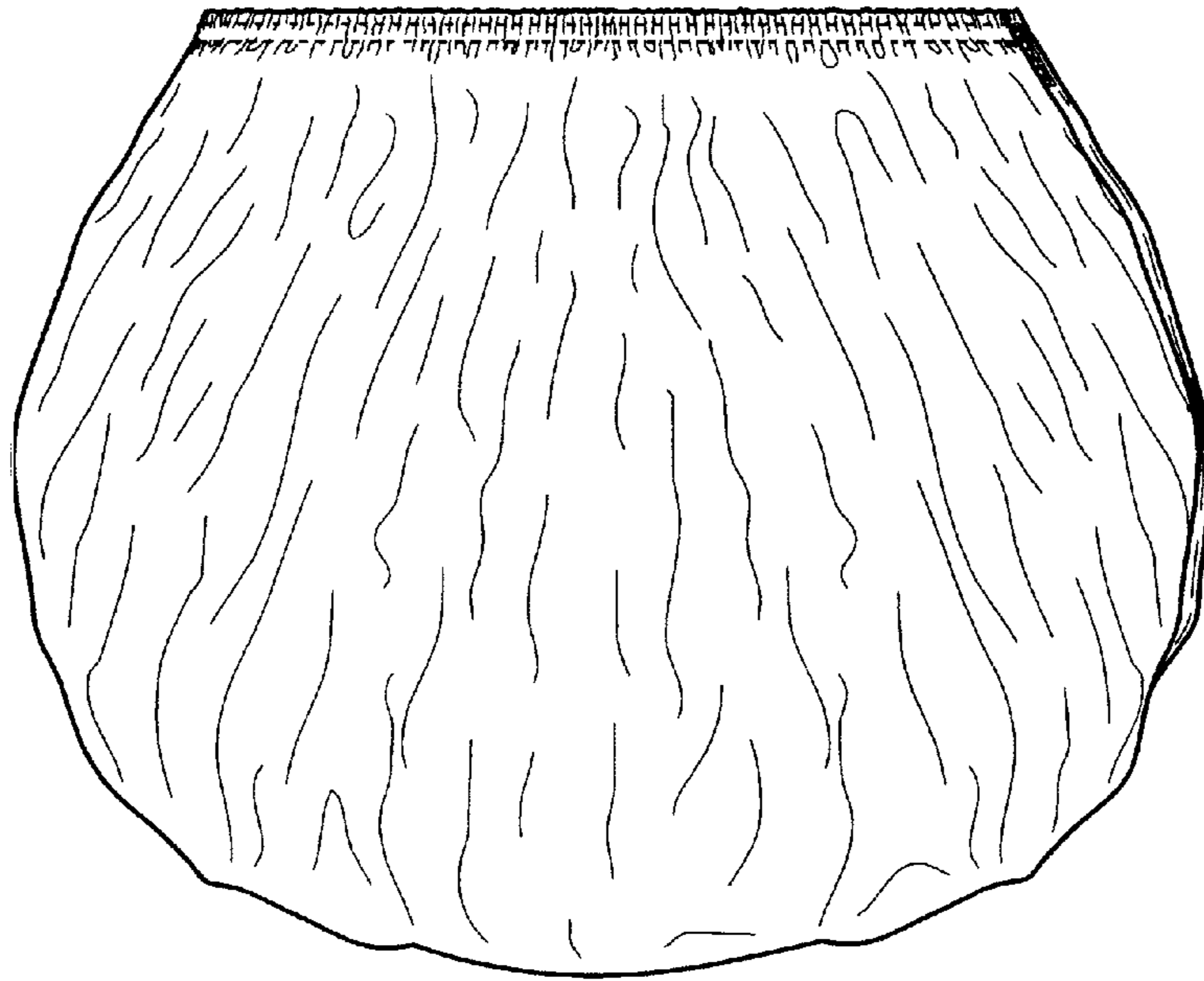

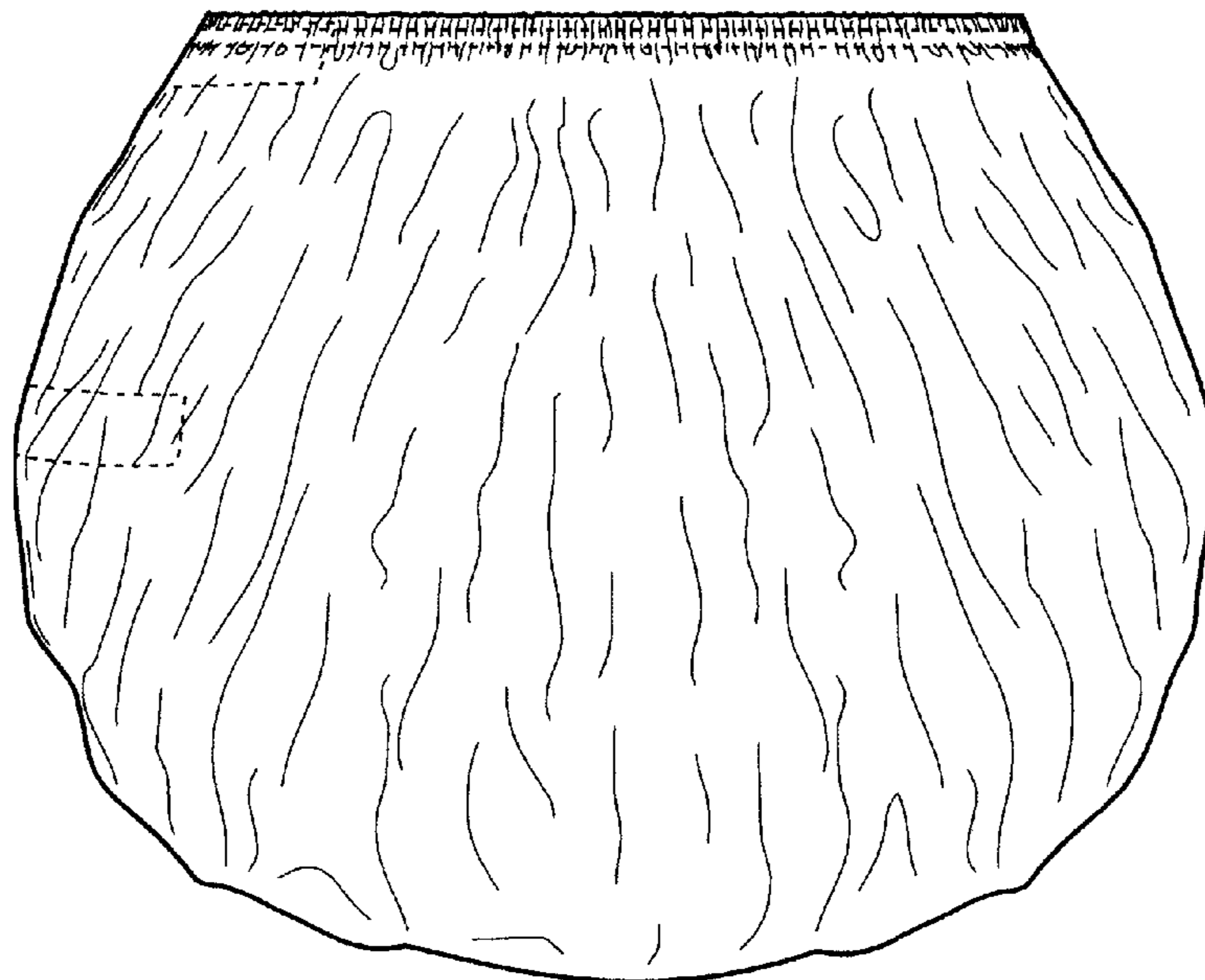

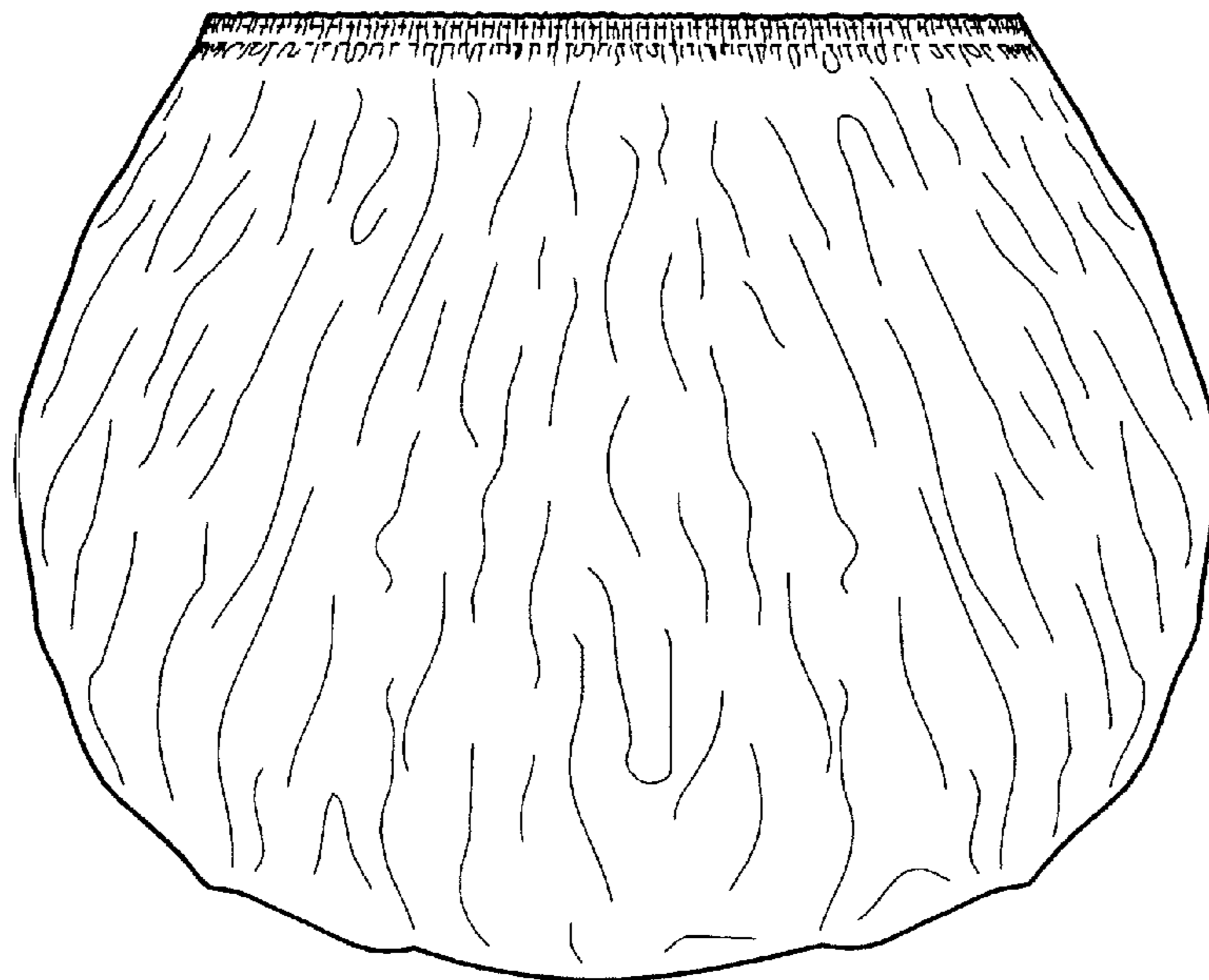

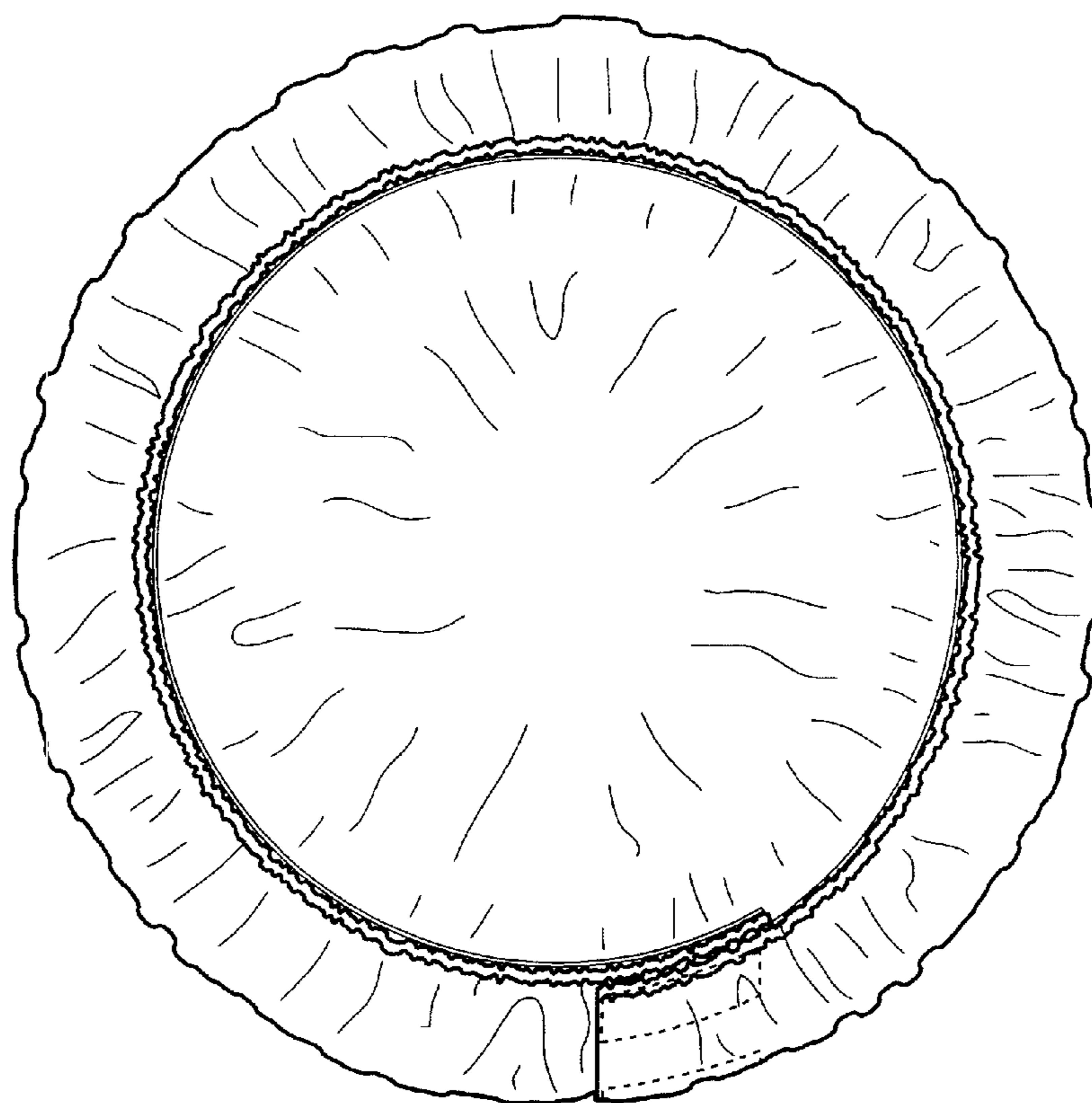

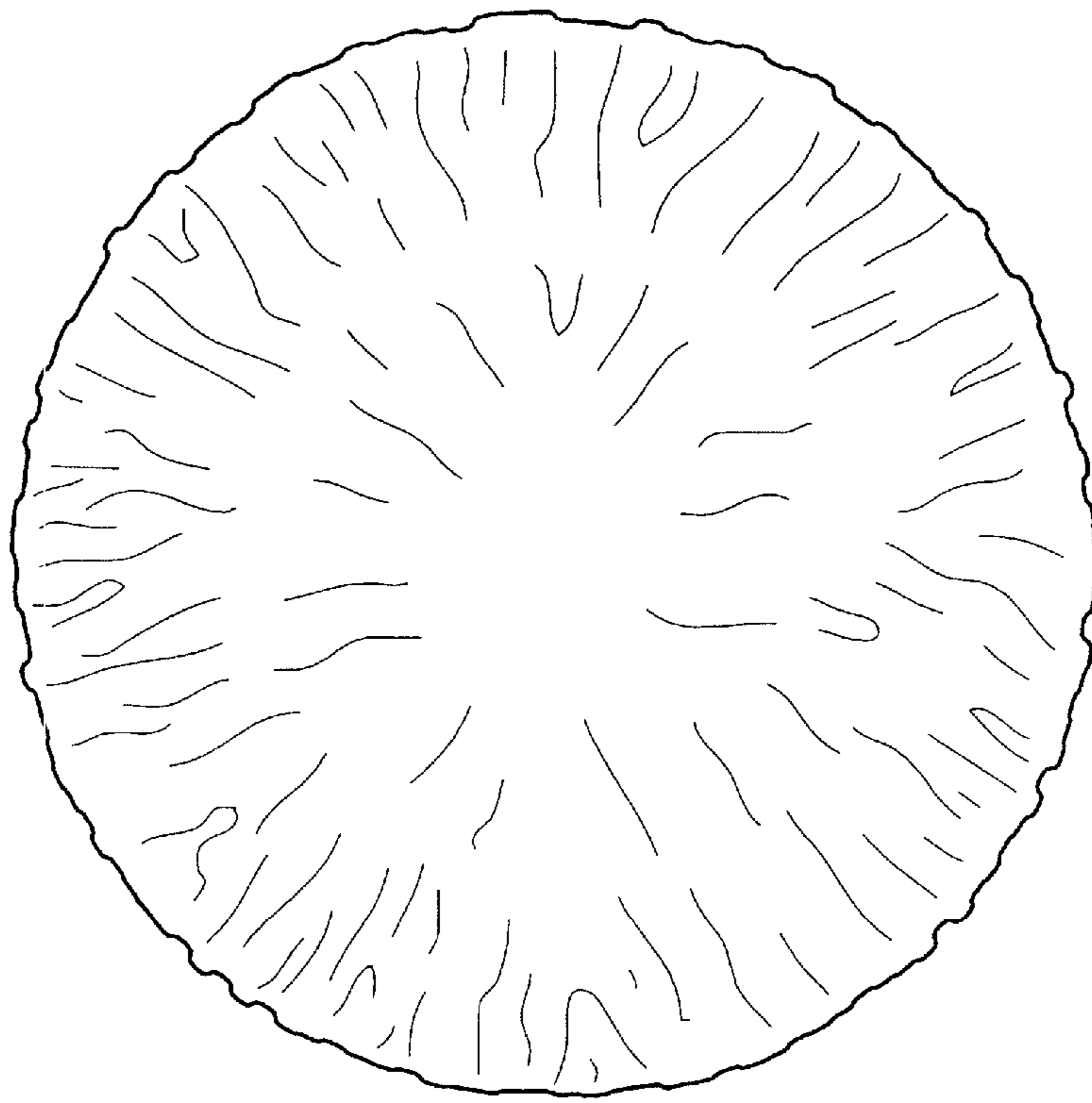

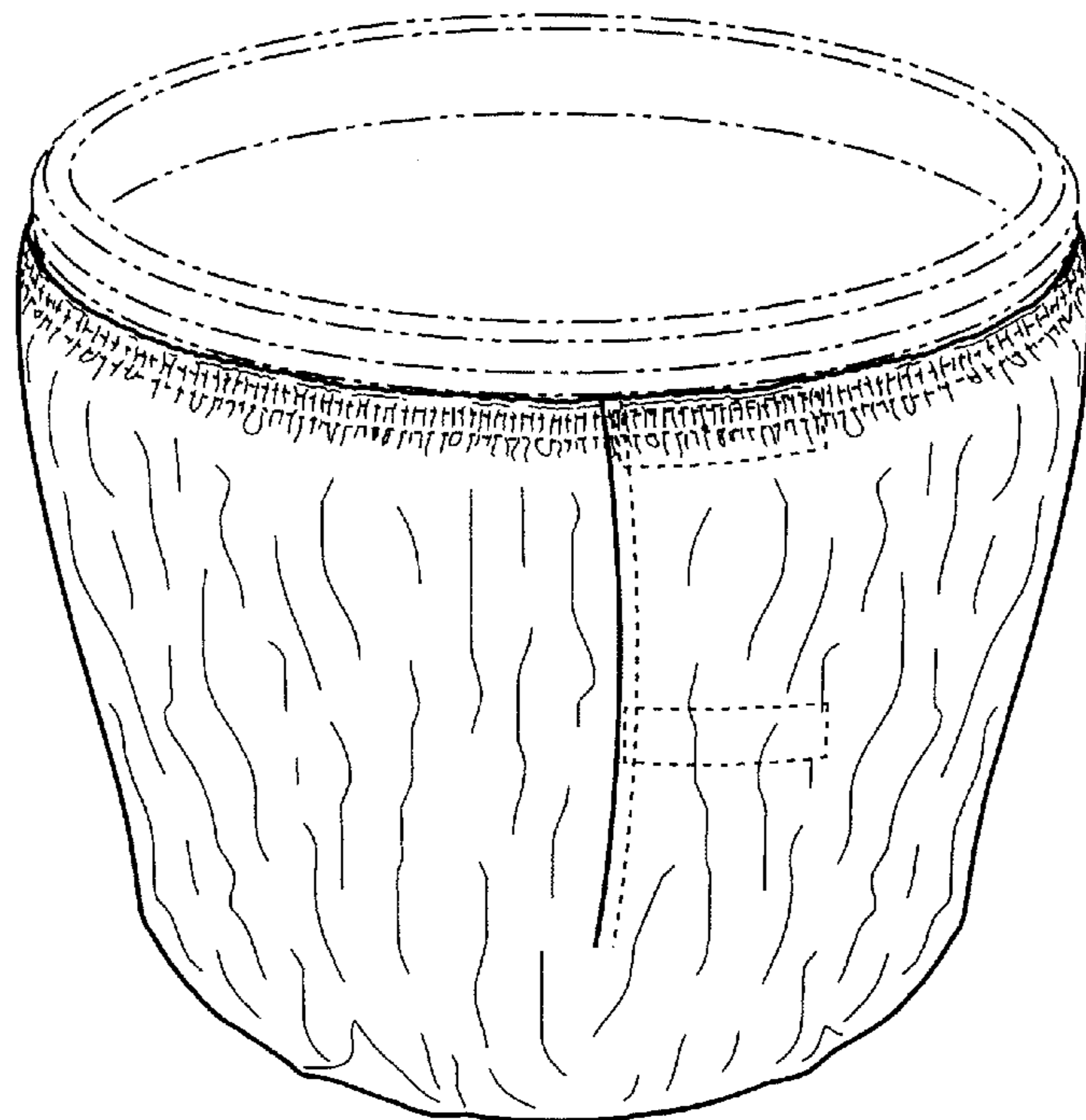
