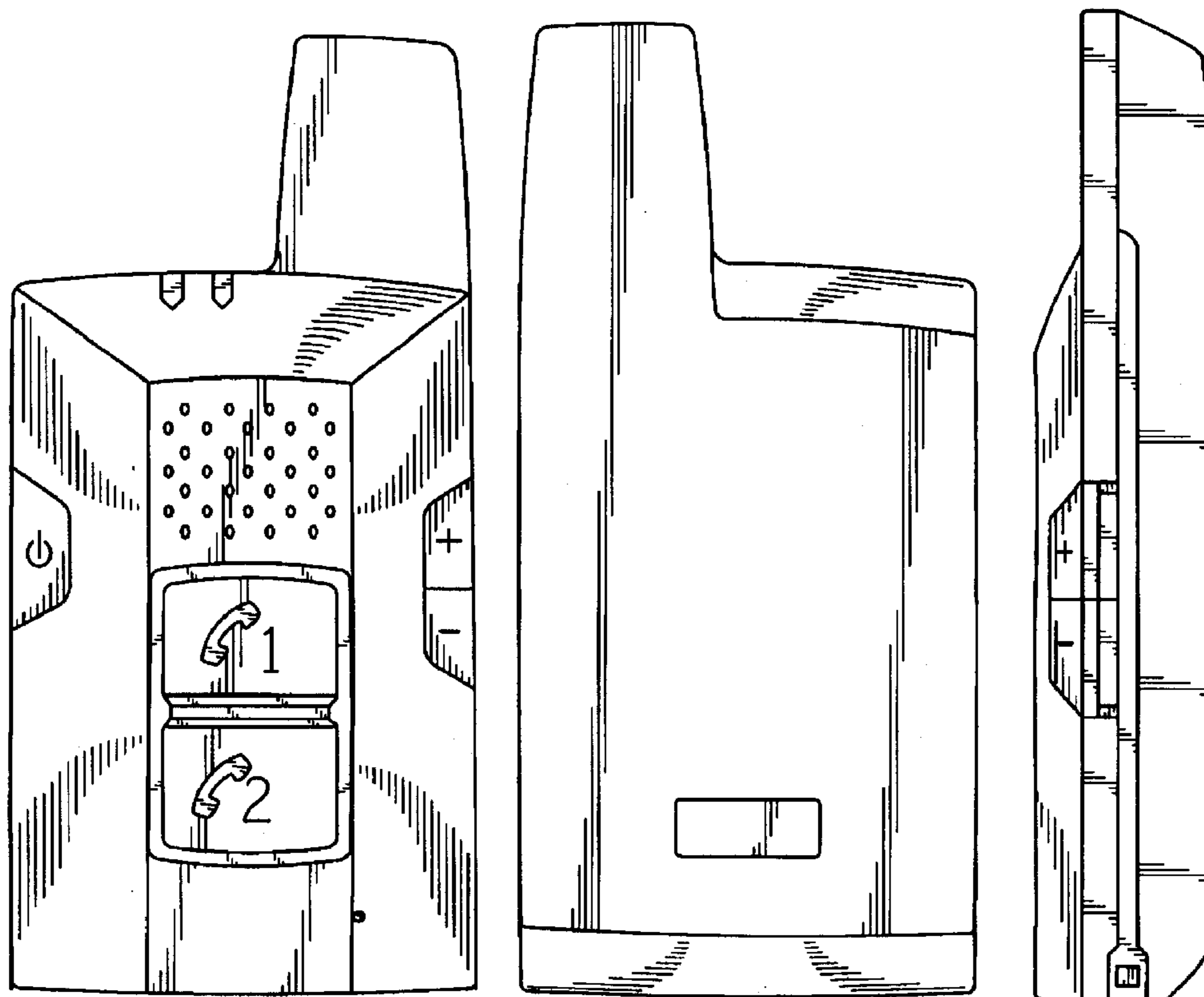
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevation view of a GPS personal locator  
phone, showing our new design;  
FIG. 2 is a rear elevation view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a right side view thereof;

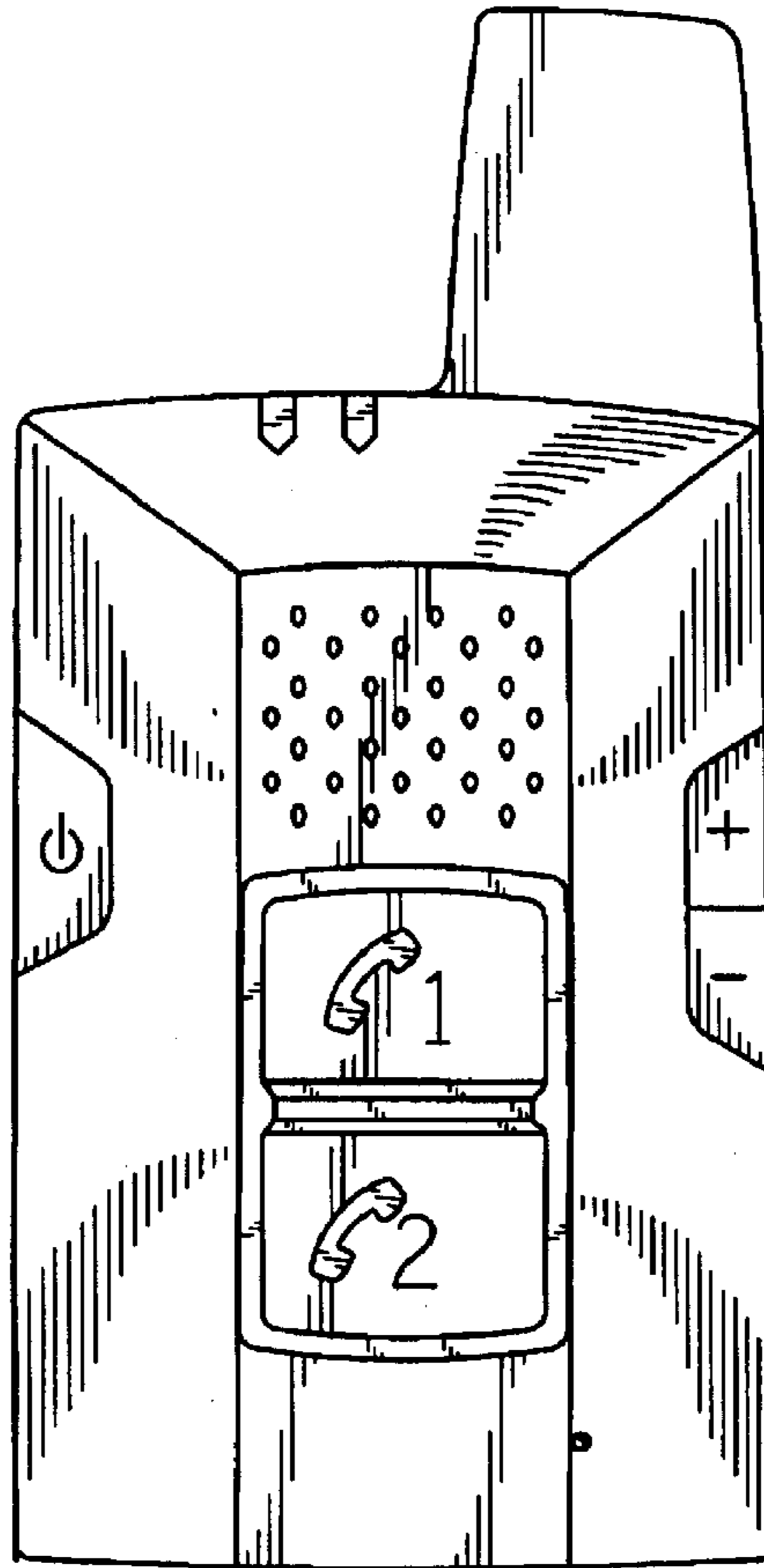

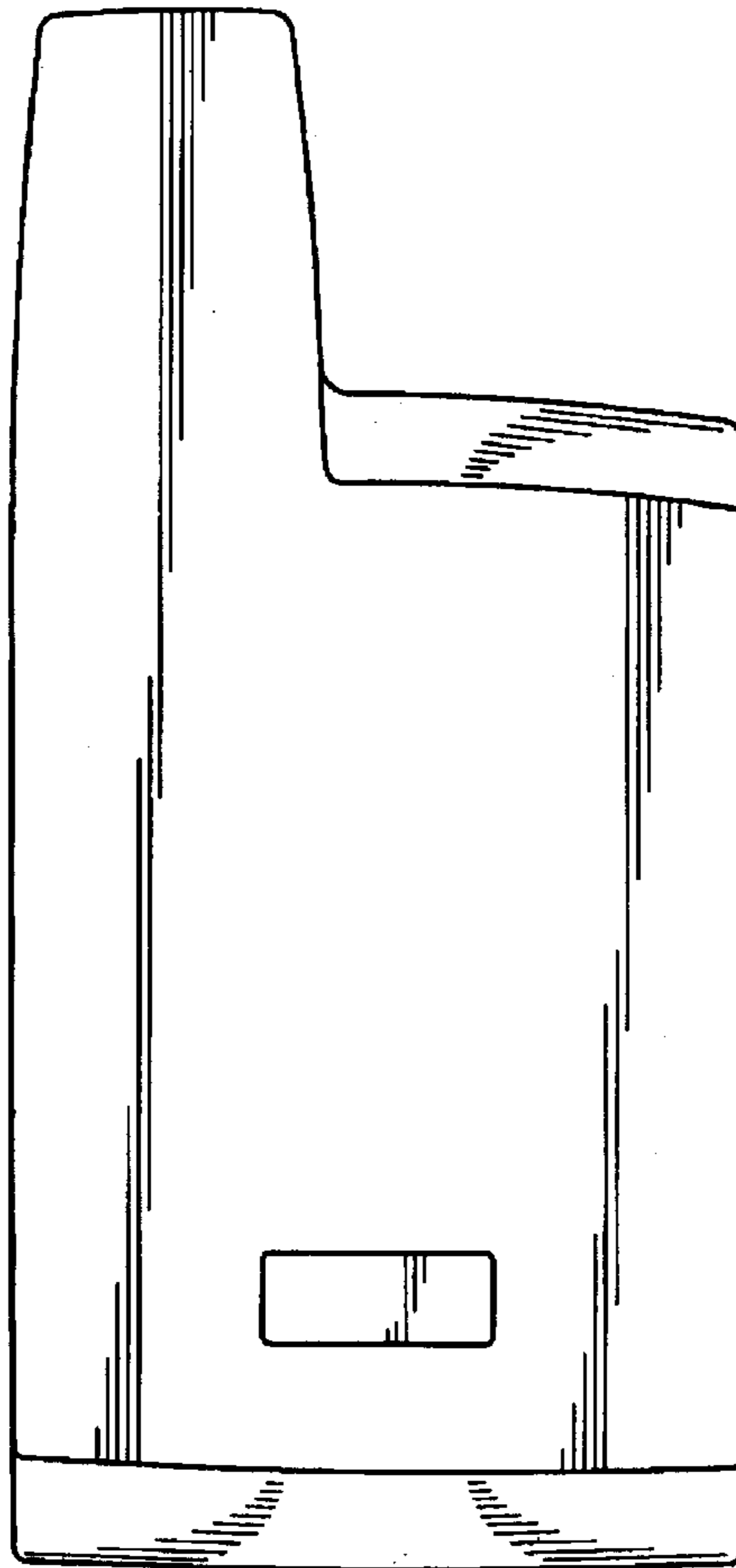

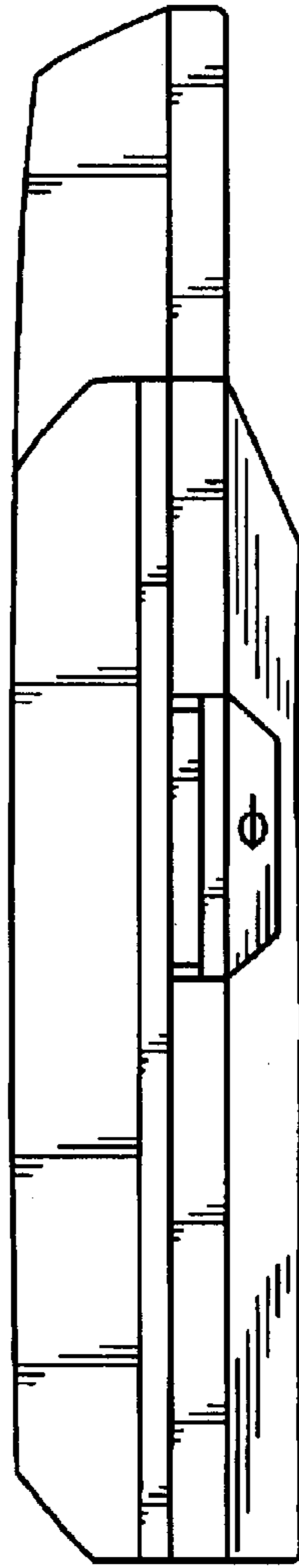

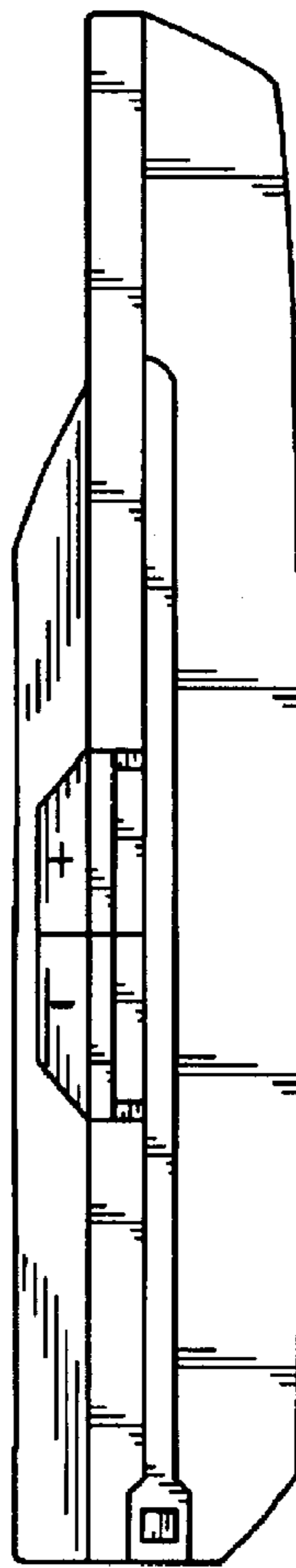

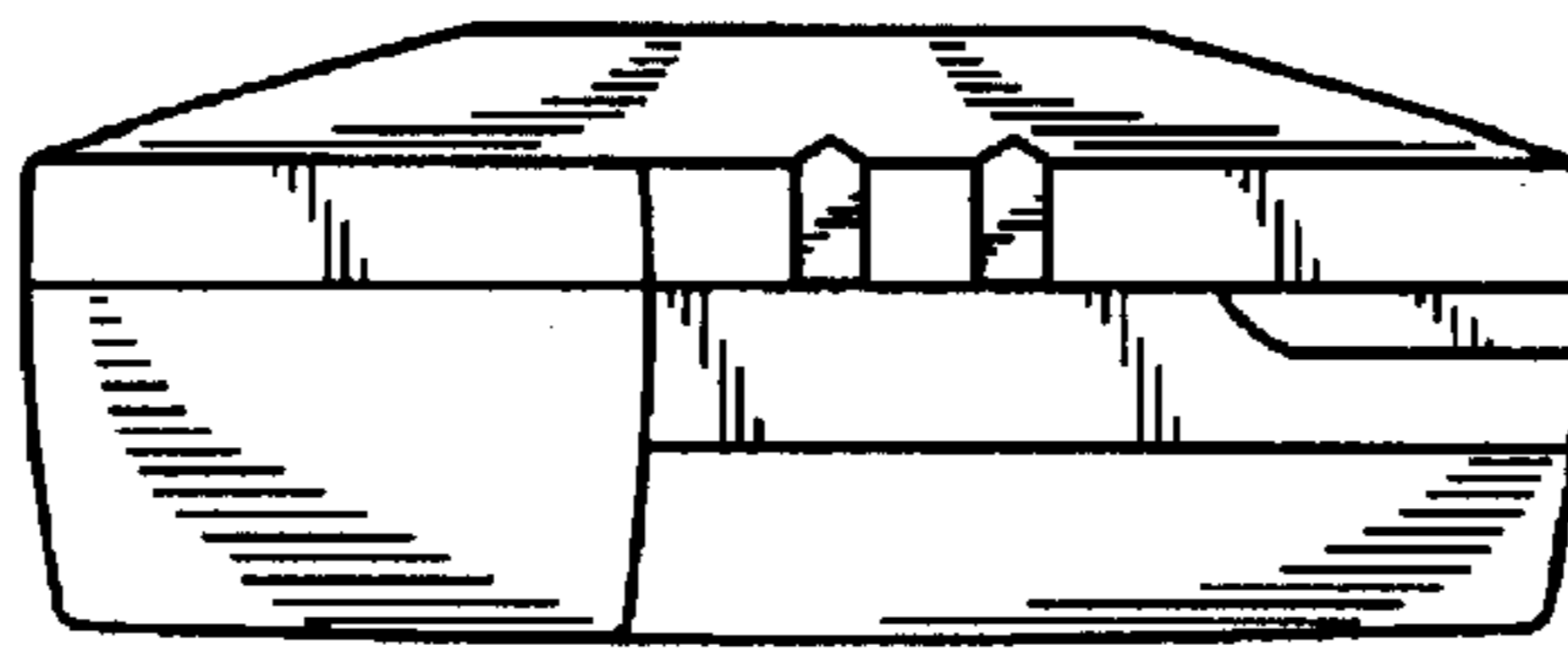

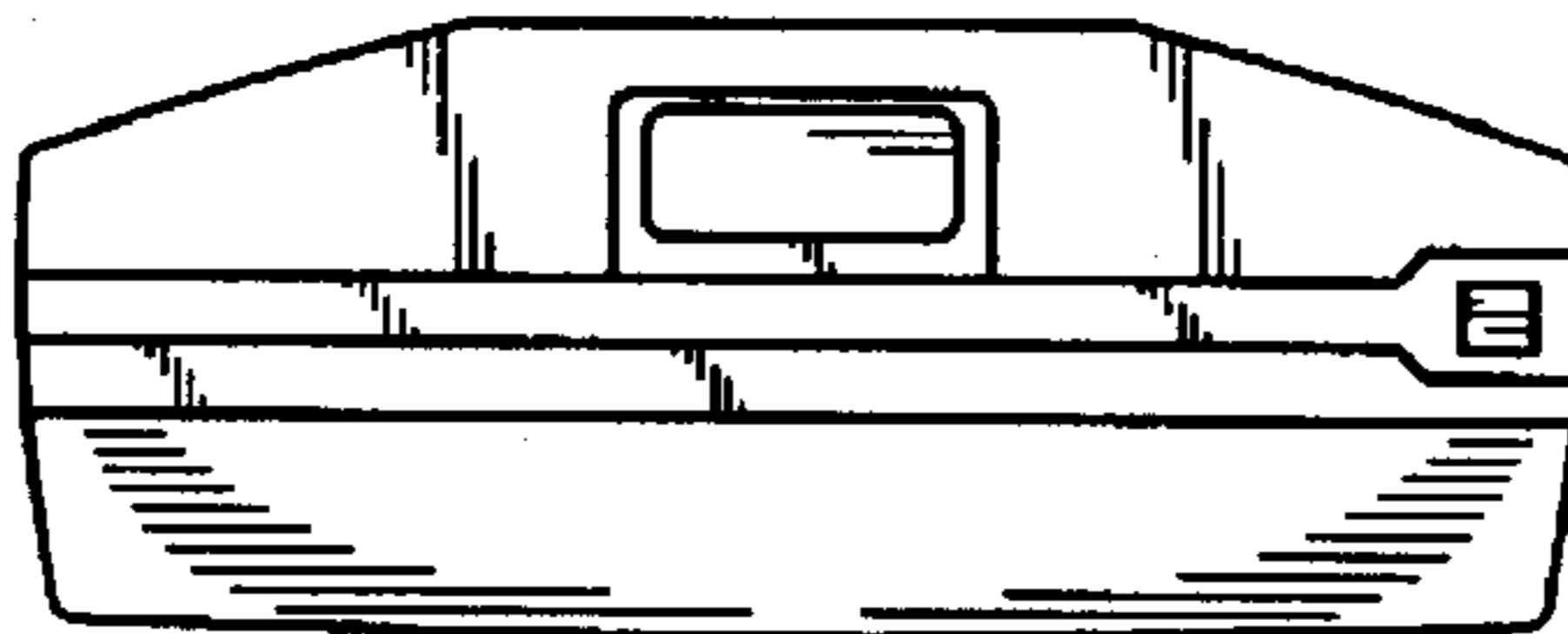

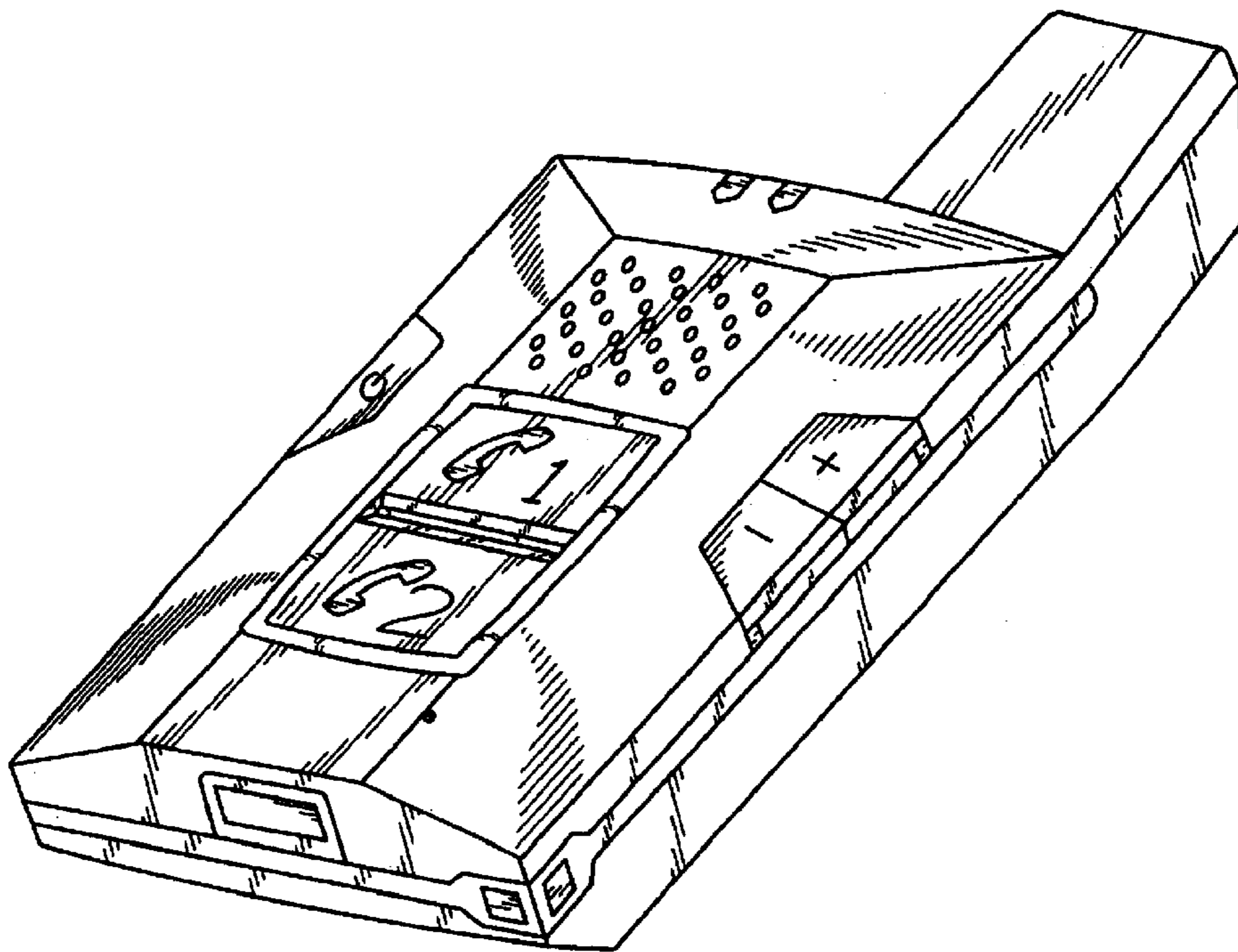
