showing our new design;

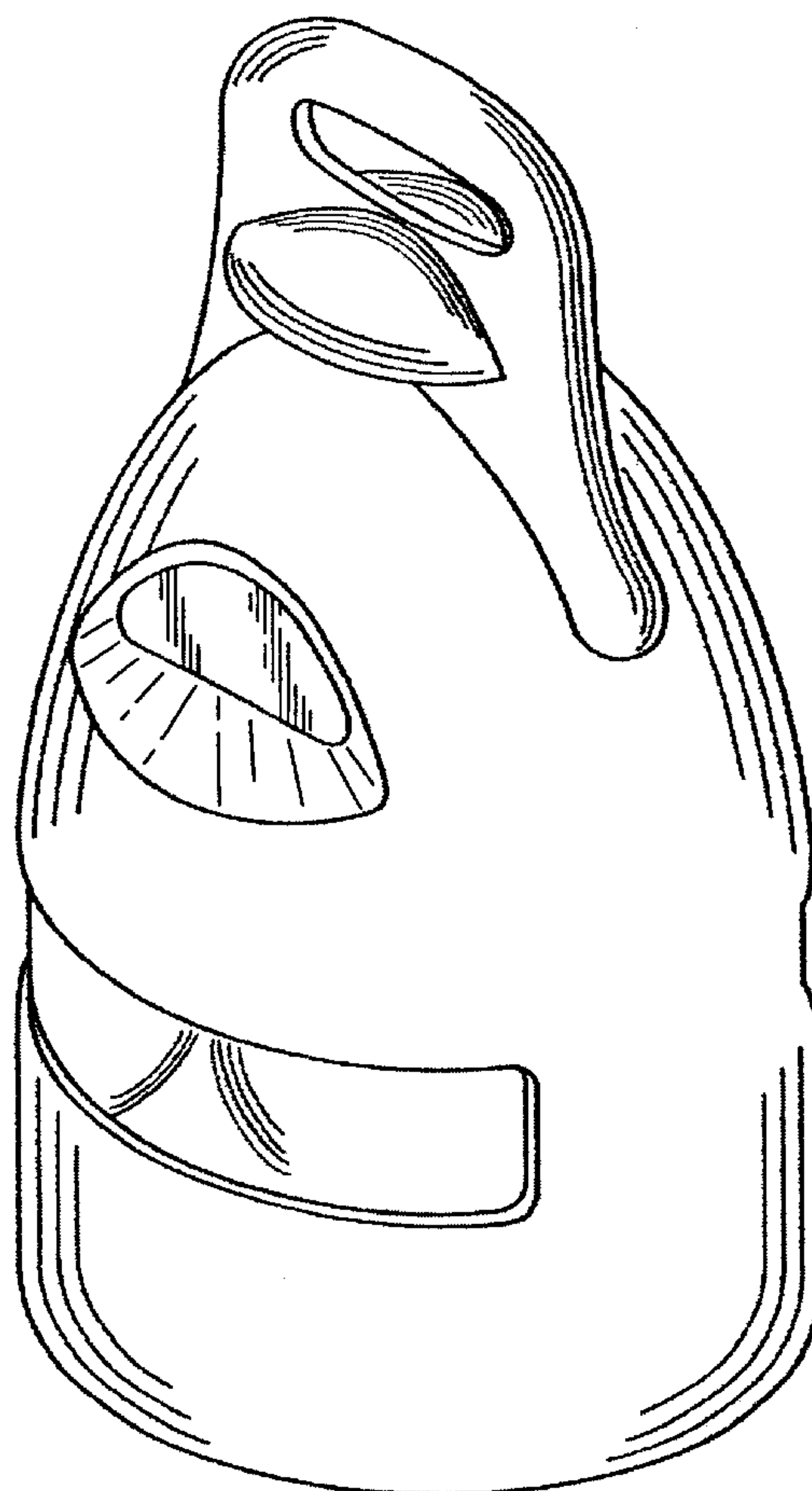
FIG. 2 is a front elevational view thereof.

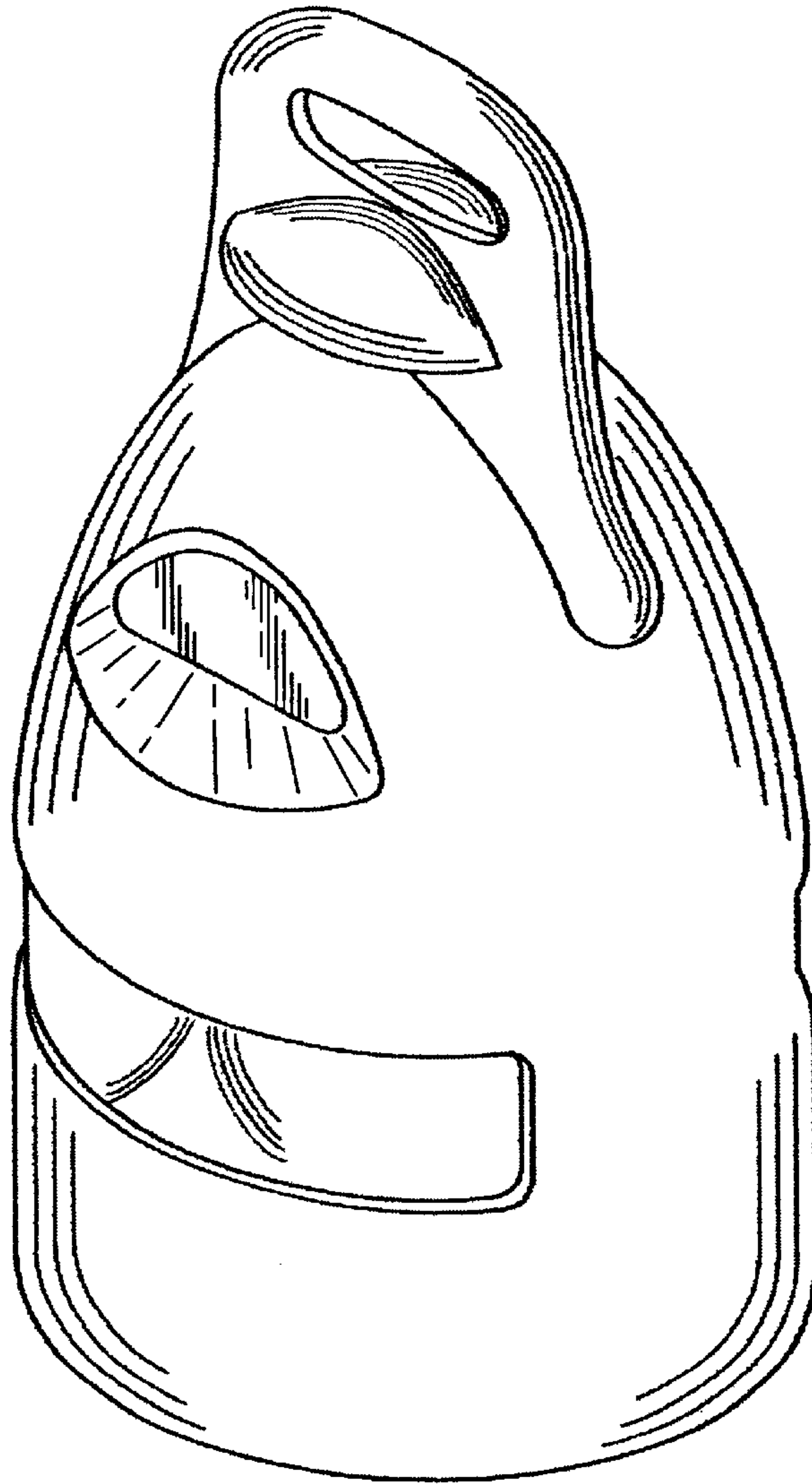

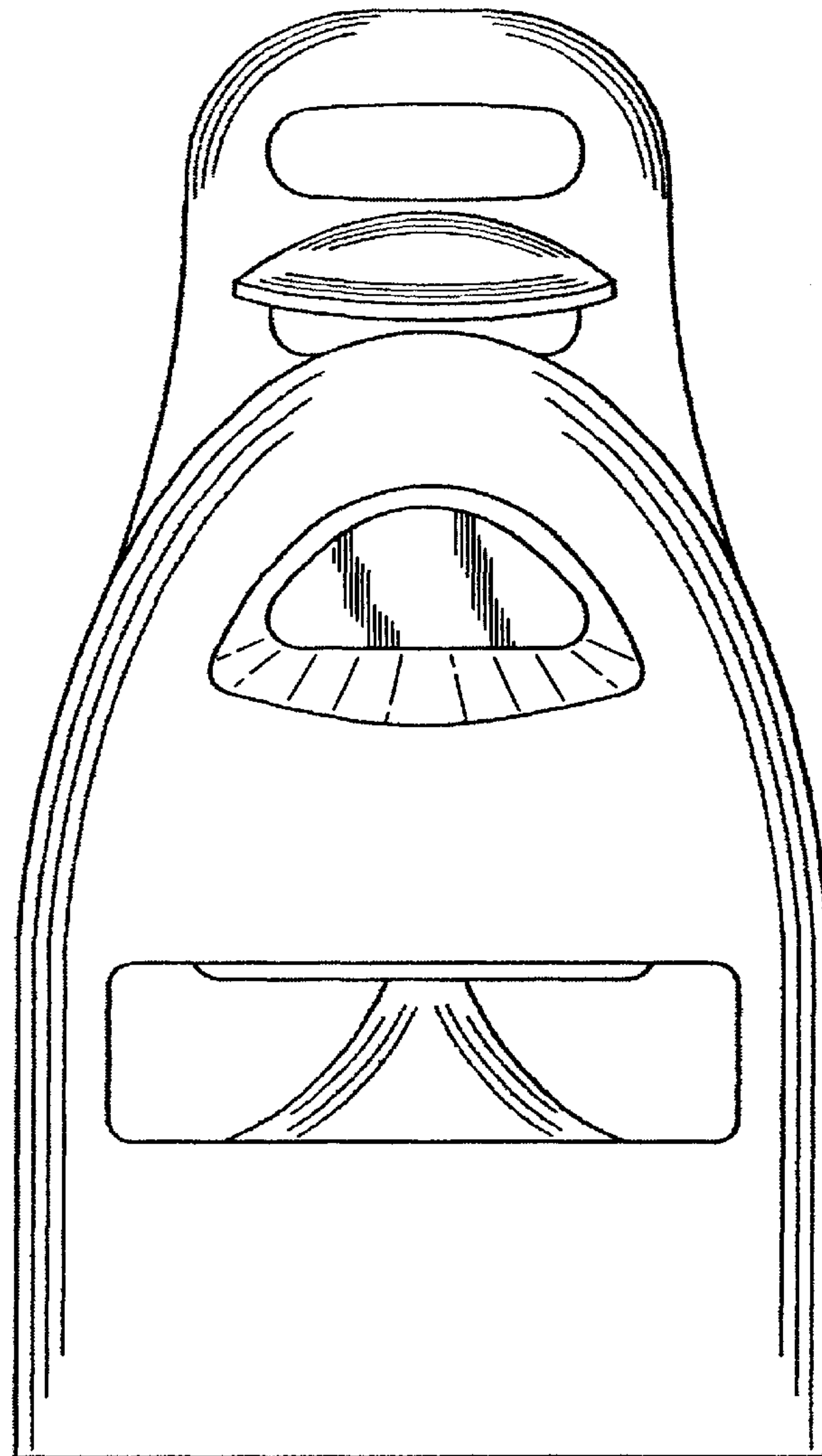

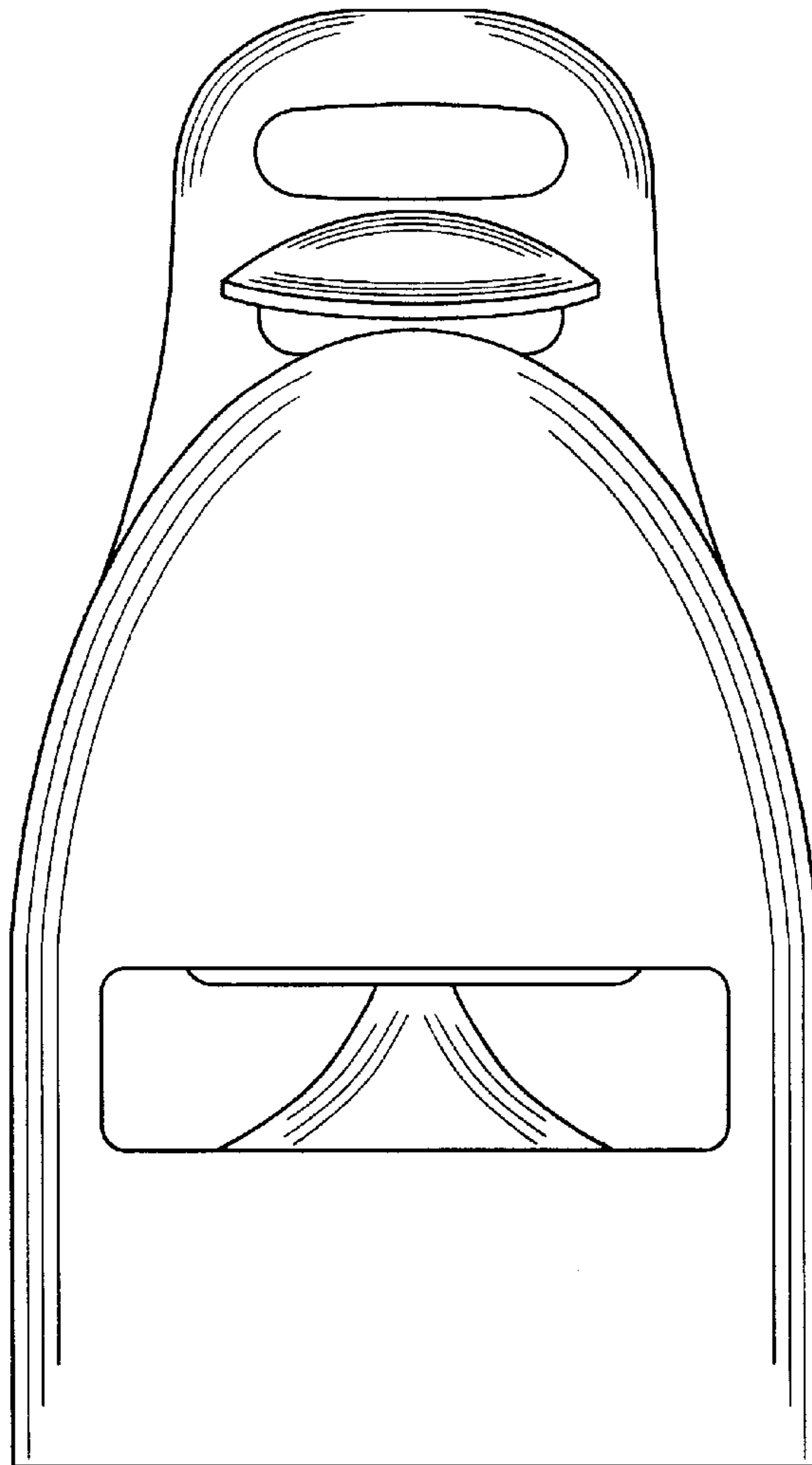

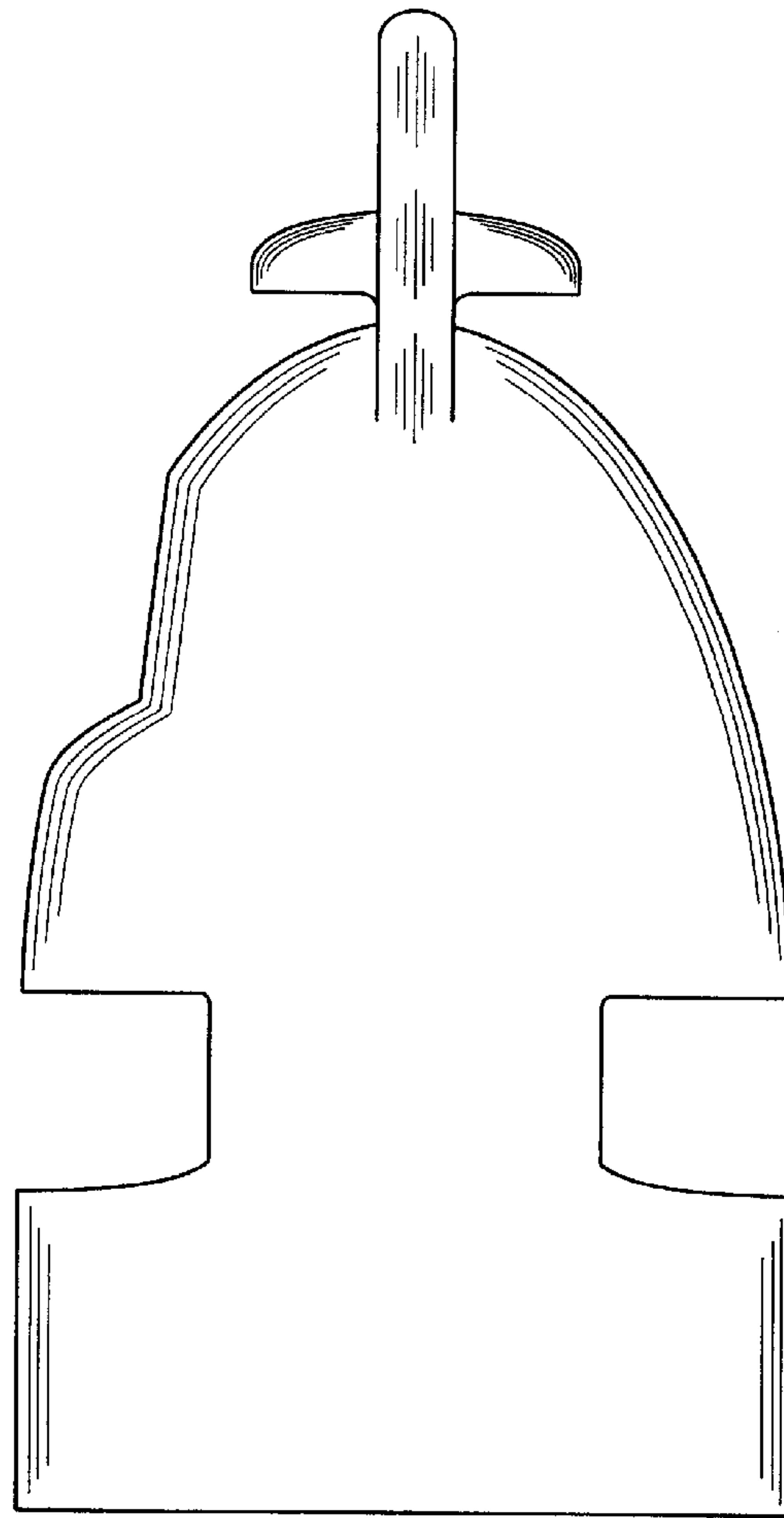

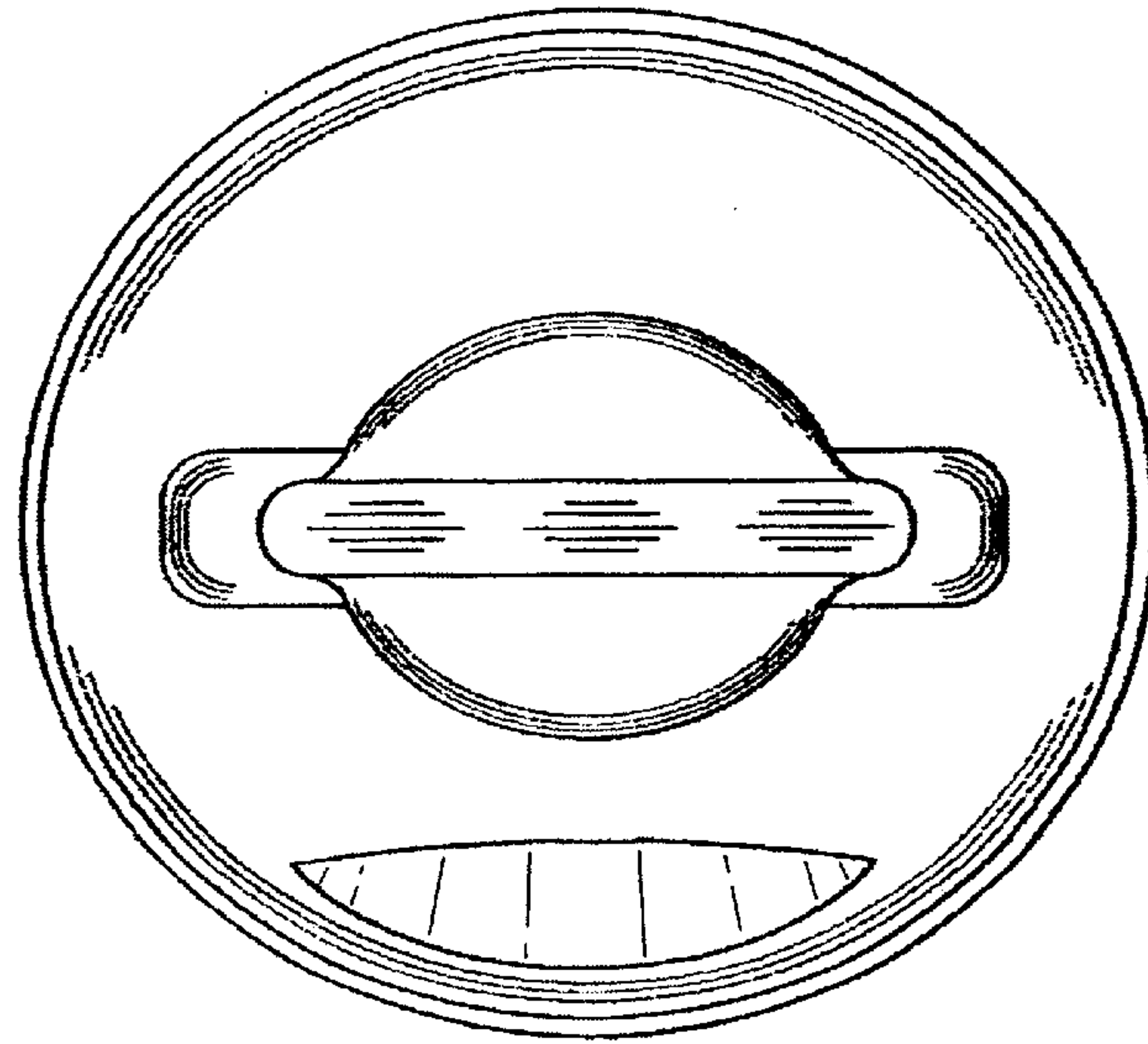
