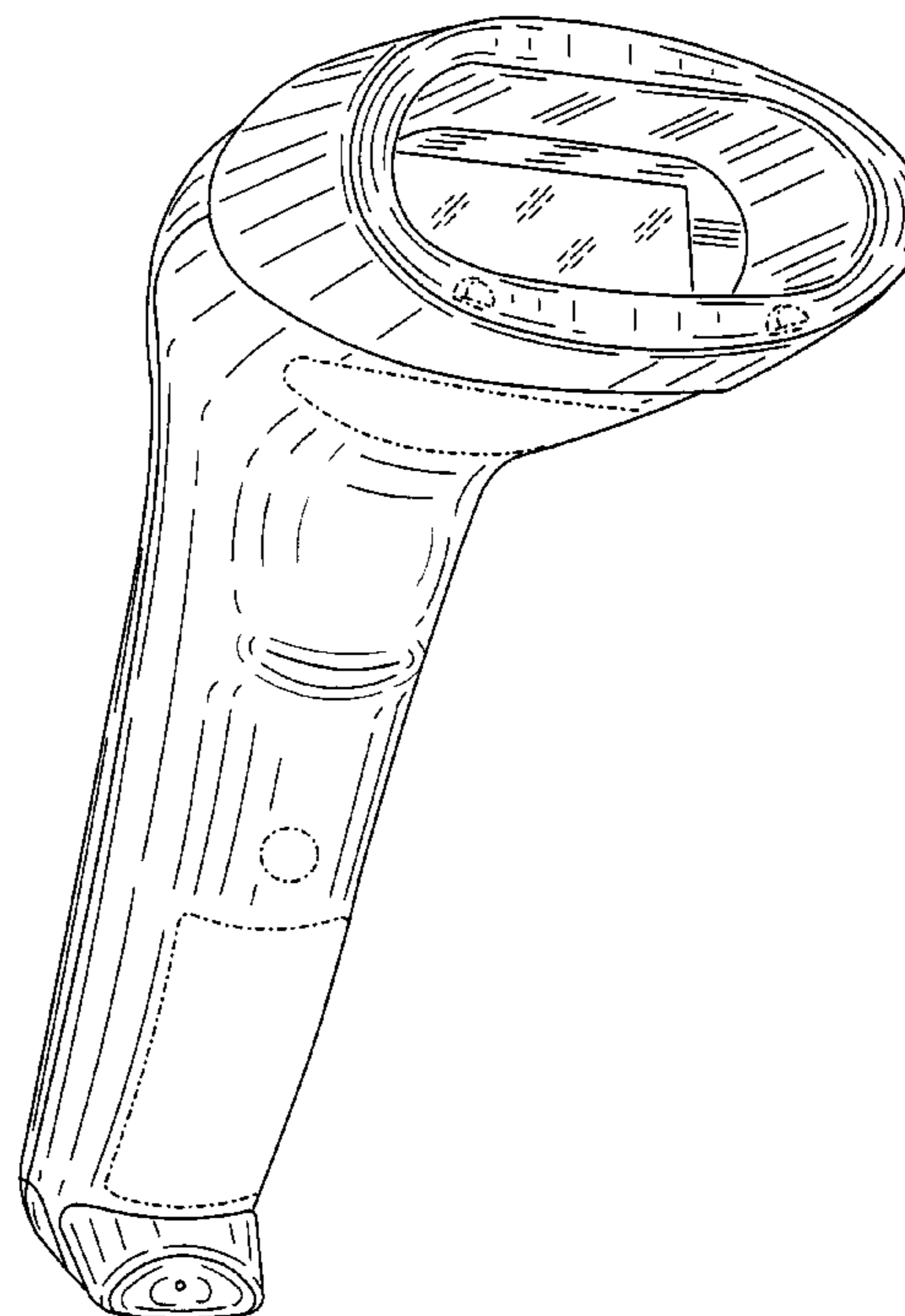
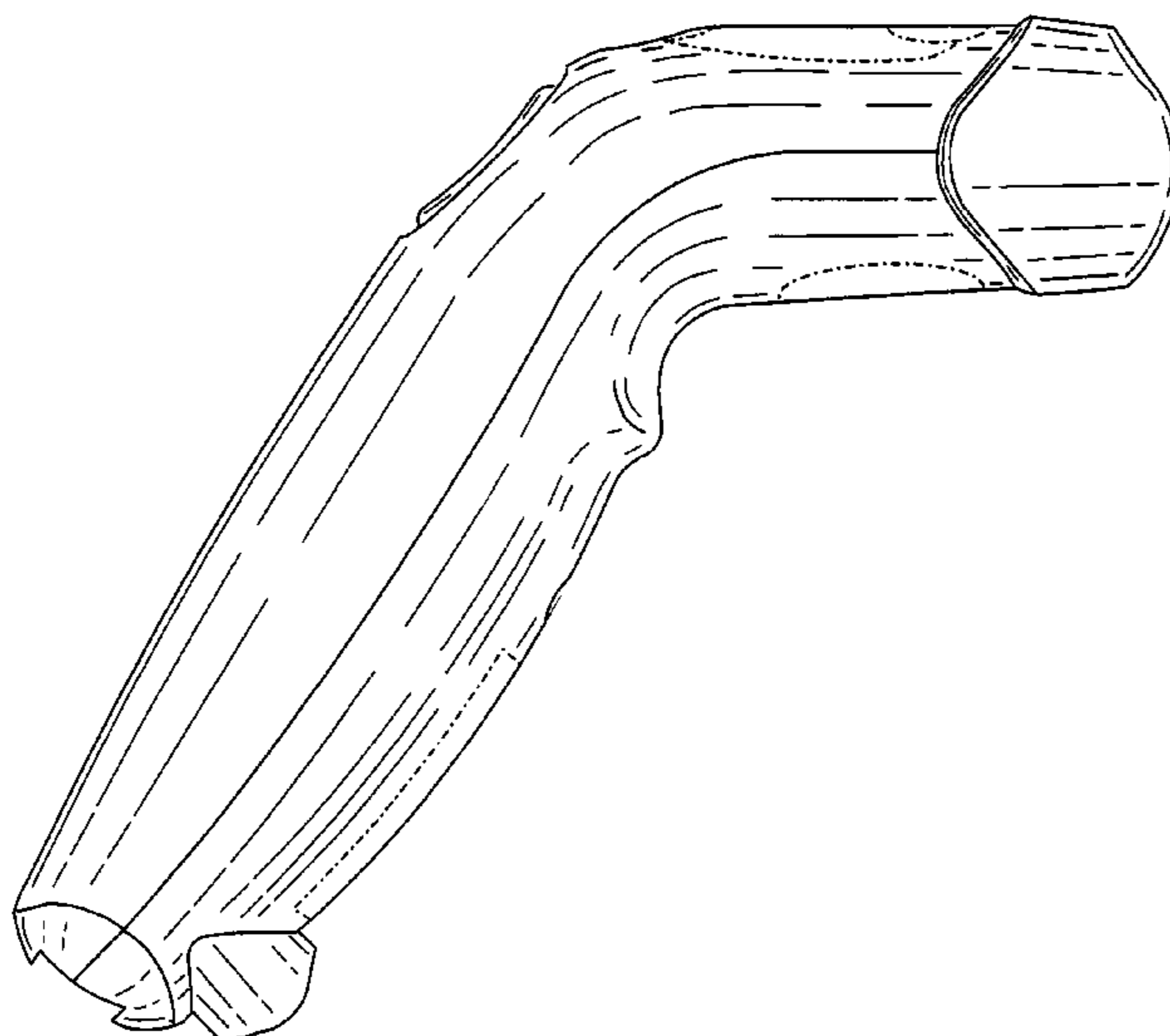
The ornamental design for a hand-held scanner, as shown

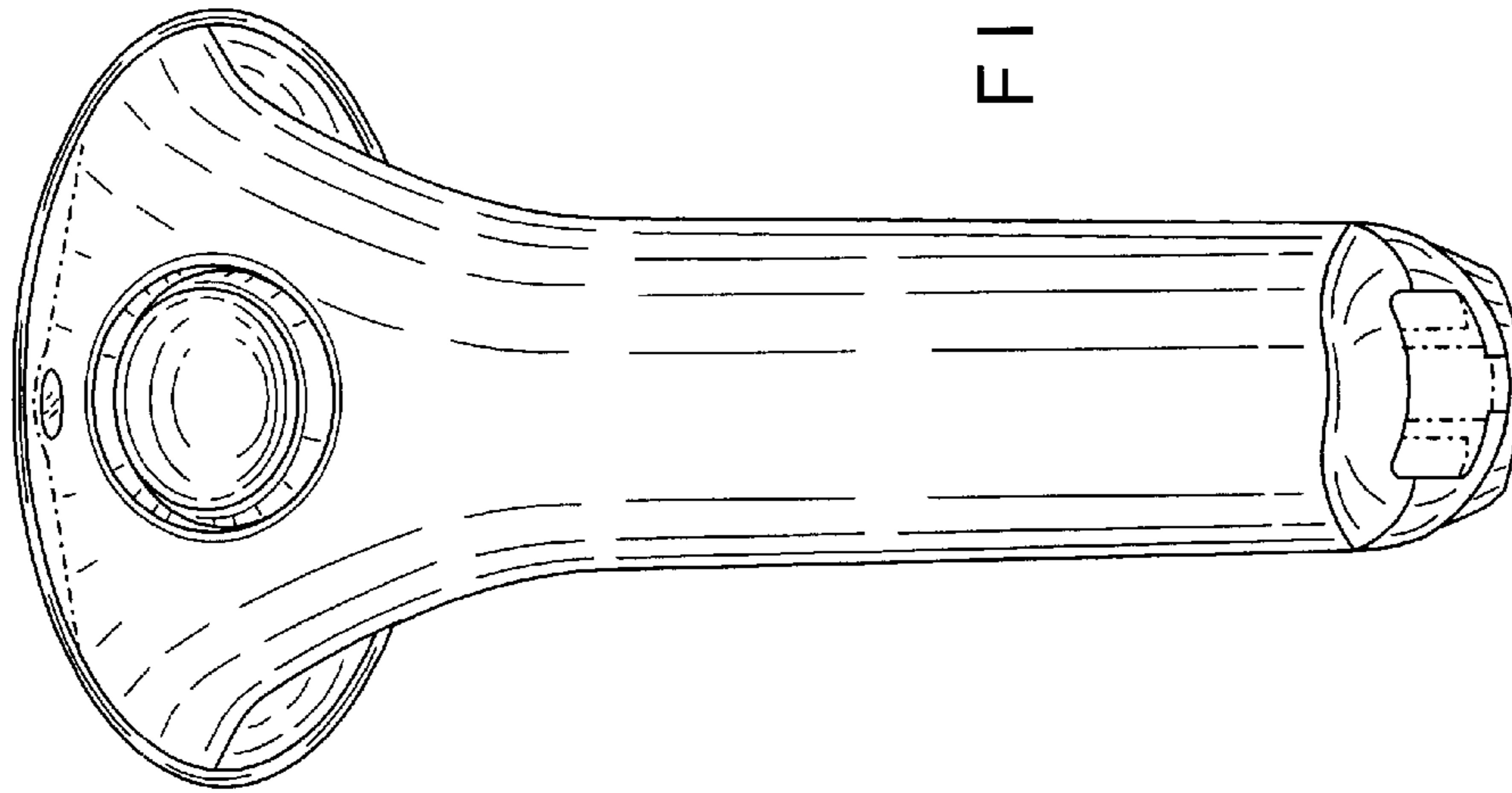

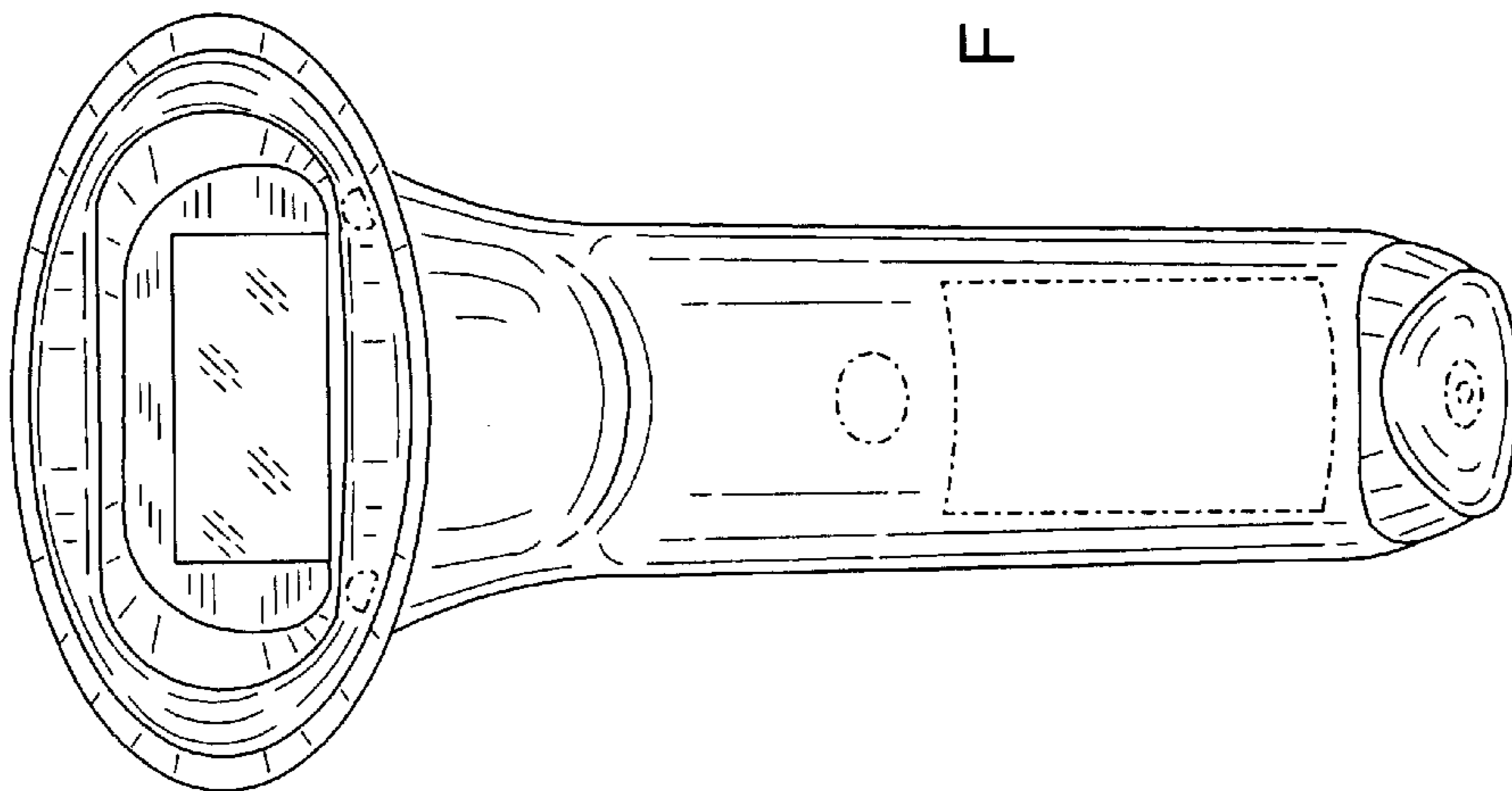

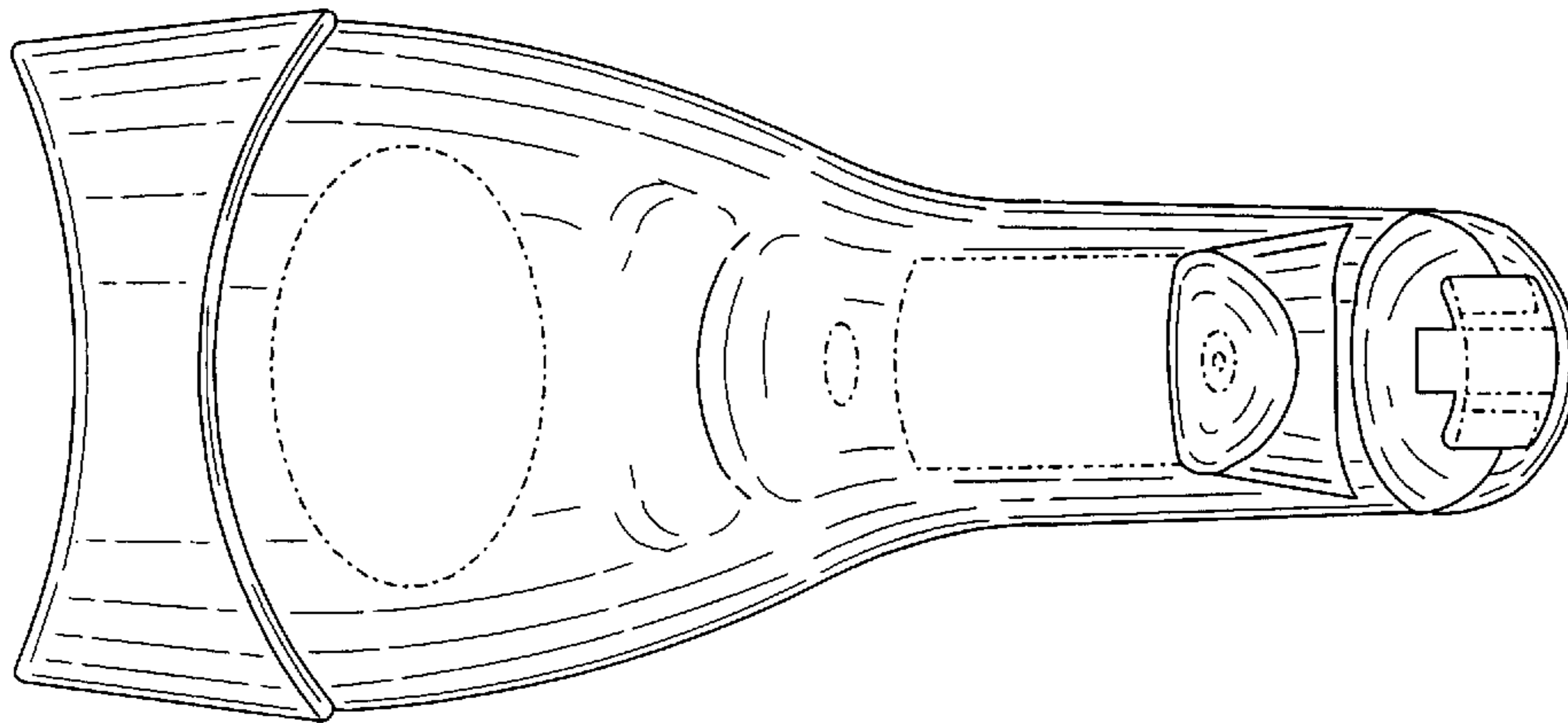
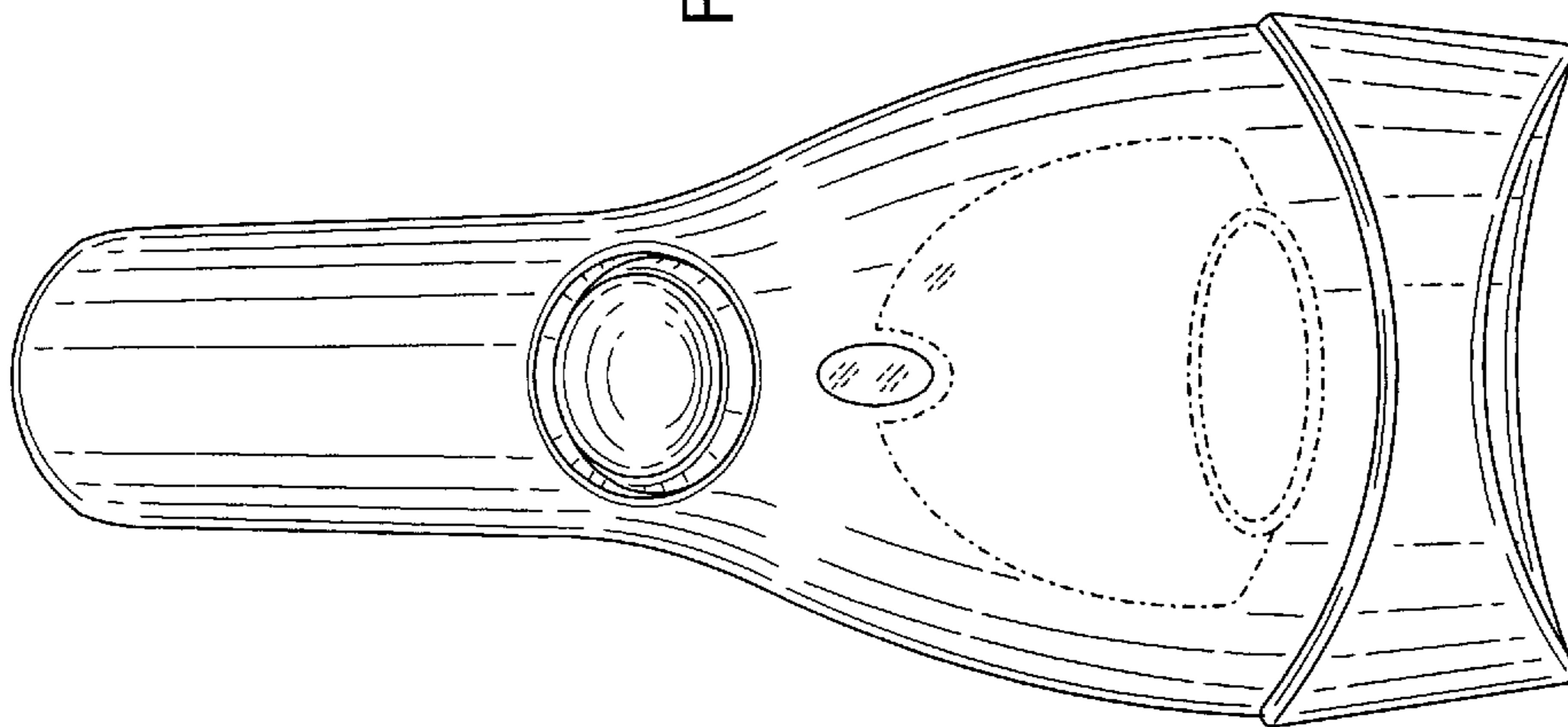

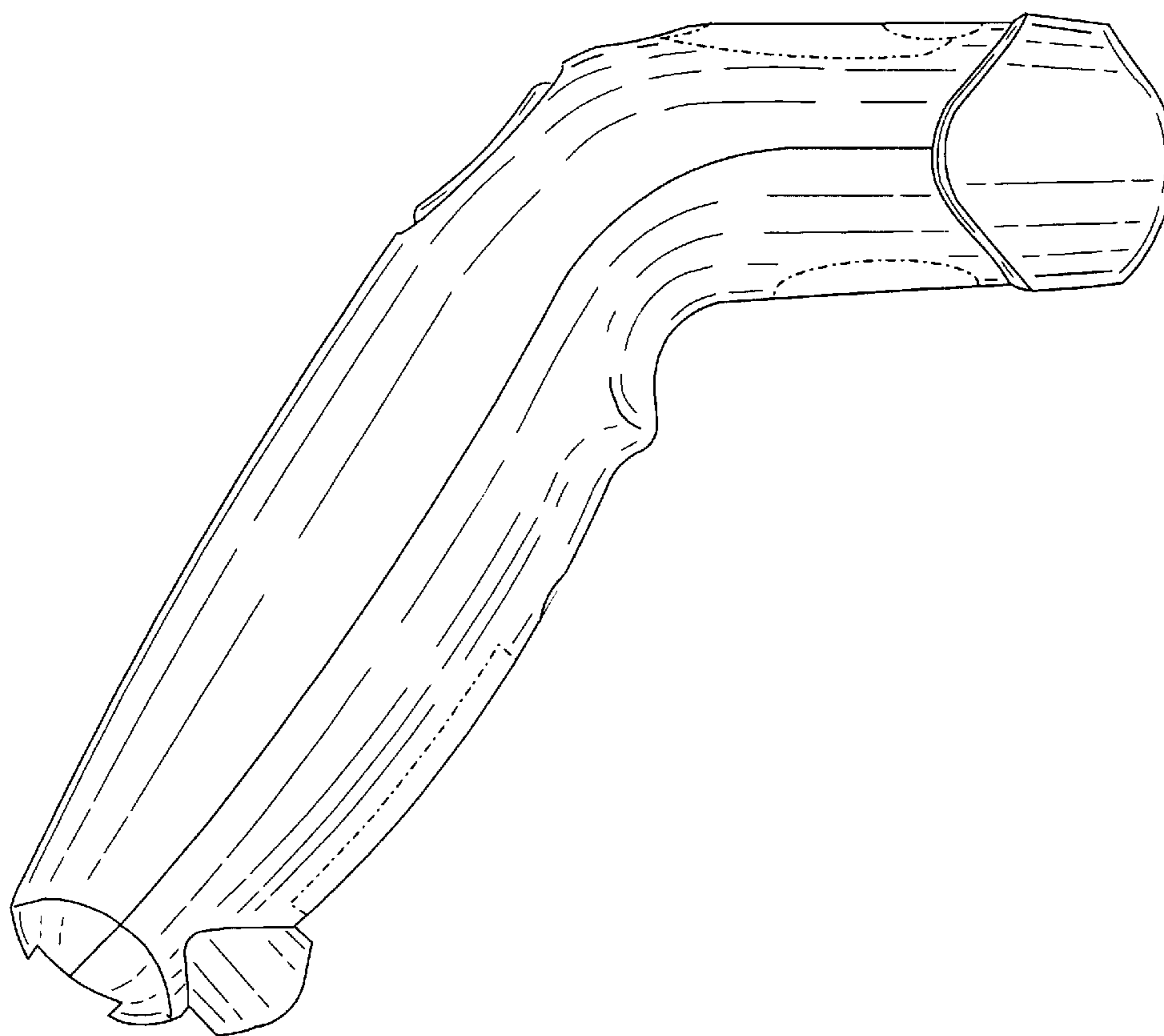

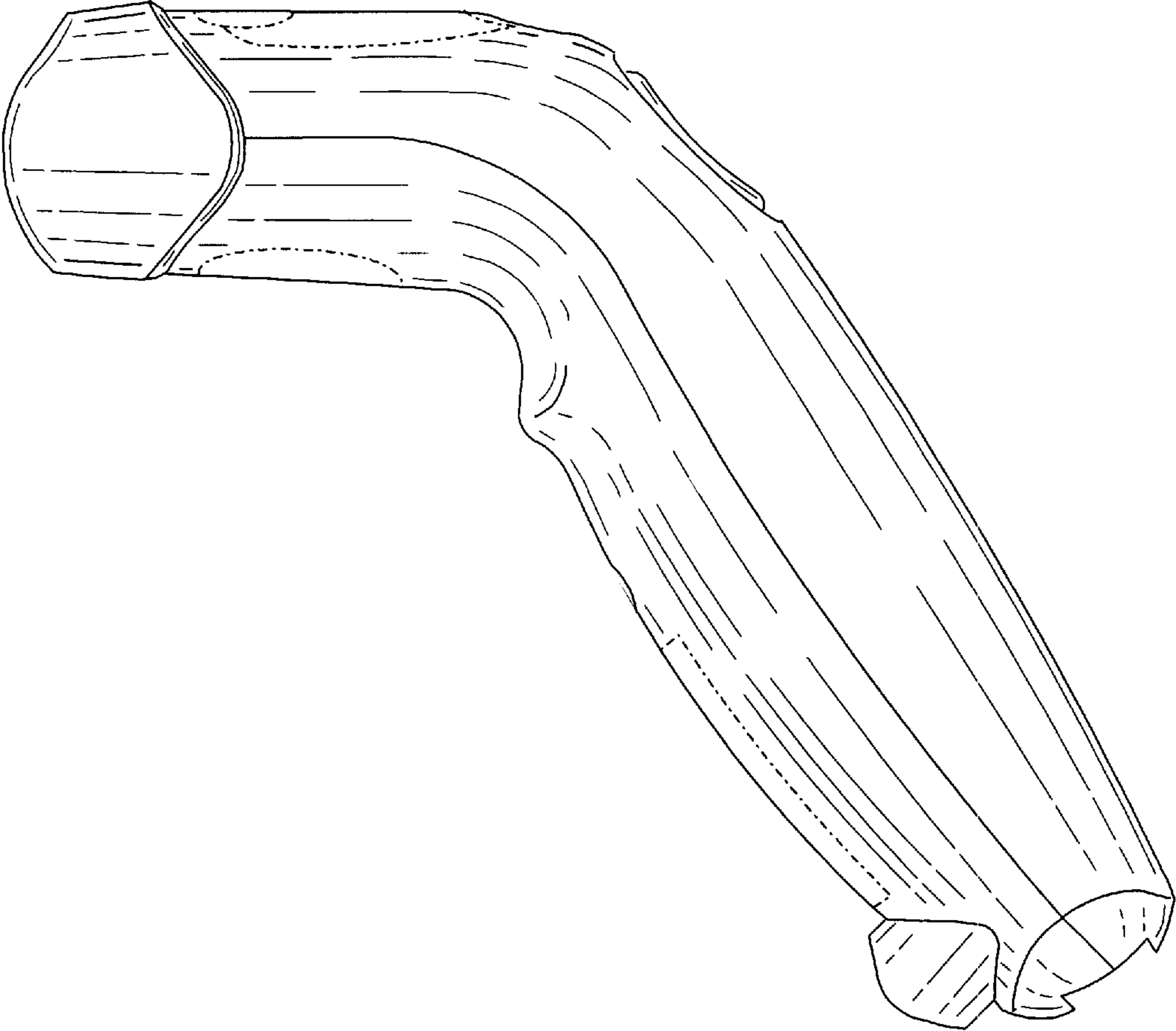

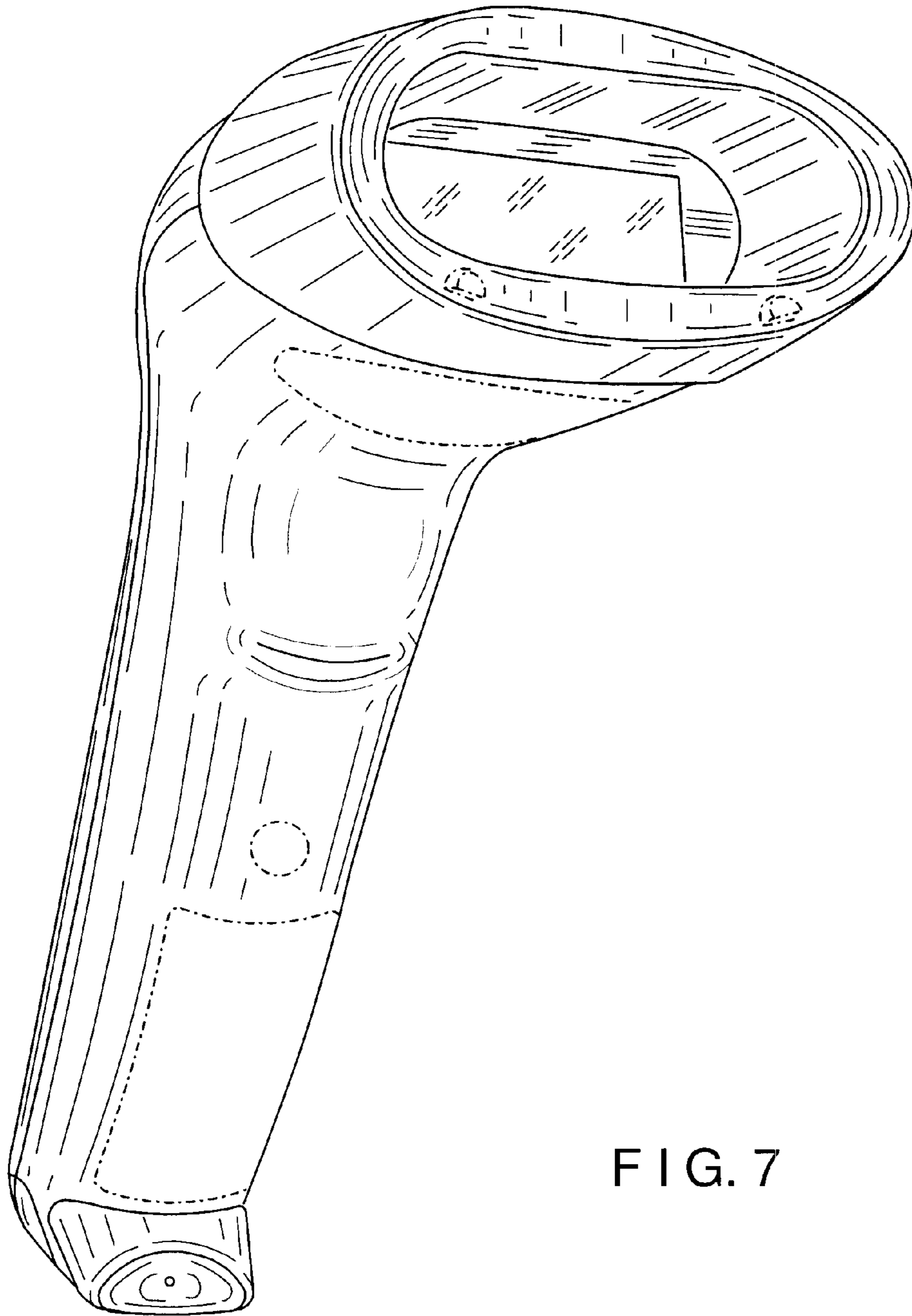
